Wounded vet's special proposal

■ Kozma Jewelers plays big part in big day; Bush family celebrates event

When wounded warrior Retired Army Spec. Tyler Jeffries (26) proposed to Lauren Lily (24) it was a very special occasion indeed and one in which local business D. A. Kozma Jewelers played a major part. They made the engagement ring, which is 14 karat white gold with a round, one carat diamond in the center and small diamonds along the side. "It was exciting for us and very unexpected and we were glad to make this important piece of jewelry," said Adrienne Kozma.

During his recovery from the loss of both legs in 2012 in Afghanistan Tyler had become close with the volunteers at Water Reed Hospital. One of them was Dava Guerin. Tyler talked to her on many occasions about his girl Lauren and how he eventually planned to propose.

Ten severely wounded vets and the moms who cared for them in rehab were scheduled to be honored by President George H. W. and Barbara Bush at their summer home in Kennebunkport, Maine. Though Tyler's girlfriend was not a part of the group she was going with him but would not be at the ceremony at the Bush compound. Plans went back and forth. Finally an August date was set when President George W. and Laura Bush would also be in residence. Tyler decided the Maine setting would be a good time to propose, maybe at a seaside restaur-



rant. But he didn't have a ring...but Dava knew a jeweler.

Dava has a summer home in Berlin and has been a frequent visitor to the Kozma store in West Ocean City. When she asked Adrienne if she could help this young man out, Adrienne replied, "I'd be honored to do it." Then she added, "After he gave me an idea of what he wanted, we talked several times over the phone and e-mailed back and forth to design the ring. At the most we had a week to complete it. We made, we sent it, he got it."

At the photo op for the vets when President Bush senior was told by Dava of the upcoming proposal plans he said, "Well, where is she? Let's get her here." Lauren did not have security clearance but the Secret Service said if she could get there in five minutes they'd take care of it. She arrived while still having no idea of an impending marriage proposal. Because of his prosthetic legs Tyler was helped to his knee by his buddies. He offered her the ring as he kneeled before his girl in front of the Bush home which faces the ocean, a lovely setting under any circumstances. Before he had a chance to say a word, Lauren said yes and numerous cell phones began clicking the unforgettable video.

After President Bush senior Tweeted it, the story went viral as all the news media picked it up and ran with it. "I literally saw it on 'Inside Edition on TV,'" said Susan Bertino, who works at Kozma, indicating that was the first she or Kozma knew it was even a major news story of the day.

As a result of her experiences in volunteering at Walter Reed Hospital Dava Guerin along with Kevin Ferris wrote a book called, "Unbreakable Bonds: The Mighty Moms and Wounded Warriors of Walter Reed." "We all became very close and someone suggested we do a book about it," said Dava. There are ten stories of severely wounded U.S. soldiers and Marines who served in Iraq and Afghanistan and the mothers who aided them on the road to recovery. President George H. W. Bush wrote the forward to the book.



A good man is hard to find

With all the continued acrimony between some members on the Ocean Pines Association Board of Directors, erupting as recently as Monday's Organization Meeting with director Tom Terry shouting at board president Dave Stevens, it is refreshing to see a newly elected board member step forward and actually display the kind of judgment and trust voters expect of their elected representatives.

That new board member is Tom Herrick.

When the board election results were announced last Saturday, the first thought the apparent victorious side of Tom Terry and Pat Renaud had was to contact OPA attorney Joe Moore and ask if they could call a private "Special Meeting" with a topic of "Reorganization of Ocean Pines." Not all board members would be invited to this private meeting. Moore apparently gave some off-the-cuff advice approval, perhaps without a close review of what the bylaws said on the issue.

Renaud and Terry then proceeded to try and have that private special meeting.

The meeting never took place, thanks almost entirely to the integrity and honesty of Tom Herrick.

Here is what Herrick wrote regarding the attempt by Terry and Renaud to hold a private meeting and involve him. It should be required reading for board members. It is a lesson in leadership and integrity.

"I will only speak for myself. After the annual meeting, there was talk

about an organizational meeting to be held within two weeks to elect officers of the board.

"A flurry of e-mails ensued trying to set up dates for all to attend. I was originally unaware that the e-mails going back and forth had to do with separate meeting agendas, as one was titled 'Special Meeting' and one was titled 'Organizational Meeting.' When I realized that the 'Special Meeting' did not include all 7 directors, I immediately became uncomfortable, now realizing the entire board would not be present.

"My goal, as stated during my campaign, and in plea to our community, is to have all seven (7) of our board members work together as a team for the benefit of our entire community. Holding a 'Special Meeting' without all seven directors attending, does not contribute to this goal, but only invites the inference of collusion and the continuation of these so-called coalitions on the board. I believe my message, stated against the extreme partisanship of some of our board members, resonated with the majority of our membership voters, and led to me being elected.

"I refused to attend the scheduled 'special board meeting' as it did not include all seven board members and made that very clear to all the other board members. Although it is purported that Joe Moore believed it would have been a legal meeting, it went further than that to me, as I do not believe it was morally right to do so."

How refreshing to read the words of an honest man, as well as a man not afraid to share such thoughts with the association members who elected him.

Lest anyone question whether or not Tom Terry and Pat Renaud did in-

deed try to hold this private "special board meeting," Pat Renaud confirmed this in an email.

Renaud wrote, "It is true that both Tom Terry and I tried to organize such a meeting only after clearing the legality of such a meeting with our legal counsel, Joe Moore right after the Annual Meeting of August 7th. It is true that an invitation was sent to both of the newly elected Board members who were not sworn in yet, which made the meeting legal since there would be only two members of the Board present."

What this boils down to is an argument over when do winners of the OPA board election actually become board members. During Monday's Organization Meeting OPA attorney Joe Moore made a half-hearted and uncomfortable attempt to defend his advice to Terry and Renaud, saying those elected did not become board members until the Organization meeting. Moore subsequently agreed to actually review the question. Moore also said Renaud's reference to the new board members not being board members until taking what is an optional oath of office was not correct. New board member Cheryl Jacobs even said she was told she was just a "quasi director" until the Organization Meeting. She did not say who told her.

Terry defended his and Renaud's actions, suggesting the same sort of private meeting happened last year, as though that would somehow make it right this year.

No one at the Organization Meeting suggested opening up the bylaws and actually reading them. The bylaws are clear and subsequent to the Organization Meeting, longtime chairman and six-year member of the Bylaws & Resolutions Committee Jim Trummel clarified this to the board and Joe Moore as part of a lengthier examination of the bylaws and Maryland law. He wrote, "Individuals elected to the board become sitting members of the board upon adjournment of the annual meeting at which the results have been presented to the membership. This is consistent with Maryland corporate law, Ocean Pines Association Bylaws, and Ocean Pines Association election procedures."

In the end it makes no difference about any debateable fine points of the law. In the end, Tom Herrick's inner sense of right and wrong prevailed, and for that we should all be grateful.

Electric bills show increased costs

A number of Ocean Pines residents have had the new advanced electric meter installed by Choptank Electric Co-operative. Several residents report being surprised when the envelope is opened for the first month's bill.




First of all, members of the Choptank Co-op should be aware that the Maryland Public Service Commission recently granted Choptank a 6% increase in the rates they can charge for electricity. Therefore, every electric bill will show a 6% increase immediately.

Several residents report that after their meters were replaced they got what appeared to be a much larger charge on their next bill. Careful review of the bill revealed that the bill was for much more than the normal 30 or 31 day billing cycle. Andrea Barnes, for example, reports she received a bill covering 52 days. When the bill was examined in light of covering 1.75 months, the bill became more closely aligned with expectations.

Choptank electric Co-operative Vice-president of Member Affairs, Mr. Bob Behlke, says that it is possible that the first bill will be for a longer period than normal, hence the charge will be larger than normal. Within a billing cycle or two the billing period should resume a steady cycle.





Answers for August 19

That's how my garden grows...

**Hello Fellow Gardeners,**

We are well into the Dog Days of August and our summer days are numbered. But this has been a great year for gardening – both for flowers and vegetables. My annuals and perennials produced beautiful foliage and flowers and my five different tomato plants were prolific producers. So, no complaints here; hope all of you can say the same.

I must update you on my hummingbird friends. It has been a most unusual summer for my little friends and they worried me a lot. They first came to my feeders in May for only a few days and then they disappeared and I did not see them again for six weeks. I continued to clean the feeders and add fresh nectar, but all through June and early July they did not come around. Like an old mother hen, I worried and wondered what had become of my tiny friends.

Finally, the third week in July, they returned in full force. Yes my feeders were full with fresh nectar and three flying acrobats returned to put on their air show. Oh I was so relieved. They have always loved my crocosmia bush with its bright reddish-orange funnel type blossoms and maybe they returned for that sweet nectar in the blossoms. Needless to say, I loved watching their swift, flying acrobatic maneuvers. They are still here, although my bush has finished blooming, my feeders are kept full. I will miss them when they fly away to warmer climates. Please keep those feeders filled as they will need to fill up on that sweet nectar for their long journey.

In case you have forgotten the recipe for the homemade nectar, it is as follows: Heat four cups of water and one full cup of white granulated sugar to the boiling point. Stir and simmer for only one or two minutes, making sure the sugar is all dissolved. Cool the nectar and then fill your clean feeders. Any remaining nectar can be stored in the refrigerator. Now just sit back and be entertained by these tiny acrobats.

You are all probably wondering about my summer blooming perennial called crocosmia. It is a fiery-colored perennial bush with lush green foliage that produces one to two inch funnel-shaped flowers that are brilliant in color of bright

orange or red. It blossoms in mid to late July and the "hummers" love the flowers. Crocosmia grows from corms similar to gladiolus. They grow two to three feet tall with leaves or shoots extending one to three feet long.

It was first bred by the French hybridizer, Lemoine in 1880. Most cultivars are of English origin. There are three varieties: Citronella has one inch orange-yellow flowers; "Emily McKenzie" has two and one half inch deep orange flowers each with a crimson throat; Solfatare has one and one half inch golden yellow flowers. They grow well in our zone seven and I leave the corms in the ground over winter but close to my house foundation.

They get the morning sun and have been beautiful every July for over 18 years; every year they come back and they do not need dead-heading. The flowers are followed by attractive seed capsules that look good with sword-shaped foliage. It is one of my favorites and one loved by the hummingbirds.

I suppose all of you serious vegetable gardeners are reaping the harvest of all your hard work and well you should. Yes, gardening is a lot of tending, watering, weeding, spraying and fertilizing but well worth the effort. I planted about five different tomato plants in huge buckets and they have produced more tomatoes than I could use. I have many friends who love my extras. When the days are very hot I find that I have to water them every day as the soil tends to dry out quicker in my containers. My favorite tomato is a red, Brandywine Heirloom, a large tomato – great for BLTs, followed by Big Boys. The cherry tomato plant which is called Sweet Million (given to me by a local greenhouse owner) is the most prolific producer of delicious cherry tomatoes I have ever experienced. It has produced over 100 tomatoes so far, and more are coming.

Well, enjoy the rest of your summer, stay cool, and Happy Gardening.

For Art's Sake

Dali combines dream with reality

One of the most fascinating artists of our time is the Surrealist, Salvador Dali. His unique paintings, combining dream with reality (the hallmark of Surrealism), are housed in museums and institutes around the world. Dali described his art as "hand-painted dream photographs."

Born in 1904 in Figueres, in Catalonia, Spain, Salvador Dali was influenced by his atheist father and devout Catholic mother who encouraged his artistic abilities. He attended the San Fernando Academy of Art in Madrid but was expelled for declaring his teachers unfit to judge his art, setting the stage for his eccentric and bizarre lifestyle. Dali met Andre Breton, a leading figure in the Surrealist movement, which embraced not only the visual arts but also music, literature and film. In 1925, he had his first solo exhibition. The Surrealists eventually dropped him from their group for his refusal to support their political views and his embarrassing behavior.

Recognized by his flamboyant mustache with its slender tips curled up-

ward to the level of his eyebrows, Dali loved to shock people at art openings and parties by his outlandish outfits, including brassieres and wetsuits. He is quoted as saying, "Each morning when I awake, I experience again a supreme pleasure – that of being Salvador Dali."

In 1929, Dali met Elena Diakonova, known as Gala, who managed the business side of his career and who eventually became his wife. Because of the upheaval in Europe in the 1940s during WWII, Dali and Gala moved to the United States. New York welcomed him as the Museum of Modern Art (MOMA) mounted a retrospective of his work. He also ventured into the film industry, working with Alfred Hitchcock on the movie "Spellbound" and with the Walt Disney Studios.

As Dali's interests expanded, his paintings began to reflect science, space and religious themes. Although he mastered the techniques of Realism and the Old Masters, he embraced Cubism, admiring Picasso and Joan Miro. During this time, his classical period, he exhibited around the world and was given one of Spain's highest honors, the

Grand Cross of the Order of Isabella the Catholic. He began work on his museum in Figueres, the Teatro-Museo Dali, which opened in 1974. Dali continued to paint throughout the 1980s and died in 1989 at the age of 84.

The museum in Figueres is a red building studded with models of bread loaves. The roof is adorned with giant eggs and goddess-like figures holding baguettes. It houses the largest collection of major works by Dali, including many entertaining installations such as The Mae West Room. In the center of this space is a voluptuous red sofa in the shape of lips. On the rear wall are two

paintings of cityscapes that represent the eyes. At the other end of the room is a viewing stand under an arch covered with blond hair. As one looks out at the room from this platform, the face of Mae West comes into view.

Salvador Dali continues to be admired in this century. In September 2015, Princeton University will publish the 150th anniversary edition of Lewis Carroll's "Alice's Adventures in Wonderland" with illustrations by Dali. His most famous painting, "The Persistence of Memory" with its melting clocks in a barren desert, can be seen at the MOMA in New York City.
