

CRL CALLS FOR FIRING OF FAIR LENDING OFFICIAL

FOR USING THE N-WORD

(TriceEdneyWire.com) - Recent and stunning disclosures of racially-offensive writings by a high-ranking official at the Consumer Financial Protection Bureau (CFPB) has unleashed an escalating barrage of criticisms, including calls for the official to be fired and more probing questions regarding the agency's commitment to fair lending.

Since a September 28 Washington Post article first reported how Eric Blankenstein, CFPB's Policy Director for Supervision, Enforcement and Fair Lending, used a pen name in blogs dating as far back as 2004, a spate of fury has been unleashed. Disguising his authorship, Blankenstein claimed that the use of the N-word was not racist, and further alleged that most hate crimes were hoaxes.

A subsequent New York Times article alleged that people who perpetuated the Obama birther conspiracy are not racist either, and noted that as late as 2016, Blankenstein's personal Twitter account posted racially charged com-

Keep in mind that Blankenstein was hand-picked by CFPB head Mick Mulvaney. Patrice A. Ficklin, a CFPB career staff member and Director of its Office of Fair Lending and Equal Opportunity reports to Blankenstein and is quoted in the Post article.

Ficklin said, "And while he has been collegial, thoughtful and meticulous, I have had experiences that have raised concerns that are now quite alarming in light of the content of his blog posts experiences that call into question Eric's ability and intent to carry out his and his Acting Director's repeated yet unsubstantiated commitment to a continued strong fair lending program under governing legal precedent."

By October 1, Anthony Reardon, National President of the National Treasury Employees Union, advised

The unfulfilled power of the Black vote

(TriceEdneyWire.com) or decades I have been hammering home the point that in a low voter participation environment, the group that effectively educates, mobilizes and organizes its voters to turn-out on election day will wield power disproportionate to its numbers in the overall electorate. Put another way, a relatively small group that registers and turns out a high percentage of its potential voters will exercise greater influence than a much larger group that fails to register and turn-out a high percentage of its potential voters. This is a Daniels political axiom. And, as Frank Watkins, Advisor to Rev. Jesse Jackson puts it, "an organized minority is a political majority."

The United States has the lowest voter participa-

tion rate of any of the western democracies. I have suggested somewhat facetiously that the biggest political

party in the U.S. is not the Democrats or Republicans but non-voters. A voter turn-out in this country in the range of 50-55% of the eligible electorate is hailed by political commentators as spectacular. This is absolutely abysmal when compared to western democracies where voter turn-out is routinely 80% or better. But, the reality of this low voter participation environment creates a major opportunity for Black voters to exercise power disproportionate to our numbers in the electorate. We may be out-numbered by Whites, but a large percentage of Whites don't bother to vote. It is not by accident that Republicans are openly implementing polices to suppress or disenfranchise Black voters. They fear the Black vote. The forces of reaction realize that if Blacks maximize voter registration and mobilize/organize large voter turn-outs, it is a threat to their retrograde agenda.

Rev. Jesse L. Jackson has relentlessly urged Black folks to register and vote in massive numbers to maximize our political power. At a session during the recent Congressional Black Caucus Foundation's Annual Legislative Conference, he shared data that illuminates the unfulfilled power of the Black vote. He noted that there are still 8 million Blacks who are not registered to vote, 4 million in the South. In 2016 some 2.5 million Blacks, who were registered, failed to vote in an election which was determined by less than 100,000 votes total in key battleground states with a large concentration of Black voters! Rev. Jackson's point is that a potent key to political resistance and transformation is in Black hands, the ballot. The challenge is to organize/mobilize and turn-out the unorganized, Black people who, for whatever reason, do not believe that voting matters as a means of

changing their lives. There is increasing evidence that a new generation of Black leaders, particularly women and young people. understand the potential of the Black vote as foundational to coalitions that can beat back the conservative tide of Trumpism by advancing people-centered, progressive policies. Stacey Abrams has an excellent chance to become the first Black Governor of Georgia by educating and inspiring hundreds of thousands of unregistered, "improbable" Black voters to register and turn-out in massive numbers on election day. Ben Jealous has launched a grassroots campaign to employ the same formula in Maryland. The polls in Boston showed Ayanna Pressley trailing long term Congressman Michael Capuano by 10 points among "probable" voters in the Democratic Primary. She won by more than 10 points because she organized/mobilized the unorganized; the improbable voters showed up in massive numbers as the anchor of her progressive coalition.

Rev. Jackson points out that in Florida Andrew



The letter was signed by Senators Richard Blumenthal (D-CT), Cory Booker (D-NJ),

Sherrod Brown (D-OH), Maria Cantwell (D-Washington State), Kirsten Gillibrand (D-NY), Kamala Harris (D-CA), Edward Markey (D-MA), Catherine Cortez Masto (D-NV), Jack Reed (D-RI) Mark Warner (D-VA), Robert Menendez (D-NJ), Elizabeth Warren (D-MA), and Ron Wyden (D-OR).

ADAMS, BUTTERFIELD BLAST **KAVANAUGH CONFIRMATION**

Both North Carolina African-American Congress members, Representative Alma Adams (D-NC-12) and Representative G. I. Butterfield (D-NC-1), blasted their Republican colleagues in the U.S. Senate after the confirmation Saturday of U. S. Circuit Court Judge Brett Kavanaugh to the U.S. Supreme Court.

"The confirmation of Judge Brett Kavanaugh to the Supreme Court will forever be a dark stain on our nation's history," said Congresswoman Adams in a statement. "His confirmation has further divided our country, and it is a profound threat to our progress and our values. Most alarming, Kavanaugh's confirmation is a blatant disregard to the suffering experienced by survivors of sexual and domestic assault and abuse. President Trump and Senate Republicans once

again put their party before the American people," Rep. Adams added. "Washington is broken, but the people have the power to fix it."

The Senate confirmed Judge Kavanaugh, 53, Saturday after a weeklong FBI investigation into allegations made by Dr. Christine Blasey Ford that, as a teenager, Kavenaugh sexually assaulted her while drinking.

Kavanaugh vehemently denied the charge during Senate confirmation hearings two weeks ago after Dr. Ford testified to the Senate Judiciary Committee, holding firm to her contention that Kavanaugh did it.

"The confirmation of Judge Brett Kavanaugh to the Supreme Court is the disturbing culmination of a longtime conservative legal movement and a Republican majority so hell bent on advancing their agenda that they rammed through a Supreme Court nominee amid disturbing allegations that have yet to be fully addressed or investigated

his judicial temperament," stated Rep. G. K. Butterfield (D-NC-1)

"In moving forward with a confirmation to a lifetime seat on our nation's highest court, there should not be unresolved questions surconduct or his judicial temperament. The sexual assault allegations brought forward by Dr. Blasey Ford and others against Judge Kavanaugh and the partisan fury he displayed at last Thursday's hearing raise very serious questions about Judge Kavanaugh's honesty, temperament, and ability to be an impartial justice."

"I am extremely disappointed in the Senate's decision to confirm Judge Kavanaugh's appointment to the Supreme Court," Rep. Butterfield continued. Now more than ever, our country needs a Supreme Court justice who will rise above ideology, protect the rights of all Americans, and

and serious questions about checks and balances by stopping presidential abuse of executive power. Unfortunately, nothing in Judge Kavanaugh's record or past has shown he will be such a justice."

Justice Kavanaugh was sworn in immediately after rounding a nominee's past the Senate confirmation vote Saturday. Pres. Donald Trump, who nominated the Maryland native to the High Court, apologized to him and his family for the partisan firestorm that ensued after Dr. Ford's allegations were made public and after former college classmates of Kavanaugh came forward to confirm that they have seen him drunk as a student.

> With Kavanaugh's confirmation, President Trump now has a conservative majority on the U.S. Supreme Court that will, more than likely, rubber stamp his policies if they are legally challenged there.

He is also expected to join the court's conservatives in beating down affirmative action, a woman's right to preserve our system of choose, and gun control.

Health of rural economies, people affected by coverage gap

CHAPEL HILL, N.C. - North Carolina's rural communities are paying the price for the state's decision not to expand Medicaid, according to a new report by the North Carolina Rural Health Research Program and the Georgetown University Center for Children and Families.

The report says states that expanded Medicaid saw more than three times the rate of decline in the uninsured adult population in rural areas.

Beyond that, John Coggin, director of advocacy for the NC Rural Center, says the economies in those communities are also impacted.

"One of the foundations of a healthy rural economy is a healthy rural health sector," he points out. "It's important to make sure we have a healthy workforce, but the jobs the health sector provides are also good paying jobs."

Prior to the Affordable Care Act, rural parts of North Carolina had a 35 percent rate of uninsured people, and that currently sits at 29 percent.

Comparatively, Arkansas, which did expand Medicaid, saw its uninsured rate drop from 45 percent to 22 percent.

Some states haven't expanded Medicaid because they fear being stuck with the costs if the federal government pulls out.

But study co-author Joan executive director of the Georgetown University Center for Children and Families, maintains states like North Carolina should expand, nonetheless.

"And this is sort of the fundamental issue with keeping folks uninsured when there's a real option here on the table to take these Medicaid dollars," states. "Really, it's a wiser use of taxpayer dollars to provide them with the primary preventive care that comes with having health insurance up front, so they don't get sicker and wind up in the emergency room."

So far, at least five rural hospitals have closed in the state since 2010, which Coggins says affects the quality and availability of care for everyone.

"That is money that not only would help hospitals pay for their current costs, but help

tempt for senators - yet Republican senators, led by Chairman Charles Grassley, no longer have any institutional pride. The Senate be damned; they are purely into tribal partisan poli-

They stuck with Kavanaugh because they know who he is. He claims to be an "originalist" and "textualist" who only applies the Constitution, but that is simply a threadbare cover. He was vetted and approved by the Federalist Society and the Heritage Foundation - both dedicated to promoting activist right-wing lawyers who will overturn precedent to serve conservative ends.

Kavanaugh's ascension to the court locks in a five-person majority for an extreme activist position. We've already seen what the conservative gang of five is prepared to do. They ignored unanimous Congressional intent to gut the Voting Rights Act. They overturned decades of precedent to empower corporations to pour money into elections. They trampled precedent to gut the ability of public employee unions to collect dues from the members they represent.

The threat Kavanaugh poses to Roe v. Wade, and a woman's right to control her own body is clear. Less attention has been paid to his consistent effort to protect corporations from accountability. When faced with a choice between the polluter and the poisoned, Judge Kavanaugh stands with the polluter. When faced with a choice between the boss and the worker, he stands with the boss. When faced with a choice between a predator corporation and a consumer, he stands with the

Public Citizen did an analysis of Judge Kavanaugh's opinions on the U.S. Court of Appeals in cases where the court was divided. They found that nearly 9 of 10 times, Kavanaugh ruled against the public interest and for the corporate interest. In 17 cases involving worker rights, he stood with the employers 15 times. In 13 cases on the environment, he was with the polluter 11 times. In 22 cases between corporations and consumers, he stood with the corporations 18 times. On seven cases involving police abuse or human rights, he ruled against the victims in all seven.

In the Senate hearing, Kavanaugh vowed to have a partisan frame. Blaming Democrats for challenging his nomination, he pledged that "what goes around comes around."

The right wing has consolidated a majority on the court. It is a gang of five that is increasingly out of step with a societv that grows more diverse, more inclusive, and is increasingly challenged by corporate corruption, big money politics, obscene inequality and catastrophic climate change. The gang of five is likely to stand in the way of fundamental reforms vital to this country.

The only thing that can save Democracy is the democracy. Even the Supreme Court responds to election returns. If Trump Republicans remain in control of the Congress and the White House, the gang of five will be emboldened. If voters rebuke them at the polls - if they elect progressive majorities focused on the changes we need - the gang of five will be

Judge Kavanaugh is probably impervious to the will of the people, too bitter, too ideological, too zealous to be reached. But Chief Justice John Roberts and perhaps Neil Gorsuch may understand that their own legacy and the court's legitimacy will be at risk if they try to defend the rich and corporations from a people demanding justice. Our task is clear. Don't mourn, organize.

With this appointment, the Senate has traduced its reputation and abandoned its responsibilities. Now it is time for the people to speak.



As I watched so many white women being arrested in Washington, DC in support of the rights and treatment of women, I couldn't help but wonder if they could relate to how my ancestors have felt since they were brought to this country against their will and treated as less than human. I wondered if this concern for humanity would last after the Kavanaugh decision is finalized.

As I watched those five elderly white Republican men stand behind the microphone on Capitol Hill with angry and self-righteous words with a "How dare anyone question what we are doing?" attitude, I couldn't help but wonder what this means for the country many of us have tried so hard to see as fair and concerned about all of her citi-

I've heard the ACLU speak out against Judge Brett Kavanaugh. We have seen the American Bar Association withdraw its support after seeing a raging performance from the man who wants to be on the Supreme Court. We've seen the National Council of Churches call for the withdrawal of the nomination of Kavanaugh for a position on the Supreme Court. At one time, we would welcome something going to the Supreme Court. but Kavanaugh's performance has made that thought a scary one for any of us who spend our days seeking justice. His activism brought him to the attention of

Dr. Martin Luther King, Jr., and he served Dr. King for years before his assassination. From then, Rev. Jackson founded and led Operation Breadbasket, the Rainbow Coalition, and the Rainbow/PUSH Coalition. Along the way he ran for President twice, gaining millions of multiracial votes and enough support to provide him with significant influence on Democratic plat-

forms. One of the most important things about Rev. Jackson is the way that he empowered others. When I listened to the "Colored Girls" - Minyon Moore, Yolanda Caraway, Leah Daughtry and Donna Brazile - speak their truth at the National Museum of African American History and Culture on October 1, I was reminded that Jackson has been pivotal in the lives so many African American political figures.

We can call the roll, and

name names, but I won't do that for fear of leaving someone out. What I will say is that there would be no President Barack Obama there were not Shirley Congresswoman Chisholm who ran for President in 1972, nor a Rev. Jesse Louis Jackson, who ran for President in 1984 and

Jackson changed the way that African American people saw ourselves politically. Before him, we thought we could not make a difference. Because of him, we know that we can. Before him, we did not believe, in his words, that "the hands that picked peaches could Presidents". Because of him Stacy Abrams is a possible winner (if we vote) as governor of Georgia; Andrew Gillum is a possible winner as governor of Florida, and unlikely candidates for Congress are poised to win.

Thanks to Rev. Jesse Jackson, African American people claimed political audacity. We don't have to wait our turn, follow the rules, and defer to the status quo. We can, like Ayanna S. Pressley, Alexandria Ocasio-Cortez and Lucy McBath, just buck up against the system and decide to do it our way. We don't have to climb up the ladder of a broken party system, or wait for the blessing of the Democratic Congressional Campaign Committee. Instead, we can step out when the time is right and the possibilities are there.

Nearly 45 years after his historic run for President, engaged in multiple fights. He is fighting for social and economic justice, as he always has, ever since he defied library protocol and insisted on his right to have access to a taxpayer funded public library. He is fighting police brutality and the unnecessary murders young black men like Chicago's own LaQuan McDonald. He is fighting for young people to thrive in a nation that is biased against them. And he is in the personal fight of his life, fighting Parkinson's disease as passionately as he fights injus-

Those of us who know Rev. well are excited by his good days, and concerned by the days that are not so good. We see the occasional slowed gait, shaking hands and slurred speech, but we also see the days when his rhetorical representation is as excellent as it ever was, and then we cheer.

We know that this is an indefatigable leader, one who will be no more slowed by a physical impediment than he has been by structural racism. And so we cheer whenever we see him stand up, whether he is standing on his own might, or whether he is assisted. We cheer the long and fruitful life of a civil rights icon who has made the world better for so many people, and opened the door for hundreds of African American politicians.

I am writing this from a profoundly biased space. I met Rev. Jackson nearly 50 years ago, when I was an

Rev. Jesse Louis Jackson is Essence Magazine intern supervised by Chicagoan Leniece Taylor, who was a friend of Rev. Jackson's. I've been connected since then, as a delegate in 1984, a campaign surrogate in 1988, a family friend, and most recently President PUSH/EXCEL the education arm of the Rainbow/PUSH Coalition.

I could not have been more delighted than when the Congressional Black Caucus Foundation bestowed Rev. Jesse and Mrs. Jacqueline Jackson a lifetime achievement award, both because they deserve it, but also because Mrs. Jackie doesn't often get the recognition she should get as "the wind beneath his wings". I'm biased, y'all, and that's just that.

Our icon, our leader, is celebrating another birthday, and that's a great thing! He is fighting, as he always has, injustice; but he is also fighting Parkinson's. And he is not yielding space in either fight. If you appreciate Rev. Jackson as much as I do, let him know! will begin by admitting I am not and never have been a Bill Cosby fan. He turned me off with the somewhat smug attitude he displayed toward low income Black folks. Also, though I have long been a strong supporter of more honest portrayals of Black folks on television programs and in movies, I was not impressed with what I considered the syrupy sweetness of The Cosby Show.

Like many Black folks, I am tired of seeing us always portrayed in films, television and at panels, workshops and conferences mainly as "the problem with the Black this, the problem with the Black that, the crisis of the Black this, the crisis with the Black that." An individual and a group of people will not make progress with that kind of 'woe is us" attitude.

However, we also won't make progress if we see our-

selves in the kind of fantasy land so often shown on The Cosby Show. We need to see ourselves as a strong group of people who have made a life

tile toward us as a group. That being said, I must state

that no one

will convince me that, in the 1970s, 1980s and 1990s in this country, White women had no one they could turn to for help when sexually assaulted or abused by a Black man, even one as prominent as Cosby. Throughout this country's history, several thousand Black men lynched, brutalized and incarcerated as a result of sexual charges made by White women. A White

woman may

involved in a consensual sex relationship with a Black man, but if that was found out, she would often yell rape and he was done for. If she didn't do that, male members of her family would force her to say she was raped to save their family's face.

Lynching and castration may not have been rampant, in the years of Cosby's foolishness in believing that he could do the same things as the big time White boys, but it is impossible for me to believe that those women couldn't find anyone in the country who would listen to or believe them if they had accused Cosby of sexual assault. Most press organizations would have jumped all over such charges with wall-to-wall coverage. I will not speculate as to why they didn't go public accusations their against Cosby. But I repeat that not having anyone who would listen to or believe that many women is unimaginable in the United States of America then and now.

By the way, there's little, if any comparison between their situation and that of Anita Hill. Justice Clarence Thomas was lucky that the charges against him were made by a Black woman. If Anita Hill had been White, he would never have been appointed to the Supreme Court. Throughout this country's history sexual crimes against Black women by White men and even by Black men have never been treated as ferociously by the so-called justice system as sexual crimes against White women.

That is another reality of U.S. history. If Cosby had been accused by Black women, he wouldn't be in the trouble he's in today. That's the real deal.

Constitutional right to counsel is meaningless under dismal current Public Defender System

"Reason and reflection require us to recognize that in our adversary system of criminal justice, any person hauled into court, who is too poor to hire a lawyer, cannot be assured a fair trial unless counsel is provided for him. This seems to us to be an obvious truth ... From the very beginning, our state and national constitutions and laws have laid great emphasis on procedural and substantive safeguards designed to assure fair trials before impartial tribunals in which every defendant stands equal before the law. This noble ideal cannot be realized if the poor man charged with crime has to face his accusers without a lawyer to assist him." – U.S. Supreme Court Justice Hugo Black

t's familiar to anyone who's ever watched a cops-and-robbers drama on television or in the movies: You have the right to an attorney. If you cannot afford an attorney, one will be provided for you at public expense.

It's enshrined in the Sixth Amendment to the U.S. Constitution: "In all criminal

prosecutions, the accused shall enjoy the right to ... have the Assistance of Counsel for his

Despite this constitutional mandate, poor defendants who could not afford lawyers to represent them were not guaran-

teed representation at public expense until 1963, thanks to defendant named Cla-Earl rence Gideon. Con-

victed of burglary after having been forced to act as own

lawyer, Gideon studied the law in prison and appealed to the Supreme Court. The landmark decision resulting from his case, Gideon v. Wainright, required states to provide an attorney to defendants in criminal cases who are unable to

afford their own attorneys. In the 230 years since the ratification of the constitution, and more than a half-century since Gideon v. Wainright, the United States has failed miserably in its duty to guarantee equal justice to rich and poor alike. The public defender system is broken, leaving thousands of poor detainees stranded in local jails unable to raise enough money under discriminatory cash bail policies - waiting months or even years for a overworked desperately lawyer to be assigned to his or her case. The system forces innocent men and women to plead guilty, just to get out of jail and return to their families and their jobs.

In Missouri, which ranks near the bottom for public spending on defending the poor, the desperate head of the state public defender office appointed Governor Jay Nixon to represent an indigent defendant. Nixon had vetoed legislation to cap caseloads for Missouri's public defenders, who average 240 cases each per year.

Nixon fought the assignment and won but the point had been made. According to the National Association for Public Defense, public defenders are handling three to five times as many cases as they can reasonably handle competently. The American Bar Association has been referring to public defender workloads as a crisis for

more than 30 year. New York State has taken

steps to reform its public defender system. A new law authorizes the state's Office of Indigent Legal Services to establish and uphold standards that address the presence of counsel at a criminal defendant's first court appearance; reasonable limits on the defenders' caseloads; proper training, supervision, and support staff for attorneys; and access to resources needed to mount an effective defense. While the legislation leaves counties responsible for funding public defenders, the state will reimburse cities and counties for the cost of complying with the new stan-

Funding to defend the poor is an easy target for cashstrapped local governments, but in the process of budgetcutting, we diminish our integrity as a nation committed to justice. Constitutional guarantees are meaningless if we are unwilling to base our public policy on our highest ideals.

In search of decency and democracy

he debacle surrounding the nomination and confirmation of Brett Kavanaugh drilled a hole into what have been thought to be solid concepts and principles of decency and democracy.

While much of what is happening seems to be a backlash against the presidency and polices of Barack Obama, the role of blatant white male supremacy cannot be overstated.

It began on former President Obama's inauguration day in 2009. Reports revealed that a group of white Republicans, including Reps. Eric Cantor (Va.), Kevin McCarthy (Calif.), Paull Ryan (Wis.), Pete Sessions (Texas), Jeb Hensarling (Texas), Pete Hoekstra (Mich.) and Dan Lungren (Calif.), along with Republican Senators Jim DeMint(S.C), Jon Kyl (Ariz.), Tom Coburn (Okla.), John Ensigh (Nev.) and Bob Corker (Tenn.) met,

along with Newt Gingrich. Neither Sen. Mitch McConnell or John

Boehner, the House Minority Leader, were there. Democracy had worked. The people had voted in some of the highest turn-out numbers in history, and the white male powerbrokers were furious. They were bound and determined to "take their country back" from someone they deemed to be unfit and unqualified to be president of the Rev. Susan United States. They wanted the "White House" to be "white" in every way, and they worked hard to K. Smith figure out how to get what they wanted.

> Though many of the Republicans did not take the campaign of the current president seriously,

once he was elected, they opted to throw their support behind him. It did not matter that he lied about nearly everything, that his words indicated that he had no respect for black or brown people, for women, or even the masses of American people. He identified a base of angry white people whose complaint was that they had been badly treated, largely due to the "special treatment" given to blacks, browns, LGBTQ, and women, and he fed their anger on a daily basis.

It was astounding that no matter how crass he was, or how rude, or how much he lied, his base stuck to him like syrup, and he knew it. He knew that all he had to do was stoke their fear which would agitate their anger, and he would be able to do what

His entire presidency has concentrated on satisfying the very wealthy and the very poor white, uneducated base. He began to dismantle as much of what Obama put in place as he could, and continued to let his base know that it was "the Democrats" who were to blame for their misery.

Even as the investigation of the Russian interference into our elections continued, with the president railing against it every step of the way, this man worked to get his agenda addressed and completed. He did as much as he could to dismantle the Affordable Care Act, he undid as many of the regulations put in place by the former president to protect the environment, frankly, the interests and needs of the masses of American people, he passed a tax cut for the wealthy which has thrown this country's deficit off the charts, and he worked steadily if quietly to overhaul the federal court system.

Everyone knows about the charges of sexual impropriety that have been leveled against him, but they do not care. In fact, his supporters have energized him as they have been willing to ignore his indiscretions, with some calling his presidency "sent" by God and calling for his forgiveness.

He has been wily and intentional. His nomination of Kavanaugh seemed to be the perfectly choreographed movement of a ballet that began during his campaign. He would fix the US Supreme Court, he promised. Ignoring the anger about the antics of Mitch McConnell, who refused to let Merrick Garland, the nominee of Barack Obama, even get a hearing, he nominated Neil Gorsuch and Brett Kavanaugh, both confirmed. While Gorsuch's nomination went smoothly, everyone has been affected by the lack of decency and respect of American democracy that we saw in the effort to get Kavanaugh on the nation's highest court.

They ignored and ridiculed the report of sexual misconduct leveled against Kavanaugh, angry that the report of the incident came so late in the confirmation process. They were right to say that it was political, but they failed the decency test as they in essence decided that Dr. Ford was somehow troubled and did not know what had happened to her and by whom. It was not beyond the pale of belief to assume that what Kavanaugh was accused of doing had in fact happened; high school and college boys and men have done what Dr. Ford described from the beginning of time. The Republicans - including Sen. Susan Collins (R-Ma) showed little to no decency in how they as a group dealt with her.

But even more disturbing is that the Republican senators ignored the behavior of Kavanaugh during the hearings on the Ford sexual impropriety issue. His emotional outburst, his apparent lying about what he did, his disrespect of the Democrats on the Senate Judiciary Committee revealing his raw partisanship should have been the red flag for men who know what America's democracy is supposed to be about. The Judicial Branch of the federal government is supposed to be neutral, non-partisan, and independent of the other two branches of government. Even if it once was (which is doubtful) there can be no doubt that with Kavanaugh on the bench, the suggestion of non-partisanship is ludicrous.

Democracies fail. Four of the tell-tale signs that a democracy is in decline are 1) rejection of the democratic rules of the game, 2) denial of the legitimacy of political opponents, 3) the toleration of encouragement of violence, and 4) a readiness to curtail civil liberties of opponents, including the media. (From How Democracies Die by Steven Levitsky and Daniel Blatt)



fine droplets of water or particles of ice dispersed in the atmosphere above the earth's surface. They are at various altitudes, ranging up to several miles above the earth. They become visible masses in the air, as of steam, smoke, or dust.

Perhaps, we recall hearing our parents, over and over

again, calling us early in the morning to get out of bed and make the final preparations to get ready for school. We recall, many times, observing clouds in the sky, sometimes white fluffy clouds, floating against the blue background of a morning sky. Most of the time, such clouds are rain (storm) clouds and precede some form of stormy weather.

There are some of us who may recall that, many years ago, early in the morning, our parents would call, "It's time to get up." It would be our signal to get up, get breakfast, and get ready to go to work. Some worked at the fish factory; some worked on the farms, picking cotton, digging potatoes, picking peanuts, etc. Others would get up and get an early start gardening. It was necessary to do whatever jobs were profitable

to support our families. Some families gardened and raised their own produce (fruit and vegetables). Some farmers raised poultry (chickens, turkeys, etc.) and livestock (hogs, cows, etc.).

I have always loved the outdoor life and never outgrown my love of spending time outside. I also love helping other people and enjoy spending time with others in the great outdoors. I like to go walking. As I walk, I spend time thinking of how we can help each other be the best we can be. One thing that often captivates my attention is how bleak the future seems to be for so many of our young Blacks, particularly our young men. It seems that all the "system" knows to do with them is put them into the jails and prisons. The judicial system and the "powers that be" seem to believe that's the place them all. "Throw them into jail and throw away the key." That seems to be the order of the

day, but I don't believe this is the answer for all of our problems. I think we would be better served to offer more counseling. Many of them are just looking for their place in this society, trying to find a way to live in comfort and peace.





Homeowner Bill of Rights: Protecting families from life's financial storms

In recent weeks, multiple news sources have reported on the 10-year anniversary since the onset of the nation's foreclosure crisis. Between 2007 and 2011, 10.9 million homes went into foreclosure, with 8 million completing that process. Additionally, \$1.95 trillion in lost property value affected both families who lost their homes to foreclosure, as well as their nearby neighbors who remained

It took years of advocacy California before the Assembly passed the initiative. At the urging of consumer advocates and the former state Attorney General Kamala Harris, the HOBR gained support from civil and consumer groups. Borrowers, lenders, workers and advocates all agreed the legislation was fair and responsible to improve the foreclosure tsunami.

For consumers, however, the most heralded legal provision, included the right to have their own day in court. If mortgage servicers did not comply with the law, borrowers could sue and seek finan- ly for owners who have been cial redress. Borrowers were also assured of timely notification on the status of their loan modifications and gained the right to appeal modification denials.

Unfortunately, as much rights organizations, banks, legislation affords, "sunsets", requirements expire, took the real teeth out of HOBR since 2017. Such times are also the moments when leadership can emerge and replace what was lost.

San Jose's State Senator Jim Beall, who also chairs state's Senate the Transportation and Housing Committee, sponsored a 2018 HOBR that restored the previously lost provisions. Moreover, on September 14, California Governor Jerry Brown signed the new bill into law.

Beyond restoring the right to appeal a loan modification denial, the updated bill also resurrects:

servicers provide homeowners with written notices to confirm receipt of their loan modifications applications and whether any necessary application items are missing; and.

•Requirements that servicers send written denial notices with sufficient information and sufficient time to

appeal a questionable denial. "Californians can once again count on the protections that helped thousands of homeowners hold onto their houses during the 2008 financial crisis," noted Sen. Beall. "Lenders will have to provide timely notifications on the status of a loan modification application and homeowners will have the right to appeal denials."

For Graciela Aponte-Diaz, California Policy Director the Center for Responsible Lending, the 2018 bill reinstates safeguards to help families stay in the homes.

"Foreclosures have rattled our housing market, especialhit hard by natural disasters," said Aponte-Diaz. "Homeowners need protection against procedural abuses - this bill helps us accomplish that goal."

Today, consumers in Minnesota and Nevada have

other locales where billiondollar property losses were suffered due to recent storms or wildfires would be wellserved if their respective states also implemented their own HOBRs. In just the past year, locales as diverse as Arizona, Florida, Carolinas, and Texas have also suffered tremendous losses and will need years to fully recover financially.

The bottom line is that whoever you are or where you live, housing is needed. At a time when most working families are dedicating an increasing amount of income to provide a home, it should •Requirements that loan be apparent that these homes deserve protection - not just from weather storms; but life's financial storms.

As former President Lvndon Johnson spoke in a June 4, 1965 address to Howard University:

"You do not wipe away the scars of centuries by saying: Now you are free to go where you want, and do as you desire, and choose the leaders as you please.

"You do not take a person who, for years, has been hobbled by chains and liberate him, bring him up to the starting line of a race and then say, 'you are free to compete with others,' and still justly believe that you have

been completely fair. "Thus is it not enough just to open the gates of opportunity. All our citizens must have the ability to through those gates."





televangelist, whose name I

sometimes strike at your very heart. He said, "In order for

someone to really hurt you, he or she has to be close enough to you, to kiss you."


