# **Analysis: Voter ID amendment too "costly"**

According to a new analysis of the proposed voter ID constitutional amendment which is on the North Carolina ballot now during early voting (Oct. 17 - Nov. 3), and on Election Day, Nov. 6, if passed by North Carolina voters by referendum, would not only be "...harmful to voters working for low incomes and poor voters of all races, while specifically targeting Black and Latino voters." Not only that, but it would unnecessarily cost all North Carolina taxpayers because "... state and county governments have to spend at least \$12 million on staffing polling sites, providing identification cards, and conducting the necessary voter education and outreach to ensure people are aware of the requirement."

That analysis is according to Alexandra Forter Sirota, Director of the N.C. Budget and Tax Center - a division of the NC Justice Center, a nonprofit progressive think tank

which publishes NC Policy Watch, an communities and voters of color, will online progressive newspaper.

Sirota makes the point that the millions of dollars that the so-called "voter integrity" amendment would cost if implemented, would be diverted from other critical state and local programs, like investing

in public schools, disaster recovery and funding search and rescue efforts, like the operations recently undertaken in the aftermath of hurricanes Florence and Michael.

"Such diversion of resources that are now more limited in our State because of successive tax cuts for the rich and big companies in order to block participation in the democratic process for some puts our State's economic well being at risk," writes Sirota in her analysis Monday, titled "Proposed Amendment requiring a voter ID is unnecessary and too costly.'

Sirota continued, "People across the Carolina, but particularly in rural

face high costs in obtaining a photo identification, even if the State provides an identification card without a fee. (It isn't even clear in the ballot language that they will do that much.) The costs alone of traveling, wait

times, and acquiring supporting documents are enough to detract from family priorities, like buying groceries, providing quality child care, or paying utility bills. Its impacts will ripple through communities in the near term."

Sirota concludes, "Every eligible voter should be able to participate in the democratic process with a vote and not be blocked because of cost."

Republican lawmakers and their conservative supporters say the proposed constitutional amendment to establish voter ID would ensure that the electoral process in North Carolina would be protected, but the amendment never spells out how.

Constitutional amendment to

require voters to provide photo identification before voting in person. FOR or AGAINST.

That's all the voter's ballot says. There is no explanation of exactly what kind of photo ID will be accepted and not accepted (will state-issued college IDs be accepted?).

Republican North Carolina lawmakers say that, if the amendment is ratified by North Carolina voters, they will call a special November session to come back and decide all the details they failed to lay out previous-

The NCNAACP counters that passage of the voter ID amendment before any legislation emanating from it can be examined and debated would be giving what would amount to a "blank check" to the very party that has been proven in the past to impose voter suppression and illegal racial gerrymandering of voting districts,

only to be struck down in the courts. The civil rights group sued in court to stop the amendment but failed. They are now actively campaigning against it.

# "The Trial of the Century" From a Black journalist's view

he "Trial of the Century" Chicago is over. No more morning rush hour drives to the courthouse and going through metal detectors. No more early morning reports on Chicago's iconic WVON radio station, called in from a musty parking garage across from a building where so many Black males have gone through and which too few bad

cops have stepped foot in. But for all the sacrifices and headaches of covering the murder trial of Chicago Officer Jason Van Dyke, it was worth it. Finally seeing a police officer led out of the courtroom left me speechless. Dressed in a black suit, he looked as if he was going to his own funeral. Only I, and a handful of Black clergy and activists in the courtroom, were not mourning. Silently, we were rejoicing.

It was a day many Blacks in Chicago never thought they would see. A white police officer found guilty of killing Laquan McDonald, a Black teenager, and locked up immediately after his historic conviction. For Black Chicago, it was the trial of the century, a moment they had been waiting for a long time.

For this Black journalist, it was history unfolding before my very eyes. It was a story that changed Chicago forever and the climatic ending was about to take place in courtroom 500.

I had a seat in the front row that was reserved for the media. Just yards away from Laquan McDonald's killer, I often sat on the edge of my seat.

For most of the trial, I sat next to Jamie Kalven. He's the prominent investigative journalist from the journalism production company the Invisible Institute, which first broke the

story that included the official autopsy report that McDonald had 16 bullet wounds in his body.

At 7:35 a.m. on Friday, October 5, I was on WVON to file my daily update of the trial. Tired from another grueling





**JUDGES: GOP-DEVISED** STATE ELECTIONS **BOARD** 

"UNCONSTITUTIONAL" [RALEIGH] The NC Board of Elections and Ethics Enforcement, statutorily created by the Republican-led NC General Assembly in 2017 and 2018, was unconstitutionally created, a three-judge panel has ruled. However, the board may stay in place until after the 2018 midterm elections. The legislature originally passed a law in 2016 to counter the fact that Gov. Cooper, Democrat, had just been elected. That law essentially took away his power of appointment to the state election boards. After that was challenged in court, GOP lawmakers passed two more laws to cut the number of board members to eight, but again, the courts say they had no right to do that. The elections board, by state Constitution. always allowed the party of the governor in power to have the majority of seats on both the state and county election boards.

However, one of the proposed constitutional amendments currently on North Carolina ballots would codify the GOP plan for an eightmember board. If that amendment passes, that will trump the court ruling.

#### **GOV. COOPER SIGNS BILL FOR \$800 MILLION** IN HURRICANE FLORENCE RELIEF

[RALEIGH] Gov. Roy Cooper Tuesday, signed legislation that will provide \$800 million in relief aid for those counties affected by Hurricane Florence in September. That is in addition to the \$56 million that was appropriated immediately after the storm struck. Homes and businesses throughout eastern and coastal North Carolina were destroyed by massive flooding and strong winds that blew down trees.

"I appreciate legislators responding quickly and taking this initial step to help North Carolinians recover from this devastating storm, particularly in the areas of education and the federal match," Gov. Cooper said in a statement. "However, we must continue to work together to provide more for affordable housing and farmers as well as to make real investments to ensure clean water and to lessen the impacts of future storms on our homes, roads, businesses and water infrastruc-

#### NC NAACP ASKS STATE **BOE FOR** "EMERGENCY" ACTION

IN IMPACTED COUNTIES [RALEIGH] The NC NAACP Chairman Andy Penry and Executive Director Kim Strach of the NC State Board of Elections and Ethics Enforcement, to immediately act in those counties negatively affected by Hurricane Florence to ensure that voters there are able to cast their ballots now that the early voting period has begun.

"These counties are home to a disproportionate number of African-American voters and to some of the highest numbers of North Carolinians living below the poverty line, Rev. Dr. T. Anthony Spearman, president of the NC NAACP wrote in an 16thletter."In the aftermath of this historic storm, North Carolinians in those counties are still struggling to put their lives back together and are exceptionally vulnerable to being disenfranchised '

Spearman requested that absentee ballots be allowed, and mobile early voting labs be deployed to hard-hit areas. "With swift action by the State Board of Elections, we can ensure that disenfranchisement will not be among the many hardships that North Carolinians will have to face in the aftermath of Hurricane Florence," he concluded.

week at the Leighton Criminal Courthouse, I called in to the radio station from my apartment in South Shore. My gut feeling was that Van Dyke would be convicted, which is what I had shared with the Chicago Crusader staff all week after watching Van Dyke contradict the video, himself and even his defense team on the witness stand.

That Friday I told the show's host Maze Jackson, there would be a verdict later that day. The only question was when.

I stayed in bed until 12:40 p.m. While I was in the shower, WGN Journalist Kelly Barnacle sent me an email saying the jury had reached a verdict. It would announced at 1:45 p.m.

I dashed out the door wearing flip flops, drove to the courthouse on the West Side and got inside the courtroom around 1:40 p.m. By then all the seats for the media had been taken. I tried to sit in the third row, where Van Dyke's wife, Tiffany sat. But a big white guy growled at me, saying I couldn't sit there, although there was room for three people.

I tried to sit in the back, but one of the court officers was called and told to sit with the media even though there were no more spaces available. Suddenly a television reporter made room for me on row two and put me right in front of Tiffany Van Dyke.

When the jury foreman on Friday, October 5 read the verdict that convicted her husband of second-degree murder for shooting Black teenager Laquan McDonald 16 times on October 20, 2014, I immediately looked Tiffany. Her face turned to gloom. She said nothing. In fact, the entire courtroom was eerily silent. William Calloway, the activist who helped force the release of the video, kept nodding as the jury foreman read "guilty" for each of the 16 counts of aggravated battery with a firearm.

So many years of pain had come to an end, but a new era had dawned in Chicago.

I couldn't believe it was happening, but it was. A justice system that for decades was viewed as broken by thousands of Blacks and minorities had finally worked and convicted a Chicago police officer of killing a Black teenager. My assignment was over, but an exciting moment for Black Chicago was just beginning.

It all happened because of Laquan McDonald, a Black teenager who in life was a ward of the state. In death, McDonald became a modernday Emmett Till (another Chicago teenager who was brutally killed in 1955 during a visit to Mississippi). Till's death helped spark the Civil Rights Movement, McDonald's sparked an effort among Black activists to clean up Chicago and changed the city forever.

happening, It's Chicago is finally on the brink of change that many have dreamed about since its first Black mayor, Harold Washington, was elected in 1983.

For the last four years, two rusty institutions, Chicago's City Hall and the Chicago Police Department, have been forced to finally change. It comes after a video was released showing McDonald's brutal murder in front of at least ten officers who did nothing to stop Van Dyke, but instead are accused of filing false reports to try to cover up the crime.

Contrary to the police video, Van Dyke also lied after the shooting, and lied on the witness Throughout the trial, he stood silent next to one of his defense attorneys, Randy Rueckart, but during closing arguments he had a smirk on his face throughout the proceedings. He looked creepy at times. At one point, he came behind me to speak to his

wife. I got the chills. But a jury saw through Van Dyke's smoke and mirrors and convicted Van Dyke anyway of second-degree murder, but with 16 counts of aggravated battery with a firearm. The convictions could put the murderer behind bars for the rest of his life if Judge Vincent Gaughan brings down the hammer at Van Dyke's sentencing on Halloween, October 31.

To Van Dyke and his family, it's a scary possibility. To Black Chicago, it's a just punishment for an officer who haunted Chicago the last several years as we watched the video of him ripping into McDonald with a Smith and Wesson 45 firearm. His name is Jason and unlike the Halloween film series, the killer with the badge won't be back for a sequel.

While the verdict was the

tainly the beginning of a new day for disenfranchised Blacks and minorities in Chicago. In addition to City Hall and the police department, the justice system in Cook County is finally showing some life too.

Which is why the guilty verdict of Van Dyke is so significant for Chicago and perhaps America.

In the most segregated city in America, all three Chicago institutions are on the cusp of experiencing unprecedented change like never before. For decades City Hall, the police department and the Cook County justice system were viewed as broken institutions that together, allowed police brutality and misconduct to run rampant in the city's Black and low-income neighborhoods.

Things slowly began to change in Chicago when McDonald's shocking death made headlines around the world. Police Superintendent McCarthy was fired, Cook County State's Attorney Anita Alvarez was ousted in the 2016 Democratic Primary and the mayor himself decided not to seek another term in office at the start of the Van Dyke trial.

Before his decision, the mayor tried to win back trust in the Black community by appointing Blacks in high positions and building new schools and bridges in the Black community.

The

Chicago Police Department, Chicago Transit Authority, Chicago Public Schools, Chicago Housing Authority and the Chicago Department of Water Management are headed by Blacks. Last month, the mayor appointed Richard Ford II to become the city's second Black Fire Commissioner in the department that for 160 years had been led by Irish and white leaders. Five of these leaders were appointed after the scandal broke. Often viewed as puppets of the mayor, they are now free lead for the people now that the mayor is leaving office. And with the city's mayoral elections just over four months away, Chicago may get its first Black female mayor.

William Calloway, the activist who got us to this point, is now talking about sweeping out the city's Black aldermen. According to an explosive exposé in the Crusader last week, many of the aldermen took thousands of dollars from the mayor less than a month before they approved a \$5 million settlement on April 15, 2015 for the family of McDonald.

In addition, the city has agreed to sweeping reforms in a new Consent Decree with Police Chicago Department after a scathing

end for Van Dyke, it was cer- U.S. Justice Report in 2017. The report said officers routinely used excessive force on Blacks and minorities and were rarely disciplined for misconduct. Since Emanuel took office in 2011, the city has paid at least \$280 million to settle police misconduct cases, many of which involve Black residents. In an investigation of 450 cases of police misconduct, the Chicago in 2016 Tribune found that city often fights to keep files secret during and after settlement talks with victims of alleged police brutality. The \$5 million settlement with McDonald's family was no different until the video broke the scandal wide open.

> In two years under Cook County's first Black State's Attorney Kim Foxx, 42 people have been exonerated years after they were convicted with the help of crooked cops Sergeant Ronald Watts and the notorious Jon Burge, who ironically died last month during the second week of Van Dyke's trial. Many of their victims are Black and poor.


Van Dyke's guilty verdict was the latest and perhaps most crushing blow to a system that stood tall for decades. Not only did it renew hope in a creaky criminal justice system, but it also sent a stern warning to bad cops in Chicago and across the nation that their time is up. And it may be a foreshadowing to another police misconduct trial that's set for November 26 in Chicago, involving three officers who are accused of falsifying police reports to cover up what I can now say was a murder.

Police shootings or killings in America have come and gone in the last five years. The officers who have gunned down Black males are back patrolling the streets while the names of their victims have faded: Michael Brown, Eric Garner, Tamir Rice, Freddie Gray, Alton Sterling and Philandro Castro. The list goes on and

They left behind sons, daughters, families and communities that will take a long time to heal. Their loved ones' killer, like many, are never charged with taking someone's life or rarely see a courtroom.

This summer, Officer Roy Oliver was sentenced to 15 years in prison after being convicted of murder in the shooting death of Jordan Edwards. The victim's family said the sentence wasn't enough.

Likewise, many felt Van Dyke should have been convicted of first-degree murder. But guilty on 16 counts of aggravated battery plus second-degree murder? I'll take that.



# Why you should vote "No" on all six admendments

You know, you have to give the Republican majority, and particularly the GOP legislative leadership in the NC General Assembly, credit.

They pretty much know that the good people of North Carolina have had enough of their legislative double-dealing, and sinister attempts at voter oppression aimed at African-Americans, so they've come up with a plan.

And it's a real doozy!

Realizing that they might not still be in power come 2019, the GOP has designed six broadly worded constitutional amendments that, if passed, would be almost impossible to remove.

You see, statutory laws are stricken from the books. All it takes is a simple majority vote of both the state House and Senate.

But a constitutional amendment is a special animal. The state constitution, according to Ballotpedia, is the "highest legal document for the state." It is our governing document, creating the structure and function of North Carolina governance.

In short, it's our state "bible."

Thus, it takes much more than a simple up-or-down vote to change anything per the state constitution. At least 60% of all the members of both the House and Senate have to put a submitted amendment to a statewide vote, which is why we've never seen six amendments proposed in one year before.

One or two, yes, but definitely NOT six.

But just because a state constitutional amendment is ludicrous on its face, doesn't necessarily mean that law-

makers can easily remove it. For example, and we didn't know this until we researched it, Section Four of Article VI of the 1868 North Carolina Constitution states that a person must be literate in the English language before registering to vote. The provision was used to deny African-Americans the right to vote then, and guess what - it's STILL in the state Constitution today.

Obviously, it is not being enforced today, but it remains because several attempts to

remove it have always fallen

Republicans know how difficult it is to remove anything from the state Constitution, which brings us back to six ridiculous constitutional amendments they've put forth on a ballot referendum for the November 6th elections.

If Republicans can get citizens to vote "for" these six proposed amendments, then all the GOP has to do is reconvene in Special Session right after the election, and pass laws based on the broad language of the amendments on the ballots - language so broad that Democrats claim is "misleading", allowing Republicans can get away always amended, or even with whatever, because voters will have voted to allow them

> For example, let's look at the proposed ballot amendment most civil rights activists, especially the NC NAACP, are concerned with NUMBER

> Constitutional amendment to require voters to provide photo identification before voting in person. FOR or AGAINST.

THAT'S IT! NO DETAILS! Republicans say if voters pass this, they'll fill in all the details later (like during that Special November Session they're planning Dangerous!

#### NUMBER TWO

Constitutional amendment to reduce the income tax rate in North Carolina to a maximum allowable rate of seven (7%).FOR percent AGAINST.

No one likes high taxes, but by that same token, no one wants to see state government go broke and not fulfill the basic needs of its citizens. Capping the income tax rate to just 7% constitutionally is a gift to the rich. But how many hurricanes and other disasters will it take to convince Republican lawmakers (since they've been in charge since 2011) that when disaster strikes, or the economy goes bad costing us jobs, or we fail to invest in our public schools, or cut services to our poor, all because we deliberately fiscally handcuffed ourselves so that no more revenue can come in when needed?

Setting the income tax rate

Democrats do take over in 2019, they CAN'T change it by themselves. Thus, it never gets changed.

THIRD **PROPOSED AMENDMENT** - taking the power to fill judicial vacancies away from the governor, and give that power primarily to state lawmakers. Why? So that they can handpick partisan judges who will rule their way, NOT according to the law or justice. And don't let the ballot language fool you. They may involve the governor in the process, but they have the last word!

**FOURTH** - Constitutional amendment to establish an eight-member Bipartisan Board of Ethics and Elections ANYONE seeking to outlaw Enforcement in Constitution to administer ethics and elections law. FOR or AGAINST.

Another "let's weaken the governor even more" attempt, taking his power to appoint members away, and eliminating the ninth member position (an unaffiliated member), and thus, allowing for a stalemate vote more times than not when it comes to election issues.

## Urban Reentry Jobs Program tapping into the full potential of formerly incarcerated community members

"I wasn't informed about the long-term consequences of my conviction before or after I accepted a plea deal for seven vears and eight months in 2004. It wasn't until my release in 2012 that I learned about the hidden sentence I would experience for the rest of my life. When I was released I had a plan to succeed, but little by little my plan crumbled. I couldn't become a welder, an auto body and paint technician or a barber. I couldn't even scrub toilets and mop floors at the local hospital. The more I tried to contribute to my community, the more I faced barriers." – Jay Jordan, Second Chances Project Director, Californians for Safety and Justice

he part of my job I appreciate the most is getting to know the exceptional men and women who have turned their lives around - after facing seemingly insurmountable challenges – with a helping hand from of the Urban League Movement.

Just last week in Chicago, I had the honor to meet two young men - one who has founded a thriving landscaping business, and another who is well on his way to a career as a commercial truck driver. These would be commendable achievements even for anyone

with a reasonable clear path, but for those emerging from incarceration, they are extraordinary.

The National Urban League has been serving the formerly incarcerated for more than

fifty years, only in the last few years with the support of the federal government. The Urban Reentry Jobs Program provides formerly incarcerated adults with the neces-

sary skills and training to successfully reenter the workforce and jobs at family-sustaining wages.

Through Adult Re-entry, a National Urban League signature program, the formerly incarcerated have an opportunity to earn industry-recognized credentials, learn employment-focused and form positive relationships with their communities.

Among the nearly 800 partic-

86% have earned a credential or certificate

95% did not return to prison 65% became employee

A 35-year-old father of three, Mario emerged from prison after eight years never having held a permanent legal job. He was living at a Salvation Army

before he found his way to the Chicago Urban League. After completing the Urban Reentry Jobs Program, Mario has graduated with high honors from the welding program at Kennedy-King College.

The need for initiatives like the Urban Reentry Jobs Program could not be more critical. As many as three out of four people remain unemployed a year after their release from prison, and just 12.5 percent of employers say they will accept job applications from the formerly incarcerated.

This burden falls disproportionately on America's people of color, who represent more than two-thirds of the incarcerated while comprising only about 24% percent of the population. African Americans are more likely than white Americans to be arrested; once arrested, they are more likely to be convicted; and once convicted, they are more likely to face stiff sentences. Black men are six times as likely to be incarcerated as white men.

No aspect of the criminal justice system has exacerbated the mass incarceration crisis more than the so-called War on Drugs, and none is more racialdisparate. African Americans are no more likely to use or sell prohibited drugs than whites, but they far more likely to be charged and sen-

tenced to prison for identical

conduct.

This crisis impacts not only the families of the incarcerated, but the nation as a whole. According to an ACLU report, the gross national product suffers an annual loss of \$80 billion a year due to employment discrimination against the formerly incarcerated. Not to mention the costs to local and state governments caused by recidivism: if states could lower recidivism rates by just 10 percent, they could save an average of \$635 million annually, according to Pew Research Center.

Millions of people leave prison to re-enter their communities each year. The Urban League Movement is committed to removing barriers to their full participation and helping every American to achieve his or her full potential. As civil rights attorney Michelle Alexander wrote in her seminal work. The New Jim Crow: Mass Incarceration in the Age of Colorblindness, "Martin Luther King Jr. called for us to be lovestruck with each other, not colorblind toward each other. To be lovestruck is to care, to have deep compassion, and to be concerned for each and every individual, including the poor and vulnerable.'

This is not about ideology nor the usual bloviations about "right" and "left." As an example, didn't Senator Lindsey Graham (R-SC) pull a Kavanaugh when he had an outburst during the Senate

Kavanaugh's outburst set a standard for outrageousness. When women of color raise their voice and lose their tempers, think Serena Williams at the US Open, they are vilified with hostile and racist cartoons coming from all over the world. 
# White supremacy is a terminal disease

The most recently reported incident - that of Teresa Klein calling the police on a nine-year-old African American boy whom she said groped her - cast a glaring light on America's sickness when it comes to the infestation of white supremacy in this nation. (https://www.nytimes.com/2018/10/12/nyregion/woman-calls-police-black-boy-brooklyn.html)

While this young boy - and his terrified little sister - sobbed in anguish, this woman threw her sense of superiority around and called the police. The little boy thought he was going to go to jail but Klein could not hear his sobs or see him

as a little boy! When Klein was shown the surveillance tape that showed that the little boy's backpack had brushed against her and that he had not groped her, she apologized.



ued breakdown of society. What we are seeing is the white supremacy subset of American government fighting to hold onto its power. Those in power are threatened by everything that has been happening in this country. There are and have been too many people being given the right to "be," and their life's work seems to be to pull everything back to where they are and have been comfortable for generations. Making America "great" again is about re-establishing the superiority and sovereignty of white maleness, a sovereignty which has caused much undue

pain and suffering for people for hundreds of years. White supremacy as a construct of racial and gender power grabbing is a spiritual and societal illness which has caused those who adhere to it the incapacity to consider anyone other than themselves as human beings, created by God. They expect those against whom they discriminate to be grateful for being allowed to live in this country and to just take their second-class citizenship treatment quietly, without challenging it. Whenever any human being cannot see and respect the rights and the worth of other human beings, it is indicative of a malfunctioning of the human spirit. The human spirit, created by God, recognizes the worth of all people - even those with whom it does not agree. When people will not and cannot respect others on that level, the society is in trouble. No nation can continue to exist when a large segment of its population has been relegated to the status of "object." Those so designated will eventually rise up and lash out. White supremacy in this country is damaging democracy - something it has been doing for a long time - and the end-result will be a shut-down of the government and more suffering for its people. White supremacy is a terminal disease, and it is spreading rapidly under the current administration. It is causing the rot to spread, as does the virus which causes Ebola, and that is dangerous. If white supremacy were a spiritual infection, the antibody called agape love would work to heal it, but viruses, as well know, do not respond to antibodies. A virus must "run its course," and it seems that at the end of its run, white supremacy will have done too much damage for this society to recover.

There is an old saying, "it takes a village," Dashiell Titus Parker loved a village.

What's at the unspoken heart of that saying is the love of a community banding together to nurture one of their own. And if that community does its job well, that root of love will take hold, grow and flourish. The harvest? The community's love comes back to them. In abundance. All who loved the child will watch him grow into a man who

loves his village in return. On a crisp January day in 1988, a new member came into our village. There was the cry of birth and Dash took his place in our world. Shelly and Carl Putnam Parker III stared down on blond hair, blue eyes, and a fertile heart that was to grow and expand to reach deeply into the lives of the circle of the people who surrounded him. Those who loved him will watch him grow into a willowy sapling of a man who became part of the village. His village. All who met him were greeted with long, wide arms as open as his heart. People's lives in Wilmington and beyond have been touched by his charm, his wit and the warmth of that gentle, loving embrace. The openness with which he enveloped you reflected the truth of his love. Someone recently said, "He had a way of making everyone feel loved and special-he loved perfectly." It has always held true. Not just in theory, but in his demonstrated practice.

If you went anywhere with Dash, no one person could be defined as the prototypical "Dash's friend." There was always an abundance of the spectrum of humanity's offerings. There is an often misquoted phrase, "How do you spell love? T-I-M-E." Misquote or not, Dashiell would take time and spend genuine heartfelt periods talking to people. The superficialities of surface conversations were stripped away. Love would be lavished in his delving deeper. He heard with his heart as richly as he heard with his

The actual quote, "To a child, love is spelled T-I-M-E" was said by a Zig Ziglar. Over the years, many children saw a living demonstration of that axiom through Dash. He would "spell love" by spending hours making them feel loved and appreciated as people, not as novelties. They often bestowed the honorary title of "Uncle Dash" on him. Not because they had to, but because he earned it.

Living in and of itself is an experience that is to be savored. Dash delved deeply into anything he did. From his observations of the world around him through the lens of his camera or the expressiveness of his music, he would pour himself into each pursuit fully. As a creator, he respected his work by being a meticulous, inventive craftsman because his thoughts would always be focused on the recipient of his handiwork. There are restored houses in Wilmington that have in every grain of wood that they contain the resonance of laughter of

those who heard Dash's humor as he left traces of his love in their res-

A place of great joy in his life was his family. The boy loved his mama, Michelle (Shelly) O'Rourke. Fiercely. Period. Dash also had many "mamas" that loved him as if he was their own. His childlike view of Christmas brought the magic of the holiday alive for his

His love didn't stop there. He loved his stepfathers, Eric Miller, and Casey Haines. He loved his siblings: Harriet (Hattie) Haines; Quinten O'Rourke; Emalee Haines; Sophia & Alissa Miller; Seth Haines, Seth's wife Ashley, and their children: Austin; Sadie, and Leah. He loved his uncle, Ian Murphy. His cousins-especially Jim Smith. He was a "brother" also to Riley Monteath; Bradley Matthews and his daughter, Etty; Jessica Nogueira and her daughter, Poppy; Rachel & Laura Harkey, Mandy Cornish & her son Xavier, and Conner Stavely. He cherished them all. He loved many other close friends - but there isn't enough ink to print them all.




