Medicare Q & A with Mary Duncan



Q: What is the Annual Open Enrollment

Mary: The Medicare Annual Open Enrollment runs every year between October 15th and December 7th. This is the time of the year that you can change your Medicare Advantage Plan

or your Part D plan to another plan of your choosing. I certainly would recommend that you call your agent to make an appointment to discuss your current plan and if that plan will continue to meet all your needs.

Q: My employer just reduced my hours from full to part time and I will be losing my medical plan. I am 68 years old and am unsure what to do.

Mary: You are entitled to a Special Election Period to purchase a Medicare Plan. You will need both your Part A & B to apply for a plan.

Q: What is the Extra Help Program?

Mary: Extra Help is a Medicare program designed to assist individuals with income and asset limits to help pay for prescription drug costs. If you qualify, you can get help to pay your Part D monthly premium, the yearly deductible, coinsurance and copays. The gap or donut home phase will also be covered and there will never be a concern regarding any late enrollment penalties. If you are enrolled in the Medicare program and think you may qualify, you can call Social Security to apply or go online to Social Security.gov/extrahelp to apply online.

Q: My husband has already received his new Medicare card and I am concerned that I have not received mine yet.

Mary: Do not be concerned or panic. And, you do not need to call Medicare. The mail out of the cards will continue to be sent out until next April of 2019. As husband and wife you will not necessarily receive your cards at the same time.

Health Talk

SHOULDER ARTHROSCOPY

I was diagnosed **U:** with a rotator cuff tear. I was hoping to avoid surgery and had heard about cell-based and biologic injections like platelet-rich plasma. Do these work? Injections of blood A: products such as plateletrich plasma (PRP) have been used for several years now and have become a topic of interest for investigational research. The process of receiving such an injection involves drawing blood from the patient, spinning it down in a centrifuge and taking a concentrated portion of the sample and injecting it back into the patient at the site of injury. The theory behind the intervention is that PRP has a greater concentration of growth factors and other elements that could facilitate healing and regeneration in an area of structural damage and might obviate the need for surgery. These treatments are often misleadingly marketed as "stem cell" injections when in fact there are few if any true stem cells within them.

To this point numerous studies have examined the effects of PRP and other such treatments for orthopaedic injuries and the evidence does not support their use. A recent paper presented by McQueen et al. at the annual meeting of the American Orthopaedic Society for Sports Medicine in July studied the effectiveness of using PRP injections in the elbows of Major League Baseball players who were experiencing pain with throwing. The results of the study showed that the athletes who received a PRP injection had a significantly lower returnto-play rate, a longer time to return to throwing and a longer time to return to play compared with players who did not receive the injection and instead participated in a traditional physical therapy program. What is more, the group who received the PRP injection had a higher rate of requiring surgery than those who did not, thus defeating the purpose of the injection in the first place. If you are diagnosed with a rotator cuff tear or other structural injury, PRP or other "stem cell" treatments will not result in healing or regeneration. The more you know about the effectiveness

of proposed treatments the more capable you are of making informed decisions. This information should help. To learn more about the treatment of rotator cuff tears visit ohioshouldercenter.com

Q: I am thinking about getting LASIK. What all can I expect during a LASIK consultation?

A: It is an exciting thing that you are considering this life-changing procedure! Before anyone decides to have LASIK vision correction surgery, they must first schedule a LASIK consultation to determine whether or not they are a good candidate for the procedure.

During your LASIK consultation, you will have a comprehensive eye exam to evaluate the overall health of your eyes. The exam includes pupil dilation to get an accurate measurement of your refractive error, corneal topography to measure the thickness of your corneas, and wavefront measurements to determine the type and amount of higher-order aberrations. Other examinations include analyzing the tear film, eyelid inspection, and testing for the dominant eye. After the initial testing is complete, you will then meet with a specialized LASIK counselor where you will discuss your lifestyle, expectations after surgery, recommended LASIK technology, as well as costs and financing options. If it is determined that you are not the best candidate for LASIK surgery, other procedures may be recommended such as PRK or phakic IOL implantation. Talk to your eye doctor about setting up a consultation and you can discuss all questions and learn more about the procedure.

Q: I have a family member that seems to have drastic mood swings. Sometimes they act very depressed and have little interest in doing anything, and other times they seem to be full of energy, won't sit still, are very impulsive, and they hardly sleep. What might be the possible cause of these mood swings?

A: The first course of action may be to consult a professional counselor or see your primary care physician (PCP). There may be several medical reasons, such as brain tumor, or stroke that may be the cause of mood swings and behavior changes. A doctor may be able to rule out any medical reason and refer you to a professional counselor.

There are four different types of bipolar disorders: Bipolar I Disorder, Bipolar II Disorder, Bipolar Not Otherwise Specified (NOS), and Cyclothymic Disorder. These disorders vary in degree and severity of manic or mixed episodes. Some people may have such a severe episode of depression or mania that they need immediate hospitalization. Other people may have milder or shorter lasting episodes of depression or mania. The best thing you can do for your loved one is to have them assessed by a Professional Clinician to determine what type of disorder the person is experiencing. All these different types of bipolar disorders can be treated and managed with psychotherapy and medications. At PBHS, I work with a highly-trained group of professionals that utilize Dialectical Behavior Therapy, an evidence-based treatment approach, for issues such as those described above. Our Intensive Outpatient Program provides a comprehensive assessment and treatment plan tailored to each individual for the best treatment outcomes. Q: My father was told his hearing loss was "normal for his age" and that hearing aids would not help. Can this be true?

There are many myths about hearing loss, these are two of them. The first myth is hearing loss is "normal" at a particular age and the second is hearing aids don't help.

Hearing loss is never normal, healthy ears hear well. Even though hearing loss is more common later in life, it doesn't mean that it's normal and needs not be treated. Hearing loss of any degree has a negative impact on his life, no matter what his age. Several things to look for are:

• Change in emotional and social behavior

Isolation and withdrawal from family or social activities
Frustration with

communication situationsAnger and sometimes

paranoia can also occur When there is hearing loss, there is always something we can do to help. Years ago the belief was that hearing aids did not help a nerve loss. That is no longer true, nearly 95% of those with nerve loss can be helped with today's hearing devices. The remaining 5% likely can be helped with a cochlear implant. Hearing aids have an impressive list of potential benefits beyond just hearing better, they stimulate the brain, decrease the risk for depression and isolation and will likely keep your father more engaged with family and friends. Encourage your father to seek a second opinion and to reconsider the use of hearing instruments. Life Sounds Great! Enjoy every moment.
