



Mr. Benjamin Fullwood was born in October 1843 and died in July 1908. He was married to Ms. Phoebe Bryant Fullwood. They were the parents of three children. They were Sarah Fullwood Gore, of the Cedar Grove area, who had one child, Elijah Benjamin Fullwood. She was buried in the Riley Hewett Cemetery in the Cedar Grove community.

A son, James Butler Fullwood, married Sarah Parker Fullwood, and they were the parents of 5 children (Sarah J. Fullwood, Lucinda Fullwood Davis, James Solomon Fullwood, Benjamin Levi Fullwood, and William Fullwood).

A daughter, Mary A. Fullwood, lived in the Supply community. She married Joseph Allen Burney, and their children are as follows: Mr. Jethro Burney, Mr. Willie Burney, Mr. Gaston Burney, Mr. Simon Burney, and Mr. Orina Burney.

Mr. Benjamin Fullwood was one of Brunswick County's first

FORMER BLADEN BLACK SHERIFF ALLEGES RACE, FRAUD LED TO DEFEAT

The former Bladen County sheriff, an African-American Democrat, alleges not only that he lost his re-election bid in 2014 because of some of the same election fraud allegations being probed now in the Rev. Mark Harris (R) - Dan McCready (D) Ninth District congressional contest, but he also believes that race was a factor as well.

"Race was an issue when I first ran....," said former Bladen Sheriff Prentis Benston, "... and it's going to remain an issue. I don't know when it will be over with."

In an exclusive interview Saturday, immediately after the NCNAACP Convention in Raleigh concluded, Benston, who served from 2010-2014, as sheriff, completing a 27 year career with the department, charged that Leslie McCrae Dowless, the two-time convicted felon and political operative, hired by the Mark Harris campaign to "get out the vote," also worked for Republican Jim McVicker, the current Bladen County sheriff, who unseated Benston in 2014.

"Yes, as of the 2014 election, the

absentee balloting process [was] not being done above board," Benston replied when asked if he were a victim of election "fraud" then. That fraud allegedly involved unsealed ballots from Black elderly and/or afflicted voters that could be manipulated before being turned in.

"Certainly, we have found out that [Dowless'] way of doing absentee ballots through going out and picking them up from voters (which is illegal), [along with] the improper witnessing of absentee ballots (also illegal)," Benston maintained.

Now the 2018 McVicker re-election campaign has admitted that Dowless was on their payroll again, this time to help defeat African-American Democratic challenger, Hakeem Brown, a former Bladen County deputy under Benston.

Brown has not made any public allegations yet, but the State Board of Elections and Ethics Enforcement [SBEET] has subpoenaed records from the McVicker re-election campaign, especially after the campaign admitted to paying Dowless \$8,800 between September 2017 and September 2018, according to campaign finance records.

Sources say whatever alleged election fraud impacted the Harris-McCready race, could have easily affected the McVicker-Brown contest too, especially if Dowless was involved.



A Dec. 21 SBEET hearing is scheduled that could determine whether Brown files a formal complaint in his race.

of the NC conference of branches.

Echoing the words of the NAACP's national board Chairman Leon Russell, Spearman told membership gathered from across North Carolina "...it's time to organize and not agonize. Try as you may to find it, there is no halfway ground between right and wrong. Either the one or the other must prevail, and I don't know about you, but I'm gonna push right with all my might."

Dr. Spearman emphasized the need for the NCNAACP and its branches statewide to intensify their political action and community action activities "...to build a strategic year round GOTV (get out the vote) curriculum going forward."

"Certainly, we must preach the gospel of morality and the NC NAACP has, but when your civil and political rights are being encroached upon every hour, we must also preach the gospel of organization,"

The NC NAACP president maintained. "People who will not organize and put themselves under the wisest and best of their leaders cannot expect other people to look after their interests."

Spearman also declared that the civil rights group must recommit itself to fighting voter suppression.

"We must find ways of fostering an inclusive, informed and more resolute electorate," he said. "This will take an approach that considers comprehensive voter outreach, education, civic engagement and community organizing and power building. In short, we must broaden the framing of the problem of voter suppression and craft tools for fighting it. The new wave of voting restrictions demands it."

The NC NAACP president blasted the recent "lame duck" session of the Republican-led NC General Assembly, which convened to pass new voter photo ID legislation based on their ratified voter ID amendment that Spearman considers yet another extension of the GOP's voter suppression efforts.

"The NC NAACP contends that this General Assembly did not have the authority to place any amendments on the ballot by virtue that it is an unconstitutionally constituted body. It falls into the category of "usurper" government."

Spearman continued, "There really is nothing new under the sun here in the state of North Carolina, lest we forget that the year was 1898 when Alfred Moore Waddell, the ex-congressman from black belt Wilmington, told an election evening crowd to "go to the polls tomorrow and if you find the Negro out voting, tell him to leave the polls, and if he refuses, kill him. Shoot him down in his tracks!"

On Friday, Governor Roy Cooper visited the convention. The gubernatorial visit was notable because last year, then NCNAACP Pres., Rev. Dr. William Barber, refused to invite the Democratic governor because he would not look into the Dontae Sharpe case, a Black man supporters say

was convicted of a crime he did not commit.

The convention also had to be abbreviated to just a day and a half because of an impending snowstorm that threatened to trap many convention attendees in Raleigh if they didn't adjourn by 12 noon Saturday.

The convention weekend ended on a sad note.

NC NAACP members received word Sunday of the passing of 97 year old Rosa Nell Eaton, a plaintiff in the NC NAACP's successful lawsuit against the Republican-led NC General Assembly and its 2013 voter photo I.D. law, which was eventually overturned by a federal court. "While we mourn, at the same time, we celebrate. We celebrate her steadfastness and her strength. We celebrate her commitment and her conviction. We celebrate her righteousness and her resolve. What an inspiration it was to watch her lead the way for us to fight and win the most monstrous voter suppression bill of all," Dr. Spearman said in a press release Sunday. "Mother Eaton kept her eye on the prize."

[RALEIGH] At press time Tuesday, at least three deaths

were attributed to the monster snowstorm that crippled the state Sunday and Monday. A truck driver succumbed to a heart attack while digging his rig out of the snow, Sunday along Interstate 77 in Yadkin County. A woman in hospice care in Haywood County died when her oxygen supply was cut off due to a power outage. And a driver in Charlotte was killed when a tree fell on

his vehicle Sunday afternoon. Thousands of homes and businesses across the state experienced power outages, as residents had to dig out amidst upwards of 12 inches of snow.

**RALEIGH WOMAN HELD
IN WHITE SUPREMACIST
ATTACK ON BLACK DISC
JOCKEY**

[SEATTLE, WASH] The FBI is investigating an alleged

attack by suspected white supremacists over the weekend on a black disc jockey at a local tavern, and one of the suspects is a white woman from Raleigh. Leah Northcraft, 25, is identified as being one of eight suspects who, according to authorities, who entered the Rec Room Bar and Grill, beat and stomped the black disc jockey as they tried to take over his equipment, calling

him racial slurs in the process. They also attacked an Asian man who came to assist the DJ. Police apprehended the suspects as they attempted to get away. Court papers identify the suspects as being members of the Aryan Brotherhood.

**UNC HEALTH CARE TO
RAISE MINIMUM TO
\$15.00 PER HOUR**

[CHAPEL HILL] All employ-

ees of the UNC Health Care System will, as of July 19th, earn a minimum of \$15.00 per hour. The move is to "...attract and retain a talented workforce" said the system through a press release issued Tuesday. The increase is more than double the national and state minimum wage of \$7.25 an hour, and will affect 9,000 employees, costing the system \$15 million annually.

accused of doing in the Harris-McCready race now. Attorney Irv Joyner said that the North Carolina BOE referred that evidence to the US Attorney for the Eastern District at the time, who did nothing.

"The office of sheriff is an office that requires a person to be of high standards," Benston said, noting that Bladen Sheriff's Dept. policy prohibits its officers from associating with known felons unofficially, let alone hiring them. "Certainly, I support the investigation to remove any corruption or corrupt individual from that position."

In addition, African-American officials of the Bladen Improvement Association (BIA) - the nonpartisan Black political action committee that endorses candidates, are bracing themselves for what they say will, once again, be unfounded accusations of election fraud from Republicans who are desperate to deflect attention on

their Ninth District controversy from the national media.

In 2016, then-Republican Gov. Pat McCrory falsely accused the BIA of mishandling absentee ballots when he was narrowly defeated by Democrat, Roy Cooper. After an investigation by the State BOE, the BIA was cleared. That didn't stop Republicans and conservative media from

maintaining that, because BIA accepts money from the NC Democratic Party and its members, it had to be "corrupt."

Prentis Benston, who is also chair of the BIA, insists that the group has endorsed Republicans too and has operated transparently since the 1960s, and, if the GOP insists on trying to smear them again,

per the 2018 midterms, they're in for a surprise.

The BIA deliberately did not engage in any absentee balloting work during the 2018 midterms, Attorney Joyner revealed.

However, that fact, he says, probably won't stop the NC Republican Party from accusing the BIA of something again.

94 YEAR OLD ROSANEL EATON SPEAKS AT NC'S AMERICA'S JOURNEY FOR JUSTICE RALLY

Rosanell Eaton, Queen Mother of Voting Rights, dies at 97

Considered a Queen Mother and a leader in the

struggle and movement for freedom, justice and equality, Rosanell Eaton proved a true matriarch to many civil rights leaders - especially when it came to the fight against voter suppression.

Eaton died on Saturday, Dec. 8, in her home in Louisburg, North Carolina. She was 97.

"Ms. Rosanell Eaton was the 97-year-old matriarch in our four-year successful court fight against voter suppression, from 2013 to 2016," Rev. Dr. William Barber, the architect of the Forward Together Moral Monday Movement, and president of the North Carolina NAACP, said in a statement early Sunday.

"While alive, she stayed focused on the prize of justice for all," said Barber, who also serves as pastor of the Greenleaf Christian Church (Disciples of Christ) in Goldsboro and is president of Repairers of the Breach. "She once told me, 'They think I'm gonna die before this case is over, but I'm not gonna die. I'm fed up and fired up.'"

Social media users joined the millions who mourned Eaton.

"May her memory be for a blessing," wrote Jody Drezner Alperin on her Twitter feed.

"May she rest in peace and rise in glory," Anne Hartley wrote on Twitter.

"RIP Queen Warrior," wrote Olga Melendez on Twitter.

Said Veronica Wade, "Thank you for your legacy Mother Eaton. Now take your rest."

In a tribute, *The New York Times* noted that

Eaton was "an obscure civil rights pioneer in her younger years, who became a cause célèbre after

President Barack Obama cited her courage in his response to a 2015 article in *The New York Times Magazine* about growing efforts to dismantle the protections of the Voting Rights Act of 1965.

"I was inspired to read about unsung American heroes like Rosanell Eaton in Jim Rutenberg's 'A Dream Undone: Inside the 50-year campaign to roll back the Voting Rights Act,'" Obama wrote in a letter to the editor. "I am where I am today only because men and women like Rosanell Eaton refused to accept anything less than a full measure of equality."

As noted in the *Times* tribute, a year after the president's letter, the Supreme Court, in a 4-4 vote, let stand a federal appeals court judgment upholding the lawsuit spearheaded by Ms. Eaton and other plaintiffs. The ruling struck down a North Carolina statute whose provisions "target African-Americans with almost surgical precision" in what the court called an effort to depress black turnout at the polls.

One of seven children born on a farm in North Carolina, Eaton attended segregated schools and used segregated bathrooms. However, she always counted as an advocate for voting

rights.

The *Times* noted that in her first act of defiance, when she was 21, she went to the Franklin County Courthouse in Louisburg. Three white men confronted her there and demanded to know what she wanted.

"I'm here to register to vote," she said.

They told her that she could register only if she could recite from memory the Preamble to the Constitution of the United States. It was a common ruse, disguised as a literacy test, to turn away black voters. The valedictorian of her high school class, she complied without hesitation.

"We the People of the United States," she said, "in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."

"Well, little lady," one of the men conceded. "You did it."

She registered and cast her ballot that year, 1942, becoming one of the state's first black voters since Reconstruction.

She voted in nearly every election thereafter. For more than 40 years, she was a county poll worker on

election days, and a special registrar commissioner, helping some 4,000 people to register to vote.

In 1950, she joined the National Association for the Advancement of Colored People, and for more than 60 years participated in protests against racial discrimination, including the 1963 March on Washington for Jobs and Freedom.

During the civil rights turmoil of the 1960s, she and her family were threatened repeatedly by night riders, according to federal court papers.

She awoke several times to the crackle of burning crosses outside her home. Farm equipment was damaged one night, and bullets were fired into a shed and into the farmhouse. One struck just below her bedroom window.

"In her 90s, Mother Eaton was arrested and taken to jail. She marched in the streets and testified in the courts," Barber said. "And, she even told Attorney General Eric Holder to tell his lawyers not to play with our case but to fight."

"God bless [Eaton]," said NNPA President and CEO Dr. Benjamin F. Chavis Jr., who was a close friend of Eaton's. "The struggle and movement for freedom, justice and equality continues," he said. "Matriarch Queen Mother Leader Rosanell Eaton ... rest in peace."

"Green Book" – Not our story; His-story, their fiction

"The greatest struggle of any oppressed group in a racist society is the struggle to reclaim collective memory and identity. At the level of culture, racism seeks to deny people of African, American Indian, Asian and Latino descent their own voices, histories and traditions. From the vantage-point of racism, black people have no story worth telling; that the master narrative woven into the national hierarchy of white prejudice, privilege and power represents the only legitimate experience worth knowing." Dr. Manning Marable – "Escaping From Blackness: Racial Identity and Public Policy" September 2000

Dr. Marable also referenced Frantz Fanon's book, Black Skin, White Masks, "...that the greatest triumph of racism is when black people lose touch with their own culture and identity, seeking to transcend their oppressed condition as the Other by becoming something they are not." This is the false impression of Dr. Donald Shirley that one is left with given the many false narratives that are perpetuated in the film "Green Book".

"Green Book" is the story of Dr. Donald Shirley, a world-renown African-American classical and jazz pianist and composer who embarks on a concert tour from New York City into the Deep South in 1962. In need of a driver, Shirley hires Tony Lip, a racist Italian-American nightclub bouncer for the job. This is just about as far as the facts in the film go.

The film is formulaic. It plays to the prejudices of a predominantly White audience employing the too often used tropes and worn out stereotypes about African Americans to weave a totally false narrative about Dr. Shirley and his relationship with Lip. Even though Lip is Dr. Shirley's driver, the film portrays Lip in the traditional but false position of the white "bwana" who introduces Dr. Shirley to African-American culture and who he "should be" as an African-American man.

To discover who the real Dr. Shirley was, I spent an hour interviewing his youngest brother, Maurice Shirley, Sr., his sister-in-law Mrs. Patricia Shirley and his niece, Mrs. Karole L. Shirley-Kimble. In addition to the interview, I also spent several hours speaking one-on-one with Mrs. Karole L. Shirley Kimble about her uncle and family.

Here are a few of the lies told in the film that are important for the public to understand.

The film portrays Dr. Shirley as being raised by a single mother. In fact, he was one of five children born to Pastor Edwin Shirley, Sr. and his wife Mrs. Stella Shirley a school teacher. The children were Calvin, Lucille (died at birth), Edwin, Jr., Donald and Maurice. His mother passed when he was nine. The four boys were raised by their father. All four boys obtained advanced degrees; two were physicians. They all were very successful in their own right. Contrary to the film narrative, Dr. Donald Shirley remained very close to his family until his death in 2013.

His talent was recognized when he was 2 years old. His mother was his initial piano teacher and he was quickly recognized as a prodigy and provided with formal piano lessons. With a father who was an Episcopal Priest with a large congregation in Pensacola, FL, the boys were raised upper middle-class. Contrary to the film narrative, he and his mother never "pan-handled" for money.

Dr. Shirley did not have an issue with alcohol. The rare times he drank scotch he preferred Chivas Regal or Pinch. He did not have a bottle of Cutty Sark delivered to his room every night while on the road.

Tony Lip did not "introduce" Dr. Shirley to fried chicken, Kentucky Fried or any other kind. As a "PK" or preacher's kid, there was plenty of "gospel bird" consumed on Sunday's after services during his childhood.

Tony Lip did not "introduce" Dr. Shirley to the music of Little Richard, Aretha Franklin, R&B or Soul. Dr. Shirley was well versed in and appreciated all types of music genres and incorporated them into his own compositions. According to Karole, the Black community was, "...the center of his world...he pulled from African proverbs and spirituals...he was a Black man..." He was not out of touch with the Black community, its people or its culture. In fact, he was very good friends with the giants of his day, Lionel Hampton, Count Basie, Duke Ellington, Leontyne Price, Dr. Martin Luther King, Jr. He also had long-lasting and great friendships with Paul Robeson, William Warfield, Harry Belafonte and many others.

Dr. Shirley did not sit on a throne in his apartment like the "king of the coons" as was described. He did not own a throne. He knew who he was and from whence he had come.

There was no green Cadillac. He only rode in Black limousines. Tony would not have worn a personal suit. All of Dr. Shirley's drivers wore a grey chauffeur's uniform provided to them by Dr. Shirley. According to Mr. Maurice Shirley, "there was no friendship relationship between Donald and Tony...in fact, Donald could not stand him. He fired Tony."

There are many other fallacies in the film that would take too long to point out. So you may ask. "Why is it important to point out all of these inconsistencies?" Why is the Shirley family upset over the portrayal of their brother/uncle? It's simple, Marable writes, "Under colonialism and Jim Crow segregation, people of African descent were constantly pressured to conform to the racist stereotypes held of them by the dominant society." This proud, educated and accomplished family cannot sit idly by and allow "Hollywood" to make them out to be anything other than

Now that the midterm elections are over, it's time, once again, to alert Black folks to the peril and stupidity of putting nearly all of our time, energy and resources into electoral politics. If we spent at least half of that time, energy and especially resources into maximizing our individual and group economic potential we would be in a much stronger position to advance and protect our campaign for equal rights, equal opportunity and equal justice.

Our continued neglect of economics has a long history. Way back in 1899, Wilberforce University president, William S. Scarborough stated "I would be false to the race and my own convictions

did I not pause to give the warning that, after all, neither parties nor politics alone can save the Negro...He must pay less attention to politics and more to business, to industry, to education, to the building up of a strong and sturdy manhood everywhere...He must lop off, as so many incubi, the professional Negro office-seekers. The professional Negro office-holder and the Negro politician who aspires to lead the race, for the revenue that is in it..."

Marcus Garvey also spoke out on the importance of economics in the fight against white supremacy. "The most important area for the exercise of independent effort is economic. After a people have established successfully a firm industrial foundation they naturally turn to politics and society, but not first to society and politics because the latter two cannot exist without the former."

Agreeing with them, Booker T. Washington is

quoted as saying, "At the bottom of education, at the bottom of politics, even at the bottom of religion, there must be for our race, economic independence."

A current proponent of the importance of economics is Prof. James Clingman, whose book, *Black Money Matters*, is a must-read. He insists that "Economics is about empowerment, and our dollars should be used more wisely to that end. Politics is about self-interest and our votes should reflect that truth...we must organize and rally around basic economic principles. And until we are really serious about playing the politics game, we must wean ourselves off the milk and pabulum of political dependence and get on a steady diet of cooperative economics and mutual support."

W.E.B. DuBois, Brother Malcolm X, Dr. Martin Luther King Jr., Mary McLeod Bethune, Carter G. Woodson, Harold Cruse and Chancellor are others among

our ancestors who have attempted to alert us on the importance and necessity of a group economic agenda. Williams was the most emphatic. "The second great understanding should be that economic activities are so fundamental in any truly upward movement, so clearly indispensable at this stage in history that is should be unnecessary to state it even. The still existing slave mentality causes millions of us to shy away from these basics of life itself because it requires more initiative, training and work and less talk than policies."

I will close with a stern warning attributed to Dr. DuBois. "May God write us off as asses if ever again we are found putting trust in either the Republican or Democratic parties."

what they are.

This film purposely and lazily infuses generally accepted stereotypes about African-American people such as being born impoverished to a single mother; no strong male figure, disconnected from his family, community and self. Here is a man that earned a doctorates in Music, Psychology and Liturgical Arts. Dr. Shirley was fluent in eight languages and was a talented painter. Still the film would have us believe that it wasn't until the great White benefactor rode in on his trusty White steed (on in this case a green Cadillac) that Dr. Shirley was able to find himself and connect. Actually, he was never

lost or out of touch with his family or who he was as a Black man.

Dr. Shirley's real-life story would have made a much better film. Had the screenwriters and producers taken the time to perform even the most rudimentary research and reached out to the Shirley family they would have uncovered a much more interesting, enlightening and empowering story. A story about a brilliant African American man, born in the deep South in 1927. A man born into a highly educated family, earns three Ph.D. degrees, becomes a world-renowned pianist and composer, millionaire, friend of Dr. King's and supporter of the Civil Rights Movement. A man that died beloved by his entire family and community and is missed

to this very day.

In 2019, we will commemorate 400 years since the first 20 slaves were transported by ship from Africa by white slave traders and landed in Jamestown, Va.

Now four centuries later, race remains a central dividing line. Today, for example, the racial wealth gap exposes a stark difference. The median wealth of a white household (median means half are above and half below) is 12 times greater than that of a black household. The median wealth of a white household is \$134,430, of blacks it is \$11,030.

This is virtually all about equity in a home, the leading source of middle income wealth. African-Americans still suffer from de facto segregation, after years of being red-lined from decent neighborhoods.

In the financial collapse, African-American households suffered the worse. Black unemployment rose twice as much as white unemployment in the Great Recession. Middle-class black

families, lacking inherited wealth, were targeted for the most aggressive and leveraged home loans. When the bust came, they were the most at risk and suffered the greatest loss of homes.

The wealth gap is not erased by educational attainment, by full-time employment, by getting the right occupation.

The typical black family with a head of household working full time has less wealth than a white family whose head of household is unemployed. Median wealth for a black family whose head has a college degree is about 1/8 that of a median white family similarly educated.

African-Americans are constantly told to pull themselves up by their bootstraps. In the black church, for example, ministers repeatedly preach the need for discipline, self-reliance, faith and hard work. Yet even those who suc-

ceed still remain behind. The divide has deep historical roots. Two-hundred forty-six years of chattel slavery (1619-1865), only twelve years of Reconstruction (1865-1877), 19 years of Black Codes, KKK and white citizen council violence (1877-1896), 58 years of legal apartheid with nearly 5,000 African-Americans lynched and, even since the 1954 Brown decision, ongoing racial discrimination.

During the recent midterm elections, I was constantly asked whether African-Americans would vote in high enough numbers and margins for Democrats so that candidates white and black had a chance to be elected. Democrats seem almost satisfied if 20 to 30 percent of whites turn out to vote for black or progressive white candidates.

What responsibility do white people have to register and turnout for progressive black and white Democrats running for office?

The nation is facing many morally relevant social, economic and political crises - voter suppression, income and wealth inequality, crimi-

nal justice reform and climate change - that now pose an existential threat to the next generation. Why does the white church remain so silent in the face of these mounting crises and denial of justice and opportunity?

In Birmingham in 1963, with dogs biting children, high-pressure fire hoses knocking down peaceful protesters, bombers blowing up churches and Dr. King in jail, many white church leaders chose to attack Dr. King's non-violent methodology rather than to fight for a non-discriminatory Public Accommodations Act.

One would have thought when the four little girls were bombed in the 16th Street Baptist Church, white churches would have at least held prayer services or services of reconciliation. Instead, most attacked Dr. King as an outside agitator, as if he had set the bombs.

Recently in Alabama, I witnessed a stark contrast. One extreme was the excitement

The remembrance of the late President George H.W. Bush was moving; his good work as president - i.e., ending the Cold War, getting the Berlin Wall down - was rightfully noted. His civility was understandably emphasized in light of the total lack of civility we are experiencing now. His family was surely comforted by affirmation of his inherent goodness.

But his racism was nearly totally closed over.

It was his administration that used the case of Willie Horton to feed into the racist fears of white people. In 1988 a group called "Americans for Bush" created and ran what came to be known as the "Willie Horton ad." It was so reprehensible that it still gives me chills. This group of white Americans capitalized on the sad fact that a man who was given a furlough by Bush's Democratic opponent, Michael Dukakis, raped a white woman twice while on a weekend furlough. Many governors in states across the nation granted furloughs at that time, but the impact of this ad on white people was enormous. Lee Atwater, the brains behind the Bush campaign, ended up apologizing for the ad on his deathbed, but at the time of the election, all bets were off. Dukakis was too much of a threat, and so white campaign strategists used what is being used

today - race - to make sure their guy got into office.

It was disgusting.

It is beyond dispute that President Bush did some really good things while in office. Nobody can dispute that. But he did some things that were not so good (https://truthout.org/articles/i-will-not-speak-kindly-of-the-dead-bush-was-detestable/?utm_source=sharebuttons&utm_medium=facebook&utm_campaign=mashshare&fbclid=IwAR3lfOMPejr4FOtXgkUdaPfQaaSjWchIGO3Lvf1uyVUm7AMBpb5hqZGPK) and in lifting him up as one of America's last great presidents, those things, which have had a tremendous impact on the world, have been ignored - including his racism.

White Americans have historically been able to separate their racism from their faith. In the ante-bellum South, whites would say that slavery was a problem but that it was not immoral or wrong; the Slavery Bible was written to contort the will of God to fit the racist mindset of Southerners who believed in it. White Christianity has always been different from the Christianity practiced by oppressed people. The god of white people has been oiled with racism and all of its tentacles, but their god did not gel with the God of all people described in the Christian Bible.

Robert P. Jones in his book *The End of White Christian America* says that "White Christian America...has died." But has it? This sect of Christians is making a comeback, using race as their foundation, to maintain what has been the status quo. If the "swamp" was drained, it was refilled with these "good, Christian" people who believe in the sanctity of white supremacy. The noticeable silence on the part of the media about this president's racism supports that reality. Nobody expected the funeral of the late president to be the place where Bush's racism was mentioned, but the media should have. The role of racism in this country and its use by the "best of the best" as indicated by the Bush campaign, should have been noted more prominently, not to beat him over the head but to remind America that we still have a problem.

My guess is that the majority of white people, white Christians especially, do not know about the Willie Horton ad, and that if they did, it would not bother them. They would shrug and say that Willie Horton was a bad guy and that using him to win an election was fair game.

This attitude, even though the very architect of the ad struggled with the wrongness of that ad until he died.

Revising history when it comes to race seems to be the only way white Americans can survive. Dr. Joy DeGruy, the author of *Post-Traumatic Slave Syndrome*, identifies the cognitive dissonance that white people have learned to use so well as a major reason why racism still fills this country with its stench.

The voter suppression that is running rampant throughout the country has a racist core; many of the policies being created have a racist core. We are a racist nation, and we will not admit it.

President George H.W. Bush was a good person to and for his family and friends. He did some things that perhaps helped the African American community during his presidency. He was certainly civil, unlike the current president; he was not an outright liar, again, as is the current president.

But he was racist and knew how to use racism to get what he wanted. I cannot forget that, and I suspect, many others cannot, either.

in anticipation of the Georgia/Alabama SEC championship football game. When a young African-American athlete, Jalen Hurts, replaced an injured Tua Tagovailoa at quarterback, every Alabamian of every political persuasion, right, left and center, was pulling for him.

With Hurts' remarkable display of skill, Alabama won the game. He not only won the game, he arguably beat George Wallace and the legislators who earlier locked blacks out of the University of Alabama. He beat Bull Connor who unleashed the dogs on demonstrators and the KKK on Freedom Riders.

He beat the KKK bombers who watched as the church was decimated and four little girls were murdered.

The other extreme was witnessed in Hoover, Ala., where E.J. Bradford was shot in the back by a policeman. That police officer is still on the payroll. The patterns and prejudices of the old South are hard to overcome.

Here once more, the white church has the opportunity and the responsibility to stand up, to serve as a Christian witness. White voices of moral authority and inclusive leadership are needed now as much or more than ever.

That is why the silence seems so deafening.

incoming Congress is not only to put a halt to the Administration's misguided agenda but to advance an agenda aimed at reducing inequality, expanding opportunity and enforcing civil rights and racial justice.

An encouraging sign that the Democratic majority does intend to advance such an agenda was the unveiling of a legislative package - known as H.B. 1, to emphasize its importance - reforming the nation's political processes.

The bill includes new donor disclosure requirements for political organizations, public financing for political campaigns, a mandatory Supreme Court ethical code, expansion of access to the polls and a reduction of partisan gerrymandering.

We believe H.B. 1 is a good start. Among the other issues the incoming House majority must address on Day 1 are: increasing the federal minimum wage and indexing it to inflation, strengthening and

restoring the Affordable Care Act, a comprehensive and targeted infrastructure bill and protection for "Dreamers" - young immigrants covered by Deferred Action for Childhood Arrivals (DACA).

The most significant and impactful initiatives the new House majority could adopt, which includes much of the above, can be found in the National Urban League's Main Street Marshall Plan, a comprehensive blueprint addressing lack of opportunity and economic inequality in America's urban communi-

ties. Elements of the Main Street Marshall Plan were introduced as part of a major legislative proposal introduced by members of the Congressional Black Caucus earlier this year.

The Congressional Black Caucus' Jobs and Justice Act includes Main Street Marshall Plan proposals addressing investment in public schools and infrastructure, a living wage for all Americans, restorative justice for ex-offenders, and tax incentives for hiring young people, veterans, and the unemployed.

It's significant that the incoming Congress is the most racially and culturally diverse in history, including first Native American congress-

women and the first Muslim congresswomen. The practical effect of such diversity is that Congress can more truly represent the interests of all its citizens - not just the wealthy, white men who still make up its largest contingent.

In an open letter to her colleagues, incoming Speaker of the House Nancy Pelosi wrote, "It is my hope that as we deliver on our For The People agenda - lower health costs, higher wages by rebuilding America and restoring integrity in government - we do so in a way that will address economic disparity in this Country. This Freshman Class has also made integrity in government its priority, supporting H.R. 1, in our Better Deal for Our Democracy. As Justice Brandeis said, 'We may have democracy, or we may have wealth concentrated in the hands of a few, but we can't have both.'"

We look forward to working with Rep. Pelosi and her colleagues on both sides of the aisle to restore integrity to government and create economic, educational and social opportunity for all Americans.

Now that the midterm elections are over, and Democrats are savoring their victory, more than a dozen Democrats say they are considering running for President in 2020. The Democratic Party needs to get its act together if any of them has even a prayer of beating the clown that white conservatives love to love. The fact that Republicans stole an election from Stacey Abrams in Georgia suggests that our electoral infrastructure isn't what it ought to be. The fact that Republicans in Michigan, Wisconsin, and North Carolina are attempting to change electoral rules suggests that the Party and civil society organizations need to spend some money ensuring fair elections. From where I sit, the focus on personalities is poorly placed. We ought, instead, think both about our election mechanics and an economic agenda to empower the majority of our citizens who live in an economically precarious situation.

Too many of us struggle to survive on the minimum wage, and too many unions have seen their influence erode in the face of hostile legislation. Too many do not have access to health care. Too many cities and states are willing to offer exorbitant

tax breaks to attract a few jobs. Meanwhile, our infrastructure is crumbling, our environment is decomposing, and civility is a thing of the past. There's a lot of rhetoric, but Democrats have to explain what they stand for more clearly.

Democrats have been so reactive, so anti-45, that they've not spun out a positive agenda. Oh, they say they stand for a living wage, for criminal justice reform, for access to health care and education, for racial economic justice (actually, they didn't say that I did), and more. But too often, Democrats have gone with the status quo instead of looking at the changing needs of our nation. And the party is expert at grabbing defeat from the jaws of victory, failing to support progressive candidates who sometimes upset the status quo.

Now, former Vice President Joe Biden says he is the most qualified person to be President. Massachusetts Senator Elizabeth Warren took a blood test to prove that she is 1/1024 Native American, falling for 45's BS. New Jersey Senator Corey Booker, also known as

Spartacus, is considering the race, as is the incandescently intelligent California Senator Kamala Harris. Bernie Sanders, the 2016 independent candidate, keeps threatening to run again. That's a non-starter for me! There are another couple of dozen potential candidates, from the very well known to the lesser known. Democrats run the risk of having a Republican-style circus during the primaries unless the field narrows. Already, two who were considering the race have dropped out. Nobody will miss Michael Avenatti since many of us did not know why he was in the race in the first place, but former Massachusetts governor Deval Patrick, who has just announced that he will not run, might have brought gravitas to the primaries. Patrick told Obama advisor David Axelrod that "It's hard to see how you even get noticed in such a big, broad field without being shrill, sensational or a celebrity, and I'm none of those things."

Our current President is shrill, sensational and a celebrity in his own mind. Democrats should not attempt to replicate that level of insanity that 45 brings to the table. The issue, also, should not be one of who is the most sensational, but who has the most focused program, and the basis of the Democratic program must be

economic justice for working Americans. Back in the day, we used to say, "It's not the man, it's the plan." In gender-neutral terms, it's not the person, it's the program. For Democrats to build on the momentum of the midterm election, they must drill down on communicating dynamic economic programs.

I'm encouraged by folks like LaTosha Brown and Black Voters Matter. They are doing ground up, not top down, organizing, going into communities and focusing on the races they deem essential, which are not always national or statewide races. When people come out for a key local, they will also vote in the "big" races. But too often the Democratic Party focuses only on the biggest elections, with an agenda people can't necessarily identify with. Democratic Party leaders need to sit down with Black Voters Matter as soon as they can and learn how to connect with the voters who can make a difference in 2020. Or, they can continue with business as usual and experience the consequences.


continue to dream of peace, success, and prosperity.

new debt could hurt future chances for that Heir to receive new debt for their own personal wants and needs.

(TWO) I know a sibling that is the executrix of a parents estate and she inherited/owns a home with a sibling. That sibling is out in the world consumed with drug addiction and seldom contacts the sibling handling the estate affairs. The executrix is ready to sell the property and after several attempts to find the sibling in the streets, they are considering exercising their right to sell. As executrix, they have that right and once the sale is complete they will leave the portion due to the missing sibling with the Clerk of Court to be claimed whenever they are ready.

(THREE) There is a sister that owns 10+ acres with nine other heirs. Three of the original 9 have since died and now their portion of the acreage past to their legal heirs. How many more heirs was gained when those 3 died? That is still being determined. That is the most troubling thing about having so many heirs owning a

property. When one dies, they multiply and also the liabilities. Did you know that when someone inherits a property and if they have ANY KIND of judgments filed downtown in the County where the property is located, those judgments attaches to the entire heir property? That is judgments like IRS or State income tax liens, bad debt personal loans, furniture debt, whatever. If it is filed downtown as a judgment, it attaches to the inherited real estate and the entire Estate must deal with the satisfaction of that debt.

Lastly, there are 4 siblings and 1 of the siblings has extensive medical needs and can't get Medicaid due to having ownership in heir property. The other siblings agreed to sell it to help the one but it was discovered it had 2 mortgages and the market will not support selling it for enough to clear both notes. Therefore the only option, let the 1st mortgage holder foreclose on the property and that will get it off all 4 heirs hands so the 1 can get the help they need. (Little FYI: The 1st mort-

gage company foreclosing will automatically knock out the 2nd mortgage holder. We will talk about that more at a later time.) So as you can see there are many different ways owning Heir properties can bless and on the other hand, TEST. At the end of the day, I'm always going to be an advocate for owning real estate to leave as an inheritance to your loved ones. The smart thing to do is to truly evaluate your loved ones personal situations and choose how best to leave the property behind that will benefit all the most. If you currently have heir property and need some guidance on your options, consult a realtor with knowledge of handling estate real estate and contact an attorney and let them guide you.



(given by His inspiration) and profitable for instruction, for reproof and conviction of sin, for correction of error and discipline in obedience, [and] for training in righteousness (in holy living, in conformity to God's will in thought, purpose, and action.) These centers serve as conduit between the generosity of 2nd Episcopal District and victims of the heavy rains, inc-

pacitating flood waters and devastating winds of Hurricane Florence.

In the aftermath of the storm, Wilmington and surrounding areas became like an island according to news reports, with aid cut off from the masses because of the conditions. Individuals and congregations in need of support and infusions of hope were beneficiaries of the 2nd District's love and care. Supplies for children as well as adults, clothing, food and money was distributed to those who have still not recovered from the storm.






