

How McCrory tried to frame Black Bladen PAC with 2016 loss

As North Carolina, indeed, the nation, awaits the final conclusions involving alleged election fraud in Bladen County from the NC Board of Elections (whose hearing is now scheduled for Jan. 11), the Wake County District Attorney's Office, the State Bureau of Investigation, and now even, reportedly, the Federal Bureau of Investigation; a group of local African-American residents known as the Bladen Improvement Association (BIA), a political action committee (PAC), is relieved that they are not in the crosshairs of yet another probe into their proven lawful electoral activities.

But they know full well what it feels like to be investigated and falsely accused just because they're Black, help voters with their ballots, and have historically endorsed mostly Democrats.

It was just two years ago when then first term Republican Gov. Pat McCrory, having lost his bid for reelection in a close race to Democratic challenger and then State Attorney General Roy Cooper, falsely alleged that voter "malfeasance and irregularities" caused his defeat in several counties across North Carolina, including Bladen.

McCrory and his attorneys, along with the NC Republican Party, contended that thousands of votes in over 50 counties statewide were in question, charged that Democrats were responsible and that "felons," people who also voted in other states, and even "dead" people, were allowed to illegally cast ballots. His goal was either to win the race outright or meet a legal threshold so that the Republican-led NC General Assembly would then, by law, choose the "winner" of the gubernatorial election, who McCrory

assumed would be him.

Two factors cast doubt on McCrory's claims: Donald Trump and other GOP'ers won throughout North Carolina and all of the county election boards which certified his race were led by Republicans.

However, that didn't stop conservative media, like Red State.com, from taking up McCrory's "voter fraud" crusade.

"Did somebody say Democrat corruption," bellowed the first line in its Nov. 15, 2016 commentary.

After noting that a complaint had

been filed with the local Bladen County Board of Elections, "...in response to several hundred fraudulent absentee ballots, all voting a straight Democrat ticket..." it went on to allege, "The filed complaint described the situation as an "absentee ballot mill," and it was perpetuated by the Bladen Improvement Association PAC (BIA), which is funded by the North Carolina Democrat Party."

And exactly who filed that complaint? None other than Leslie McCrae Dowless, the very same "person of interest" at the center of the current allegations involving illegal absentee ballot harvesting in the Mark Harris vs. Dan McCready Ninth Congressional District election fiasco.

Dowless, whom Republican Harris admits to knowing and hiring, is alleged to have coordinated and managed an operation during both the GOP primary last May and the November 2018 midterm elections, where people who worked for


REV. BARBER BLASTS VOTER ID LAW

The Reverend Dr. William Barber, President of Repairers of the Breach, and Co-chair of the Poor People's Campaign: A National Call to Revival, blasted the Republican-led NC legislature Monday for using the recently called special session primarily to pass a new voter photo ID law, instead of addressing the urgent needs of those suffering in the aftermath of September's Hurricane Florence.

"We call a special session in the season of Thanksgiving, Christmas and Advent, and this legislature could have taken that time to address the needs of poor people and sick people throughout North Carolina," Rev. Barber said. Noting that at least one million people in North Carolina do not have health insurance, Barber chided North Carolina lawmakers for not using the special session time to extend

grounds consistently, time management, and other unfamiliar adaptations to college life away from familiar surroundings, are true tests of campus survival, which some manage successfully and others struggle to make the necessary adjustments.

Khairy Ishaan Jenkins, who is a freshman at North Carolina Agricultural and Technical State University in Greensboro, seems to be taking it all in stride as he recently completed his first semester of college successfully, and is looking forward to the start of his second semester in January. It is fair to say Jenkins is living his dreams on his own terms and simultaneously enjoying every minute of it.

Jenkins attributes his current success, determination and razor focus to multiple factors that include his mother, Alycia Shaw, who he refers to as his "great support system", and the "primary stimulus" behind his having written and published his first book titled, *If My Horn Could Speak - A Self-Help Journal Guide for Youth*.

Jenkins admits using the information from his book filled with "useful points-of-reference" when he must make decisions he considers important and those that could be life altering, if wrong choices are acted upon at any time during his day-to-day living. He is grateful to have authored a book at age 16, which he and his mother self published because they did not have finances to seek external publishers' support.

Jenkins, who initially had no idea or intentions of writing a book, shared that his mom "tricked him into writing a book" by encouraging him to write down his daily thoughts. She began saving their text message exchanges that they later found helpful when actually composing the book. Discussions that involved inquiring about "how her son's day was progressing", "what decisions he had made", "lessons learned", and "what, if anything, he might do differently", were all topics that required the engagement of reflective thought processing and discernment necessary to make the best choices based upon various circumstances.

As Khairy Jenkins matured, naturally his decision-making skills continued to improve and his recorded thoughts evolved into the age-appropriate, self-help journal that he and other young adults, between the middle and high school grade ranges, will find useful in helping them to make more appropriate life choices. Some readers in particular may find the book useful when making decisions when their parents, older siblings, teachers, and others may not be available to offer guidance during crucial times in their lives.

Jenkins admits that when his mother shared that she "had kept all their conversations" and began encouraging him to write a book, he

was not exactly insightful as to how he would have the time to ever make that happen. He had so much to do and more on his plate than he believed he could handle when she shared her proposal that he "should write a book" during his senior year at James B. Dudley High School.

He knew his mother had insisted on keeping his schedule packed with school work, music, volunteering, and other activities, so that Jenkins would remain focused on his plans for college after graduation. Knowing that, Jenkins was taken aback at the thought that his mother assumed he could now add authoring a book to his busy schedule.

However, when he began examining all the information his mother had retained and his own journal notes, Jenkins soon realized that the possibility of publishing a book was well within his means.

Without further delay, he began composing his book and working closely with his mother to format the information to identify the appropriate photographs to com-

pliment the content. Their action plans began coming together smoother than Jenkins had ever imagined.

When all was said and done, and he saw his finished publication, Jenkins was very grateful that he had followed his mother's advice about writing a book and leaving behind a "lasting legacy" from which others could benefit from at his beloved Dudley High School. After completing the book, he realized that he had accomplished something important just as other Dudley Alumni before him had done.

Jenkins admits being a true "Band Head", and his love and appreciation for the role that music has played throughout his life, made incorporating his horn into the book's theme easier for him. He admits constantly listening to music even as he writes, reviews and studies in preparation for classes and exams at A&T. He cannot imagine life without his music, so it completely complements his book.

Having begun playing his horn in grade six, Jenkins talks freely regarding the

significance music has had in who he has become. Just like writing, being a skilled musician and performing in A&T's world renowned Blue and Gold Marching Machine Band, are the actual manifestations of the ambitions he envisioned for himself.

Since having published his book, Jenkins has had opportunities to conduct book signings and to speak with young adults regarding the book's contents. He somewhat closely relates to their life choices. Those public speaking opportunities have increased his self-confidence and impromptu speaking skills for which he is grateful, and looks forward to future opportunities to speak about his book to others.

He admits that he "enjoys interacting with youth, who are experiencing similar issues just as he did" when he was their same ages. He sees the publication of his first book as an important way to demonstrate to others that they too can accomplish goals and other endeavors which they may have doubted could ever be accomplished.

Jenkins concluded by sharing that "seeing my published book made me feel I could accomplish anything that I seriously put my mind to"; and that he "looks forward to the composition and publication of his next book".

Jenkins added that "whatever life offers him" during his pursuits of dual-major degrees in Animal Science and Animal Laboratory Science from A&T that he anticipates completing by 2023, he expects to do successfully.

Jenkins and his mother reside in Greensboro. Jenkins has two older siblings, Alexander and Elizabeth, and his father, Kevin Pressley. Kudos to Khairy Isaan Jenkins and Alycia Shaw, on their outstanding joint publication! We look forward to what awaits him as he lives out his dreams! "Aggie Pride!"

**STATE SENATE OVERRIDES GOV. COOPER'S VETO ON VOTER ID LAW**

[RALEIGH] Using the last days of its supermajority, the NC Senate voted to override

Gov. Roy Cooper's veto of the new voter photo ID law that passed the Republican-led legislature last week. Cooper blasted the law, say that it was a "solution in search of a problem," but lawmakers countered that they had no choice but to pass it since voters ratified the voter ID amendment to the state Constitution during the midterm elections. The state House, at press time Tuesday, hadn't voted to override yet,

but that is expected by the end of the week.

**BLADEN COUNTY RESIDENTS EXPRESS CONCERNS ABOUT BALLOT CONTROVERSY AT TOWN HALL MEETING**

[BLADENBORO] Anger and frustration were on full display during a town hall meeting at First Baptist Church in Bladenboro Tuesday as residents came together, not only to listen to leaders like Rev. Dr.

T. Anthony Spearman of the NC NAACP commit to finding out the truth behind allegations that absentee ballots were illegally manipulated during the 2018 midterm election between 9th District Congressional candidates Mark Harris and Dan McCready. Several residents spoke of people coming to their homes and taking their unsealed ballots, even though that is illegal under North Carolina law. The stat Board of

Elections has called for a hearing on the matter for Jan. 11th.

**WAKE SHERIFF RELEASES 19 UNDOCUMENTED IMMIGRANTS**

[RALEIGH] The new sheriff of Wake County, Gerald Baker, has kept one of his campaign promises. Vowing, if elected, that his department would no longer work with agents of the US Immigration and Customs

Enforcement in holding undocumented immigrants for possible deportation, Sheriff Baker released sixteen detainees from the county jail after they'd either served their term, or posted bond. Another 79 are being held for state charges, but Baker says they will soon be let go as well. Sheriff Baker is one of the newly elected sheriffs across the state who promised to no longer hold detainees for ICE.

him illegally collected, or even changed, the votes on unsealed absentee ballots distributed throughout Bladen County, ultimately delivering a 905-vote victory for Harris.

However, in 2016, it was Dowless who was claiming to be the victim of illegal

absentee ballot shenanigans in his race for local Soil and Water Conservation District supervisor.

Lawyers for the McCrory campaign latched on to Dowless' Bladen election complaint, alleging that it was indicative of what was happening across the State. "The staggering evidence of voter fraud in Bladen County and the number of similar (read Black) PACs that the North Carolina Democratic

Party donated to shortly before the start of early vote requires close examination throughout the state."

Dowless, a convicted felon, alleged that the absentee ballots had the witness signatures of paid BIA members. Red State.com called this "shocking evidence."

The North Carolina Board of Elections (NCBOE) investigated and found that nothing the BIA did was illegal. The witness signatures (two

are required) were done at the time the voter signed their ballot, and the BIA canvassers also did GOTV (get out the vote). Indeed, their names were reported to the local and State BOE by BIA. There was nothing illegal about what they did, or BIA's getting contributions from the State Democratic Party, or various Democratic candidates or elected officials to operate.

In the end, not one absen-

tee ballot with which the BIA worked was deemed illegal, and Cooper ultimately defeated McCrory statewide after a recount by over 10,000 votes, weeks later.

"The procedures, the methodology used by the (BIA) did not violate State law," Atty. Joyner maintained the NCBOE ruled. "They had been trained by the State Board, and did it the right way"

Burned by the experience, the BIA and their Attorney

Joyner braced for more false allegations this year and decided not to engage in any absentee ballot activity for the 2018 midterm elections.

It is most likely now, given what is known about allegations pointing toward Dowless and Harris, the Bladen Improvement Association will not be targeted this time.

However, if so, BIA and Attorney Joyner stand at the ready.

Medicare to the poor, many of whom live in the flood ravaged counties affected by Hurricane Florence.

The NC General Assembly did pass an initial \$850 million hurricane recovery package in October, \$450 million of which could be spent right away for construction, rebuilding damaged schools, or help some rebuild their home.

Still, critics say the amount was not enough to help the many victims still dealing with the after effects

of the 2016 Hurricane Matthew.

"Thousands of people in those areas could benefit from a raise in the minimum wage and a living wage. TOPhat would really help them recover. Did this legislature choose to hear their cries? No!" Rev. Barber roared.

The former President of the NCNAACP charged that lawmakers chose to "...focus on an unnecessary photo ID bill, rather than deal with the real issues that are impacting North Carolinians."

Barber continued that there are currently lawsuits filed challenging how the

voter ID and other proposed amendments to the State's constitution were placed on the referendum ballot. He also announced that the Poor People's Campaign is supporting an NCNAACP lawsuit against how the legislature passed the laws calling for the "unconstitutional" amendments, challenging "the whole process in the first place."

Rev. Barber also

announced that the Poor People's Campaign is working on a "major, major" statewide bus tour and a "major poor people's march on the State Capitol in the spring of 2019.

"We are not going to be silent," Barber vowed. "And we're not going to stop fighting for the 4.7 million poor people in this State, and the over one million people who do not have healthcare."

To the press, Rev. Barber said, "The "story" isn't that the legislature overrode Gov. Roy Cooper's veto. The story is they called this legislature back into session! It's an unconstitutionally constituted legislature, and, instead of all of the good things they could have done to help the hurting, the broken and the poor people of this State, they chose to act contrary to our deepest moral values

and contrary to the season of Thanksgiving and Christmas, and contrary to our own [state] Constitution, that says "...the first duty ...of a civilized and Christian state, is to provide beneficent provisions for the poor, the orphaned, and the unfortunate," Rev. Barber said. "This legislature ...is out of order," Barber concluded, "... and we have to continue to fight!"





## ESSA: A roadmap for achieving equity in education

**S**tates are in the driver's seat when it comes to improving their struggling schools. But how can we make sure they're not taking the "path of least resistance" when it comes to this important work, risking the academic prospects for students of color.

Building on the work done by Bellwether Education Partners, which conducted independent peer reviews of all 50 states' and the District of Columbia's ESSA plans that were required to be submitted to

the U.S. Department of Education for approval, the Collaborative for Student Success analyzed plans to see which states are taking advantage of new-found flexibility regarding equity in education. The new report, Check State Plans: Promise to Practice, found that just 17 states met its threshold for even having enough public information to review. The report notes that the results are "sobering" in that "more than 9 million students attend schools that do not meet anyone's standard for what is acceptable." This is particularly acute for students of color and who come from low-income families.

The fact is, achievement gaps between white and black

students exist. We see this time and again in the National Assessment of Education Progress as well as on individual states' annual assessments. Students who attend inner city public schools tend to fare worse than their peers in suburban public schools. The gaps are even more pronounced when we look at private schools that draw privileged students away from city institutions. These racial divides segregate communities.

A report from the Young Invincibles examines these divides and developed three main findings: (1) minorities disproportionately enroll in for-profit and community colleges, which can condemn them to a vicious cycle of debt; (2) college costs hit minority students harder than their white peers; and (3) the achievement gap is racially divided. While 36.2 percent of white students completed four years of college in 2015, just 22.5 percent of black students could say the same, according to the analysis. While that's much better than the 1974 numbers in which just 5.5 percent of black students finished four years of college compared to 14 percent of white students, that progress leaves little cheer.

State education chiefs and their in-state partners at teaching and research institutions plus educators on the front lines have a real chance to make a difference for black students and other minorities. But do they have the courage to make the necessary changes?

The Collaborative's report is a good starting point, and it provides a roadmap written by education and policy leaders who are displaying the courage necessary to create bold plans that prioritize equity. Low-performing schools must be identified as such and be given real plans with real accountability measures to improve. There have to be consequences for students who don't make the grade, but for too long, our education system as a whole has punished students by not giving them the tools they need to succeed. We have to look at the institutions and root out systemic problems.

As such, the Promise to Practice reviewers evaluated state plans based on a rubric that included whether the state has a coherent vision for improving student outcomes, whether there is a strategic use of funding and alignment of resources, the use of evidence-based interventions, and how well state leaders engaged stakeholders. That last component is perhaps one of the most interesting aspects of ESSA—federal lawmakers required states to gather input from a wide range of groups outside of traditional education. Civic groups, business leaders, parents and community activists were given a seat at the table.

We watched excitedly as several NAACP groups got involved from the very beginning, helping policy and lawmakers understand community and even neighborhood needs for the betterment of students. Still, it disheartens

ing to learn that just 17 states are ready to identify and provide the kinds of supports that low-performing schools require. Other states can look at Colorado, which has developed a clear menu of school improvement items for districts to choose from, or Nevada where districts have to describe how their strategies for addressing equity gaps in funding applications. Nevada is also using equity-oriented data like behavior and attendance to understand schools' challenges.

There's so much anger and divisiveness in our society today, but the importance of education equity should be among the things on which we can all agree. Every single student in every single school, no matter where that school is located or what kind of home life the child has, must be given the tools and knowledge to succeed. We shouldn't have to fight for this right—the right to an education. And yet we find ourselves year in, year out looking aghast at assessment scores that prove achievement gaps are still there. Thought-provoking analyses like that done by the Collaborative for Student Success will help close those gaps until they are well and truly gone.

of thieves. He is ignored by a priest and a religious official. He is saved by a Samaritan — a people who were widely despised at the time — who binds his wounds, takes him to an inn and pays his fare. "Go and do likewise," Jesus instructs.

In contrast, Trump slanders the strangers. His administration has ripped babies from their parents, shackled pregnant women, locked up thousands indefinitely. He has constricted legal immigration, even as employers seek new workers as the baby boomers age and retire. And now he threatens to shut down a good part of our own government unless he can waste billions on the wall that Mexico won't pay for.

In the midterm elections, Trump, worried about mobilizing his base, descended into hysteria, threatening to revoke the citizenship of those born here — a direct violation of the Constitution — rousing fears

about a supposed invading army of migrants, eventually dispatching 7,000 troops to the border; an insult to our military and to our border patrols.

He succeeded in raising the importance of the issue, but he lost the argument. Democrats swept to a majority in the House. Polls showed most Americans still believe that immigrants benefit this nation, as opposed to costing it. The percentage of Americans supporting lower levels of immigration has fallen from a high of nearly two-thirds in the mid-1990s to an all-time low of less than 30 percent in June.

Rep. Pramila Jayapal, who immigrated from India at 16 and is the first Indian-American woman elected to the House of Representatives and one of 12 naturalized citizens, notes that a bipartisan comprehensive immigration reform bill exists — one that once got 68 votes in the U.S. Senate.

It paid for more border security, while providing a clear road map to citizenship for the 11 million undocumented, including the Dreamers, and fixed many of the problems of our system: outdated family visa caps, cruel immigration

backlogs, and a failure to address pressing needs of employers.

Trump, however, doesn't seek a solution; he seeks the preservation of an issue — one that he believes can help him divide and conquer.

What's needed instead, as Rep. Jayapal wrote, is a moral imagination about immigration. This is not about "open borders," as Trump slanders Democrats. It is about creating a humane, sensible, smart system to deal with legal immigration, cut down on illegal entry and address those desperately seeking asylum.

We would also be wise to seek to assist rather than destabilize our neighbors so that their economies thrive. People don't want to leave their homes. Only desperation for their families leads them to venture into the unknown.

As we head into this holiday season, it is a good time for each of us to look into our hearts, to see our neighbors without blinders. They aren't seeking to invade America. They aren't long-

**The Myth of "Law and Order" in America**

I have long been troubled by the fact that politicians, including judges and lawmakers, will and do swear "upon the Bible" that they will "faithfully execute" the requirements of their offices or "tell the truth, the whole truth and nothing but the truth" but once in office or on the witness stand, promptly ignore their very promises - made, presumably, to God.

This president, as have all presidents, made serious promises to "... faithfully execute the Office of President of the United States, and will to the best of my ability, preserve, protect and defend the Constitution of the United States," but at every turn, seems intent on dismantling the components of this government in order to impose his desire to be an authoritarian leader.

United States senators and representatives likewise promise to "support and defend the Constitution," but their commitment right now is clearly to support and defend the president, at the expense of many of the people who elected them.

Presumably, many people lie while testifying in criminal cases, but when law enforcement officers do it - which they frequently do - the result is too often people being wrongly convicted and imprisoned. A report published by The Innocence Project determined that since 2015, police lied under oath more than 25 times. (<https://www.innocenceproject.org/prevalence-police-lying/>)

My hunch is that that number is far greater than we know. Why is this kind of lying tolerated by a judicial system which touts its commitment to "law and order?" And why aren't more Americans upset that in the current administration, not only is the lying leading to a total disrespect for the rule of law but is also contributing to the ruination of this government as we have known it?

And then there is the big question: in a country in which citizens boast of being "Christian," even as they put down other religions, why is lying tolerated even though people supposedly pledge their obedience to God by putting their hands on the Bible? Where is the outcry?

What we are seeing is the raw disrespect people in power have for "law and order," and their arrogance in ignoring it even as they break the rule of law themselves. A woman who as a young girl was caught up in sex trafficking and ended up killing a man whom she thought was going to kill her must spend 51 years in jail before she can be considered for parole. ([https://www.huffingtonpost.com/entry/cytoia-brown-life-sentence-supreme-court\\_us\\_5c0c7f30e4b0ab8cf693f5c5](https://www.huffingtonpost.com/entry/cytoia-brown-life-sentence-supreme-court_us_5c0c7f30e4b0ab8cf693f5c5)), while a young white college student will get no jail time for allegedly raping a young woman, even though he is now not being allowed to graduate. Crystal Mason voted because she thought that she was allowed under Texas law even though she had a criminal past, but found out the hard way that her supposition was incorrect and she was sentenced to five more years in prison for voter fraud (<https://www.cbsnews.com/news/crystal-mason-texas-woman-sentenced-to-5-years-for-voter-fraud-speaks-out-on-felon-voting-rights/>) while Brian Kemp, who was Secretary of State in Georgia even as he ran for governor, won that election and is not being held accountable in spite of evidence of voter suppression. (<https://www.nytimes.com/2018/11/04/us/politics/georgia-elections-kemp-voters-hack.html>)

All of this, and so much more, goes on in this country in spite of oaths uttered promising to uphold the law "so help me God."

What this reveals is a disregard and a disrespect for the United States Constitution and for the God whom people say they loved. We have in this country a disdain for God's law and an arrogance about the need to promise to obey and follow laws made by human beings. There is no "law and order" in this country when it comes to how the wealthy and powerful live their lives. They do what they want, law and US Constitution notwithstanding, confident that they can use their money - which is their power - to circumvent whatever laws they may break.

Meanwhile, people who have few resources to even survive, let alone pay for attorneys who know how to work the system, end up in prison for crimes which should not be the basis for them being locked up for decades. For example, a friend of mine shared that she has a cousin who is spending 25 years in prison for stealing \$25 from a store, while former Donald Trump attorney Michael Cohen will serve only three years for crimes which may adversely affect this country for a long time.

Police officers get away with using state-sanctioned violence in their work, while a woman in Florida who abided by the "stand your ground" laws and fired a shot into the air to fend off a man who was about to attack her was given 20 years in prison. (<https://www.nytimes.com/2017/02/07/us/marissa-alexander-released-stand-your-ground.html>)

The judicial system in this country is apparently one that can be deftly manipulated and bypasses if one has the resources to do it. "Law and order" is of no concern to the wealthy; they use the system to increase their wealth and chew up, swallow and throw away laws that should by definition bring them down. Meanwhile, our prisons are filled with people, too many of whom committed crimes which could have been punished in a more productive way for them and for society. The absence of law and order in the practices of the powerful is killing this country by killing individual communities.

To the rich and powerful, it seems on this end that to them, the notion of an exacting God, one which holds all people to accountability, is of no concern. They have no more regard for God than they do to the Christian Bible on which they place their hands when they promise to uphold, protect and preserve this country and its ideals.

The Bible says that God will not be mocked. Maybe not, but God has remained strangely quiet as the rich and powerful tout the myth of "law and order" to justify their treatment of "the least of these." To be clear, they have shown that upholding "law and order" is viewed by them as a way to hold onto their power at the expense of everyone else.

Society Transformed Safely Transitioning Every Person (FIRST STEP) Act with an overwhelming bipartisan majority.

Rep. Bass has been a leading advocate for a legislative package based largely on the National Urban League's Main Street Marshall Plan, the Jobs and Justice Act. As she explained in a statement announcing the introduction of the omnibus bill, during the 2016 Presidential campaign, an infamous question was asked of African Americans: "What do you have to lose?"

Rep. Bass and the CBC executive leadership team answered that question in the form a 130-page policy document titled, "We Have A Lot to Lose: Solutions to Advance Black Families in the 21st Century." That document, along with the Main Street Marshall Plan, served as the basis for the Jobs and Justice Act.

Prior to serving in elected office, Rep. Bass worked as a Physician Assistant and

served as a clinical instructor at the University of Southern California's Keck School of Medicine. In response to the gang violence epidemic sweeping Los Angeles in 1990, Rep. Bass founded Community Coalition, a community-based social justice organization addressing the root causes of injustice.

The other officers elected to lead the CBC for the 116th Congress are Rep. Joyce Beatty (Ohio 3rd), 1st Vice Chair; Rep. Brenda Lawrence (Michigan 14th), 2nd Vice Chair; Rep. Hank Johnson (Georgia 4th), Secretary; Rep. A. Donald McEachin (Virginia 4th), Whip; and Congressman-elect Steven Horsford (Nevada 4th), Parliamentarian.

**To be young, gifted, and dead**

McKenzie Adams wanted to be a scientist. The gregarious 9-year-old Alabama girl was just that, a girl, a little girl, a brown-skinned baby girl with braids or, in one picture, just a side ponytail. She wanted to be a scientist, and her family described her as "bubbly" but bubbles burst, sometimes in the worst way. McKenzie hung herself in her grandmother's home in the face of racist bullying and taunting, which included the vile directive to kill herself. Her fellow students didn't like the fact that she was friends with a white boy, and we don't know enough to know whether the deathly hazing came from Black or white students. All we know is that a child is dead, a baby black girl is dead. Her suicide has shaken me to my very soul.

currency is at the bottom of the societal totem pole. What, you might ask, does that have to do with public policy? The demonization and denigration of Black women seep into the ways we are dealt with in the public space, and even in the workplace.

Little McKenzie could not take being called ugly, Black, and more. She was not immunized from the ways we live in a racially hostile space. She could have been a scientist.

dead. She is not the only young Black child who has died by her own hand. Earlier this year, US News and World Report writer Joseph P. Williams reported that suicide rates among Black children were rising. He highlighted children, both male and female, promising young people who ended their own lives. According to Williams, "More elementary aged African American children have been taking their own lives, and Black boys and girls between the ages of 5 and 12 are doing so at roughly twice the rate of white kids the same age."

Researchers say they don't know why young Black children are killing themselves, but if we speculate we can factor in mental illness, family dysfunction, unstable socioeconomic conditions and, in my opinion, hostility to African American people that many Black children

cannot help but internalize. How might young Black people process the killing of Tamir Rice? The murder of Sandra Bland? In Baltimore, the vicious killing of Freddy Gray? Some young people might look at these incidents, and the barrage of episodes directed at Black people, and wonder if there is a safe space for them.

Part of the challenge with Black children and suicide is that Black people are not accustomed to sharing their feelings. Indeed, mental health issues are often dismissed among African Americans. Folk are told to "pray" about depressed feelings, forgetting that prayer without works is dead. Adults and children are advised to shrug it off when there is no shrugging to do. The feelings of dystopia, nihilism, and depression that many African Americans experience because of the hostility they experience by merely living in their skin shows up in suicides, but also in homicides and in other acting out. And while young Black men may indulge in senseless violence, young Black women too often turn their pain inward not outward.

Gender stereotypes are not always appropriate. Both Black girls and boys are killing themselves. Both Black girls and boys are working out some of their pain through violence. According to some data, Black girls are now involved in violent incidents with each other almost as often as Black boys (blame the housewives, just kidding). Both Black girls and Black boys are being



## Members of Congress introduce Bill to award Aretha Franklin with Congressional Gold Medal



Many of the tributes to Franklin since her passing have emphasized not only her musical talent but her role in shaping and empowering the role of women with songs that gave voice to life experiences from a decidedly female perspective.

In the wake of the August 16th death of the "Queen of Soul," Aretha Franklin, Senators Kamala Harris (D-CA) and Orrin Hatch (R-UT), along with Representatives Brenda Lawrence (D-MD) and Doug Collins (R-GA) have introduced legislation to posthumously award Franklin the Congressional Gold Medal.

The legendary artist died of pancreatic cancer at the age of 76.

"Aretha was simply a legend. Her work and impact will be felt for generations to come, and it's long past time Congress honor her with the Congressional Gold Medal," said Senator Harris in an August 21 release.

The legislation will be called, "The Aretha Franklin Congressional Gold Medal Act" and, should it become law, it will honor Franklin's role in "shaping the nation's cultural and socially relevant discography and highlight how she was an example to all people in how one person's talents can make a difference in the lives of millions of people across the globe."

Many of the tributes to Franklin since her passing have emphasized not only her musical talent but her role in shaping and empowering the role of women with songs that gave voice to life experiences from a decidedly female perspective.

Aretha Franklin's involvement in civil rights is also noted in the legislation. Her

music often served as a call to action that inspired thousands to join civil rights movements and still maintains a social context that resonates across events even in present day.

"I am proud to join Senator Harris in introducing a bill to award a Congressional Gold Medal to honor an American music legend, Aretha Franklin, for her contributions to American music culture," said Rep. Lawrence.

"Aretha Franklin was soul personified and she gave us the gift of her voice, her truth and her unapologetic passion to demand compassion, love and R-E-S-P-E-C-T for women everywhere. An iconic entertainer, powerful civil rights leader, history maker and a beautiful spirit I was privileged to call friend; we honor this Detroit native, the true Queen of Soul. She will be dearly missed, never forgotten and always treasured," Lawrence added.

"Aretha Franklin's legacy, like her voice, will sing through the generations," said Senator Hatch. "Through her talent, she touched the hearts of millions, lifting all of us with songs of hope and humanity. Aretha brought light, laughter, and love to all who would hear. I'm grateful to play a small role in honoring the life of this remarkable artist."

The legislation is expected to pass and be signed into law.
