

Community angered by Williston arts school proposal

Florence Johnson Warren proudly graduated from all-Black Williston Senior High School - "The Greatest School Under the Sun" - in 1963, five years before the New Hanover Board of Education vengefully closed it down in retaliation for a federal judge's ordering the system to desegregate its high schools.

Williston Senior High was shuttered, later to be resurrected as a middle school, as it remains today.

Now, in the wake of news that the school board is considering a proposal to turn Williston Middle School into an arts high school, alums of Williston Senior High, like Ms. Warren - also a former Williston instructor and Barbara Smith-Walker, class of 1955, say they've seen this movie before and do not like the ending, especially if it does little to help Black children achieve the skills necessary to suc-

ceed.

"We are very concerned about this proposal," Ms. Smith-Walker, a member of the Williston Alumni Association, told *The Journal*. "I object that it should be a school of the arts."

"What does that mean, exactly?" she continued. Our students need a curriculum that will give them a job, such as technical studies, along with liberal arts courses."

Ms. Smith-Walker ended her reaction by saying that she hoped to learn more about "...what seems to me to be another railroad tactic."

The Williston Alumni Association is already on record, per a letter issued and read at the Jan. 8, 2019 NHC School Board meeting, as formally opposing the proposal.

Ms. Deborah Dicks Maxwell, President of the NHC NAACP, is not an alumna of Williston Senior High School, but the idea of transforming it into an arts high school still disturbs her.

"Not in favor of this [arts] school

personally as it was almost cloak and dagger the way it was thrown at us," she told *The Journal*.

In the various forthcoming community meetings and forums that will be held on this controversial proposal, NHC School Board members can expect to hear much of the same, especially from the African-American community, which historically has had its fill with school system leaders politically manipulating the education of Black children against their ultimate welfare.

The school system closed Williston Senior High in 1968. Williston not only was New Hanover County's only Black high school, but it was academically considered one of the finest high schools in the South. The school system refused to bus White students there to keep it open.

In the interim, Williston has served in various capacities, including a ninth-grade center and math and science magnet school, in addition to its current status as a middle school.







Regardless of what the SBOE does, Congress may decide 9th District seat

The president of the NC NAACP vows that if Pres. Trump re-nominates Raleigh attorney, Thomas Farr, to become a federal judge in North Carolina's Eastern District, the civil rights group will be right back in the fight to defeat his U.S. Senate confirmation once again.

Dr. T. Anthony Spearman, President of the NC NAACP, was responding to reports that now, with South Carolina Sen. Lindsay Graham, one of Pres. Trump's most loyal Republican supporters, now the new chairman of the Senate Judiciary Committee, recently published reports say he's met with the White House recently to go over a list of Trump's judicial nominees who were not taken up by the Republican-led Senate for con-

fimation in the 115th Congress.

Farr, a former campaign attorney for racial segregationist, Sen. Jesse Helms (R-NC), who is documented to have coordinated a so-called "ballot security" program for the Helms campaign against Black Democratic voters in the 1980's and 90's, was nominated by Trump in 2017 and had his nomination voted out by the Senate Judiciary Committee in early 2018, only to have it temporarily shelved before going to the full Senate before the midterms.

After the November midterms, Senate Majority leader, Mitch McConnell scheduled Farr's confirmation, only to have a damaging *Washington Post* piece expose Farr's role in Helms' campaign ballot security scheme,

WHITE MALE CHARGED WITH ASSAULT OF 12-YEAR-OLD GIRL AT MALL

[ASHEVILLE] A 51 year-old white male from Black Mountain has been charged with assault on a 12-year-old girl after an altercation Saturday evening outside of an area shopping mall. David Bell, who is said to stand 6' 1" and 250 lbs, is also charged

with two counts of assault on a female after violently striking the black female pre-teen.

A video of the alleged incident shows Bell in the middle of a group of teenage girls outside one of the mall's entrances, angrily exchanging barbs. A young black girl approaches Bell yelling at him. He shoves her back hard. She then rushes back, raising her right arm as if to punch him, but before she does, he braces, and punches her with a crushing left closed fist. The girl hits the ground immediately, apparently stunned. An off-duty police officer later arrested Bell. The girl refused medical attention. At least one

onlooker said Bell was trying to break up a fight, and stepped in, pushing the teens away. He is scheduled to be in court on Feb. 5th.

UNC CHANCELLOR FOLT TO LEAVE AFTER ORDERING SILENT SAM PEDESTAL REMOVED

[CHAPEL HILL] Originally she was supposed to step down after spring commencement. But after she ordered the pedestal to the controversial Silent Sam statue removed Monday evening, outgoing UNC-Chapel Hill Chancellor Carol Folt will be leaving her post in two weeks. Her unannounced action

apparently caught her bosses, the all-Republican UNC Board of Governors by surprise, which voted to end her employment Jan. 31st. In a statement, Folt - who has been at the helm at UNC - CH since 2013, said the safety of students on campus was her highest priority, and given that the statue (forcibly removed last August and currently held in an undisclosed location) represented white supremacy, she saw no choice.

HEARING FOR HARRIS IN 9TH DISTRICT CASE SCHEDULED FOR JAN. 22ND

[RALEIGH] The hearing in

Wake Superior Court requested by Republican Mark Harris, the candidate in the controversial Ninth Congressional District race that was marred by alleged illegal absentee ballot handling, has been set for Tuesday, Jan. 22nd at 10 a.m. at the Wake County Courthouse in Raleigh. Harris, who unofficially won his race against Democrat Dan McCready, asked for a judge to certify the race when the State Board of Elections twice declined to certified the result. Harris is expected to maintain that as long as the vote count was not affected, the race should be certified.

redistricting plans that assigned a large percentage of high poverty students to the school, along with a considerable lack of resources, has mightily contributed to any deficiencies.

In published reports, NHC School Board Vice Chair, David Wortman, the originator of the arts high school proposal, says he's starting an exploratory committee "immediately," based on survey results that "85 percent" of county parents support the idea of a performing arts high school. Other board members, however, say, given the level of community con-

cern, especially in the wake of adoption of the new school redistricting plan last week.

The Williston arts school proposal was discussed, and it was clear that if it is later adopted, middle school students who currently attend, will be transferred elsewhere.

followed by members of the NCNAACP, led by Dr. Spearman, to go to Washington, D. C. and lobby vigorously against it.

One of the several Republican senators they lobbied was Senator Tim Scott, of South Carolina, the Senate's only Black GOP member. Ultimately it was Senator Scott, along with the outgoing Senator Jeff Flake (R-AZ), who announced they would not vote to confirm Farr, thus crippling Farr's chances of passage because the GOP slim majority had eroded.

However, Republicans in the Senate did very well during the midterms, padding their number to 53 to 47 Democrats, meaning that at least four Republicans would have to buck Farr's re-nomination in the new Congress.

Sen. Thom Tillis (R-NC), strongly supported Attorney

Farr before, and says he would do it again.

"We're looking at it right now," Tillis told McClatchy [Newspapers] last week.

That is not something that Dr. Spearman is pleased to hear.

"In light of recent events, the possibility of Tillis' and (NC Sen. Richard) Burr's resurrecting Farr's nomination is certainly viable, especially with Graham's urging," the NCNAACP leader said. "However, this would fly in the face of the only seated African American [Republican] Senator [Scott] whose broken silence is speaking powerful truths."

"Will the Republicans declare themselves outright racists," Dr. Spearman continued, asking rhetorically. "If so, the NCNAACP will not stand down. We will stand strong and endure."

The Eastern Judicial District is where at least 30 percent of North Carolina's black population resides, yet an African-American judge has never presided over fed-

eral court there in its 145-year history.

Dr. Spearman, along with other civil rights leaders, says it would be a mockery to have someone with Attorney Farr's reported racial history - which includes defending the NCGOP's racial gerrymandering and voter ID laws - serve a lifetime appointment to the bench there.







Government shutdown hits African Americans the hardest

With over 50,000 federal employees, the fourth congressional district in Maryland represents the fifth largest number of workers, and Maryland likely counts as the third-largest impacted state by the government shutdown, according to Democratic Rep. Anthony Brown.

"So, I'm hearing about this, like my colleagues, each and every day from my constituents while this shutdown is set to become the longest in the nation's history," said Brown, who joined Congressional Black Caucus Chair Karen Bass (D-Calif.); Rep. Bennie Thompson (D-Miss.), and Rep. Barbara Lee (D-Calif.), on a media conference call on Friday, Jan. 11.

The CBC members said they were calling for an end to the shutdown so that workers can again begin to collect their paychecks and critical government services can resume.

During the call, the members discussed the debilitating effects of the ongoing government shutdown as thousands of federal employees are unable to collect their paychecks.

They also denounced President Donald Trump's threat to declare a state of emergency if Congress refuses to fund a border wall — one in which the president claimed during his campaign that Mexico would pay for.

"This shutdown and the whole issue of the wall is a fake crisis," Bass said.

"At the end of the day, even if he had all the money, it would still take eminent domain to build his wall. That process will take years. This is further evidence that this is a fake crisis and, in my opinion, just an attempt to change our attention away from the numerous impending investigations," she said.

Thompson, the chair of the Homeland Security Committee, said the shutdown is taking its toll on workers and government operations.

"It is a challenge for us in Homeland Security. We have 80 percent of the workforce not being paid. That goes from TSA employees in airports, to the Coast Guard, to the Secret Service, to Custom Border Protection individuals, and all of those individuals who have sworn to keep us safe, are not being paid," Thompson said.

"That's not fair and we are compromising our national security strategy by reducing the morale of the employees."

On Saturday, Jan. 12, the shutdown entered its 22nd day, a record.

NBC News and other outlets estimate that 800,000 federal employees are furloughed or working without pay because Trump and Congress cannot reach a deal to reopen the government.

They are at an impasse over \$5.7 billion for construction of a wall along the southern border.

The number of furloughed employees does not include federal contractors, according to a report by NBC News.

It's unclear how many contract or grant employees are affected by the shutdown — or even how many there are in total — but a Volcker Alliance report estimated that nearly 5.3 million worked as contractors in 2015.

Unlike furloughed federal employees, who have received assurances that they will be paid once the shutdown ends, contractors are not owed back pay and that has left them in an even murkier economic position.

Further, communities of color are probably the hardest hit by the shutdown, said Lee, who co-chairs the Steering and Policy Committee and serves on the House Committee on Appropriations.

Black people comprise 12 percent of the country's population but are 18 percent of the federal workforce, according to the Partnership for Public Service.

"We know that communities of color are disproportionately affected by this irresponsible Trump government shutdown. And today is especially painful for so many workers because it should be payday," Lee said.

Without these paychecks, many federal workers are hanging on by a thread, she said.


"I know there are hundreds of thousands of families out there who are grappling with the anxiety, and really fear, of not being able to pay the bills as this shutdown drags on."

"Let's be very clear: what's happening here is President Trump is holding this government hostage and holding people hostage in order to get his useless, wasteful wall," Lee said.

A change for the better: House rules on staff diversity

Diversity matters. In a world that is both diverse and deeply interconnected, companies and institutions with greater levels of diversity are achieving better performance. Most organisations, including McKinsey, have more work to do to take full advantage of the opportunity presented by a more diverse leadership team. Organisations also have more work to do on their talent pipeline to attract, develop, mentor, sponsor, and retain the next generations of diverse leaders at all levels. But with the rewards of diversity set to increase, investing now is the best plan. Winners will pull further ahead and laggards will fall further behind.

The National Urban League congratulates the U.S. House of Representatives, which

approved a rules package creating a new Office of Diversity and Inclusion and requiring the appointment of a Chief Diversity Officer and the development of a diversity plan.

Congressional staff diversity has long been a top priority of the National Urban League. Just last month, we joined with more than 60 other national civil and human rights organizations and stakeholders in sending a letter calling on Members of Congress to prioritize diversity in hiring top staff.

In the letter we encouraged the Members to take the following steps:

1. Set Clear Goals: Promptly develop hiring goals to ensure diversity among those hired in new top and key mid-level staff position openings in your

office.

2. Adopt a Diversity Plan: Develop a written office diversity and inclusion plan that includes recruitment and hiring goals, retention and development strategies for staff, data collection and analysis procedures, a clear allocation of responsibility among staff and performance evaluation for implementation of the plan, and unconscious bias training for all managerial staff involved in recruitment, hiring, evaluation, and retention.

3. Adopt the Rooney Rule: Formally adopt and implement the Rooney Rule, which would require your office to interview at least one person of color for every top and key midlevel staff position opening. Senate Democrats adopted this rule in 2017. Data should be kept to measure the compliance and effectiveness of the rule.

4. Support Chamber-Wide or Conference-Wide Efforts to Improve Staff Diversity, such as the creation of an independent and bipartisan Diversity

Office, the disclosure of demographic data of staff, and adoption of the Rooney Rule.

These are the same recommendations we made when we hosted a panel on diversity at the U.S. Senate nearly two years ago.

Soon afterward, we delivered senior-level resumes of qualified, African-American candidates to senators who represent states with a high percentage of minority residents. Our intention was to encourage senators to consider a diverse pool of candidates when hiring for positions like chief of staff, legislative director, and communications director.

Newly-elected Senator Doug Jones of Alabama last January appointed the first Black Chief of Staff in the Democratic caucus, joining Republican Senators Tim Scott of South

I know it's your business where you spend your money, but I can't help but wonder where many of us would be today if our ancestors like Dr. Martin Luther King, Jr., Fannie Lou Hamer, Amelia Boynton Robinson, Medgar Evers, John Lewis, Rosa Parks, and a whole lot of our warriors for justice would have taken the position that they were not going to risk their lives for the good of our community so long as they were personally benefiting.

my dollars to destroy my community." I trust that that's where most of us are. The National Congress of Black Women, under the leadership of my predecessor, Dr. C. Delores Tucker, has been working to rid our community of this filth called gangsta rap for many years. We've continued to make the lives of our young people better. Recently, we've been blessed to be joined by Bob Law-Chairman, National Black Leadership Alliance, Kwabena Rasuli and Bernard Creamer of Clear the Airwaves. Some will tell you

these performers are just talking about their reality. To that I say, "Your breath smells bad when you wake up, but you brush your teeth to change that reality. Those who want to change/better their reality don't do gangsta rap."

In our continuing effort to put an end to the filth and the damage it creates, we recently invited some of the biggest offenders to meet with us in New York so that we could help them understand what the ads they pay for are doing to destroy our community. While we had representatives from many groups attend, not one of the biggest offending advertisers invited (McDonalds, Subway Restaurants, JCPenney, Kohl's or Adidas) attended. After at least 5 contacts with each company, not one had enough respect for the Black community to send a representative, forcing us to take action. Our call to action is against "hateful rhetoric that encourages violence against Black women." Our movement is called "Respect Us" and to be clear, this is not about free speech. It's about getting rid of hostile environments.

All of us appreciate righteous, conscious music, and we would urge offenders to spend their advertising dollars to promote that kind of music.

Since the named corporations have chosen to disregard our willingness to hold a reasonable discussion about the matter at hand, we have been forced to ask every conscious member of our community to refrain from spending your dollars at the offending companies named in this article until they respect our community enough to withdraw their advertising dollars making the offensive gangsta rap possible. Our starting targeted areas are New York, Chicago and Washington, DC. Others may be added as necessary.

Carolina and Jerry Moran of Kansas.

In a letter accompanying the resumes we sent to the Senate, I wrote:

At the core of economic civil rights is the idea that all people should have access to jobs for which they are qualified.

Despite the progress this country has made related to corporate diversity and inclusion, our Congress, specifically the U.S. Senate, has failed to move the needle when it comes to diversity and inclusion. This is deeply concerning and an embarrassment to our country. While policy decisions affecting all Americans are debated in the halls of Congress, persons of color are largely absent in top-level staff positions. Thus, on issues like education, the economy, health care, and decisions of war and peace, Members of Congress are legislating without the perspective of black and brown staff.

According to the Joint Center for Political and Economic Studies, more than 31 percent of top staffers hired so far by newly-elected House Members are people of color

As of September, fewer than 14 percent of top staff in the House were people of color.

The rule change is a significant step toward a Congress that truly represents the rich diversity of the nation and an expansion of economic opportunity for all Americans.

Essentially, Trump now has three choices. He can stay in office and be impeached. The evidence of high crimes and misdemeanors is building each day, from trampling election laws by payoffs to keep his mistresses quiet to blatant self-enrichment that surely offends the Constitution's ban on emoluments, to open and secret efforts to obstruct justice.

Democrats will no doubt wait for special prosecutor



REALITY CHECK**Economics, not electoral politics, is the key to success**

At the risk of being accused of repeating myself, I will say once again that black people who live in the continent of North America (aka USA) continue to recognize the importance of maximizing their economic potential.

In 2018, as in the previous 100 or so years, we as a people put most all of our time, energy, and resources into electoral politics. We jump for joy when a black person is nominated for or elevated to some political position without understanding that a group of people may have a limited degree of political influence but will absolutely never have political power without

economic power.

No one better understands and explains this better than the perceptive visionary James Clingman, who warns us of this basic fact over and over again in his must-read book, *Black Money Matters*. The book, published in 2015, includes the following:

"Our aggregate annual income of \$1.2 trillion is mainly used to create wealth for everyone except black people because we spend the vast majority of it at their businesses. Politics has not and will not solve these issues. We must solve them ourselves by 'the work from our own hands' as Martin Delany told us. This book deals with the potential and economic issues that affect us and between 2008 and March 2015; it directs the readers' attention not only to the problems we face as individuals and as a collective, but also to practical, achievable and appropriate solutions. It points us to a way out

of the economic ditch in which we have remained for decades since the 1960s when we owned more assets, relatively speaking, and controlled economic enclaves across the country...Each day we can see how much 'Black Dollars Matter' to everyone else's worth and well-being, the question is:

How much do they matter to black people? This is my final attempt to enlighten, to inspire, to challenge and to change our thinking in such a way that it has a positive impact on those who come behind us. It encourages the elders among us but our passing must be with patience, direction, advice and counseling."

This is serious guidance from a Brother who now is dealing with a debilitating illness. In his book he does exactly what he advocates above. It offers concrete guidelines on how to more effectively use our collective economic resources in the

campaign against white supremacy and for equal right, equal opportunity and equal justice.

By the way, Prof. Clingman is not the only one who urges us to do more to maximize our economic potential rather than relying much too much on electoral politics. Ancestors such as Booker T. Washington, Mary McLeod Bethune, Marcus Garvey, Chancellor Williams, Harold Cruse, Brother Malcolm X, and Dr. Martin Luther King, Jr. have also spoke out on our becoming more diligent and intelligent economically.

If we chose to ignore their wisdom and guidance in this arena, we will have no one to blame but ourselves if other ethnic and religious groups continue to take advantage of our willful ignorance.

Shame and shade in Birmingham: In praise of Angela Davis

If anyone deserves a civil rights award, Angela Davis certainly does. The activist and scholar has been on the front lines of the civil rights movement all of her life. She has been especially active in prison reform matters, but she has also been involved in other civil and human rights issues.

When I learned back in October that she would get the Fred Shuttlesworth Human Rights Award from the Birmingham Civil Rights Institute, I was absolutely delighted. I imagined the wide smile the daughter of Birmingham must have flashed when she learned that she would be honored.

Everyone in Birmingham wasn't thrilled, though. Some people in the conservative Southern town seemed disturbed that she had been a member of both the Black Panther Party and the Communist Party. Others were concerned about her support of the BDS (Boycott, Divestment and Sanctions Movement) against the Israeli occupation. She has said that she stands in solidarity with the Palestinian people, and advocates for their fair treatment in Israel.

Some ill informed people consider the BDS movement "anti-Semitic". They suggest that any questions that one raises about Israel shows a bias against Jewish people. But Davis, a lifelong human

rights activist, is concerned about the humanity of Palestinian people, as well as other people.

And she is rightfully concerned, as many of us are, about the spate of laws recently passed that downright outlaw the BDS movement. According to the Middle East Monitor, a teacher in Texas, Bahia Amawi, refused to sign an oath that required her to pledge that she "does not currently boycott Israel", that she will not boycott Israel and that she will "refrain from any action that is intended to penalize, inflict economic harm on, or limit commercial relations with Israel".

Texas is among some 25 states that have passed laws forbidding the state from doing business with companies that boycott Israel! It will also not invest pension funds in companies that support BDS. Thirteen more states including Washington DC, have similar laws to the Texas law pending, pitting people's first amendment rights of free speech against support for Israel.

And Florida Senator Marco Rubio, in the middle of a government shutdown, had the nerve to introduce national legislation that mirrors the Texas law (actually, Illinois was the first state to pass this discriminatory law).

Lots of people in Birmingham aren't having it. Though the "Civil Rights Institute" has rescinded its award to Dr. Angela Davis, there has been significant protest about the decision.

Birmingham's Mayor, Randall Woodfin, who is a non-voting member of the Museum Board and did not

participate in the decision to rescind the award (the city provides the museum with about a million dollars a year in operating funds) has expressed his dismay about the decision. Three board members have resigned from the board. And Alabama columnist Roy S. Johnson has written a fiery column accusing the Civil Rights Institute of insulting Rev. Shuttlesworth and staining its own legacy. Johnson says the Birmingham Jewish community may have been the loudest, but not the only folks pushing for Davis' award to be rescinded.

Who rescinds an award after it has been granted for statements that were not recently made, but are a matter of record? Angela Davis has long been an outspoken activist, just like Rev. Fred Shuttlesworth was. Nothing had been changed from the time Davis was notified of the award and January 4, when it was rescinded. The BCRI did not have to honor Davis, but their canceling the award is a special kind of insult.

Fortunately, Angela Davis has a thick skin, and she knows exactly who she is. She didn't cringe when then-California governor Ronald Reagan had her fired from UCLA for her membership in the Communist Party. She didn't flinch when she was incarcerated for a crime she did not commit. And she will not tremble because the BCRI rescinded the award.

Indeed, demonstrating the indomitable spirit that she is known for, Angela Davis will travel to Birmingham in February for an alternative event. And the Birmingham Civil Rights Museum has egg on its face. That city showed

a young Angela Davis who they were when the Four Little Girls, some of whom she knew, were killed at the 16 Street Baptist Church in Birmingham. And they are showing her who they are once again. Shame and shade!

Unfortunately, I'm not surprised. One of the founders of the Women's March has demanded the resignations of Tamika Mallory and Linda Sarsour because they attended one of Minister Louis Farrakhan's Savior's Days. Marc Lamont Hill lost his CNN commentary gig because he spoke up for Palestinian rights. Alice Walker has been criticized because she supports BDS. Now Angela Davis is being denied an award. When is enough going to be enough?

For the record, I support Palestinian rights. And I support Israel's right to exist. Are the two incompatible? I think not. The one-state solution, with a right to return, and full citizenship rights for Palestinians makes sense. But Israel is not about to budge, and BDS as an attempt to influence it. States passing laws to outlaw free speech erodes the first principle of our Constitution and undercut the actions at the very foundation of our nation. Remember the folks who dumped tea into the Boston Harbor because of an unfair tax? Today that action might be against the law!

When Donald Trump became a candidate for president of the United States, there was a fairly substantial number of Republicans who pushed back against his rhetoric, his name-calling, and his general disregard for diplomacy and decorum.

His fellow candidates decried his lack of character. This man was no serious contender, they seemed to suggest. He was compared to a used car salesman; candidate Ted Cruz called him a "pathological liar," "utterly amoral," and a "narcissist." The battle was brutal. Nothing, though, that Trump said or did riled his supporters, his almighty "base." There was no lie, no insult, no racial or sexual slur, no put-down of American heroes - nothing - that could pull them from his side, and he won. (<https://www.cnn.com/2016/05/03/politics/donald-trump-rafael-cruz-indiana/index.html>)

And now, most of the Republicans who criticized him are glued to his side, seeking his help and support, making excuses for him, with no shame.

It is difficult to watch.

What Cruz said about Trump is true: he is, in fact, a pathological liar, and a shameless one at that. But Cruz sucked up to him in order to win his bid for reelection to the Senate, and he won. Lindsay Graham, who had many crass words for Trump, is now acting like his best friend, basically endorsing anything Trump says he wants to do. Mitch McConnell is a shameless sycophant, leading the Senate to honor the president and his wishes over the well-being of the country whose constitution he swore to honor and protect.

The evil of Trump, simply put, spread. The late theologian Walter Wink said that evil is a contagion and said that many people who fight evil will become evil. Specifically, he said, "...the struggle against evil can make us evil and no amount of good intentions automatically prevents this from happening." (<http://www.lqve.org/blog/2018/11/9/the-real-struggle>) It seems that the majority of Republicans, who may have prided themselves on being "good" and on the right side of morality, have slipped into Trump's moat and have found that deep within, they are not all that different from him. Moreover, they do not seem to care; the contagion has infected their very souls.

The partial government shutdown has illustrated the depth of the evil that is bubbling around us. Few of the Republican senators have voiced outrage or concern for the nearly 1 million people who did not get paid. Few have offered any solution which would indicate that they care about or worry about how people are going to get through this economic catastrophe. Graham is on record as having told Trump to go ahead and declare a "national emergency," not caring about how doing that will seriously undermine the capacity of such an emergency to be called if really needed. (Reports say that there is no "national emergency" on the Southern border.)

Even as discussion about other ways to get the \$5.6 billion Trump is asking for, there has been little outrage at the suggestion that money designated to help cities in America hit by natural disasters be redirected to build "the wall." The so-called "fiscal conservatives" are showing their willingness to spend money at will, and Trump himself said that he doesn't worry about the consequences of the tremendous debt he is incurring because when that happens, he won't be around. (<https://www.thedailybeast.com/trump-on-coming-debt-crisis-i-wont-be-here-when-it-blows-up>.)

To not care about those who suffer is evil. To buy into policies that will adversely affect millions of people is evil. To act like your life is the only one that matters is evil. It is as though Trump sneezed and his infected droplets fell all over the souls of the GOP. The evil is spreading, following the path on which other democracies found themselves before they ultimately fell. And the evil is not just spreading among the lawmakers; it is spreading amongst the general population. Extrajudicial, state-sanctioned shootings are not only continuing but increasing; white civilians are calling the police on black people at will; hate crimes are rising, and there seems to be no "doctor in the house," no lawmaker or judge who is concerned about the decaying of our social fabric.

Walter Wink was right. Evil is contagious, and like a necrotic bacteria, it is eating this country alive.

nation the agony of what will inevitably be an ugly, divisive fight over impeachment and over criminal indictment after he is defeated.

Americans tend to forgive and forget, once an offender resigns. President Gerald Ford took a hit for pardoning President Richard Nixon, but Nixon survived and regained some of his stature with books on foreign policy. Pelosi and Schumer might take a hit for cutting a deal with Trump, but Trump could retain his freedom and his celebrity, with a base surely willing to support him in the wilderness.

It has come to this: impeachment, disgrace or resignation. Trump, no doubt, will rail against his fate. He'll claim he could be vindicated in court or in Congress or in the elections. His twisting will grow more frantic and more venomous.

His impulsive and destructive behavior — pulling troops out of Syria suddenly and then reversing position and reversing again, shutting down the government over a wall that won't be built, using the bully pulpit to try to intimidate his former associates who are testifying against him — will get ever more dangerous.

His flailing only deepens the hold that he already has. Trump never expected to win the presidency. He clearly might find it sensible to save his fortune and freedom by resigning from a position he never expected to hold.


Remember! We can do more today to help in this changing society. It may seem a little thing to give respect and give a friendly smile, but

GET THAT DEED AND FLIP THOSE KEYS!**Credit impacted by recent hurricane?**

Lately, I have come across several individuals whose credit scores have declined due to financial hardships during the aftermath of Hurricane Florence. There are protections in place to prevent creditors from reporting late payments for borrowers located in "official" zip codes affected by disasters.

Every creditor should have access to this zip code list and in those areas, they may work with the borrowers and not report missing or late payments. I'm finding that even when the late reporting is challenged and the creditor agrees to reverse the negative reporting, the correction on the credit scores may not be immediate.

Therefore it is important that you have the creditor provide a written statement acknowledging your account is current and in good standing... These missed, deferred

payments are sometimes moved to the back of the loan and sometimes they keep rolling over as a past-due amount. If you are dealing with bruised credit due to negative reporting, I encourage you to contact the creditor, ask to speak to the head manager on duty at the time and get a resolution.

Make sure to get the names, direct phone numbers, and extensions of every person you speak with in reference to your account. You may find a need of that in coming days until your credit scores have been com-

pletely restored. If after doing all of this and you're still not having any resolution, contact the North Carolina Consumer Protection Agency for guidance on what to do next. You can reach them by calling 877-566-7226.



This happened several years ago in Providence RI, and I still wonder if there were something more the family could have done. Don't we have legal aid?

The question is don't we

have community leaders who can address such issues? We go to church on Sunday, but we only do Bible Study. No one wants to hear about my nephew in Providence.

In other words, we can't defend our children if it costs money just to ask questions. So we just stand by. The church is the center of the community, but we only do Bible Study. Yet there must be people in the audience who could address any issues.

We have lawyers, doctors, teachers and politicians who come to church but they are never invited to speak. So who can help us when we

have a problem?

A doctor could speak about anything from AIDS to Alzheimer's.

A teacher could tell us about problems in the classroom.

A lawyer could tell us where to get help when we need an attorney but can't afford one.

Politicians will tell us to go to the polls and vote, but that's not enough. They need to come to church and get to know the people. We have something to say, and they need to listen.

What constitutes or what

are the characteristics of a

Christian? I read this story years ago: "The story was told of a little boy who went fishing with his dad, who professed to be a Christian. While they were waiting for the fish to bite, the boy asked his dad, what is a Christian? The dad, of course, gave his son the biblical definition and described the behavior and conduct or lifestyle of a Christian. The little boy looked up at his dad who was suppose to be a Christian and with excitement in his voice, asked his dad if he had ever seen a Christian." Isn't that a sad commentary?

The first persons that should recognize that you have changed should be your family: wife, husband, children and the dogs and cats because you are not kicking them around anymore. I remember when I was a boy. My dad was out in the streets for years, drinking and coming home at night drunk and terrorizing the whole family. But, suddenly, something happened that changed our home overnight. Let me try to give you a mental picture of what

I'm trying to describe to you.

We just experienced Hurricane Florence. We experienced record devastation throughout this area with several days of wind and rain, constantly. Many trees were uprooted with branches everywhere and places were flooded out. However, Monday morning came; the wind and rain were gone and the sun came out like nothing had happened; the storm was over!

When my dad got saved or born again, it was like a different person had moved into our house overnight, a changed man with no more fussing, fighting and drinking. I know that being born again of the Spirit of God, makes you a new person (species) in Christ Jesus. 2 Corin. 5:17, "Therefore, if any man be in Christ Jesus he is a new creature old things are passed away". I, too, had a supernatural birth that transformed my life. Not only was I born again, but I also was healed of a mole on my face and Hepatitis B. Healing is a part of the package of salvation,

everyone that Jesus healed, He said, "go and sin no more".

Jesus made some astounding remarks: to those of us who have been born again into the family of God. Jesus said in Matthew 5:13-14 (KJV) 13 "Ye are the salt of the earth: but if the salt has lost its savor, wherewith shall it be salted? it is thenceforth good for nothing, but to be cast out, and to be trodden under foot of men. 14 Ye are the light of the world. A city that is set on a hill cannot be hidden. 15 Neither do men light a candle, and put it under a bushel, but on a candlestick; and it giveth light unto all that are in the house. 16 Let your light so shine before men, that they may see your good works, and glorify your Father which is in heaven."

Then God's Word is narrow minded: You must be born again; you cannot see the Kingdom of God except you are born again. You cannot enter the Kingdom of God except you're born again. It's a spiritual law or a necessity,

a requirement. It's imperative, an indispensable requirement, essential: all these definitions. It is also a prerequisite or required (before you can have eternal life).

Principles are laws that are narrow-minded: a stop sign is narrow-minded: it simply says stop and yet millions have been killed and are being killed because somebody failed to stop. Water boils at 212-degrees Fahrenheit, and it freezes at 32-degrees Fahrenheit. The law of gravity is narrow-minded; if you go up on the roof and step off without being tied off, you will fall to the ground and possibly break something or get killed. The law of oxygen is also narrow-minded; it says wherever you go you need oxygen to breathe, to sustain life and without it you will suffocate and die.

God's law, the law of the spirit of life in Christ, will make you free from the law of sin and death. It's the law above all laws; your eternity is dependent upon it.

Can I ask you a personal question? Have you been born again from above of the Spirit. I'm not asking if you are a member of a church, choir member, usher board, deacon board or any other board. The question is, have you made Jesus Lord of your life? The ONLY way this can be done is by accepting Jesus Christ as your personal Saviour. For those who want to receive this precious gift, let's pray this simple prayer: Close your eyes and repeat. "O Lord be merciful unto me, I have sinned against you and I repent, I'm sorry for my sins. I believe that you died on the cross for me; forgive me. I now receive you in my heart as Lord. Amen." It's done and you are a new person, now, find you a Bible-believing church where the Word of God is being taught. Amen (so be it!).




