

## "SLAVERY GAME" PROBE CONCLUDED; NEW VETTING RULES ADOPTED



New Hanover County Public Schools Supt. Tim Markley's investigation into how a controversial "Monopoly-like role-playing slavery game," used by fourth grade teachers in their classrooms is reportedly complete, and, while none will lose their jobs because of it, new policies have been put into place to prevent "culturally insensitive" teaching materials from being used again without careful review, says a NHC Public Schools spokesperson.

Controversy erupted over two weeks ago when it was revealed that fourth-grade teachers at

majority White Codington Elementary School used a game titled "Escaping Slavery," and, according to materials that come with the activity, most notably a "Freedom Punch Card," students indeed assume the role of runaway slaves during the Underground Railroad and are told on the card, "...If your group runs into trouble four times, you will be severely punished and sent back to the plantation to work as a slave. Write your name on the back of this card."

Among the materials with the game were illustrations of shackles and Black slave families.

A Black grandmother complained to a local television about the game, concerned that her

grandchild was not being taught appropriately about perhaps the most painful historical period in the lives of most African-Americans.

She called it "horrifying."

NHC School Board chair, Lisa Estep, in a letter to the community, countered an early statement of

support for the game by Codington Elementary principal, Graham Elmore, saying that use of the game was not appropriate and promising that Supt. Markley and

Conservation partners joined together and purchased Reaves Chapel

The Coastal Land Trust and Cedar Hill/West Bank Heritage Foundation are pleased to announce that one of the Cape Fear region's most culturally and historically significant African American structures, Navassa's Reaves Chapel, has been purchased by the Coastal Land Trust. The purchase of Reaves Chapel was made possible thanks to a generous grant from The Orton Foundation.

Reaves Chapel African Methodist Episcopal Church was built along the Cape Fear's riverfront after the Civil War by formerly enslaved people of Cedar Hill Plantation. The congregation was made up of formerly enslaved people who farmed the property where the Cedar Hill Plantation once stood, and other neighboring rice plantations. When Mount

Misery and Cedar Hill roads were built, roads replaced the river as the main mode of transportation. In response, around 1922, the congregation, with logs and a team of oxen, moved the church from the riverfront to its present location. Reaves Chapel now stands on a small plot of land on Cedar Hill Road, which was given to the church by Edward Reaves, the church's namesake.

"This was our community church," said Al Beatty, president of Cedar Hill/West Bank Heritage Foundation. "Everyone in the community went to church there. Major groups came there to perform. A revival would bring in 80 - 100 people. If somebody died, they rang the church bell," he added. The bell, incidentally, still hangs in place in the church tower.

As evident of the church photo, time and weather have taken its toll on this historic beautiful building. "Navassa Mayor Eulis Willis helped establish the

## Adams, Butterfield, Black lawmakers demand release of Mueller Report

African-American members of Congress, many of whom are leaning strongly for the impeachment of President Donald Trump, have joined their Democratic colleagues in demanding the release of Special Counsel Robert Mueller's report on alleged Russian interference into the 2016 presidential

campaign, and the Trump campaign's suspected collusion with Russian operatives to do so.

Both of North Carolina's African-American congressional representatives, Rep. Alma Adams (D-NC-12) and Rep. G. K. Butterfield (D-NC-1), have added their voices to the growing Democratic

his staff would immediately look into it.

After a March 22nd request for comment, NHC Public Schools Chief Communications Officer, Ms. Valita Quattlebaum, responded to questions Monday.

"Dr. Markley's investigation into the situation has concluded," she wrote, confirming that the slavery game was only used in the fourth grade at Codington. "The district determined that there was no ill will on the part of the teachers, but

they did fail to show the cultural competence and sensitivity needed to effectively instruct on the topic of slavery in the U.S. As a result, there are some diversity and equity training programs that will happen throughout the district."

"Also, principals are now required to preview all third-party teaching materials before they can be used. The NHCS Instructional Services Department is reviewing guidelines for the use of outside materials in the classroom. NHCS Human Resources is reviewing policies and practices related to

onboarding for new staff to ensure that the district is providing the necessary training regarding implicit bias and diversity."

Who approved the use of the slavery game in the first place?

"This activity was purchased by teachers from a [popular] third-party website and at the time not vetted or approved by the administration," Ms. Quattlebaum said. "The use of the activity was a part of a larger scope of related instruction connected to the Civil War. Going forward, all materials from this

third-party website and others must be vetted and approved by the administration of the school."

Quattlebaum maintains, "...there was no intent to belittle or trivialize this topic..." adding, "The district intends to improve overall in the teaching methods that are being used in presenting sensitive subject matters..." She also confirmed that schools normally "have flexibility in determining materials to include as a part of their curriculum..."

No rules were broken, but, again, new vetting poli-

cies are now in place for third-party instructional materials.

And while no one will be disciplined or terminated for their role in the "slavery game" episode, Ms. Quattlebaum says, "...the district intends to provide cultural competency training for all teachers and staff."

The NHC NAACP chapter did call for "...a timeline of when the implicit bias and cultural competency training will be implemented," and also recommended that members of Wilmington's African-American community be involved.

reliance and racial respect. Newsome's legacy followed suit with decades of service related policies that aided students, colleagues, and the North Carolina Department of Education.

While Woodson's history includes being an author and founder of many projects and educational successes, Newsome's accomplishments mirror such acts. With a keen interest in the plight of students unable to participate in regular school matriculations, Newsome is credited with developing the first night high school for students in North Carolina. Referred to as the Extended Day project, the concept and realized plan allowed for expelled and suspended students to continue rather than disrupt formal learning.

According to Newsome's family, he also worked with Rock Sanders to design a program that introduced and exposed minority students to engineering disciplines. A forerunner to what is referred to as STEM education is ROCAME. Newsome and Sanders' names are not mentioned in the online histories and accolades regarding the well-respected initiative. Defined in some narratives, the program idea was developed by educators and local industries.

ROCAME, the Region O Council for the Advancement of Minorities in Engineering's founding and historical links are now dictated by a concept that Dr. Carter G. Woodson, the founder of Negro History Week respected greatly. That is the need to combine the oral traditions and actions of black people with primary documents, if or whenever they exist. The family members of Newsome have brought the dictates of what's in his name full circle.

Carter Newsome's loved ones, included another educator, the late Mercedes Jones Newsome. Their daughter, Dr. Paula Renee Newsome, and grandchild, Ayana Renee Washington reside in the Charlotte area where the 89-year-old patriarch died, on the last day of Black History Month, Feb 28.

The Hampton Institute, and East Carolina University graduate got his start in education from race conscious parents, and a public school, R.L. Vann

High in Ahoskie. One of North Carolina's long term vocational education consultants for the Department of Education made his initial mark in the lives of local Willistonians who learned from him the art of drafting, and the harnessing of electricity.

Newsome's legacy like that of his namesake, Carter G. Woodson, highlights histories that might easily pass away if the people are allowed to forget.

Marshall Kilimanjaro, publisher of the Carolina Peacemaker, died Wednesday morning after a long illness. He was 88.

Dr. Kilimanjaro, along with his wife, Vicki, started the Peacemaker in 1967, determined to give Greensboro's black community a voice in the midst of the civil rights movement, and tremendous change in the South. For 52 years, the Peacemaker has served the Greensboro community. Dr.

Kilimanjaro has received many honors throughout the years, including the prestigious Order of the Long Leaf Pine.

Funeral services for Dr. John Marshall Kilimanjaro will be held Friday, 11 a.m. at Temple Emmanuel in Greensboro.

**US SUPREME COURT  
HEARS ARGUMENTS ON  
NC PARTISAN  
GERRYMANDERING**  
[WASHINGTON, D.C.]

Attorneys for both Republican legislative leaders, and plaintiffs against partisan gerrymandering in drawing voting districts in North Carolina, made their arguments before the U.S. Supreme Court Tuesday. The High Court must decide whether GOP-leaning congressional voting districts, as the NC legislature have been drawing them since 2011, are indeed legal and constitutional, even though they have given Republican 10 of 13 con-

gressional districts; or if having such lop-sided voting districts will always deny Democratic voters there their constitutional right to choose their representation in Congress. A ruling is expected by late summer.

**FEDERAL JUDGE STRIKES  
DOWN NC'S ABORTION  
LAW**

[GREENSBORO] North Carolina's ban on abortions after 20 weeks of pregnancy was struck down Monday by a

federal judge, saying that the restriction was arbitrary, and denied a woman her constitutional right to choose the law. "[N]o matter what the state's legitimate interest in restricting abortion, this interest can never support an outright ban prior to viability," U.S. District Court Judge William Osteen ruled.

Congressional chorus to U.S. Attorney General William Barr (a Trump appointee) to release the entire Mueller Report immediately or face legal subpoenas.

"This is about trust and transparency," tweeted Rep. Adams Monday, a day after Barr released a four-page summary conclusion of Mueller's findings, determining that no evidence of collusion was found land

that Trump, arguably, did obstruct justice during Mueller's 22 month investigation.

"AG Barr must listen to the American people," Rep. Adams continued, "...and #ReleaseTheReport."

Her North Carolina colleague agreed.

"Now that Special Counsel Robert Mueller has completed his investigation, transparency is paramount," Congressman G. K. Butterfield tweeted. "It is absolutely imperative that AG Barr expeditiously

release the report to Congress and the American people."

Indeed, Butterfield and Adams were among the 420 U.S. House members, both Democrat and Republican, who unanimously voted March 21 for the full Mueller Report to be released.

Republican Senate Majority Leader Mitch McConnell blocked the U.S. Senate from even considering a similar measure, even though Pres. Trump told reporters he had no problem releasing the report.

Two powerful African-American House Democrats, Rep. Maxine Waters (D-CA), Chairwoman of the House Finance Committee, and Rep. Elijah Cummings (D-Maryland), Chairman of the House Oversight Committee, joined four other House Democratic committee chairs in a March 25 letter to Attorney General Barr, demanding that he turn over the Mueller Report and all supporting documentation by April 2.

"Those of us who chair these committees have the

responsibility to continue with our oversight," Rep. Waters told MSNBC Sunday.

House Democrats are also planning to call Barr and Mueller to testify in congressional hearings to ask key questions they feel have not been satisfied by Barr's initial summary.

Even the national NAACP is formally calling for the Mueller Report to be released, saying, "The people of this nation deserve transparency. The integrity of our democracy is at stake. Our country cannot afford any-

thing less than the unvarnished and unedited truth." Republicans, in response to the Democratic clamor for release of the full report, say that can't happen as long as it contains grand jury testimony and classified information. The GOP charges that Democrats are angry because the report "exonerates" Trump on charges of collusion and that Democrats and the media should be ashamed for "falsely" alleging that the President was guilty of colluding with the Russians.



#### Imposing a modern-day version of a poll tax is a new low

Until 2018, Florida — the state vital to the presidential victories of George Bush and Donald Trump — deprived one in 10 voters, and two in 10 African Americans, of the right to vote with a constitutional provision banning felons from voting, even after they had fulfilled their sentences.

Many with nonviolent drug felonies, enforced by a systematically biased criminal justice system, are kept from the polls. The discriminatory effect and intent of this exclusion is obvious.

In a stunning act of decency in 2018, Floridians voted overwhelmingly to amend their constitution and restore the voting rights of Floridians with felony convictions "after they complete all terms of their sentence, including parole or probation." According to the Tallahassee Democrat, the "Voting Restoration Amendment," would "grant most of the 1.7 million convicted felons the right to vote and help select their leaders for local, state and federal offices."

Voting rights activists drew up plans to help contact and register them, with the charismatic young leader, former Democratic gubernatorial candidate, Andrew Gillum committed to leading the effort.

Now Republicans in the state legislator are moving to frustrate the will of citizens, adding a new burden to exclude voters, a new form of one of the most loathsome Jim Crow tactics — the poll tax. Republicans in a House committee have voted — contrary to the intent and the text of the referendum passed by voters — to exclude from voting those who haven't paid their fines (even including those on a court-approved payment plan). Fines are imposed not by judges as part of the sentence, but by administrative clerks. They do not block any other voters from voting. If Republicans have their way — and they have a majority in the House legislature — they will likely use these fines to block a substantial portion of African Americans from voting. Despite the will of its people, Florida Republicans want to impose a racially biased poll tax to strip citizens of the right to vote — and to tilt elections in their favor.

Beginning in the 1890s, the poll tax was central to enforcing segregation in the South. Most of the laws had a "grandfather clause" that exempted those whose parents or grandparents had the right to vote prior to the Civil War. In 1964, this foul measure was outlawed for federal elections in the 24th Amendment to the Constitution. In 1966, the U.S. Supreme Court ruled it unconstitutional even in state elections. So states like Florida found other tricks and traps to limit the vote. Now, after the citizens of Florida have thrown out felony exclusion, Republicans threaten to impose a new Jim Crow poll tax.

There is no justification — except partisan zealotry built upon race-based politics. Republicans, from Trump on down, have chosen to make themselves the party of racial division. African Americans, not surprisingly, tend to vote overwhelmingly against them. So Republicans use various tricks to suppress the African-American vote — gerrymandering, restrictive voter ID laws, cuts in early voter hours and opposition to same-day voter registration — all to make it harder for the poor and minorities to vote.

But imposing the modern-day version of a poll tax is a new low.

If Republicans do succeed in passing this injustice, it will be challenged in the courts or in another referendum. But none of this should be necessary. The real question is to the Republican congressional majority in Florida: Have you no decency? Are you so blinded by partisan self-interest that you would maliciously deprive a million Floridians of the right to vote? Are you so arrogant as to ignore the 65 percent of the voters who voted to erase this injustice from Florida's constitution? Have you no shame?

"In the worst tradition of Florida voter suppression, some lawmakers want to take the harshest possible line on implementing a constitutional amendment that arguably doesn't even require the Legislature to interpret the constitution," says the Orlando Sentinel.

The implementation of Amendment 4 is turning into one huge mess and voting is becoming a privilege instead of a right. This is not a surprise because the Florida state government has failed to implement citizen-driven ballot amendments in recent years.

At this time in the Florida legislature, the bill is in subcommittees and the Voting Rights Restoration Bill has passed in the House. Basically the bill requires ex-prisoners to pay all court costs and fines before they can vote. This week, the Senate subcommittee is vot-

ing on their version of the Voting Rights Restoration Bill, which is very similar to the House version.

Many are calling this a new poll tax and nationally there is outrage and condemnation. Even though there is fierce opposition from the Democrats, the bill is expected to move quickly in the Senate because the Republicans have the numbers. Political experts and pundits would tell the Democrats that the state is turning purple, but the vote in the Florida legislature is still primarily red.

Andrew Gillum and the Democratic Party in Florida have a goal to register one million new Democrats by the 2020 election.



Second, yet another in a seemingly endless stream of reports surfaced about a player accused of domestic violence. This time: Kansas City Chiefs wide receiver Tyreek Hill, who has a history of domestic violence, is being investigated for assault of a child.

It's hard to deny that the NFL appears to be an institution that is tolerant of domestic violence, but intolerant of social activism.

Over the last several weeks, two incidents have served to remind us of the hypocrisy and racism that still permeates the National Football League. First, the league reached a settlement with San Francisco 49ers Colin Kaepernick and Eric Reid, who accused the league's 32 teams of colluding to keep them from playing because they knelt through the national anthem to protest racism and police brutality.

The excuse that signing Kaepernick would be a bad business decision was obliterated last fall by sportswear giant Nike. After unveiling an ad campaign featuring Kaepernick, sales rocketed and its stock price soared. As sportswriter Jason La Canfora noted of the "bad for business" argument, "Oh really? How's it working out for Phil Knight? You think he did this as a publicity stunt? It ain't warm and fuzzy in the Fortune 500, brother; it's just business – cutthroat

business at that in sporting apparel – and Nike made this calculated decision to make money. And that they are doing."

The excuse that Kaepernick simply isn't a good enough player, also is laughable. Even the most casual football fan can observe quarterbacking every week that is not up to Kaepernick's standards. Since 2011, Kaepernick is tied for 14th in QB rating, tied with Carson Palmer and Andy Dalton.

Plenty of quarterbacks with lower ratings not only are playing, but have secured deals worth more than \$10 million per year.

The facts simply do not bear it out that Kaepernick's skill and abilities don't measure up. Sports news site The Athletic in January surveyed 85 defensive NFL players from 25 different teams about their favorite and least favorite quarterbacks. "There is one quarterback the defensive players surveyed were nearly unanimous on: Colin Kaepernick," The Athletic wrote. Only two of the 85 said he should not be on an NFL roster and another two chose not to comment."

Audio recording of a meet-

ing between owners and players last spring revealed a simpler – and feebler – answer for why Kaepernick isn't signed: the owners are afraid of the President's Twitter account.

"The problem we have is, we have a president who will use that as fodder to do his mission that I don't feel is in the best interests of America," Patriots owner Robert Kraft said. "It's divisive and it's horrible."

Buffalo Bills owner Terry Pegula shared Kraft's fear. "All Donald needs to do is to start to do this again."

Fear of a Tweet is keeping a talented athlete in the prime of his career from earning a living at the sport in which he excels. It's depriving the league and its fans of that talent.

Signing Kaepernick would not just be good for Kaepernick. It would be good for the NFL, good for the fans, and good for American. The NFL must right this wrong and give the fans and the players what they want.

**REALITY CHECK****Rev. Jeremiah Wright and Rev. Howard-John Wesley are master teachers**

I strongly believe that one of the most valuable members of any community is a master teacher. Rev. Dr. Jeremiah A. Wright, (77), Pastor Emeritus of Trinity United Church of Christ in Chicago, Illinois and Rev. Dr. Howard-John Wesley, (46), Pastor of Alfred Street Baptist Church in Alexandria, Virginia are master teachers. A quote credited to Nelson Mandela is also apt to when describing them. He noted "A good head and a good heart are a formidable combination." Pastors Wright and Wesley are both blessed with that formidable combination.

That was re-affirmed recently when they delivered sermons in Howard University's Andrew Rankin Memorial Chapel. Each provided over 1,500 congregants, many of them Howard students, faculty, and alumni, with a memorable and spiritual experience. In his sermon, "No More Masks," Pastor Wright quoted Paul Laurence Dunbar ("We wear the masks that grins and lies"). He stated that we must remove those masks if we are

to successfully move against white supremacy and white privilege. We should act like the strong and proud people that our ancestors were. He insisted that such conduct by too many of us today is not a proper way to celebrate Dr. Martin Luther King, Jr.'s birthday. "There are two types of clergy," he said, "the prophet whose allegiance is to God and the priest whose allegiance is to the government. Dr. King was a prophet; Billy Graham was a priest."

Along with Dunbar, Pastor Wright also quoted Old and New Testaments, Maya Angelou, Brother Malcolm X, James Baldwin and Dr. King in his sermon. He also called out the word for God for some 15 African ethnic groups (not tribes, ethnic groups).

Pastor Wesley delivered an equally compelling sermon two weeks after Pastor Wright. He began by saying to the congregation, "I am going to disturb you today." He then

began to preach and teach about "Surviving Lots" from childhood into young adulthood, he noted he was taught that Sodom and Gomorrah's destruction resulted from the overwhelming presence of homosexuality. "Then I read the Bible myself," he stated. That reading informed him about the treachery of Lot, who owned the equivalent of a modern day hotel. When an invading army threatened his hotel, noted Pastor Wesley, Lot offered his "two virgin daughters" to the leaders of the invasion if they would spare his hotel. He then stated that there is a sizable number of modern day Lots who sexually exploit, abuse and harass women. They include corporate executives, politicians, professors, entertainers, athletes and even preachers. He expressed special concern about black women, who throughout this country's history, have been sexually exploited by white males. He was equally scornful of black men who use their positions to sexually exploit black women. He urged male congregants in the chapel to stand and pledge to not be a modern day Lots and to assist black women who are victims

of such behavior. Like he warned, Pastor Wesley disturbed people with that sermon.

On the other hand, he inspired them when he announced that his church had given \$50,000 to financially strapped Bennett College and \$100,000 to Howard to pay off the accounts of 34 seniors who are scheduled to graduate in May 2019. Now all they have to focus on is their grades. Alfred Streets contributions are the very definition of not just talking the talk, but walking the walk.

Master teachers, Pastor Wright and Pastor Wesley, bring to mind a quote from David Walker. "David Walker Appeals" is one of the most revolutionary documents in Black History. "I would crawl on my hands and knees to sit at the feet of a learned man... For colored people to acquire learning in this country makes tyrants quake and tremble on their sandy foundation." The two pastors are learned men.

**The myth of meritocracy**

William Singer is going to jail. He's the man who masterminded the college cheating scandal, collecting more than \$25 million in bribes between 2011 and 2018 for helping the children of millionaires get into college through what he called "the side door." More than 50 people got caught up in his scam, including a couple of well-known actresses, and some not so well known corporate CEOs who were willing to pay big money to get their unqualified children into elite colleges like Yale, Georgetown, and Stanford. Singer's unsavory antics were outrageous – hiring people to take ACT and SAT scores for young people, photo-shopping photos onto athletic bodies, lying about student's background and athletic prowess. It boiled down to creating opportunity for young people who are already endowed with the blessing of their parent's wealth. It flies in the face of the notion of meritocracy.

If you are surprised by this entrance-buying scheme, you are deluding yourself, though. Wealthy people have been buying their children's admission to elite schools for years; they just did it the legal way. They

gave substantial contributions to colleges and then asked for a place for their children. Or, they took advantage of the legacy preference (affirmative action for white people) to get their children in. So Singer called himself "the side door" to admissions, with traditional admissions being the front door, and large contributions being the back door. We in the African American community are clear that the front door has often either been closed to us or slammed in our faces, while we lack the wealth to enter the back door or side door. The fact that money buys admission, either through the back or side door makes the notion of "meritocracy" a bad joke.

Meritocracy suggests that people hold power (or have access to things like jobs or college seats) because of their ability, but the current leadership in these United States suggests that meritocracy is a myth. It's not just that our 45th President seems to lack the ability to behave himself (witness the attacks on John

McCain), read a briefing book, or do his job correctly; it's that he has found a gaggle of miscreants to make and implement public policy. That Betsy DeVos (Devoid of good sense) runs the Department of Education flies in the face of meritocracy. That the man who lives in the House that Enslaved People Built brought his law-breaking daughter and son-in-law onto his staff as "senior advisors" flies in the face of meritocracy. That the administration is actively seeking appeals court judges whose primary qualifications are their youth and conservatism flies in the face of meritocracy!

Alison Rushing, at 37, has not even practiced law for a decade but is now a member of the US Court of Appeals in the 4th Circuit. That court covers North Carolina, Virginia, West Virginia, South Carolina and Maryland, and convenes in North Carolina, where Ms. Rushing has not even passed a bar exam. But she has a lifetime appointment to the court. What meritocracy?

The college cheating scam is a counterpoint to the myth of meritocracy, but African American people are clear that meritocracy has never worked for us. Even those who get into school "the old fashioned way," through the front door, come to

the door with myriad advantages that many African American students, especially poor, working class and first generation Black students do not have. They've spent hundreds, if not thousands, of dollars on prep courses. They've used alumni-rich networks for recommendations and advice. They've taken advanced classes (International Baccalaureate, Advanced Placement) that are not available at all schools, especially inner-city schools. The playing field has never been level, nor has there ever been a meritocracy!

Here is the real tragedy – millions of African American young people can't afford to go to college, no matter what their merit or ability. When they graduate, many face a hostile job market, and often experience pay discrimination. Not to mention the fact that even walking while Black might get you shot if the wrong police officer finds your walk "threatening."

**CRAZY FAITH MINISTRIES****God and the current administration**

My very soul has been rankled by the claims of some that this president was sent to us by God. My spiritual angst was further troubled when this week Secretary of State Mike Pompeo said that the president may well have been sent here by God to save Israel from an invasion from Iran. As I believe in a "good God," I am struggling. The people who are making the president an angel from God believe in a good God as well. But their notion of "good God" and mine are diametrically opposed.

In my Christian upbringing I was taught that God sent his son, Jesus, to "save the people from their sins." Sin was all that separated people from God, and being connected to God meant that one could understand the lessons of life that God wanted us to have.

Among those lessons were the sovereignty of God ("the earth is the Lord's and everything in it"), the need to love God with all our hearts, minds and souls and our neighbor as ourselves, and to understand that what we give to others we receive.

I was taught that I was to forgive my enemies, to be reconciled with those with whom we had an issue. Our Sunday School teachers taught us that as followers of Jesus the Christ, we were "the light of the world." Others would see the God in us by how we acted, which would be dictated and directed from our obedience to the Christ. We were taught to love those who persecuted us, including our enemies. We were taught not to judge others, to understand that we were unqualified to point out the speck in someone else's eye while we simultaneously had a log in our own.

Nothing our Sunday School teachers taught us, things that Jesus said, were comforting, palatable or easy to think about, much less do.

But the people over time who have supported racism and oppression and injustice seem to have a different God. Surely the God of my Sunday School would not verify that this man in the White House, who stokes violence based on white supremacy, xenophobia, sexism and homophobia, is one of his special angels?

Those who support the idea that the president was sent by God point to the Bible and the story about how the Persian King Cyrus was sent by God to carry out God's will. (<http://www.bibleresearch.org/articles/a2pws.htm>) But I am not clear that Cyrus' role was to support tyranny and the oppression of people created by God. I have always believed that God used people who could be said to have been in violation of God's will to remind the people of who was sovereign, and the punishment for ignoring the words and the will of God.

The Christians who have lifted the president up as a bearer of God's Good News seem to be in no way in alignment with God's commands to us as taught by his son. Jesus taught that there was value in all people because all people - back then, referring to women, lepers, ordinary "sinners" - and more. Jesus taught that we were to love and embrace all people and to love all people. Jesus seemed to be teaching that only being in community with each other was the fulfillment of God's will.

Or so I thought.

It has long been the case that there is a religion of "Empire," which has put the God of the Bible on the periphery of life, in juxtaposition with the "religion of creation," given to us by Jesus the Christ. Many who follow Jesus and call themselves Christian understand that.

But many do not. In fact, the "religion of Empire" says scholars, superseded and replaced the religion of Creation as early as the period of the Roman Empire. People knew about God but did not seek God as had been taught by the Christ; they used God to justify and sanction the treatment of each other carried out by individuals, governments and institutions in order to hold onto their power.

Nothing this administration has done seems to be "of God." While wealthy people smile and those committing crimes get slaps on the wrist, the masses who call themselves the "people of God" are suffering.

That cannot be the will of God; that cannot be what an angel of God would be told to do.

Akwaaba!! 2019 marks the 400th documented year of the enslavement of Africans who endured the Middle Passage to the Americas. Ghana has extended an open invitation for descendants of the diaspora to come back to Alkebulan to reflect on the tragedy of slav-

ery, for healing and reconciliation. Ghana is one of the few West African countries that has apologized for its participation in the slave trade. The government of Ghana would like for African Americans to consider relocation or repatriation, become entrepreneurs and home owners in the country of Ghana. There is already a growing number of African Americans that have dual citi-

zenship and have done well for themselves in Ghana.

Inez International.LV, owned/operated by Inez Campbell-Eason, a Wilmington resident, provided a tour group to Ghana in August 2018 and will be returning this August 15 - 25, 2019. Most of the group's participants met on Facebook and the internet, departed from their perspective cities and connected as perfect strangers

once in Ghana and had the time of their lives. Last year travelers on the tour flew from Michigan, Georgia, and North Carolina. This year they will be flying from Canada, California, Arizona, Georgia, Michigan, North Carolina, District of Columbia, Virginia, and Pennsylvania.

Campbell-Eason said, "I traveled alone so yes; I experienced excitement and a little anxiety. The closer I got to Ghana the more I started seeing people who looked just like people from home. It was uncanny. Ghana is the epitome of free enterprise. There is no one to harass residents for permits to conduct business along the streets of Ghana. Their methodology is not to prevent success; but encourage and embrace the everyday hustle of individuals attempting to provide for themselves and their families. All you need is to claim your spot. You will see craftsmen hand carving wicker beds, coffins, stone columns,

making bricks, welding gates of pure gold, making earthen wear, beads, art, drums, selling street food and fruits. To see the women and men in contemporary and traditional fashions is like watching African art in motion. Everybody is Black from all the merchants in malls that would dwarf many of ours in the U.S., everyone working

in the airport, all the tv shows, commercials, videos, billboards, I mean it's just an amazing experience. The police do not shoot or accost their citizens. They are very well respected because they respect the people of their culture. It was the safest that I have ever felt. I was told by a local that Ghanaians love African American tourists the most because we are a lot of fun."

Campbell-Eason jokingly shared, "People have asked me to briefly explain Ghana. To me it's like Walmart but on the street. You can buy your groceries and furnish your apart-

ment before you get home. There's a bargain waiting for you at every stoplight."

Lastly, the students of Ghana are required to pay for their education up until grade 8. It is difficult for many parents to provide education for all of their children. The illiteracy rate is extremely high in Ghana. Four years of education is the equivalent of \$240.00 here in the United States which includes college or university fees as well. In support of students in Ghana, Campbell-Eason created an educational scholarship called, "Educate to Elevate Abroad" and was fortunate to have local sponsors here in New Hanover County volunteer to financially provide 4 years of education for two students. She hopes to be able to help many more students in the future.

## An American hero: Jackie Robinson's 100th birthday and reflections from Wilmington N.C., Little League baseball players

**T**he belated and most recognizable baseball player in the history of Major League Baseball celebrated his 100th birthday January 31, 2019. Mr. Robinson played football, basketball, track and baseball at the University of California, Los Angeles (UCLA). After being drafted into the military and entering the Army on April 3, 1942 he was honorably discharged from the military, as a result of a matter similar to that of Rosa Parks. Soon thereafter he played in the Negro Baseball Leagues for one season with the Kansas City Monarchs. Baseball executive, Branch Rickey in 1946 provided the opportunity for Jackie to participate in the majors. That particular opportunity served as a vessel for Jackie to make the Dodgers top farm AAA team, Montreal Royals. He went on to be a color barrier breaker and integrate baseball in the major leagues on April 15, 1947. Jackie played with a burning desire to win every game. Jackie played the game to the fullest, the same way he lived his life. Fast forward, Jackie completed 9 years in the majors retiring in 1956. Near the conclusion

of his busy career, Jackie

Robinson visited Wilmington, N.C. in 1955. The individuals in this vintage historical photo are at the Wilmington Blumenthal Airport welcoming and highlighting Jackie's visit. At the time of this article March 20, 2019 all the Little League Baseball players in the photo are living. They are L-R Jerome Fennell, Andrew Oates and George Peterson. Through recent interviews, they were able to reflect on that historical visit for the arrival by Mr. Robinson. The community representative and chaperone with the boys was Mrs. Eunice B. Kirton. She wrote a newspaper column for the African American Newspaper as well as being an accomplished trained classical singer. Mrs. Eunice B. Kirton was the Chairperson of the Phyllis Wheatley Branch of the Young Women's Christian Association. Mrs. Kirton was the wife of Rev. Dr. Edward E. Kirton of St. Marks's Episcopal Church on 6th and Grace Street. Their daughter, Elsie, five at the time of this event recalls, "that the community came out to be a part of the event." Elsie is in the group picture, standing behind the first Little Leaguers kneeling from the

left. Jerome Fennell is pictured on the far left with a distinctive expression of pride, wearing his Taylor Holmes Projects Little League baseball uniform. His eyes are focused on the camera with distinction and absolute joy to be a hospitable host. His reflection of the event is that the event occurred during a winter month at which Jackie came to the Port City. Jerome stated, "I was elated because Jackie was a household name in my grandmother's home. That was a major, major event just to be in his presence. I felt I was fortunate that I actually got selected to represent our Robert Taylor Holmes team and see him." He goes on to say, "that my grandmother put lots of emphasis of having good role models in my life to look up to."

The Little League baseball player in the middle is Andrew "Jimmy" Oates. Jimmy recalls and shares, "he may have been selected to represent Community Boys Club, because he was a year older and had played on the original first team when the league opened." Jimmy has a shy eagerness with curious

eyes at the time of camera clicking. Jimmy like Jackie played second base and was a wizard with his glove. Jimmy's feelings about the event are, "that it was like meeting the greatest hero in the world and that was a huge deal." When he reflects going back over six decades ago, "Jimmy felt extremely proud to have been selected for the event. I tried to imitate my baseball skills like Jackie both at hitting and fielding." Andrew Oates did not recall any comments that Jackie made during the event, however that experience appears to be etched into his memory for years, including his muscle memory as a second baseman like Jackie Robinson.

"Life is not a spectator sport. If you're going to spend your life in the grandstand just watching what goes on, in my opinion you're wasting your life." Jackie Robinson

George "Tin Soldier" Peterson is the Little League Player nearest to Jackie's right shoulder. George's face shines with a peaceful joy of pride from ear to ear. George recalls that, "I was Captain or Co-Captain for the Jervay Projects Baseball Team." The image of Jackie at the Community Boys Club brings back memories for George. His adoration for Mr.

Robinson and that visit is a cherished moment in his life. He does not remember the specifics of his speech, however he shares, "I can't remember his pitch, but I can imagine, because the civil rights movement was in its beginnings, he was a strong advocate of non-violence. I was 12 years old and I had never seen a celebrity not alone shake his hand. As you can imagine I was in awe." George's emotion of being in awe appears to be gandered by his parents of being respectful and inspired by people of authority. His lasting reflections of the emotional reverence are both gleeful and mirthful. He goes on to say, "I was really impressed with Mr. Robinson's professional demeanor. He seemed calm, unassuming and thoughtful. He did not appear loud, aggressive, or outspoken. As I later came to realize, he let his performance on the field do his talking. It was later that I learned of the agreement he had with Branch Rickey that he would not let the fan's taunts (name calling and other demeaning behavior) get to him or evoke a response." Finally, "Jackie let his performance do the talking. I believe in that!"

"Plenty of times I wanted to haul off when somebody insulted me for the color of my skin, but I had to hold myself. I was, kind of an experiment. The whole thing was bigger than me." Jackie Robinson

All three of these young men at the time of this event represented themselves, families, communities and baseball teams with distinction, exhibiting an absolute joy to marvel at their hero. Their actions proved that they were hospitable hosts. One would wonder if these little leaguers were aware, just months prior to his visit, that Mr. Jackie Robinson and his Brooklyn Dodgers teammates had just become baseball's World Series Champs. These little leaguers around 1950s lived in segregated communities with somewhat limited resources, however on the other hand these boys were showered with a wealth of pride, encouragement with meaningful role models. Albeit this event was an element of aspiration for these little league baseball players. This event is a testament which illustrates and symbolized how local leaders from the community raced down third base and stole home plate like Jackie to make a winner in the lives of others. In quoting Mr. Robinson, "A life is not important except in the impact it has on other lives."




