

CHARLOTTE BRACES ITSELF AFTER GREENVILLE TRUMP RALLY

In the aftermath of Monday night's Charlotte City Council vote to condemn "all hate speech, bigotry, racism, and discrimination" by President Trump, the Queen City is now emotionally bracing itself for possible vehement protests in August 2020 when the Republican National Convention comes to town.

Several citizens warned the council that if it did not rescind the invitation to the RNC to convene in the city in 2020, they were effectively "putting the lives of citizens of

color in danger."

"Let's call racism what it is," demanded one public hearing speaker.

By a 9-2 vote Monday night, and after passionate arguments on both sides of the issue, the City Council made it clear in a nonbinding resolution that it abhorred, not only the recent controversy at Trump's July 17 campaign rally at East Carolina University, where a raucous crowd, apparently responding to the Republican President's racially charged tweets targeting Somali-born Congresswoman Ilhan Omar (D-Minnesota), chanted "Send her back, send her back..." but previous "racist and xenophobic" lan-

guage by Trump since he came to office in 2017.

"Whereas, in June 2017, President Donald Trump said 15,000 recent immigrants from Haiti "all have AIDS" and that 40,000 Nigerians, once seeing the United States, would never "go back to their huts" in Africa, and...in August 2017 [Trump] called some of those who marched alongside White supremacists in Charlottesville, Va. ... "very fine people" ... on May 16, 2018, [Trump] referred to undocumented immi-

NCCU alumnus and renowned journalist honored

Influential black newspaper pioneer and North Carolina Central University graduate, the late Louis Austin, was honored June 14, 2019, with establishment of a North Carolina Historical Marker in his hometown of Enfield, N.C.

Born in 1898, Austin became known for his work as a journalist and civil rights activist. He gained notoriety in the 1950s and 1960s for his influence on the Civil Rights Movement in Durham and throughout the state.

Austin graduated in 1921 from the National Training School, now known as North Carolina Central University, and initially worked at North Carolina Mutual Life Insurance Company. Later that year, he became a sports editor for The Standard Advertiser, a Durham newspaper that was later renamed *The Carolina Times*.

By 1927, he had purchased the paper and shifted his editorial focus to civil rights. He published opinion pieces and news stories about the need for racial equality

that challenged discriminatory policies aimed at African Americans and other minorities. Austin often wrote about school integration as a means of achieving educational parity, as well as equity in school funding and unfair teacher hiring practices.

In 1933, Austin participated in a lawsuit filed on behalf of NCCU student Thomas Hocutt challenging the whites-only admission practices of the University of North Carolina. The controversial case split Durham's black community, with many fearing the legal fight would lead to violence.

The suit was eventually dismissed based on the judge's conclusion that the plaintiff should have sought consideration of Hocutt's application regardless of race, instead of arguing that UNC was compelled to admit him. Nonetheless, it was the first legal challenge to educational segregation in the south and is widely considered the test case for *Brown v. Board of Education*,

NC High Court Republican blasts Democrat colleagues

If there were any doubt that the 2020 race for NC Supreme Court chief justice has already begun, look no further than remarks reportedly made by Associate Justice Paul Newby, the only Republican on the State Supreme Court, during a recent "campaign address" at a Wake County conservative GOP fundraiser.

"What do you think the most dangerous branch of government is," Justice Newby asked the partisan, predominantly White crowd at the Annual Red, White and BBQ Fundraiser, Saturday, July 13. "The judicial branch is the correct answer."

"Imagine seven 'AOCs' on the State Supreme Court," the conservative justice continued, as the crowd audibly booted the thought. "AOC" is popular shorthand for U. S. Rep. Alexandria Ocasio-Cortez, the controversial liberal Democratic congresswoman from New York, who is loathed by President Trump, conservatives, and the Republican Party for her progressive socialist policies.

"Well, folks..." Newby continued jokingly "... we got six. It's six to one...I'm the last man standing."

The "six," the conservative justice was referring to were his six Democratic colleagues on the NC Supreme Court, apparently suggesting

Black wealth 2020 adds HBCUs to its economic empowerment agenda The catalyst for Black wealth also applauds Robert Smith's gift to Morehouse

(TriceEdneyWire.com) - The short-term economic impact of Historically Black Colleges and Universities (HBCUs) is \$15 billion - rivaling corporations such as Bank of America in its

more than 177,000 employees.

Yet, according to the U. S. Department of Education, approximately 60 percent of all Black college students have no expectation of family financial contributions to their education. That's a family financial expectation far lower than that of Whites. Approximately 30 percent of White

college students have no expectation of family financial contributions to their education. That number is approximately 48 percent for Latinos and 38 percent for Asians.

The economic impact of HBCUs, their struggle to stay afloat, and the dire financial disparities faced by HBCU students are the reasons that

Black Wealth 2020, a catalyst for Black economic equality, recently decided to add HBCUs as a forth leg to its three-pronged focus to grow Black wealth through Black-owned businesses, Black banks and Black homeowner-

that each was as liberal as Rep. Ocasio-Cortez.

A tape of Justice Newby's remarks was given to Raleigh TV station, WRAL-TV, which then reported and posted the ten minute recording.

Later on the tape, Newby is heard making reference, though not by name, to the newest Democratic associate justice who was elected last year; former civil rights Attorney Anita Earls.

"In 2018, the left put \$1.5 million to get their 'AOC' person on the court," he is heard saying.

A political consultant for Newby told WRAL-TV that he wasn't referencing anyone in particular, only pointing out "ideological differences."

"I lose sleep at night, thinking, what would it be like if we had no one to hold accountable, those that want to cause social change through our judicial branch," Justice Newby told the GOP crowd,

alleging that it was part of a "...long-term strategy by [Pres.] Obama and his inner circle to stack the state Supreme Courts...."

"Keep your eyes open and your ears open for the next eighteen months and see what kind of judicial activism occurs on your North Carolina [Supreme] Court," he cautioned.

Justice Newby, who said "Our rights come from God...and no governmental authority shall interfere with those rights...", went on to warn the GOP audience that only four votes on the seven-member State High Court are needed for decisions. He urged them to elect Republicans to the three open seats on the State High Court in 2020, one of which will be his as he seeks the Chief Justice slot.

"Do you want a government...of the judges, by the judges, and for the judges," Newby further warned the audience, as they said, "Nooooo!"

Ironically, Newby actually preceded Pres. Trump's controversial Twitter complaint

about those complaining about America by a day, saying that "...I will buy you a ticket to leave..." for America's critics to go somewhere else.

Why was a purportedly impartial Republican conservative jurist of the State's highest court making such highly partisan remarks in the first place? Again, it was a GOP campaign fundraiser, sponsored by the East Wake Republican Club, not just for Justice Newby, but for three other conservative 2020 Republican hopefuls like gubernatorial candidate, Lt. Gov. Dan Forest, U.S. Rep. George Holding, and Congressman Ted Budd.

Rep. Budd, from Greensboro, was given "The Spirit of Jesse Award," named after the late, racially divisive U.S. Senator Jesse Helms (R-NC), and a Sig Sauer P365 handgun was raffled off at the event where "...fellow Republicans who are trying to return our country to the founding principles that made America great ..." gathered.

Newby's sharp partisan public references caught the attention

of several court watchers across the State, who wondered whether it was judicially appropriate. "I am not sure if the comments violate the Code of Judicial Conduct as it could be deemed as campaigning," Irving Joyner, attorney and professor of law at North Carolina Central University School of Law, said. "It seems to run close to the line by painting a highly partisan label to the upcoming elections where he is pitted against Chief Justice Beasley. We are looking into the comments."

It was last February when Newby, the court's longest serving associate justice, bitterly complained after Gov. Roy Cooper a Democrat, made history by choosing Democratic colleague, Associate Justice Cheri Beasley, the first African-American woman, to serve as chief justice of the N.C. Supreme Court.

An outraged Newby issued a Twitter statement after the choice was announced, saying, "Sadly, today Governor Cooper decided to place raw partisan politics over a non-partisan

judiciary by refusing to honor the time tested tradition of naming the senior associate justice as chief justice," Newby opined. "The governor's decision further erodes public trust and confidence in a fair judiciary, free from partisan manipulation."

During his July 13 GOP fundraising remarks, Newby called Gov. Cooper "...a political creature" who does not do "...what is right for the State."

Chief Justice Beasley, when asked about her Republican colleague's reaction just prior to her taking office March 1, replied, "Let me be clear ... I will indeed be seeking election in 2020, and I'm excited and I'm ready to go. I am very comfortable with who I am as a person. I am comfortable with the fact that the governor has placed his confidence in me and that I'm equipped to do this job."

There has been no response to Justice Newby's July 13 broad brushstroke, highly partisan remarks against his Democratic colleagues, especially from Chief Justice Beasley.

ATTORNEYS SUE NHCS SYSTEM IN TEACHER SEX ABUSE CASE; SEEK CLASS ACTION LAWSUIT
[WILMINGTON] Lawyers representing the victims of a former New Hanover County School System teacher are suing the system, and asking

a judge to allow a class action lawsuit representing all known victims in the case. Former teacher Michael Kelly pled guilty to 59 charges, including indecent liberties with a minor, on June 25th. By raising the case to class action status, all of the victims will be entitled to victim's compensation. Attorneys also want the NHCS System administration replaced, alleging that they knew about Kelly's crimes for years, and did

nothing about him. Kelly was once cleared by a NHCS probe.

COURT RULES FOR TRANSGENDER PUBLIC BATHROOM USE

[RALEIGH] Transgenders in North Carolina can now legally use the public bathroom in government buildings they most identify with, according to a federal court ruling Tuesday. "We are thrilled to obtain some clarity and relief for transgender

North Carolinians who have been suffering under H.B. 2 and [the replacement] H.B. 142 for years," said Irena Como, acting legal director of the ACLU of North Carolina, in a statement. "While this part of the court fight may be ending, so much urgent work remains as long as people who are LGBTQ are denied basic protections from violence and discrimination simply because of who they are." Republican legislative lead-

ers said they are reviewing the ruling.

CHARLOTTE POLICE CHIEF OPEN TO CHANGES IN DEADLY FORCE POLICY

[CHARLOTTE] -The chief of the Charlotte-Mecklenburg Police Dept says he is now willing to listen to proposed changes to his agency's use of deadly force policy, according to members of the city's Citizen Review Board. Chief

Kerr Putney reportedly is interested in how to de-escalate confrontations between police and armed suspects. Putney asked the eleven-member board to begin work on drafting new policy in June, hoping to unveil it by this fall. Chief Putney is under no obligation to accept the proposed policy change.

grants as "animals"...on July 14, 2019, [Trump] suggested that four minority United States congresswomen, all of whom are American citizens and three of whom were born in the United States, should "go back" to "the totally broken and crime infested places from which they

came...[and] on July 17, 2019, [Pres. Trump] held a rally in Greenville, N. C. where his supporters chanted "Send her back" in reference to Congresswoman Ilhan Omar...", the resolution read, in part, listing several instances of what the author, Councilman Dr. Justin Harlow, felt were clear examples of past statements and behavior Trump was likely to bring to Charlotte next year.

"...[T]he Council deems it imperative to condemn such racist and xenophobic language that only serves to stoke fear of others and perpetuate division everywhere based on ethnicity, religion and/or race," the resolution continued.

All nine of the Council Democrats, some of whom assisted Dr. Harlow in composing the document, lamented before the vote how Trump's racist behav-

ior did not comport with the kind of welcoming environment the Queen City has worked hard to establish for all who live and work there.

Saying that Charlotte is a "city of immigrants," the Council's Democrats, including Mayor Vi Lyles, stressed how important it was for the condemning resolution to be passed unanimously.

However, the council's two Republicans refused to support the measure, joining

their colleagues in criticizing the President's racial tone, but adding that the council was overstepping its bounds, stepping into a national controversy.

"I don't personally endorse the way the President has chosen to conduct himself," Councilman Ed Driggs said, "but he didn't create the tension that we're experiencing ... He's the result of the tension."

Prior to the vote, the city

attorney warned that the council could not now rescind the contract it signed, inviting the RNC to convene in 2020, risking severe legal ramifications if it did.

At press time Monday evening, neither the national Republican National Committee nor the North Carolina Republican Party issued a reaction to the Charlotte City Council's condemnation resolution.

ship.

"We've got to keep on pushing this agenda. And hooking up with HBCUs is a big way of doing that," said Michael Grant, former president of the National Bankers Association, and a founder of Black Wealth 2020 in a meeting just before the principals voted unanimously to expand its vision to acknowledge HBCUs as being "central to strengthening the American economy."

Grant added, "If we're serious about building Black wealth, how can we not have a focus on our youth and the next generation?"

The vision expansion was inspired, in part, by a presentation by Dr. Lezli Baskerville, president/CEO of the National Association for Equal Opportunity in Higher Education, also a principal of Black Wealth 2020.

"But for HBCUs, there would be no African-American middle class today. And that's a fact and that's documented," Baskerville told the group. "And just the existence of HBCUs in our communities - even the ones that are not thriving today - ends up collectively to generate about \$15 billion in short term. And that doesn't include anything other than what the campuses, including employees and students, spend in surrounding communities."

Billionaire Robert Smith's Morehouse initiative has challenged Black Community on support of HBCUs

In an initial move to encourage support for HBCUs, Black Wealth 2020 principals have also sent a thank you letter to Black billionaire businessman Robert Smith, chairman/CEO of Vista Equity Partners, who touched hearts across the nation when he announced that he would pay off all of the student loans of the Morehouse College class of 2019.

The letter applauded Smith, saying, "With student debt nationally at over \$1.4 trillion and with the average college student leaving school \$30,000 in debt, your gift not only relieved an enormous financial

burden from the graduating class from Morehouse and their parents, you have challenged all African-Americans of means to think bigger about how to use their wealth to improve the lives of others within our race."

The letter was signed by members and supporters of the Black Wealth 2020 coalition. Those organizations include the National Association of Black-owned Broadcasters; the U. S. Black Chambers, Inc.; Delta Sigma Theta Sorority; National Bankers Association; The Collective Empowerment Group; the National Association of Real Estate Brokers; The National Black Caucus of State Legislators; Marc Morial of the National Urban League; NAFEO; Congresswoman Maxine Waters; former SBA Deputy Administrator Marie Johns; John Rogers, CEO, Ariel Investments; Andy Ingraham, CEO, National Association of Black Hotel Owners, Operators and Developers; and Marcia Griffin, CEO, HomeFree USA.

"We thought it fitting that a coalition committed to building wealth should take the opportunity to acknowledge and praise your commitment to uplifting our people," the letter told Smith.

HBCUs struggle for funding to the detriment of the nation

In her presentation to Black Wealth 2020 on the state of HBCUs, Baskerville made the case that student loan debt is inevitable for students who are forced to borrow because their families cannot help. But, she said, financial issues also hinder even good students from making it through college in the first place.

Baskerville drew heavily from a report compiled by noted national economist Bill

Spriggs, who has contended that HBCUs are the key to diversifying technology, currently among the top paying fields in the U. S. job market.

"In the pipeline of people who generate wealth in the African ancestry community, there is not today a challenge in terms of Blacks getting into college. Bill's data shows that there is no disparity in the percentages of African-Americans and their numbers and Whites that are going into college and enrolled in these high needs areas. The gap happens when they get in," Baskerville said. "It's not that they're not prepared, it's not that they can't get in and could not thrive, it's that once they get in, they don't have dollars."

Among other facts that Baskerville noted from the Spriggs report:

*** Despite the challenges of the institutions and the financial challenges of the students, HBCUs are performing above average and do very well in moving students from low income families to the top 20 percent.

*** Generally, many universities now have more students drawn from the top 1 percent of the U. S. income distribution than the bottom 40 percent of the U. S. income distribution.

*** With a declining number of White students, and a growing share of low income students, HBCUs are an under-resourced asset for growing the US economy; therefore an increased investment in HBCUs would expand their unmet capacity.

According to the US Department of Education, there are currently 107 HBCUs operating in the U. S. All have struggles with funding.

"HBCUs Punching Above Their Weight", a recent report by the United Negro College Fund, the premier fund-raising organization for HBCUs, says despite their difficulty with fund-raising, HBCUs are still succeeding beyond expectations given their struggles.

"Given their small average size and a history of being under-resourced, the enrollment, degree and economic impacts of HBCUs on African Americans in their respective states are significantly greater

than one would expect," says an introduction to the report.

No more Mary Turners

Mary Turner was lynched on May 19, 1918 because she dared raise her voice. Her husband, Hayes Turner, was among 13 people lynched in two weeks in and around Valdosta, Georgia. The lynchings took place because one brutal white man, who was known to abuse workers so severely that he was only able to attract workers by getting them through the convict labor system, beat the wrong Black man too many times. Sidney Johnson shot and killed the brutal Hampton Smith, and in response the white people of the area started apprehending, beating, and lynching Black men believed to be associated with Sidney Johnson (even though many of those lynched were not). Mary Turner was nineteen years old and eight months pregnant, and her husband was lynched. She openly denounced the lynchings and threatened to have the men who killed her husband arrested.

After Mary Turner's lynching, an investigative reporter stated that Turner was lynched because she made "unwise remarks." The mob, it was reported, "took exception to her remarks as well as her attitude." Her "defiant voice" was the impetus for mob retaliation. The mob action was particularly brutal. Mary Turner was hung by her ankles, lowered face down from a tree. Her clothing was set afire while she was alive. When she was dead, one of the mobsters slit her belly open, and her fetus came out, landing in a pool of blood. Then the sick and brutal white men crushed the infant's skull.

Black women have been, too often, cautioned to be silent, to be demure, not to rock the boat. And Mary Turner's lynching reminds us that mouthy Black women often suffer the consequence of their vocality. The 45th President of the United States stands in the shadow of the men who silenced Mary Turner with his vicious and vile attacks on Black women. From Congresswoman Maxine Waters to Congresswoman Fredricka Whitfield, to journalists April Ryan, Abby Phillips and Yamiche Alcindor, this man neither has the grace or the gravitas to interact with these brilliant and amazing Black women. Now, here he goes again, spewing his filth. He suggested that four fresh women members of Congress, the self-described "Squad" of Congresswomen Ayanna Pressley (D-MA), Ilhan Omar (D-MN), Rashida Tlaib (D-MI) and Alexandria Ocasio-Cortez, "go back to where they came from." He amplified and attacked the women so vociferously (and inaccurately, but that's another story) that one of the mobs, I mean crowds, that attended one of his rallies began to chant "Send her home."

Three of the four members of the Squad were born in the United States. Ilhan Omar is a naturalized citizen and member of Congress. The President is out of line and out of order; but that's nothing new. What is new is that he's stopped dog-whistling his racism and now just shouts it out. And sometimes retreats. Five days after his offensive tweets, he claims he did not incite his crowd and instead tried to shut the racist chants down. Films of the mob at his rally shows otherwise.

Ilhan Omar and the other members of the Squad have had their lives threatened, sometimes by identifiable Trump supporters. We can't expect 45 to repudiate the threats. After all, he thought there were "good people on both sides" in Charlottesville when Heather Heyer was killed. So we aren't surprised that he let the vitriolic chants of "send her back" to go on for more than 13 seconds before they died down naturally (he did nothing to stop them, nor did he comment at the time).

If something happens to Ilhan Omar, our 45th President will be responsible. If something happens to any of the Squad, it will be the result of our putrid President and the silent Republicans who are reluctant to tell this man he is wrong. It took a full day after his offensive "go back" tweet for a handful of Republicans to speak up and say something.

Like the white men who lynched Mary Turner, our President "takes exception to her remarks as well as her attitude." Without accusing Mr. Trump of lynching, one can accuse Mr. Trump of being a racist and hostile to Black women. Ilhan Omer isn't the first he went after, and she won't be the last.

Ilhan Omar, Ayanna Pressley, Alexandria Ocasio-Cortez, and Rashida Tlaib had better not shut up. They need to continue to raise their loud, discordant, disruptive voices to make our country a better, more inclusive nation. They must raise their voices because Ida B. Wells did, and she paid the price. Because Shirley Chisholm did, and she paid the price. Because Barbara Lee did and got death threats as a result. Because Maxine Waters does, despite attacks and ridicule. Mary Turner chafed at her husband's lynching, and she paid the ultimate price. But the story of her lynching should strengthen us all. We must surround the Squad with support. We need more mouthy women to challenge patriarchal predatory white supremacy. There must not be another Mary Turner.

South Carolina heads down a dead-end street in rejecting Medicaid expansion

South Carolina's James Louis Petigru was a Civil War-era lawyer, judge, congressman and most notably the attorney general who opposed South Carolina's use of nullification of federal laws and, after Abraham Lincoln was elected president in 1860, opposed state secession.

He famously quipped, after learning that his state had seceded from the Union, "South Carolina is too small to be a republic and too large to be an insane asylum."

While not insane, the state was a little nutty when it rejected Medicaid expansion under the Affordable Care Act (ACA). South Carolina has one of the highest percentages of uninsured people in the country.

The leaders of the state are leading the people down a dead-end street. They support tax cuts for the rich and health care cuts for the poor. South Carolina is a red state with blue needs — more health care, less poverty, better schools and fewer jails.

Nikki Haley, the former governor of South Carolina and President Donald Trump's former ambassador to the United Nations, was

born in Bamberg, South Carolina, a small city of approximately 3,600 people.

The Bamberg County Hospital, where Haley was born, closed on April 30, 2012 for lack of money. Not only did people lose health services but Bamberg County Hospital workers lost their jobs.

Many other small rural hospitals and workers faced the same fate in South Carolina when the state rejected the \$10 billion over 10 years it would have received if it had expanded Medicaid.

A recent article in the Greenville News reported that when hospital beds fill up in the state, patients are boarded in emergency rooms. It is inhumane and economically foolish and morally wrong to argue against expanding Medicaid when 50,000 jobs and greater health care is involved.

Arguing against keeping rural hospitals open, like

Bamberg County, makes no sense. It's arguing for sickness and unnecessary death.

It's a national problem, but recently South Carolina's Greenville News documented the situation locally when 80-year-old Ron Miller of Pickens County collapsed at home two days after surgery and had to be rushed back to the hospital and readmitted. The problem was there were no available beds at that hospital or any of the hospitals in Greenville.

The paper reported, "The phenomenon, called boarding, occurs when hospitals hold patients in the ER until they find a bed for them on a medical floor." Dr. Ryan Stanton, a spokesman for the American College of Emergency Physicians, an ER physician with Central Emergency Physicians in Lexington, Kentucky, has indicated it's a growing problem across the nation. It's a simple problem of supply and demand.

There are more patients than there are beds. A further concern is whether patients forced to stay in the ER for long periods of time have the same equipment made available to them and receive the

same level of care that those in hospital beds receive.

Expanding Medicaid could help, but South Carolina is a state that pretends to resent big government and federal dollars, even though 32 percent of its general revenue comes from Washington for education, health care, airports, highways, seaports, the big military presence in the state and more. South Carolina couldn't exist without federal dollars. It, apparently, just doesn't want to receive Medicaid funds for its neediest citizens.

There is a better South Carolina on the horizon and Congressman Joe Cunningham (SC-01) is an example. He's the new Democrat from the Lowcountry and he's worked to reinstate the ban on offshore drilling, protect Lowcountry jobs from damaging tariffs and fix South Carolina's ailing infrastructure. On Jan. 3, 2019, he said he was "ready to roll up his sleeves and get to work" and he has. South Carolina needs more Joe Cunninghams.

We all do.

Eric Garner died pleading for his life on a New York City sidewalk.

The chokehold that triggered his fatal asthma attack was illegal.

Eleven times, Eric Garner said he couldn't breathe, and Officer Daniel Pantaleo did not loosen his strangling, illegal grip on Garner's neck.

The world saw Pantaleo's deadly assault. The world heard Garner's pleas. But there will be no justice for Eric Garner.

When U.S. Attorney General William Barr abandoned the civil rights case against Pantaleo, it sent a devastating message from an administra-

tion whose hostility toward civil rights protections is unprecedented in the last 50 years.

Astonishingly, Pantaleo remains a member of the New York Police Department, pending a decision by an administrative judge who is expected to rule within a few weeks. His continued employment by the NYPD diminishes the institution, and he should be terminated.

It is difficult to imagine the grief of Garner's family. To lose a father; a son, a brother; to an untimely death is painful enough. To have been dragged through five years of injustice after injustice, to see the person responsible for that death escape accountability seems almost too much to bear.

Not only has Pantaleo escaped accountability, he has received a substantial raise in his pay since Garner's death.

Sadly, police officers are

rarely held accountable when unjustified brutality – local prosecutors are predictably reluctant to bring charges. That's precisely why the federal government has a special responsibility to seek justice in such cases, and why Attorney General Barr's failure to do so in the Garner case cuts so deeply.

In the wake of the death of Garner and other unarmed people of color who died violently at the hands of police officers, the National Urban League promulgated a 10-Point Plan for Police Reform and Accountability, elements of which were incorporated into the final report of the President's Task Force on 21st Century Policing. One of the key recommendations is "external and independent investigations and prosecutions of officer-involved shootings and other use of force situations and in-custody deaths."

In the Eric Garner case, as in many others, the Department of Justice's civil rights inquiry was arguably the only hope for an external and independent investigation.

But this is an administration

that is intent on weakening enforcement of civil rights laws. Under Barr's predecessor, Jeff Sessions, the Justice Department abandoned all efforts to work with local police departments to address discriminatory practices. Consent decrees historically have been a crucial tool in the Justice Department's efforts to ensure constitutional and accountable policing.

The department also tried, unsuccessfully, to block a federal court in Baltimore from approving a consent decree between the city and the Baltimore Police Department to rein in discriminatory police practices that the department itself had negotiated over a multi-year period.

The Department of Justice's failure to seek justice in the Eric Garner case is just the latest in a series of missteps with regard to civil rights. Our hearts go out to Garner's family as they suffer yet another blow in the ongoing tragedy of Garner's untimely death.

Visit the African American Museum of History and Culture: It is MUST

On the way to visit to the National Museum of African American History and Culture in Washington D.C. on July 12, 2019 I wondered at all of the things I would see. Never did I imagine the way it would touch my life and prompt me to write this letter. It was very enlightening by illuminating...revealing...clarifying...and informing me more clearly of the plight and pilgrimage of our fore parents, who were taken from their own land and transported to this land as slaves. Many did not survive the trip from Africa to this country due to death at sea. Those that survived the malnutrition and many sicknesses were then auctioned off to the highest bidders on the slave auction block in a new land; sometimes in America, sometimes in the West Indies and sometimes in other places. They were forever separated from their homes, families and friends; losing everything including their surnames. They were dehumanized in every way possible. They were deprived of human qualities of life and other attributes given to their lighter counterparts.

On chronological display in the museum is how they were abused, beaten, raped, murdered and denied any rights of defending themselves as they were owned by the white people that committed the crimes against them. It is further revealed that even after slavery was abolished, the same crimes were being committed against African descendants by white people, but taken to another level. Even after building this country in many ways, once it was established and functioning economically and there was no longer a need for slave labor, the torture and abuse continued. Systems were put into place to deny equal rights to African descendants...equal education, equal pay for doing the same work, the right to lawful assembly, the right to public accommodations, and the right to vote. Although African descendants fought and died for this country guaranteeing somebody else's freedom, they themselves didn't have it!

Now here we are in 2019 wit-

nessing the evil done against God's creation, acting as if some new thing is being done. When we witness inhumane treatment to people of color; a lack of equal education for children of color; unequal pay for people of color; mass prison time for people of color; voter suppression for people of color; abuse and brutality and killing

to people of color; object poverty of people of color; it allows me to compare it to what our ancestors endured. I'm reminded of what Solomon wrote in Ecclesiastes 1:9-10, "The thing that hath been, it is that which shall be; and that which is done is that which shall be done: and there is no new thing under the sun; 10 Is there any thing whereof it may be said, See, this is new? it hath been already of old time, which was before us."

I challenge every African American in this nation to please make every effort to visit the National Museum of African American History and Culture in Washington D.C., that you might commit to memory where God has brought us from and we that we never forget what we've been through. Note these two verses written by Moses found in Deuteronomy 6:11-12 which say "11And houses full of all good things, which thou filledst not, and wells digged, which thou diggedst not, vineyards and olive trees, which thou plantedst not; when thou shalt have eaten and be full; 12 Then beware lest thou forget the LORD, which brought thee forth out of the land of Egypt, from the house of bondage." We must always know that we cannot undo that which has already been done but we can look on it and learn from it, never allowing it to ever be done again. Hate is overcome by love...madness by compassion...evilness by kindness...vindictiveness by mercy and forgiveness. When we do those things, we help prepare a people for to coming of Christ, who is soon to come.

The question is, Who is more qualified to teach than those that suffered as He did?

Action Needed

1. Visit the National Museum of African American History and Culture in Washington D.C.

a. Upon your return start teaching our history; in church, in homes, at play, at work, at school, in groups of two or more.

b. This will help people to understand that we are a blessed, honored, gifted, and much beloved people that are humbly kind, generous, and are people of God.

c. Teach everybody that we don't have the right to sit down and do nothing. The price paid for our freedom was extremely high. It cost Jesus and our fore parents their lives.

d. Teach that when we make life better for ourselves, it gets better for everyone around us.

2. Teach the preciousness of life that is given by God and not man. Genesis 1:27 says "27So God created man in his own image, in the image of God created he him; male and female created he them." In this verse, it does not say what color man was. Therefore all men of every race were created by God. When African Americans teach each other our history, there might be a greater love for each other and a greater support and desire to see the fulfillment of one's life. Out of this will be less violence and harming towards one another and more assistance. Jesus taught in Matthew 22:37-40 that "37Jesus said unto him, Thou shalt love the Lord thy God with all thy heart, and with all thy soul, and with all thy mind.38 This is the first and great commandment. 39 And the second is like unto it, Thou shalt love thy neighbor as thyself. 40 On these two commandments hang all the law and the prophets."

a. Teach that we are our brother's keeper being responsible for each other's wellbeing. Jesus spoke in Matthew 25:34-36 & 40 saying "34Then shall the King say unto them on his right hand, Come, ye blessed of my Father, inherit the kingdom prepared for you from the foundation of the world:35 For I was an hungry, and ye gave me meat: I was thirsty, and ye

gave me drink: I was a stranger, and ye took me in: 36 Naked, and ye clothed me: I was sick, and ye visited me: I was in prison, and ye came unto me. 40 And the King shall answer and say unto them, Verily I say unto you, Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me."

b. Teach the effects of psychological warfare, which is intended to mislead, intimidate, and demoralize others by altering one's mindset to change their though process.

c. Teach the word of God that came to lead us through a dark and evil world. Jesus spoke in John 8:12 "12Then spake Jesus again unto them, saying, I am the light of the world: he that followeth me shall not walk in darkness, but shall have the light of life."

d. Teach the righteousness of God and how the world will look on you because you strive to be righteous also. 1 John 3:13-15 says "13Marvel not, my brethren, if the world hate you.14We know that we have passed from death unto life, because we love the brethren. He that loveth not his brother abideth in death. 15Whosoever hateth his brother is a murderer: and ye know that no murderer hath eternal life abiding in him."

In the Preamble it contains the words, "We hold these truths to be self-evident that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness..." Teach that we are still working on this as it is yet unfulfilled!

CRAZY FAITH MINISTRIES**Don't call me racist!**

It has been troubling and fascinating to watch people deny that they are racist and that this president is racist.

It is as though the "r" word is as offensive to some as is the "n"

word. While people - media included - are fighting the trending verbiage which states unequivocally that the president is racist, they are also denying that they are racist.

What is up with that?

America was born in white supremacist ideology; the Puritans were convinced that they had been anointed by God to make a new nation which would be morally superior to all other nations.

They also believed that this new land was to be a place for white people.

Americans were obsessed with creating a master race during its eugenics movement. Edwin Black writes in War Against the Weak: Eugenics and America's Campaign to Create a Master Race that "during the first six decades of the twentieth century, hundreds of thousands of Americans and until numbers of others were not permitted to continue their families by reproducing." Those sterilized were chosen because of "their ancestry, national origin, race, and religion." The practices were supported by the elite of American society: professors, ivy league uni-

versities and wealthy industrialists.

America's race laws were so sophisticated that the Germans referred to and used them in the development of their quest for creating a master race as well - what they called a "superior Nordic race" and a "master Aryan race." Black writes that "it was only after the truth about Nazi extermination became known did the American eugenics movement fade. American eugenic institutions rushed to change their names from eugenics to genetics.

Racism is a part of America's story.

They therefore, their religion notwithstanding, felt no internal or spiritual angst when they systematically, methodically, and intentionally killed and/or forced the relocations of Native Americans. They believed it was God's will.

White supremacist ideology was already a known entity by the time the Puritans arrived here in the 1600s. Racist ideas and beliefs were known and practiced by Europeans for nearly two centuries by the time the Puritans landed at Massachusetts Bay (<https://www.publicbooks.org/rewriting-history-racist-ideas/>) Those ideas were used to "codify New England Slavery," notes Kendi.

The idea that black people were inferior in all ways, made that way by God, was "baked into the founding documents." The Founding Fathers wrestled with the contradiction of making a new, independent nation while forcing others into total dependence on white people. It was through and by the labor of black people that the economy was built, but as the nation grew older, whites decided that there was no place for black people in what had become their country.

They wanted to get rid of black people; they had outlived their usefulness, but wrestled with how to do it. A major push was made to colonize people of African descent; ship them back to Africa, the proponents said, where they can teach the "savages" the principles of Christianity - the same Christianity which was used to justify their being slaves - and thus make the world a better place. Major historical figures supported the colonization of black people. The American Colonization Society has a prominent voice in American history.

Even the white president who has been deified because of the Emancipation Proclamation, Abraham Lincoln, fully supported the colonization of people of African descent. He did not believe that black people were on an equal plane with whites or that they would ever be. He issued the Emancipation Proclamation for a number of reasons, none of which was his belief in the full humanity of black people.

We all know that many of the Founding Fathers owned slaves. We know that even though black people fought in every American war that once the wars were over, whites made sure they understood that, their military service notwithstanding, they were still "niggers," still unqualified to have full rights of American citizenship, and were still inferior to white people.

The belief in black inferiority - which is the key component of white supremacist thought - is a part of America's ethos. It has accounted for the substandard housing, education and economic opportunities for black people; it accounts for the lack of attention and care given to the conditions which have since the beginning of this nation's birth been the bane of this country's existence. Because of the widespread belief in the inferiority of black people, and the subsequent dehumanization of black people perhaps subliminally carried in the very souls of white people, there is little care or attention given to the substandard treatment of black people, allowing too many people to turn a blind eye to situations such as tainted water in Flint, Michigan, or run-down schools with lead paint which black children in so many cities still attend.

In this political season, the statement keeps coming up, "We are better than this." But in truth, we are not. America is doing as America has always done.

So, denying the charge of being racist is fascinating to watch, and it begs the question of how white Americans define racism. Just because one does not use the "n" word and has a couple of friends does not make one a non-racist. At the end of the day, it is the acceptance of racist policies and practices which defines racism, and a willingness to be silent as black people are subjected to these policies and practices on a daily basis.

The racism is not just directed at black people, either. As brown people have grown in number in this country, the racism has extended to them as well. Incorporated in the white supremacist standard of white supremacy is xenophobia and Islamophobia - and sexism as well. White supremacy is not only racist but is sexist as well.

And it is who we are.

If white people would just own their racism, this nation might be able to move forward, but they refuse to. If one says the "r" word, too many whites get immediately defensive, more worried about protecting and defending their honor than addressing and owning the problem that is killing America.

White supremacy is an illness, like drug and/or alcohol addiction. In order to not be a racist, a person has to say, "I am a racist," and then the process of healing can begin. Without the admission of the malady, there can be no healing and no reconciliation.

And unfortunately, too many whites seem to be all right with that reality.

GET THAT DEED AND FLIP THOSE KEYS!

Pull the permit or naw?... "CAREFUL, A MUST READ"

This week I want to share something very personal and is timely not just for me but for many that are still recovering from Hurricane Florence.

After months of negotiations with the insurance company, they finally released a "measure" of funds so I could start putting my house back together. I will spare you all the commentary about how I've been living like a gypsy from

post to post, box to box and just give you some info that will help save you a lot of heartaches, headaches, and money.

Fam, when doing repairs, renovations, rehabs, "GET THE PERMIT!"... Below is the email I got from the NH. Co. Building permits office.

To give you a lil clip note back story on this, I went down and told them the work I needed to do and asked if I needed to pull a permit. The fact that I had a tree come in my house that broke several rafters automatically triggered the permit, smh. They went on to say how it could take 7-10 biz days to even approve my application for the permit and how I would be breaking the law if I started work before I got the permit and folks, that was the beginning of me asking myself

"WHAT IN THE WORLD DID I JUST DO?"

Thankfully I had an engineer look at the rafter damage and they gave me a recommendation on how to fix correctly and that is the ONLY thing that speed up the process for me and I received this awaited email: "Good Morning Ms. Dixon, I have approved your permit and it is ready for payment. If you have a user account for our COAST portal, just log in and you can pay online. If you prefer to pay by phone please call 910-798-7308. Please share this permit # with your plumber and electrician so they can obtain their permits. We will link the existing mechanical permit to your permit. My comments on your permit are as follows:

1) Storm damage repair including truss repair per engineer letter, insulation, drywall, approved. Truss chord repair to include sistering of 2x4 to the entire length of each damaged member as specified by the engineer. 2) Engineer letter to be on site for an inspector for framing inspection. 3) All work to comply with 2018 NCRC and is subject to inspection. As soon as the truss repairs are completed per Engineer requirements, you will need to schedule a framing inspection with us. I think I forgot to mention this on Friday. Next, all trades need to have passed their rough-in inspections before any insulation is installed. Once the insulation is installed, you will need

an insulation inspection. Once this is approved, you can continue with drywall, etc. (we only need to inspect flooring if you are replacing the structural sub-floor or repairing any joists. We do not need to inspect your finish flooring.) Your trades will need to have their final inspections, then you will schedule a building final inspection when the work is complete. If you have any questions or concerns please do not hesitate to call us at 910-798-7308. You can also reply to this email. Best Regards"

Ohh ok, well Journal Fam I'm not going to lie, this is not easy. Something about someone telling me what has to be and how it has to be done at my own house doesn't sit just so with me. I promise you reading that email had me wondering if I made the right decision BUT then I did the math.

I started thinking about how if I spent \$60,000+ in repairs/renovations and couldn't get any benefit from it, and it made me sit my whole self down and just be quiet. I started thinking about how over the years when I had a homeowner call me to help sell their home and they start telling me how they have done this and that upgrade/improvements and then when I ask "Did you pull a permit?", they get that deer in the headlights look. That's when I knew they had not and I had to tell them that none of the improvements they did would be considered when

it comes to figuring a List price to sell. Those were "illegal" improvements and they can't get any value gained from them unless they are willing to open up walls and let the inspection company come in and pass the work. That HURTS, and it doesn't feel too good but it's a reality. I could go on but let me wrap this up and say, "PLEASE GET THE PERMIT".... Doing repairs, renovations, rehabs & additions w/o it trying to cut corners, Jack-leg it to save time and money will COST YOU BIG when trying to sell it. Most times un-inspected work is done wrong or 1/2 right and Appraisers and Insurance companies are now trained to check the permit office ... For liability purposes and to protect their money, Banks are not financing these illegally repaired/rehab homes and some of the insurance companies will not insure them. Yes, I hated to pull it because I'm ready to get back in my house and waiting for inspectors will slow me down BUT I GOT IT...

Fam, do yourself a favor and protect your investment... JUST GET IT! Trust me, you will pay now or even the more sooner or later.

Earned Income Tax Credit reduces taxes for low- and moderate-income wage earners

"The Earned Income Tax Credit (EITC) is probably the number one cash benefit program for low income families in the country," according to Chris Rockey, senior vice president, market manager, Greater Maryland Community Development Banking for PNC Bank.

"It can be a challenge to get into the program," Rockey adds, "but it is a way to put needed cash into a family's pockets."

The EITC was implemented as a way to offset the impact of Social Security taxes on low to moderate taxpayers and to provide them with an incentive to work. The credit can be worth up to \$6,431 for 2018 and up to \$6,577 in 2019 for families with three or more qualifying children. For taxpayers with two

qualifying children, the maximum credit this year is \$5,828. The maximum credit for one qualifying child is \$3,526.

"The EITC is different than other federal assistance programs," Rockey continued, "because you actually have to have income in order to qualify."

There are several ways individuals can determine if they are eligible for the EITC, Rockey explained. "A number of community action associations through their financial programs are very aggressive about educating their clients about the EITC, as well as other programs like the CTC (Child Tax Credit)," he said.

Rockey also noted that he has seen a trend with Volunteer Income Tax Assistance (VITA) preparation sites whereby they are focusing on reaching out to working families to help them through the eligibility process.

"There are clearly efforts

under way from an educational standpoint," Rockey said, "but like any other government program it can be cumbersome, and unless you have someone who can help you navigate the twists and turns it can be confusing."

In a best-case scenario, Rockey notes, a family or individual works with a case manager or social worker who is skilled in the process. He adds that by consulting with a VITA site, taxpayers can position themselves to be eligible for next year's credit even if they are not signed up for the current tax year. It is also possible to apply for the benefit retroactively.

Rockey said that PNC Bank does not work directly with potentially eligible taxpayers to qualify them for the EITC, but it does explain how the program works and will refer them to its trusted community partners for intake. "Our partners can provide the information

and resources our customers are looking for," he adds.

Still, obtaining accurate, reliable information about the EITC can be a challenge, Rockey warns. It is often difficult for those who need information about their eligibility to get access to transportation and take time off from work to meet with someone who can help them to qualify.

"It's not just getting educated about the EITC," he added, "it's also about learning how to access the benefits while keeping their job."

Even in the current divided political environment, Rockey is encouraged about the outlook for the EITC because over the years it has gained a great deal of bipartisan political support. In recent years, he adds, there has been some talk of trying to modernize some of the EITC's income qualifications.

"Unlike federal programs that benefit individuals and

If you're poor in America, debtor's prison is real

Despite a centuries-old Supreme Court ruling that outlawed the practice, debtor's prison remains very much alive in America, experts told NNPA Newswire. Being poor is challenging enough, but some states, like Missouri, have continued to punish those of lesser means.

A federal class-action suit claims thousands of those living in Missouri were jailed because they couldn't pay off fines – essentially, a debtor's prison and conundrum for the poor.

Pro Publica reported that four years after the suit was filed, the plaintiffs are still waiting, and wondering if the deck is stacked against them.

The report details the plight of Tonya DeBerry, who, in January 2014, was

driving through an unincorporated area of St. Louis County, Missouri, when a police officer pulled her over for having expired license plates.

"After discovering that DeBerry, 51, had several outstanding traffic tickets from three jurisdictions, the officer handcuffed her and took her to jail," according to Pro Publica.

"To be released, she was told, she would have to pay hundreds of dollars in fines she owed the county, according to her account in a federal lawsuit. However, even after her family came up with the money, DeBerry wasn't released from custody.

Because DeBerry still owed fines and fees to the cities in Ferguson and Jennings, she remained jailed and her attorney likened it to "being held for ransom."

"The crisis that is going

on in Missouri is taking place all around the country. It is a rising issue amongst people who cannot afford to pay court fees and, or fines," said Attorney Dameka L. Davis of the Davis Legal Center in Hollywood, Fla.

"I believe the more appropriate action is to implement programs and services that are free or offer a person to do community service in lieu of paying fines or fees," Davis said.

"Our system is perpetuating a money-based system, which in turn systematically affects minorities and people of color," she said.

Matt C. Pinsker, an adjunct professor of Homeland Security and Criminal Justice in the L. Douglas Wilder School of Government and Public Affairs at Virginia Commonwealth University, said the problem runs deeper than in Missouri.

"The American people

would be horrified if they knew of just how many laws still exist which send poor people to prison over their inability to pay fines, court costs, and related expenses," Pinsker said.

"It is a tragedy and absurdity that we will essentially have debtors' prisons here in the United States of America," he said.

In DeBerry's case, Pro Publica reported that after the Michael Brown killing, "the city slowly stopped jailing people for not being able to pay fines as the news media showed the victims were primarily black and the Justice Department made clear that what Ferguson had been doing was wrong."

Still, the lawsuit remains unresolved with the city seeking dismissal.

In 2018, the American Civil Liberties Union detailed more than 1,000 cases in 26 states in which

judges, acting on the request of a collection company, issued warrants for people they claimed owed money for "ordinary debts, such as student loans, medical expenses, unpaid rent and utility bills."

The ACLU said it's a system that breeds coercion and abuse.

The report concluded that, "with little government oversight, debt collectors, backed by arrest warrants and wielding bounced check demand letters, can frighten people into paying money that may not even be owed."

Few tools are as coercive or as effective as the threat of incarceration, ACLU report authors said.

As an example, one 75-year-old woman subsisting on \$800 monthly Social Security checks, went without her medications in order to pay the fees she believed were required to avoid jail time for bouncing a check.

And as one lawyer in Texas, who has sought arrests of student loan borrowers who are in arrears, said, "It's easier to settle when the debtor is under arrest," the report's authors found.


The people who are jailed or threatened with jail often are the most vulnerable Americans living paycheck to paycheck, one emergency catastrophe, the report said.

Many were struggling to recover after the loss of a job, mounting medical bills, the death of a family member, a divorce, or an illness.

"They included retirees or people with disabilities who are unable to work. Some were subsisting solely on Social Security, unemployment insurance, disability benefits, or veterans' benefits – income that is legally protected from outstanding debt judgments," the report's authors wrote.

Unexpected struggles in the fight against Ebola

July 22, 2019 (GIN) – The battle to knock out the Ebola virus should have its eyes on the goal. Instead, politics and a divisive struggle between two drug makers has interfered. A key health minister in the Democratic Republic of Congo (DRC) has resigned in protest.

In his resignation letter, Health Minister Oly Ilunga Kalenga condemned President Felix Tshisekedi's takeover of the country's Ebola response, removing him as head of the Ebola response team.

He also criticized what he described as outside pressure to roll out a second experimental Ebola vaccine.

Oly Ilunga Kalenga defended the work of his ministry, saying it had communicated daily on the situation in the ongoing outbreak "to reassure and show the world that the country is managing this epidemic."

But on Saturday, Tshisekedi's administration announced that direct super-

vision of the Ebola response was being placed with a team of experts under the direction of Jean Jacques Muyembe Tamfum, director-general of the DRC's National Institute for Biomedical Research (NIBR) and a microbiologist at the University of Kinshasa's medical school. Tamfum has studied Ebola and responded to outbreaks for more than 40 years.

The change in leadership came days after the World Health Organization (WHO) declared the Ebola outbreak a Public Health Emergency of International Concern.

"There is no sign of this epidemic slowing down. We therefore welcome the DRC President's bold decision to change strategy and bring the Ebola response under his direct supervision," Peter Piot, director of the London School of Hygiene & Tropical Medicine, said in a statement.

Since August 2018, the DRC has recorded more than 2,500

cases of Ebola and, among them, more than 1,700 deaths.

In his resignation letter, Kalenga attacked efforts to launch trials of an experimental vaccine made by Johnson & Johnson (J&J) in the country. A Merck & Co. vaccine is already in use there.

Groups backing the use of the J&J vaccine include the Wellcome Trust, Doctors Without Borders, the Coalition for Epidemic Preparedness Innovations (CEPI), WHO, J&J, and NIBR.

But there are important differences from Merck's vaccine that have to be taken into account, he said. Made from a live, replicating virus, Merck's vaccine mounts protection against Ebola in about 10 days. While the J&J immunization appears to raise the body's defenses for the long-term, it's administered in two shots, about two months apart.

"We have developed a vaccine for a time of peace," said Paul Stoffels, J&J's chief sci-

entific officer. He worked in clinics in poor African communities in Congo and elsewhere for years before coming to the company.

How much, if any, protection a person gets from the first shot before getting the second isn't clear. Ensuring people are fully vaccinated

with the two-shot regimen would be challenging among mobile populations, especially in people fleeing conflict, and could stoke suspicions.

Empire star Taraji Henson speaks on suicide and mental health on Capitol Hill

Tam here using my celebrity, using my voice, to put a face to this, because I also suffer from depression and anxiety. If you're a human living in today's world, I don't know how you're not suffering in any way."

Award-winning actress and 'Empire' star Taraji P. Henson testified before members of Congress on mental health issues in the African American community.

The Congressional Black Caucus launched a task force on mental health issues in April of this year. They have held hearings on mental health and the increasing number of suicides among black youth. The CBC Emergency Taskforce on Black Youth Suicide and Mental Health is chaired by Congresswoman Bonnie Watson Coleman (D-NJ).

The members of the task force are Reps. Alma Adams (D-NC), Emanuel Cleaver II (D-MO), Danny Davis (D-IL), Alcee Hastings (D-FL), Jahana Hayes (D-CT), Eddie Bernice Johnson (D-TX), Barbara Lee (D-CA), John Lewis (D-GA), Ilhan Omar (D-MN), Ayanna Pressley (D-

MA) and Frederica Wilson (D-FL).

"I'm here to appeal to you because this is a national crisis," Henson said. Henson founded The Boris Lawrence Henson Foundation in 2018 to eradicate the stigma surrounding mental illness in the African American community with a specific emphasis on the suicide rate among Black youth.

"I really don't know how to fix this problem, I just know that the suicide rate is rising," she said. "I just know that ages of the children that are committing suicide are getting younger and younger," the actress added.

"It breaks my heart to know that 5-year-old children are contemplating life and death, I just...I'm sorry. That one is tough for me. So, I'm here to appeal to you, because

this is a national crisis. When I hear of kids going into bathrooms, cutting themselves, you're supposed to feel safe in school." Henson told the members of Congress and those in the audience in a hearing room on Capitol Hill in Washington.

Every year, 1 in 5 adults in the U.S. experience a mental illness, but a National Alliance on Mental Illness study discovered that black adults utilize mental health services at half the rate of white adults.

Dr. Patrice Harris sworn-in as the American Medical Association's first Black female president

In June, Dr. Patrice A. Harris, a psychiatrist from Atlanta, was sworn-in as the 174th president of the American Medical Association (AMA). She is the first African-American woman to hold the position.

During her inauguration ceremony in Chicago, Dr. Harris said she plans to implement effective strategies to improve healthcare education and training, combat the crisis surrounding chronic diseases, and eliminate barriers to quality patient care.

She also promised to lead conversations on mental health and diversity in the medical field.

"We face big challenges in health care today, and the decisions we make now will move us forward in a future we help create," Dr. Harris said in a statement.

"We are no longer at a place where we can tolerate the disparities that plague communities of color, women, and the LGBTQ community. But we are not yet at a place where health equity is achieved in those communities," she said.

According to her biography on the AMA's website, Dr. Harris has long been a mentor, role model and an advocate.

She served on the AMA Board of Trustees since 2011,

and as chair from 2016 to 2017.

Prior to that, Dr. Harris served in various leadership roles which included task forces on topics like health information technology, payment and delivery reform, and private contracting.

Dr. Harris also held leadership positions with the American Psychiatric Association, the Georgia Psychiatric Physicians Association, the Medical Association of Georgia, and The Big Cities Health Coalition, where she chaired this forum composed of leaders from America's largest metropolitan health departments.

Growing up in Bluefield, West Virginia, Dr. Harris dreamt of entering medicine at a time when few women of color were encouraged to become physicians, according to her bio.

She spent her formative years at West Virginia University, earning a BA in psychology, an MA in counseling psychology and ultimately, a medical degree in 1992.

It was during this time that her passion for helping children emerged, and she completed her psychiatry residency and fellowships in child and adolescent psychiatry and forensic psychiatry at the Emory University School of Medicine, according to her bio.

"The saying 'if you can see it, you can believe it' is true," Dr. Harris said during her swearing-in ceremony.

"And I hope to be tangible evidence for young girls and young boys and girls from communities of color that you can aspire to be a physician. Not only that, you can aspire to be a leader in organized medicine," she said.



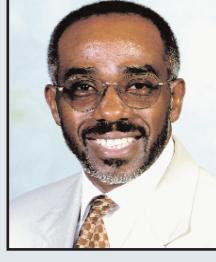
