Read all about it

Are you one of those people who still subscribe to a newspaper?

Yes, there are still a few of us.

Chances are you complain about the high cost of a subscriptions and the fact that all the “news” is something you’ve already seen on TV and there’s nothing but “ads” in the paper!

We agree with most of those complaints but I find it puzzling that newspapers say they are dying because of declining subscriptions. The paradox is - if newspapers are losing customers why are businesses still continuing to advertise with multi-page supplements. Why continue to buy ads to a shrinking readership?

If you do occasionally pick up a paper you surely must have noticed the larger than life Obituaries. These death notices seem to be long biographies of the deceased (certainly a fitting tribute to a beloved family members). It Used to be that an obituary was not much more than a few lines—date of birth, surviving family members and the time and place of a memorial service.

A recent issue of the Milwaukee Journal had an eight page supplement and seven of those pages were filled with these very large obituaries. A recent Sheboygan Press had a four page section

of which three pages were all “bigger than life:” obituaries.

I’m sure these expansive tributes are not free. What a great new idea to secure more revenue—why not sell big hunks of newspaper space that recite the life history of the deceased. It makes that person perhaps seem more important than they were if only a few lines were written. So these large notices are of comfort to the bereaved and produce big bucks for the newspapers.

It’s a win-win situation for everyone.

We certainly don’t object to have a concise, complete life history of a deceased. We are just pointing out how a financially dying enterprise can financially pull itself up by capitalizing on the human nature sense of “not wanting to be forgotten” or “let me tell you about my life”.

Newspapers have certainly tapped into the dual spirit of filling a need for the public and preventing itself from oblivion. This is a very creative way to produce income and also satisfy the emotional needs of surviving relatives.

We guess there is just no end to tackling a personal financial need that also benefits others.



Governor Evers has issued Emergency Order 12 which is also called "Safer at home order."

In this order the Governor is mandating that all non-essential businesses cease operations and that all non-essential travel be stopped. Although travel has been prohibited a complete travel ban has not been issued therefore you can still travel to work (if essential), medical appointments, grocery stores, restaurants to get food, take care of neighbors, etc.

The police department will NOT be stopping people who are out driving around and also does not mean that you need to have a letter from your employer indicating that your position is essential.

With this order the Village will be closing all playgrounds until the end of April, or whenever the order is lifted. We ask that you please respect the closure and remain off the equipment.

If you have any questions about the order please contact us so we can help clarify it. Again, thank you for all your help in "flattening the curve" here in Elkhart Lake and we are excited when we can get back to the Resorter Way.

Family focus drives three Tietz grocery locations

With three locations, one in Howards Grove and two in Sheboygan, Tietz's Piggly Wiggly is one of the newest members of the Elkhart Lake Chamber of Commerce.

The Howards Grove location is the newest member of the Tietz family trio, with Mark and his wife Robin acquiring the store from Bill Schleh in May 2019.

For the Tietz family, the grocery store business has been part of their family tradition since their teenage years.

High school sweethearts both Mark and Robin started their careers at a young age, working for Olsen's Red Owl (later Olsen's Piggly Wiggly) in Cedarburg.

With 27 years under his belt at the Cedarburg location, Mark and Robin decided to venture on their own, when an opportunity opened up for them to purchase their Northside Sheboygan Piggly Wiggly (North and 15th streets) in 2009. In 2016, they added their Southside PigglyWiggly store on Southside Drive. Then they added the Howards Grove location on State Hwy 32 just two years later.

While Mark may be the face of the business for many, Robin has vital roles behind the scenes. "She does a lot of work for us from the home. Besides, she is my rock and my sounding board," Mark said.

Robin also took on the important role of home-schooling the Tietz children, all four of whom are now part of the Tietz Piggly Wiggly operation. Sons Nathan, Clayton, Jordan and Cameron are all part of the team that operates the trio of stores. They are joined by Mother in law Sheila and daughter in law Alyssa.

"We have a blast - a really great time working together," Mark said.

Though operated as independent stores, Tietz's Piggly Wiggly follows what Mark calls the Piggly Wiggly Plan. The stores enjoy the buying power and muscle of a chain. "But we also have the flexibility to do what we need to in our stores to take care of our specific communities," he said.

"Each community, and each part of our town has its own special food interests, and we try to serve those needs."

Tietz Piggly Wiggly follows the weekly Piggly Wiggly ad program, but occasionally offers its own in-store specials. Throughout the year, special events such as Pumpkin Fest or Customer Appreciation Day offer additional specials.

Faith a key value

Operating under the corporate name of One Guide, Tietz Piggly Wiggly stores also reflect the strong Christian face of its owner family.

All three stores play Christian music in the background throughout the day. It was a decision Mark made for several reasons. "I decided that if I was going to have my family working here, I wanted the atmosphere to be right," he said.

He also noted that the music helps him to remain grounded when going through the daily stresses of running business.

"It also reminds me that I am not that important, I'm just a little cog in the big wheel," he added.

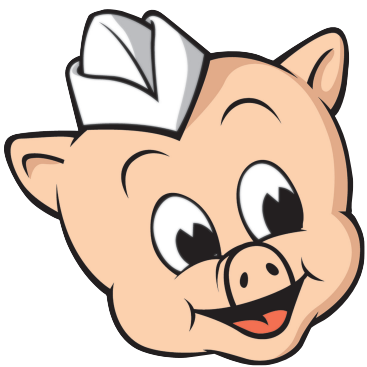

Elkhart Lake Village update

COVID-19 (Coronavirus) Update

On March 17th, President Sadiq signed an emergency declaration for the Village of Elkhart Lake due to the COVID-19 crisis. This declaration allows the Village to have its broadest authority and greatest discretion in respect to emergency response and operation. As of the writing of this article, Village offices, visitor center, police lobby, and the library have been closed to the public except for absentee voting. We would encourage people to watch the Village's website www.elkhartlakewi.gov and the Elkhart Lake Police Department's facebook page for the latest updates.

We would like to remind all that people should:

- Wash your hands often with soap and water for at least 20 seconds, especially before eating and after going to the bathroom, blowing your nose, coughing, or sneezing.
- If you do not have soap and water, use an alcohol-based hand sanitizer with at least 60% alcohol. Always wash hands with soap and water if hands are visibly dirty.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.
- Please practice social distancing.

It is imperative that we all take steps to do what we can to limit the spreading of COVID-19.

Comprehensive Planning Survey - Get in the Know Outdoor Warning Sirens

The Village has four weather warning sirens. One is located on top of the Village offices at 40 Pine Street, one is located in the parking lot by Charlene's, one is located in Lion's Park, and one is located at the Fire Station. The one in Lion's Park is currently not working, but we are having it fixed in the coming weeks. There are some common misconceptions about the warning sirens. Below are some frequently asked questions when it comes to weather warning sirens.

1. What does it mean when I hear the outdoor warning sirens?

In short, it means that something life-threatening is happening and you should go indoors and get more information.

2. What should I do when I hear the outdoor warning sirens?

When the sirens are heard, go inside and tune to local media to get more information.

3. Why can't I hear the outdoor warning sirens in my house?

Sirens are an outdoor warning system designed only to alert those who are outside that something dangerous is approaching.

4. How can I get alerts when I'm at work or in my house?

For alerts indoors, every home and business should have a NOAA Weather Radio All-Hazards. NOAA Weather Radio is like a smoke detector for severe weather, and it can wake you up when a warning is issued for your area so you can take appropriate action.

5. When are outdoor warning sirens tested?

Sirens are tested according to local community or state policies. In Sheboygan County, this is every other Wednesday at 11:00 a.m.

6. Why don't the outdoor warning sirens sound an all-clear signal?

People should be indoors and monitoring local media for updates on the storm. 7. Will the outdoor warning sirens warn me of every dangerous storm? The safest approach is to be proactive and use all the information available to protect yourself and your family from threatening weather. Nothing can replace common sense. If a storm is approaching, the lightning alone is a threat. Sirens are only one part of a warning system that includes preparation, NOAA Weather Radio, and local media.

8. Who activates the outdoor warning sirens?

All Sheboygan County sirens are activated by County Dispatch personnel when directed to do so by the National Weather Service.

Dog Licenses

Please stop in at the Village Hall to license your dog by March 31st. You need to provide a proof of rabies vaccination and pay the fee (\$7.00 per spayed or neutered dog and \$14.00 per dog if not spayed or neutered). A late charge will be assessed to all dogs not licensed by March 31st.

Short-Term Rental Licensing Ordinance

Did you know that if you rent your house out for one night, the State of Wisconsin requires you to have a Tourist Rooming House Permit?

More information on this process can be found on the State of Wisconsin DATCP website https://datcp.wi.gov/Pages/Programs_Services/TouristRoomingHouses.aspx. This means that if you are planning on renting your house for the Ryder Cup or Road America races you need to have the State's Tourist Rooming House Permit.

Due to this requirement by the State and to help ensure properties that are being rented for short-term (less than a month) are meeting health and safety regulations, the Village Board approved a new ordinance for licensing short-term rentals.

This ordinance requires all people who rent their property for more than 10 nights to be licensed by the Village. More information on this process, including an application, will be available by March 1st.

Fresh Meals on Wheels making delivery safer

Fresh Meals On Wheels of Sheboygan County (FMOW) is committed to providing nutritious, medically-tailored meals throughout the COVID-19 epidemic while being cognizant of social distancing and reducing risk of illness among all populations so that people can be well at home.

To do so effectively, we have begun to rollout the delivery of emergency, frozen meals on a weekly basis – we anticipate that ALL clients will be receiving these meals beginning April 1 – until then daily meal delivery continues. The emergency frozen meals are made in the Christopher Family Kitchen at FMOW and meat nutritional recommendations.

Volunteers who traditionally deliver meals, will begin to call meal recipients daily to say hello and to make sure all is well on home, as the social interaction and wellness check remains an important component of the FMOW program.

“Our community is built in kindness and love, so we want to make sure that we laying love on everything we do, even if we need to eliminate the person-to-person contact,” said Kelly Anderson, Fresh Meals On Wheels CEO.

As additional precautions, all FMOW staff members and volunteers have their temperature taken by an infrared no-touch thermometer. As of March 18, only 10 volunteers at a time can pick up meals to keep with the suggestion by Governor Tony Evers, that no more than 10 people be in a space at one time.

Older adults face higher risks of contracting COVID-19 and/or experiencing serious complications and death, particularly if they also have chronic medical conditions. While there are often additional prevention and treatment recommendations for such individuals, that currently is not the case for COVID-19. At this time, Centers for Disease Control and Prevention (CDC) recommends that everyone, regardless of age, take the same precautions to avoid illness including stocking up on supplies, staying home as

much as possible and being diligent about washing hands throughout the day.

Beginning March 12, FMOW cancelled all non-essential group volunteer projects, daily disinfecting of all delivery bags and baskets began, and sanitizing stations were. Volunteers who have traveled to areas with high contagion-risks and/or cruise ships are required to wait 14 days before delivering meals. Staff and volunteers are to remain home if they show signs of fever, cough or sore throat.

All of these changes have been an enormous expense to this not for profit organization. As additional staff, food and supplies have been needed to make the hundreds of extra meals required to be able to deliver a week’s worth of meals to 300 people a day. “And some of our most at-risk population receive two meals a day, so maintaining safe food delivery is imperative,” said Anderson.

Support from the community would be greatly appreciated to cover the cost of the additional food and supplies needed to safely provide extra meals to current clients and to feed those additional people in need of home delivered meals who may

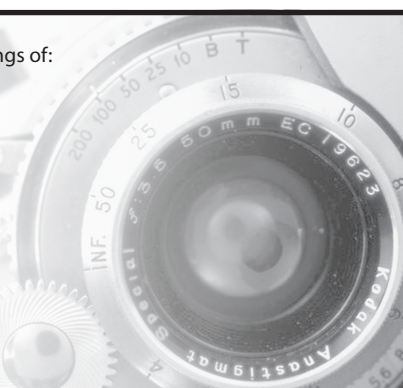

Carolyn's family had a summer home in the area and lived in Milwaukee. When the two married and purchased this house she established LynField and did business as Villager Yarn Shoppe, I was given a yardstick by an acquaintance who had visited her shop. Later with the Souvenir and Gift shop business at Elkhart Lakes Road America. The Langenfeld's donated, along with others, to the historical marker, Briggs Bend.

The house was originally built in 1902 by William Krueger who was a farmer and owned land going back towards the rail tracks. He passed away shortly after the house was built and land was slowly

sold over the years. The Fireman's lot has been here just about as long, you can look at old Sheboygan county maps. Through the years the house was used to help with travelers and visitors to the area in connection with the Pine Point Resort.

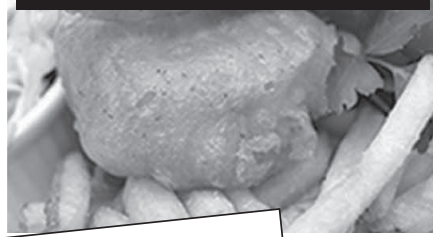

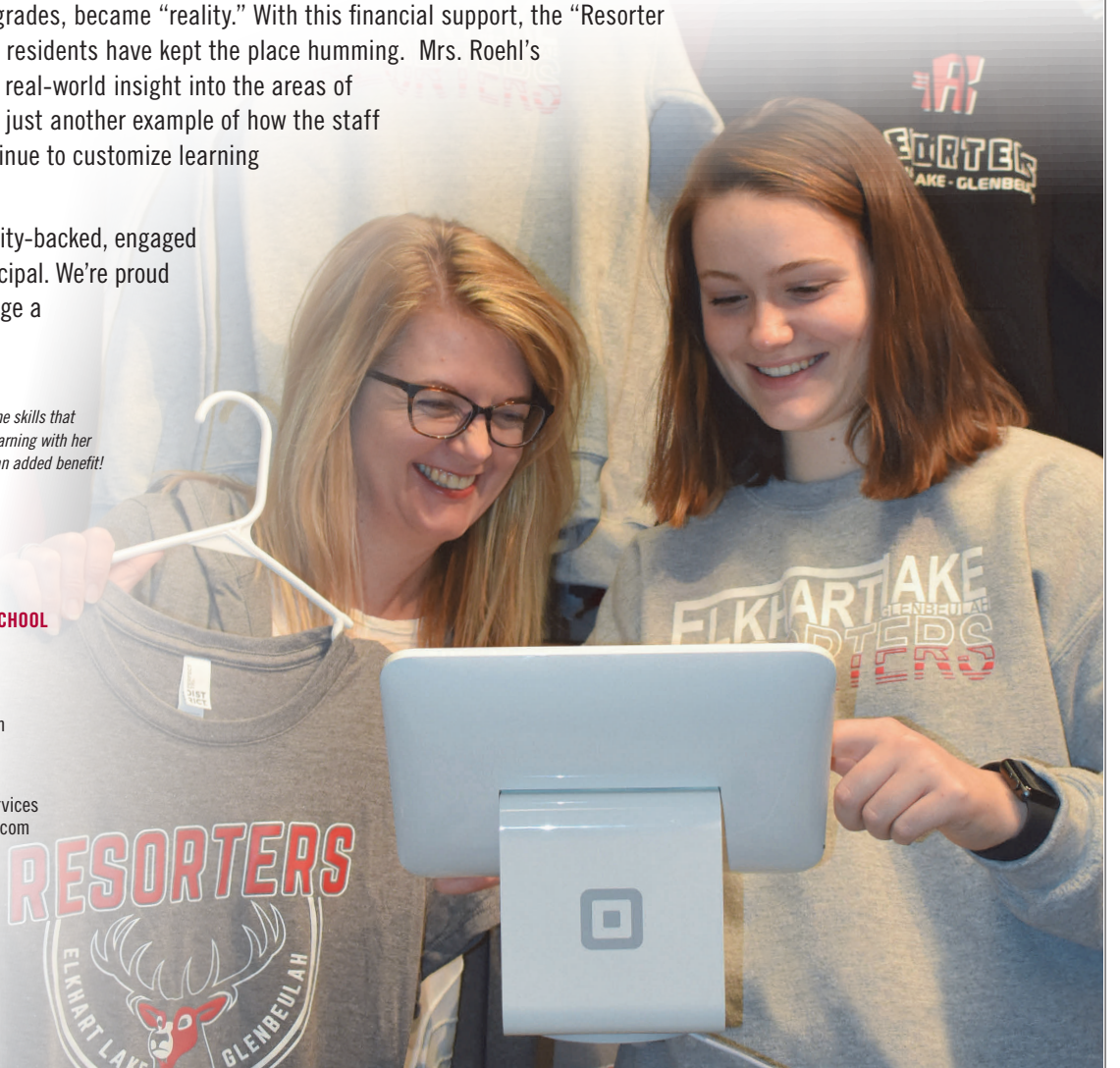
