

## VOTE, VOTE VOTE

I find myself very upset and angry today about the murder of a young Black man who was killed by a police officer on public television this past week and the actions that followed this police action. There was marching, looting, burning, protesting and very adverse actions taken in response to this killing of a Black man as though he were a wild animal. This action sparked a chain of its time to actions that have been performed on Blacks by the police and the legal system the last 12 months. Time and time again, Blacks have been shot down in the streets, and the legal system has made all kinds of excuses, and most of the time, your elected officials have turned them out or slapped them on the hand. We had a killing here in Brunswick County wherein a young Black was killed with excessive force, and it has been overlooked and actions not

## OUTRAGE AND PROTEST

### Will the black rage over Floyd death return?

What comes next days after a nationwide rage in the streets over the Memorial Day Minneapolis police killing of George Floyd, 46?

From coast to coast, in all fifty states, including North Carolina, in Raleigh, Greensboro, Fayetteville and Charlotte, diverse groups of angry youth filled the streets after hours of peaceful protests in memory of Floyd, who

was slain when four Minneapolis police officers in Minnesota arrested him for allegedly passing a counterfeit \$20.00 bill at a store, handcuffed him, and then further subdued the Black man by placing him face down in the street, with one officer's knee in Floyd's neck for over eight minutes.

Video of the incident, with the helpless Floyd crying out that he couldn't breathe and asking for his mother, went viral, causing a national chain reaction of street rage with uprisings, first there in Minneapolis, then spreading to other major urban centers like New York, Los Angeles, Atlanta, in addition to major cities in North Carolina and South Carolina.

Ironically, Durham, Rocky Mount and Wilmington had peaceful demonstrations in memoriam to George Floyd.

In the aftermath of the devas-

tating uprisings across North Carolina over the weekend, leaders spoke out, urging all angered by the killing of George Floyd to respect his memory and bring an end to police violence against Black people.

"My people," admonished Rev. Dr. T. Anthony Spearman, President of the NC NAACP, "it is imperative that you see the hand of White supremacy capitalizing on George Floyd's painful death to ignite your anger and lure you into more riotous conduct and loss of life. Turn your pain into gain. Don't get baited and berated!"

Spearman was alluding to reports of many White supremacists' coming in from out of state, in several instances, going with demonstrators, igniting the vio-

The New Hanover County NAACP was saddened along with the world by the untimely and unwarranted death of George Floyd. We are angry like the rest of the Nation but we are turning our "Anger into Action." Protesting has its place, but to create a more just and equitable system, there are other things that need to occur. Taking it to the street generally does not change policy but taking it to the ballot box in November will. We are asking for seven items to make sure there is not a similar incident in North Carolina. We will hold those in position of policy accountable and inform the public incrementally about our progress. Then on May 25, 2021 we will recognize the day Mr. Floyd left this earth crying for his mother and how we turned his death into action. We will then also give a final review on what we have requested which is listed below.

1. Request a Citizen's Review Board with subpoena power.
2. Request a review of Law Enforcement Use of Force Policy
3. Review of North Carolina Open Records Acts to determine if Officer misconduct information and disciplinary histories are shield from the public.
4. Review of Local Law Enforcement record of disciplining or charging Officers charged with misconduct
5. Demand with other NC NAACP units for a Statewide review board for Police Officers who use deadly force. This will deter them moving to a new location as their re-certification credentials will be tied to this.
6. Full funding of Community Based Policing initiatives
7. Call for the full funding of DOJ Community Relations Service

Rev. Murphy believes race played role in attack on Shepard family

It has now been over a month since an all-White mob, some with guns, led by a law enforcement officer, allegedly tried to force their way into the home of a Black family in Pender County, looking for a missing biracial teenage sister.

The family of Jordan Kita, the now former deputy for the NHC Sheriff's Dept., maintains that race was not a factor in the assault he allegedly led on the home of Monica Shepard and her 18 year old son, Dameon. And to the allegation that he was erroneously tipped off that a Black male teenager named "Josiah" was with his sis-

than sixty attendees Monday.

The Crimes Against Humanity: Justice for George Floyd drew commentary from faith leaders, educators, and others.

It was Devon Scott, community activist and former mayoral candidate who interjected the phrase that national, and now global citizens have chosen as a rallying cry.

"I can't breathe," dying words spoken by George Floyd, murdered May 25 under combined body weights of three Minneapolis Police Officers during an arrest for a nonviolent offense.

Floyd was reportedly accused by a small business owner of purchasing items with a suspected counterfeit twenty dollar bill.

"We must find a way to guard ourselves psychologically, physically, and legally,"

Scott said and referred to existential threats faced by black people.

Sonya Patrick, chairperson of the local North Carolina Black Leadership Caucus, and Black Lives Matter requested, "Words of Empowerment," from Minister Tyronne Muhammed.

He characterized the current mindsets of thousands of protesters and communities that connect institutionalized racism and evil to another black person's death by law enforcement.

"Now America is standing saying, 'Enough is enough,'" Minister Muhammed said.

"Babylon ultimately fell due to evil," he added and stressed the need for unifying efforts.

Native son, Pastor Kojo Nantambu of the Temple of Light and Truth Church, and former chairperson of the Charlotte NAACP echoed sentiments about evil and demonic behavior by powerful lead-

ers and policy makers.

Since the 1600s the power structure has manipulated truth and deemed black people as less than human, Nantambu said.

"Still we rise from the gates of hell and maintain our holiness."

Speaking of geopolitical and environmental effects on a possible, "judgement," by God, Nantambu also described the United States' current president as "a jackass."

Recent floods in the US, the COVID19 Pandemic, climate change, and general disrespect of the earth and its people, were referred to as unnatural plagues and disasters.

"We've lost a lot of topsoil due to floods in the midwest," Nantambu said and asserted that families must be prepared for future food shortages and other long term needs.

"We must tell our people our truth, what needs to be done and how it can be done."

George Floyd, Nantambu

said was the straw that broke the camel's back.

The pastor offered warnings about possible groups of anarchists making legitimate protests about Floyd's death problematic.

The destruction of grocery and drug stores in black communities that already had few is especially bad, he said.

The chance of a Marshall Law declaration by the current president, or the use of a military trained to kill, means that protesters and communities need to be more organized and prepared, Nantambu said.

"He (President Trump) might be evil as hell, but he is not stupid."

Educator Sean Palmer participated and indicated that students in fraternal Greek organizations, and area higher education

institutions are likely to organize to have their voices heard in future weeks.

They know about being

treated unfairly or profiled, he said.

"We need to stand with children who want to change a corrupt system, not define children as criminals."

He decried the knowledge that black youths will deal with tear gas and rubber bullets.

Regarding workers, older adults or groups that cannot physically participate in protest marches, other self-help strategies were provided. "We can create bail funds for students, and determine what lawyers can do this activist work," Palmer said.

A coalition of area citizens has formed to address critical community needs, according to Sonya Patrick.

Plans include requesting the creation of a law enforcement-related citizens' review board with subpoena power, and creating new low tolerance policies designed to limit the possibility of police brutality.

**Hoke County.**

"While I cannot bring her brother back, I can work for justice in his name. The Minneapolis police officer who allegedly killed George Floyd has been fired, along with three other officers on the scene who stood and did nothing. The officer

has been charged with third degree murder and second

degree manslaughter. Minnesota Attorney General Keith Ellison, a former congressman, has taken over the prosecution.

During a press conference on Sunday, Gov. Roy Cooper said he spoke to the sister of George Floyd, who lives in

covered up. Witness intimidation, corruption, and coverup in our communities today. lence, looting, and fueling racial tension.

After Charlotte and Mecklenburg County were placed under a state of emergency for the second time in four years last weekend, Rep. Alma Adams (D-NC-12) said,

"The reason we are here is because of modern day lynchings, the murders of George Floyd, Ahmaud Arbery, and Breonna Taylor, and others and the failure of individuals within police departments across the country to value Black lives."

Congresswoman Adams added, "In this moment, we must be the spark that ignites justice, but we cannot light a

fire so hot that it consumes us as well."

Attorney Irv Joyner, professor of law at North Carolina Central University in Durham and chairman of the NC NAACP Legal Redress Committee, lamented that another Black life has been taken at the hands of law enforcement.

"George Floyd did not get the benefit of that respect of his humanity," Prof. Joyner said in a statement. "Even if he intentionally attempted to pass counterfeit money, he did not commit an offense worthy of the death penalty. The law simply does not allow police officers to determine that a person is guilty of a crime and then execute him or her. The law does not give them that authority and

power; when the officers abuse the limited authority which they possess, they should be held accountable. In the past, this accountability has not occurred."

Kita's lawyer and family maintain they didn't even know that Josiah was Black, even though they were looking for him, and went to one of the only two Black homes in the Avendale community.

What also doesn't make sense then, observers say, is that, if they knew nothing about Josiah, then why were at least three guns brandished? Did Kita and his group display weapons every time they knocked a door looking for his sister that night?

Rev. Dante A. Murphy, President of the Pender County NAACP and leader of Southern Coalition for Equal

Protection Under the Law, isn't buying it either.

After reading last week's Wilmington Journal analysis of the facts surrounding the Shepard home attack and The Journal's exclusive interview with the Shepard family attorney, Attorney James Lea, Rev. Murphy weighed in.

"To ask people is it about race will get different answers, depending on all sorts of things," Murphy said in a statement. "But if you are Black and a mob of armed White people are trying to get into your home, then it is about race. All you have to do is look at American history, about what has happened over and over to our Black ancestors and our present brethren.

There is abundant evidence suggesting that a White mob in pursuit of a Black citizen will result in some horrible and traumatic event if not stopped in its tracks."

"But there is also a kind of non-racial perspective to this event that has to do with the arrogance of power," Rev. Murphy continued. "It has been played out across our nation and in our school systems and institutions for hundreds of years. Both Whites and Blacks and other minorities suffer from it. It happens because of 'good old boy' networks. It happens because of the 'good old boy' system."

"And in this particular Shepard case, with glue apparently holding together an armed mob, a deputy sher-

iff, two sheriff's departments, and a slow moving district attorney, you have the face of an arrogance of power that has, for example, recently shown up with the death of George Floyd in Minneapolis. A Mississippi mayor recently quipped about that event, "If you can talk, you can breathe." Do you for one minute believe that this White Mississippi mayor is not part and parcel of a White "good old boy" Mississippi system?"

"What is welcomed is newspapers like The Wilmington Journal speaking out against armed mob behaviors, and all behaviors of white on Black violence," Rev. Murphy continued.

"Violence in our communities can also be silent and

**TRUMP PULLS RNC CONVENTION FROM CHARLOTTE**

[CHARLOTTE] After Gov. Roy Cooper made it clear Tuesday that the Republican

National Committee would not be allowed to bring 50,000 attendees to Charlotte for their convention in August because of concerns about COVID-19, Pres. Trump announced later that night that the RNC would be pulling the political gathering from the Queen City. The Republican governors of Florida, Texas and Georgia have all indicated that they

would be ready to host the convention on short notice, despite the danger of coronavirus contamination. Trump wants no face masks, and no social distancing during the event.

**NC COVID-19 HOSPITALIZATIONS JUMP TO HIGHEST LEVEL EVER**  
[DURHAM] 716 patients

identified with COVID-19 are listed in hospitals across the state, the highest number of hospitalizations in North Carolina since the pandemic began, reports NCDHHS. There are approximately 30,000 confirmed cases in the state, and approximately 1,000 deaths. Over 450 of those deaths occurred in nursing homes.

## Weeks after court ruling Black pastors still abide by COVID-19 restrictions

As cities across North Carolina were entrenched in turmoil this past Saturday evening in protest of the killing of George Floyd, there was nothing many Black pastors wanted to do more than to preach about it in their respective churches Sunday morning.

As social media starkly revealed, their communities, their congregations, the people to whom they regularly minister, were in pain and needed to

hear the Word.

However, despite the fact that a federal judge's May 16 order now allows North Carolina churches to conduct indoor services unrestricted by Gov. Roy Cooper's COVID-19 mandate limiting gatherings to just ten, something over which several White churches filed suit and Republican leaders supported, many African-American pastors across North Carolina are still abiding by Gov. Cooper's mandate in order to keep their predominantly Black congregations safe from contracting the coronavirus.

faith groups to publicly support positions adversely affecting minority communities."

"Accordingly, considering the empirical data revealed during the COVID-19 pandemic has had on the African-American community, I write to (1) debunk the politicization of well reasoned, governmental "shelter in place" orders; and (2) urge members of populations that are disproportionately vulnerable to refrain from mass, in-person gatherings, including worship experiences, at the current time."

The Reverend Augustine is

not alone in his pronouncement. Many faith leaders across the State echo the view.

The Greensboro Faith Leaders Council also offered a statement decrying reopening for in-person worship.

As Jewish, Muslim, and Christian Faith Leaders in Greensboro and Guilford [counties], we are aware of the very real suffering that the COVID-19 virus is causing in our community, our nation, and our world. Based on the central teachings of our faith traditions and the most reliable science, we will wait a while longer to gather face-to-face, and we encourage other faith communities to do so as well."

Rev. Dr. William Barber, national social justice leader, and Pastor, Greenleaf Christian Church in Goldsboro, railed when President Trump declared that he wanted the nation's churches open for Memorial Day weekend.

"Trump doesn't get to tell the Church what's essential," Rev. Barber said on Twitter May 22. "Buildings are not more important than people doing the will of the Lord."

There were many Black pastors across the country who disagreed.

According to the website "Church Leaders," "the leadership of the Church of God in Christ, a predominantly African-American denomination, has been hit particularly hard by COVID-19." Reportedly, "... up to 30 leaders in the church, including two out of 12 board members, have passed away from complications from the coronavirus."

There are reports across the nation of other churches which defied shelter restrictions, refusing the option of holding outdoor services with congregants in their cars, holding in-person services and spreading the virus mostly to older attendees, several of whom have died.

Many Black pastors have said that's a risk they want to avoid and have instead gone to online social media (Facebook) or telephonic ministry to keep in spiritual contact with their church families.

"The ongoing pandemic has forced us all to adopt "new norms," Rev. Augustine wrote. "Rather than place faithful parishioners in potential danger, I encourage clergy leaders and concerned citizens to use alternative options, including free technological advancements made available to everyone through social media."




### Add one more name

In his poem "No Man is an Island," John Donne wrote, "Any man's death diminishes me, because I am involved in mankind." I've always been involved in humanitarian issues and the universality of justice. This past week has

ing and heart-rending numbers, I'm sure others were woefully desensitized to the full scope of loss from COVID-19.

To put these COVID-19 numbers into perspective, a comparison to the Viet Nam War isn't unreasonable. By official measure, the number of American deaths in Viet Nam is 58,220. That number was matched and surpassed in late April for COVID-19 deaths. Reaching the 100,000 milestone signifies a point of nearly doubling the loss of life in Viet Nam. The greater tragedy is that it took US Forces 19 years in Viet Nam to reach 58,000. We've nearly doubled that number in 3 months!!

Arguably, had the Trump administration begun efforts to combat this virus one week earlier, the loss of life could have been reduced by 36,000. Instead, we add those names to the list of those we've lost. Although not lost to COVID-19, one other name MUST recently be added to those we have lost – George Floyd.

By now, most Americans have seen the video of Mr. Floyd being suffocated by a police officer. The officer

applied near-total force of his body to Mr. Floyd's neck for 8 minutes. During that time, Mr. Floyd repeatedly begged for mercy and, probably from past life-lessons, remained respectful to the police. Mr. Floyd even addressed his assailant as "Sir." In an MSNBC interview, Princeton Professor Eddie Glaude, Jr., described this problem as one of African Americans having to live under the "trauma" of Coronavirus and the "terrorism" of lawless policing.

Those who have lost relatives or friends to the Coronavirus, or even had relatives or friends contract the disease, understand the trauma and uncertainty of living under the threat of the disease. There is genuine trauma in wondering, "Who's next?" or "How can I avoid it?"

If one cannot understand the terrorism that Professor Glaude describes, imagine being apprehended, tried and executed by a rogue police officer. Backing-up from George Floyd on the ground and begging for mercy, we learn of the initial allegation that brought Mr. Floyd and the police in contact. A store

owner called the police with an allegation of passing counterfeit currency. Whether he attempted to pass bogus money or not, there is no charge of counterfeiting that results in execution.

George Floyd joins Eric Garner, choked for selling single cigarettes, Ahmaud Arbery, killed for jogging, Tamir Rice, killed for playing as a 12 year-old child would, Trayvon Martin, killed for walking home wearing a hoodie and eating Skittles, Emmitt Till, killed for allegedly whistling at a white woman, and on and on..

George Floyd endured suffocation AND ridicule to the point of his death. These killings are the result of ideation that denies the humanity of the victims. They cannot be excused because of mental illness. They are deluded expressions of superiority and control over selected victims. This MUST stop!! We need no more names on this list!!

## Andrea Harris and the fight for minority business

Andrea Harris was not well-known, but she should have been. She was the co-founder of the North Carolina Institute of Minority Business Development, an advocate for

ters, from her alma mater, Bennett College ([www.bennett.edu](http://www.bennett.edu)), from the Minority Business Development Agency (<https://www.mbdab.gov/news/news-and-a-newsroom/2020/05/remembering-andrea-harris>)

and from her beloved Institute. A community organizer before she was a minority business advocate, Harris was a little woman with a big voice that she did not mind using for advocacy. For many years, she convinced the North Carolina legislature to fund the Institute of Minority Business Development. At 51", Andrea was a compact hurricane, a force to be reckoned with. And she was a friend.

I was so sorry to hear of transition. We talked at least a couple of times a week when she was a trustee at Bennett College and I was its President. More recently, we might spoke infrequently and no matter how much time passed between our conversations, either of us felt free, at any time, to pick up the phone to chat or ask for a favor. The

news about the ways the coronavirus has affected Black and other minority business would undoubtedly have prompted a conversation with brainstorming, commiseration, advocacy, action possibilities, and possible solutions.

When I read the news that the corona-imposed recession has wiped out more than 40 percent of Black-owned businesses nationally, I thought about Harris and passion she brought to her advocacy. And I thought about the "bailout" has shortchanged minority-owned businesses, many who saw their requests for funding through the Paycheck Protection Program (PPP) be declined. I imagined that Andrea would have called her friend, former Bennett faculty member and Congresswoman Alma Adams to push for set-asides for minority business. I imagined her calling another mutual friend, Rev. William Barber, to weave the minority business cause into his advocacy for social and economic justice.

Harris would not be sur-

prised, just as I am not, that Black-owned and other minority businesses got the short stick of bailout funds and that such a large number of Black-owned businesses (more than any other racial or ethnic group) are imperiled by the coronavirus recession.

The massive hit Black-owned businesses took is partly a function of the industries, including personal services, that minority businesses are concentrated in. It is also a function of the precarious position of minority businesses, many of which are underfunded, with unequal access to capital and market discrimination. People like Andrea Harris fought hard for the right of minority businesses to thrive. And she believed in helping young women, especially her Bennett Belles, to learn about entrepreneurship. She helped us set up a summer entrepreneurship program for high school students, helped establish an entrepreneurship

minor; and took many fledgling businesses under her wing.

We need more advocates for minority business. Most Black-owned businesses have but one employee. Many are unable to provide essential job benefits – health care, sick leave, and more. More Black-owned businesses need more

access to capital. Coronavirus has heightened our awareness of inequality in employment, income, occupational status (22 percent of nurses' assistants are Black women, and another 22 percent are Latina), health status, housing status, and more. While the Small Business Administration did not initially collect demographic data on who got bailout money, instinctively, we know that Black-owned businesses

were less likely than others to get funding.

Andrea Harris's life work was about promoting Black business. As these businesses are being harder hit than others by the corona recession, many of us know that our feisty friend would roll her sleeves up and dig in to offer advocacy and provide solutions for Black-owned business. Amid a national pandemic, some don't think we should talk

much about race. But if we are all in the same boat, some folks are riding, while others are rowing. Harris would be one of those who would focus on the rowers. In tribute to her, we should all be advocates for Black-owned businesses, and direct some of our dollars their way.

## OWN, TV ONE and BET ignore functions of the Black Press

**A**s a child growing up in Tuskegee, Alabama in the 1950's, my only connections with the national black community was the *Pittsburgh Courier* newspaper and *JET* magazine. I could hardly wait for them to be delivered every week. That's why no one has ever had to convince me of the importance of the Black Press.

When hearing Black pontificators from the broadcast press so cavalierly predict the demise of Black newspapers I get extremely agitated. If they are right, then we, as a people, are in much more trouble than even I thought because of

Black-owned TV One, OWN and Black oriented BET are not up to the job. I came to this conclusion after watching them religiously during the homeboundness brought on by the COVID-19 virus. I enjoy programs such as Living

Single, Martin and a couple of Tyler Perry films but they present not one second of news coverage or one second of discussion focusing on issues such as COVID-19 and the lynching of George Floyd. In fact the only

program on the three that one can say has any cultural relevance is *Unsung* on TV One.

A friend, Dr. Lionel C. Barrow, Jr., who was dean of Howard University's School of Communications, defined the role of the early Black Press in a 1977 handbook that celebrated the sesquicentennial of the Black Press. He stated that it has four major functions: "to perform as a watchdog function for the black community that the white press was either unable or unwilling to perform, to answer the attacks published in the white press, to present a viewpoint that differed even from that of liberal whites and to be a carrier and pre-

server of black culture." I am not saying that black newspapers are all that they can and should be in carrying out the functions cited by Dr. Barrow but at least many of them make an effort to do so.

TV One, OWN and BET do none of the first three functions and very little of the fourth. That's why we, as a people, are in deep you know what if the predictors of the demise of black newspapers are on target. It's up to us to prove them wrong.

## How Long O Lord, How Long?

**T**he words of King David that appear in Psalm 13 of the Old Testament echo in the hearts of American people of color today:

"How long, O Lord? Will you forget me forever?"

How long will you hide your face from me?

How long must I take counsel in my soul and have sorrow in my heart all the day?

How long shall my enemy be exalted over me?"

Despite its self-aggrandizement, America is an ugly, hateful place, filled with pain.

The building blocks of this nation were not freedom and democracy, but genocide, enslavement and race hatred. The historical record is clear:

For more than 400 years since we were dragged here, existence in this country for African Americans has been heart-wrenching.

For more than a century before that, people of the first nations suffered systematic attempts at extermination at the hands of European invaders bent on genocide.

Spanish-speaking people, whose ancestors inhabited this land for many decades before the arrival of English speakers, have been robbed and abused at almost every point of

contact with the oppressive forces of "Manifest Destiny."

Asian immigrants and their descendants, who bent their backs to build this nation's wealth, have at different times been unjustly barred entry into this country, deported for no legitimate reason and interned in concentration camps merely

because of their cultural ancestry.

The perverse notion of white supremacy has done all of this. There are those who believe that, because of their "whiteness," they are more deserving of the fruits of the labor of our community garden than are people of color. This evil notion of white supremacy can be tracked through the ages.

There no longer can be any pretext that America is populated with only kind and caring people who abide by the rule of law and respect the sanctity of human life.

We live in a country that placed a pernicious and perverse human being in the high-

est seat of authority. And in so doing, all the minions of the worst demons of this country were let loose to victimize the most vulnerable segments of our national community.

African Americans are not the only people bearing the brunt of white supremacy, but we see our humanity denied and cry out for justice for:

Ahmaud Arbery, killed while jogging in a Georgia suburb,

Atatiana Jefferson, killed in her home in Fort Worth, Texas, Breonna Taylor, killed in her bed in Louisville,

George Floyd, killed on a Minneapolis street.

These are just a few of the Black victims murdered in the name of law enforcement in America.

But let us not forget the suffering of other people of color in America.

Let us not forget the daughters and mothers of the first nations, whose murders and disappearances at an alarming rate cause little concern among most Americans and get little attention in the country's media.

Let us not forget the Latinx children locked up in cages like animals because they tried to enter this country in the same manner as count-

less Europeans who came without passports or papers two centuries earlier.

Let us not forget the Asian Americans who are spat on, punched and kicked by bigots who believe Donald Trump when he lies about China bringing COVID-19 to U.S. shores, rekindling old fears and intolerance toward anyone with Asian ancestry.

There must be responses to these injustices. These transgressions must stop. Americans of all stripes must make a legitimate effort to stop them.

King David prayed for a cure to injustice thousands of years ago when he wrote:

"Consider and answer me, O Lord my God;

light up my eyes, lest I sleep the sleep of death,

lest my enemy say, 'I have prevailed over him,'

lest my foes rejoice because I am shaken."

We must open our eyes and not sleep the sleep of death. We must not let the enemies of justice prevail over us. We must march on, 'til Victory is won.

## NFL comments on George Floyd and gets roasted on Kaepernick

**N**FL Quarterback Colin Kaepernick, 32, hasn't played in the NFL since the 2016 season. He was blackballed by the NFL after silently protesting police brutality by silently taking a knee on the sidelines during the national anthem at the start of NFL games.

On the night of May 30, after three nights of protest around the country following the death of George Floyd, 47, recorded on video showing former Minneapolis police Officer Derek Chauvin kneeling in the neck — the NFL released a statement.

"The NFL family is greatly saddened by the tragic events across our country," stated NFL Commissioner Roger Goodell.

"The protesters' reactions to these incidents reflect the

pain, anger and frustration that so many of us feel. Our deepest condolences go out to the family of Mr. George Floyd and to those who have lost loved ones, including the families of Ms. Breonna Taylor in Louisville, and Mr.

Ahmaud Arbery, the cousin of Tracy Walker of the Detroit Lions," the NFL statement continued.

"As current events dramatically underscore,

there remains much more to do as a country and as a league. These tragedies inform the NFL's commitment and our ongoing efforts.

There remains an urgent need for action. We recognize the power of our platform in communities and as part of the fabric of American society," the NFL statement also read.

The reaction that followed, which recognized the deep irony of a league that ostracized

and blackballed a player protesting police brutality and the statement was not lost. Kaepernick often made the point that his protest was focused on police brutality and racism in America. Other players joined Kaepernick in protest during his last year in the league and his momentum was building

"Wow I can't believe all the NFL owners turned out to be colluding racists and Kaepernick was right the whole time. It's almost as if this is a systemic issue in America," wrote Justin Horwitz on twitter.

"Where were you when Colin Kaepernick was peacefully protesting racial injustice by taking a knee? Oh, that's right your entire league and its racist owners were conspiring against him," wrote Ryan Knight on social media.

"Michael Vick served more time in jail for killing a dog than all the cops combined who have killed the last 493 unarmed black MEN. Let that sink in," wrote Adam Webber on twitter.

On May 28, Kaepernick wrote the following from his

twitter account: "When civility leads to death, revolting is the only logical reaction. The cries for peace will rain down, and when they do, they will land on deaf ears, because your violence has brought this resistance. We have the right to fight back! Rest in Power George Floyd."

"Two knees. One protesting in the grass, one pressing on the back of a man's neck. Choose. You have to choose which knee you will defend. There are no half choices; there is no room for indifference. There is only the knee of protest or the knee on the neck," wrote Sally Jenkins in The Washington Post in a widely read article.

A GoFundMe for Floyd's family reached \$4.4 million as of the night of May, 30 as protests raged across the nation.



"For the love of money is the root of all evil: which while some coveted after, they have erred from the faith, and pierced themselves through with many sorrows." I Timothy 6:10

## A WORD FROM THE LORD

## God is the head of the church and we are his body and members that make up the church

**W**ho is He? In the beginning there was God and he created all things: the world and all that is in it. John 1:1 He is its wisdom: the who, what, where, how and when of wisdom. We, too, accomplish our purpose best when realize it's together we stand to accomplish and divided we fall.


