

## Wilmington healing after three racist officers fired

After a dramatic week when three White veteran Wilmington police officers were unceremoniously fired after it was revealed they were caught on a recording making racist, derogatory, and undeniably threatening remarks regarding African-Americans and what they wanted to do to them, citizens are left wondering, "Are there more?"

"I'm alarmed that these individuals were hired to "protect and serve" the same citizens they spoke about in a threatening and intimidating manner," said Deborah Dicks Maxwell, President, New Hanover County NAACP. "My concern is that these are the three who were caught. How many more lurk behind the blue, not only at WPD, but across this state and nation?"

Wilmington Police Chief Donny Williams,

lauded for taking the bold step of not only terminating the three officers on his first full day as the Port City's permanent police chief (Williams is a 30-year veteran of WPD, and had served four months as interim before being officially named June 24), but also displaying

unusual transparency in revealing virtually every detail about just how vile and hideous the officers' behavior was, says for now, the

## Chief Williams stands up for the community and his department

When three racist White Wilmington police officers were accidentally recorded last month calling Black citizens, Black police officers, and Black demonstrators n-words, even discussing the possibility of a race war to "slaughter," and, in the words of one officer, "...wipe 'em off the f\*\*\*ng map," Wilmington Police Chief Donny Williams, an African-American himself, took it personally.

"It was racially offensive to me, the 29-year WPD veteran told *The Journal*. "I don't know any other way about it, and it was also racially offensive to people who are not Black. It was just outright wrong and disgusting."

Those longtime officers were not only publicly fired, but banished like a bad memory, and Chief Williams made sure of it.

Those racist officers severely tarnished the city, and police department that Donny Williams loves, and, on his very first day as permanent chief, he stood strong in denouncing their actions, and standing up for the values he wants Wilmington and the world to see he cherishes without apology.

"It was just outright wrong, and disgusting," he insisted to *The Journal* in his very first interview the day after his explosive June 24 press conference.

That reaction, to anyone who knows Williams, should come as no surprise. The veteran officer is Wilmington born and bred. First from Wilmington's public housing (son of a single mother in the Creekside housing Community), and first from the police academy to now lead the city's main law enforcement agency.

"This is my home," the married father of two says proudly. "I was born here. There are great people in this community."

And it didn't hurt any five months ago when his predecessor, Ralph Evangelous, wholeheartedly endorsed his former assistant chief's taking over as interim.

"For the past year and a half, I've had the pleasure of watching Assistant Chief Williams help to lead the Wilmington Police Department," Evangelous said in an outgoing statement. "His hard work and commitment to community policing continues to be an asset to our agency. I'm confident he will continue to move this agency forward, while focusing on the safety and well being of our citizens."

"Personally I feel honored and essentially humbled that the City Council would trust me with such a large and awesome responsibility, and by the support that the residents of the city have given me," Williams, the first Black

If you have a nonviolent criminal record in North Carolina with misdemeanors and low-level felonies, and you've served your full prison sentence and paid all of your fines, you can now have those bad marks expunged, thanks to the Second Chance Act.

Governor Roy Cooper signed the long awaited bill into law last week, giving many nonviolent offenders who have paid their penance, indeed, a fresh start and second chance at rebuilding their troubled lives.

The new law automatically expunges criminal charges that are dismissed or disposed "not guilty" after Dec 1, 2021 and allows individuals to petition for expungement of all nonviolent misdemeanor convictions after 7 years of good behavior after Dec 1 2020.

Ex-offenders who also committed low-level, nonviolent crimes between the ages of 16 and 18 years of age qualify for expungement.

The "clean slate" measure, Senate Bill 562, was introduced in April 2019 by a bipartisan coalition of state senators headed by former

inadvertent police recordings only point to the three fired.

"Those are the only ones we could determine and prove," Williams assured.

However, if there are other current members of the Wilmington Police Department who are as disgruntled or racially biased as the three he kicked out the door last week, Chief Williams, an African-American, has a serious message for them.

"I'll be honest. If any officer that's out there has the same views that [those three officers displayed] they need to do me a favor, their sheriff, their patrol commander, whatever agency they work for ...do us all a favor as law enforcement leaders, and leave the profession," Williams said sternly. "We cannot tolerate that. There are no discriminatory biases allowed to

exist in the law enforcement profession. We're dealing with people, and we need to treat people fairly."

"Fairly" is nowhere near how now former veteran officers Kevin Piner, James Gilmore and Jesse Moore, II talked about treating Black people when they were caught on an accidentally activated patrol car video camera earlier this month spewing racial hate during two conversations.

A police sergeant, doing her job by routinely auditing patrol car video, discovered a June 4 taped conversation between Piner and Gilmore, and then Piner and Moore that so alarmed her, she alerted superiors. It wasn't long before that concern made it all the way up to then Interim Chief Williams.

Per transcripts of the offending dialogue, not only was the n-word liberally used referring to Black Lives Matter demonstrators and Black police officers, but talk of a "civil war" between Blacks and Whites coming,

and being "ready" for it.

"We are just gonna go out and start slaughtering them f\*\*\*\*\* n\*\*\*\*\*. I can't wait. God I can't wait," Piner told Moore, later adding that he plans to buy an assault rifle, "I'm ready."

Piner strongly advocated for a nationwide civil war to "...wipe 'em off the f\*\*\*\*\* map. That'll put 'em back about four or five generations."

Moore apparently wasn't at ease with Piner's civil war talk, but a later taped conversation had Moore more energized about a Black female he arrested the day before, someone he freely demeaned as an n-word who needed "...a bullet in her head right then and move on. Let's move the body out of the way and keep going."

Moore also referred to a Black judge as a "f\*\*\*\*\*g Negro magistrate."

The officers also made negative reference to Chief Williams during their diatribes.

Once it was investigated, the officers were hauled in and forced to admit to what they said, and when the city manager and City Council signed off on his decision, Williams decided he wasn't having any of it.

There were "extensive violations of the department's manual of rules and policies which include the standard of conduct, criticism, and use of inappropriate language," the chief told reporters during a June 24 press conference.

He could have allowed them to just resign in disgrace, but no, Williams wanted the three officers fired, their behaviors fully exposed, their ability to work anywhere in Wilmington law enforcement or city government forever blocked, and past cases they testified in examined for probable racial bias and cleared.

He also notified the N.C. Criminal Justice Training and Standards Commission.

"[The conversations] were brutal offensive and deserved immediate attention," Williams said, noting that Mayor Saffo and the City Council concurred with releasing all of the pertinent personnel information to the public. "When I first learned of these conversations, I was shocked, saddened, and disgusted. There is no place for this behavior in our agency or our city and it will not be tolerated."

Police chiefs across the state agreed that Chief Williams did the right thing.

"What I'm most pleased about is how the city of Wilmington and its new police chief responded," Colonel Glenn McNeil Jr., African-American commander of the NC Highway Patrol, told the Raleigh-Apex NAACP during a June 27 Facebook interview.

At press time, whether the actual tapes of the conversations will be released had not yet been decided by a judge.

police chief in the Port City's modern history, continued. "It's been overwhelming for me and my family."

"I may adopt some of the things the prior chief had established, and he was very big in technology, being on the cutting edge, and [adopting] best practices," Williams continued.

"But I also want to put my own stamp on things, and, given what's happening right now [in policing], I want to lead a team that's progressive and do community policing with a different look to it. I want to

accomplish the mission but do it in a way that is very inclusive."

Serving the community of Wilmington; protecting the community of Wilmington. That has been the personal and professional mission of Donny Williams ever since he became a police cadet in 1990, formally graduating to sworn officer in December 1992.

As *The Journal* stated in a Feb. 6, 2020, editorial after Williams began as interim police chief after Ralph Evangelous retired, "...beyond being an officer, a police captain, a deputy chief over Special and Criminal Investigations, and overseeing the department's largest patrol divi-

sion, Chief Williams has always made time for our community's youth, working to expand the Police Activities League (PAL), enrolling over 500 young people per year."

*The Journal* editorial continued, "Chief Williams meets all of the requirements of experienced and educated leadership, with a BA from Mt. Olive College in Management and Organizational Development. He is also a graduate of the Administrative Officers' Management Program at NC State University, [and] completed the 75th Session of Police Executive Research Forum Senior Management Institute for Police."

"And last, but certainly not least, Chief Williams oversaw the design, development, and completion of the Haynes-Lacewell Police and Fire Training Facility," the editorial concluded.

During the recent demonstrations in the aftermath of the killing of George Floyd, Chief Williams left his office, went to the streets, and joined protesters, publicly agreeing that, even as a lawman, Floyd's tragic and senseless death was intolerable.

Now, in the midst of dramatic social justice and police reform, how does Wilmington Police Chief Donny Williams envision his challenge to balance keeping the community safe, while simultaneously

maintaining a strong bond of trust with young people and the African-American community?

"We have to connect police officers with the people, and once you make those connections, our officers and the people they serve are going to have to sit down and have honest conversations," Williams told *The Journal*.

"Officers that are assigned neighborhoods that are primarily African-American are going to have to get both groups together. Also [this is true for] groups that are Hispanic, White, or [in] combined neighborhoods."

"It's all about people communicating with people," Chief Williams said.

Sen. Floyd McKissick (D-Durham). It passed the Senate unanimously, went over to the House where it stalled until last month when that body also passed it unan-

imously, then back over to the Senate where it was passed again on June 16th, and signed by the governor on June 25th.

"We can give people who make amends for past mistakes the opportunity to clear their records. This bill offers that opportunity and

a path to good jobs and a brighter future," said Gov. Cooper.

The bill was supported by both the NC NAACP and conservative groups like Americans for Prosperity.

One of the law's strongest proponents was Dennis Gaddy, executive director of

Community Success Initiative (CSI), a nonprofit re-entry program for ex-offenders who have served their time, and are looking to start their lives over again crime-free and more productively.

Gaddy, once a successful businessman who made

some bad choices years ago, and served time in prison, has led CSI for 15 years, and has helped hundreds of former offenders find stable work.

He says the Second Chance Act now makes it easier for exoffenders to build productive lives.

[WILMINGTON] Mike Adams, the controversial UNC-W professor accused of making inflammatory

sexist and racist comments on his social media, has agreed to retire from the university as of August 1st, the school announced this week. It was a May 29th Twitter post where Adams used slave imagery to chide Gov. Cooper for his COVID-19 restrictions that North Carolina "a slave state." Adams then followed with "Massa Cooper, let my peo-

ple go." The call for Adams to be dismissed got national attention.

**LEGISLATURE****APPROVES****\$1.5 MILLION****N.C. FREEDOM PARK**

[RALEIGH] In a 1 a.m. vote last Friday morning before adjourning, the NC General Assembly approved \$1.5 million for the proposed NC

Freedom Park. The bill has since been sent to Gov. Cooper for his signature. The park honoring Black North Carolinians and how they contributed to the history of this state will be constructed on Lane Street at Wilmington Street in downtown Raleigh between the Executive Mansion and the Legislative Building. The park was designed by

the late architect Phillip Freelon.

**Health officials announce two more deaths from COVID-19 in New Hanover County**

Public Health officials were notified Wednesday of two additional deaths from COVID-19 in New Hanover County, bringing the total number of deaths of New Hanover County residents to seven.

Both individuals were hospitalized; one person was in their 60's and the other in their 80's. Both were considered at high risk of severe illness because they had underlying medical conditions. To protect the privacy of these individuals and their families, no other information will be shared.

"I am so saddened to hear of the loss of two more of our residents, and I extend my deepest sympathy to the family and friends of these residents," said Board of Commissioners Chair Julia Olson-Boseman. "The virus didn't only affect these individuals, but their family, friends, neighbors and community, who never expected this tragic outcome. COVID-19 is spreading in our community, and it takes each of us individually to protect those around us. I urge our residents to follow the three W's - wear a face covering, wait six feet from others and wash your hands frequently.

It's simple, but it will save lives."

The cumulative number of lab-confirmed cases of COVID-19 surpassed 1,000 Tuesday, and Wednesday is at 1,068. Cases among people under the age of 49 are increasing, as well as cases in the LatinX community. Additionally, hospitalizations are rising, with 33 people hospitalized at New Hanover Regional Medical Center Wednesday. (Data reported from NHRMC is for a seven county region, and not specific to New Hanover County residents). Health officials continue to conduct contact tracing to contain the spread of the virus.

"It is heartbreaking to receive notification of two more New Hanover County residents passing away from COVID-19, especially knowing that simple actions, if taken by everyone, can prevent the spread of the virus and protect those at risk of severe illness, and my sincere sympathy goes to the friends and family of these individuals," said Public Health Preparedness Coordinator Lisa Brown. "COVID-19 cases in the area continue to rise with increased activity and lack of

adherence to social distancing and face covering measures. Following the three W's are vital to maintaining activity and slowing the spread. Another way individuals can help is to answer the call and participate in contact tracing if you hear from our public health team. This helps us identify a source of exposure and have individuals take action to get tested, isolate, and keep the virus from affecting the next person. If we all work together in these ways, we can continue reopening and activity in the safest way possible."

**Answer the Call**

Everyone can be part of

the solution of slowing the spread and containing COVID-19 by answering the call if/when a COVID-19 Community Team member reaches out for contact tracing. Contact tracing is the public health practice of identifying people who may have come into contact with someone infected with a communicable disease like measles, tuberculosis, sexually transmitted illnesses and COVID-19. Contact tracers reach out to individuals confirmed to have COVID-19 and help them recall everywhere they have been and with whom they came into contact from 48 hours before symp-

tom onset to the time they got their test results. Then, they call those identified as close contacts - those who had been within six feet for 10 or more minutes. Without sharing identifiable information about the person who has COVID-19, close contacts are informed they may have been exposed to COVID-19 and to monitor for symptoms and self-quarantine for 14 days.

Close contacts are also eligible for diagnostic testing if they choose.

It's important to work with those conducting contact tracing to slow and contain the spread of COVID-19, connect those eligible to testing,

and protect others in the community. Learn more about contact tracing and Answering the Call at NCDHHS.gov.



### D.C. Statehood is a racial justice issue for the entire nation

**T**he District of Columbia is the one spot where there is no government for the people, of the people and by the people," the great abolitionist and D.C. resident Frederick Douglass once wrote. More than a century later, the 705,000 residents of Washington, D.C.—nearly half of them Black—are still denied the full citizenship that every American deserves. They have no vote in a Congress that can override decisions by voters and elected officials about local priorities and tax dollars. Rectifying this injustice should be a top priority for every American who is committed to advancing racial justice and voting rights.

Senate Majority Leader Mitch McConnell has said—wrongly and ridiculously—that righting this wrong would be “full-bore socialism.” On Friday, the House of Representatives rebuked McConnell’s farcical reasoning by voting to make the District of Columbia the 51st state.

The House vote was a historic step toward resolving this glaring injustice. Achieving the final result will require removing McConnell and President Donald Trump from their current posts. The need to do so could not be more urgent.

Denying D.C. statehood has devastating real-world consequences. The coronavirus pandemic is having an especially deadly impact on Black and Latino people in D.C. and elsewhere. Yet Senate Republicans refused to treat D.C. the same way it treated the states in relief legislation. That cost District residents \$750 million in relief funds, even though D.C.’s caseload was higher than 19 states’.

This denial of COVID-19 relief funds is just the latest harm imposed on D.C. by members of Congress who have been happy to treat D.C. as their fiefdom, from interfering with public health officials’ response to the AIDS crisis to blocking implementation of a voter-approved referendum to legalize the use of marijuana.

There is no doubt that both historically and today, opposition to extending democracy to our nation’s capital has been grounded in racism and the desire to maintain racist structures of power.

And there is no doubt that denying citizens of the nation’s capital representation in the national legislature—something no other free country does—undermines our self-image as leaders of the free world and our credibility as a beacon of democracy on the international stage.

Civil rights leaders and other advocates for statehood, including Jesse Jackson and Julian Bond, D.C.’s nonvoting delegate to Congress Eleanor Holmes Norton, and the activists at DC Vote, have been making the case for statehood for decades.

The case is clear. D.C. has more residents than either Wyoming or Vermont, and nearly as many as Alaska. D.C. residents contribute more federal taxes than those of 22 states, and more per capita than any state. There is no principled justification for continuing to treat the people of Washington, D.C. as second-class citizens.

Many of the systemic problems Americans are grappling with do not have simple solutions. But this one does. All it will take is for the Senate to pass and the president to sign the legislation that just passed in Congress.

What is standing in the way is the same ruthless Republican desire to maintain power that brings us racial and political gerrymandering and voter suppression. The illegitimate entrenchment of power in the hands of right-wing politicians undermines democracy. It harms Americans everywhere, not just in D.C., by making it harder to adopt policies that protect American lives and communities. That is why D.C. statehood must be part of the agenda of the broader movement to advance racial equity and a healthy democracy.

For now, D.C. statehood legislation is sure to join the growing pile of common-good measures passed by the House that die in Mitch McConnell’s graveyard. That should intensify our resolve to mobilize voters and overcome every undemocratic tactic Republicans will deploy to suppress the vote between now and November.





### TOO BE EQUAL

#### “Plan A: Don’t go in a crowd. Plan B: If you do, make sure you wear a mask”

“Look at the guidelines. The leaders, the governors, the mayors, the local leaders at the county level - look at the guidelines. Many of the governors and the mayors are doing well, but it’s the people that are out there that are not listening because, as you said, they’re pent up. Please restrain that. If you follow the guidelines and do it slowly and discreetly and do it very carefully, we’ll get through this.” — Dr. Anthony Fauci, head of infectious diseases at the National Institutes of Health

Weeks ago, as some governors began to lift stay-at-home orders against federal guidelines, the National Urban League urged people to stay home. In a joint statement with other civil rights

organizations, we said the governors’ actions showed “reckless disregard for the health and life of Black residents.”

Now, sadly, a surge in coronavirus infections has confirmed our worst fears. The United States set a

record this week for the most infections confirmed in one day: 36,880. That brings the number of confirmed infections to more than 2.4 million.

The Centers for Disease Control estimates that only about one in every 10 COVID-19 cases in the U.S. has been identified. That means more than 20 million people in the U.S. may have been infected.

Officially, more than 122,400

Americans have died from COVID-19 in just over four months. That is more Americans than died in all of World War I, or the Vietnam and Korean wars combined.

It’s more Americans than died in the first wave of the deadly flu of 1918. And most experts agree the true death toll is much higher than the official count.

Contrary to the claims of the Trump administration, increased testing does not explain the surge in reported infections. The number of people testing positive is rising much faster than the number of people being tested. 20 states currently have a positivity rate above 5%. The World Health Organization recommends rates of positivity should remain below 5% for 14 days before states consider reopening.

Arizona reported that

21.15% of tests are coming back positive. Florida’s positivity rate is 12.22%.

There’s little question that the surge is related to the rush to reopen the nation’s economy without proper safety measures in place. Earlier outbreaks were linked to nursing homes, prisons, and meat packing plants – places where people had little choice but to be present. The current surge is linked to crowded bars, casinos, and churches – where there is little need for anyone to be present.

It has always been a dangerous fiction that our choice is between saving the economy or saving lives. The stock market tumbled in response to the surge in infections, and states are being forced to

No one understood this better than Professor James Clingman. obvious connections between politics and economics. Moreover, as others before me have done, my task is to do everything I can to convince Black folks in particular that our interests must be returned to economics over politics as it was when we owned economic enclaves across this nation. I know that's hard for some of us,

because we have been seeking political power since 1965. Irrespective of our feelings about our favorite politicians, the status quo will remain the same until we demonstrate our willingness to use our dollars to effect public policy. Everything else is rhetoric."

Furthermore he continued "I am not advocating an 'either or' scenario between the two disciplines; certainly our actions in response to them must be 'both and.' We must understand the priority however; which one comes first, which one depends on the other, and which of the

two can achieve real power faster. We have struggled with politics for 50 years now, since we abandoned our economic base of business ownership and mutual support. Five decades should be enough to convince us that if and until we have a strong economic base, a position of struggle from which to negotiate our grievances with politicians, we will never have real political power. **Symbols, statues, and substance**

Socially isolated and alone in my home, I lifted my fist into the air when I learned that the Mississippi legislature voted to remove the Confederate stars and bars from their flag. As NACCP President Derrick Jackson said, "it's been a long time coming." A long time since the songstress Nina Simone put it out there with Mississippi G—damn. A long time since Emmitt Till was massacred for "reckless eyeballing." A long time since James Chaney, Andrew Goodman, and Michael Schwerner were murdered. It's been a long time coming, but has Mississippi changed?

I'm an economist, so I have to go with the data. Mississippi is the most impoverished state in our nation. It also has the highest percentage of African Americans – 37 percent. Still, the state voted in a racist white woman – Cindy Hyde-Smith, who joked about lynching in the days leading up to her election. Mississippians found such jokes acceptable since they rejected Mike Espy's candidacy for the Mississippi Senate seat that Hyde-Smith now occupies. He garnered 46 percent of the vote in what was described as the closest Senate election in Mississippi since 1988, still, his defeat speaks to the

intransigence of racism in his state. Perhaps his 2020 candidacy will yield different results. From my perspective, though, it's not the symbolic flag, but also the substantive racial inequality in Mississippi.

So while I also cheered that the Princeton University Board of trustees finally agreed to remove the nation's racist 28th President's name from its public policy school, I wonder if anything else has changed at Princeton. Students have demanded a more diversified faculty and curriculum and funding for research on reparation. The name change is the first step. What is the next step?

In Virginia, Governor Ralph Northam (D) said he would remove the statue of Jefferson Davis, the traitorous President of the Confederacy from Richmond's Monument Avenue. As soon as he announced it, there was a lawsuit challenging his decision, and the matter is headed for court. Rita Davis, the Black woman who is Northam's legal advisor, said the statue was designed to minimize "a devastating evil." If you walk down Monument Avenue, evil

abounds. Taking the statue down is a first step for the blackface-wearing governor, but again what's next?

Even as the winds of change are swirling, there are dinosaurs who cling tenaciously to our nation's racist past. I do not understand why Confederate loyalists seem to have forgotten that THE CONFEDERACY LOST THE CIVIL WAR. Except to stir up his racist base, I don't understand why a man who was born and raised in New York has such loyalty to the Confederacy.

On June 26, the 45th President issued an executive order "protecting monuments, memorials, and statues and combatting recent criminal violence." The executive order is replete with combative and incendiary language, describing protesters as "rioters, arsonists, and left-wing extremists." It uses terms like "Marxism" and "agitator" to describe those who oppose historic racism as "ignorant of history." Because of this "ignorance" (look in the mirror, Mr. President), the executive order says the Feds will prosecute people who "destroys, damages or desecrates a monument on federal or state property," and their "accomplices" and imposes criminal penalties of up to 10 years in jail. Really? If our nation's founders had been held to the same specious standards, there would be no United States of America.

The folks who are clinging to statues are clinging to a way of life where Black people are supposed to bow and scrape and accept any kind of treatment from "powerful" white people. In adhering to the Confederacy and folks like Woodrow Wilson and Andrew Jackson, they are clinging to Presidents who were oppressive segregationists. Wilson's legacy is especially egregious as he deliberately attempted to reverse Black progress by resegregating the civil service. Now, we have a President who would do it all again by embracing racism, retweeting a "white power" video, demonizing protesters, and using language designed to divide.

Some of the symbols of racism are being erased, albeit slowly, but little has changed about the substance of racial inequality. People should not be celebrating symbolic victories unless they are prepared to challenge structural inequality. I cringe when I walk in downtown DC, looking at signs that proclaim "Black Lives Matter," knowing that many of these stores have exhibited racist behavior toward Black neighbors. Don't eradicate the symbol, Mississippi, Princeton, commercial establishments, if you aren't also willing to eliminate the substance of racial inequality.

**RAINBOW COALITION****Mandatory college football practices at time of pandemic are nuts**

The NCAA has just ruled that mandatory football practices can begin in July, anticipating a full season of college football.

This is nuts. The pandemic isn't going away; it's surging in more than 29 states, with seven reporting new records for cases in a day. States that opened early without adequate safeguards — Texas, Florida, Arizona — now face a spread of the pandemic that may soon exhaust the supply of hospital beds. Deaths are now over 125,000. Increasing numbers of young people are contracting the disease, presumably because of the lack of social distancing, the scorn for masks that has accompanied the reopening in many states — and, of course, in the White House itself.

The experience of Texas and Florida and Arizona in reopening suggests that it may not even be safe to reopen college campuses with thousands of students gathering together in dorms, classes, parties and bars, much less begin practices on a football field. In the so-called "voluntary workouts" that some schools began in June, dozens of players have already tested positive. UNLV suspending on-campus workouts when four athletes tested positive for the virus.

Texas Tech reports 23 players have tested positive; Clemson reports 37 football players and 47 cases in all among athletes. And now the NCAA says it's time to open mandatory workouts.

Football is a physical contact sport. The coronavirus is transmittable through respiratory droplets. If an infected athlete wipes his nose or mouth between plays, or takes out his mouth guard, he has the virus on his hands that will be in repeated contact with other players.

Does anyone doubt that the virus will spread like wildfire once mandatory camps and contact drills begin? To discount this reality, we hear a lot of gibberish. The athletes will be tested regularly, we're told, and isolated, traced and quarantined if they have the disease. How regularly? Well, daily would be optimal — that is what wealthy professional teams are talking about doing — but few if any universities can afford that.

So some will test weekly; some only if an athlete exhibits symptoms, even though young people are

often asymptomatic. No wonder Ohio State University is forcing players and their parents to sign an "acknowledgment of risk waiver."

The university is prepared to risk the lives of the players, but not open itself up to liability. Don't worry, we're told, "college athletes in general are a young, healthy population in relation to the general public. They are usually well-equipped to fight off the infection physically unscathed." Usually. But we're learning that even those who survive the virus are often scarred with weak lungs, or bad hearts.

The watchword, we're told, is "flexibility." Second- and third-string players have to be ready to step in at any time. "This scenario," one doctor wrote, would be analogous to spraining an ankle or pulling a hamstring during warmups and suddenly needing to sit out the next one to three games." No, a sprained ankle does not put a life at risk. A pulled hamstring is painful, but not as lasting as a damaged lung or weakened heart. Sprained ankles and pulled hamstrings aren't contagious. We're not talking about "flexibility," we're talking about irresponsibility.

Many of the football players in Division One schools come from low-income families. Many depend on their scholarship to pay for their schooling. Now they are

asked to risk their lives for their sport. I believe that this college football season should be postponed. It can't be played in a "bubble," as Dr. Anthony Fauci suggests. And we've already got vivid proof of how vulnerable the players are to the virus. But if the NCAA and the universities are intent on playing despite the risk — driven no doubt by the billions of dollars at risk if the season is called off — they should at the very minimum give the players and their parents a real choice.

Every player should be given the choice of whether to play or not, with their scholarship sustained no matter what decision they make.

Every player and their families should be guaranteed free health care if they contract the virus. No player should be extorted to put his or her life at risk in order to get the education that they have earned. In this time of Black Lives Matter protests, the lives of these young athletes — black, white, brown and yellow, male and female, must matter. If the NCAA isn't responsible enough to suspend the season, it should at the very least require that every athlete be given a choice on whether to take the risk, without losing the scholarship that has been promised to them.

ing real economic power collectively and individually as quickly as you can....Our aggregate annual income of \$1.2 trillion dollars is mainly used to create wealth for everyone for Black people, because we spend the vast majority of it at their businesses. Politics has not and will not solve these issues. We must solve them ourselves, by 'the work of our own hands,' as Martin Delany told us." For those who don't know, Martin Delany was an Afro-centric contemporary of Frederick Douglass. Finally he noted the term,

"Black dollars matter! is in response to our efforts to tell the world that 'black lives matter!' When purchasing a home there are 4 pots of monies you will need, and the bank wants to know if you have enough money to complete the purchase. These monies can be either from your bank account, 401k account, or any other

sources that can be proven that it belongs to you and where it came from. 1) Down payment 2) Upfront/Prepays 3) Closing cost 4) Reserves. Depending on the loan program you are applying for, you may or may not have a down payment. There are several 100% financing options out here so definitely see if you can qualify for one of them. Otherwise, the next most popular for 1st-time buyers is an FHA loan with 3.5% of the purchase price as a down payment. The prepaid is a collection of fees like Earnest deposit, Due diligence fees, home/pest inspections, and appraisal. These fees totaling can range between \$1800-2500.

The closing cost will be paid at the end of the transaction at the closing table. These fees are lender fees, Attorney fees, 1-yr insurance paid upfront, the start of the tax/insurance escrow account, etc. The closing cost varies depending on the loan, price of the house, etc but typically they can range between \$4500-7000. The good news is that a good Realtor can usually negotiate for the seller of the home to pay all or at least some of the closing costs on your behalf. So, it's important that you make sure the Realtor you hire has mad negotiation skills. Lastly, Reserves are funds that will be left in your account after the down pay-

ment, prepaids and closing cost are out of it. The bank wants to know that you have at least 2-3 months of the new mortgage amount left in there in case you can't work for some reason because hey, they just want to know they can get paid, LOL.. Now I know this is a lot of funds to come up with but here is where pre-planning and budgeting will come in. As stated, if you have a 401K or other assets that could be sold to get funds you need to purchase, all these things will help you. Your other option is gift funds. Lenders will allow for immediate family members to give you funds for any of these pots of money but those rela-

tives must be willing to prove that they had the money in their bank accounts for at least 60 days prior to giving you the funds. Relatives must also sign a statement saying the funds are indeed a gift and you are not expected to pay them back. Sit down, strategize, and get your monies up and then go ahead and Get That Deed.

**Brunswick County reports sixth death of county resident related to COVID-19**

BOLIVIA, N.C. – Brunswick County Health Services is reporting the death of another county resident associated to the novel coronavirus (COVID-19).

The individual was a resident at the Universal Health Care of Brunswick congregate living facility who received a positive test result for COVID-19. The patient was considered a person at high risk for severe illness as they were over the age of 65 and had underlying medical conditions. To protect the family's privacy, no further information about this patient will be released.

This individual is the sixth Brunswick County resident and second resident at this congregate care facility to pass away with a death related to the virus. Health Services reported on the passing of the first facility resident this past Saturday, June 27.

"It is with a heavy heart that we received this news today, and this individual's family and friends are in our thoughts and prayers," Chairman Frank Williams said.

As of Tuesday, June 30, there are now 22 residents and 14 employees at Universal Health Care of Brunswick who have received positive test results for COVID-19. These totals reflect the previously reported cases from June 13, June 17 and June 23\* including the two deaths.

"We were saddened to hear that another positive resident at the facility had passed away so suddenly, and we extend our sympathies to those affected by this loss," Health Services Director Cris Harrelson said. "We urge all our residents to continue to take this virus seriously, as our cases continue to grow among individuals of all ages or health backgrounds.

We appreciate the efforts so many have taken to protect the most vulnerable in our communities and support our health care workers, but our work is far from done yet and we need everyone to take the initiative to help slow the spread."

Health Services conducts daily check-ins and regular conference calls with the Universal Health Care team to assess the situation and the actions taken to help the patients. Since June 23, Universal Health Care identified two more residents and three more employees through a third round of testing. The facility is continuing to proactively test residents and staff that have tested negative in previous rounds to contain further spread as well as possible. Health Services and NCDHHS are also supporting Universal with any staffing to best protect one another.

Positive facility residents are isolating in rooms in a dedicated section of the building and have staff members who only serve these individuals. Per NCDHHS guidance, all employees are wearing proper personal protective equipment (PPE) including face coverings while at work and all residents are wearing face coverings when leaving their rooms.

No further information concerning the facility's employees or residents will be shared. Health Services will provide another update should it identify additional positive cases at the facility in the future.

People can take simple actions each day to help prevent the spread of COVID-19, particularly through asymptomatic spread. Everyone is urged to follow the three Ws when visiting any public area to best protect one another.

These efforts work best when they are all practiced together by as many people as possible:

Wear a cloth face covering when in public (Make sure both your nose and mouth are fully covered and you are able to breathe normally while wearing it.)

Wait six feet apart to avoid close contact and maintain appropriate social distancing between yourself and others.


Wash your hands often or use hand sanitizer while also following other best hygiene practices.

The Governor's Executive Order No. 147 has also extended Safer at Home Phase 2 to Friday, July 17 and now requires individuals to wear face coverings in certain public places—both indoor and outdoor—where staying six feet apart from others not in your household is impossible.

In the past six days, Health

Services has identified nearly 130 more residents who received positive COVID-19 test results, surpassing the 500 case count mark by the end of June. More positive cases are expected to be identified in the coming weeks due to the observed increase in activity at public places and lax behavior to social distance during get-togethers with family and friends from other households, in addition to the expected travel and activity that occurs during the Independence Day weekend.

As of Wednesday, July 1, six county residents have had deaths related to the virus. Health Services reported the first resident to pass away April 3, the second resident April 15, the third resident June 1, the fourth resident June 27, and the fifth resident June 29.






