

Local BLM leader says nothing less than "BLACK LIVES MATTER"

The leader of "Black Lives Matter-Wilmington" agrees with City Councilman Kevin Spears that nothing less than BLACK LIVES MATTER for a street mural will do, to be placed on Third Street downtown.

Sonya Patrick, head of the group, as well as the National Black Leadership Caucus for the Southeastern Region, tells *The Wilmington Journal* that neither she nor her members will accept any of the substitutes offered by

City Council members in an attempt to "soft soap" the message.

We will not compromise on the Black Lives Matter Street Mural on Third Street," Ms. Patrick told *The Journal*.

"If the Mayor Pro Tem honors Congressman John Lewis as she stated in the last city council meeting, she will respect the fact that the last public appearance Congressman Lewis made was on Black Lives Matter Plaza in [Washington]DC, which is the name of a street which displays a Black Lives Matter street mural. We feel certain that if Congressman Lewis were here

today, he would have concerns with the mayor and City Council's not approving a street mural in a city that imposed the only successful government takeover known as the 1898 Massacre, killing unarmed Black men, women and children."

Noting that "...old school good old boy money does not fund all ...tax dollars generated by New Hanover County, just a portion," Ms. Patrick went on to assert that "We are taxpayers too, and 5000 of

Obama makes North Carolina endorsements

Remember when former President Barack Obama was carefully keeping himself publicly at arms length from anything political once he left office?

Well, apparently those days are over. Beyond giving a full-throated endorsement of his former vice president in the upcoming November election a few weeks ago, and speaking out forcefully against what he sees are the excesses of the current Trump Administration, the nation's first Black former U. S. President is now endorsing 118 Democratic candidates for federal, statewide and state legislative offices across the country, including here in North Carolina.

The high-profile move further confirms North Carolina as an important swing state in the crucial Nov. 3 elections. Pres. Trump had already declared North Carolina as a key state in his re-election, having originally chosen it for his Republican National Convention, only to cancel much of it here because of COVID-19.

According to the press release from his office, Obama "...set guiding principles for issuing this fall's endorsements. He selected candidates because their election would advance key goals: winning control of the U.S. Senate and holding the majority in the U.S. House; electing Democrats who will support fair redistricting in 2021; supporting alumni of his campaigns and administration; and promoting diverse, emerging leaders for this time."

In his Monday endorsement announcement, Obama threw his backing behind incumbent Democratic Gov. Roy Cooper, now vying for his second term.

Then Obama listed several Democratic statewide hopefuls for support, including State Rep. Yvonne Lewis Holley for lieutenant governor; Ronnie Chatterji for state treasurer; Wake County Commissioner Jessica Holmes for state labor commissioner; and former state

NHC school board hires first Black superintendent

The New Hanover County Board of Education has hired the first African-American superintendent in modern history to lead the school system in its history.

His name is Dr. Charles Foust, Superintendent of the Kansas City, Kansas Public School System since August 2018, and, according to the New Hanover County NAACP, when Dr. Foust starts on Sept. 1, 2020, he has a lot of work to do.

"The New Hanover County NAACP welcomes Dr. Foust to our community. Ms. Deborah Dicks-Maxwell, President, New Hanover County NAACP said in a statement to *The Journal*.

"It is always good to return home, as he is doing by coming back to North Carolina. He has a history of improving school systems and we all know New Hanover County is in need of improvement to become a fairer and more equitable school system."

"He has a lot of work to do," Ms. Dicks-Maxwell said.

"Issues like elementary school suspension, increasing staff morale, providing a safe teaching environment during COVID-19, reductions of SRO's for disciplinary measures the school should address, are just a few of the issues with which he will have to contend, in the opinion of this branch," Dicks-Maxwell continued.

"We are also cognizant of the fact that he will be

"Poor people" could turn the election, says campaign study

If poor and low-income voters turned out to vote as much as those with higher incomes this November, they could change the course of the election, especially in North Carolina, says a new study commissioned by The Reverend Dr. William Barber's "Poor People's Campaign: A National Call for a Moral Revival."

According to a new study

by Robert Paul Hartley, an assistant professor at Columbia School of Social Work, "Low-income people are less likely to vote in national elections than those with higher incomes for many reasons, including that candidates don't speak to their issues; they don't think their vote will make a difference; they have mobility/time impediments."

However, based on data from 2008-2016, poor or low-income voters could elect U.S. senators in 16 states in the upcoming Nov. 3 general

elections if they voted at the same level of higher-income citizens.

In North Carolina, according to the study, "...low-income eligible non-voters made up 22% of North Carolina's total electorate relative to average midterm election years from 2006 to 2018."

The study continued, "The percentage of the low-income eligible non-voting population equal to the average 2006-2018 midterm senate election margins is 12%. That means that, if

12% of low-income eligible non-voters in the midterm elections voted, they would match the average margin of victory in those contests."

"In North Carolina, 44% of people are poor or low income - a total of 4.6 million people," the research states. "This includes 53% of children (1.2 million); 46% of women (2.3 million); 58% of Black people (1.2 million); 67% of Latino people (699,000) and 36% of White people (2.2 million)."

As a result, the Poor

People's Campaign, a non-partisan issue advocacy organization, with less than 100 days before the Nov. 3 election, is undertaking a voter outreach drive in North Carolina and 15 other states called "We Must Do MORE: Mobilizing, Organizing, Registering, Educating People for a Movement that Votes."

The study is produced by a faculty affiliate of the Center on Poverty and Social Policy and Columbia Population Research Center.

[us] petitioned for a BLACK LIVES MATTER street mural, although the petition was altered, and there was no way [to] change it back."

Patrick further states that BLM was not asked "to the table" by those planning the art installation that the council seems to be leaning

toward.

"The current artwork needs improvement to reflect the spirit and historical significance of our culture. The city's request for "Black Lives Do Matter" ...is unacceptable. If Black lives do matter, we would not need the movement Black Lives Matter."

Ms. Patrick also made the point that the BLACK LIVES MATTER street mural on Third Street would not be a traffic

obstruction in any way.

"BLM street murals are visible by plane, helicopter and walking traffic. There is no walking traffic on Third street which is where we want the mural to protect it from vandalism."

"However, the [mural] can be visible from the 1898 monument if placed on Third Street."

The Council is expected to make its decision at its next meeting.

the first African American school superintendent since Reconstruction," she continued. "This is important from a historical perspective, and his presence should also encourage our youth to aspire for a career in education. He will be held to the same standards of accountability as any other superintendent.

"It is our sincere hope that the community, school board, staff, principals, teachers, and non-classified personnel will support him, as there will be change because there has to be for this county to improve. Our courts have stated that each child deserves a 'sound basic education' which we are not equitably providing. Dr. Foust has a large task, and, with our support, it can be achieved."

Dr. Foust, unanimously chosen by the school board from a

list of 39 well qualified candidates, will earn \$225,000 annually as NHC school supt. As far as School Board Chair Lisa Estep is concerned, he's worth every penny.

"The members of the New Hanover County Board of Education unanimously and enthusiastically support Dr. Foust's selection as our new superintendent," Estep said in a statement. "We are certain that Dr. Foust's energy, aggressive goal setting, and experience with school turnaround will lead our high achieving school system to

even higher achievement. His demonstrated commitment to equity, communication, and transparency made his selection a strong choice for our schools and our community right now."

Foust was appreciative. "Thank you to the New Hanover County Board of Education in this new partnership," said the new supt. Friday. "What an honor to be entrusted as the next district leader of New Hanover County Schools. I sincerely believe all students have the ability to learn; our job is to create and offer a first-

class education in a safe and inviting setting. My charge is to assist all employees in the development of our school district so that we move from a good district to a world class educational facility. I'm thrilled to be at the helm at this critical moment for our school district, which I believe has the potential to be an exemplar of educational excellence and social impact."

Charles Foust has deep North Carolina roots.

Before leading Kansas City Public Schools, Foust was chief school performance officer in

the Union County Public Schools in Monroe. He started his education career as a fourth grade teacher, then as a principal, asst. principal, and curriculum facilitator for the Guilford County School System in Greensboro.

Foust also served as an asst. principal, school support officer and principal in the Houston Independent School District in Houston, Texas.

He has served in public education for 23 years and has a strong record of student achievement.

The group will be comprised of both students and board members. Chancellor Jose Sartarelli says the committee is an "opportunity to reaffirm the

university's commitment to an inclusive campus." Prof. Adams was forced to resign from UNC-W because of statements he made that many considered to be racist and sexist. He was found dead in his home two weeks ago, the result of a self-inflicted gunshot wound.



The COVID vaccine decision awaiting us

COVID-19 has turned the lives of every man, woman, and child on the planet upside down, and continues to sweep around the world with a vengeance. Here in the United States the virus particularly vicious, as we watch in horror as it becomes crystal clear it's not going anywhere for the foreseeable future.

To date, the best understanding in the medical and scientific field is that transmission and spread of COVID-19 will not slow down until 50% to 70% of the population is infected. One prominent epidemiologist sums it up by saying, "We will be dealing with this forever."

The U.S. declared a national emergency in mid-March, and here we are almost six months later; the death toll continues climbing and the human toll of the virus in America has just passed 150,000 lives lost, with all indications that we will most likely exceed 200,000 deaths by the end of this year.

I know, some of you are reading and saying, "Doesn't this guy know that we are at the brink of a COVID vaccine?" Sure, we might have a vaccine soon, but many experts are already stating with confidence, "some communities are not ready to accept it." Well, I belong to one of those communities, and let me tell why I believe they are right.

The majority of people with little, or no, experience nor insight to the lives of members of these communities, automatically default to the U.S. Public Health Syphilis Study at Tuskegee! Well, the issue is much deeper than that.

We make a huge mistake of resting all of our attention and focus on attributing the mistrust and suspicion on vaccines and Blacks on that one atrocity; there are a plethora of factors!

Perhaps (in the interest of time and space), these "factors" can best be summed up by an article in the Journal of Healthcare for the Underserved, "Several factors that affect the participation of African Americans in studies have been identified including elements of study design, logistical problems, low levels of health literacy, sociocultural factors, and specific attitudes that hinder research participation. Mistrust of academic and research institutions and investigators is the most significant attitudinal barrier to research participation reported by African Americans".

All of the issues and conditions that have disadvantaged poor and communities of color in this country, are the very things resulting in the disproportionate burden that Black people all over this country are experiencing with COVID. Discrimination; healthcare access and utilization; occupation; education, income, and wealth gaps; and housing. All, according to the CDC are associated with more COVID-19 cases, hospitalizations, and deaths in areas where racial and ethnic minority groups live, learn, work, play, and worship. Researchers at the CDC found that 47% of US adults have an underlying condition strongly tied to severe COVID-19 illness. By middle age, 50% of Blacks have hypertension, and 70 percent of retirement-age Blacks.

FDA data shows that Blacks, Latinos, Asians, and others are underrepresented in clinical research in the U.S. According to U.S. Census data, Black or African Americans represent 13.4% of the U.S. population, yet make up only 5% of clinical trial participants. The disparity is even greater for those of Hispanic or Latino origin. They represent only 1% of clinical trial participants.


If FDA approves the any drug or treatment, it will be prescribed for people of all different ages, genders, races, and ethnicities; so, it is essential that data reflects the effectiveness and potential side effects for all groups. So, if we are not included in the clinical trial, how in the world are we supposed to know that it's safe and effective for us? How do we make an informed decision?

Lastly, I have to address the issue of rationing. Who will even be offered the opportunity to get the vaccine first? How will we give priority to different groups or communities whose case load and death rate indicate that they are most vulnerable and deserve to be vaccinated first? In an ideal world, the elderly, Black and Brown communities, and essential workers. The overwhelming majority of the "essential workers" in this country are members of Black and Brown communities. Going to work, therefore, could mean being exposed to a virus that disproportionately targets those "essential workers" with underlying health conditions.

The social and structural factors that make Black and Brown people, in this country, especially vulnerable are long-standing and historical. What makes it all so frustrating and tragic is that some of the things that could have fixed them were not done...ever!

Let's do what's necessary, and for once focus on health literacy, equitable distribution of healthcare; and full inclusion and retention in the clinical research for COVID-19

The issue of inability to pay, poverty, and unemployment – that existed pre-COVID-19. The difference between now and then is that the pandemic has shifted the line of poverty. There are more people at risk than before." Attorney Raphael Ramos of Wisconsin's Eviction Defense Project

In his Pulitzer Prize-winning book, *Evicted*, Matthew Desmond's book quotes a woman he calls Arleen describing the profound exhaustion of trying to keep a roof over her children's heads. She says, "Just my soul is messed up."

Her children are so defined by the experience of being evicted, over and over again, that one of them vows to become a carpenter so he can build her a house.

The moratorium on evictions that was imposed by the CARES Act in March expired last week. The estimates on the number of Americans on the brink of eviction range from 10 million to 28 million.

With the nation fountaining in the worst economic crisis since the Great Depression and poised to plunge even further, more than 12.5 million renters were unable to make

their most recent rent payment. Almost twice as many fear they won't be able to pay next month's rent. About 56% of those renters are Black or Latino. More than 3 out of every ten Black renters is behind on rent, and 46% of Black renters have no confidence they can make their next rent payment.

Even before the pandemic, nine of the 10 highest-evicting large U.S. cities had populations that were at least 30 percent black. Among the eviction cases filed since the pandemic began, nearly two-thirds were in communities with above-average populations of color. With evictions clustered in lower-income black neighborhoods, entire communities already struggling with massive job loss and business closures are disrupted by a churn of people moving in and out that severs close-knit social networks.

With supplemental unemployment insurance payments expiring and Congress nowhere near a deal to extend

them, the nation is facing an unprecedented wave of evictions that will drive the nation even further into economic crisis and despair.

Eviction doesn't just mean the loss of a home. It means the loss of self-esteem, peace of mind, community and support systems, and physical and mental health.

Safe, affordable housing has always been at the heart of the National Urban League's mission. As economic first responders, Urban League affiliates around the country are keeping people in their homes with emergency rental assistance, intervention and counseling. We are seeing the devastating economic effects of the pandemic first-hand.

Last October, before any one ever heard of the novel coronavirus, the National Urban League issued an urgent call to presidential candidates to address the affordable housing crisis. The following month, we went them a letter.

It wasn't until late November, on the sixth night of debates, that the candidates finally were asked a question about the housing crisis.

Evictions are not just a result of poverty, they are a

cause of poverty. It can result in job loss and make it hard to find a new job. It can make it almost impossible to secure decent housing. It leaves scars that can last a lifetime.

This week, I joined Senator Kamala Harris, House Financial Services Chairwoman Maxine Waters and Sherrilyn Ifill, President and Director Counsel of the NAACP Legal Defense and Educational Fund to announce the introduction of the Housing Emergencies Lifeline Program (HELP) Act, which will provide funding so those at risk of eviction can access legal representation and any evictions will do limited damage to renters' credit. The bill would allocate \$10 billion in Emergency Solutions Grants, which provide funding to states and localities for homelessness prevention and outreach and legal representation for those on the verge of being evicted.

The HELP Act can do more than save people's homes. It can save entire communities. It can stop a cycle of poverty and hopelessness. For people like Arleen, it can even save their souls.

He doesn't like the violence that is going on in those cities, he says.

"Operation Legend" is his effort to stop violent crime. Without being invited or asked, he has decided that it is his job to send these people into cities, clothed in military camouflage uniforms and armed with assault weapons. While he has adjusted his message to say that it is the responsibility of the federal government to protect federal property (as was the reason given for sending these men to Portland, Oregon,) the truth of the matter is that most of the people his private police plan to assault are in no way attacking federal property.

But as one listens to this riffraff about being concerned about violent crime, a couple of things are clear. One, it is the paramilitary forces who are initiating the violence. Two, these people are ignoring the "rule of law" in that they are taking people off the street and putting them in unmarked cars, even as they deploy tear gas to these American citizens, and three, they are being the violent force in this country as white people have always been.

In story after story, we learn how mobs of "angry whites" have stormed black communities (Rosewood, Tulsa, East St. Louis, for starters) and wiped those cities out, forcing the black residents to move from their homes. (<https://www.usatoday.com/story/news/nation/2019/07/23/racial-violence-red-summer-1919-witnessed-white-black-murder/1802371001/>) (<https://www.bet.com/news/national/2019/12/17/not-just-tulsa-five-other-race-massacres-that-devastated-black.html>) Whites, including law enforcement officers, have opted to lynch black people just because they could do it and know they would never be held accountable.

These white "officers" being sent to cities seem to be nothing more than classic American mobsters, breaking the law at will, terrorizing black people. The protests over police brutality is providing an easy way in for these people, as occasional violence breaks out. Even though it is becoming more and more clear to those who will read that much of the violence is being started by provocateurs, not a few of whom are white - the president ignores that fact. Some of the white protesters - even those with good intentions - are bringing their own issues to the protests. While the chant is "black lives matter," some people in the protests are there to air their own grievances, feeling comfortable that they can do it under the umbrella of the Black Lives Matter protests. White people in this country have a history of being violent against black and against each other, but they are protected by the attention paid to black people and the unfortunate violence that happens in too many black communities. But white violence is real, it is toxic, and it is responsible for much of the suffering that has led people to chant, "black lives matter!" (<https://www.newstatesman.com/world/2020/05/minneapolis-protests-george-floyd-killing-black-white-america-race-riots>)

Diverting attention to street violence helps keep the attention off the violence - and the rampant criminality - that exists in white communities. While decrying street violence, white people with money and power continue to break the law and get away with it because they have the money to pay their way out of jail. That they escape jail does not mean they do not need to be in jail. In our country which honors mass incarceration, white criminals ought to be in the cells in equal if not greater than the numbers of black and brown people in jail, many for petty, nonviolent crimes.

This "concern" for violent crime being expressed by the occupant of the White House is as disingenuous as is his concern for the lives and well-being of black, brown, and poor people in general. It is difficult to listen to him go on about being the "law and order" president, even as he and his friends are being exposed for their crimes, some being arrested and jailed. In addition, the policies being supported and pushed by this administration cause conditions which exacerbate the conditions in cities which too often result in crime.

That, it seems to me, has to be the ultimate violence.

Why we must support plans for a new reentry center in DC

Advocates, faith leaders and members of the community in DC have long called for the nation's capital to build a more compassionate, holistic and effective model for providing social services to the men, women and young people transitioning back into society after incarceration.

Yet, despite a shared goal of providing better support to individuals making that daunting transition, the thorny question of how, exactly, to move forward has been the subject of much debate and sometimes, rancorous disagreements over the particulars. This has clouded the considerable consensus that something must be done and, as a result, stalled whatever progress was made.

In 2018, the Federal Bureau of Prisons awarded a contract to a nonprofit organization to replace the city's incumbent reentry provider, Hope Village, and manage a new program at an existing location in Northeast Washington. But some in the neighborhood resisted the idea of such a facility in their backyard, prompting the owner of the building to abruptly back out of the deal, leaving the city back at square one.

Now, after the BOP tapped the same organization –

CORE DC – in June to start up a new reentry center in Ward 7, the city once again finds itself at a critical moment. As an unflinching advocate for real criminal justice reform, I am determined to do all I can to help the community come together to bring about real change on this issue.

I have long followed efforts aimed at reforming DC's criminal justice system, and have spent many years giving voice to returning citizens, their families and the varied challenges they face. Often those of us in the wider community forget that we're dealing with our brothers and sisters, human beings who made a mistake but paid their debt to society. Unfortunately, the stigma of their incarceration follows them and they're often not afforded the opportunity to get a second chance. I articulated the need for the District of Columbia to move on from Hope Village if it was really committed to assisting returning citizens and providing them with the crucial support and range of services they need.

Today I launched a new website calling on DC to sup-

port plans for a new reentry center in Ward 7. The website will also focus on other criminal justice issues. I did this because it is imperative that we not let this process suffer the same fate it did last year. Especially now that Hope Village has closed and there is not a single facility able to provide services to citizens returning to the community.

Having no place for returning citizens to go for a safe place to sleep, to readjust to being in the community and get job training is not an option.

We should also take advantage of the profound social changes sparked by the murder of George Floyd in Minneapolis, Minnesota in late May. It's clear that we are at an inflection point in our nation's history. Americans appear to finally be ready to confront the reality of the insidiousness of racism and its corrosive effects on all of us. Young people have taken the reins, eschewed asking for permission and are driving this movement forward. They are determined to hold their parents, adults, elected officials, the police and others in authority to account.

Our nation is grappling with a racial and moral reckoning that if successful, will change the way we look at the criminal justice system and those entangled in it. Americans are trying to figure out how to navigate the treacherous but long overdue dis-

course about social and racial justice, inequities, disparities and privilege and what our country will look like going forward.

The District of Columbia has a unique opportunity at this moment to take one seemingly small but important step in the right direction and set an example for other communities looking to take similar steps of their own.

We came together as a community to demand better services for those returning home from incarceration, and our efforts paid off. Hope Village – which became known as Hopeless Village in DC – is receding into our rearview mirror. Now, with a bold plan in place to provide services that will give returning citizens the support they need to transform their lives, we have an opportunity to demonstrate what real change looks like.

There is still a great deal of work to be done, and one reentry center alone will not nearly be enough to bring down recidivism rates that are still far too high, but the city's plan for a new facility in Ward 7 is progress – not just progress on paper – and we should support it.

NFL chief doctor says teams, players must be educated about risks of COVID

Following a disastrous re-opening by Major League Baseball, where as many as 17 Miami Marlins players and personnel have tested positive for COVID-19 forcing the postponement of several games, the National Football League remains cautiously optimistic as training camps open.

"It's about education and understanding," NFL Chief Medical Officer Dr. Allen Sills told BlackPressUSA.

I think people are trying to be really thoughtful about this, and I think people do look at risk and risk mitigation in different ways. But I feel like it's the right thing to do, to try to learn to live with this virus."

A big part of the challenge remains finding ways to carry on safely, Sills agreed.

This week the heavy contact sport re-opened camps, but officials have decided not to hold traditional pre-season games to help keep risks at a minimum. All players are scheduled to report by August 4, but as many as 22 already have opted out of the 2020 season.

The season is scheduled to

kick-off on Thursday, September 10.

"Players and coaches [and other personnel] have to make the best decisions for them," Sills stated. The league announced that it has put in place safety measures that include increased sanitizing. Social distancing would be

enforcement, including in player treatment rooms, weight rooms, mealtime, and on the playing field.

Reportedly, training camps are equipped with proximity tracking devices that will alert players or staff when they are too close to one other. The device also collects data, making contact tracing easier if someone becomes infected with the coronavirus.

NFL players will live in and travel from their own homes, a contrast to the National Basketball Association, which has isolated all teams and personnel at one location in Orlando, Florida.

If they're around each other each day, they're going

to share risk. They also share a responsibility to each other, which means that they're each making good choices when they're away from the facility," Dr. Sills said.

"We've tracked the CDC risk guidelines, made decisions on which ones put our players at high risk, and players can rely on those risk fac-

Minister Alonzo Feaster, Jr., affectionately known as "Duball" was born December 25, 1948 to the late Alonzo Feaster, Sr., and Juanita Davis Feaster and departed this life July 27, 2020 at his home.



A WORD FROM THE LORD

Where will we go from here?

Where will we go from here? Choose this day whom you will serve! In this computerized world, we don't use the same thing that we use when I was a boy, which was a road map. We establish where we were on the map, and then found the best route to take and it took some time in doing so.

But now we have what we call a GPS that you purchase or have it on your iPhone or build in most of all new automobile you purchase, and you program it to take you to places you have never been before. The methods are the same, you must establish where you are and program it according to where you are and where you want to go.

Life is the same way you must program your destination based upon where you are! According to the Bible, which is our spiritual road map, we all began our life journey from the same place, position, or source. Let's turn now to the teaching of the infallible Word of God which is the fountainhead of all truth and the complete will of God for man.

Psalm 51:4-10 (KJV) 4 Against thee, thee only, have I sinned and done this evil in

thy sight: that thou mightest be justified when thou speakest and be clear when thou judgest. 5 Behold, I was shapen in iniquity; and in sin did my mother conceive me. 6 Behold, thou desirtest

truth in the inward parts: and in the hidden part thou shalt make me know wisdom. 7 Purge me with hyssop, and I shall be clean: wash me, and I shall be whiter than

snow. 8 Make me hear joy and gladness; that the bones which thou hast broken may rejoice. 9 Hide thy face from my sins, and blot out all mine iniquities. 10 Create in me a clean heart, O God; and renew a right spirit within me.

What is a sin according to the Word of God: 1John 5:17, All unrighteousness is sin: and there is a sin not unto death.

1. We must know that all unrighteousness is sin. Too many people think too lightly of some sins. They rank sins, feeling that some sins are not so bad and are more accept-

able to God. They feel that...

o some sins are small; others are big. o some sins are white; others are black.

*some sins are more permissible; others are less permissible.

*some sins are more acceptable; others are less acceptable.

But note what Scripture says: "All unrighteousness is sin." There is not a single act of unrighteousness that is not sin. There is only one sin that is ranked as a sin unto death.

As seen above, that sin is either apostasy, denying that Jesus Christ is the Son of God, or else obstinate and persistent sin that just refuses to repent. This is the ultimate sin, the unpardonable sin. But God does not list this sin to

say that we can commit all the other sins and get away with them. He tells us about the sin unto death in order to warn us that we can sin too much.

We can turn away from Christ too often, so often that we become engulfed and encrusted with sin-so hardened that we cannot break away. We doom ourselves if we continue to sin. All unrighteousness is sin; no matter how small and white or how permissible and acceptable we may think the act of unrighteousness is,

it is sin to God. And if we persist in it, we are moving toward becoming so engulfed and encrusted in it that we border on the sin unto death.

The point is this: the way we live free of sin is to know that all unrighteousness is sin. There is not an act of unrighteousness that is not sin.

No matter what we think, no matter how we may rank sin, there is no rank of sin with God. Sin is sin; unrighteousness is unrighteousness.

We must repent and forsake all sin-know that all unrighteous acts are sin-if we are to live free of sin. (POSBC)

Romans 1:18, "For the wrath of God is revealed from heaven against all ungodliness and unrighteousness of men, who hold the truth in unrighteousness".

Romans 6:13" Neither yield ye your members as instruments of unrighteousness unto sin: but yield yourselves unto God, as those that are alive from the dead, and your members as instruments of righteousness unto God".

Romans 14:23"And he that doubteth is damned if he eats because he eateth not of faith: for whatsoever is not of faith is sin".

(James 4:17)."Therefore to him, that knoweth to do good,

and doeth it not, to him it is sin". We must have a precise knowledge of sin and its consequences, it separates from God (Sin in the heart is like carrying a rattlesnake in your pocket or your purse). At an unsuspected time, you will be bitten that may cost you your life

The Amplified says, "We know [absolutely] that anyone born of God does not [deliberately and knowingly] practice sinning, but the One Who was begotten of God carefully watches over and protects him - Christ's divine presence within him preserves him against the evil - and the wicked one does not lay hold

(get a grip) on him or touch him."

The Bible is our road map the Holy Spirit is our GPS: John 14:16-17, And I will pray for the Father, and he shall give you another Comforter, that he may abide with you forever; 17Even the Spirit of truth; whom the world cannot receive, because it seeth him not, neither knoweth him: but ye know him; for he dwelleth with you, and shall be in you. V.26, But the Comforter, which is the Holy Ghost, whom the Father will send in my name, he shall teach you all things, and bring all things to your

remembrance, whatsoever I have said unto you.

John 16:13-15, Howbeit when he, the Spirit of truth, is come, he will guide you into all truth: for he shall not speak of himself; but whatsoever he shall hear, that shall he speak: and he will shew you things to come. 14He shall glorify me: for he shall receive of mine, and shall shew it unto you. 15 All things that the Father hath are mine: therefore said I, that he shall take of mine, and shall shew it unto you.




