### Moody on The Market



Steak 'n Shake fans in Michigan's Great Southwest might still be able to "takhomasak" (their slogan for Take

Home a Sack) from the Pipestone Road restaurant someday, as the restaurant hits the auction block along with 14 other corporate owned sites across the country. When Steak 'n Shake closed down dozens of restaurants across the country in the spring of 2019, including the one at 1917 Pipestone Road in Benton Harbor, many of them disappeared completely, while others held out hope of being bought by franchise holders. The restaurants that closed at that time were some of the nearly 400 sites in America owned by the Steak 'n Shake Corporation. While many Steak 'n Shake locations were stripped of all signage as they were decommissioned, it was clear that they would not be returning. Local fans have always held out hope that a new buyer would come along, and now that becomes a distinct possibility as the restaurateur has hired several firms to market them at auction and find newly interested parties

One of those firms is Keen-Summit Capital Partners of New York whose web-site has details, saying that Steak 'n Shake Inc. is bringing to market 15 restaurants the company closed during the last 12 months. Keen-Summit Capital Partners LLC, and their local partners at NAI Global, have been retained to run a sale process of the portfolio with a bid deadline of August 31st and auction date of September 3rd. It is anticipated additional properties will be sold by Keen-Summit Capital Partners through an auction during September. The Pipestone Road Steak 'n Shake in Benton Harbor is one of the 15 being sold along with two other Michigan locations in Livonia and Madison Heights. The Benton Harbor location is the largest facility by far on the entire list with 7,041 square feet under roof on a 1.45 acre parcel across from The Orchards Mall. This auction also includes properties in Alabama, Florida, Illinois, Indiana, Iowa, Missouri, Ohio, Pennsylvania and Texas. Keen-Summit Capital says that all of the locations are available for sale individually or can be sold in combinations, and each holds a reserve price per property of \$367,000 with a buyer's premium of 7-percent. Many of the Steak 'n Shake properties that the company closed with plans to either refurbish or offer for sale to franchise holders were identified the by company as virtual turn-key operations with the vast majority of restaurant equipment still intact and ready to go.

## A very generous offer

Dear Dave,

My in-laws have very generously offered my wife and I \$250,000

to help with a down payment on a home. I know the amount exceeds the IRS's yearly gift allowance, but they want to structure it as a family loan and have already told us they don't care if we pay it back. If we accept, we technically owe them a lot of money. If we say no, they may be offended. What do you think about this and how it might impact the relationship?

James Dear James,

Well, it makes sense your wife would be onboard with the whole thing. It's *her* dad making the offer, so of course she would be a lot more comfortable with the idea than you are.

This is a big deal, and it's something you two should have a very serious conversation about. Get on the same page in every regard. Also, I'd recommend making sure you get *everything* in writing. See to it, as well, that it can be forgiven at the maximum allowable annual gift rate

In addition, in the event of death make sure it's included in the estate, it's forgiven, and there will be zero call on the note. In effect, that would make it an advance on your inheritance instead of debt. Under no circumstances should they, or any other heirs, have grounds to call the note.

That's a good question, James. And a nice gift!

## Dave Says Keeping the side hustle alive

I have a full-time job, but I also have a side job providing firewood to help pay off debt. I make \$600 to \$1,000 a month with this project. My log splitter went down recently when a hydraulic line burst, and the machine caught on fire. I'm not sure how much it will cost to get it going again. Should I invest in a new one that will increase my productivity and help me pay off debt faster?

Dear Chris,

If I'm in your shoes, I'm going to fix the old one. Even it means duct tape and glue, I'm going to try to find a way to repair it instead of spending a bunch of money or going deeper into debt.

If you can't do that at a reasonable price out of pocket, I'd be in the market for a decent, used log splitter. And pay cash! I get your line of thinking when it comes to increasing productivity. Splitting wood is real work. But don't try to justify buying an expensive, new piece of equipment when it's just not necessary.

If you're making that much with a side hustle, you can make your money back on a used splitter in a month or two—three at the most. Be smart about it, Chris!



#### The Veterans Voice – VA Overpayments




One of the most common problems that a number of veterans and dependents can create for themselves is an overpayment with the Department of Veterans Affairs. Most

of the overpayments result from failing to report excessive income with a non-service connected Pension, failing to remove a dependent from a disability compensation award (e.g. a divorce or children are now adults, quit and/or graduated from college), unreported gambling proceeds and educational benefits where classes were not completed or failing grade(s) were issued. In some instances, you can dispute the amount or existence of the debt. In the latter instances, you can request a hearing. You should notify the VA in writing before the 30-day deadline from the date of letter while simultaneously submitting a Debt Waiver (which will be explained shortly). Instances where a debt is not valid from the VA. you can always appeal, especially if you believe the VA erred in notifying you that there was a debt. One of the best websites that explains the entire VA overpayments process and various countermeasures to take is located at www. swords-to-plowshares.org/guides/overpaymentsof-va-benefits. Although the scenarios vary, the methods for correcting the VA overpayments are similar. The best way to avoid a VA overpayment is to remember that anytime there is a change in your income (e.g. for a non-service connected VA Pension) or dependents award (e.g. child is now an adult, graduated from college or change in marital status) or with educational benefits you either failed or quit a class is to report it to the VA as soon as possible. If a veteran or dependent

is past that phase and received a letter from the VA's Debt Management Center (DMC) in St. Paul, Minnesota (www.va.gov/debtman), please take immediate actions to remedy the situation. You need to complete VA Form 4138 Statement in Support of Claim requesting a Debt Waiver and explain why you are unable to pay it back. You also need to have that form accompanied with VA Form 5655 Financial Status Report which shows that you are unable to pay the debt back to the VA. Ignoring a DMC overpayment letter can have very adverse consequences. Unless you work out a deal with the VA to pay back the overpayment, the DMC will take matters into their own hands and possibly stop all payments. The best thing to do is contact Veterans Services. We will try, if the circumstances behind the VA overpayment permit, to file a Debt Waiver. You can find more information about a Debt Waiver at www.va.gov/debtman/submit a waiver request. asp. The DMC will take one of three courses of action in response to the Debt Waiver: 1) Deny the waiver, 2) Fully grant the waiver, or 3) Partially approve the waiver. If the Debt Waiver results are unsatisfactory to the veteran or dependent, the next course of action is to submit a compromise (see www.va.gov/debtman/ Submit Compromise Offer.asp). You would again use VA Forms 4138 and 5655 to accomplish.




On a totally unrelated note, I happened to read an article about why cats stop using their litter box. I'm willing to bet it is one of the most common reasons that cats are taken to a shelter. No one wants their home to become the litter box, but it seems there are many reasons why this can happen. They include: Dislike of the litter or the type of litter box. The box is too small or large (difficult for a kitten or an older cat to get into). Doesn't like location or can't get to it easily. Doesn't like a box with a liner or a hood. Box is dirty. Conflict with other cats. Afraid because something scary happened while he/ she was using the litter box. Stress in the household. Litter is too deep in box. According to the ASPCA, the issues can be a bit complicated, but here are a few solutions. Provide one litter box per cat in the house, plus one. Place in quiet but easily accessible places, away from their food and water dishes. Sometimes, with multiple cats, the boxes need to be placed apart to prevent confrontations. Keep dogs away, especially while the cat is using the box. They usually don't like an audience. A simple enough solution might be to clean the box more often or change the type of litter you're using. An often-overlooked reason for elimination outside the box is health-related. Urinary tract infections, kidney stones, and a variety of other illnesses can make it painful to go, leading them to avoid the box. An older cat or one with special needs might not be able to use a box with a hood, as our three-legged Sandwich cannot. One thing to remember is to thoroughly clean with an ammonia-free product any places where a cat has gone outside the box. If their scent remains, they may keep going back.

The important thing to remember is that you shouldn't punish your cat for not using the littler box, because there is a reason. It might take some time to figure it out, but once illness has been ruled out, a little investigation and trial and error should lead to a solution. Ever since Starbucks Coffee Shops popped up on seemingly every major corner of metropolitan areas large and small across the globe, the general public in Michigan's Great Southwest has collectively wondered when there would be a free-standing Starbucks somewhere in Berrien County. Up until now there has only been the Starbucks tucked inside of Martin's Super Market in St. Joseph, and one off the lobby of the Courtyard by Marriott in Benton Harbor. The lack of a free-standing option is in the process of being changed, however. Earthmovers, surveyors, and other excavation crews have launched the construction process for the first ever free-standing Starbucks between the Stevensville I-94 entrance ramp and Marquette Woods Road across from Burger King. It falls nearly in the shadows of the just-opened Tru by **Hilton** hotel that opened at the end of last week. Don't pack up vour kitchen coffee-maker just vet. however. The 4,000 square foot building won't be completed on the outside until around the end of the year, and Starbucks design teams won't begin the interior finish work until January of 2021 according to Lincoln Township Building Inspector Jim Pheifer. The Starbucks operation will actually use about half of the 4,000 square foot building being put up by developers from TDM in Grand Rapids, with the balance of the space set aside for future use by an ancillary business which is yet to be determined. TDM has owned the property for several years now. Plans were originally filed with Lincoln Township in April, but everything was put on a back burner due to the pandemic until now. The just over 1-acre site has been under consideration by Starbucks for more than a year now, according to Pheifer, who is happy to see progress being made in that quadrant of the I-94 interchange along with the new Tru by Hilton which is a 98-room hotel now open there as well. Lincoln Township Supervisor Dick Stauffer says, "I think a Starbucks is a very good use for this long vacant and unusually shaped property. This convenience location should serve nearby hotel guests, traveling Starbucks customers and local residents very well." Regarding the new Tru by Hilton, Stauffer says, "It's certainly an attractive, eye-catching, design and very easily accessed from Exit 23, and I think it should do well." With Starbucks not undertaking the interior work until after the first of the year and that process slated to run some 60 to 90 days, Pheifer says the new coffee shop, complete with drive-thru service as well, will likely not conduct a grand opening celebration until late winter or early spring at this juncture. Building Inspector Pheifer is ecstatic that the overgrowth of that corner will be cleaned up and suggests confidence that other businesses will see the advantage of that part of the community and hopefully follow suit with new opportunities to add into the mix.

Families in the Benton Harbor neighborhood who find themselves with limited access to fresh produce in Michigan's Great Southwest are invited to hit up The Veggie Van, making a special visit to the community on Thursday afternoon, August 20th. 




