



CITY MOCK UP OF BLACK LIVES MATTER PROPOSAL

Spears pleased with Black Lives Matter compromise

As of Tuesday night, the city of Wilmington goes on record as agreeing that "BLACK LIVES DO MATTER - END RACISM NOW," thanks to the City Council's 5-2 vote, for at least one year anyway.

In what has been called a temporary "pilot project," the city will accept the donation of the BLM art installation, which will be large 8x4 letters at Jervay Memorial Park near Third Street and the 1898

Memorial.

After an almost two month delay from when the original BLM Third Street mural was introduced, Councilman Kevin Spears was pleased after the vote the issue had been favorably and finally decided.

"It's politics," he conceded, acknowledging that he wanted "BLACK LIVES MATTER - END RACISM NOW," but if adding "DO" got the job done, he's fine with it.

"You have to give a little to get a little, and...overall, I'm satisfied."

"It's a small gesture to Black citizens and their allies and sends a

message to other municipalities across the nation and to people all over the world that we want to be a part of the change," Spears told The Journal.

One person seemingly in desperate need of that message is conservative Councilman Charles Rivenbark, one of two votes against the mural after earlier calling it "racist."

At Tuesday night's Council meeting, Rivenbark's opposition was in

Postmaster General backs down after Adams, Congress threaten to have him fired

After pointed threats to have both "his job and his head" if he didn't straighten out the mess with the U. S. mail service, Postmaster General Louis DeJoy, a Greensboro native, Tuesday did an abrupt about face, ordered all "cost cutting initiatives" postponed until after the Nov. 3 general elections.

Not only was DeJoy, a top contributor to the Trump campaign, facing two

Congressional hearings - the first a senate hearing this Friday - but he was also looking down the barrel of litigation from at least 20 states seeking to stop his disruptions of mail service.

"In the meantime, there are some longstanding operational initiatives, efforts that predate my arrival at the Postal Service, that have been raised as areas of concern as the nation prepares to hold an election in the midst of a devastating pandemic," DeJoy

Kamala Harris stands strong against Trump's "birtherism"

No sooner than last week had Democratic presidential candidate, Joe Biden, announced his historic choice of Sen. Kamala Harris to be "a heartbeat away" from the presidency should he win in November, than Pres. Trump led a parade of racial detractors to tear the vice presidential candidate down and apart.

"I heard it today that she doesn't meet the (citizenship) requirements," Trump told the White House Press Corps last week, "... and by the way, the lawyer who wrote the (controversial Newsweek Magazine) piece (calling Harris's eli-

zens of these United States. I would like to talk about some facts that can be checked with little effort. People of color were beaten and killed when they tried to vote. They were given all kinds of tests to keep them from voting here in Brunswick County. Klansmen came to some of their houses at night to keep them away from the polls. When it came to the census, people of color were told not to talk with the people who came to their houses or only tell them about the people that they would see because the census taker was out to destroy them and take their land with that information that they gave them. People of color would not talk about the Civil War or its outcome because they were harassed and reminded that the Black man was less than a White man, and most of the laws sided with the White people whether they

full flourish.

"To think that Black lives don't matter is folly," he said in opposition. "I mean, it's ludicrous, and it makes me think that they don't think that much of themselves if they've got to have a sign out there that says Black Lives Matter. I can't get my head wrapped around it."

Spears firmly chided his colleague for his remarks, noting that it's that attitude that necessitates erecting the mural.

"With the [1898 race massacre] history that we have, I think it's essential," Spears told The Journal. There will be inspiration for a lot of generations. They'll come through and say, 'You know what? Anything is possible.' 'They're going to be inspired to try new

things...push against resistance. For my generation, it's never too late to get involved."

Deborah Dicks Maxwell, president of the New Hanover County NAACP was leery of the Council vote, but still pleased that it leaned the right way.

"The City Council of Wilmington forced constant compromise on the placement and wording of a Black Lives Matter mural," Dicks-

Maxwell told The Journal. "It will now be placed obscurely so, as the old adage goes, 'out of sight, out of mind.' It is disappointing that in 2020 this has occurred. Thank you to Councilman Kevin Spears for forging the way to this point."

Ms. Dicks-Maxwell also had some choice words for Charlie Rivenbark.

"The remark of 'those people' by Councilman Rivenbark was insulting

and degrading to every person of color and our allies in this city. It shows that he really needs the implicit bias training that was recommended by the Community Relations Advisory Committee. I will not say his name but say to the people of Wilmington he showed you who he was and do not forget. So now, more than ever before, you need to get out and early vote," she said.

said in a statement. "To avoid even the appearance of any impact on election mail, I am suspending these initiatives until after the election is concluded."

DeJoy, who took over as postmaster in June, found himself the target of extraordinary heat from congressional leaders after President Trump openly bragged that he was undermining the U.S. Postal Service because he believed that mail-in balloting was "corrupt" and a ploy by Democrats to seize power from him.

That admission caused House Speaker Nancy Pelosi to recall House members from their August recess to deal with the matter, especially after Rep. Alma Adams (D-NC-12) was among the first to call for DeJoy's resignation.

The mail is piling up, and the moves that he has made and the changes that he has made have really created problems in terms of our mail's not getting out," Adams

told WFAE-FM last week. I think it's a move to really dismantle the post office but also more than to disrupt this election."

This week, it's virtually every Democrat in Congress, even in the U.S. Senate, who is calling for DeJoy to be fired amid the growing catastrophe threatening to delay the U.S. mail to tens of millions of Americans, just because President Donald Trump says he fears losing because of mail-in voting.

DeJoy, one of Trump's top campaign fundraisers and donors, is also being hauled before the House Committee on Oversight and Reform on August 24 to answer tough questions about some of the changes he's implemented in mail service, changes designed to slow service down.

Rep. Adams will be questioning DeJoy during that session, she announced Tuesday during her "Don't Mess with the USPS" press conference.

"Let me say this plain and clear," said Rep. Adams at her presser Tuesday. "If we deter-

mine during that hearing that the Postmaster General has deliberately harmed USPS, if this wealthy Republican donor, Louis DeJoy, has intentionally slowed down your mail and broken the trust between the Postal Service and its customers, the American people, then the House of Representatives should file articles of impeachment against him, and I will gladly lead the charge."

The Inspector General of the USPS is also investigating reports that DeJoy owns businesses associated with the USPS, which many see as a conflict of interest.

DeJoy is scheduled to appear before the House Oversight Committee Monday along with Robert Duncan, current chair of the USPS Board of Governors and past chair of the Republican National Committee.

When DeJoy does testify, he'll be asked about the reported removal of over 600 mail sorting machines from processing centers across the country, the elimination of

overtime for postal employees, mailboxes' being removed from street corners in various states, the removal of over 30 postal executives from their positions overseeing day to day operations, and a letter last week to 46 states warning that mail-in ballots may not arrive in time to be counted by Election Day, Nov. 3, 2020, because of cutbacks in service.

"The American people want their mail, medicines, and mail-in ballots delivered in a timely way, and they certainly do not want drastic changes and delays in the midst of a global pandemic just months before the election," said Rep. Caroline Maloney, (D-NY) chairwoman of the House Oversight Committee.

Last Sunday, protesters gathered in front of DeJoy's house in Greensboro, demanding that he step down as head of the USPS.

Ironically, Pres. Trump himself, during a Saturday night press conference in New Jersey, admitted to reporters that DeJoy "doesn't

know what he's doing." DeJoy had no previous experience with the USPS before his appointment.

On Monday, Congresswoman Adams, House Speaker Nancy Pelosi, and 173 other House Democrats sent a letter to Postmaster General DeJoy, saying in part, "The House is seriously concerned that you are implementing policies that accelerate the crisis at the Postal Service, including directing Post Offices to no longer treat all election mail as First Class. If implemented now, as the election approaches, this policy will cause further delays to election mail that will disenfranchise voters and put significant financial pressure on election jurisdictions."

The House Democrats' letter to DeJoy continued, "Because many states have traditionally allowed voters to request absentee ballot applications and absentee ballots within a few days of the election, it is essential that standard delivery times remain short and pricing remain consistent."

For the record, Sen. Kamala Harris, the first Black woman ever to be vice presidential candidate for a major political party, was


born in Oakland, California on October 20, 1964, to a Jamaican father and Indian mother, but activists in the '60s civil rights movement, so there is no doubt about her citizenship.

She was born on U.S. soil. And there is little doubt about her blackness, given that her father was Jamaican. In fact, as is well known by now, Harris chose attending the legendary HBCU, Howard University, in Washington, D.C., to further immerse herself in her heritage and culture.

She later graduated law school and eventually was elected as district attorney for San Francisco in 2003 and later California State Attorney General in 2010 and 2014.

It was 2018 when Harris won a seat in the U.S. Senate but had to fold up her underfunded campaign for President earlier this year before the Democratic primaries began, though she did make her presence known during the contentious debates when she confronted former Vice President Joe Biden about his past history as a U.S. senator who opposed racial school busing.

Yet none of Kamala Harris' personal American history mattered to her critics.

Trump called her "nasty" and "mean" for her tough Senate panel questioning of members of his administration, and her Black critics blasted her on social media

for not being "Black" enough and for having a White husband.

Sen. Harris, in an interview with The Grio.com, recently fired back, saying that she expects "dirty tactics" from her detractors, and noting that the election isn't about her or her background but the issues through which everyday Americans are struggling in the face of racial injustice, economic uncertainty and the COVID-19 pandemic.

"We have to meet people where they are and address their needs," Harris, who was officially nominated as the vice presidential candidate during the 2020 virtual Democratic National Convention this week, is quoted as saying.

"You may not fall in love with who you're voting for, but if you just look down on a piece of paper at the issues that are impacting you every day..."

"Whether you've got relatives who have been impacted by the COVID virus, you're unemployed or trying to get that extra check, that unemployment, that six hundred dollars. Or you look at who's going to pay attention to whether the Black community is going to have equal access to a vaccine when it's created ... There is so much on the line in this election," Sen. Harris said. The General Election is Nov. 3, 2020. Early Voting in North Carolina begins Oct. 15 and ends Oct. 31. North Carolina will mail out ballots on Sept. 4.

STATE BRIEFS**COOPER BANS CRIMINAL RECORDS FOR STATE JOB APPLICATIONS**

[RALEIGH] Gov. Roy Cooper this week signed an Executive Order to "implement fair chance policies"

by prohibiting any inquiry into an applicant's prior criminal history. Called "banning the box," Cooper's order allows state job applicants to skip checking the box on the application asking about criminal records. "People will get a chance to shine and show themselves on their own merit when they're going through the employment process," the governor said. "There's a wealth of talent out there, a

wealth of people who've made a mistake who are now about to come back into society who could be good employees."

TRUMP'S FACE ON ABSENTEE BALLOTS SENT TO NC VOTERS

[GREENSBORO] Amid all of the controversy about the U.S. mail being deliberately being slowed down in order to influence the November 3rd presidential election,

some North Carolinians found a surprise in their mailboxes this week - absentee ballot request forms with Republican Pres. Donald Trump's picture on them. The words under Trump's picture ask, "Are you going to let the Democrats silence you? Act now to stand with President Trump!" Reportedly, the form is not from the State Board of Elections, but is approved by the SBOE. The forms them-

selves are fine and can be used. The mailers were sent by the NC Republican Party.

DUKE ENERGY URGES PAST DUE CUSTOMERS TO SETTLE UP SOON

[CHARLOTTE] The state's moratorium on paying your utility bills during the COVID-19 pandemic is about to end. Duke Energy is urging all past due customers to settle their outstanding bills soon in order to stave off dis-

connections of service. Customers have until Sept. 1st. to hold back payments, and Duke will even grant 30 days after that. But that, unless you make payment arrangements, all payments are due, the utility says. Duke will continue to waive late fees, until further notice.

State Supreme Court rules 4-3 for Black death row defendant

In what has been hailed

as an "historic" ruling, the NC Supreme Court, on Friday, ruled in a 4-3 decision that a Black convicted

murderer should not have been returned to death row after he had been re-sentenced to life in prison with-

out parole under the now defunct Racial Justice Act, a Law that the Republican-led NC General Assembly

repealed in 2013.. Doing so amounted to legal "double jeopardy," the High Court said, especially after it was proven that Black jurors were "intentionally denied the right to serve on his jury" by White prosecutors.

The 29-page decision came in the case of Marcus Robinson, the first inmate to claim, and prove, under the RJA that his 1994 capital conviction for a Fayetteville murder was racially biased because prosecutors found ways to keep African-Americans off his jury.

Robinson's death sentence was commuted to life in prison without parole in 2012 as a result, but the GOP repealed the RJA a year later, voiding all cases already decided in court and dismissing any pending cases.

By effectively throwing out Robinson's commutation, the legislature put him back on death row, thus violating his Constitutional protection against double jeopardy, the North Carolina Supreme Court said Friday.

"Once the trial court found that Robinson had proven all of the essential elements under the RJA to bar the imposition of the death penalty...," wrote Chief Justice Cherie Beasley in the majority decision, "... he was acquitted of that capital sentence, jeopardy terminated, and any attempt by the State to reimpose the death penalty would be a violation of our State's constitution."

"Robinson's claims under the RJA do not negate, or diminish, his guilt or the impact of his crimes on the victim's family, the victim's friends, and the community," Chief Justice Cheri Beasley wrote. "Rather, the Act ensured that even those who commit the most serious offenses are entitled to a trial and sentencing free from racial discrimination."

Justices Mike Morgan, Anita Earls, and Robin

Hudson all joined Beasley in the majority decision.

The court's only Republican, Justice Paul Newby, who is running to unseat Chief Justice Cheri Beasley, was one of three dissenters. He wrote,

"Apparently, in [the majority's] view, the law is whatever they say it is," The votes of the four justices prevent defendant's execution for murder. It appears, however, that three justices may have a larger purpose: to establish that our criminal justice system is seriously, and perhaps irredeemably, infected by racial discrimination."

Newby wanted Robinson's case to be returned to the trial court in order to give the state a chance to appeal.

"Instead of doing the legally correct thing, the majority opinion picks its preferred destination and reshapes the law to get there," Justice Newby wrote.

Still defendants' rights advocates hailed the decision.

"This is one of the most important decisions I've ever seen from our State Supreme Court," said Center for Death Penalty Litigation Executive Director, Gretchen Engel. "It seems that Justice Beasley and her colleagues intend to make good on the promise that no person should be executed if race was a factor in their death sentence. This is a critical issue of racial justice, both for people on death row and for African Americans seeking to participate in our democracy. It's heartening to see the court recognizing that fact in all its difficulty and complexity and taking bold action."

This state High Court ruling comes three months after it ruled in State v. Ramseur that over 100 death row cases that applied for consideration under the RJA should have their day in court.



Get your ballot now

What would you do if somebody walked by your house and promised to rob it the next day? Most of us would take every precaution, checking the locks, the door, and the windows. Some of us might weapon up, making sure we could defend our homestead. Some might also reach out to law enforcement, sharing the threat with them. Almost all of us would take the threat seriously and make the appropriate precautions to prevent our violation.

The 45th President of the United States has warned us that he plans to rob us. First, he placed one of his crooked cronies in charge of the postal service.

He would not fund the postal service to facilitate the timely processing of mail ballots. He has continuously associated mail voting with fraud, although nine states have had universal mail voting for years. And finally, he just put it out there, plain and simple. He thinks mail voting favors Democrats, and he doesn't want to do Democrats any favors. So instead, his postal chief is removing mailboxes and shutting down sorting machines. And now the USPS has warned election officials in most states that ballots mailed before election might not arrive in time to be counted.

The 45th President is setting up a situation where the November election can be contested. He's doing it because he has already stacked the Supreme Court in his favor. He has no interest in maximizing the number of people voting but minimizing that number. He's not interested in democracy, but in dictatorship.

If someone told you they were planning to rob you, you'd take precautions. Trump has declared that he intends to steal this election. We can't let him do it. Here's what you must do.

1. Voting procedures vary by city and state. Make sure you know the rules. Some places send all registered voters mail-in ballots, while others require you to request an absentee ballot. Find your local Bureau online, or call your favorite local elected to get the information.

2. Return your ballot in the shortly after you get it. If you put your ballot in the mail on election day November 3, it may not be counted. Some places will have drop boxes for ballots, and others will allow you to drop off your ballot. Just get your ballot back by whatever means necessary.

3. If you prefer to vote in person, or if you've neglected to mail your absentee ballot, make sure you know where your polling place is. Because of the coronavirus, some cities are reducing the number of available polling places, and the site where you usually vote may be closed.

4. It is also possible to vote early in person. Check with your Board of Elections about when and where you might vote early.


5. Be patient. Conducting an election amidst a pandemic is new for us, and some election procedures have been unnecessarily politicized. You may encounter obstacles if you choose to vote in person. Document any hurdles you have to clear, get names of anyone who denied you the right to vote, and complain if the matter is not resolved. The Lawyer's Committee for Civil Rights Under Law runs a hotline on election day. Their number is 866-OURVOTE, or 866-6878683.

6. Spread the word. Reach out to your circle to share information about voting and encourage your friends and colleagues to vote.

7. Because of the coronavirus, which is not likely to be gone by November, there will be fewer gatherings to discuss the vote. Be on the lookout for zoom town halls and other meetings that civic organizations are holding. Encourage your church, your sorority, or your local NCNW section to consider virtual town halls. It is in some people's interest to suppress the vote, and we've seen enough of it these past few years. It is your absolute right to exercise the right to vote, even if some make it difficult. We don't have to guess the number of jelly beans in a jar or translate a passage of the Constitution into Latin, as our foremothers did. It is in their honor and the memory of Congressman John Lewis that we vote.

descent. The first HBCU grad.

More importantly, though, her candidacy is emblematic of this unprecedented moment of racial reckoning in America, and the outsized role that Black women are playing in leading the nation through this period of crisis.

It's no surprise that Black women have emerged among the nation's strongest and most competent leaders. The formidable challenges that women, particularly women of color, must overcome to achieve positions of prominence, are like the fire that tempers steel.

The National Urban League has had a strong relationship with Senator Harris for many years. We honored her as one of the first recipients of our "Woman of

Power" awards in 2004, just after she was elected District Attorney of San Francisco. In 2017, when she assumed office as California's third female U.S. Senator, and the first of Jamaican or Indian ancestry, we honored her with the Hiram Revels Award for Achievement, named for the first African American to serve in the U.S. Congress.

While we've worked closely with her since her election to the Senate, her fierce advocacy for underserved communities since the onset of the pandemic has been invaluable. She, along with Sen. Cory Booker of New Jersey, was a prime sponsor of the George Floyd Justice in Policing Act in the Senate. We recently joined her and other members of Congress to announce legislation that would allow those at risk of eviction to access legal representation, and help protect their credit. As a member of the Senate Judiciary Committee, she famously held Supreme Court nominee Brett Kavanaugh and Attorney General nominee

William Barr to account during their confirmation hearings.

Her groundbreaking selection to the position of vice presidential nominee has drawn comparison to the legendary Shirley Chisholm, whom she often cites as a source of inspiration. In 1968, Chisholm became the first Black woman to serve as a member of Congress, and in 1972 became the first Black woman to seek the nomination of a major party for President.

When she launched her presidential campaign, Harris chose a red and yellow design for her logo that resembles Chisholm's campaign buttons. Chisholm faced abhorrent racial harassment on her campaign, and nearly half a century later, the racist attacks not only have not subsided — they're amplified through social media. But it's not just crude slurs hurled on

Those black folks, including myself, who strongly believe that the most important goal of 2020 is to oust No. 45 as president of the United States are not shouting "Hallelujah" and feeling good about former vice-president Joe Biden's selection of Sen. Kamala Harris as his running mate.

We believe that once again the Democratic Party has given No. 45 an enormous, undeserved gift. Klobuchar of Minnesota, or Sen. Tammy Duckworth of Illinois, or Gov. Gretchen Whitmer of Michigan as his running mate. At the same time he would have committed to putting a Black woman on the Supreme Court. By failing to recognize that, the Democratic Party has reinforced the view of many serious Black folks that No. 45 is one of, if not the luckiest politician in America. Trump administration ramps up efforts to dismantle post office

President Donald Trump has made no secret of his desire to dismantle the United States Postal Service or revamp the agency in a way that has angered Democrats and others who said it's a tactic to prevent mail-in voting for the upcoming election.

The CARES Act passed in April authorized the postal service to borrow up to \$10 billion from the Treasury Department for operating expenses if it's determined that, due to the COVID-19 emergency, the post office would not fund operating expenses without borrowing money.

"They have withheld that money. They have broken the law," Congressional Black Caucus Chair Karen Bass told BlackPressUSA during a livestream interview last month. Other Democratic lawmakers, including Sen. Sherrod Brown (D-Ohio), Rep. Bobby Scott (D-Va.), and Rep. Hank Johnson (D-Ga.), also told BlackPressUSA that the president is trying to dismantle the postal service.

Trump has steadfastly opposed funding the postal service.

Despite recently voting with his wife by mail in a Florida primary election, the president said he's against mail-in voting.

"Trump is not stupid. He knows if there is a decent-sized turnout in this election, he loses," Sen. Bernie Sanders (D-Vt.) wrote on Twitter.

"He and his friends believe they can suppress the vote by destroying the post office. We aren't going to allow that to happen."

Several postal workers have reported the removal of sorting machines at postal facilities and the removal of sidewalk mailboxes.

Postal officials reported that in the last week, the agency had removed letter collection boxes in at least four states: New York, Oregon, Montana, and Indiana.

Postal workers in at least three states - West Virginia, Florida, and Missouri - have received notification that retail operating hours also face reduction.

Removing mailboxes had become a practice along marathon and parade routes since the 2013 Boston Marathon bombing, however, the latest removals are believed intentional and strategically coordinated to impact the election.

In response to the removal of mailboxes and a slowdown in the delivery of mail, the National Association of Secretaries of State (NASS) sent a letter to the Postmaster General on Aug. 7. New Mexico Secretary of State Maggie Toulouse Oliver (D), Louisiana Secretary of State R. Kyle Ardo (R), Michigan Secretary of State Jocelyn Benson (D) and Ohio Secretary of State Frank LaRose (R) joined in signing the letter.

"State and local election officials are busy planning for the November general election, and many expect an increase in the use of absentee and mail ballots, along

with other election-related mailings," the state officials wrote.

"We view the [United States Postal Service] as a vital partner in administering a safe, successful election and would like to learn more about any planned changes around USPS service due to COVID-19, preparations for increased election-related mail, USPS staffing levels and processing times, and other pertinent issues."

The postal service has sent letters to warn 46 states that it could not guarantee all mail-in ballots cast for the November election would arrive in time to be counted.

Some states, like Maryland and Virginia, received a "heightened warning" that the postal service could not meet state-mandated deadlines.

In response, a large group of protesters staged a "noise demonstration" on Saturday, Aug. 15, outside of Postmaster General Louis DeJoy's home in Washington, D.C.

The demonstration was organized by the direct-action group "Shut Down D.C."

The organization said they believe DeJoy is "dismantling" the U.S. Postal Service in favor of President Donald Trump's re-election. They said his actions contribute to voter suppression.

"DeJoy has fired or re-assigned much of the existing USPS leadership and ordered the removal of mail sorting machines that are fundamental to the functioning of the postal service. Meanwhile, mail delivery is slowing down under other decisions made by DeJoy, such as eliminating overtime for postal workers," the organization

wrote in a statement.

This week, the U.S. Inspector General opened an investigation into DeJoy's policy changes at the post office.

According to some lawmakers, those changes are reportedly taking a toll on military veterans who are experiencing much longer wait times to receive mail-order prescription drugs.

Slowdowns at the post office have reportedly also resulted in seniors receiving their medications late and other important mail like social security checks.

It has also angered those who work for the agency.

Postal workers throughout the country have reported low morale, and many have cited the actions of DeJoy, who was appointed by Trump. On Friday, Aug. 14, the National Association of Letter Carriers (NALC), a union that boasts nearly 300,000 active and retired postal workers, endorsed Presumptive Democratic Presidential Nominee Joe Biden.

"Vice President Biden is, was, and will continue to be a fierce ally and defender of the United States Postal Service, letter carriers, and our fellow postal brothers and sisters," NALC President Fredric Rolando said in a statement.

"Together, Biden and [vice presidential running mate] Sen. Kamala Harris fully exhibit the experience, dedication, thoughtfulness and steady hands that will work to ensure that letter carriers and working families are put first," Rolando declared.

This president has certainly done a lot of projecting; so many times when he says something will happen "if" someone else is in office, or "if" someone else had been elected, it has turned out that what he is decrying is being done or has been done by his own administration. The new postmaster general, a major donor to the Trump campaign, has authorized the removal of mail sorting machines, and is cutting down overtime hours for postal employees. The result of these shenanigans is that people are becoming worried about and afraid of voting. Many people - myself included - are not about to mail their ballots in, but will opt to find a ballot box into which to drop it, but even at that, they are not sure that their ballot will be counted. Some ballot boxes are being removed; in Ohio, Secretary of State Frank LaRose ordered that there can be just one ballot box in each county, his response to the request that the counties be allowed to install more ballot boxes in light of the post office fiasco. It is said that organized people can beat organized money, and if ever there was a time for people to organize, it is now. It is clear that the election is being rigged right before our eyes, with a spirit of arrogance that is as maddening as it is real. There is a need for people to register, yes, but also a need for people to organize in their communities to figure out how to beat the powers and principalities that are working to thwart the gains made in voting rights over the last 50 years. Tellingly, Larry Kudlow, economic advisor to the federal administration, said this week that "voting rights is a liberal, left-wing list." Kudlow said that "voting rights is not our thing. But it is the thing of a people who have been fighting for the right to vote ever since the end of the Civil War. If there is one thing we as Black Christians like to quote, it is the scripture found in the Book of Isaiah, "No weapon formed against you shall prosper; and every tongue which rises against you in judgment, you shall condemn."

It is time to organize as we have never organized before - not just black people, but all people who are not wealthy, white, and too often, Protestant and male.

Americans have to stop denying what we are seeing before our very eyes - a president and a group of wealthy men who care so little about the democracy and the people who have made them wealthy that they dare obstruct our right to vote.

Many of the ancestors are crying out the words that the late Rep. Elijah Cummings said his mother said on her dying bed, "Don't let them take away our right to vote."

So let it be said. So let it be done.







Novant Health has intercepted cancellation, and expanded offerings.

Two thousand boxes with grade specific school supplies, face masks, and health related information will be distributed this Saturday, August 22 from 12:00 noon to 3:00 p.m. from the MLK

Center.

Drive-up and walk-up lines will be allowed. Social distancing is required.

Sub sites are being added to include some public housing sites like Houston Moore, and communities or trailer parks that are heavily populated with Latino/Hispanic children.

Tanya Blackman, an African-American who serves as Novant Health EVP and Chief Diversity, Inclusion and Equity Officer states, "aggressive programming," for unique communities will also address Hispanic and Latino needs.

In 2019 Novant Health invested approximately \$1 Billion for community benefits, and health care accessibilities.

With a mission to provide "compassionate treatment of the whole person," the Novant Health sponsored back to school supplies and masks can aid stressed parents who oversee current remote and future in-person learning.

Grade specific assignments, and hands-on projects require supplies beyond iPads.


In promotional narratives Novant emphasizes partnership.

His huge fist repeatedly struck her face. This wasn't the first time her boyfriend beat her up...but this was definitely the worst. Hours later, she awoke with blood caked between her face and the floor. Seeing that her boyfriend was asleep, she quietly ran out the door. Due to multiple warrants, she was too scared to call the police. So, she ran to the only place she knew to go. Seeing the steeple in the distance, she ran harder. For many years, her church was known as a place that would help victims of domestic violence. It was her only hope.

Once she got on the lawn, she raced to the side door. There was always someone there. Running up, she missed the sign. Over and over again, she banged on the door. Nobody came. Backing up, she realized that there was a sign, "Churches are not considered essential based on the recent COVID-19 order...so we have been forced to suspend all

social services until the order is lifted."

He was sitting at home watching television. The phone rang. On the other end of the line, was a voice he did not know. After identifying himself as a local police officer, the voice proceeded to tell him that his son was shot and killed earlier that night. Devastated, the man called his pastor. After hearing the anguish in his voice, the pastor raced over to his parishioner's house.

Not long after he got off of the exit, he was pulled over. Unable to understand what he had done wrong, he rolled down the window. The officer asked where he was going. After his explanation, the pastor thought he was just going to be able to go. Instead, the officer went back to his car. After a few minutes, the officer came back with a citation. Immediately, the pastor demanded to know the reason for this ticket.

The officer didn't hesitate, "Ministers are not considered essential workers under the recent COVID-19 order." She

needed food. The church was closed. He needed emergency counseling. The church was closed. She needed somewhere to sleep. The church was closed. He needed to take a shower. The church was closed. She just needed help. The church was closed. He just needed help. The church was closed.

The church is the largest provider of social services in our country. Dallas County and various other counties have discouraged/inhibited such work. Repeatedly, churches and their ministers are not included in the definitions of what is essential to our society. The language is all about businesses. While there is room given for churches to meet "virtually," churches can't do the vast majority of their work over a computer screen. More lives will be lost if the church stops being the church. I can't accept this.

We must love our neighbors. We must stand up for the marginalized and
