In other action the council:

• Talked about the plowing of the city walking trail and trails were very important, during this time of COVID-19, for families and children to get fresh air and exercise. The plowing of the trails is done by volunteers, but the trail is not clear behind Rippleside Elementary. Bob Nicko, street commissioner, said the department would plow it the next day for the city portion, which is through the park and behind Rippleside.

• Introduced Workman and Henke to Nicko, Interim Police Chief Paul Ryan and Fire Chief Brian Pisarek. Ryan has been acting chief since mid-November.

• Agreed to a \$3,400 a year contract with Lexipol to update and train the police department on mandatory procedures. "They quiz officers

on scenarios, so they have to

• Tabled action on the former Newton lot on the south side of Hwy. 210 across from Aicota. The former owner had dilapidated buildings on the property. He moved and the lot was cleared and cleaned up. Neither Beverly nor the council were happy with the low appraisal they got. They said that lot, with highway frontage and access, should be worth a minimum of \$38,000.

Agreed to hold work sessions once a month on the second Wednesdays at 5:15 p.m. to discuss long range financial and infrastructure planning. The council will also discuss the status of a proposed position of park director.


