

Black legal experts blast Trump call and Jim Crow caucus move

"So what are we going to do here folks? I only need 11,000 votes. Fellas, I need 11,000 votes. Give me a break!"--President Donald J. Trump on leaked telephone call to Georgia Secretary of State Raffensperger Jan. 2, 2021


Irving Joyner, law professor at NC Central University School of Law, and chair of the NC NAACP Legal Redress Committee, was livid when he heard a recording of Pres. Trump's Jan. 2, 2021 phone call with Georgia Secretary of State Brad Raffensperger, allegedly trying to illegally pressure the fellow Republican officeholder into "finding" 11,780 votes from the Nov. 3, 2020 presidential election there so that Trump could officially claim Georgia's already certified 16 electoral votes.

"Had you done what Donald Trump did with Brad

Raffensperger, or anyone else for that matter, you would have already been arrested, prosecuted, and executed or deported back to Africa," Joyner exclaimed in an email, echoing other legal experts that Trump may have violated federal and state laws. "What the hell is going on in America?"

For the record and history, Democratic challenger, Joe Biden, beat incumbent Trump by approximately 12,000 votes in Georgia, and over 7 million votes nationally. However, that hasn't stopped Trump, who is scheduled to officially leave office at the stroke of 12 noon on January 20, from

Other than the Black church, no other institution in the African-American community has fought harder for freedom than the Black Press, and in Wilmington, that institution is *The Wilmington Journal*.

No matter what the cause, concern or story, if it affects the African-American community in the Port City or surrounding areas, *The Wilmington Journal* covers it to ensure that Black people are properly informed and empowered and has been doing so since 1927.

However, today, with dramatic changes in the economy, not to mention the drastic impact of the COVID-19 pandemic, *The Journal* is in desperate need for community support to maintain its high level of service and commitment.

Its Seventh Street headquarters is in need of critical repair from years of storm and wind damage. Without needed repairs, the building will be auctioned, and *The Journal* will cease to exist.

Thus, members of the Wilmington community, led by Dorian Cromartie of the Black Leadership Caucus, and Deborah Dicks Maxwell, president of the New Hanover County Branch of the NAACP, have come together to kick off a GoFundMe page titled "Save The Wilmington Journal," with the goal of raising \$95,000.

As of January 7, 2021, \$5,746 has been raised in the effort from 77 donors. Ms. Cromartie herself has raised \$470 from nine donations. Ms. Maxwell has raised \$1,725.00 from 20 donations.

"*The Journal* must continue to be a voice in our community as it has for the past 93 years," she says. "It is time to support them as they have supported us."

Black vote makes history in Georgia

The first African-American U. S. senator in history from the state of Georgia was elected Wednesday morning, thanks to the brilliant voter registration and mobilization of Georgia organizer/activist, Stacey Abrams.

The Rev. Raphael Warnock, a Democrat and the senior pastor of the historic Ebenezer Baptist Church in Atlanta, Ga., defeated incumbent Republican Sen. Kelly Loeffler in a tight runoff to claim the seat. His race was called by the Associated Press and the major television news networks before 1:00 a.m..

Rev. Warnock's Democratic running mate, Jon Ossoff, was leading his Republican opponent, incumbent Sen. David Perdue, by over 16,000 votes, Wednesday morning. Once Ossoff was officially projected to be the winner, and his victory certified, he joined his colleague, Senator-elect Warnock in the U. S. Senate.

What is the latest on vaccine availability in N. C.?

The Pfizer and Moderna vaccines for COVID-19 have been out several weeks now, and just over 4.5 million people across the nation have taken their first dose thus far.

What is the status, however, of

vaccine treatment now in North Carolina, and how soon will it be before communities of color, which have suffered up to three times as much as their White counterparts from the coronavirus, receive their dose?

According to the U. S. Centers for Disease Control and Prevention, as of Monday, January 4, North

Carolina is one of seven states that have vaccinated fewer than 1000 people per every 100,000.

The CDC also notes that North Carolina ranked among the ten lowest for vaccine distribution.

Part of the problem with both vaccination and distribution is the considerable degree of confusion associated with them. Some com-

munity health centers have designated those 75 and older to be the among the first to be inoculated. Some areas designate those in long term care facilities to be the first to receive shots.

Confusion comes when those not sure of their status show up to

Domestic terrorist attack at U. S. Capitol



Crucial questions must be answered in days to come

(TriceEdneyWire.com) - The U. S. Capitol in the heart of Washington D.C. was hit with a violent domestic terrorist attack on Jan. 6 as thousands of vastly White American citizens, right wing groups and Trump supporters stormed the building.

Capitol Police barricaded doors and drew guns to stave off the terrorists.

After it was over, four people were dead; members of Congress and their staffs were terrorized, and dozens of crucial unanswered questions remain. Among those questions:

•Why were there not more security officers on duty since this rally was openly planned?

•Why weren't police, Secret Service, FBI, ATF among other security agencies on the ground in preparation for this insurrection as hundreds of them were in attendance during protests by Black Lives Matter?

•Is it because these masses of insurrections were White that they did not receive the same treatment as Black Lives

Matter protesters and they were not expected to do the damage that they did?

•Were any members of these law enforcement groups accomplices in sync and in cooperation with the terrorists?

•In addition to Trump himself, were there any members of Congress who were accomplices in sync and in cooperation with the terrorists.

•What part did Twitter, Facebook and other social media sites play in failing to flag the plans for this terrorist attack; including the failure to end Trump's use of Twitter and social media to help encourage and organize it?

•What about those members

of Congress who had remained silent for the past two months as Trump railed, claiming to have been the rightful winner of the election.

•Will there be a Congressional investigation to answer these questions and will there be more arrests?

The insurrectionists had been invited to D.C. and sent to the Capitol by President

Donald Trump and his lawyer, former New York Mayor Rudy Giuliani who, at a rally Wednesday morning, encouraged the crowd to go forward and "Let's have trial by combat!"

Carrying Trump flags, U. S. flags, Confederate flags and other paraphernalia; wearing MAGA (Make America Great Again) hats, the crowds stormed the building during a joint meeting of Congress. The crowd overwhelmed armed Capitol Police officers to gain entry to the building. They broke windows, knocked down doors, climbed inside and outside walls. Pipe bombs were found at the Republican and Democratic headquarters.

Four people were killed during the Mayhem. At this writing, their names had not been released. According to reports, 52 people were arrested.

The intent was to stop lawmakers from certifying the presidential and vice presidential elections of Joseph Biden and Kamala Harris. The attack did not work. After members of Congress hid on floors under

their desks and Congressional leaders were whisked away to secure bunkers, hundreds of police and National Guard troops in riot gear were finally able to clear the building.

In the early morning of Jan. 7, the Congress voted to certify the Biden-Harris election. Inauguration is set for January 20th. Vice President Mike Pence, who was presiding over the joint session of Congress, affirmed the Congressional vote. Historians say nothing close to this physical attack on the Capitol had occurred in more than 200 years when British forces stormed and burned the Capitol in 1814.

Members of Congress, Trump's cabinet and the media are now discussing how to prevent continued attacks in this regard; including the possible invoking of Section 4 of the 25th Amendment, which states in part, "Whenever the Vice President and a majority of either the principal officers of the executive departments or of such other body as Congress may by law provide, transmit to the President pro tempore of

the Senate and the Speaker of the House of Representatives their written declaration that the President is unable to discharge the powers and duties of his office, the Vice President shall immediately assume the powers and duties of the office as Acting President."

In the midst of the attack Trump, in a Tweet, told the terrorists to respect police and said, "We are the party of law and order." Ultimately, he tweeted, "Go home, we love you. You're very special."

Twitter ultimately blocked Trump's tweets on Wednesday, but not until after the damage was done. On the morning after he tweet through a staffer's account that will go down in history as an ultimate insult. After Capitol Police barricaded doors and drew guns to protect members of Congress from the terrorists that he sent; after, for weeks, calling Jan. 6 a "day of reckoning," Trump tweeted through someone else's account, there will be a "peaceful transfer of power."

Rev. Warnock's and Ossoff's victories were immensely important to incoming Pres.

Elect Joe Biden and Vice Pres-Elect Kamala Harris because, not only does the double victory even up the U. S. Senate (50 Democrats vs. 50 Republicans), but allows VP Harris to be the tie breaking

vote on important issues.

Warnock and Ossoff benefitted from the large statewide African-American voting coalition led by Stacey Abrams that helped Joe Biden win Georgia in November.

Long early voting lines and millions of mail-in ballots also marked the over 3.3 million total early votes.

"We were told that we couldn't win this election, but tonight we proved that, with

hope, hard work, and the people by our side, anything is possible," Warnock said. "May my story be an inspiration to some young person who is trying to grasp and grab hold to the American dream."

declaring that the 2020 election was "stolen" from him.

Problem is, after approximately 60 lawsuits, neither Trump nor any of his legal team has offered a shred of provable evidence in various courts or elsewhere to bolster his claims. His Jan. 2, 2021 telephone stunt is now seen as a desperate act by a desperate man.

"This call is despicable and unprecedented!!!," said retired Senior Resident Superior Court Judge, and former Orange County District Attorney Carl Fox in a Facebook post. "It should be investigated and submitted to a grand jury for its consideration. Rest assured! This call would be submitted to a grand jury if the caller were Mary Jo or John Q. Public! The President is NOT above the law!"

That feeling isn't just limited to N. C. African-American law professors and former Superior Court judges.

Congresswoman Alma Adams [NC-12], just sworn-in Sunday for her fourth term, joined a congressional resolution, along with North Carolina colleague

Rep. G. K. Butterfield and over 90 other House members "censuring and condemning Pres. Trump for attempting to overturn the results of the November 2020 presidential election in the state of Georgia."

Rep. Adams, however, didn't stop there. She also later added, "Donald Trump belongs in prison. His actions justify it; the integrity of the Constitution necessitates it; the sanctity of our democracy requires it!"

However, approximately 140 Republican House colleagues of Adams disagree, so much so, in fact, that they joined with what was expected to be at least 13 Republican U. S. senators yesterday who declared they would not accept the Electoral College votes certifying Democrat Joe Biden as the new President-elect, instead demanding a 10-day period to appoint a commission to investigate allegations of "voter fraud."

So why should African-Americans care? African-Americans should care because legal and political analysts say this is really about race and discounting the votes of African-Americans.

In the six battleground

states, where Trump's lawyers sought to overturn the election results, they targeted predominantly Black areas where African-Americans won the state for Joe Biden and Vice President-Elect Kamala Harris. The courts in those states threw out those cases.

In Georgia, Trump claimed that thousands of votes were shredded in Fulton County, where 44% of its one million population is Black.

Michael Steele, the Black former chairman of the Republican National Committee was blunt. "[Trump] tried to engage a conspiracy to violate the Constitution and the U. S. Code by throwing out duly certified votes of citizens...by attempting to deprive" Black voters in Georgia of their vote after "a fair and impartially conducted election."

"In every jurisdiction that is presently being challenged by Donald Trump today is where African Americans eagerly used mail-in balloting to enlarge their participation in the voting process," Prof. Joyner explained. "This enlarged and engaged participation by African Americans (because of the

pandemic), in those Trump targeted jurisdictions, provided the overwhelming margin of victory for President-Elect Joe Biden.

"As such," Joyner continued, "the attacks on voting that are being orchestrated by Donald Trump and his allies are directed at taking away votes which were cast by African Americans.

When the Donald Trump gang rants about the casting of illegal mail-in ballots, they are referring to this large outpouring of African American political power and opposition that ousted him from office. In past elections, mail-in ballots have been primarily used by White voters."

"Trump and his forces are outraged that they can't identify anything illegal or inappropriate in these African American cast ballots to justify not counting them, which has caused them now to focus on "outright" theft of the election in these targeted jurisdictions," Joyner continued.

White moderate Republican "Never Trumpers," like former strategists Stuart Stephens and Steve Schmidt, call the GOP Trump supporters in Congress pushing for the 2020 presidential election

results to be thrown out "the Jim Crow Caucus."

"The Jim Crow Senators are trying to throw away the votes of millions of Black Americans," Schmidt said on Twitter, noting that Trump's current chief of staff, former North Carolina Congressman, Mark Meadows, was on that Jan 2 Georgia call with Trump.

"A man who cried crocodile tears at the death of a great man

@RepCummings is now seeking to toss out the votes of millions of Black Americans," Schmidt said. "Meadows has betrayed his country. His shame will be forever."


Legal analysts note that, if the Fulton County district attorney wanted to charge Meadows as an accessory to violating Georgia election law, she could do it immediately.

"This represents the lowest of the lows," former Judge Carl Fox says of the Republican effort to overturn the election. "So the sore losers with no evidence whatsoever should be able to keep the legitimate winner of the election from taking office based upon their unfounded, unsubstantiated objections, feelings, or beliefs?" GOV. COOPER MOBILIZES NATIONAL GUARD TO DISTRIBUTE COVID-19 VACCINE
 [RALEIGH] On Tuesday, Gov. Roy Cooper mobilized

the NC National Guard in order to accelerate distribution of the COVID-19 vaccine. "Ensuring COVID-19 vaccines are administered quickly is our top priority right now," Cooper tweeted. "We will use all resources and personnel needed. I've mobilized the NC National Guard to provide support to local health providers as we

continue to increase the pace of vaccinations." Approximately 50 National Guard members will be utilized for the effort.

WAKE COMPANY SEEKS BLACKS, HISPANICS FOR NEW VACCINE TRIAL

[RALEIGH] A Raleigh company called Wake Research

is seeking Black and Hispanic patients for a trial of the Novavax vaccine for COVID-19. Doses are administered three weeks apart. It is a two-in-one vaccine. According to Dr. Matthew Hong of Wake Research, the trial has about 40 participants thus far. Novavax is a two-year trial.

WILMINGTON FIRE DEPARTMENT ASSISTANT CHIEF RETIRES
 [WILMINGTON] After over thirty years, WFD Asst. Chief Rick Pearsall is retiring from the department this week. A former Marine, Pearsall joined the WFD in November 1990. He is also the second African-American to be appointed

assistant chief with the department, the first being Lorenzo Edge. Pearsall is known and respected for being a leader who always looked after his men as long as they did their jobs.

receive shots, only to be turned away. Many say they have tried to call numerous times before going, in many cases not being able to reach anybody because of phone problems.

Local health centers are still trying to coordinate with doctors and health specialists as to how and when to schedule vaccinations.

There is general agreement that the frequency of vaccinations is nowhere where it needs to be if CDC

goals are to be met for complete inoculation by this time next year.

Furthermore, as for communities of color, the NC Dept. of Health and Human Services "...has a specific focus building trust with historically marginalized populations," the agency says. "Longstanding and continuing racial and ethnic injustices in our health care system contribute to lack of trust in vaccines. The Department is partnering with trusted leaders and organizations to provide accurate information about the vaccine."

Take a stand against gun violence terrorizing our streets

Gun violence spiked across the country in 2020, the most violent year in decades. 19,000 were killed in shootings, the highest death toll in 20 years (and that does not include gun suicides). Mass shootings—defined as four or more shot in an incident—also rose drastically to over 600. Chicago's 769 homicides in 2020 were, according to ABC News, "more homicides than in all but one year in more than two decades."

The 4,033 shooting victims were also drastically higher. The spike in Chicago was echoed in other big cities like Detroit, Washington, D.C., New York and Atlanta and in smaller cities like Grand Rapids, Michigan, and Rockford, Illinois. In all these cities, the victims are disproportionately people of color.

The new year started off where the old ended, with 30 people shot and five killed in Chicago over the holiday weekend. We are killing one another in larger numbers in the midst of the national pandemic. The experts agree on the underlying causes. The COVID-19 economic devastation increased misery, anger, and fear. More and more found themselves under harsh pressure, unable to keep the roof over their heads, get adequate schooling for the young, secure decent health care and adequate food. The pandemic also caused a severe cutback in violence prevention programs, in conflict de-escalation services.

The George Floyd murder and recurrent police violence exacerbated the tensions. And most important of all, of course, is America's perverse addiction to guns. The year 2020 witnessed record sales of guns across the country. There are 5 million new gun owners in America. Sensible gun regulations have been blocked at the federal and state level. In too many instances, state legislatures have blocked the efforts of cities to regulate guns.

Guns are not made in Chicago. There are no gun ranges. Guns are brought in across state lines. The result is, frankly, absurd. The ban on assault weapons, weapons designed to kill people in large numbers in warfare, has been repealed. States across the country allow open carry and camouflaged carry. Protesters surrounded the Michigan legislature armed with rifles and guns.

Others threatened and began to plot an armed kidnapping of the governor, protesting her sensible COVID restrictions. At Donald Trump's calling, the streets of Washington, D.C., will be filled with protesters, many of them armed. This is yet another example of how a rabid minority—dispensing lots of cash and armies of lobbyists—can spurn the will of the majority. The majority of Americans want sensible gun control laws.

Now, however, there is a yawning partisan divide with Democrats and Independents supporting stronger gun control and Republican support waning. With gun violence spiking and political disputes turning into armed confrontations, it is past time for real leadership to step forward. Mike Bloomberg, the former mayor of New York, has shown the way. As a presidential candidate, he put forth a sensible comprehensive reform agenda. As a private citizen, he has helped to support groups calling for reform. He understands, more than most, that gun violence takes far more victims than those who die.


It is a major public health crisis, leaving thousands permanently disabled and in need of care. The incoming administration inherits staggering catastrophes that it must address. Surely one of these is the growing gun violence that terrorizes our streets. This administration should push America to make a real choice about gun violence. Do we want to allow more and more violence, to witness political disputes turning into violent exchanges of gunfire? Or will we make a commitment to making our streets safer with police not having to worry about being outgunned by the violent. Banning assault weapons should be a no-brainer.

Cracking down on the shipping of guns across state lines is another. Real investment in violence prevention services must be increased. Our schools should be teaching the practice and praising the courage of nonviolence. From its endless wars to the spiking gun violence on its streets, America leads the world in violence. This is not a race we want to run or to win. It is time for the majority to be heard.

Black folks should focus on our group's strengths

It is way past the time for serious black folks in this country to resolve that in 2021 we are focused all of our attention on identifying, analyzing and building upon our strengths as individuals and as a group. This will do much more to protect our economic, cultural, political, educational, health, legal, technological and self-defense interests than using our meetings to tell can-you-top-this horror stories about the latest actions of white supremacists. If we build upon our strengths, it will send a clear message to those whose goal is to keep us in a permanent position of second-

classhood.

Contrary to popular propaganda and beliefs of our enemies and, unfortunately, too many black people, we do have strengths. Only a strong group of people could have survived the physical and psychological attacks that have been inflicted on us in a basically white supremacist society.

That's why one of the first things we should do is put together a national conference during which we will have divisions

in the above listed arenas of economics, culture, politics, health, education, legal, technology and self-defense. Each division would be required to come up with plans of action in their field that will advance our group's interests in their particular field of action. If a hostile move is made by proponents of white supremacy against us in their arena they should be able to provide us with concrete guidance on how to deal with it.

Believe me, I am well aware that what I am proposing is not going to happen overnight. But I do believe that there are enough serious black folks in this country to begin laying the groundwork in 2021. I share the belief expressed by

the great journalist-historian Lerone Bennett, Jr. who noted that "Given the way we are forced to live in this society, the miracle is not that so many families are broken, but that so many are still together. That so many black fathers are still at home. That so many black mothers are still raising good children. It is the incredible toughness and resilience in black people that gives me hope." Those of us who share Brother Lerone's hope most definitely must walk the walk in 2021.

We were guinea pigs for the U. S.: It isn't just Tuskegee

People who don't know Black history have probably heard more about the Tuskegee syphilis "experiment" in the last month than they have in their whole lives. The chattering class has used the debacle of allowing hundreds of Black men live with untreated syphilis to monitor its effects to explain the resistance that many Black Americans have to accepting the COVID vaccination, thus imperiling the possibility of "herd" immunity.

It wasn't just the men, enticed into the study with the promise of lifetime health care, who suffered. Dozens of wives were also infected because they didn't know their partners had syphilis. At least nineteen children were born with syphilis because they were untreated. There was no known treatment for syphilis when the study, which was supposed to last just six months, began in 1934. Penicillin was the widely accepted remedy in the late 1940s, but none of the men in the study were offered it. The study is referred to as the "Tuskegee" experiment, but it really needs to be called the United States Public Health Service experiment. Our government initiated and funded this abomination and used Tuskegee as its base for this putrid study.

This was not the first time, though, and it is not likely to

be the last when Black bodies were experimented on for white comfort. During enslavement, "doctor" often purchased enslaved people to experiment on them. After Reconstruction, when Black folks died from being overworked, often their relatives were not told of their demise, but nearby medical schools used their bodies to teach medical students about anatomy.

It was legal in thirty-two states to sterilize Black women (and others considered "marginal") without their permission. In Alabama, in 1973, the Reif sisters, aged 12 and 14, were involuntarily sterilized in a federally funded clinic. An Essence magazine writer broke the story with the help of a whistleblower. The offending physician seemed to think the girls were mentally deficient and incapable of caring for the children they had not yet conceived. That was their decision to make, not his.

Between 1929 and 1976, at least 7000 people were sterilized in North Carolina by judicial order. Thousands more were sterilized by order of local judges. The state set aside \$10 million in 2014 to pay some of the oppressive state policy victims, but

many don't qualify because they lack documentation. Those sterilized were treated as guinea pigs.

J. Marion Sims, known as the "father of gynecology," perpetuated some of the more chilling experiments on Black women's bodies. He performed sterilizations, unnecessary C-sections, and more on Black women and worked on them until he could perfect the technique to use on white women. Sims performed many of the painful operations without anesthesia. In other cases, Black women were given so much mind-numbing morphine that they became addicted. Sims is credited with inventing the specula, a tool routinely used in most gynecological exams.

Actually, he used a spoon, then improved on it, for the examinations. Sims had quite the career, serving for a time as President of the American Medical Association. There was a statue of him in New York's Central Park and tributes to him all over the country. Blessedly the Central Park statue was taken down in 2018, after several protests. Why was it there in the first place?


In her book, *Medical Apartheid: The Dark History of Medical Experimentation on Black American from Colonial Times To The Present* (Doubleday, 2006), Harriet Washington details the many ways Black bodies were guinea pigs for white

experiments. That's not all. The Institute of Medicine has documented that black folk with broken bones are less likely to get pain medication than whites. And the very recent COVID death of African American physician Dr. Susan Moore, who was denied pain medication and was described as "intimidating" by the medical staff, illustrates how the medical establishment treats too many Black people.

Having said all that, I'll still be standing in lines soon as my number is called for the COVID vaccination. I prefer the Pfizer vaccination from the research I've done, but I'll take the Moderna if available. Why? I'm over 60, diabetic, and thus at high risk for getting COVID. I want to travel again, get on a plane, and see my mama and my friends. I don't know about eating out — my culinary skills have improved. But I know that my limited exposure to the world has gotten on my last nerve.

We were their guinea pigs, and the medical establishment has been negligent toward Black people. By now, though, enough white people have had the vaccination that by some wicked irony, they are my guinea pigs. Get the vaccination if you can, medical racism notwithstanding. Black folks are twice as likely to die from COVID as white people. Protect yourself!

Attorney Ben Crump wants White woman who attack Black teen over cell phone prosecuted

Civil Rights Attorney Ben Crump said, "enough is enough." The famed lawyer has demanded that New York prosecutors bring charges against a white woman who viciously attacked a young African American teen in a hotel lobby after she falsely claimed the youth stole her iPhone.

"As this year of racial awareness is drawing to a close, it's deeply troubling that incidents like this one, in which a Black child is viewed as and treated like a criminal, continue to happen," stated Crump, who in 2020 has represented the families of Ahmaud Arbery, Breonna Taylor, George Floyd, and Jacob Blake.

On Tuesday, December 29, 2020, a spokesperson for Manhattan District Attorney Cy Vance, Jr., confirmed that

the office was investigating the assault on Kenyon Harrold Jr., the son of jazz trumpeter Kenyon Harrold.

The incident, which the senior Harrold captured on cell-phone video, occurred on December 26 at the Arlo Hotel, a boutique four-star hotel in New York's Soho section.

While the Harrold's were grabbing breakfast, the still-unidentified white woman lashed out, tackled, and scratched the innocent teen, accusing him of stealing her phone.

When the elder Harrold stepped in with his camera recording the incident, the woman allegedly assaulted the Grammy-winner as well.

She then confronts a hotel

manager and accused Harrold, Jr., of stealing her phone and again lunges at the youth.

"Take the case off, that's mine," the angry woman yells in the video. "Literally, get it back," she demands of the hotel manager.

A few minutes later, the woman's missing phone was returned by an Uber driver, who noted that she mistakenly left it in the car.

"I am furious!!! the elder Harrold, who counts Prince, Common, and Dr. Dre as influences, wrote on Instagram.

"We see this crap happening all the time, but it hits different when it hits home!!! I typically try to keep things positive, but nothing about this video is positive."

The hotel issued an apology and called the Harrold's experience "inexcusable" before offering that "more

could have been done to de-escalate the dispute."

Crump remained furious. Compounding the injustice, the hotel manager defaulted to calling on 14-year-old Keyon to prove his innocence, documenting that we have two justice systems in America and that Black people are treated as guilty until proven innocent," Crump exclaimed.

"We strongly urge Manhattan District Attorney Cy Vance Jr. to bring assault and battery charges against this woman to send the message that hateful, racially motivated behavior is unacceptable. This is what it will take to drive change. We also call for a civil rights investigation into the Arlo Hotel for its implicit bias in its treatment of Keyon."

TO BE EQUAL**With Tamir Rice decision, Trump's Justice Department once again protects the powerful at the expense of the powerless**

"Anyone with decent vision can see from the parking-lot video of the shooting that the claim that Loehmann was able to repeatedly warn Tamir warrants incredulity. In less than two seconds, Garmback screeches to a halt in the cold mud, Loehmann pops out of the passenger door, and he fires the shot that eventually killed Tamir. He'd have had to be speaking like one of those speed readers dictating legal disclaimers on radio advertisements. However, despite that common-sense view of things, Fishman and Reddick reportedly encountered tension within the DOJ. You see, they had to write a memo requesting a grand jury to subpoena documents and testimony from witnesses, and that memo needed approval from a deputy assistant attorney general who works alongside Trump political appointees within the DOJ. And no one responded. ... Quite simply, the DOJ let the clock run out on accountability for two cops involved in killing an unarmed black child." —Jamil Smith, Rolling Stone

Black life. Tamir Rice was a child playing with a toy. It would have taken Timothy Loehmann and Frank Garmback only a few seconds to ascertain that he posed no threat to anyone. But they didn't bother to spend even those few seconds because all they needed to see was the color of Tamir's skin to decide he was a threat.

They didn't even bother to stop their car completely. As Judge Ronald B. Adrine wrote in his ruling that probable cause existed to charge the officers, "This court is thunderstruck by how quickly this event turned deadly ... the Zone Car containing Patrol Officers Loehmann and Garmback is still in the process of stopping when Rice is shot."

The toy gun wasn't even in Tamir's hands when the officers shot him. The video "does not appear to show him making any furtive movement prior to or at the moment he is shot," Judge Adrine wrote. Tamir's arms "do not appear to be raised or outstretched."

A grand jury declined to indict the officers in 2015,

calling the killing a "perfect storm of human error, mistakes, and communications by all involved." However, because grand jury proceedings are shrouded in secrecy it's unknown what evidence the grand jurors heard or what recommendations the prosecutors made.

After a judge granted grand jurors in the Breonna Taylor case permission to speak publicly, the public learned that prosecutors had not given them the opportunity to bring homicide charges against the officers. Kentucky Attorney General Daniel Cameron falsely claimed the grand jury "agreed" that the shooting was justified.

The city of Cleveland last year settled a wrongful death lawsuit filed by Tamir's family for \$6 million.

This brutal year of COVID-19 has seen armed protesters storm state capitols, threatening lawmakers and even menacing police, and not one was harmed. The armed protesters were white.

In Kenosha in August, police nonchalantly allowed accused killer Kyle Rittenhouse, armed with a AR-15 style rifle, to walk by them even as witnesses shouted that he had just shot someone. Rittenhouse is white.

The same week as the Kenosha killings, police in Utah arrested an

unharmed Richard Grant Lees after he fired shots at the officers with assault rifle. Lees is white.

Time and again, Black people are considered a threat just for existing, while violent white men are cossetted.

A Justice Department that does not consider Tamir's death a crime is a Justice Department that has decided that white officers must never be held accountable for taking Black lives, under any circumstances. Among those recently pardoned by President Trump were a white police officer who unlawfully ordered her police dog to attack people of color; a Border Patrol agent who brutalized a Latino man trying to cross the border; an immigration agent who illegally harassed Latino store owners, and a sheriff who defied a court order to stop racial profiling and who once said it was "an honor" to be compared to the Ku Klux Klan.

It may be too late for the incoming Biden Administration to re-examine this case. But we expect the new Attorney General to be committed to police accountability, and to pursue such cases with a sincere motivation to seek justice for the victims rather than to protect their killers.

One of the greatest disappointments is that there are so many people in elected office who do not like democracy. While they say "the Democrats" will make this country a socialist nation, they are, in fact, working to make fascism an American reality. They are not interested in the masses of people having rights - and neither are over 70 million people who support them. They make a mockery of the law while saying they supportive of "law and order." It is like a law enforcement officer beating his wife, even while in uniform. Law enforcement officers are supposed to uphold the law, not blatantly break it.

It feels like American democracy is on the ropes, doing very little to fight back. Like an abused spouse, America is taking the abuse, save for the courts that have rejected the over 60 lawsuits that have been filed to try to invalidate the election results.

The men in power, supported, by the way, by a base which includes many who need democracy in order to have quality lives are bullies, and are proud of it, doing everything but baring their chests and showing their erect genitals. The newly elected senators and representatives were sworn into office yesterday, and it was like an abuser being honored and promoted in spite of having engaged in reprehensible behavior. Those sworn in promised to protect the Constitution and this country but their promises were empty and meaningless.

People who are abused take it until one day they cannot. When they fight back - if they do - the end result is often tragic. The abuse and assault of this nation by these power-grabbing men will only get worse. The question is, what will it look like when those who believe in democracy say "enough!"

That is a word which should have been said long before this. God help us all.

GET THAT DEED AND FLIP THOSE KEYS!

Co-signing, look at your neighbor and say.....

DON'T DO IT!" Let me tell you I recall countless times that families were forced to continue renting due to helping others and it turned into a great mistake. They were doing it out of the kindness of heart. Just wanted to help their friends and loved ones only to find out later the carnage that came from it.

Being too debt-heavy (high debt ratio) is the #2 reason (after bad credit) that most can't get a home loan approval. Oh, I know not all co-signing situations end badly but unfortunately, some stats reveal in most cases the bad out ways the good... SMH, it can also be challenging to be removed as a cosigner from a loan. To gain a better understanding, let's look at why a cosigner is needed at all. A cosigner is needed when the borrower's own credit and/or income isn't

enough to qualify for the loan by him or herself. The cosigner has stronger credit and income and is required by the lender or creditor to help guarantee that the loan will be repaid. Please believe me when I tell you that IF you sign that document saying you will pay if they don't, YOU WILL BE HELD TO THAT. So many blindly believe that it could never happen because they know that person so well and I know they won't leave me hanging like that, but sometimes things happen that are out of their control. What if that person loses their job? What if their job decides to downsize or just close altogether with no warning? What if that per-

son gets sick and can't work? What if that person dies? The what IF'S are the unknowns, but they can happen. When that borrower is 30, 60, or 90 days late, you are 30, 60, and 90 days late and both of your credit files will show that. Their credit is getting reported negatively and your credit scores are being affected at the same time. Truth is "Life Happens" and it's out of our control so know that if you sign that doc saying you will if they don't... GET READY BECAUSE THEY ARE COMING for you to make that word good. Now that you know the role of a co-signer let's look at what you may could do to be removed from a co-signed account. I have found that co-signing for a car is the most common mistake most make. I'm going to be upfront with you and let you know that if you didn't ask upfront if there is a way to be released from this obligation,

you may have a real uphill battle, but nothing beats a failure but a try.

So, you could try (1) asking for a "CO-SIGNER RELEASE": Some loans have a program that will release a cosigner's obligation after a certain number of consecutive on-time payments have been made. Two years of on-time payments have been most common. Read through your loan documents to see if there's any type of program associated with your loan. Or, call the lender and ask if something like this applies to your loan. Generally, the bank won't remove your name from a co-signed debt unless the other person has demonstrated they can handle the loan on their own. Think about it: you would never have been asked to cosign if the other borrower had shown this ability from the beginning. People can change and become more

responsible, yes but the bank will definitely want proof. (2) The less hectic way to get a co-signer removed from a loan/car loan is to refinance the loan. Reach out to the lender and see if they will allow the refinance since so many payments have been made on-time by the primary borrower. It is important that the payments be made in a way they can be tracked with a paper trail showing that the primary borrower, not the cosigner made these payments. NO CASH, the most effective way is to pay with a personal check or make a payment with a card that can be easily verified by monthly statements. (3) Lastly, if being released from the loan, or a refinance is not an option, you just got to work overtime and throw every extra dollar at this debt and pay it off. This is the most disturbing option to most. Who really wants to pay off a debt for

UNCW College of Arts & Sciences launches Diversity and Inclusion Cluster Hire Initiative

As part of coordinated diversity and inclusion initiatives within the UNCW Division of Academic Affairs, UNCW's College of Arts and Sciences is launching a cluster hire initiative in the areas of Africana studies, race, racial inequality and social justice.

New faculty will serve within existing departments and programs connected to their specific discipline and will also form a cohort of scholars to contribute to the college's interdisciplinary minor in Africana studies and the planned interdisciplinary bachelor's degree in Africana studies.

"When I took over as inter-

im dean, a primary focus was to increase diversity and inclusion within the College of Arts and Sciences. This specific initiative was within that charge and driven by department chairs and faculty who felt the need to move beyond just understanding the need and having the desire to diversify our faculty," said Richard Ogle, interim CAS dean. "We realized that given the history of Wilmington and our region, we should take action and develop UNCW as a leader in these areas of study. We had a level of investment in this idea that led to departments changing the focus of planned replacement hires to

areas of study that would allow us to begin to build this strength."

Diverse representation and voices are also essential to providing a rich educational experience to students, Ogle added. The initiative will also improve the college's ability to attract diverse and underrepresented students.

"We cannot truly fulfill our mission of educating students to be the next generation of problem solvers and global citizens unless our faculty are truly representative of the multitude of voices and perspectives we see in the United States and beyond," he said. "A wealth of research shows that diverse

teams provide better solutions to problems. We know that culturally competent individuals succeed in the current marketplace. We owe it to ourselves, our students and our world to ensure that students have the experiences necessary for them to succeed - awareness of and understanding underrepresented voices is one of these critical experiences.

Students often choose a university where they hear their voice and where they get to see its importance lived out on a day-to-day basis."

Department chairs who were the driving force behind the initiative are Mike Maume (sociology and crimi-

nology), Theodore W. Burgh (philosophy and religion), Lynn Mollenauer (history), Julian Keith (psychology), and Mariana Johnson (film studies).

"It's a solid step in a positive direction, but the energy, time, money, and a committed, collective effort must be maintained for as long as it takes," said Burgh. "UNCW's past actions and incidents continue to make it a challenge to bring faculty from underrepresented groups to campus. Nevertheless, new hires will benefit the university with fresh ideas, enthusiasm and innovative courses.

However, along with the challenge of hiring new faculty,

UNCW must work to make them want to remain here."

The hires will be in the area of psychology, history, sociology, criminology, film studies and philosophy. As this is a multi-year initiative, additional future hires in other disciplines are planned.

"This is not the only way in which we are focusing on increasing the diversity of the faculty and staff in CAS," Ogle said. "We are also working with Academic Affairs on best practices to ensure that all our recruitments allow us to maximize our ability to diversify our faculty and staff and to create an inclusive environment for all."


Thelma Williams Mallette




