



George Floyd's N. C. family unveils May 25th "Day of Enlightenment"

In under two weeks from now, May 25, 2021, will be the first anniversary of the police murder of George Floyd at the hands of former Minnesota police officer Derek Chauvin, but, according to Floyd's family last Saturday, May 25 will also be a "Day of Enlightenment" to commemorate the dark anniversary, honor George Floyd, and promote a hopeful change in societal attitude towards racism.

Last Saturday, the Floyd family from Fayetteville, where he was born 46 years prior to his death, gathered at the John P. "Top" Greene Community Center in Southeast Raleigh, along with Mayor Mary Ann Baldwin and District C City Councilman Corey Branch, to announce the inaugural kickoff of the special occasion and also the establishment of the multicultural nonprofit George Floyd Memorial Center in Raleigh. Their hope is that the center, estimated to cost between \$10-\$20 million, will be a source of inspiration and information for generations to come. The center's motto will be "Achieving Greatness Through Focused Service."

"We want them to know that they can make a difference! You don't have to die to make a difference," Thomas McLaurin, Floyd's cousin, told those gathered Saturday. "We want them to live and make a difference and see things [as] they could be in our community moving forward."

Even though George Floyd was a native of Fayetteville, his family plans to build the name-sake center in the Capital City and are in the process of fundraising towards the effort. The cen-

ter, once completed, will contain an interactive museum, classrooms, and a leadership academy, as well as online educational programs, all geared towards helping young people find a positive path through life. The Floyd center, with a projected construction and opening within the next two to three years, will also sponsor a scholarship fund to assist in that effort.

McLaurin says the family is hopeful that it can identify a site for the center close to Shaw University in downtown Raleigh and Southeast Raleigh, primarily because they have been in discussions with Shaw about collaborating on various projects.

The center is also a way to turn the tragedy of George Floyd's death into a peaceful and effective way to deal with the specter of racist police brutality that has plagued the nation for so long.

"We want to use the name George Floyd to make an influence," McLaurin said, adding that the family wants to "change the world" by turning "from hurt to hope."

Mayor Baldwin and Councillor Branch made clear that the city of Raleigh was on board with the goals of the Floyd family and the proposed center. They brought an official proclamation making May 25 "A Day of Enlightenment" in honor of George Floyd.

"We'll help draw attention to the long history of racism and discrimination in our world and provide an opportunity for people in our community to stand together and embrace a hope for the future," Councillor Branch said.

Meanwhile, as the family of George Floyd gathered Saturday to announce their efforts to pay tribute to the fallen police brutality victim,

the family of Andrew Brown, Jr., joined by clergy and supporters, peacefully marched through the streets of Elizabeth City, demanding transparency in the investigation of the fatal April 21 shooting of Brown by Pasquotank County sheriff's deputies during the course of serving a warrant on Brown.

A local judge restricted what footage the family could see of police bodycam video of the slaying, saying that it will remain restricted while an SBI probe is underway.

When the family and attorneys did see about 20 minutes of the police footage on Tuesday, they said Andrew Brown, Jr. was "ambushed" by sheriff's deputies while he was in the car in which he was ultimately shot to death. They maintained that at no time was he a threat to any of the deputies present.

Attorney Chance Lynch, representing the family, told reporters Tuesday, "there were so many shots that we had difficulty in counting the number." Lynch maintained that Brown never moved the vehicle until after the first shot from law enforcement.

Civil rights leaders, Rev. Dr. William Barber, and NC NAACP president, Rev. Dr. T. Anthony Spearman, have echoed Governor Roy Cooper in calling for a special prosecutor to investigate the case.

The FBI is also conducting a federal civil rights investigation.

On Monday, a State Senate committee voted to rewrite North Carolina's law governing release of police bodycam video, allowing families of police shooting victims to see it within five days. Law enforcement would have the right to object.

NC'S PRICE GOUGING LAW ACTIVATED AFTER GAS SHORTAGE

[CHARLOTTE] In the Queen City, an estimated 71% of gas stations have run out of fuel. In Raleigh, 69%. All over the state, and

indeed the southeast, "Out of Gas" signs are being posted in the aftermath of the Colonial Pipeline Russian ransom ware attack earlier in the week. Consumers and businesses are lining up to get as much gasoline as possible. The law prohibits gas stations from raising the price of gas beyond reason. Officials hope the pipeline will be up and running by the end of the week.

VACCINE DEMAND DOWN IN NORTH CAROLINA

[GREENSBORO] The demand for COVID-19 vaccine in North Carolina has dropped in the past week by 78%, officials say. More than half of the state's adult population have received at least one dose of the vaccine. The goal is to reach herd immunity, which would be 70-85% of the population immunized. The sooner that happens,

the sooner places can reopen back to normal capacity, and face masks in public can be removed.

NC REPUBLICAN LAWMAKERS MOVE TO OUTLAW CRITICAL RACE THEORY

[RALEIGH] Following the lead of Lt. Gov. Mark Robinson, Republican lawmakers in the state House have fast-tracked a bill that, if adopted, will "give students a positive view of

American history" and not deal with its racist past. Rep. James Gaillard (D-Nash), who is Black, has called the measure, "a bill of hatred...a bill of privilege...a bill of fragility."

Crossover week sees bills of key interest

Welcome to Crossover Week at the NC General Assembly. According to WUNC North Carolina Public Radio, legislative "crossover" is when "...a bill must have passed at least one chamber of the Legislature by the end of the day today, May 13, to stay alive for consideration this year in the other chamber." Of course, lawmakers in the past have found creative ways around this "rule."

The following are highlights of House bills that might not make today's crossover deadline but are worth keeping an eye on going into next session.

HB 247 - Standards of Student Conduct

AN ACT TO MAKE VARIOUS CHANGES TO LOCAL STANDARDS OF STUDENT CONDUCT

Wherein local school boards, "...in consultation with teachers, school-based administrators, parents, and local law enforcement agencies, shall adopt policies to govern the conduct of students and establish procedures to be followed by school

officials in disciplining students."

The school board policies "shall include or provide for the development of a Code of Student Conduct that notifies students of behavior expected of them, conduct that may subject them to discipline, and the range of disciplinary measures that may be used by officials.

HB 536 - Law Enforcement Duty to Intervene

AN ACT TO ESTABLISH A DUTY FOR LAW ENFORCEMENT OFFICERS TO INTERVENE IN AND REPORT EXCESSIVE USE OF FORCE

In the aftermath of the police murder of North Carolina native, George Floyd, wherein three Minneapolis police officers did nothing to stop a fourth officer, Derek Chauvin, from pressing his knee to the neck of Floyd for 9 minutes and 29 seconds, effectively killing him, this proposed amendment to NC General Statute 15A-401 reads:

Duty to Intervene and Report Excessive Use of Force - A law enforcement officer, while in the line of duty, who observes another law enforcement officer use force against another person

son that the observing officer reasonably believes exceeds the amount of force authorized by [this law], and who possesses a reasonable opportunity to intervene, shall, if it is safe to do so, attempt to intervene to prevent the use of excessive force. Additionally, the observing officer shall, within a reasonable period of time not to exceed 72 hours thereafter, report what the officer reasonably believes to be an unauthorized use of force to a superior law enforcement officer within the agency of the observing officer, even if the observing officer did not have a reasonable opportunity to intervene.

HB 608 - Dignity for Women Who Are Incarcerated

AN ACT TO PROMOTE THE DIGNITY OF WOMEN WHO ARE INCARCERATED

A Proposed Law to Protect the Rights of the Female Incarcerated

Prison personnel shall not apply leg restraints; handcuffs or other wrist restraints; restraints connected to other incarcerated persons or waist shackles to "...a pregnant female [prisoner] during the sec-

ond and third trimester of pregnancy, during labor and delivery, and during the six-week postpartum recovery period (unless an important individualized circumstance exists). "In this case, only wrist handcuffs held in front of the female [prisoner's] body may be used and only when she is ambulatory."

The proposed law also prohibits anyone other than a "certified health care professional ...[to] conduct body cavity searches of a female [prisoner] who is pregnant or in postpartum recovery period..." unless there is probable cause to believe the female [prisoner] "...is concealing contraband that presents a threat of harm to the female [prisoner], the fetus, or another person."

HB 805 - Prevent Rioting and Civil Disorder

AN ACT TO INCREASE THE PENALTIES FOR RIOTING OR INCITING RIOTING THAT RESULTS IN DAMAGE TO PROPERTY, SERIOUS BODILY INJURY, OR DEATH AND ASSAULTING EMERGENCY PERSONNEL DURING A RIOT OR STATE OF EMERGENCY; TO ALLOW RECOVERY OF TREBLE

DAMAGES TO PROPERTY DAMAGE OR PERSONAL INJURY CAUSED BY RIOTING OR LOOTING; AND TO REQUIRE PRETRIAL RELEASE CONDITIONS FOR RIOTING AND LOOTING OFFENSES TO BE DETERMINED BY A JUDGE.

Under this proposed law, "A riot is a public disturbance involving an assemblage of three or more persons which, by disorderly and violent conduct or the imminent threat of disorderly and violent conduct, results in injury or damage to persons or property or creates a clear and present danger of injury or damage to persons or property."

Any person who willfully engages in a riot is guilty of a Class I misdemeanor, or a Class H felony, if the person possesses any dangerous weapon or substance.

Any person who willfully engages in a riot is guilty of a Class F felony if in the course of and, as a result of the riot, there is property damage in excess of fifteen hundred dollars (\$1500) or serious felony bodily injury, and of a Class E felony, if in the course of, and as a result of the riot, there is a death.



Angry Old White Civil Rights Lawyer Not Tired Yet

Taking another giant step forward to end rogue policing

May 25th marks one year since Derek Chauvin and his four accomplices murdered George Floyd.

May 28th marks one month since Elizabeth City's Black Mayor and Police Chief's overhead camera filmed a Fallujah-style assault pickup truck carrying several standing men with military Assault Rifles (AR) ready to fire deadly military rounds into soft, unprotected human vital organs, including the back of a skull.

This film, the property of the Town of Elizabeth City, captured the pickup racing toward it on the wrong side of the street, make a hairpin turn and race up the hill to its obvious destiny—Andrew Brown's driveway. Seconds later, Mr. Brown was dead from gunshot wounds to the back of his skull. EC Police Chief Eddie Buffalo posted the video, pre-empting any official statement about Mr. Brown's imperfections and creating a heroic narrative for the shooters. The EC Mayor, Town Council, and Chief struck a major blow for Truth before the Trashing the victim; before the firing squad executioners could publish their diversion version of the driveway execution of Andrew Brown.

We are therefore faced with two tasks to honor the lives of George Floyd and Andrew Brown. First, we must continue our strong EC and N.C. solidarity with Mr. Brown's big family, which began with the Town's leaders, and has mushroomed into scores of clergy of all colors, who are ready to Walk and Talk about this outrageous act,

Second, we must use the energy for Truth, by creative confrontations with Senators and Representatives, who are presently considering the brilliantly written Police Accountability Act, "George Floyd Justice in Policing Act of 2021" which has already passed the House and is presently being worked on by three Black Senators. Here are some pertinent excerpts from the H. R. 1280. The George Floyd Justice in Policing Act, to hold law enforcement accountable for misconduct in court, improve transparency through data collection, and reform police training and policies.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. (a) SHORT TITLE. This Act may be cited as the "George Floyd Justice in Policing Act of 2021."

Pattern and practice investigations.

Independent investigations.

Accreditation of law enforcement agencies.

National task force on law enforcement oversight.

Ban on no-knock warrants in drug cases.

Stop Militarizing Law Enforcement Act.


Patrol vehicles with in-car video recording cameras.

The Wilmington Journal, our sister Back Newspapers across the state and the increasing number of White Publishers and Editors who are beginning to recognize that being white in a racist society brings with it what we call a "White Skin Responsibility." Part of that Responsibility is to inform our diverse electorate of the brilliant work, over the last 50 years, that have gone into the George Floyd Act. Imagine if we can support NC NAACP President T. Anthony Spearman, and President Emeritus William J. Barber II, with the dedicated leadership they have shown since the Falluja-style execution of Andrew Brown.

Imagine walking (and riding for old-timers) from Elizabeth City, straight north into Virginia, to meet our many allies there. Then by Jamestown, where the first Africans in 1619 were dehumanized and enslaved. Then up the slave road to Richmond's slave markets for study and memorial services; over to Charlottesville and Thomas Jefferson's Monticello/UVA, to remember Heather Heyer, the violent Klan-Nazi rally with its "good people" recognized by the President.

Then the last 90-mile leg to the Lincoln Memorial, Washington's outdoor Cathedral, to ask for holy blessings of our Journey for Truth and Andrew Brown. On the Journey we can hold teach-ins on the George Floyd Act; invite its key proponents to visit and participate in our studies and discussions, such as the three Black Senators to help them get 100% Senate Support, to visit our evening study groups, to help us be more effective in our lobbying at the Capitol and in our meetings with U.S. Attorney General Garland and his Civil Rights Staff to expedite his designation of North Carolina as a "Pattern and Practice" state.

Att. McSurely worked in the Civil Rights Movement from 1960 to 1968, when his family's home was dynamited in Eastern Kentucky. Margaret Herring and he were charged with overthrowing the Government of Kentucky by building moral fusion alliances with Appalachian coal miners and Black voters. He became a lawyer after 15 years of apprenticeship to Bill Kunstler, Arthur Kinoy, and Morton Stavis while they fought off charges of sedition and contempt. He earned his law degree from NCCU Law School and has been suing racist institutions ever since. He has worked closely with his friend, Bishop William J. Barber II. Five years ago, he married O'Linda Watkins, President of Moore County NAACP Branch.

Survival

I'm not perfect nor do I claim to be. Although I strive to get as close as possible, I don't evaluate my comportment as perfect or my judgment as infallible. I accept the humanity and infallibility of others and hope, that when evaluated by others, I will be extended that same courtesy and grace. On occasion, my eyes have even been closed to the obvious.

My focus has been the achievement of social and economic justice for those who've been historically or systematically disadvantaged by the imposition of impediments to their progress — typically women and people of color.

The imperative of eliminating the internal and external threats to our personal and collective security has always loomed large as a personal objective and is exemplified by the incessant and growing list of those murdered by agents of "law enforcement." I'm moved to action by the anguish of children who're victimized by a never-ending cycle of hunger or those who receive an education that's inadequate to provide future incomes that will sustain them or any children they will

attempt to parent.

The dedicated and principled effort necessary to even begin to confront the myriad of problems impacting our communities requires single-minded focus. For generations,

the volume of problems that our communities have had to face have been challenging for some and overwhelmingly difficult for most.

I sometimes compare our socio-economic difficulties to an adult reality game of "Dodge Ball." Like that ball that nearly knocks your head off, the strife and trouble common to our communities, seemly comes out of nowhere with the goal of knocking you out of the game - literally.

Rather than really resolving issues, many of us are caught in situational survival. We move from one crisis to another only catching the periodic "break" or respite giving us enough energy to survive through the

next struggle. Having so little time for reflective thought, many of us are caught in the loop of tackling the next most critical threat to us. It's no wonder that many people of color are without a real sense of urgency about the growing threat to our ecology.

As one who previously only focused on the more recognized, recurring, and active threats against my community, I wasn't first among those on the ecology bandwagon. Encouraged by the philosophy of indigenous people, I accepted that "Only when the last tree has died, and the last river has been poisoned and the last fish has been caught will we realize we cannot eat money."

If we can't live without the threat of natural disaster or a poisoned environment, what does it matter how long or under what circumstances we live? That guidance from the original caretakers of this land led to the realization that a requirement for the "true" social activist is to maintain a 360-degree awareness of things necessary to guarantee the long-term, positive quality of life.

Any observer with common sense should understand

that the appointment of former U.S. Rep. Deb Haaland as Secretary of the Interior (first Native American so appointed), the U.S. rejoining the Paris Climate Accords, and the emphasis placed on the development/refinement of renewable energy sources by President Biden should give a clue as to a growing economic opportunity.

The movement toward renewable energy should encourage those looking for high-growth employment opportunities. Increasingly, training or ground-up experience is available in solar or wind energy. Those with scientific, technical or mechanical skills can potentially write their own ticket to success.

I'm impressed with a company working to do just that. See [mimsmotorsusa.com](http://www.mimsmotorsusa.com) and see what they're doing. Chief Flying Hawk once said: "Nobody can be in good health if he does not have ... fresh air, sunshine and good water."

Living within a lie

Even a person who does not believe a lie may be forced to live within it.

The truth that the color of one's skin does not determine a person's God-given abilities has always been evident to people of color. But within a global social structure designed to advantage white people over everyone else, that truth has been denied and hidden from view.

The orthodoxy of white supremacy, reinforced by a willingness to employ gunpowder in a pan-global rampage, allowed white supremacists to amass most of the material resources of the earth, along with the means to exploit them solely for their own benefit. What school-aged child has not seen graphic renderings of Europeans, cast in a heroic light, gunning down indigenous people of North America, South America, Africa and Asia? This oppression and annihilation of people of color have been characterized by British author Rudyard Kipling as "the white man's burden" to bring

civilization to the rest of the world.

Poisonous race hatred spawned by white supremacy has flowed through Western society like filth in an open sewer. Yet there are those who

take offense at the assertion that America is a racist country. While there are innumerable instances that evidence this fact, one very clear, recent example stands out for me.

When the feature film "The Hunger Games" was released in 2012 based on a series of young adult fiction, many white fans were enraged by the fact that one of the main characters, Rue, was portrayed by Amandla Stenberg, a mixed-race actress with an African American mother and a Danish father. The plot of the film revolves around 12 children who are forced to fight to the death in a futuristic, dystopian America. The shock and anger of many moviegoers booted over even though the author, Suzanne Collins, described Rue in the book as having "dark skin." A blizzard of offensive, racist posts filled with the n-word and other derogatory terms flooded social media because a little Black girl had invaded their imagined white space of innocence and bravery. But a particularly telling post was a tweet by someone with the handle "KK" who wrote: "Call me racist but when I found out rue [sic] was black her death wasn't as sad #ihate myself." There can be no more clear affirmation that some people cannot even imagine that Black lives mat-

ter.

This race hatred began in America when European invaders, arriving with Christopher Columbus, annihilated as many as 3 million indigenous inhabitants in the Bahama Islands and continued with the slaughter of indigenous people in the early days of every state in this nation. This genocide of Indigenous Americans, combined with the importation of enslaved Africans as unpaid labor, created wealth for the European invaders founded upon stolen land and stolen labor.

The continued encroachment on Indian land and exploitation of people of color through immorally low wages continue to underpin this disproportionate accumulation of wealth by white Americans. Current policy decisions by lawmakers and corporate leaders such as refusing to legislate a livable minimum wage, redlining, discriminatory hiring practices, gerrymandering, and on and on, also continue to obstruct wealth accumulation by people of color.

The facts are clear, written in the blood-soaked soil and the countless unmarked graves of people of color who were murdered, massacred and worked to death so that certain white people could accumulate wealth and live as they pleased. This includes mistreatment of the Chinese, who were barred entry into this country after they helped build its railroads, and Japanese Americans who were herded into concentration camps during World War II without due process of law, while German Americans largely were allowed to go about their lives untroubled.

Approximately 1.2 million individuals born in Germany

resided in the United States in 1940. Another 5 million had both parents born in Germany and 6 million had at least one parent born in Germany. Of these people, approximately 11,000 were detained during World War II and most of those were German nationals.

During this time, almost every Japanese American was placed in concentration camps. Approximately 127,000 Japanese Americans lived in the continental United States in 1940 and it has been reported that more than 120,000 were interned in concentration camps despite reports from the FBI and the Office of Naval Intelligence stating that the vast majority of Americans of Japanese ancestry were loyal to the United States.

Nevertheless, it was ordered that any person with "one drop of Japanese blood" - regardless of age - was to be interned. This resulted in infants and children living in orphanages and hospital patients with any Japanese ancestry being interned. Many of those hospital patients died as a result of being separated from their health care.

Despite many white supremacists wanting to avert everyone's eyes from the truth, America's racism has followed a long and winding path, leaving a history too lengthy to recount here. But critical race theory is an effort to place the facts before the world so that people, armed with the truth, can make meaningful change and not be forced to live within a lie.

Solving The Race Issue In America**Will it fade into yesterday?**

While the world is coming out of the pandemic, the Republican party is attempting to turn back the clock on truth, freedom, and justice.

It is attempting to take America back to the good old days that conservatives long for.

Second: The republican party is committed to restrict voting rights of black Americans.

An article by Amy Gardner in The Washington Post (3/11/2021) reveals that Republican

lawmakers in 43 states have proposed at least 250 laws that would restrict voting rights.

Georgia and Florida have already enacted legislation that will restrict voting rights.

This current national assault on voting rights is taken from the racist playbook of voter suppression.

The playbook for voter suppression was an outcome of the only coup that occurred on American soil - "the Coup of 1898" in Wilmington, North Carolina."

After the legitimately elected government of Wilmington, North Carolina was overthrown in the "Coup of 1898," white legislators in the state government enacted "Jim Crow" laws that would suppress the rights of black voters.

A direct result of the effectiveness of the voter suppression campaign in North Carolina made it impossible for George Henry White, the last black American in the US Congress after the reconstruction, to be re-elected.

After Congressman White's term ended in 1901, it was nearly 92 years before another black American was elected to the US Congress from the state of North Carolina. Eva Clayton - a black American - was elected to Congress from North Carolina in 1992.

As a result of voter suppression laws enacted after the Coup of 1898, no black people served in Congress for the next 28 years, and none represented any Southern state for the next 72 years.

In 1898, the goal of the state legislators was to prevent the recurrence of the 1898 liberal political victory that had been destroyed by the "Coup of 1898."

The true goal of today's national assault on voting rights - the "New Jim Crow" - is the

same as in 1898. Republicans want to ensure that the victories by the democrats in winning the presidency and control of the US Senate would never be repeated in upcoming elections.

Third: The denial of the existence of systemic racism in America.

The republican claim that America is not a racist country clearly ignores the history and present reality that most black Americans live every day.

According to The Washington Post on April 28, 2021, there are "... GOP efforts across the country to push similar legislation that would ban critical race theory, which examines the way policies and laws perpetuate systemic racism.

The injustice and impact of historical racism will never be resolved if political and religious leaders continue to deny that America has been and continues to be infected by systemic racism.

The denial that America is a racist nation provides a cover for attempting to re-enact a 21st Century version of the Black Codes, Jim Crow, and voter suppression. It also undermines the spiritual solution to the issue of

Greater justice is coming: Taking on abusive and deadly policing with new DOJ leadership

Thanks to the voters who elected President Joe Biden and Vice President Kamala Harris, we now have a Department of Justice that actually cares about justice.

And I am not just talking about justice as an idea. I am talking about a Department of Justice that is willing to take on abusive policing and law enforcement agencies that are corrupted by racism.

In his first month on the job, U.S. Attorney General Merrick Garland reversed a Trump-era policy that made it harder for the Justice Department to investigate police departments and hold them accountable for violating people's civil rights.

And he was just getting started. In the past few weeks, the Justice Department has announced that it is starting an investigation of the police departments in Minneapolis - where George Floyd was murdered by former officer Derek Chauvin while other officers watched. The Minnesota AFL-CIO has called the city's police union a white supremacist-led organization.

The Justice Department has also launched an investigation of policing practices in Louisville, where Breonna Taylor was shot to death in her own home.

These investigations will look at more than those individual killings. This kind of

"patterns and practices" investigation looks at the big picture to determine whether and how a law enforcement agency is violating people's civil rights. They are a way to evaluate - and do something about - the impact that systemic racism has in a police department and the communities it is supposed to serve.

"Patterns and practices" investigations can lead to consent decrees - agreements that require police departments to change the way they operate, with oversight from the Justice Department to make sure change actually happens.

In the past, Justice Department investigations and consent decrees have been important tools for getting violent police behavior under control and changing abusive cultures in out-of-control departments.

When the Trump administration shut down this kind of investigation, it sent a signal to police departments that the Justice Department would look the other way rather than hold them responsible for misconduct. Of course, Trump himself repeatedly made it clear that he was not opposed to violent policing. In fact, he

encouraged it. President Biden has spoken personally about the importance of ending police violence and reimagining public safety. He has called on Congress to pass the imperfect but important George Floyd Justice in Policing Act.

Another good sign was the announcement that the FBI is doing a civil rights investigation of the killing of Andrew Brown, Jr., who was shot in the back of the head by police in Elizabeth City, North Carolina.

All of these are important steps in protecting Americans, especially Black Americans, from abusive policing.

President Biden has also spoken out against Republicans' racist efforts to pass new voting restrictions in states all over the country. Biden has called those efforts "sick" and we can count on his Justice Department to do what they can to challenge voter suppression - even though right-wing justices on the U.S. Supreme Court have greatly weakened the tools that the Voting Rights Act gave the department to prevent Black voters from having their rights denied.

The Justice Department's Civil Rights Division has just written the Arizona Senate president to raise concerns that a bogus "audit" of ballots from last year's presidential election that is being conducted by private contractors from

the so-called "Stop the Steal" movement could be violating the Voting Rights Act.

There are more signs that we can expect changes at the Justice Department.

Associate Attorney General Vanita Gupta, who was recently confirmed by the U.S. Senate, started her career as a civil rights attorney by winning freedom for dozens of mostly Black people wrongly jailed in a small Texas town.

And the Senate should soon confirm Kristen Clarke to head the civil rights division, where she started her legal career investigating police conduct, hate crimes, and human trafficking.

Together with President Biden and Attorney General Garland, Gupta and Clarke will save lives, defend civil rights, and give millions of Americans hope that greater justice is coming.

The false Republican mantra: "America is not a racist country"

America is not a racist country." This is quickly becoming a Republican mantra. Sen. Tim Scott, the only Black Republican in the Senate, used it in his rebuttal to President Joe Biden's address to the Congress. Sen. Lindsey Graham, the Republican weather vane, echoed him, as did Republicans across the country. Scott went on to accuse Democrats of dividing the country by using race as a "political weapon." This is an old, threadbare rhetorical trick. Racism is not the problem; those protesting discrimination are the problem.

Racist rhetoric and actions like those of Donald Trump aren't dividing us. Those protesting the hatred are doing the dividing. The upside down, inside out duplicity can be traced back through the history of the Republic. Even when the South seceded from the Union to protect slavery, its leaders argued that it was Lincoln who caused the sedition because he wouldn't guarantee the spread of slavery into the new states coming into the union. This dog whistle race-bait politics may be old, but it still has force, so politicians deploy it regularly. So, it is worth taking the question of whether America is a racist country seriously.

A racist nation-state is a

country that enforces racism as a matter of law. Apartheid South Africa was universally condemned as a racist country because apartheid was the law of the land until Nelson Mandela and the African National Congress and allies forced the change in laws and policy. By that standard, the United States began as a racist country. For 246 years, slavery was the law of the land.

The Constitution counted slaves as three-fifths of a person for the purposes of the apportionment. In the 1857 Dred Scott decision, the Supreme Court ruled that African Americans were not and could not ever be citizens of the United States, that blacks were "regarded as beings of an inferior order and...had no rights which the white man was bound to respect."

Much of the wealth of the country - North and South - was built on the backs of the enslaved. (And the country's expansion was built on the slaughter of the land's native peoples.) The Civil War brought an end to slavery and a "second founding" of the Union with the 13th, 14th and 15th

Amendments. Yet by 1896, the former slave owners in the South had taken back power - propelled by the terrorist campaigns of the Ku Klux Klan and others - and made segregation - legalized apartheid - the law of the land. White immigrants had more rights than African-American soldiers. The Supreme Court in Plessy v. Ferguson ratified the injustice of legally enforced segregation.

America was once more a self-declared racist country. It wasn't until 1954 that the Supreme Court in Brown v. Board ruled segregation unconstitutional. It took the Civil Rights Movement to transform the laws - winning the passage of the Civil Rights Act and the Voting Rights Act and extending equal rights under the law to all. At that point, America was no longer an apartheid country by law but it was still a country that had to address the legacy of racism. Inevitably, hundreds of years of legalized racism were institutionalized into the very marrow of the society. African Americans have less wealth because they were deprived of any ability to accumulate wealth for decades.

Blacks were zoned into ghettos, urban areas then deprived of private or public investment. Black unemployment remained about double that of White unemployment. Blacks were and are the last hired in an upturn and the first fired in a

downturn. Our criminal justice system systematically discriminates against African Americans.

This list can go on. Change - reform of the laws and institutions - doesn't come easily. Those with privilege generally don't see the shackles burdening those without. If overt racism is increasingly frowned upon, racist attitudes and assumptions - measuring people by the color of their skin rather than the content of their character - die-hard. Dog whistle politics - stoking of racial fears subtlety or brutally - are still a common currency. For decades, Southern Democrats, barons protecting the white privilege in the South blocked reform. Once Lyndon Johnson joined with Dr. King to lead the Civil Rights Revolution - Republicans took advantage by becoming the party of white sanctuary across the South.

Now that too has become institutionalized, as Republicans in states across the country press reforms designed to suppress the vote of minorities and gerrymander districts to isolate the minority vote.

And not surprisingly, they cynically accuse Democrats and the civil rights movements of our age of using race to divide America. What's increasingly

America is like a person with an addiction who has never acknowledged it.

The foundational principle of Alcoholics Anonymous is that one has to admit that he or she is addicted to alcohol. Step one of the twelve steps members adhere to is honesty. Addicts must take an honest look at themselves - something many of us do not want to do because who we are as opposed to who we would like to think we are, or who we've gotten other people to believe us to be is often painful and humiliating to admit.

To heal, though, addicts must be honest. They must tell the truth.

America has not done that and refuses to do so when it comes to its addiction to white supremacy. As alcohol affects and damages the human body, including and especially the liver which functions to rid our bodies of toxins, white supremacy has affected and damaged the very soul of this country, including its foundation, which is necessary for us to exist.

Even while legislators enact voter suppression laws and anti-riot laws designed to suppress the vote of Black and Brown voters and dissuade them from exercising their First Amendment rights of freedom of speech and assembly, they look this country straight in the face and say that they are not racist.

That is like an alcoholic, drink in hand and already tipsy, saying to the ones who know his or situation that he or she does not have a drinking problem.

America's first illness, as pertains to white supremacy, is not white supremacy itself, but its denial of its existence, and that denial is killing this country, just as alcohol kills the liver.

Sasha Banks, the author of *America, Mine*, wrote in *The Atlantic* that in the fourth grade, as the teacher shared information about American presidents that the students were required to memorize, objected when she lifted Thomas Jefferson up as a paragon of virtue. She raised her hand and said, "Thomas Jefferson had descendants who were black." The teacher was flummoxed and said, "That's not true! How would that be possible?" a question to which Sasha answered, "He had babies with one of his slaves. They said it on BET."

The teacher relaxed, telling Sasha and in fact the entire class that BET (Black Entertainment Television) was not a reliable source of or for information. She concentrated on the word "entertainment" saying that the word meant that anything said on the channel could not be true and said it was unpatriotic to believe such disparaging things about [our] country" (<https://www.theatlantic.com/ideas/archive/2021/05/patriotism-isnt-an-option-for-everyone/618767/>)

White people are quick to say they are not racist and that this is not a racist country. It is appalling that a Black man, Sen. Tim Scott, said that the country is not racist, but it is a fact that some Black people join the denial chorus sung by white people to declare this country racism-free, in spite of the racist practices, policies, and procedures which have been in operation since this country's inception. (<https://www.theguardian.com/news/datablog/2021/may/06/tim-scott-america-racist-data-racial-disparities>)

The fight to keep Black people away from the polls is clearly based on white supremacist beliefs that Black people are not qualified to vote or to govern any entity, local, state, or federal. In the 1898 Wilmington race riot perpetrated by white people, the carefully planned and executed coup was carried out because whites insisted that there would never again in that city be a situation where Black people governed whites. We could go on and on, but everyone knows what I am describing. White Americans will not admit their racism and their complicity in supporting a government which is racist at its core. And every time they deny it, they increase the toxins of racial hatred deeper into the creases of American government. In those creases, where they attempt to hide their contempt for Black people, there is rot and a stench that results from organic material decomposing - and the life of America is in fact organic, filled with living creatures that have depended on this country for their livelihood.

If an alcoholic never admits his or her problem, he or she does not heal. And I am afraid that this country, addicted to white supremacy, is no better off. White people believe this country was formed by white people for white people; some of them are sounding that sentiment out loud now, and I, for one, appreciate the honesty. But there are a whole lot more people who need to step away from their denying protestations, and own the truth - theirs and this country's.

Only then does this country stand a chance of escaping its steady roll toward authoritarianism.

GET THAT DEED AND FLIP THOSE KEYS!

You just got to compromise, that's it

In this current real estate market, as a Realtor, it is very important that I explain clearly to my clients the options they have before them to decide rather buy or continuing to rent. It is clearly a seller's market, and the sellers are the ones in the position to call most of the shots. Rocky Road to economic recovery - even worse for African-Americans

While the economy generated 916,000 jobs in March, it only generated 266,000 in April, essentially slowing the previous month's momentum. Last month, the Biden team was crowing about economic progress. Republicans were suggesting that the economy made so much progress that we don't need the stimulus embodied in the American Families Plan or the American Jobs plan. Biden proposals that will inject \$4 trillion into the economy. Republicans say that unemployed people won't go back to work because they get too much money from unemployment benefits and that there is a "labor shortage."

The Black unemployment rate is 9.7 percent. If there were a labor shortage, it would not be that high. 9.8 million people are officially unemployed, and many don't get unemployment benefits, but if employers think there is a labor shortage, they should pay higher wages. Too many are still paying the minimum \$7.25 wage, and some maneuver to pay even less. They use tactics that require workers to come to work, do some work, then punch in, work a full day, punch out, and then go back to their work station to "clean up." The big box stores are worst at this, but they aren't the only ones.

We have a rocky road to economic recovery. While more than half of all adults have been vaccinated against the coronavirus, many

women remain homebound because more than half of all schools are not yet open. Vaccinations will likely be available for children and teens in the next few months, but some teachers hesitate to return to the classroom until then. When teachers aren't teaching, some moms aren't working. So many women have left the labor market that participation rates are as low as they were in the 1980s. Affordable child care, which is included in Biden's American Families Plan, would make it easier for more women to return to work. Without child care, it's a rocky road to recovery.

Senate Republicans are treating President Biden nearly as severely as they treated President Obama. Senate Minority Leader Mitch McConnell committed to making President Obama a one-term president. He failed, but he behaved like the Last Obstructionist, blocking legislation, court appointments, and more. Last week, he said that "100 percent of our focus is stopping this new administration." His focus is not on economic recovery, infrastructure, or health care. It's on stopping the Biden administration.

McConnell and his cronies claim that the Biden infusion of cash in the economy is inflationary, and prices are, indeed, 2.6 percent higher than they were a year ago. Many of these price hikes result from the pandemic, with supply chain problems part of the reason for higher prices. These issues will

resolve themselves as we return to "normal" and supply chains are strengthened. Senate Republicans are using inflation as a fig leaf; both Treasury Secretary Janet Yellen and Federal Reserve Board Chair Jerome Powell are more concerned with getting people back to work.

If the road to economic recovery is rocky for most, it

is even worse for African Americans who earn just two-thirds of what whites earn and have nearly twice the unemployment as whites (5.3 percent for whites, 9.7 percent for African Americans). While the Biden Administration has spoken of equity issues, there must be a race-specific plan to close these gaps.

The March job creation data was exciting, but it was also impermanent. The April data confirms that two steps forward, one step back, will be the path we are on until there is meaningful structural change. That won't happen when Republicans are 100 percent focused on opposing President Biden.

Some people made money

from the pandemic. Some are no worse off than they were a year ago. But many, especially those at the bottom, continue to suffer. Republican indifference to this hardship illustrates the utter callousness that McConnell and his cronies have for most of their fellow citizens.

100 days of Biden-Harris: \$6 Trillion: Investment or spending?

President Joe Biden and Vice-President Kamala Harris are off to a running start. With more than third of Americans fully vaccinated against the coronavirus, and now potentially more shots than arms, President Biden did what he said he'd do, thus jumpstarting our sluggish economy. Unemployment rates have lowered (although the racial unemployment rate gap remains – that won't disappear in just 100 days). Economic growth at 6.4 percent is at a healthy high, proving that controlling corona is essential to economic health.

However, when asked to provide a letter grade for President Biden, all I could give him was an Incomplete, or perhaps an Incomplete Plus. The plus means that he's moving in the right direction. The Incomplete means just that, incomplete. It means we need more results.

But it occurs to me that I'm not fair, that my expectations may be too high. Through his efforts and those of Vice President Harris, the American Rescue Plan was passed. He has now proposed the American Families Plan and touted it in his speech to the joint houses of Congress on April 28. It provides many features for low and moderate-income working families, including a child and dependent care tax credit, more affordable health insurance, and more paid family and medical leave. It's a good plan, but Republicans have lined up in lockstep to oppose it.

There is likely to be more consensus around infrastructure because our nation's

infrastructure is crumbling. Biden and his team use the term "Build Back Better" to describe the goal of an infrastructure plan, the American Jobs Plan, that will fund jobs both for construction and for the "caretaking" economy, for social service workers, health workers, and others. Republicans prefer the more traditional definition of infrastructure, roads and bridges, bricks and mortar. They forget that people, too, are part of our nation's infrastructure. That's why it is essential that the expansion of educational opportunities is part of the American Families Plan. Free community college. An increased Pell grant. More money for HBCUs and Minority Serving Institutions (MSIs).

These three pieces of legislation cost about \$6 trillion and will add to our national debt. Republicans are balking at the price tag, but they weren't so hesitant when their massive tax cut for corporations added trillions to the national debt. While we don't expect consistency from Republicans, we know they only oppose deficits when they benefit people.

I see the \$6 trillion price tag on the Biden legislation as more of an investment than simple spending. A better-educated workforce earns more money, pays more taxes. A healthier workforce means less absenteeism, more efficiency, and productivity. Quality child care means more women in the workforce — millions of women left in the wake of covid. The investment makes sense to build our labor force back better.

Many have compared President Biden's vision to that of President Franklin Delano

Roosevelt, whose New Deal created jobs, reduced poverty, replaced fraying infrastructure, and more. It has been decades since we've seen this kind of significant investment in infrastructure. Lyndon Baines Johnson focused on the human infrastructure, but no one has done so since. Republican Presidents have been disinclined, and Democratic Presidents have

either been too moderate or too timid (Obama) to push hard for their vision. I think one of the benefits of Biden's Presidency was the time he spent with President Obama, observing what happens when you don't go big enough.

Biden has a big vision, and now he has a big job getting others to buy into it. There are Republican governors and mayors who would benefit

from infrastructure improvements. There are Republican college presidents who know the value of more Pell grant money. These are the Republicans who must pressure their senators to support the Biden legislation.

The first 100 days of Biden have been a stark difference from the previous president. It's not just what Biden says, but the way he says it. He

doesn't bark, although he can be emphatic. He doesn't call names or use epithets. He listens. My grade for Biden's first 100 days stands – Incomplete Plus. It means moving in the right direction. Thanks for the vision, President Biden.

A WORD FROM THE LORD

The vocational prayer clinic- Part 1

And it came to pass, that, as he was praying in a certain place, when he ceased, one of his disciples said unto him, Lord, teach us to pray, as John also taught his disciples.² And he said unto them, When ye pray say,

The purpose of the vocational prayer clinic is to do a practical study of prayer through actual self-participation in prayer so that the Word of God will become a reality in our lives through practice. The vocational prayer clinic is designed with a specific goal in mind; first, to teach the "simplicity of prayer" as Jesus taught His disciples. Secondly, to define prayer based upon the word of God.

Simplicity means the condition or quality of being simple, which is having or composed of one thing or part only (the word of God), without additions or modifications; without embellishment; not ornate or adorned, not elaborate, elegant, or luxurious.

What is described in our definition is what prayer should be, simplistic, but oftentimes we do the opposite and call it prayer. In other words, what is

being described as not being prayer is exactly what we do and call prayer. For instance, embellish means to make beautiful, as by ornamentation. What comes to mind is my own prayer life or lack of it. I was never taught how to pray according to scripture and the people who I modeled my prayer life after, had not been taught properly either. So it was a unlearned (ignorant) learning from the unlearned (ignorant).

My prayers were designed to sound good, with feeling or with great emotions and great intensity. It was made to sound embellish or beautiful, elaborate, and adorned by people and not God.

I was also taught that prayer was the sincere desire of the heart. Well, I've learned in life that it does matter how sincere you are, if you do not know how to do a thing, sincerity does not matter without knowl-

edge of how to do it. You can't do what you don't know. Notice the term "without embellishment."

Jesus describes this kind of praying in the gospel of Matthew, chapter 6:5, 7:8a: And when thou prayest, thou shalt not be as the hypocrites are: for they love to pray to stand in the synagogues and the corners of the streets, that they may be seen of men. Verily I say unto you, they have their own reward. But when ye pray, use not vain repetitions, as the heathen do: for they think that they shall be heard for their much speaking. Be not ye, therefore, like unto them:

These verses describe the kind of prayers we pray and the kind we hear being prayed in our churches. Jesus says to us, do not pray to be seen or heard of men nor use vain repetitions.

I remember being unintentionally set up by the people in the church with their compliments, saying, "I enjoyed your prayer" or the expression, "many you prayed today". I was praying one of those decorated, beautified, good-sounding, emotional, high volume, and entertaining prayers. Very

soon, without recognizing it I was praying to be heard and complimented or congratulated by those persons who were in attendance. When they came and said, "man you prayed today" or "I enjoyed that prayer" that was the answer to my prayer. The majority of prayers we hear being prayed in our churches today are to entertain those persons in the pews and not to get an answer from God.

The God kind of prayer, which is described and is rooted in 2 chronicles 7:14-15: "If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land. Now mine eyes shall be open, and mine ears attend unto the prayer that is made in this place."

This kind of prayer has been so ignored, neglected, abandoned, or forsaken that it has died in many churches and replace with some form of entertainment or activity. Prayer is what I call the vocation, livelihood, or profession of the church. Prayers also like the

power line that brings the electrical current into your home whereby all your appliances and electrical equipment function. The God kind of prayer, keep us the church connected to the power source, God, so that the gifts of the Holy Spirit can be manifested in and through the church. Without prayer, the church cannot function properly because prayer is a relationship function.

Prayer as our vocation or livelihood is our regular occupation or profession (prayer), especially one for which a person (Christian) is especially suited or qualified through training. Livelihood refers to that which provides the necessities of the church.

Psalms 145:18-19. "The Lord is nigh unto all them that call upon him, to all that call upon him in truth. He will fulfill the desire of them that fear him: he also will hear their cry, and will save them."

Welding was my occupation or profession. I took vocational training in high school for four years, which included carpentry, auto mechanics, and welding. I then attended the community college for one year; being taught the principles of welding.

Part of that training in welding included practice to develop that skill. I also attended Newport News Shipbuilders Dry Dock Welding School and graduated as a certified welder. It was with this company that I began my vocation or profession as a welder. I needed to become proficient as a welder because that proficiency would determine my preparedness for growth and advancement in that field. Welding became my livelihood whereby I supported my family. The extent of my preparedness would determine the level of advancement I could achieve. Most family spends thousands of dollars to train and educate the children for their vocation or profession over a period of several years.

That they may be able to provide for themselves or for their families. Father, I pray in the name of Jesus that we will be taught how to pray the prayer of faith. So you can answer our prayer. Amen.

Pervis Staples, Co-Founder of Rock and Roll Hall of Fame Inductees*A Member of The Staple Singers, Passes Away at the Age of 85*SPECIAL TO

Pervis Staples, a co-founding member of the legendary gospel group, The Staple Singers, passed away suddenly on May 6, 2021 at his home in Dolton, Illinois according to Adam Ayers, a member of Mavis Staples' 525 Worldwide Music management team. He was 85 years old. Beginning in 1956 with "Uncloudy Day" on Chicago's Vee Jay Record label and stretching into the early 1980s, the Staple Singers were one of the most influential acts in gospel, soul, and social protest music. Their signature songs such as "Uncloudy Day," "Why Am I Treated So Bad," "Respect Yourself" and "I'll Take You There" are hailed as soul music masterpieces.

Pervis Staples was born November 18, 1935 in Drew, Mississippi. His family moved to Chicago for economic opportunities, and he was raised on the city's Southside where his guitar-playing father, Roebuck "Pop" Staples, started teaching his children gospel songs to entertain them and occupy their time. Eventually, word spread throughout the Chicago church community about the singing family, and they cut their first recordings for a local label, United Records. However, it's when they started recording for Vee Jay Records that they gained a national following with rootsy songs such as "So Soon," "If I Could Hear My Mother Pray Again," "Will the Circle Be Unbroken," and "Uncloudy Day" - which has been reported to have sold a million copies.

The early Staples sound was constructed around Pop Staples' lute tenor and his understated, blues-influenced guitar playing. Surrounding it, was his teenaged daughter,

family became fast friends with folk artists like Bob Dylan on the festival circuit. Pervis and Dylan were close. In Kot's book, Pervis recalled Dylan showing him the song, "A Hard Rain's Gonna Fall" at the President Hotel in 1962. He lobbied Pop Staples to let the family record it. He did and it was done as a duet between Mavis and Pervis for the 1966 LP This Little Light of Mine (Epic Records). Although Mavis opened the song, Pervis led the bulk of it in a smooth, mellow, and commanding voice that was reminiscent of his father's but uniquely his own. Another stand-out solo for Pervis was his lead on The Staple Singers' remake of Hank Williams' 1952 cut, "Be Careful of the Stones You Throw," on their 1965 LP, Amen (Epic Records). Underneath a gentle southern-blues melody, Pervis recites the song in a pleasing tone as his sisters provide urgently earnest background vocals for

the morality tale about a young girl who is killed saving the child of a woman who had gossiped about her.

Pervis' last album with The Staple Singers was their first for Stax Records, Soul Folks in Action (Stax Records), in 1968. The album featured new songs such as "The Ghetto" and their interpretations of tunes like Otis Redding's "Sittin' On The Dock of the Bay" and The Band's "The Weight." In Kot's book, Steve Cropper, an iconic session musician at Stax Records, credited Pervis with helping him with production on the album. "If I had an idea, he would work with the girls and stretch the idea," he said. "He would become the band leader, work with them over and over. Every idea wouldn't work right away, so he'd work on it until they got it right."

Pervis is also featured on duets with Carla Thomas on their 1965 LP, Amen (Epic Records). Underneath a gentle southern-blues melody, Pervis recites the song in a pleasing tone as his sisters provide urgently earnest background vocals for

My Soul" for the LP Boy Meets Girl (Stax Records), in 1969. He also appeared on the all-star, "Soul-A-luja," track that featured Stax artists such as Johnnie Taylor, William Bell, and Mavis Staples. It's during this period that Pervis left the group to begin managing another Chicago act, The Hutchinson Sunbeams, who later became known as The Emotions. He was involved with several business ventures, including Perv's House, a successful nightclub that was one of the most popular nightlife spots on the south side in the 1970s.

The Staple Singers were awarded the Rhythm & Blues Foundation's Pioneer Award in 1992. They were inducted into the Rock and Roll Hall of Fame in 1998 and earned a Grammy Lifetime Achievement Award in 2005. They were also inducted into the Nashville-based Gospel Music Hall of Fame in 2018. "Pervis was one of a kind

comical and downright fly," Mavis Staples recalls. "He would want to be remembered as an upright man, always willing to help and encourage others. He was one of the good guys and will live on as a true Chicago legend."

Staples was preceded in death by his parents, Roebuck and Oceola; three sisters, Cynthia, Cleotha, and Yvonne. He is survived by his sister, Mavis Staples. He also leaves six children: Gwen Staples, Beverly Staples, Perlita (George) Sanders, Pervis Roe Staples, Paris Staples, Eala Yvonne (Michael) Sams; seven grandchildren, and seven great-grandchildren.

Pervis Staples' funeral services will be held Monday, May 17, 2021 in the King's Chapel at Leak & Son's Funeral Homes, 7838 South Cottage Grove Avenue, Chicago, IL 60619 - (773) 846-6567. The wake is 10 AM and the funeral is 11 AM.

PGA Tour announces partnership with NNPA on National Golf Day

Diversity, Equity, and Inclusion was a prime focus during the 2021 National Golf Day event held virtually on Monday, May 10.

We Are Golf, a coalition of the game's leading associations and industry partners, usually hosts the event in Washington, D.C., with industry leaders, members of Congress, the Executive branch, and federal agencies.

Because of the pandemic, this year's event occurred virtually.

The biggest announcement came during the first hour when Neera Shetty, the Senior Vice President and Deputy General Counsel at the PGA Tour, announced that the organization is entering a relationship with the National Newspaper Publishers Association (NNPA), the trade association that represents the Black Press of America.

"The Tour has entered into a relationship with the NNPA, which has an outreach to over 230 publications that reach Black and African American audiences, and we are planning to leverage that," Shetty proclaimed.

"I think that what we're seeing now, which is different, is just that everybody is coming together and really putting some passion and thought into how we can work collaboratively to try to overcome some of the past issues and really move forward in this area."

While National Golf Day celebrates the sport's more than \$84.1 billion annual charitable impact and its environmental and fitness benefits, the event kicked off with a panel discussion on Diversity, Equity, and Inclusion.

"Equity is fair treatment, access, and opportunity for advancement and recognizing there are barriers but working to overcome them," she explained.

"Inclusion is about creating that environment because you want to make sure that individuals and groups not only feel welcome and supported, but that they belong."

Cross offered that it is critical golf embraces diversity, equity, and inclusion.

"We have to understand that what and the why before we collectively, as an industry, can move to the how," Cross said.

"How do we operationalize diversity and inclusion?"

The PGA Tour has worked diligently over the years to diversify the sport on all levels.

The PGA Tour currently has a 10-year and \$100 million commitment to support racial equity and inclusion," Shetty remarked.

It has highlighted through video and social media individuals like Cameron Champ, one of just a handful of Black pro golfers.

In December, the PGA Tour made a \$500,000 donation to five Historically Black Colleges and Universities, including \$100,000 to Prairie View A&M's men's and women's golf teams.

The PGA Tour made the Prairie View A&M donation in the name of Champ's grandfather, Mack, who wanted to attend Prairie View A&M but went into the military instead.

The PGA Tour also made \$100,000 donations to Delaware State's women's golf team, Tennessee State's men's and women's teams,

Wilberforce University's men's and women's teams, and the Bowie State Golf Classic, an annual fundraiser for the school's athletic department.

Augusta National also announced two Lee Elder scholarships for the men's and women's teams at Paine College, an HBCU in Augusta, Georgia.

"We know we have a lot of work that we are planning to do and will do to make sure that we address [diversity,

equity, and inclusion] as an industry," Shetty remarked.

White House COVID-19 Response Team and the Black Press

Misinformation and disinformation are the primary drivers for vaccine hesitancy in African American and Latino neighborhoods.

Still, individuals should cautiously seek trusted voices in their respective communities who only present life-saving facts.

That is the message from two of the nation's leading physicians, who are members of the White House COVID-19 Response Team.

In a special live interview with the National Newspaper Publishers Association (NNPA), Dr. Marcella Nunez-Smith and Dr. Cameron Webb extolled the importance of everyone getting fully vaccinated.

They told NNPA President and CEO Dr. Benjamin F. Chavis Jr., NNPA Chair Karen Carter Richards, and other members of the Black Press, that the Biden-Harris administration is not only meeting – but exceeding – expectations of making vaccines available to all communities.

"We see misinformation all of the time and folks ask questions that are rooted in disinformation," declared Dr. Webb, the senior policy advisor for COVID-19 equity and a physician and professor at the University of Virginia.

"As it gets spread from person to person, from family to friend to friend, it's so important for the Black Press to tell the story of what is happening on the ground. Grandmothers can spend time with their grandchildren

again. These vaccines are a key path to get back to normal life. Science bears out that these vaccines are safe. The real risk is COVID-19, the virus, not the vaccine."

President Biden recently announced a goal of vaccinating at least 70 percent of the adult U.S. population by July 4.

With more than 105 million fully vaccinated to date, the goal is viewed by many as well within reach.

"Ultimately, we're trying to get everyone vaccinated who are medically able to," stated Dr. Nunez-Smith, the director of the White House's COVID-19 Equity Task Force and associate professor of internal medicine, public health, and management at Yale University.

"What I stress is that this has to be a community-level goal, too," she said. "It's about getting everyone in our social network, our community, vaccinated."

Dr. Webb pointed to each of the three vaccines – Pfizer, Moderna, and Johnson & Johnson. He said each has proven safe.

"They work a little different, but each teaches your body how to recognize the threat of COVID-19," Dr. Webb noted.

"[The vaccines] are not giving you the virus. It's teaching your body how to recognize the bad guy – the virus. We have great data, and before they ever made it to market, over 75,000 people went through clinical trials and over 10 percent were Black, and in one trial, over 20 percent were Latino. We have 105 million people vaccinated, and the data we have tells us that it is safe."

Part of the vaccine hesitancy lies in the belief that vaccinations had become politicized,

and many did not have confidence in the review process, Nunez-Smith remarked.

"Those processes are transparent, and we should have high confidence," she demanded. "There is diverse representation in the trials and the scientists who were a part of the review process."

Dr. Nunez-Smith also referred to the "rigorous" systems behind the surveillance of the vaccines.

"When we talk about the Johnson & Johnson vaccine, one of the takeaways is that it strengthened my confidence in how the surveillance works," she said.

"Almost 8 million doses were administered, but they found those six cases of blood clots, and the Centers for Disease Control and Prevention paused it to review the data and to figure out how to treat the blood clots and to let the people know what symptoms might present. No steps were skipped."

As for the number of minorities receiving the vaccine, the task force members said the numbers are grossly misreported.

"We do have an idea how many Black people have received the vaccine," Dr. Webb responded.

"The reporting shows that a little less than 9 percent where we know their ethnicity are Black, 12 percent are Hispanic. However, there is a lot of missing data. For about 40 percent of the shots in the arms, we don't know the ethnicity or race because it hasn't always been required data. We have been working closely with states on that."

Dr. Webb concluded:

"We also can look by zip codes and the concentration of

communities of color. We know we still have work to do and ground to make up, but in terms of precise numbers, we still have missing data."

NNPA's chairwoman of the board, Karen Carter Richards, stated that she's looking forward to working with the White House to continue providing accurate information about the vaccines to communities of color.

"The Black Press is the trusted voice of the Black community," the chair declared. "In fact, in many communities we are the mainstream press, and we
