GENERAL EXHIBITION RULES AND REGULATIONS

Deadline for livestock (Open Dairy Cows) entries July 1st. See Dept. 10 for entry dates for 4-H and FFA.

Pre-registered general entries must be received by July 15th.

Please look over your fair book. We have added some new classes and deleted some from different departments. If you are a livestock exhibitor, please take note of the pass system this year

1. PRE-REGISTRATION IS STRONGLY ENCOURAGED

(\$1.00 entry fee per exhibit) If you bring items on the day of registration you will be charged a \$0.50 service fee for each entry. Blank forms for entry are located in the back of this book, or if needed will be furnished by the Fair upon application. They are to be filled out by the exhibitors, giving: the name of the exhibitor, address, class department, and description of the articles or animal. ONE EXHIBITOR NUMBER is assigned to be used by the exhibitor in any or all departments entered. The Fair Association will prepare a separate entry tag to be attached to each exhibit. All general entries must be brought to the fairgrounds and taken to the appropriate department(s) on Saturday July 31st between 11 A.M. and 4 P.M. (See Fair Schedule or Dept. 10 for times of 4-H and FFA livestock entries.) No exceptions made.

2. All general exhibits must be removed from the fairgrounds between 11 A.M. and 2 P.M. on Sunday, August 8th. Any article not removed by 2 P.M. will become the property of the Fair to dispose of as deemed fit. If you would like your vegetables or fruits back, please make note on your exhibit form or be at the fairgrounds by 10 A.M. on August 8th.

3. All exhibits, unless otherwise stated, must be on display for the duration of the Fair. Any exhibits removed before being instructed by the Department Superintendent will forfeit their premiums.

4. Every care will be taken to protect the animals, food or articles exhibited from injury, but the Association will not in any way hold itself responsible for accidents, loss or damage by fire or theft or whatever may be the cause of the damage or loss sustained.

5. No one article may receive two premiums. No entry for the same article will be made in more than one department. Every entry must have a number to correspond to the number in the premium list. (EXCEPTION: Department 10, 4-H and FFA exhibitors may also enter their animals only, in the open class if they pay the ENTRY FEE.)

6. The Fair Board of Directors reserves the right to exclude from the grounds any article obnoxious, offensive, objectionable or repulsive in character. The Fair Board also reserves the right to remove an article that has been erected without their knowledge. These rules are established to ensure that the articles exhibited at the Schuylkill County Fair are suitable for a family audience.

7. Articles exhibited, whether edible or not, must be respected as private property. Any person detected purloining or injuring them will be dealt with according to the law.

8. In cases where there is no competition, judges may give an award such as they deem the exhibit worthy to receive. The same rule applies where there are fewer entries in any class than the number of premiums offered. The judges may, at their discretion, award a prize or prizes of such grade as the exhibit deserves.

9. The Fair will award premiums according to the lists printed in each Department.

10. The Fair Association reserves the right to limit the number of entries. ENTRIES CANNOT BE CHANGED AFTER THE CLOSING DATE.

11. Refunds of entry fees will only be made for exhibits that were pre-registered for Departments 13, 14, and 17 but which were not suitable for display at Fair time due to no fault of the exhibitor. Refunds will be made only on entry day.

12. One exhibit entry per class per exhibitor.

13. No classes will be added to the various departments.

14. In order to properly control security and maintain order during overnight hours of the Fair, anyone wishing to remain overnight to be with their exhibits (animals and midway) MUST register at the Fair Office and indicate the nights they intend to remain. Anyone not registered with the Office by 8:00 PM will be asked by security to leave the grounds. Also, anyone not abiding with the overnight superintendent's regulations or the security officers will be asked to leave the grounds.

15. If there are any questions regarding entry of exhibits to the Fair, all questions are to be directed to the appropriate superintendents, whose telephone numbers are listed with each department.

16. All entry fees are \$1.00 (late entry fee \$1.50) unless otherwise stated.

18. UNLESS OTHERWISE STATED, PREMIUMS WILL BE AWARDED AS FOLLOWS:

1ST- \$5.00, 2ND-\$3.00 3RD- \$2.00

ADVICE TO EXHIBITORS

1. Make your entries early, either in person or by mail, and take your exhibits to the grounds at the time designated in the rules. Please do not remove them until the close of the Fair.

2. Upon your arrival at the grounds with stock or other articles for exhibition, inquire for the Superintendent of the department in which you are an exhibitor. They will direct you to the stall or space your stock or exhibits are to occupy.

3. Entries must be made in the name of a bona-fide owner. Violation of this rule will result in forfeiture.

4. If you desire any information in regards to the business of the exhibition, go to the Superintendent of the department in which you are an exhibitor and they will gladly give you all the information needed.

5. The Superintendent in charge of the department will deal with false representation, interference or unsportsmanlike conduct by an exhibitor or their agent, where the exhibit is entered. There will be no appeal of this decision.

6. Protests awards must be in writing indicating the reason. The protest must be filed with the Fair Secretary not later than the day after the award is made. Persons submitting a protest will be granted a hearing, if deemed necessary, by the Schuylkill County Fair Board of Directors.

7. If any exhibitor or their representative interferes with the judges or shows disrespect to them, or the Fair, the Board may withhold from the exhibitor any premiums that may have been awarded or take any other steps deemed appropriate up to and including expulsion from contest and removal from the grounds.

8. Department Superintendents MAY enter exhibits in their own departments, but neither they nor any other exhibitor may communicate with the judges during the time of determining the awards, except to answer questions posed by the judges. 9. By following these suggestions you will save yourself much disappointment and trouble. You will go home with a better feeling by making friends and by having contributed to the enjoyment of others.

10. Plan now for next year's Schuylkill County Fair. If you are planning to exhibit or would like to show animals at the next Fair you should plan early.

ADDITIONAL RULES CONCERNING LIVESTOCK 1. Do not expect bedding to be provided. Exhibitors should expect to furnish grain, hay, bedding, and care for animals.

 Pets are not permitted on the grounds except for those that are part of an approved exhibit or display; this does not apply to service or therapeutic animals.
 All livestock offered for show must have been the property of the exhibitor for a period of not less than 30 days. 4-H and FFA rules may be more stringent. Check with your Educator or Advisor.

4. ***PASSES: Passes will no longer be mailed to the exhibitor! Each exhibitor is responsible to locate either the livestock or dairy Superintendent when they check in fair week. The Superintendent will provide the exhibitor and their family with individual and vehicle passes. Each Livestock exhibitor will be issued 1 exhibitor pass/ wristband with 2 additional exhibitor passes/ wristbands per family and 2 parking passes per family. Additional passes can be purchased at the Fair office at the cost of \$10 per week for a person pass and \$20 per week for a parking pass. Holders of livestock passes will be admitted ONLY through the livestock gate. Livestock passes/wristband must be in exhibitor or exhibitor helpers' possession at all times. Superintendents, Security and Fair Board members have a right to ask to see the pass and it must be produced without delay. If an individual is not in possession of their credentials and they are not easily producible, the individual will be escorted to the main entrance gate to pay regular admission price to the fairgrounds. All vehicles entering through the livestock gate must have a vehicle pass. Each and every occupant in the vehicle must have a personal livestock pass/wristband. Any occupants of the vehicle who are not properly credentialed will be asked to vacate the vehicle at the checkpoint and will be sent to the main entrance to pay regular admission to the fairgrounds. All livestock exhibitor vehicles will be requested to park in the livestock parking area. In an effort to alleviate crowding in the parking area, all livestock haulers being left at the grounds during the Fair will be required to park in the expanded livestock parking area near the Museum. No haulers will be permitted to park in the Livestock parking/camping lot. 5. Any neglect of an animal or animals during the week of the fair can result in an exhibitor not receiving a premium check. This will be left up to the

discretion of the Superintendents. 6. CVI must be on the fairgrounds while the animal resides on the facility. Must be dated after May 1st. Download a copy of the official PDA document at <u>www.agriculture.pa.gov</u> Search using "fair animal health rules"

The Pennsylvania Department of Agriculture recommends that animals returning home from fairs and shows be isolated from other members of the herd or flock for a minimum of three weeks to help prevent the spread of disease and recommends that exhibitors of all animals discuss the health of their animals, including vaccine recommendations, with a veterinarian on a regular basis.

The following Animal Owner or Caretaker's Verification of Veterinarian-Client-Patient Relationship (VCPR) statement for the animals being exhibited must be included with a signature line on the fair registration form: I attest and affirm that a "veterinary client-patient relationship" – as that phrase is defined in the Animal Exhibition Sanitation Law found at 3 Pa.C.S.A. § 2501 et seq. and any amendments thereto – exists with regard to any animals I will be exhibiting.

Section 8 EQUINE

In order to show, animals must have proof of negative Coggins test dated within 12 months of date of show and proof of rabies inoculation dated within 12 months of show. **No exceptions!**

A Certificate of Veterinary Inspection (CVI) issued after May 1st, 2021 is required.

Helmets must be worn by anyone under the age 18.

Appropriate attire required. No tank tops allowed. The show committee and/or Schuylkill County Fair reserves the right to cancel or combine any classes.

All participants will be required to complete an acknowledgement of risk waiver and release form. Youth requires a parent's signature.

1. No dogs, alcohol or unsportsmanlike behavior allowed.

2. Bridle Wild 4-H Horse Club, Schuylkill County 4-H and the Schuylkill County Fair Association is not responsible for injury to horse, rider or stolen articles.

All protest or discrepancies should be taken to the secretary's stand. The show judge has the final decision.
 Dollar bareback riders must use a \$1.00 bill. Winner will receive all \$1.00 bills from all entrants.

5.Entrants in the lead line may not cross enter into any other class. Riders under 4 years of age must have a side walker.

6.Entrants in walk/trot may not cross enter into any other canter classes.

7.Open equals open to any age level and may not cross enter into walk/trot or lead line.

Section 1 DAIRY CATTLE

1. Exhibitors will be expected to display or parade their animals as directed by the Superintendent; to accept the stall assigned without controversy and to keep their animals in every way that may serve to increase the educational value of the show.

2. Extra space will not be assigned in the dairy barns for dairy beef animals. Dairy beef exhibits should be housed as designated by the livestock superintendent(s).

3. Exhibitors of livestock must inform themselves as to when their livestock will be judged. Stock must be in the ring promptly on call and a failure to comply with the order renders exhibitors liable to be ruled out of competition.

4. Decorations with ribbons or ornaments previously won by animals at shows will be prohibited until after the animals have been judged in their respective classes by the judges. Exhibitors are encouraged to leave displays intact until after the good housekeeping has been judged on Saturday.

5. Exhibitors must have all the animals listed for competition on the grounds before 1 PM on Monday of Fair Week. All animals shall remain on the grounds until released by the Superintendent. Dairy animals will be released Saturday night at 9 PM.

5.1. Milking animals ONLY will be released after the open dairy show on Friday. Specific timing and details will be posted at the fair on Monday of fair week. NO trailers are to be moved, and NO loading of animals should occur until after the Supreme Champion selection has been completed. NO heifers are to be removed from the grounds until Saturday night after release by the Superintendent. 6. The exhibitors will be expected to keep the space they occupy in a clean and sanitary condition and to remove all their equipment promptly as the Superintendent may direct. After removing equipment, supplies, animals, etc. at the end of the week, the straw, hay, etc. needs to be removed from the front of the stalls and from the rails. Exhibitors are encouraged to leave displays intact until after good housekeeping has been judged on Saturday.

7. Female dairy animals only will be accepted.

8. All milk from cows housed and milked at the Fair becomes the property of the Fair.

Only one entry per exhibitor in group classes.
 The same owner must own substitute animals. Animal substitutions are allowed up to the close of check-in day.
 The Fair reserves the right to limit the number of entries.

12. Exhibitor's harness must be worn for the show.

13. Show order for Open Dairy Show 2021* Brown Swiss, Ayrshire, Lineback, Jersey, Guernsey, Milking Shorthorn, Lunch/Intermission, Preemie Class, Red & White, Holstein ***Show order subject to change depending on the number of entries in each breed. ***

CVI and registration papers must be presented upon arrival at the fair.

1. 4-H club members must have passed their 5th birthday as of January 1st of the current year and must not have passed their 18th birthday as of January 1st of the current year in order to be members of 4-H. In order to exhibit livestock, dairy or equine animals, members must be between the ages of 8-18 as of January 1st. Members 5-7 should direct their attention to the General 4-H Exhibit section of the 4-H and FFA Department. All members must be registered with the extension office and carrying a 4-H project by March 31st.

The Schuylkill County 4-H Round-Up is held in conjunction with the Schuylkill County Fair. 2. **FFA members** may retain active membership until November 30th, following the fourth national FFA convention after graduation from high school. FFA members must also have completed all required activities and paid dues in order to be eligible to have entries in any areas where they are carrying an approved record book. All entries must have the approval of the respective advisors of the exhibitor. All exhibitors must specify either 4-H or FFA on their entry forms.

RULES

1. Any person wishing to exhibit in this area must meet the above eligibility requirements. 4. All 4-H and FFA animals must arrive before **3 PM Sunday of Fair week**, except beef animals being hauled on a dairy cattle truck. They must be on the fairgrounds no later than 1 PM Monday. You must notify the extension office if you are arriving Monday. There are

unloading times again this year! Animals will be allowed on the fairgrounds between 7 AM-3 PM Saturday. All hogs must arrive on Saturday. Market goats, lambs, steers, rabbits and dairy beef will also be allowed to arrive between 12 Noon-3PM on Sunday. They will also be allowed to arrive only between 11 AM -3 PM on Sunday. If there is a problem with the unloading times, contact the 4-H Coordinator at the Extension Office. The 4-H Coordinator must approve all exceptions. All livestock will be weighed under the supervision of the 4-H Extension Educator and FFA Advisors. ALL ANIMALS MUST BE CLEAN AND PRESENTABLE BEFORE PENNING. ANIMALS MUST BE DRY UPON WEIGH-IN. Market hogs will be weighed upon arrival and unloading on Saturday, July 31st, Market goats and lambs will be weighed at 4PM on Sunday, August 1st. Rabbits will be weighed at 10AM on Monday, August 2nd. Dairy beef and market steers will be weighed at 3 PM on Monday, August 2nd. 5. All 4-H/FFA exhibitors must have their project and

5. All 4-H/FFA exhibitors must have their project and record books up to date through July of the current year in order to exhibit or sell animals at the fair. 4-H club leaders and FFA Advisors will be responsible to check over the project and record books prior to fair week. If the project and record books are not up to date, the exhibitor will not show or sell. If an exhibitor is found not doing his/her own work or is allowing another person to do his/her work, the exhibitor will not be allowed to show or sell.

6. All livestock and dairy members must attend one ethics and quality assurance training annually whether it is in their project county or in another county prior to their Round-up each year. If the member does not, they may not exhibit that year. This is a state 4-H rule, not a county rule.

7. All livestock must show in order to sell at the sale Thursday night of fair week. If an animal cannot walk on its own free will through the sale, it may not be sold. If death occurs between show day and sale day, the animal or products of that animal may not be sold.

8. Market Swine: All overweight and underweight hogs must stay for the week. However, exhibitors may choose to take the hog to a private processing facility (4-H will provide approved processing facilities list) on Sunday, August 8th, or exhibitors may choose to send the hog to the packer for packer value. Exhibitors must notify 4-H/FFA staff of your decision by Saturday, July 31st, 4PM. Additionally, underweight swine may show in the showmanship and fitting divisions. They may not show in weight divisions. For all other livestock other than market swine: If an exhibitor has an overweight animal, the exhibitor can either choose to take the animal home the night of weigh-in or show the animal in the showmanship and fitting division. The animal will not have a market division class and may not compete for champion or reserve. home the night of weigh-in or show the animal in the showmanship and fitting divisions. The animal will not have a market division class and may not compete

for champion or reserve. There is an exception in the dairy beef show, please see the dairy beef section for showmanship and fitting division. However, upon weigh in at the fair, livestock (market steer, hog, goat, lamb and dairy beef) animals will be given a 5-pound weight allowance, under and over the minimum and maximum required weight. As for market meat pens of rabbits, they will be given 4 oz. weight allowance per rabbit. The roaster rabbits will be given an 8 oz. weight allowance. 9. All livestock ear tags naming the farm, sale or origin in which the exhibitor purchased or bred the animal must be removed prior to July 1st. If an exhibitor needs an ear tag or questions this ruling, please contact the extension office for clarification and/or a tag.

10. A code of ethics is in place by the fair for all animal exhibitors. All exhibitors are required to sign the code of ethics and turn it in upon fair check-in. The form may be found in this fair book.

**Due to Covid, there will be mandatory requirements and guidelines that Penn State/4-H, FFA, will be implementing in order to provide a safe and inviting experience for exhibitors and attendees. The requirements and guidelines will be advertised as fair approaches. If you are unable to comply with the instituted requirements or guidelines, you will be unable to participate.

11. Dairy cattle and horses will be released no earlier than <u>Saturday at fair closing</u>. Livestock animals going to private buyers will be released between 8 AM and 11 AM on Sunday. Livestock animals sold to the packer will be loaded on Sunday. It is the responsibility of ALL 4-H/FFA exhibitors to assist with FAIR clean-up on Sunday following animal release.

12. There are three classes for livestock and dairy showmanship. Junior (8-12), Intermediate (13-15), and Senior (16 and up). It is mandatory for the exhibitor to show his/her own animal in the showmanship division. No substitutions will be permitted. There will be only one showmanship and fitting entry per exhibitor per species. 13. There are two fitting classes for livestock.

Intermediate (13-15) and Senior (16 and up). Again, this year, if you are between the ages of 8 and 12 (as of January 1st of the year) you will be competing in a "cleanliness" class for livestock. This class will not be judged on the fitting of the animal, but on how clean the animal is for show.

SECTION 3A DAIRY BEEF FEEDER STEERS

Every effort possible is to be made to properly dehorn the animal as to eliminate occurrence of scurs. These procedures should be completed at about 1 month of age. No clinical signs of castration or dehorning should be visible at fair arrival.

4. All calves must be ear tagged or tattooed by February 10 of the current year.

5. Animals must be an approved 4-H or FFA project.

6. Only one calf may be shown per individual.

7. Calves weighing less than 400 lbs. will not be accepted.

8. Calf must be of one (1) dairy breed- cross breeds of dairy or meat breeds aren't allowed.

9. It is strongly recommended but not required that Holstein calves rather than smaller dairy breeds be used.

10. Show day is Wednesday, August 4, 2021, at 12:30PM

11. The dairy beef project is to be raised, shown, and fitted as a beef animal, not a dairy animal. This is a beef project.

12. The member is to be caring and fitting his/her animal for the duration of the project. Limited assistance will be permitted.

A. Due to large numbers of dairy beef, there will be two dairy beef judges (a type and a showmanship/fitting judge). The judges will judge simultaneous with the exhibitors showing to the type judge. The show and fit judge will determine which exhibitors will come back in for placement in their respective age categories prior to the selection of champion. B. Underweight dairy beef will be shown in their own showmanship and fitting class prior to the first weight division. Should the show/fit judge choose for them to come back, they will come back with the rest of the other dairy beef in their respective age categories prior to the selection of champion.

13. For complete project rules and requirements, participants may contact their club leader or the extension office.

Note: Participants showing dairy beef may tag up to two (2) animals but may only show and sell one at the fair. **Class:** 10000 (Weight divisions will be determined after final weigh-in.)

The Criteria for Judging the Pet class is as follows:

1. Youngsters must bring animals to show tables and handle animals. The judge will observe the animal and owner interaction. A pet will be used to being handled and the exhibitor should handle the animal in the normal manner-I.e. depending on size of exhibitor and animal, animal should be carried similar to a football with feet supported and head tucked under arm. Temperament of animals evaluated. 25 points

2. Condition of animal-Fur is not matted; mange, dirty, excessively stained, Flesh-good flesh, not skin and bone, and the animal looks fed and watered properly. No disease, wounds/sores, Snuffles, wolf teeth, tumors or abscesses or physical deformities 50 points

3. Exhibitors will be asked-age, gender, possible breed identification and variety of the animal. Note: A tie breaker will use the answer the exhibitor gives for the possible breed identification for any ties in the pet class. 20 points

4. Tie breaker-The answer given by the exhibitor to the judge about the possible breed and variety will be used by the judge to see how closely the animal meets the standard as per *The Standards of Perfection.* The animal closest to standard has a higher score. Any ties will use this criterion. 5 points

5. Showmanship for Rabbits and cavies will use PASRBA materials and criteria form given to participants before the exhibitor is judged.

SECTION 8B MASTER LIVESTOCK SHOWMAN CONTEST

The master livestock showman contest is to establish a master showman of livestock.

SECTION 8C RABBIT HOPPING CONTEST

1. Animals entered may be any breed of domestic rabbit, no pedigree is required.

2. Animals must be at least 4 months of age to compete.

3. Rabbits must be healthy and free of any disease or parasite. Any animals found to be in poor health must be removed from the fairgrounds immediately. Health checks should be done prior to any rabbits entering the competition area. This check should include a check for mites, lice, diarrhea, discharge, any open wound, or dirty bottoms, feet, or fur. Nails should be trimmed. If a rabbit has any of these health issues it shall not be allowed in the competition area.

4. Pregnant does are not permitted to compete. In addition, any doe that has had a litter in the past 8 weeks is not permitted to compete.

5. Only approved H-style harnesses are allowed. The H-style harness must have detachments from the neck strap and girth strap and the D-ring must be in the back to ensure the least pressure on the rabbit's neck. No vests, collars, figure 8 harnesses nor harnesses with the metal part at the rabbit's throat area are allowed in the competition

6. Animal handlers will be responsible for cleaning up any debris their animal leaves on the competition course during the competition and in the warm-up area.

7. Careless handling of rabbits will result in a warning. Serious negligent handling will result in a disqualification.

8. Rabbits shall proceed through the course and over the jumps voluntarily. Animal handlers are prohibited from forcing or carrying animals through the course, but may lift them over jumps or obstacles, if necessary. Assistance and encouragement may not involve yelling loudly or any other method that would subject a rabbit to excessive stress. Touching your rabbit with your feet is not permitted.

9. Handlers will not use the leash to hit a rabbit to get it moving or as a means of discipline. Rabbits may not be lifted with the leash.

10. If, in the opinion of the judge, the rabbit becomes lame or the course is too difficult for the rabbit, the rabbit will be disqualified for its safety.

11. Animal handlers must always use good sportsmanship. Violations will result in warnings and disqualification. It is up to the judge's discretion as to what constitutes poor sportsmanship. The judge's decision is final.

12. Only one rabbit is permitted on the course at any time.

13. A familiarization period may be allowed prior to the start of competition. Each rabbit may investigate each obstacle for a brief time. Three attempts may be made at any obstacle. The order of obstacles in this time period shall not be the order used in the competition. This familiarization period shall be supervised by the ring crew.

14. Judges will inspect all equipment prior to the beginning of the show and may modify the requirements to the extent needed to eliminate any unsafe equipment.

15. Animal handlers are not permitted to step over jumps. They must go around the jump. Repeated violations will result in disgualification.

16. Beginning and ending jumps must always be present and are not taken into account on scoring (no faults will be given for displacing rails on these jumps).

17. Any course which is not a straight-line course shall have the obstacles numbered.

18. The final obstacle must be cleared in the right direction for the clock to stop. Once the rabbit has touched all four feet on the ground after clearing the final obstacle the clock is stopped and the course is considered complete.

19. No treats (for you or your rabbit) will be allowed on the hopping course or in the warm-up area.

20. If the rabbit turns and jumps back over the hurdle while competing, the rabbit and handler is disqualified.

21. Leashes, when used, must be held at all times except when going through a tunnel or tire jump (if these obstacles are used). After each tunnel or tire jump, the leash must be picked up before the next obstacle.

22. Rabbits may not be left unattended outside of their carrier or coop. Rabbits may not be tied up with their leash.

23. All contestants will compete in the same level of expertise/experience. The class will consist of:

a. A minimum of 5 jumps to include a start and finish jump.

b. Example: Start Jump -- 6" 8" 10" 8" 6" -- Finish Jump

c. Maximum Height -- 10" Minimum Height -- 6"

d. 5 faults allowed.

e. At least 1 jump must include length (maximum of 10" length).

f. Minimum distance between jumps: 4'

24. The Danish Rabbit Hopping Scorecard shall be used. Contact the Schuylkill County 4-H Office for complete rules and scoring. If two rabbits have the same

number of faults, the rabbit with the faster time is placed higher. In the event of a tie, there shall be one run at a course. This run will determine the winner.

25. The contest will be held at the Rabbit/Horse Barn on Saturday, August 7th, at 9 am. Class:

The certified first-place winner from the Schuylkill County Fair will have the opportunity to enter an apple pie in the Annual Blue Ribbon Apple Pie contest at the 2022 Pennsylvania Farm Show. The Fair will certify the winning apple pie baker. Listed below are the criteria to be used in the contest.

1. Open to any individual who is a PA resident; only one entry per person.

2. To be eligible for the State Contest, entrants may NOT have won 1st Place in this Blue Ribbon Apple Pie contest at any other fair in 2021.

Entry to be a pie that must include at least 60% apples in the filling. It does not need to be a "traditional" two crusted apple pie and it can have a variety of fillings.
 The entire pie must be submitted for judging in a disposable pie pan AND COVERED (All pans, plates and dishes are considered to be disposable and will not be returned.)

5. The recipe for the pie and pie crust must be submitted with the entry. It should be submitted on one side of 8 ½" by 11" paper. 

1. Wines entered for competition in Department 21 must be amateur wine, home produced under regulations of part 540 of the Code of Federal Regulations. No entrant shall be involved with commercial winemaking or use the facilities or products of a commercial winery during any stage of wine preparation and/or storage of the wine.

This is an amateur contest.

An amateur winemaker makes wine either alone or in collaboration with other amateur winemakers. If there is collaboration, all persons involved must be named on the entry form and are considered one entrant. Only one entry (one bottle) per class per entrant. Entries may be distributed among the classes at the discretion of the winemaker or superintendent(s) of Department 21.
 Wines registered and entered for competition in Department 21 will be delivered in accordance with the general rules of the Fair.

4. All wines will be evaluated by a competent judge(s) and will be placed within a class position. Decisions rendered by the head judge will be final.

5. All wines must be produced and bottled by the entrant. Wines produced and bottled may be from any years' grapes, fruit, honey, or other fermentable. **No concentrates or fruit juices.**

6. All wines must be in standard 750 ml. Burgundy, Bordeaux, or Rhine shaped bottles. Screw capped bottles are permitted but will not be accepted if sealed with a cork. Sparkling wines will only be accepted if contained in standard 750 ml. Champagne-type bottle and sealed with a cork or plastic closure secured with the proper safety wire, or a crown cap. Ports and Sherries may be entered in Fortified wine bottles with "T" corks.

- 7. All bottles entered must be labeled as follows: (typed or printed)
- year of fermentation
- name of wine (if applicable)

- if blend, approximate percentage of components NO ENTRANT NAME IS TO BE PLACED ON THE LABEL. THIS IS TO ENSURE FAIRNESS IN JUDGING.
8. Breakage due to incomplete fermentation will not be the responsibility of the Fair.

9. The same vintage may not be entered in subsequent years.

<u>Tractors</u> – Tractors must be model year 1959 or earlier and be wheel driven by the rear wheels only to participate in the antique tractor pull.

Inspection – Tractors will be subject to inspection at any time by the pull committee. Any tractors judged to be unsafe or in violation of the rules will not be allowed to participate in the pull.

Drawbar – The drawbar must be original or Match factory specs with a maximum height of 20". The length of the drawbar must be no less than 18" from the center of the rear axle to the hook point. Drawbar must remain stationary in all directions during pull. Must use a flat plate with 3" hole or twisted clevis only. Farmall tractors must pull from the original drawbar hooked to the original belly hook point.

<u>Weights</u> – Weights may be added to make weight classes.

<u>**Tires and Rims**</u> – Rim diameters may not be larger than factory specs. Pressed steel (tin) wheels allowed on all tractors. Maximum tire size for any class is: 20.8-38.

Tires cannot measure more than 21 inches across tread. No duals are allowed. <u>CUT TIRES ALLOWED IN OPEN</u> <u>CLASS ONLY!</u>

R.P.M. – A maximum of 10% over factory specs <u>ONLY</u> – subject to check at any time. **Antique tractors only will** have a max speed of 3.5mph. There will be two warning horns. If the horn sounds the third time, you will be disqualified. No pace for classics. No duplex carburetors allowed on JD letter series tractors except in open class.

<u>**Classes**</u> – A tractor may pull in two classes, BUT ONLY ONCE IN EACH CLASS. This may be changed at drivers meetings depending on tractor count/weather. Anyone may pull in the 10,500 open class in addition to the two regular classes.

<u>Antique Open</u> – The maximum drawbar height will be 20" with a minimum drawbar length of 18" from the center of the axle to hook point. Cut tires allowed in open class only.

<u>Classic</u> – 1960 to 1972. Factory turbos allowed. All Antique rules apply.

<u>Modern Stock</u> – 1973 to Present. Factory turbos allowed. All antique rules apply.

PULLING COMPETITION RULES

1. All drivers must be 14 years of age or older. All drivers must display the ability to confidently and safely operate the tractor. They must also be able to reach the pedals/controls when sitting normally on the seat. Only drivers are allowed on tractors. No riders!

2. Tractors must be registered at least one hour prior to the pull.

3. The PULL COMMITTEE will hold a safety and procedures meeting prior to the start of the pull. ALL drivers must attend.

4. Tractors must be operated in a safe manner AT ALL TIMES.

5. The order of pull will be determined by drawing at time of sign in.

6. The sled operator has the option to recall the first pull in each class for sled adjustments. The first puller in each class has the option to accept or decline the pull. This decision must be made immediately at the end of the first pull.

7. The driver must start with a tight chain and only after the flagman displays the green flag. Anyone not starting with a tight chain will be disqualified.

8. Speed must be controlled by a hand throttle only. Strings and wires are not allowed. Foot throttles allowed if original factory equipment.

9. Drivers must remain seated and be in full control of the tractor at all times.

10. Tractors losing weights or any other objects while hooked to the sled will be disqualified.

11. Tractors must stay within the pulling track boundaries during the pull. Neither the tractor nor the sled may contact the barriers at any time.

12. If a tractor stops or stalls before the sled passes the 40 foot mark, the driver has the option of restarting the pull or dropping to the end of the class. Sled and tractor will be pulled back to the start point. Full pull lines for the sled will be marked at the end of the track.

13. All tractors must stop pulling upon the RED Flag signal from the Flagman.

14. In the event of cancellation, refunds for any incomplete pulls may be requested up to 30 minutes after cancellation. Otherwise all hook fees will be donated to the Ag Museum.

5. All modified drivers must wear a D.O.T. approved helmet.

6. Competing vehicles may not contain any passenger while on track. DRIVER ONLY!

7. No consumption of alcohol before or during event by driver or crew member. No alcohol is permitted in the pits. If found, you will be immediately disqualified.

8. All drivers and crew members must sign a waiver stating they are competing at their own risk and will not hold any official, promoter, or track owner liable for any reason.

9. All vehicles must be operated in a safe manner at all times especially in the pits Recklessness will not be tolerated and may result in ejection and forfeiture of entry fees and premiums. A five mile per hour speed limit is imposed at all times while on the grounds.

10. Officials reserve the right to change any rule at any time when the primary concern is the safety of the participant(s) and or spectators.

11. All vehicles must drive onto the track, compete, and leave track under their own power unless breakage occurs.

12. Puller is allowed a second attempt if the first attempt does not exceed 75 feet.

13. Test puller may drop their first pull and drop back to the sixth position. If the test puller drops the first run he/she must take their second attempt.

14. ABSOLUTELY NO COMBUSTION

ACCELERATORS ALLOWED. Examples are as follows: nitrous and propane

15. All pulls must start with a tight chain. No shifting standard transmissions and no jerking the sled.

16. All vehicles are subject to technical inspection before any event and at any time during an event as seen fit by an official.

17. No fuel tanks or batteries allowed in the cab of the truck unless factory installed.

18. Hitches will be of sturdy construction with a minimum 3 inch diameter hole at hook point. Hitch will be horizontal to the ground. Hook point may not be more than 26 inches from the ground. (Hitches will be covered in greater detail in each set of class rules.)

19. Engine must be located in a factory location.

20. All tires must be D.O.T. approved with no modification to the tire such as cutting, grooving,

paddles, chains, studs, etc.

21. A driver will be disqualified for losing any weights and will lose any points for that class. All weights must be secured on a weight rack or in the bed of the truck. No weight in the cab.

22. All trucks must be composed of 1 ton or smaller frames. Flat beds are permitted.

23. If there are not enough trucks to fill a class we may combine classes. For example if there are only two or three trucks for the classic gas then they will be asked to run with the stock class.

24. Hand throttles and relocation of parts such as moving the radiator to the bed etc. allowed in all classes except stock classes.

25. If 10% over stock rpm's must have a scatter blanket. 26. ALL DRIVERS MUST BE AT DRIVER'S MEETING. ANY CHANGES DISCUSSED AT THIS MEETING COULD AFFECT YOUR CLASS. NOT BEING PRESENT TO HEAR CHANGES IS NOT THE FAULT OF THE STAFF AND OFFICIALS. ANY ANNOUNCEMENTS MADE AT THE DRIVER'S MEETING THE DAY OF THE EVENT SUPERSEDE ANY WRITTEN MATERIAL.

1. Maximum weight of 6800 Lbs.

 All Trucks must have a minimum of 1 lb. dry charge fire extinguisher mounted within driver's reach.
 Four examples of bolt-on modifications allowed are : Header/Exhaust; Throttle body/Air intake; Visible chip; Cylinder headers.

4. No hanging weights allowed in stock Gas I. All weights must be secured in the bed of the truck. No weight is allowed in the cab. (hanging weights are allowed in stock Gas II)

5. All factory body panels must be in place. This includes a full floor to support the factory payload. You may trim the front fenders and remove front wheel wells for tire clearance. If any interior is removed to make weight, no ballast may be placed anywhere on the vehicle.

6. All factory glass must be in place.

7. Must pull off of a Reese style hitch, bolted to the bottom of the frame rail. Hook point must be rigid in all directions with a minimum 3 ³/₄ inch hole for hook. Hitch must be horizontal to the ground and the hook may not exceed 26 inches in height. Hook point must be the furthest point on the back of the truck.

8. A minimum of 1 inch of suspension travel required. If airbags are installed they cannot be a live system, lines must be unhooked.

9. Tires must be D.O.T. approved with no modifications.

Modified Gas

1. Maximum weight of 6200 lbs.

2.Fully welded suspension or sub frame allowed. 3.Hitch must be of solid construction and rigid in all directions, draw bar style permitted. Hook point must have a 3 ³/₄ inch diameter hole. Hook point cannot be more than 26 inches from the ground, and cannot extend more than 6 inches under the truck. Centerline of the rear axle to hook point must be a minimum of 25% of the vehicle wheelbase.

4. Maximum of one four barrel carburetor or single throttle body or fuel injection, must be naturally aspired. No blower or turbo chargers.

5. All trucks must have a minimum of 1 lb. dry charge fire extinguisher mounted within driver's reach.

6. Must have an operational kill switch mounted within 18 inches of hook point.

7. Mandatory blow proof bell housing or transmission blanket.

8. Trucks may hang weights, but cannot exceed more than 60 inches from the centerline of the front axle. No weights allowed in the cab.

9. If the bed floor and/or tail gate have been removed, they must be covered to contain debris should breakage occur. Canvas covers are acceptable.

10. One scatter shield must be on all universal joints beyond the rear of the transmission and front universal joint at the front differential. Scatter shield must be of a solid construction and be able to contain debris and direct debris toward the ground.

11. One drive shaft loop must be installed on any drive shaft over 36 inches long including those with a carrier bearing.

12. All trucks must have all hubs covered. Covers don't have to be solid, but must be able to contain parts should breakage occur.

13.No injection of combustion accelerators permitted. Examples are nitrous and propane.

14. D.O.T. approved tires only & can be in offset stance.

Work Stock Diesel

1. Truck eligible with a stock OEM turbo. No wheel or internal changes allowed to turbo. Turbo will be checked so all drivers need to prepare to expose inlet.

2. Maximum weight of 8500 lbs.

3. All trucks must have a minimum of 1 lb. dry charge fire extinguisher mounted within driver's reach.

4.No excessive spooling on line. When the green flag comes out and you touch the throttle you have 5 seconds from that point to leave the start line.

5.No hanging weights. All weights must be secured in the bed of the truck. No weight allowed in the cab.

6. All factory body panels must be in place; this includes a full bed floor able to support the factory payload. You may trim the front fenders and remove front wheel wells for the tire clearance. If any interior is removed to make weight, no ballast may be placed anywhere on the vehicle.

7. All factory glass must be in place.

8. Must pull off of a Reese style hitch bolted to the bottom of the frame rail. Hook point must be rigged in all directions with a minimum 3 ³/₄ inch hole for hook. Hitch must be horizontal to the ground and the hook point may not exceed 26 inches in height. Hook point must be the furthest point to the back of the truck.

9. **MUST HAVE STOCK SUSPENSION.** If airbags are installed it can not be a live system and the lines must be unhooked.

10.Tires must be D.O.T. approved with no modifications.

11.No hood stacks. Trucks must be street legal. No state registration required.

12. Pump diesel or Biodiesel only. No injection of any foreign matter such as water, water/meth, propane or nitrous, etc.

13. Cold air intakes, exhaust upgrades, tire upgrade, (but still must be D.O.T. approved) are allowed.

14. No programmers allowed in this class.

Stock Diesel

1.Maximum of 8500 lbs.

2. Suspension may be rigid, but may not be welded solid, must retain factory style spring set up.

3. <u>STOCK APPEARING SINGLE TURBO, UNLESS</u> FACTORY INSTALLED TWINS (EXAMPLE 6.4 POWERSTROKE.)

4. Hitch must be of solid construction and rigid in all directions, draw bar style permitted, hook point must have a 3 ³/₄ inch diameter hole. Hook point cannot be more than 26 inches from ground and cannot extend more than 6 inches under the truck. Centerline of the rear axle to hook point must be a minimum of 25% of the vehicle wheel base.

5. All trucks must have a minimum of 1 lb. dry charge fire extinguisher mounted within driver's reach.

1.Maximum of 8200 lbs.

2. Suspension may be welded solid. This is an open driveline class.

3. MODIFIED TWINS AND BIGGER THAN 2.6 TURBOS ALLOWED.

4. Hitch must be of solid construction and rigid in all directions, draw bar style permitted, hook point must have 3 ³/₄ inch diameter hole. Section 1- BEES, HONEY and WAX

1. Class 1 is to be judged on uniformity of color, bees, presence of queen, brood, and honey, cleanliness and appearance of observation hive.

2. Comb honey to be judged on perfection in filling, capping uniformity, neatness, and cleanliness of section. Entries must be in window cartons, round section lids - both transparent.

3. Extracted honey to be judged on body:

- A. Body.
- B. Flavor (subtract only for off flavor).
- C. Clarity (freedom from granulation).

4. Creamed honey to be judged on fineness of crystals, uniformity and firmness of product cleanliness and freedom from foam. Entries must be in cylindrically uniform, 1 pound glass jars.

5. Chunk honey to be judged on neatness and uniformity of cut, absence of watery capping, uncapped cells and pollen, cleanliness of product. Entries must be in cylindrically uniform, 1 pound class jars.

6. Beeswax to be judged on:

- A. Cleanliness / Purity.
- B. Color and Aroma.
- C. Uniformity of Appearance.
- D. Freedom from Cracks and Shrinkage.
- 7. Identifying labels on the entries are forbidden.

8. All entries must be the product of the entrant's apiary having been produced since the previous Fair and presented by the entrant in person.

9. Classes 2 and 3 are to be presented in 3 circular sections.

10. Classes 4 and 5 are to be presented in 3 sections.

11. Classes 6 and 7 are to be presented in 3 packages of 4 inch squares.

12. Classes 8 through 10 are to be presented in three 1-pound Classic or Queen line jars.

13. Class 13 is to be presented in not less than a 1-pound product.

14. Judges reserve the right to place all entries in the proper class.
