

## NEWS ANALYSIS N.C. GOP declares war on affirmative action and relevant race history

The gloves are now off!

Top N.C. Republicans have now publicly vowed to fight the practices of affirmative action and teaching relevant race history (what they call "critical race theory") in public schools legislatively to ensure that people of color and women are not afforded what the GOP perceives to be any advantage over White citizens.

"Children must learn about our state's racial past and all of its ugliness, from the 1898 Wilmington Massacre to Jim Crow," the conservative *Carolina Journal* online magazine quoted Senate Leader Phil Berger, R-Rockingham, as saying at a news conference July 14, prior to a committee meeting. "But students must not be forced to adopt an ideology that is separate and distinct from history; an ideology that attacks 'the very foundations of the liberal order' and that exalts 'present discrimination' - so long as it's against the right people - as 'antiracist.'

The *Carolina Journal* story continued, "Berger said he opposes Critical Race Theory and 'will combat it with everything that I have because I believe the doctrine undoes the framework that produced the most successful ongoing experiment in self-government in the history of mankind ... whether you acknowledge it or not, this doctrine seeks to recast the foundational principles of American society. We must not let that happen."

North Carolina has now officially jumped onboard the anti-Critical Race Theory train, even though not one public school teaches, or

is slated to teach what, in reality, is a 40-year-old legal term for determining institutional and systematic racism in American society.

That didn't stop Republican N.C. Lt. Gov. Mark Robinson from telling the Senate Education Committee, "I want to make one thing clear: The issue of indoctrination in our classrooms is real. It's not some figment of somebody's imagination. It's happening all across the state, unfortunately."

That committee is working to toughen HB 324, which, if passed, would effectively make it illegal to teach that "one race or sex is inherently superior to the other," or even have discussions about America's racial history because that could be interpreted as "indoctrination."

In effect, Republicans believe that what they call "CRT" would teach White children that they are inherently bad because of how badly their ancestors have historically treated Black people. Apparently, White parents across the nation have that impression and are rising up in arms at local school board meetings, apparently taking the GOP political bait that Democratic liberals are trying to miseducate their children.

Last week, a New Hanover County Public School Board meeting had to be halted because "concerned" White parents demanded that CRT not be taught.

Sen. Berger has cited both Durham and Charlotte, where public school leadership have respectively welcomed a more accurate teaching of America's racial history, as examples of exactly what he vows to fight "...with everything I have."

NC Democrats, as best as they can, aren't having it.

"If we want to learn from history, then we need to teach history, all of it, the good and the bad," N.C. Senate Democratic Leader, Dan Blue (D-Wake), wrote in a July 14 tweet. "When we exclude the hard parts, we are doing a disservice to our students and our country," he continued. Sen. Blue's Democratic colleagues agree.

"HB 324 would limit teachers' and students' ability to have crucial conversations that address the systematic inequities in the United States that persist today," say NC Senate Democrats.

"I fear that what it really does away with is critical thinking in the classroom," said Sen. Jay Chaudhuri (D-Wake).

But Democrats in the State Senate and House are in the minority, so unless Gov. Cooper can veto the HB 324, it will become law.

Not willing to pass up a golden political opportunity when they see it in the leadup to the crucial 2022 midterm elections, N.C. Senate Republicans are moving to place a constitutional amendment on the ballot to ban affirmative action in the State, and that's something Gov. Cooper cannot veto.

If passed, that would prohibit North Carolina colleges and universities from using race as key factors in admissions and employment from using it in hiring.

Thus, Senate Bill 729 "...would prohibit discrimination against or preferential treatment toward 'any individual or group on the basis of race, sex, color, ethnicity, or national origin in the operation of public employment, public education, or public contracting.'

Currently, race is allowed to be a factor in North Carolina university admissions.

night. The main concern was that without clarification, students of color, special needs students and others will be abused by law enforcement. Even though the new version of Policy 5120 reportedly suggests that parents will be called, there was still concern by community activists that the language is still not clear enough before it is adopted.

"This policy has to be changed and the parents should be present when law enforcement talks to their children even if it's as a witness or interrogation of any form or fashion. I want people to understand that we have to stand up for our children and be the voice for our children," said Sonya Patrick, local leader of Black Lives Matter.

**NHC SCHOOL BOARD  
 MEETING HELD  
 REMOTELY AFTER  
 PREVIOUS OUTBURST**

[WILMINGTON] After last week's New Hanover County Public School Board meeting was disrupted by people speaking out of turn, and angry parents yelling about the possibility of Critical Race Theory being taught, the board decided to complete the meeting by Zoom this week to forestall any other disruptions. The board even had speakers who were properly signed up last week but not heard tape what they had to say.

School Board Chair Stephanie Adams chided those who disrupted last week's live meeting, one that she did not attend. Adams maintained that disruptions

cannot be tolerated.

**STUDENTS WILL STILL  
 HAVE TO WEAR MASKS;  
 NEW SOCIAL STUDIES  
 CURRICULUM ADOPTED**

[WILMINGTON] Many parents believe that with the threat of the COVID-19 pandemic waning, their children should not have to wear protective masks to school. Tuesday evening, the NHC Public School Board maintained that the state still requires children's faces to be covered while they're in class.

Meanwhile NHC Public Schools will adopt the new NC Social Studies Standards for this fall, which are designed to dive deeper into "underrepresented voices" throughout history, and challenge all

students to learn more about the impact of slavery and the civil rights movement, but challenge them to better understand these events through critical thinking and discussion.

NHC Public Schools Supt. Dr. Charles Foust assured the public that what has been labeled as "Critical Race Theory"-- a 40-year-old law school lesson--is not part of the curriculum. "Is there reference of slavery in history? Yes. Is there reference of injustices in the history books? Yes. Are we teaching critical race theory as it's written at the collegiate level and at when you are getting your JD? No."

# Top Biden advisor says president always has Black community on his mind

(TriceEdneyWire.com) Cedric Richmond, senior advisor to President Joseph Biden and former chair of the Congressional Black Caucus, says he never has to bring up the needs of African-Americans in his conversations with Biden because he usually gets to it first.

"I don't have to bring it up because he brings it up and the vice president brings it up. They are very intentional," Richmond said in an interview with the Trice Edney News Wire. "And you have a president who talked about racial equity in his inaugural address; that talked about it in his joint address to Congress. So, just like he talks about it in front of the camera, he talks about it in the back of the camera."

In the exclusive interview the day after Richmond attended a meeting between Black civil rights leaders, President Biden and Vice President Kamala Harris, Richmond listed a host of examples of how the President is targeting and specifically addressing issues that directly and often disproportionately affect Black people.

**On Voting Rights:**

He said he thought the meeting with civil rights leaders that largely focused on voting rights legislation now before Congress "was a great meeting."

Richmond said, "Our African-American civil rights leaders were very succinct and clear in their assessment of where we are and what people in the community are saying what they need that they need to hear what they need to see, how we need to help educate them, how we need to help motivate them to get past this while we fight it in the courts and in the halls of Congress. So, it was good," he said. "The president listened. He talked to them about what he saw, what he wants to do."

President Biden has tapped Vice President Harris to lead the Administration's efforts on voting rights "because it's so important," Richmond said. "He reauthorized the Voting Rights Act himself while he was in Congress and got every senator to vote for it."

According to Richmond, the leaders were on one accord in the White House meeting, acknowledging Biden's past record on voting rights. "But they also articulated the challenges that we face now with these real threats to democracy. And this is not hyperbole, this is not exaggeration, but when you have people saying that the legislature will decide who won an election, that is dangerous. It really puts our democracy at risk."

**On Gun Violence:**

It was about a year ago that

Biden announced his "Build Back Better" campaign, focusing on issues across the board as he ran for President. Now, seven months into his administration, he is facing some unexpected crisis; including a rise in gun violence in most major cities.

Richmond says Biden believes his addressing economic and social issues across the board in Black and other communities will impact crime as well as targeting the dissemination of guns.

"I think if you're going to deal with violence and gun violence in any community, especially in the Black community, you have to invest in the community - period. So, we're giving money that can be used in technology such as gun spotter programs," he said. "I think the President says the idle mind is the devil's playground. So, we have to give our kids something productive to do. So, summer jobs reduce the likelihood of kids dropping out of school; also, after school programs. We have to invest in our families and that's how we look at it. At the same time, we do have to look at where these guns are coming from. So, DOJ [Department of Justice] has announced that ATF [Bureau of Alcohol, Tobacco, Firearms and Explosives] is going to go after these rogue gun dealers that are flooding our streets with guns."

Richmond says it takes a "very comprehensive approach" to deal with crime and violence in the streets. That includes investments in families, youth, and cities, he says.

"What we also did was we gave money to cities and now we just went back and gave them new guidance that says, 'Look, you can take that money that we gave you, you can invest in community violence intervention. So those interceptors to make sure that we stop crime before it happens. We want you to invest in summer jobs programs for our young people. We want you to invest in after school and recreational programs. We came up with a really comprehensive way to invest in communities to help them - through economics and other means, technology and others - to fight this rising gun violence that we see."

**On COVID 19:**

According to the Centers for Disease Control and Prevention, African-Americans, at the height of the pandemic, were nearly three times more likely than White Americans to be hospitalized with COVID and about twice as likely to die from it.

Richmond said the struggle for racial equity in the fight against the pandemic was in access to the vaccines.

"So, you saw us come in quickly to get equity in the vac-

cine distributions. We did community health centers; we did our own vaccination centers; we did mobile vaccination centers.

**Poverty, Economics and  
 Racial Wealth Disparities:**

Vaccines without economic relief would not have begun full recovery from the effects of the Coronavirus Pandemic, Richmond said.

"So, we gave out \$1,400 checks to 168 and a half million households. Then, we increased the child tax credit and made it half refundable and paid it out in monthly installments," he recounted. "And so, starting July 15, Black children and their parents, all children and their parents, they're going to start receiving a check for \$250 for every child that they have under the age of 18, per month. And every child under 7, they will get \$300 a month. We figure that families shouldn't have to wait until the end of the year. That there are bills that become due every month and that we should help them," he said. "That's going to reduce Black child poverty in half. This year, it's going to reduce poverty in the Black community - period - by 30 percent some numbers say. So, that's what we did."

**HBCUs:**

Richmond indicated that among Biden's proudest achievements thus far has been funding for Historically Black Colleges and Universities.

"We gave HBCUs a historic amount of funds - \$4.2 million - \$1.6 million debt forgiveness and \$2.6 million direct aid - to help them through the pandemic. So, we're doing a number of things to be very intentional about making sure the interests of African-Americans are being met."

**Black Wealth**

Still, the wealth gap between Black and White Americans is "staggering" according to the Brookings Institute. A Brookings report says the net

worth of a typical White family is nearly 10 times greater than that of a Black family.

Richmond says Biden has been on top of the leading wealth creators in the Black community - entrepreneurship and homeownership.

"We talk about both of those, and we act on both of those," he said. "The plan is to put \$35 billion more in the SBA [Small Business Administration] to help with the small, Black disadvantaged businesses, help them with access to capital, we're pushing the private sector and the federal government to provide access to contracts; so, we're going to go from 10 percent to 15 percent, which is \$100 billion over five years," he said.

"As for homeownership,

we've directed the secretary of HUD, Marcia Fudge, to root out systemic barriers and racism in housing policy. For example, the president specifically called out appraisals and other redlining where two homes in two different neighborhoods - one Black and one White - are worth different amounts simply because of where they are.

"So, we are going to tackle all of those things. We're going to help people buy a home because we know that that is the sound way to pass wealth off from generation to generation. And we're going to make sure that we invest in building those affordable homes that people can buy. So, we have a really all hands-on deck comprehensive approach to dealing with it all."

# As lawsuit in Andrew Brown, Jr. case filed, Republicans want to toughen bodycam law

It was three months ago this week, on April 21, when Pasquotank Sheriff's deputies fatally shot an unarmed Andrew Brown, Jr., 42, in front of his Elizabeth City home as they were serving a warrant for his arrest.

The three deputies responsible have not been criminally charged, but last week, the Brown estate filed a \$30 million federal lawsuit against Dare County Sheriff Doug Doughtie, Pasquotank County Sheriff Tommy Wooten, and the seven Pasquotank deputies involved. Reportedly, Dare County law enforcement worked with Pasquotank authorities in identifying Brown per the outstanding warrant.

Meanwhile, three months after the fatal shooting, none of the sheriff's deputies' bodycam footage of the killing has been officially released to the family or the media by a judge, as has been demanded by the family and protesters.

Now there's word that Republican lawmakers want to actually make it tougher for the families of police shooting victims or the media to obtain law enforcement bodycam footage in a timely manner after an incident. Currently, only a judge can release the footage.

In May, a bipartisan group of senators sought to rewrite the law so the families could have access within five days,

unless law enforcement can show why that should not be the case. However, now, thanks to lobbying by the North Carolina Sheriffs' Association, the families would not have automatic access to the bodycam. A

judge would be the sole arbiter of who sees the footage and when.

The new proposed version, Senate Bill 300, also would not prohibit those who see the bodycam footage from describing what they saw, but it would criminally punish anyone who made an unauthorized copy, and then publicly released it.

SB 300 was passed by the Senate and is currently in the State House Rules Committee.

In the \$30 million lawsuit, filed by Andrew Brown, Jr.'s estate against the Dare and Pasquotank County Sheriff's Departments, it contends that Brown's constitutional rights were violated when deputies used unlawful deadly force as he drove away in an attempt to flee upon their arrival. The suit continues that there was no evidence of Brown posing a threat as he was unarmed, and thus, his was a "wrongful death" and "battery and assault."

The lawsuit also seeks the full public release of all bodycam footage of the Brown fatal shooting.

Some of that footage was displayed by Pasquotank District Attorney Andrew Womble during a May press conference wherein he announced that he would not criminally charge three of the seven county deputies for firing into Brown's vehicle.

Andrew Brown, Jr. was killed when one of the bullets fired by deputies at his moving vehicle struck him in the back of his head.



#### Please run for school board

Critical race theory (CRT) asserts that racism is woven into the very fabric of our nation's institutions. This is not new information for those who have studied how race affects our economy, politics, education, health care, and more. CRT is not an attempt to "blame" white America for its origins as much as it is a pedagogical approach to reality. Through critical race theory, we can see the many ways that the uneven application of laws allowed envious white people to destroy Tulsa's Black Wall Street, colonizers to gentrify Black neighborhoods, doctors to experiment on Black people and more. CRT helps us understand how California stole parts of Mexico, Chinese people were imported here (without wives or families) to build railroads, and how our Constitution defined black folks as fractions of people.

Attorney and Professor Derrick Bell (1930-2011) wrote about the many ways our racist gendered patriarch systematically oppressed Black people and others at the periphery. He used both legal theory and fiction to amplify his points. Critical race theory has been taught in our nation's colleges and universities, and especially in our law schools, for decades. Now white legislators are passing laws in several states to outlaw the teaching of CRT because it hits too close to home.

Much of this legislation demonstrates how ignorant some of these legislators are. It also illustrates how heated the battle for fact and knowledge is. Some think the South won the Civil War, which they describe as the war of "Northern Aggression". Though the statues are coming down, there are still those who believe those statues were erected for heroism, not resistance to equality. And every time you see a Confederate flag flying, you must know that those stars and bars were only added to state flags after Brown V. Board of Education became law, and white Southerners wanted to communicate their allegiance to racism.

The legislators who oppose CRT also oppose knowledge. Now, their fearlessly foolish conservative leaders are urging them to "take over" the schools by running for school boards around the country. Rich Lowry, the National Review Editor, wrote a piece, "The Point of the Anti-CRT Fight Should Be To Take Over The Schools" (<https://www.nationalreview.com/2021/07/the-point-of-the-anti-crt-fight-should-be-to-take-over-the-schools/>). What he means is to take over young people's brains. Lowry is smart enough to know that the historical whitewash conservatives are attempting cannot withstand historical scrutiny. So he and his conservative minions would instead inject their ideology into our schools, using low-turnout, low-budget races to grab power.

Roland S. Martin deserves credit for lifting this. He has been looking at the damage school boards do for years. He says, and Lowry echoes, the power school boards have. To choose book vendors. To shape the curriculum. To select teachers and trainers. The anti-CRT crowd would shut this down. But we also shut ourselves down when we get stuck at the top of the ballot. It is essential to choose a President and Vice-President, a Senator and Congressperson, and it is equally important to select a zoning commissioner or a school board member. Rich Lowry's piece makes it clear and makes it plain. He says that "education is too important to be left to educators." He wants rabid (he didn't say white, but I will) parents to run for school boards and to use their passion to lock knowledge out.

So this is my plea to woke, progressive Black folk. Please run for school board. There are tens of thousands of Black women who have retired from education. Would you please run for the school board? There are young people of color who understand the flaws in the education that was delivered to them. Please run for school board. There are entrepreneurs who decry the inadequate education that so many young people bring when they apply for new jobs. Please run for school board.

Many of these posts can be won with a few hundred votes and a few thousand dollars. The right-wing has their marching orders. We need to have ours, too. We can serve our communities and our nation by standing up for knowledge. Please run for school board.

According to results from a new Commonwealth Fund survey, Americans who have suffered the most during the COVID-19 pandemic are also the most likely saddled with medical bill problems and debt.

The Commonwealth Fund, a foundation that promotes a high-performing health care system that achieves better access and improved quality, noted that adults ages 19 to 64 contracted the virus, lost income, or lost their job-based health insurance coverage.

Those individuals also reported higher rates of medical bills and debt problems than people not affected by the pandemic in those ways.

Researchers found those who lost income experienced medical bill problems at the highest rates, especially those who also tested positive or became sick with COVID-19 or lost coverage.

The report revealed that Black and Latinx adults "face the greatest financial challenges from chronic lack of affordable health care, even as the pandemic eases and more gain insurance coverage."

More than half (55 percent) of Black and nearly half (44 percent) of Latinx/Hispanic adults said they had medical bill problems and debt, compared to one-third (32 percent) of white adults.

Overall, one-third of U.S. adults said their income fell during the pandemic, but Black, Latinx/Hispanic, and low-income adults were particularly hard hit, the report continued.

Forty-four percent of Black adults and 45 percent of Latinx/Hispanic adults reported a loss of income.

Insured and uninsured adults alike struggle to pay their medical bills, but those without coverage face more significant challenges.

More than one-third of insured adults and half of uninsured adults said they had a medical bill problem or were paying off medical debt.

One-third (34 percent) of working-

age adults with employer coverage reported medical bill or debt problems, as did nearly half (46 percent) of adults with individual and marketplace coverage.

Relatively few adults lost job-based health insurance coverage during the pandemic. However, many of those who did were left exposed to health care costs, researchers wrote.

The survey, which took place between March 9 and June 8, revealed that just 6 percent of working-age adults lost job-based coverage — whether through their job or that of a spouse, partner, or parent — since the pandemic began.

Of those individuals, 67 percent gained coverage elsewhere.

Just over half (54 percent) of people who lost coverage through their job and did not get COBRA were without coverage for three months or less.

About 30 percent did not gain

insurance until four to 11 months later, and 16 percent were uninsured for longer than a year.

An estimated 10 percent of working-age adults were uninsured during the first half of 2021 — a smaller share than 2020 estimates from federal and private surveys.

The survey findings suggest that more people have gained insurance than lost it since the pandemic began.

Federal efforts to help people maintain their Medicaid coverage, combined with state and federal efforts to encourage people to enroll in the Affordable Care Act (ACA) marketplaces and Medicaid, have increased enrollment in both.

The researchers determined that medical debt leaves people with lingering financial problems.

Thirty-five percent said they had used up most or all their savings to pay their bills.

Forty-three percent had received a lower credit rating because of their medical debt.

More than one-quarter (27 percent) were unable to pay for basic necessities such as food, heat, or rent.

The authors noted several policy options they said could alleviate medical bills and debt problems and provide relief, including making the temporary American Rescue Plan marketplace subsidies permanent.

That could reduce the number of uninsured by 4.2 million in 2022, the researchers said.

They also suggested providing Medicaid-eligible adults in the 13 states that have not yet expanded their program a fed-

eral insurance option to cover an estimated 2.3 million uninsured.

Reigning in deductibles and out-of-pocket costs in marketplace plans with new subsidies and rules also should help, they said.

More individuals with unaffordable or skimpy employer plans should be allowed to enroll in marketplace plans, the Commonwealth Fund researchers stated.

"Although the survey indicates improvement in insurance coverage during the pandemic, it also shows that health insurance in America is not protective enough," stated Dr. Sara R. Collins, the lead author and Commonwealth Fund Vice President for Health Care Coverage, Access, and Tracking.

"The persistent coverage inadequacy and vulnerability among U.S. working-age adults is compromising their ability to get the care they need and leaving many with medical debt at a moment when they should be recovering after months of financial insecurity."

Dr. David Blumenthal, the president of the Commonwealth Fund, remarked that people struggled with inadequate health coverage and mounting debt before the pandemic.

"Now, the administration and Congress have an opportunity to ensure not only that all U.S. residents have health insurance but that the coverage is affordable and comprehensive," Dr. Blumenthal declared.

Interim President of the Leadership Conference on Civil and Human Rights; Damon Hewitt, President and Executive Director of the Lawyers' Committee for Civil Rights Under Law; Sherrilyn Ifill, President and Director-Counsel of the NAACP Legal Defense Fund; Derrick Johnson, President and CEO of the NAACP; and Reverend Al Sharpton, President of the National Action Network.

I was grateful for the opportunity to impress upon the President and Vice President the urgency of confronting the wave of anti-voter legislation that is surging through state legislatures. When we look at what is happening in this nation, we see an effort to impose a system of American apartheid on our grand and glorious multicultural nation.

State laws are used to suppress the vote, the filibuster process is used to obstruct Congressional oversight, the courts are used to undercut the Voting Rights Act, all to subvert the democratic process and overturn the will of the people.

We look forward to continuing the discussion and holding the President and Vice President to their commitments.



## Delta variant now makes up 83 percent of all U.S. COVID cases



The delta variant of the coronavirus now accounts for roughly 83 percent of all U.S. COVID-19 cases, Centers for Disease Control and Prevention Director Dr. Rochelle Walensky announced on Tuesday, July 20.

The delta variant of the coronavirus now accounts for roughly 83 percent of all U.S. COVID-19 cases, Centers for Disease Control and Prevention Director Dr. Rochelle Walensky announced on Tuesday, July 20.

"The best way to prevent the spread of COVID-19 variants is to prevent the spread of disease, and vaccination is the most powerful tool we have," Dr. Walensky asserted during a U.S. Senate hearing.

On July 3, the CDC noted that the delta variant accounted for about half of U.S. COVID cases.

That number has dramatically increased.

The latest delta surge also has led to increases in hospitalizations and deaths, Dr. Walensky stated.

She remarked that deaths have risen by about 48 percent over the past week, and the U.S. now averages 239 COVID-related fatalities each day.

Dr. Walensky insisted that the surge could have been prevented.

"Each death is tragic and even more heartbreaking when we know that the majority of these deaths could be prevented with a simple, safe, available vaccine," she demanded.

About two-thirds of U.S. counties have vaccinated less than 40 percent of their residents. That has allowed for the emergence and rapid spread of the highly transmissible delta variant," Dr. Walensky continued.

President Joe Biden previously set a vaccination goal of reaching 70 percent of eligible adults by July 4, but the U.S. fell short.

Medical experts have warned that the delta variant is highly contagious and easily transmitted compared to other strains.

"The reason it's so formidable is the fact that it has the capability of transmitting efficiently from human to human in an extraordinary manner, well beyond any of the other variants that we've experienced, up to now," Dr. Anthony Fauci, the White House's chief medical

advisor, said during the Senate hearing.

Dr. Ebony J. Hilton, the medical director for GoodStock Consulting, LLC, and Associate Professor, Anesthesiology and Critical Care Medicine at the University of Virginia, repeatedly warned that the combination of vaccine hesitancy, the refusal to wear masks, and the delta variant would create the perfect storm for a worsening pandemic.

Expressly, Dr. Hilton has noted that Covid-19 deaths in predominately White communities have continued to rise at dramatic rates.

She said the snapshot provides a glimpse into just how bad the pandemic remains in African American neighborhoods.

"We see the disparity starting to close, but not because Black people are dying less, it's because white people are dying more," Dr. Hilton remarked.

"Between February and March, 58,000 White Americans died of COVID, and it's largely because of the 'I don't want to wear a mask,' crowd."

Dr. Hilton concluded that all should strongly consider getting vaccinated, and everyone should continue wearing masks.

"People are dying today, and they are likely leaving behind orphans," Dr. Hilton determined.

"We know that one in 9 Black children were already likely to see foster care in their lifetime. Because of COVID, imagine how many now if we are not taking it seriously and not getting vaccinated? It is not worth the risk. We have an agent, an intervention that has been proven safe, and it works."

Dr. Hilton concluded:

"Look at the studies. We have 77 percent of people saying that they are not fully back to being themselves after they have experienced COVID."

"They have brain fog and other problems. It is not worth the risk, especially when we think about how the Delta variant has shown to be more contagious and more transmissible for our younger generation. We are setting ourselves up for a crisis."






