





A BETTER LIFE FOR ALL

I see growth coming to Brunswick County. There are new houses everywhere, even where there were none before, areas which used to be forests, but there are housing developments.

There is less farming; there are no more commercial fishing boats; there are just a few shrimp boats. This industry used to make up a third of the jobs in this County.

There is growth in facilities for the aged (elder care homes), but there are no industries of

Is House Bill 324, the "Ensuring Dignity and Nondiscrimination [in] Schools" Act, better known as the "anti-Critical Race Theory" bill, really about protecting students from "radical" racial distortions of American history and preventing "an individual solely by virtue of his or her race or sex, [from feeling] discomfort, guilt, anguish, or any other form of psychological distress" from what they learn or discuss?

Or is the measure really a Republican attempt to officially rewrite American and North Carolina history so that the truth about slavery, the '60's civil rights movement, the Wilmington 1898 Race Massacre, and even, eventually, the January 6, 2021 siege of the U. S. Capitol be whitewashed and covered up?

Several students, teachers and North Carolina lawmakers took part in last Friday's special statewide webinar, *Digging Deeper: A Conversation on the Impact of HB 324 on Students, Educators and Classrooms.*

Sponsored by the nonpartisan Public Schools Forum of N. C., the 90-minute virtual discussion focused on the controversial bill that is currently being debated in the N. C. General Assembly, and its ramifications, if passed.

Participants offered their perspectives and, for the most part, made it clear that restricting what social studies and literature teachers can instruct about fact-based American history, in addition to openly and freely discussing that knowledge, only hurts students, not "protects" them.

KaLa Keaton, is an 18 year old African-American student who graduated from Wake County's Middle Creek High School in June and will be attending Yale University in the fall.

She said that, thanks to her African-American literature instructor, Mr. Matthew Scialdone, she not only learned about North Carolina's history of lynching, a word she said she'd never heard in prior classes, despite North Carolina being one of the top 12 states in the country for it, the State's eugenics

program, the Wilmington 1898 Race Massacre and other important episodes of North Carolina history, but was intrigued enough to follow up on her own and learn more.

That junior year class was optional, she noted, but she considers it "essential" learning.

"I learned historical points in those classes I never heard in other classrooms," Ms. Keaton continued. "The point of these classes and culturally responsive curricula is not to sit and wallow in oppression, struggle and negative energy, and then we're off to second period math."

"There was never a day when I felt the weight of the world was on my shoulders," concluded Keaton, who added that as a result, activism has become a critical part of her life because what she learned was "solution-oriented."

In other words, having been taught that history usually repeats itself, Ms. Keaton believes knowing the problems and conflicts of history better helps to make sure that those problems and conflicts are better addressed in the future before they manifest themselves.

Keaton later shared the experience of being the target of racism, sometimes being the only Black student in her predominately White classes, and wondered why no one ever thought to pass a law to protect students like her from the hurtful racism that she faced.

Abby Rogers, another former Middle Creek High School student who will be attending UNC at Chapel Hill in the fall, talked about the value of being a White student who took an African-American history class, being in the minority in the class, and "...being allowed to understand perspectives that I otherwise would never have been exposed to."

Matthew Scialdone, KaLa Keaton's teacher from Middle Creek High, made the point that if students of color are experiencing racism in the classroom, then White students are certainly emotionally strong enough to learn about it, and why it happens.

"The concept that discomfort should be removed from the educational process, to me, that is the moment where the most educational growth happens," Scialdone, a White teacher who has been in the classroom for twenty years, said, dispelling the stated Republican belief that White students would be emotionally crushed learning the truth about this nation's racial history.

Rodney Pierce, a Black social studies teacher from Nash County, offered that if HB 324 is passed, then it might become against the law for him to share actual historical documents with his students where White leaders spoke out against the rights of "the Negro," let alone lead movements against them.

Pierce explained that such historical documents and speeches are key to understanding what prompted the Civil War or the Confederacy.

HB324 did have at least one defender during the webinar. State Representative John Torbett (R-Gaston County), a primary sponsor of the bill, said "...I support almost everything I'm hearing."

Representative Torbett, who is actually from Tennessee, added that contrary to the problem teacher Rodney Pierce presented, the bill would not prohibit the use of historical documents or quotes in the classroom that deal with racial statements made by historical figures.

"Don't read past the language of the law," Torbett cautioned. "We're simply [against] promoting things that are bad for the future of the State and the future of this country," Torbett said, later adding that he had no problem teaching about the bad things of the past, as long as the good things were also taught.

Thus, Torbett said, he had no problem with school children's learning about the 1961 Greensboro lunch counter sit-ins, remarking that the closer that history was for students to learn about, the better.

Critics note that HB324 is so broadly written, that, if White parents wanted to challenge a teacher for focusing on the issues surrounding the Greensboro sit-ins, they could legally do so if they felt their children were negatively affected by that instruction and subsequent discussion.

Lt. Governor Robinson's hypocrisy on COVID-19 vaccine

It is rare, but on this issue, North Carolina Lt. Governor Rohinson Mark а Republican, is on the opposite side of several of his party's top leadership. Saying that "individual liberty" is how North Carolinians should navigate the COVID-19 pandemic, Robinson, during his August 2 weekly videoed "Monday Monologue" on Facebook and in earlier public appearances, maintained that "it should be left up to individuals if they want to wear masks" or receive the COVID-19 vaccines.

"It is not my job, as an elected official, to convince anyone to take the vaccine, coerce anyone to take the vaccine, or dissuade anyone from taking the vaccine," he said. Robinson's controversial remarks are in direct contradiction to the efforts of Governor Roy Cooper and North Carolina health officials to convince as many of the unvaccinated as possible to "get the shot" in an effort to stem further spread of the new Delta variant amongst those who have chosen not to be vaccinated.

The Black Republican lieutenant governor then virtually capped his remarks by saving that his only role is to provide the necessary information about the vaccine to North Carolinians "...to make that informed decision, along with your health care provider, and then make sure that, if you want the vaccine, you can get the vaccine..." Robinson won plenty of plaudits and kudos from Facebook followers of his video post, but what they didn't hear there is what he told the conservative Wake County Taxpayers Association during their July 29 monthly meeting at N.C. State's McKimmon Center in Raleigh, where Robinson indeed tried to dissuade the audience from considering taking the vaccine, telling them he's spoken with medical personnel who are against it. "I know cardiologists, neurologists, ...I know podiatrists, Ι know urologists...None of them want the vaccine" a video of Robinson's remarks show him saying. "The highest ranking Republican in North Carolina State government is irresponsibly endangering human lives and needs to stop," wrote columnist Rob Schofield in the August 6 edition of NC Policywatch about hypocritical Robinson's remarks. What really riled the Black conservative's critics was his declaration that any elected official who pushes people "...to take the vaccine should be voted out of office! It is not your job to convince anybody to take that vaccine. That's not your job," he added. Lt. Governor Robinson's admonition to fellow elected officials that "It's not your job

to convince anybody to take that [COVD-19] vaccine" flies in the face of documented and disturbing numbers showing that North Carolina's coronavirus cases are dramatically going back up, primarily in counties across the State that are the least vaccinated. His remarks also fly in the face of top Republicans in the State and the nation who have recently been urging their constituencies to get the shot to be better protected against serious coronavirus infection and, possibly, death.

"As you know, the Delta variant of COVID-19 is more contagious than earlier strains, and it's important to make sure we all take care of ourselves and others," U. S. Senator Thom Tillis (R-NC) said in an August 2 statement. "If you have any questions or concerns, please talk with your doctor about the vaccine....It is safe and effective and our best tool at beating this virus." Indeed, Senator Tillis himself contracted the coronavirus last year. Unlike his former State House colleague, Republican NC House Speaker Tim Moore straddled the fence in his recommendation. "I have personally been vaccinated against COVID-19, and I have done my best to help educate the public and urge others to get vaccinated if they choose to do so," Moore said in a July


And then there is Congressman Madison Cawthorn (R-NC-11), who spoke at a recent Buncombe County School Board meeting, telling officials there that "forcing our children to wear a mask is nothing short of psychological child abuse... period." Cawthorn made his remarks after the board voted to require students and school staffs to wear protective masks during the upcoming school year. Fact is, a recent national

poll by Monmouth University shows that 31% of self-identified Republicans say they "will likely never get vaccinated against COVID-19," despite growing evidence that the new Delta variant is more dangerous.

In recent weeks local school boards, depending on the level of vaccinations in their respective county, either have mandated masks for students and personnel for the upcoming school year, or not. Many local governments have mandated protective masks for anyone entering their government buildings.

Many large businesses have also required not only masks again for customers to enter, but some are leaning towards requiring people to show proof of vaccination as well, something at which civil libertarians cringe.



Bi-partisan infrastructure deal brings long-awaited justice to Black America, White House says

(TriceEdneyWire.com) - As America continues to await the signage of President Biden's \$1.2 trillion Bi-partisan Infrastructure deal, White House officials say African-Americans and other people of color will benefit vastly from the bill which is set to pour billions of dollars into urban and rural communities.

"The infrastructure bill is a bill for all Americans. It's about better roads and bridges; it's about expansion of commuter rail and public transportation. That's one area that lots of communities of color are cut away from - the job centers of their states and their areas," said U. S. Department of Labor Secretary Martin J. Walsh in an interview with the Trice Edney News Wire. "So, it's an opportunity for us to do better connectivity there."

In addition to years of neglect in Black communities, Walsh said the bill will intentionally work to help undo much of the recent economic, educational, and quality of life damages to communities resulting from the COVID-19 pandemic.

"During the pandemic; particularly communities of color; the Black community; when kids were learning from home, they weren't connected to the internet; they weren't connected to WIFI," Walsh said.

The President's infrastructure bill will bring "broadband to all of America - rural America, urban America, poorer communities in our country," he said. "And it tackles the environment - [bringing] new buses, clean buses. Many of the buses that go through our communities of color now in our country are diesel buses. Pollution is higher, the asthma rates are higher. This is no secret; we know that."

Walsh concludes, "There's lots of great investment in this bill for the Black community in this country; but also, for the entire community quite honestly."

Meanwhile, as 10 senators who negotiated the bi-partisan bill are jointly protecting it from sabotage before Biden gets to sign it, the White House has listed a string of benefits and opportunities that the bill will provide to African-Americans and other communities of color. A White-house issued document; titled, "Bipartisan Infrastructure Deal: Advancing Economic and Public Health Opportunities for Communities of Color", says "The bipartisan infrastructure agreement will grow the economy, enhance our competitiveness, and make our economy more sustainable, resilient, and just."

It continues, "The agreement will also create good-paying, union jobs. With the remainder of the President's Build Back Better Agenda, these investments will add, on average, around 2 million jobs per year over the course of the decade, while accelerating America's path to full employment and increasing labor force participation."

According to the White House document, the bipartisan infrastructure deal:

•"Addresses economic disparities in our economy and the consequences of decades of disinvestment in America's infrastructure that have fallen most heavily on communities of color. Through critical investments, the Bipartisan Infrastructure deal increases access to good-paying jobs, affordable high-speed internet, reliable public transit, clean drinking water and other resources to ensure communities of color get a fair shot at the American dream...These critical investments are first steps in advancing equity and racial justice throughout our economy. The President believes additional investments are needed in our nation's caregiving infrastructure, housing supply, regional development, and workforce development programs to ensure that communities of color and other underserved communities can access economic opportunity and justice...And, earlier this summer in Tulsa, OK, President Biden announced a whole-of-government effort to increase the share of federal contracts going to small, disadvantaged businesses by 50 percent over the next five years, leveraging the government's purchasing power to help more Americans realize their entrepreneurial dreams."

• "Delivers high speed internet to every American household. There is a digital divide in America. Black families are 9% less likely to have high-speed internet than their white peers, and Latino Americans are 15% less likely."

• "Ensures every American has access to reliable high-speed internet with an historic investment in broadband infrastructure deployment, just as the federal government made a historic effort to provide electricity to every American nearly one hundred years ago. This includes a \$2 billion investment in broadband in Tribal communities which were hit particularly hard by the COVID-19 pandemic."

• "Helps lower prices for internet service by requiring funding recipients to offer a low-cost affordable plan, by creating price transparency and helping families comparison shop, and by boosting competition in areas where existing providers aren't providing adequate service."

• "Helps close the digital divide by passing the Digital Equity

Act, ending digital redlining, creating a permanent program to help more low-income households access the internet, and establishing a new program to help low-income households obtain the devices required to access the internet."

• "Makes the largest investment in clean drinking water in American history, replacing all of the nation's lead pipes and service lines. From rural towns to struggling cities, the deal invests in water infrastructure across America, including in Tribal Nations and disadvantaged communities that need it most."

• "Invests in more public transit options and addressing the backlog of repairs. Asian American and African American workers commute by public transit at nearly 4 times the rate of white workers. For example, low-wage Black residents in Chicago spend 70 additional minutes commuting to work than their white peers. In New York City, the average Black resident spends 110 minutes more per week commuting to work than the average white resident. The Framework's historic investment in public transit - the largest federal investment in history - will reduce commute times and create more economic opportunities in communities of color."

• "Creates a first-ever program to reconnect communities divided by inequitable transportation infrastructure. Significant portions of the interstate highway system were built through Black neighborhoods, destroying homes, schools, churches, and parks, and causing lasting disconnection and disinvestment for residents who stayed. More broadly, historic investments in transportation infrastructure, especially highway construction, cut too many Americans off from opportunity, dividing and demolishing communities, and perpetuating economic and racial injustices."

• "Electrifies school buses, improving the air quality for children. The deal will make a critical down payment on helping the more than 25 million children and thousands of bus drivers who breathe polluted air on their rides to and from school. Diesel air pollution is linked to asthma and other health problems that hurt our communities and cause students to miss school, particularly in communities of color and Tribal communities."

• "Remediates Brownfield and Superfund sites. Across America, 26% of Black Americans and 29% of Hispanic Americans live within 3 miles of a Superfund site, a higher percentage than for the overall population. Proximity to a Superfund site can lead to elevated levels of lead in children's blood. Recent studies demonstrate that cleaning up these sites can lead to a decrease in blood levels by approximately 13-26%."

• "Provides the full American Jobs Plan funding level -- \$21 billion - to create good-paying union jobs plugging orphan oil and gas wells, cleaning up abandoned mines, and remediating Brownfield and Superfund sites. As we transition to a clean energy future, the bipartisan Infrastructure deal will begin to remedy economic injustice for communities across the country that have relied on the fossil fuel industry and have been affected most by the impacts of climate change and pollution, including rural communities and communities of color."

• Safeguards communities of color from climate crises and extreme weather risks. People of color are more likely to live in areas most vulnerable to flooding and other climate change-related weather events. For example, in the wake of Hurricane Harvey, Black and Hispanic residents were twice as likely to report lost income. Tribal lands are significantly at risk to the effects of climate change and Alaska Natives are particularly vulnerable, as they face multiple climate impacts."

• Invests in clean energy grid to mitigate the disparate impacts of pollution on communities of color. Black, Latino, Asian American and Pacific Islander, and Native communities are more likely to be burdened by pollution. Black people are almost three times more likely to die from asthma related causes than their white counterparts. And more than one in three – or over 23 million – Latinos in the U.S. live in counties where the air doesn't meet EPA public health standards for smog."

The killing of Walter Rodney

n the evening of June 13, 1980, a bomb blast shook a neighborhood in Georgetown, Guyana and took the life of Black scholar, writer and activist Walter Rodney. Few Black people in the United States, or elsewhere around the world felt the explosion, but it was an event that shook our lives to their very foundations.

The assassination of Walter Rodney on that bad luck Friday the 13th silenced a voice that was pressuring bastions of white supremacy to loosen their grip on the formerly enslaved and colonialized people of color around the world.

In 1972, Rodney published his brilliant book, "How Europe Underdeveloped Africa," and stripped away the false narrative of humanistic motives driving European and American interactions with Africa both before and after most modern African nations gained their independence. This book, described by some as "the 20th century's most important and influential book on



African history," eloquently sets out the case of how European and American regimes deliberately exploited and underdeveloped Africa. It also called for people of color to understand the capitalist system underpinning European and American economic dominance and to work for its overthrow.



Walter Rodney knew that modern Western culture was built upon, and maintained by, a worldwide system of racialized labor exploitation of people of color, coupled with the theft of the natural resources from the lands where those people lived. He was determined that people of color should come to understand this. And

this is why, for some, he had to die.

We must understand that Walter Rodney's death is not a singular instance of European and American regimes shutting down voices calling for the economic freedom of people of color. Economic freedom translates into political power, and the former slave nations and colonial powers cannot allow people of color to gain the type of power that comes with economic independence.

For those who would argue that this last statement is an exaggeration, a brief survey of history presents a very clear picture of how white supremacy and Eurocentric dominance has been maintained by violence throughout the centuries.

Climate change alert: Tuvalu is sinking

uvalu is a tinv Polynesian island nation located midway between Hawaii and Australia. Home to just 11,000 people, it is just 10 square miles. It is smaller today than it was a decade ago. Thanks to world climate change, Tuvalu is sinking, and the evidence is everywhere.

I'd never heard of Tuvalu until I attended COP15, the Copenhagen climate change conference, in 2010. It was an intense experience, partly because white climate change progressives were prepared to disrespect President Obama for not taking an extreme enough position on climate change. It was also intense because many small countries, like Tuvalu, did not have the opportunity to address the assembled delegates. Instead. they had to clamor for attention through booths and flyers in an area outside the main assembly.

Tuvalu is sinking, a man Indifference or the tepid

Folks, this climate madness is all our fault. The IPCC says that emissions are "unequivocally caused by human activities." They have pushed the global temperature up and will move it further if we don't do something. But climate change deniers seem to think this is all-natural. The 44th President was rabidly vocal on this matter, and his acolytes deride climate change mitigation as a part of a "woke" Democratic plan. The leader of the pack is a non-Missouri living Missouri Senator, Josh Hawley (his residence issues could be the subject of an entire column). This man has raged against the infrastructure bill, which, though insufficient, represents necessary bipartisanship as we look to the future.

\$39 billion on transit is significant, especially in the context of climate change. We need to get cars off the road, and we can only do it if people have easy ways to get around. Safe, reliable public transportation could help, but, as always, there is tension. Many would use the \$39 billion for public transportation; some would use it for roads and carbon

There will be others as resources become scarce in one community and people are pushed into other communities, straining those resources and creating conflict. We will pay for ignoring climate change one way or another. We will pay now, we will pay later, but we will pay.

History tells us of Toussaint L'Ouverture, the most prominent figure in the Haitian revolution against France from 1791 until his capture in 1802. But his capture and subsequent death in a French prison in 1803 did not end the Haitians' thirst for liberty. The fighting continued until the black and brown population of the former French colony won their freedom in 1804 at a great cost of lives loss. This victory also created the nation of Haiti - the world's first Black-led republic.

However, 21 years later, France sailed warships into Haitian waters and threatened a devastating invasion if its demands for reparations for the loss of its slaves and its slave colony were not met. Haiti was forced to submit to the overwhelming French show of force and, over the years, has paid to France what amounts to \$21 billion in today's dollars. This economic burden severely stunted Haiti's economic development and has kept the island nation impoverished to this day, as well as making it a source of cheap labor for more developed economies.

Not long after Haiti became a nation, Mexicans began their war of independence against Spain, and after 11 years, threw off the Spanish colonial yoke. But when Vicente Guerrero, the second president of Mexico, issued a decree abolishing slavery in 1829, it sent shockwaves through the Texas region of Mexico, which was being flooded with Americans bringing their slaves and seeking fertile lands to grow cotton.

Three months after abolishing slavery, Guerrero, who was an Afro-Mexican, was driven from office and eventually executed by reactionary conservatives who took over the Mexican government. But the prohibition against slavery remained in place.

Texas slaveholders eventually rebelled against the Mexican government and its abolitionist policies and declared independence, sparking a war that is famous for its sanitized myth about the Alamo. After gaining independence in 1836, Texans codified white supremacy by, among other things, establishing a constitutional provision banning free Black people from its borders.

More than a century after Texas gained its independence, Africans in various European colonies began to agitate for their freedom and, in many instances, fought bloody wars of liberation. Unable to maintain their geopolitical grip on these overseas holdings, European nations devised "post-colonial" strategies to achieve the same economic results they enjoyed during centuries of colonial exploitation.

History also documents how African financial independence has been thwarted by Western colonialist and imperialist powers.

It is now a part of the public record that President Dwight Eisenhower ordered the murder of Patrice Lumumba, the first prime minister of the mineral rich Democratic Republic of the Congo, an act that has led to decades of instability in that nation and made its riches easily exploitable by Western interests.

From the beginning of their independence in the mid-20th century until 2020, former French colonies in West Africa were forced to deposit half of their foreign exchange reserves with the French Treasury. This economic constraint gave France control over the financial prosperity of those countries. And to this day, France controls the currency of its former central African colonies this way.

There are many chains with which global white supremacy and Eurocentric policies have kept people of color in economic bondage and unable to develop the necessary power to con-

The attack on the Capitol and the shameful right-wing Republican response

he Jan. 6 attack on Congress and the U.S. Capitol was an assault on our democracy. So is the effort by congressional Republicans and their rightwing media allies to keep Americans from learning the truth about the insurrection. They are desperate to protect the people responsible for that deadly attack. We can't let them.

The U.S. House Select Committee to Investigate the January 6 Attack on the United States Capitol held its first hearing on July 27. It was hard to watch, but important for Americans to witness.

Four officers testified, two from the Capitol Police and two from the Washington, D.C. police department. They the physical described attacks they endured and the moments in which they feared for their lives. Capitol Police officer Harry Dunn described being surrounded by an angry mob taunting him with the n-word, something he said he had never been called while protecting the Capitol.

The power of the first hearing, and the impact of the officers' stories, testified to the importance of the select committee created by Speaker of the House Nancy Pelosi after Republican congressional leaders refused to join in creating a bipartisan commission to investigate

the insurrection. The leader of the House Republicans, Minority Leader Kevin McCarthy, even tried to tank the select committee by appointing people who were intent on disrupting its work.

Thank goodness Speaker Pelosi wasn't going to let that happen. When she refused to play McCarthy's game, he tried to stop any Republicans

from joining

their To credit, two conservative Republicans, Reps. Lynn Cheney of Wisconsin, and Adam Kinzinger of

Illinois, decided to put country over party.

They have refused to be bullied by former President Donald Trump into promoting his lies about the election. They have refused to be intimidated by threats from McCarthy and other Republicans who are downplaying the fact that a violent mob incited by Trump tried to prevent the peaceful transfer of power to President Joe Biden.

I was disgusted to see right-wing activists and media figures like Charlie Kirk and Laura Ingraham mocking and belittling the police officers who were traumatized by the attack. And I am even more disgusted by the Members of Congress

who have betrayed and abandoned the officers who put their lives on the line to protect them. Some Republican members of Congress dismissed the mob that hung a noose and hunted members of Congress as "tourists." Some Republican members of Congress are calling insurrectionists "political prisoners."

Capitol Police Sgt. Aquilino Gonnell testified that such distortions are deeply demoralizing. I believe it is possible that kind of betrayal may have contributed to the suicides of four officers who were defending the Capitol that day.

All the lies that Trump and his team can spew could not stand up to the actual experience of those officers. And that was just the beginning. There are a lot of dark corners that need some light thrown on them.

We need to learn more about what Trump was doing on Jan. 6. We need to know which members of Congress he talked to and what he said. We need to know which members of Congress or congressional staff might have helped insurrectionists plan and carry out the attack.

We need a fuller understanding of how all the different groups promoting Trump's stolen election lies fueled the rage of his supporters and built the momentum behind the violent mob that swarmed the Capitol.

We also need to get a better handle on some bigger picture questions, like problems of racism and authoritarianism in law enforcement. At least 17 law enforcement officers that we know about took part in the attack on the Capitol. The military needs to get a handle on the existence of white supremacy and other extremist ideologies in the ranks.

We cannot forget just how deadly and dangerous the insurrection was-and is. Former President Trump continues to rile his supporters with the big lie that he won the election and had it stolen from him. Right-wing politicians, media personalities, and pastors spread those lies. Some still say Biden will be removed and Trump returned to power. Some talk openly of civil war.

This is all discouraging. But remember this. As loud, and mean, and violent as Trump's supporters can be, they are still a minority. They may have the power to intimidate cowardly Republican officials. But they cannot prevent us from learning the truth about Jan. 6.

Scott v. Taney

hen presented without context, the name Roger Brooke Taney means little to most contemporary Americans. Taney was born in Calvert County Maryland, very close to Washington, He was an attorney, DC. served in the Executive and Judicial Branches of the US government, was a member of the Democratic Party, and is infamous, as the US Chief Justice of the Supreme Court, for authoring the equally infamous Dred Scott decision.

To provide context, in addition to being the Chief Justice of SCOTUS, Taney was pro-slavery and a southern sympathizer during the Civil War. His legacy of racism would live for over a hundred years. Some, like me, say that his legacy yet lives on. Tanev's decision held that no Black, free or enslaved, had ever enjoyed the rights of citizenship under the Constitution. He argued that Blacks were "regarded as beings of an inferior order, altogether unfit to associate with the

white race ... and so far inferior, that they had no rights for equal rights began to which the white man was bound to respect." I would argue that, consciously or not, his decision is ingrained in the psyche of white America and is used as justification for all forms of racial discrimination.

I submit that the current pattern of race-based voter suppression

ing the number of bubbles released by a bar of soap were mere indicators of the respect accorded to the rights of Blacks. After 1965, as long as African Americans and other people of color offered no real threat to the power and authority of the white establishment, they could "play" the game of voting. Ultimately, the usefulness of gerrymandering as a control against the demands erode. We now see an unapologetic, full-blown racist attack on the voting rights of people of color and a perversion of the democratic principles fundamental to this nation. They understand that we have learned to effectively use the most powerful tool in any democracy.

Thursday, July 29, 2021, was my chosen day to get arrested. I stood in protest for the restoration of voter rights established under the For the People Act and the John Lewis Act. Inaction is unacceptable!!!

Congresswoman Sheila Jackson Lee, Dr. Johnetta Cole (NCNW President), Faya Rose Toure (Alabama), Arlene Holt (AFL-CIO), Jarrett Sawyer (Morehouse University), and I were arrested for, allegedly, blocking the entrance to the Hart Senate Building. When given the option to pay a fine or request a court date, I chose the latter. The Federal Magistrate will hear my concerns on November 24, 2021.

Considering the struggles of the past, this experience was relatively uneventful. There were no batons. There were no firehoses. There were no horses or dogs. There was a sense of urgency! We all knew that action could not be deferred for a later date. We all know that for the sake of survival we must mobilize in greater and increasing numbers. We have no time to waste!!

On August 3, 1857, the same year as the Dred Scott **Decision**, Frederick Douglass delivered what some consider to be his greatest speech. From that speech came the words, "If there is no struggle, there is no progress...

Who would be free, themselves must strike the blow.


He continued, "Power concedes nothing without a demand. It never did and it never will. Find out just what any people will quietly submit to and you have found out the exact measure of injustice and wrong which will be imposed upon them, and these will continue till they are resisted with either words or blows, or with both."

Angry Old White Civil Rights Lawyer Not Tired Yet The First Reconstruction, the 15th Amendment, and the VRA

Grandfather, S i m o n Spearman, was a Freed Man in North Carolina's Cape Fear River Valley in 1870, when the United States passed the 15th Amendment. He was a proud member of President Lincoln's Republican Party. He knew Lincoln was born in Kentucky, apprenticed himself to become a lawyer in Illinois and, with the Republican Abolitionist Party as his national network, recruited hundreds of thousands of White and Freed Black soldiers to the United States if America Army to abolish the sin of slavery. The diverse Army and Navy Lincoln commanded included virtually every Free Man of Color and every enslaved African who made the long night-walk to reedom alongside the back roads and rivers to enlist in the U.S. Army. New Bern, Quaker and other abolitionist faiths near Greensboro, and the bustling Wilmington Port city, were controlled by the USA throughout the War to abolish slavery. Simon Spearman knew well the 15th Amendment was just the first step in the long daywalk to Equality. He knew well the right to vote and to run for public office would be temporary, unless Black men exercised their hard-won rights every November. So did thousands of Black men who won seats in North Carolina state and county offices in the period between 1870 and 1898. But this new generation of civil rights leaders were not blind. They knew the slavers' whip which had lashed their fathers' backs on the plantation was being replaced by the money, press, churches, and secret political organizations that formed the militias in the county courthouses and Raleigh General Assembly organized by the sons of the confederacy. The historical irony of this backlash was the "literacy" test the county militias forced prospective Black voters to take. Slaves had been backlashed 17 times, when the slavers caught them reading, usually the Bible. After the 15th Amendment, the militias in the courthouses forced a prospective voter to read and recite long passages of documents written in legalese before they could register, much less vote, or run for office.

Great tenant-farms, and holding had urged his former Senate Wednesday Bible studies at their rural churches, as preachers taught literacy and liberation to the eager classes. Dirksen agreed, he voted for the VRA, the bill passed with a wide majority, and the nation moved into the early stages of the Third Reconstruction, which is playing out now. Of course, the VRA became the target of the dying but deadly racist militias and cults of racist rationalizers who have been normalized by national demagogues and private websites ever since. This weekend marks the

Anniversary of the Voting Rights Act. It is my solemn duty to report the violent strain of racism it was designed to prevent has surfaced again, backed by violent, gun-toting, well-funded militias. This violent strain includes about a

maybe a couple thousand dollars. But the dying militia movement has decided to pump millions of dollars into small tea party caucuses and factions, to promote the national agenda they are sent from faraway places about masks, vaccinations, critical race theory, and reverse racism. If they get elected, they use old authoritarian meeting tactics, filibustering public meetings late into the night, until regular working people have left, before taking votes. These tactics send a message to our frontline trusted messengers, our teachers, who know better than anyone how much work we have to do to catch-up from both Covid and Truth Deficits, which have hit historically marginalized families and their children the

hardest. Let us celebrate the VRA this week. But let's also get back to work, analyzing how to bring Justice for All into the classrooms all day, not just the first minute of the day. Tomorrow I am asking our legal team to provide our local Branches with an analysis of how at-large school board voting affects the segregated housing patterns which haunt many of our counties. When Black neighborhoods are still identifiable, when school boards vote to surplus historically Black schools which were built and funded in violation of Brown and the VRA, we must educate and litigate these policies. The NAACP must complete the purpose of Brown and the VRA: Dismantle Jim Crow. A fusion voter alliance can build a movement in which all God's children can accept the ugly truths of the long nightwalk and the joyous day-time miracle of building a more Perfect Union. Att. Who is the Lord Jesus?

n my most recent book, With Liberty and Justice for Some: The Bible, the Constitution and Racism in America, I come to the conclusion that in this country, there is no monotheism. In spite of a broad swath of people claiming to be Christian, I conclude that there are at least two Christ-figures in this country, one that Black people worship, and the other that white people worship.

But as conspiracy theories rage out of control and the voices of White Nationalists become louder and louder, there may in fact be three versions of the Christ of the Bible.

I have found it difficult to stomach racists declare their love 'for the Lord Jesus Christ." Their Jesus seems to be blind to and uncaring about racism and how racists use his name to sanction their hatred.



But this week, as the Delta variant of COVID-19 rages across the land, killing thousands, some churches are declaring that they will not bow to safety measures suggested or mandated by any government - local, state, or federal. Referring to restrictions that have been and may yet be put in place to protect people, this pastor called the precautions "Luciferan," and said that his church will ignore any efforts to curtail and control the virus. "When the Luciferans tried to shut down churches last year we didn't bow to them...we will have church every night while there's a lockdown. Don't touch the church of Jesus Christ Lord'

It is flabbergasting. I keep asking myself, "What's wrong with (these) white folks? How in the world did they get person of Christ so twisted?" There is nothing in the Bible that supports a Messiah who ignored or supported bigotry of any sort, but these people constantly lift up the name of Jesus as the reason for their bigotry. The strength of Jesus - and what set him apart according to the scriptures - was his willingness to love and embrace everyone, especially and including those who society marginalized and ostracized.

What we see happening is a group of disgruntled white folks whining and claiming themselves to be victims of a system which has not treated them fairly. It is against the will of their "Lord Jesus Christ." Their Jesus wants them to overturn the government, to "take over" government on all levels and "think everyone like make them." When I tried to share with a very religious friend of mine that there are a lot of people who see and interpret Jesus in a different way, she shut me down. "There is only one Jesus," she snapped. "You're talking foolishness."

But the fact is that people have taken not only the Jesus of the Bible but the Bible itself and shaped them both to adhere to their ideology and sociology and have called it theology. The problem is one of interpretation - and from the moment humans in this country embraced the enslavement and subsequent mistreatment of Black people and any other non-white group, a Jesus and a God foreign to the way I thought everyone was taught in Sunday School emerged and has never been successfully submerged.

The people who are living in and practicing hatred based on racism are convinced that they are in the right.

So, will the real Jesus the Christ please stand up?

The First Reconstruction Is Betrayed

In 1877, state militias sold out the African Americans, scratching out a living on their

National backlash against Fusion and integrated voter leagues. Jim Crow was encoded into law by the sinful 1896 Supreme Court decision, Plessy v. Ferguson, which found racial segregation was fine, as long as public facilities were "separate but equal." The Court told every Judge as long as they closed their eyes to the massive inequalities Africans had endured during slavery, the Constitution's 14th Amendment clear requirement of Equal Protection Under the Law should be ignored. In other words, Plessy left a gaping loophole for County and state militias to drive their Jim Crow policies through for 58

more years! The Second **Reconstruction's Crown** Jewel, the Voting Rights Act, Authorized by the 15th Amendment

In 1954 the NAACP's lawyers knocked the legs out from under Plessy's racist nonsense. Eleven years after this magnificent victory had turned loose the Civil Rights Movement in the South, Pres. Lyndon B. Johnson sent a Voting Rights bill to Congress. LBJ said the bill "will make it impossible to thwart the 15th Amendment" and "We cannot have government for all the people until we first make certain it is government of and by all the people."

It was no coincidence that President Johnson quoted President Lincoln's Gettysburg Address as mass graves were being filled in the cemetery behind him, with the concise definition of American democracv.

A Century later, the 1965 Senate, except for its stone-cold racist southern caucus, voted for the Voting Rights Act. LBJ

third of white voters who pledge allegiance to the Flag "and to the Republic for which it stands, one nation, under God, with freedom and justice for all" who apparently are following the delusions of a cult leader.
