



North Carolina's redistricting process begins with racial rules

Now that results from the 2020 U. S. Census are in, redistricting committees in the North Carolina General Assembly have once again begun the process of redrawing the district population lines for the next decade to determine voting strength throughout North Carolina for local, legislative, and congressional elections

Dramatic changes are already in the offing, as North Carolina's 13 congressional districts will be redrawn to make room for a 14th, especially since eleven of the current 13 are overpopulated beyond the required 746,711.

One of the most overpopulated voting districts is the 12th in the Charlotte-Mecklenburg area and is represented by Congresswoman Alma Adams (D-NC) at 899,779, one of only two Black representatives from North Carolina.

Ironically, the population count in the other Black congressional district, the 1st, is short by 59,355. That district is represented by Representative G. K. Butterfield.

North Carolina's population in the past ten years has grown 9.5%, especially in the six county areas surrounding Raleigh and Charlotte, respectively.

North Carolina currently has eight Republican representatives and five Democrats.

The use of past election results and party registration is disallowed, according to the new rules governing the process, as is any information about the racial composition of a proposed voting district.

That's a problem toward not constituting the districts fairly, say Black lawmakers like State Senator Dan Blue (D-Wake) and State Senator Ben Clark of Fayetteville. Concerned about complying with the 1965 Voting Rights Act and its mandate not to dilute Black voting rights, Democrats proposed guidelines for the use of Black population data per the districts but were essentially shot down by the GOP majority.

Since 2011, Republicans have been in control of both Houses of the Legislature and thus have been in control of the redistricting process. As a result, the fruit of their efforts, namely racially and partisan gerrymandering voting district maps - have been challenged in state and federal courts, with the majority of rulings catching the GOP trying to gain unconstitutional advantage more times than not by rigging the racial voting numbers.

Democrats maintain that the courts have ruled out the use of race as the primary factor in redrawing voting districts, but that doesn't mean it can't be a factor.

The U. S. Supreme Court has ruled in the past that, while racial gerrymandering or "stacking and packing" Blacks into districts is

unconstitutional, but partisan gerrymandering is not. Democrats, not trusting their Republican colleagues, are challenging them on every aspect of developing the process now, in order to get the best outcome of what normally turns out to be a one-sided affair where the ruling party (Republicans) use redistricting to gain even more political advantage for the next ten years and ultimately retain power.

Republicans, however, now vow to change that behavior.

"North Carolina has been the epicenter of redistricting lawsuits for decades," said Sen. Warren Daniel, R-Burke, co-chair of the Senate Redistricting Committee, in a statement. "It's time to put the last 30 years of litigation behind us and begin a new era of nonpartisan map drawing."

Even though Republicans rejected Democratic recommendations about the rules for drawing the maps, they insisted that the process will be "transparent," as maps will be drawn out in the open during committee sessions with a video camera streaming the process for North Carolina and world to see.

The deep concern among Democrats is that Republicans across the nation are well positioned with redistricting to take over the majority in the U. S. House during the 2022 midterm elections.

North Carolina is considered one of the key states to watch in that GOP effort.

U.S. Grows Ever-more Diverse

Census Data Show a Multiracial, Urban and Older U.S.

The United States population is more racially diverse than ever and increasingly urban, according to new data collected in the 2020 Census. But overall population growth in the country has slowed, newly released Census Bureau data show.

The Census Bureau released on Aug. 12 the first trove of narrowly focused information gathered in the 2020 Census. It will immediately be put to use in the redistricting process whereby states and local political jurisdictions redraw political boundaries to create districts of equal populations for upcoming elections.

The information will also be used in countless other ways over the next decade, for instance, to decide where new schools or hospitals are needed, or roads, or where it might profit a business to set up shop.

Of the 331,449,281 people enumerated in the 10-ques-

tion census form last year, 204.3 million identified themselves or other household members as white. There were another 31.1 million identified as mixedrace -- white and something else - and 2.7 million described as mixed race in a combination that did not include white.

The 204.3 million 'white alone' population is 8.6% less than it was the last time everyone was counted, in 2010.

The census questionnaire data on ethnicity parsed the population into the following racial categories: White, Asian, Black or African American, American Indian or Alaska Native, Native Hawaiian or Other Pacific Islander, and Some Other Race. There was a separate question asking if the responding household members were Hispanic or Latino.

Once those questions were answered. respondents could further describe themselves by tribe or other origins within those six initial categories.

Black Americans, including mixed-race, now number 46.9 million, according to the Census Bureau, American Indian or Native Alaskans are 9.7 million, Native Hawaiian or Pacific Islander 1.6 million.

Those choosing "some other race" alone or in combination were 15.1 percent nationwide, led by New Mexico at 32 percent, California at 31.6 percent, and Texas at 28.3 percent. Nationwide, 10.2 percent claimed "two or more races," led by Hawaii, with more than 25 percent so identifying, followed by New Mexico at 19.9 percent.

There are 22.7 million more people in the United States now than there were when the last decennial census was taken, in 2010, enumerators found. But that population growth of 22.7 million is the smallest gain in the once-every-10years count since 1990, and the smallest gain percentagewise since 1930.

The top 10 most-populous cities remained unchanged, with New York at the top of the list, followed by Los Angeles, Chicago, Houston, Phoenix, Philadelphia, San Antonio, San Diego, Dallas and San Jose.

The only change was that now-5th place Phoenix and 6th-place Philadelphia changed places. All of them grew larger, as did metro areas in general (8.7 percent), while the more rural areas declined by 2.8 percent.

Census Bureau statisticians compiled a "diversity index" that measured the likelihood that two randomly chosen people would be of different ethnicities.

Overall, in the United States, that likelihood is 61.1 percent, up from 54.9 percent in 2010. In Texas, Nevada, California, New York, Jersey,

> The likelihood that two people chosen at random would be of different ethnicities was lowest in Maine (18.5 percent), Vermont and West Virginia (20.2 percent each), and New Hampshire (23.6 percent).

> The U.S. population is aging. Of respondents, 77.9 percent are 18 or older (258.3 million), a 10.1 percent increase from 2010. The 73.1 million who aren't yet 18, represents a 1.4 percent decrease from 2010's statistics.

> The Census Bureau in April released the state-bystate population counts that determine which states gain or lose seats in the House of Representatives.

In non-pandemic times, census data has typically been released a year after "Census Day" - April 1 last year - but, "as we all know, the delivery has been delayed," said James Whitehorne, chief of the census' redistricting and voting rights data office.





NC NAACP leader believes convicted Jordan killer may be innocent

The president of the NC NAACP believes that the convicted killer of James Jordan, father of NBA basketball legend Wilmington native, Michael Jordan, may, in fact, be innocent and is supporting a filed petition for an evidentiary review by the North Carolina Court of Appeals in order to secure a new trial.

The Reverend Dr. T. Anthony Spearman, president of the civil rights group, says he's convinced that Daniel Green, who was convicted in 1996 for the July 1993 murder of the elder Jordan, did not get a fair trial.

Green, who has been in prison for the past 28 years,


Green and his attorney. Chris Mumma, executive director of the North year old Green lived in Carolina Center on Actual Innocence, filed his latest appeal with the court on July 30, 2021.

"I'm hopeful about the appeal," Green told WRAL-TV, which produced a documentary entitled Moment of Truth, questioning the original 1993 investigation that charged Green and the subsequent trial that convicted and sentenced him.

The Raleigh television station also produced an accompanying podcast entitled, Follow the Truth, about the case.

It was upon viewing the documentary and then speaking to people whom he knew about the Green case, that NC NAACP Pres. Spearman decided to publicly get behind the effort to help Daniel Green petition for an evidentiary appellate hearing in hopes of securing a new trial.

"The NC NAACP has closely monitored developments in Mr. Green's case, and supports his efforts to obtain an evidentiary hearing to review the issues raised in his petition," Rev. Dr. Spearman said. "These claims and the lower courts' failure to review them have

seriously undermined public confidence in the investigation that identified Mr. Green as the person who shot Mr. Jordan."

Spearman added, "...the circumstances surrounding [Green's] conviction are

RAINBOW COALITION Time for democracy to work

 \blacksquare he right to vote is fundamental to a democracy. Today in America, however, that right is under partisan attack across the country. If it is to be defended, nonpartisan reforms must pass across a partisan divide.

The question now is whether Democrats will join together to protect the right to vote from the assault it faces from Republicans at every level of government. That assault is

clear and unrelenting. Right-wing justices on the Supreme Court — appointed by Republican presidents — have systematically undermined the right to vote — gutting the Voting Rights Act, opening the door to unlimited and secret money from corporations and the super-rich, and enabling partisan gerrymandering free of judicial review. At the state level, Republican operatives and politicians have echoed Donald Trump's Big Lie about the 2020 election — a lie refuted by Trump's own attorney general, by Trump-appointed judges and by Republican election officials.

They have all used fictitious delusions about fraud as an excuse to pass a bevy of laws to make voting harder in states that they control. Thus far, 18 Republicancontrolled states have passed laws to limit access to the ballot box, or, even more dangerously, to undercut an independent, nonpartisan counting of the ballots cast.

And at the national level, Republicans in the Senate have joined at the hip to block efforts to reform election laws to protect free and fair elections. They have used the filibuster to block the ability of the majority to act. The reality is indisputable. One party — the party supported by a minority of the American people — is seeking to make it harder to vote.

One party supported by a growing majority is seeking to make voting easier. That isn't new. After the Civil War, the 14th and 15th Amendments, which guaranteed freed slaves the right to vote and to equal protection under the laws, were only passed over the bitter partisan opposition of Southern Democrats. Modern-day Republicans are now following in the footsteps of the plantation Democrats of the Old South, who enacted the Jim Crow laws that suppressed the Black vote for

Are today's Democrats prepared to protect the right to vote against their efforts? On August 16, the population data from the recent census will be released to the states. This will trigger a flurry of redistricting with Republicans intent on partisan gerrymandering that could give them enough rigged seats to win the House. Two Democratic senators — West Virginia's Joe Manchin and Arizona's Krysten Sinema — argue that they will oppose suspending or repealing the filibuster to pass voter reforms because they should be passed on a bipartisan

"The right to vote is fundamental to our American democracy and protecting that right should not be about party or politics," wrote Manchin, adding that "protecting this right ... should never be done in a partisan manner." Surely, it would be preferable to pass reforms with the support of both parties, but it is impossible when one party is all in on voter suppression. The Democratic leadership plans to give Manchin the chance to enlist Republican support for the modest election reforms that Manchin backs.

There is no sign that he can gain anything close to the 10 Republican votes needed to overcome a filibuster. Delay is a loser's game. It is time for Democrats to act, and for Manchin and Sinema to face reality. Congress must pass reforms to outlaw partisan gerrymandering and protect access to the ballot box before it is too late. That will require suspending or repealing the filibuster and ending the ability of the minority to frustrate the will of the majority. It's time for our democracy to work — this time to protect itself.

ep. John Lewis, the civil rights icon who died last year, liked to tell activists that building a better world depended on people being willing to make "good trouble." Rep. Cori Bush has just given us an example of effective troublemaking that should inspire us to action.

Rep. Bush is in her first term as a member of Congress representing St. Louis, Missouri. She didn't come with a typical resume of prestigious college and law school degrees and previous political jobs. Bush got into politics protesting police killings of unarmed Black men. Because her work was seen and respected in her community, she beat the odds and beat a long-time member of Congress.

Bush has experienced eviction herself. She knows how disruptive and dangerous it can be. So she wasn't going to stay quiet when Biden administration officials and congressional leaders were ready to let a COVID-19 moratorium on evictions expire and put millions of families at risk.

The temporary eviction ban was put in place by the Centers for Disease Control last September as a public health measure. Millions of families fell behind on rent

because of the economic turmoil caused by the pandemic. The CDC knew that forcing those families out of their homes and into shelters or onto the streets in the middle of a pandemic would cost

That original moratorium expired

to kick people out of their homes just when the Delta variant of the COVID-19 virus was pushing the pandemic into another deadly phase.

But Supreme Court's right-wing justices had signaled their disapproval for the moratorium. So the White House and congressional leaders played a bit of last-minute hot potato before Congress left town for its August recess without taking action to protect the families at risk of homelessness.

Rep. Bush grabbed a sleeping bag and camped out on the steps of the U.S. Capitol for several days to shame people into action. You can be sure that many of her colleagues didn't like being put on the spot as they went on vacation. Some of them anonymously criticized her

tactics. Her hometown paper said she was ignoring "political reality." Her right-wing critics ranged from dismissive to abusive.

But it worked. Bush's troublemaking meant that public officials could not just deflect attention from the crisis that was about to engulf thousands of families. And the White House worked with the CDC to extend protection against eviction for the vast majority of people at risk.

The new moratorium is being challenged in court, and it will expire in October. But it is buying time for families at risk. It is giving local officials a chance to get money into the hands of people who need it.

Bush's good troublemaking also brought needed attention to the fact that Congress had approved \$46.5 billion to help renters and their landlords, but some states and counties hadn't distributed a penny of it even months after they got

the money. When I saw people criticizing Rep. Bush for her tactics, I thought of Martin Luther King, Jr.'s Letter from a Birmingham jail. He wrote that he had almost concluded that a greater stumbling block to the freedom movement than the KKK was the white moderate more devoted to "order" than justice, who constantly says, "I agree with

you in the goal you seek, but I cannot agree with your methods of direct action."

Rep. Bush saw that families behind on rent were facing a crisis point. Our democracy is also facing a crisis point. In state after state, where Republicans are in control, they are imposing new barriers to voting as they try to prolong and expand their hold on power. They want the power to resist progress on racial equity, access to health care, and all the other issues that motivated people to turn out and vote for Joe Biden.

We can't let them win. Voting rights activists across the country are organizing. They're looking for people to help them make good trouble. When that opportunity comes your way, think of John Lewis and Cori Bush. And answer the call.

America's dirty laundry is in full view

epublican politicians are gleeful, it seems, as the debacle in Afghanistan unfolds before our very eyes, debacle in Alguanistan unions solors as the Delta variant of COVID-19 continues to cause hundreds of thousands of people to get sick and, worse, die, and as states pass laws to curtail the ability of Black people to vote in upcoming elections.

Their disrespect and disregard for the law is astounding. given the fact that they have always said that they were supporters of law and order and touted the mantra that America goes by "the rule of law."

But what we saw during the previous administration is not only a disrespect for the law, but blatant arrogance as law-

makers ignored subpoenas issued to find out what was going on in that administration that was illegal, immoral, or both. We saw during the January 6th insurrection scores of peo-

ple who were themselves members of "law enforcement," and of the military. We saw these people disregard the law and the United States Constitution as they stormed the capitol building, intent on stopping the certification of the outcome of the 2020 election - and we saw them beat police officers who were there doing their job.

Their disrespect of the law - and of police officers - was highlighted for me this week as I listened to a podcast where Cecil Rhambo, a candidate for sheriff in Los Angeles, described the reality of some police departments being populated by white gang members. I was not surprised, because I have long

thought that too many police officers took those jobs in order to legally kill and harass people - including and especially Black people, but to hear this political candidate talk about it

Republicans, I am sure, are aware of this, but ignore it. Their goal is to stop the browning of America and to keep people "in their place." But the hypocrisy is as staggering as it is troubling. White Republicans are so afraid of losing their power that they have lost their moral compass; all that matters is holding onto power, no matter what. If they have to rig and set up the infrastructure to steal elections, they are showing us that they will do it.

They slyly jump on and criticize those who say "defund the police," meaning that Black and Brown people are tired of being criminalized, unjustly targeted, harassed and brutalized by police, but at the same time they are silent as some politicians call for the "defunding" of hospitals, public schools, colleges and universities, and private businesses that are trying to curb the spread of COVID-19 by requiring that people inside their walls wear masks.

This weekend we saw footage of a man who threatened city officials with violence if the city did not back off from requiring people to wear masks. And we all saw angry parents attack medical representatives who tried to explain the benefits of having children wear masks as the Delta variant continues to wreak havoc. (

Not only are we seeing the blatant disrespect for the law by Republicans, but also a fairly disregard for human life. The "pro-life" people are silent as unvaccinated people - including children - continue to contract COVID-19. What about their commitment to life? If they do not care about school children getting sick and dying from a virus infection that could have been mitigated by taking a vaccine, what is life to them, real-

I am surprised that these values-touting politicians have lost their tongues and voices, and that their commitment to police is so fake. Everything that they are, and everything that they stand for, has been dumped in the middle of this struggling nation. It is not clear how we get clear of this mess that we are in, but one thing is sure: The sheet has been pulled off of the imposters of justice. What we do with what we have learned and are still learning will be critical as we move forward and if this country survives the attack on democracy. I hope and pray that politicians, legislators, organizers, and the media will recognize that the America we grew used to is gone and is under attack - and that they will move forward in their work accordingly.

The gated community of white supremacy and raw, corrupt power has been breached, and that is a dangerous, yet prescient reality.

Angry Old White Civil Rights Lawyer Not Tired Yet Memories of John Lewis

love the fact millions of old, people-young, Black, Brown, Bi-racial, Asian, "Others"-- have recently been introduced to John Lewis through one of his favorite sayings: Lets' Make Some Good Trouble. Let's Make some Necessary Trouble.

I met John Lewis on August 28, 1963. I had been working with CORE-the Congress Of Racial Equality--which James Farmer and other non-violent anti-racists had spun off from Fellowship Reconciliation in the late 1950's

when its members risked their lives in bus trips throughout the South. These Freedom Rides introduced John Lewis to the Moral dimensions of Non-Violent Direct Action. The long term aim was to put a stake in the heart of Jim Crow in the South, after the NAACP's Brown v. Board victo-

John Lewis was 23 years old; I was 27 at the March for Jobs and Justice and the speeches of the major civil rights groups. John was the chair of the Student Non-Violent Coordinating Committee (SNCC) that was formed three years earlier at Shaw University in Raleigh. His job that day was to represent SNCC and CORE, since our leader, Jim Farmer was in prison in Mississippi.

The original copy of his speech was seen as too militant by the Bayard Rustin and the March organizers. John's original speech blasted Nixon in the late 1960's. One of President Kennedy and his Attorney General-Brother, Robert Kennedy, for not using the Government's full power to protect the non-violent SNCC and CORE organizers in the deep South. When some of the

Now! That has always been John's favorite word. Now! Listen to the toned down speech John gave on August 28. 1963. You can find it on the internet

John came up with "Good "Necessary and Trouble" Trouble" sayings much later, after the Racist Republican-Tea Party groups had insinuatthemselves into Mr. Lincoln's Party, with Richard the tricks of Tricky Dick was to set up false dichotomiesfalse choices--to prevent our generation's from completing our historical duty-to build a broad popular Movement to dismantle the systems of slavery and Jim Crow in the South.

My friend John loved to challenge false dichotomies. . . fale choices. He loved putting Good and Trouble into the same phrase. Let me close by examining John Lewis'challenging these false choices with a little quiz:

1. What do we want? Justice or Truth? Answer: Yes!

2. When do we want it? Now! (John's favorite word!) Or it is obviously a long struggle to build a multi-racial grass roots movement? Answer: Yes

3. In 1963 at the March on Washington, was Rev. John Lewis or Rev. Martin Luther King the most effective Prophet? Yes

4. In John Lewis' congressional years and he challenged his colleagues to take up their generational duty, which was more powerful-- "Necessary Trouble or Good Trouble?"

5. When my friend, Rev. Dr. William Barber II, says this is a Movement, Not a Moment, which is it? Yes.

6. Is it a Movement of Truth or a Moment of Justice? Yes

7. Which are the best verses of the Anthem of the Civil Rights Movement? We Shall Overcome or We Are Not Afraid? Yes

8. Is it Race or Class? Yes 9. Is our Legislation Target Voting Rights or End the

Filibuster? Yes. 10. Which is more neces-Getting your head cracked open on the Pettus Bridge or Meeting with LBJ in the White House to figure out

how to get the VRA passed?

Dear white people-Please don't lose your minds

hite people, don't take it personally and don't lose vour minds, but the numbers are in and the numbers don't

For the first time in the history of the U.S. census, the non-Hispanic white population has fallen. With their numbers dropping from 63.7% in 2010 to 57.8% in 2020, white Americans are estimated to become a minority by 2045, according to the U.S. Census Bureau.

This shift in numbers need not be perceived as a bad thing by white people or anyone else because demographic shifts are not a reflection of merit. While many white people will certainly be cool with these declining numbers, others may not welcome the opportunity to join the community of minorities. They will see this diminution of their percentage of the population as an existential threat.

The long-enforced social order that has afforded white people the lion's share of the values available to the American community has been dependent upon the ability to visit violence upon anyone who challenged that order. Much like the lion's ability to remain at the top of the food chain because of its sharp claws and teeth and aggressive nature, Because of its capacity for violence and aggressive nature, Western society has

majority rule and the rule of law were used to hide the racebased inequities inflicted upon people of color for centuries. It was a very simple formula for justifying the maintenance of power by white people. In a democracy, numerical superiority guarantees dominance. The shorthand version of this reality is "majority rule." With white people in the majority, the principles of democracy guaranteed that they made the rules, which codified white privilege into laws in many instances. White privilege necessitated the maintenance of democracy and the rule of

Prior to the Civil War, the rule of law dictated that enslaved African Americans were chattel, property of the people who enslaved them. If any of these enslaved individuals escaped their bondage, the rule of law required that they be returned to their enslavers. And until the 14th Amendment to the U.S. Constitution was passed in 1868, "[the Negro] had no rights which the white man was bound to respect," according to U.S. Supreme Court Chief Justice Roger B. Taney in his decision handed down in the landmark Dred Scott case. Descendants of Africa were not deemed to be deserving of respect.

This logic was born out of a world view of Western culture that was thousands of years in the making and twisted during the last five centuries into its current manifestation.

Western political structure was based upon notions of meritocracy stretching back beyond ancient Greece to the time of the pharaohs of Egypt. Meritocracy dictated that those deemed deserving by society should make its rules and regulate the allocation of its benefits.

After the collapse of the ancient world, religion was the general measure of merit, as the faithful were doing God's

will. Christians, Muslims and Black political power during Jews all claimed the path of righteousness as theirs and theirs alone, and enslaving pagans was justifiable on the grounds of religion. During the Renaissance in

Europe, as the enslaved began to convert to Christianity, it became difficult to justify enslavement based upon the lack of Christian values. At this point, religion gave way to race as the justification for the enslavement of people of color and numerous inferiorities were ascribed to them as justification for the continuation of their enslavement.

Even after the American Civil War and passage of the 14th Amendment, African Americans and other people of color were relegated to a lower status in this country, entitled only to those crumbs of life and liberty that white Americans deemed to allow them. The rule of law democratically enacted enforced by the political majority was a bulwark against any loss of privilege by white people.

On the other hand, when superior numbers fade, so does the utility of democracy. Then democracy is scrapped for expediency

In the wake of the rise of

Reconstruction, the Ku Klux Klan and extreme violence arose to enforce a new unwritten rule of law - a law of white supremacy at any cost. And as always, the justification for violence against people of color was that they were a threat.

The shrinking of the white majority in America has agitated a certain portion of the population that sees a threat in the rising tide of black and brown people. They realize that if the demographic trends continue, they no longer can rely on their superiority in numbers to guarantee them advantages in life.

A great deal of rhetoric is being espoused by white alarmists denying that their raising a red flag signaling the loss of numerical superiority in America has anything to do with white privilege. But just as Confederate lovers claim the Civil War was about state's rights without specifying that the right the states were primarily fighting for was the right to own slaves, these demographic alarmists do not reveal that the increasing percentages of people of color threatens white dominance.

Historians today tell us that the Germans who followed

Adolph Hitler believed they were facing an existential crisis and had to fight for their very existence. Additionally, Hitler offered the majority population identifiable minorities as scapegoats. Germany's descent Nazism did not work out well for Germany or the world at large, and it was thought to be common knowledge around the globe that such desperate attempts to maintain cultural or ethnic dominance were bad ideas. The rest of the country,

and indeed, the rest of the world are watching tensely to see if that restive portion of America's white population further loses its grip on reality and strikes out in fear with destructive consequences. But the global community will not tolerate a hateful America motivated by grievance politics and behaving like a schoolyard bully to maintain the status quo. Even if America is not able to prevent its own descent into authoritarianism, the community of nations will not stand for it.







COVID vaccine booster shots will start in September

Top health officials and medical experts joined on Wednesday, August 18, to announce that booster shots of the Covid-19 vaccine will be available beginning on September 20.

The officials said the boosters are still pending authorization from the U.S. Food and Drug Administration.

CDC Director Dr. Rochelle Walensky, U.S. Surgeon General Dr. Vivek Murthy, National Institute of Allergy and Infectious Diseases Director Dr. Anthony Fauci, and COVID Health Equity Task Force Chair Dr. Marcella Nunez-Smith counted among the experts and officials to issue a news release about the additional shots.

booster shots for all Americans beginning the week of September 20 and starting eight months after an individual's second dose," the officials wrote.

"At that time, the individuals who were fully vaccinated earliest in the vaccination rollout, including many health care providers, nursing home residents, and other seniors, will likely be eligible for a booster." The statement continued:

"We would also begin efforts to deliver booster shots directly to residents of longterm care facilities at that time, given the distribution of vaccines to this population early in the vaccine rollout and the continued increased risk that COVID-19 poses to them."

The announcement arrives as the virus continues a rapid try, with hotspots identified in Florida, Mississippi, Texas, Oregon, and other states.


