# Gov. Cooper vetoes anti- riot bill and anti-critical race theory bill

It should not have come as a surprise to any Republican state lawmaker that Gov. Roy Cooper, a Democrat, was going to veto their most controversial legislation this term. Last week, Cooper vetoed House Bill 805 and House Bill 324. Both measures were seen by Democrats as Republican overreaches of First Amendment and educational freedoms, so much so that there is little chance of any Democrat joining GOP lawmakers in attempting to over ride Gov. Cooper's veto. As reported recently, HB 805, ratified by the Republican-majority N. C. House after winning approval in the GOP-led Senate, was purported to be a direct response to last summer's protests and calls for racial justice and police accountability, proponents said.

However, opponents, primarily Democrats, countered that it was an attempt to stifle peaceful protests. "The bill is a clear attempt to suppress free speech and the right to assemble," the progressive-leaning N. C. Justice Center said. "It also

leaves the definition of a "riot" intentionally vague, thus granting police and prosecutors immense power to target Black, brown, and indigenous communities. By standing up for racial justice, those communities will be most hurt by the subjective legislation."

"Interestingly, a federal judge in Florida last Thursday ruled that state's anti-riot law as unconstitutional as well, arguing that law's language too vague,"...[permitting] those in power to weaponize its enforcement against any group who wishes to express any message that the government disapproves of,"

Governor Roy Cooper agreed. "People who commit crimes during riots and at other times should be prosecuted and our laws provide for that, but this legislation is unnecessary and is intended to intimidate and deter people from exercising their constitutional rights to peacefully protest," said Cooper in a statement, explaining why he was vetoing the measure.

The Democratic governor also had sour grapes for the controversial HB324, which Republicans assured was an effort to prevent "indoctrination" by liberal teachers of students about racism, sexism, and America's racist and sexist history.

Led by Black Republican N. C. Lt. Gov. Mark Robinson, HB 324 mirrored similar so-called anti-Critical Race Theory laws in numerous other states.

"Republicans haven't uncovered indoctrination in our schools," said Democratic Senate leader, Dan Blue (D-Wake). "What they have done with this bill is distract the public and ourselves from the real work that we should be doing to improve our public schools." Again, Gov. Cooper and his veto were on the same page.

"The legislature should be focused on supporting teachers, helping students recover lost learning, and investing in our public schools," said the governor in a statement. "Instead, this bill pushes calculated, conspiracy-laden politics in public education."

Again, because Republicans do not have enough members in either the House or the Senate to constitute the required supermajority, the governor's veto of HB 324 is expected to stand. Thus far this term, Gov. Cooper has vetoed ten bills.

#### STATE SUPREME **COURT ALLOWS EX-FELONS WHO HAVE REGISTERED TO VOTE** BY SEPT. 3RD TO **REMAIN SO**

[RALEIGH] Ex-felons, who immediately registered to vote between August 23rd to September 3rd, shall remain registered until further court order, states the NC State Supreme Court.

On August 23, 2021, a North Carolina superior court expanded this earlier

decision and ordered that of the court. all felons on community supervision be permitted to register and vote. This would include people on felony probation, parole, or post-release supervision. However, on September 3, 2021, the North Carolina Court of Appeals ordered a halt to that decision while it is on appeal. Last Friday's decision from the N.C. Supreme Court affirms the halt put in place by the Court of Appeals, with one exception. The Supreme Court's order allows any felon on community supervision who registered between August 23 and September 3, 2021, to remain registered

## **Actor's death reminds** of N.C.'s opioid crisis

The untimely death of gifted actor Michael K. Williams, star of HBO's Lovecraft Country and The Wire, among other noteworthy productions, last week, according to authorities, apparently attributed to a drug overdose in his Brooklyn home, in the midst of the COVID-19 pandemic, reminded all that the Black community has to struggle with two growing health challenges that threaten our everyday living.

It has been well documented that, even though, at press time, there was no official determination of what caused the Emmy nominated Williams' death, the actor's well documented drug use history, the paraphernalia, and heroin allegedly found on his kitchen table, pointed toward an apparent overdose of the deadly, and illegal opioid as the culprit.

Williams, 54, was always

Carolinians died each day from unintentional opioid overdose. From 2000-2019, more than 16,500 North Carolinians lost their lives to unintentional opioid overdose," reports the N. C. Dept. of Health and Human Services' Opioid Action Plan Data Dashboard.

Think the opioid and COVID-19 crisis have nothing to do with each other? Think again!

According to North Carolina Public Radio, in a report out just last month, opioid overdose deaths in the State actually increased during the coronavirus lockdown, contributing to the fact that North Carolina had more opioid overdose deaths in 2020 than any other year on record. The most common, and overly prescribed opioid, is Oxycontin.

"Opiate addiction is a group of diseases that people call the diseases of despair," said Dr. Graham Snyder. Medical Director, WakeMed, in Raleigh to WUNC-FM, "meaning when things are bad, when unemployment, education, job uncertainty, food uncertainty, are bad, then those diseases get worse. You take people who are already struggling and say, 'Oh, by the way, now vou're unemployed. You can't do the fun things you used to and everywhere you look, there's uncertainty.' That's a setup for an opioid crisis. And the numbers have gone up, but they're not skyrocketing yet," Dr. Snyder continued. So how does that translate racially? In a new report issued just last week, "an increasing number of Black people in America are dying from opioid overdose deaths, compared with their White peers....," states The Independent. "The rate of opioid overdose deaths has been climbing for African-Americans faster than other groups, a study from the National Institute of Health's National Institute on Drug Abuse (NIDA) found," The Independent added.

North Carolina wasn't part of NIDA's four-state study, but that doesn't mean

the results don't apply to areas like Wilmington, Greens-boro. Charlotte-Mecklenburg and Asheville.

In 2016, according to the study, The Opioid Crisis in America's Workforce from Castlight Health, Wilmington, led the nation in opioid abuse at 11.6%

In 2014, opioid addiction was reported as "spiking' in Guilford County, the third most populated in North Carolina. Heroin addiction was found to be particularly bad in Greensboro.

In 2017, Axios Charlotte reported that '...in the last decade, opioid-related deaths in the county have increased by 134 percent."

Furthermore, according to the Buncombe County Dept. of Health, Buncombe County experienced "....147% increase in overdose deaths from 2015-2017."

open about his drug abuse problems, something he suffered from since the age of 19. In 2012, he told NJ.com that he spent his earnings from The Wire on drugs. "I was playing with fire," he said. According to the National Institute on Drug Abuse, an estimated 79% of drug overdose deaths involved opioids in 2018 in North Carolina. In 2019, "nearly five North



## Thank you, Black women

hen California governor Gavin Newsom woke up on Wednesday, September 15, 2021, I hope he fell to his knees and said, "Thank you, God, thank you, Black women." To be sure, there are many others to thank, from the energized Chicanx/Latinx community to the Democrats who surged to the polls at the last minute. Some of the more prominent who thronged to his side were Black women, including Vice President Kamala Harris, Congresswoman Maxine Waters, California Board of Equalization member Malia Cohen. Others include grassroots women whose names you'll never know but whose work was invaluable. They had to get out the vote drives.

Street fairs. Voter awareness events in parks and playgrounds. They were determined that the recall effort would fail and even more determined when talk show host Larry

favorite. Those who worked for Governor Newsom weren't necessarily his biggest fans, but they appreciated all his work to develop a progressive agenda. They enjoyed his appointment of Dr. Shirley Weber as Secretary of State. They appreciated his support of Vice President Harris and President Biden. Despite his flaws and unforced errors, they appreciated his leadership on covid matters (like the French Laundry debacle). And they turned up and turned out, although with laggardness that

put the outcome of the recall in doubt, especially in mid-August when Elder was polling very close to Newsom

Democrats ought to be ashamed that things got that close. In a state that has twice as many Democrats as Republicans, there should never have been a question about the outcome of the vote. Frankly, there never should have been a recall election. But if Republicans can't get their way the old-fashioned way (by winning), they'll try the renegade way by stealing. So we were treated to allegation after allegation of voter fraud before a single ballot had been counted. We heard reports that some partisan poll-watchers were aggressively challenging voter signatures in the name of preventing fraud. Republicans have been able to gain all these advantages because Democrats, in a word, have been sleeping. President Joe Biden would be the first to assert that Black women made a difference in the 2020 election. Women like LaTasha Brown, Melanie Campbell, Barbara Arnwine, and so many others crisscrossed the country, urging people to get out and vote. Sometimes it wasn't an easy case to make President Biden has been in public office long enough to have a record that energizes some and causes others to cringe. Too many Black men (around one in six) believed the hype and voted for Trump. As hard as that is to understand, it is reasonable to note that Black people are not a monolith, and we don't vote in lockstep. That makes the Republican embrace of arch-conservative Larry Elder (he would have given reparations to slave owners) all the more cynical. Some Republicans see Elder as the new face of conservatism. Others see him as a Black man who can hoodwink Black people into voting against their interests. One critic described him as "white supremacy in Blackface". She was kind. Elder is coyly considering a gubernatorial run against Newsom in 2022. He may have some momentum, having garnered 46 percent of the votes to replace Newsom, but given that Californians soundly rejected the recall effort, will he have the numbers? His 46 percent of the 37 percent who voted in favor of the recall amounts to a paltry 14 percent or just one in seven votes. The California recall process distorts both the voting outcome and Elder's relative unimportance. Still, Elder isn't going anywhere. The popular talk-radio host is likely to use his electoral experience to expand his audience and ratings. And with the help of Fox, he may multiply his base. There is little or nothing that Democrats can do about Larry Elder, but there is plenty that we can do about pushing a Democratic agenda. Democrats, just do your work. Organize, strategize, keep the momentum going. Stop thinking that you have to "play nice" with Republicans because they sure ain't playing nice with you. If you care about health care, education, clean air and water, economic justice, call it out. And if you care about the political space in which we live, say thank you to the Black women who helped make it happen. irginia's voters will pick the state's next governor in November. The choice couldn't be clearer, and neither could the national implications of this race in a bellwether state. Not only is the Virginia election a curtainraiser for the midterm elections of 2022, it's also the biggest test so far of whether the Trumpified GOP can win major races.

The Democratic candidate, Terry McAuliffe, had a successful term as governor. The Republican candidate, Glenn Youngkin, is a super-wealthy businessman trying to buy his way into power. state has a budget surplus, lower-than-average unemployment, and a AAA bond rating. This summer CNBC declared Virginia the top state in the country for business.

The real danger of the state dropping into a ditch comes from Youngkin himself. His desire to abolish the state's income tax would slash the state's ability to provide services to its residents.

When McAuliffe was governor, he was so successful at attracting economic development and generating new jobs that he was named "Public Official of the Year" by "Governing" magazine in 2017. The magazine honored fails another test that is of McAuliffe "based on his success navigating an opposition legislature, creating new jobs, and persevering in restoring the civil rights of more than Virginians." 168,000 McAuliffe credited his team for helping him "build a stronger, more inclusive Virginia."

In his previous term as governor, McAuliffe also oversaw record spending on education and created the country's first workforce training program to help people without a college education get access to jobs in high demand. He is pledging to build on that track record by raising teacher pay above the national average, expanding access to preschool, and getting all students online.

Meanwhile, Youngkin's search for ways to fire up right-wing voters has led him down another divisive road paved by Trump. Youngkin has joined Trump, Fox News, and right-wing activists who are trying to stop schools from having honest conversations about racism in our history, culture, and institutions. They're hoping to inflame conservative white voters to drive up turnout, and Youngkin has made it the centerpiece of his campaign.



vital importance to Virginians' health and economic future: dealing responsibly with the COVID-19 pandemic. Youngkin opposes vaccine mandates and doesn't think schools should require students to wear masks. He said he would follow the lead of Gov. Ron DeSantis of Florida, whose irresponsible policies have encouraged an upsurge in hospitalizations and deaths. McAuliffe knows that you can't rebuild the economy if the pandemic is allowed to ravage the workforce and disrupt our lives and jobs.

Virginia voters rejected Donald Trump twice and I believe they will reject Trump's pick for governor. McAuliffe, whose successful record as governor reflects his commitment to a Virginia that works better for everyone, deserves Virginians' votes, and the nation will be watching.



## NNPA honors Dr. Ebony Hilton with National Leadership Award

From the onset of the global pandemic about 18 months ago, Dr. Ebony Hilton emerged as a leader and a powerful voice of reason.

"I cannot begin to tell you how honored I am to be considered," Dr. Hilton said of the NNPA honor.

"I have to be honest. It's difficult to think of my efforts as worthy when there is so much left to do. One thing I can promise is to continue trying my best and showing up in hopes of truly deserving this prestigious recognition," Dr. Hilton stated.

Dr. Hilton received her M.D. from the Medical (MUSC) in 2008.

She remained at MUSC to complete her Residency in Anesthesia, followed by a Fellowship in Critical Care Medicine.

In 2013 Dr. Hilton made history as the first African American Female anesthesiologist since the hospital's opening in 1824.

Throughout her tenure at MUSC, Dr. Hilton's passions have centered on exploring the issue of health disparities, particularly as it pertains to race, and bridging the gap between physicians and the communities they serve.

According to Dr. Hilton's official biography, her works have led to her integration into the medical school curriculum, serving as a clinical instructor for fourth-year medical students in Intern 101.

She traveled the globe to participate in numerous medical mission trips via Project Madaktari Bugando Medical Center in Mwanza, Tanzania.

As a practicing physician at the University of Virginia – Charlottesville, Dr. Hilton has continued advocating for underserved and marginalized populations.

Heron performed a work entitled, "The Revolution Will Not be Televised," and while the piece came out on the heels of the Civil Rights Movement of the 60s, Scott-Heron later explained revolution is about change and that "the first change that takes place is in your mind."

As Right-Wing extremists continue to threaten violence to protect their rights, and as so many people refuse to see what is happening to the very structure of this country, it is clear that there is not enough change happening in the minds of Americans.

We are stuck. We are stuck in our legacy of white supremacy, sexism, classism and bigotry on many levels. like Mitch Politicians McConnell and President Biden are stuck; McConnell in his belief in and practice of domination politics, and Biden in his belief that bipar-

n 1970, Gil Scott- tisanship is something that human beings rather than still exists -if it ever did.

Institutions, including the church, are stuck as well, stuck in the idea that "church" is a building, a place one goes to as opposed to being a way of living. White Nationalists are stuck in their belief that Jesus sanctions their bigotry and hatred, and others who call themselves Christian still do not get it that the foundation of Christianity is the Great Commandment - that we love God first with all our hearts, and that we are to love our neighbors as ourselves.

We are all stuck; if a revolution is taking place, it is not obvious.

Change is difficult, no matter when it happens or why. We get used to being where we have always been, even when we know moving will make our lives and the lives of the people we love better. We remain stuck in our tendency to serve and honor

God- even though we use the name of God to justify our actions. We don't know what loving our neighbor as ourselves will ultimately look like and cost us, but we do not

want to know. We stuck. I recently watched movie about the horrific experience of Richard Jew-Rev. el, the securi-Susan ty officer who discovered a K. Smith bomb

Centennial Olympic Park in 1996 and, even as he notified law enforcement, ushered many people away from the bomb's location - only to be later accused of planting the bomb himself.

He was a young white man, overweight, and apparently had no swag of the sort that people respect and want to emulate. He had a checkered past - as we all do - and his past was used by ambitious journalists to spread the lie that he, in fact, was the culprit who planted the bomb.

It turned out that it was a man named Eric Rudolph who had planted that bomb and others, a white man as well who hated the government and ascribed to conspiracy theories. The most striking thing about this movie (and I do not know how accurate this is) is that Rudolph, who had a community of white nationalists supporting him because he had bombed abortion clinics as well. The white nationalist community of which he was a part had a deep hatred of abortion clinics and for people "killing babies," but what the movie brought out was that they also had a deep love for their families. When Rudolph first made his way to a specific white nationalist community, they embraced him, but a bomb specialist representing the ATF who also knew the white nationalist community told the FBI that the way to catch Rudolph was to let them know that Rudolph had planted the bomb at Centennial Olympic Park as well. That would make them angry because members of their families had been at the park on that day.

What was depicted in the movie was a revolution that was not televised. The white nationalists teamed up with the federal government to catch Rudolph. Within both these groups, a change of mind had to happen so they could act upon their common goals and interests - for the FBI to catch and stop a serial bomber and for the white nationalist community, to protect their families.

America needs a revolution. but not one with guns with "both sides," whatever they are, working to kill each other. No, the revolution that needs to happen is in the minds of people who have adhered to and continue to cling to ways of thinking, moving, and acting that have not served this country or its citizens well.

At the end of the day, a true revolution in this country would be where people with opposing political, religious, and ideological beliefs came together to work for the common good, as opposed to staying in their camps allowing the rich and powerful to become more rich and more powerful at the expense of all of us.

That is a revolution which would not be televised or supported by corporations and many institutions in this country. They maintain their power by feeding us spoonsful of rhetoric that only make us more angry and anxious.

### There is no longer serious doubt Global Warming is real — Now what do we do about it?

ecord fires in Oregon and California. Floods in Houston and New York. Deadly winter storms in Texas. Droughts across much of the west. Flash floods in England and Germany. Blinding dust storms in China. One hundred year cyclones devastate Fiji Indonesia. Deadly and droughts across sub-Saharan Africa. Wildfires in Greece and Italy.

The year is not over yet, but in the United States and across the world, the toll in lives and destruction is growing in storms of biblical proportion. The poorest peoples and the poorest nations are most at risk, but no one is insulated against the impact. The wealthy on Lake Tahoe are evacuated in the face of unprecedented wildfires. Texan oilmen struggle when record winter storms shut down the electric system. Wall Street bankers are hit with floods sweeping through subways and streets.

As the storms increase, food supplies and prices will be hit. Millions will be displaced. There is no longer any doubt about the reality of global warming, the dangers of it, or the causes of it. Republicans who for years scorned the reality of global warming — Donald Trump dubbed it a "Chinese hoax" — now accept that it is real. Corrupted scientists paid by oil companies that argued the crisis wasn't manmade, now quietly reverse their opinions. Now the only question is: what will we do in the face of what the United Nations warns is literally an existential threat?

We can't undo what we have done, but we can alter how bad the future becomes. We can move to sustainable and efficient energy systems, make production and housing and transport more energy efficient, replant forests, invent new ways to generate or save energy, or more. In its last authoritative report, the UN issued what it called a "code red for humanity." The change must take place over the next decade or we will seed calamities too horrible to imagine.

Already this year, the town Lytton, British Columbia, in Canada was erased by a hit so extreme — temperatures reached 121 degrees — that it literally went up in smoke and was reduced to ashes.

And yet, we keep putting

Can we summon up the awareness, the moral courage,

The interests invested in stopping change are mobilized. The only hope is that we the people rise up to demand the change that is desperately needed.

## National survey finds people of color struggle amidst work, family duties to get vaccinated

57% of unvaccinated said no one discussed getting vaccinated with them

As vaccination rates against COVID-19 steadily climb across the country, an alarmingly high percentage of people of color are unable to get vaccinated because of job restrictions or family obligations, according to a nationwide poll released today by Made to Save.

Forty-eight percent of

unvaccinated respondents said their jobs did not allow time off to get vaccinated or their childcare responsibilities made it difficult to leave home.

began, it has taken an unequal toll on communities of color, something made worse by the fact so many workers were unable to get paid time off to get vaccinated," said Chris Wvant, executive director of the Made to Save Campaign.

"While the new federal vaccine requirements for workplaces will go a long way to protect workers of color, there is so much more their employers can do to make it "Ever since the pandemic easier for them to get vaccinated."

The survey also revealed that 57 percent of people who are unvaccinated had not been approached by a friend or family member to encourage them to get a shot. This presents an opportunity, as such conversations were

reported to be effective by 30 percent of respondents who are vaccinated.

Other notable survey findings include: • An individual's doctor is the most trusted source of information about the vac-

cines (75 percent); • As a protective measure, 52 percent report wearing a mask most of the time outside their homes, and 43 percent limit their time at indoor settings like grocery stores; and

cited reason for not being their race or ethnicity, of vaccinated was a lack of data (32 percent), followed by waiting for FDA full approval (24 percent) and it was not required by an employer (18 percent). The FDA fully approved Pfizer's vaccine on Aug. 23, a week after the poll ended.




