

Trooper makes Fayetteville man walk six miles to his car--Part 2

Editor's Note: This is Part 2 of a story about a Black North Carolina medical professional who flew to Missouri for a medical conference in August and found himself the target of alleged police abuse within a half hour of

Greg Smith's ordeal August, 6, 2021, was every Black driver's nightmare come true, being stopped in the middle of the night on the road by police for no legal reason, faced with the uncertainty of either being physically assaulted, or hauled off to jail, or both. To make matters worse, Smith was a clinical director from Fayetteville, N. C., who had just flown in to Missouri, documented as one of the worst states in the nation for racial profiling, for a medical conference. Black, alone, and from out-of-town! How much worse could it get? Smith was about to find out.

He had already refused to show his driver's license to the irritated White Missouri state trooper who stopped him until a supervisor arrived, keeping both his hands on the steering wheel of his rental car and having called 911 so that the operator could both hear and record

the entire confrontation from his car until he was aggressively taken out, arrested, handcuffed, and taken away. Yet the whole time, Smith had no idea why he was "legally" stopped. "There was never a crime committed

nor law broken," Smith maintains. He was taken to a Platte City Highway Patrol station, where, at first, Smith was charged with speeding, except that he could prove he was doing 65 mph in a 70 mph zone and vigorously defended himself while still handcuffed, sitting in a chair. Indeed, the arresting officer had to account to the desk sergeant as to why Smith was even brought in in the first place. Missouri law enforcement looked for Smith's criminal record through their computers and discovered that....he didn't have one. He was a Black man who was who he was. Eventually he was uncuffed.

There was still a problem. Smith was informed by the desk sergeant that they just couldn't let him go because of the way the arresting officer wrote up the traffic stop in the computer: "PERSON WILLFULLY RESISTS OPPOSES A MEMBER OF THE PATROL IN THE PROPER DISCHARGE OF THEIR **DUTIES.**'

Smith had to pay \$1,040 to bond himself out in order to be released or else he would have had to remain in jail "for a while." Fortunately, Smith says, he had his Visa card on him. However, even that would not have helped Smith find his rental car, which was taken to a Quick Stop all-night gas station approximately six miles away by officers and left there. If Smith wanted his car back, he'd have had to call a taxi to take him to it. He'd also have had to stay in the building downstairs in order to have had any kind of shelter and safety. After 90 minutes of "shelter and safety" and five fruitless calls, waiting for a taxi, a tired and frustrated Greg Smith decided to strike out on his own, and he walked the dark streets of Platte City to find his rental car. After getting confusing directions from officers, he went. Using the flashlight on his cellphone, Smith reached a gas station about a mile and a half away, where an attendant told him that his rental car was most likely at another station six miles away.

Smith finally reached the vehicle and then took himself to an emergency room because of "the incredible pain" from the handcuffs. To Smith, it was apparent that the irritated White

As previously reported, no less than the Missouri State Attorney General's Office has confirmed that African-Americans were 75-85% racially profiled by Missouri law enforcement in previous years. 



We suffered and continue to suffer because no one at the FBI, USAG or the USOPC did what was necessary to protect us. We have been failed, and we deserve answers." - U.S. Olympic Gymnastics Champion Simone Biles, testimony to Senate Judiciary Committee

ust 17 years old in June of 2015, Maggie Nichols disclosed to USA Gymnastics officials that the organization's team doctor, Larry Nassar, had been molesting her since she was 15. Furthermore, she said she suspected that Nassar was abusing her friend and teammate Simone Biles as well.

USA Gymnastics waited more than a month to report the allegations to the FBI, by which time a private investigator had identified at least six victims, including McKayla

only to get USA Gymnastics "off of our For nearly three hours, Maroney described to FBI agents -- over the phone, in graphic detail -- the six years of sexual abuse she endured at Nassar's hands. She called it

"the most uncomfortable conversation I had ever had in my life." The agents who interviewed her took almost no notes and filed no reports. It would be another year and a half, after an Indianapolis Star investi-

gation brought renewed attention to Nassar, before Nichols, Biles, and Raisman finally were interviewed, and a wildly inaccurate and misleading report of Maroney's interview was filed. Despite the trauma of their abuse and betrayal by a system stacked against them at every turn, these four young women

found the courage not only to seek justice for themselves and the hundreds of Nassar's other victims, but also to stand before the U.S. Senate to tell their stories and demand accountability for those who failed them so completely. The testimony of Biles, Maroney, Nichols and Raisman at

last week's hearing was both heartbreaking and enraging to witness. But it was clear to see that the same fortitude, resilience, and strength of spirit that made them athletic champions also drives their unshakeable quest for justice. As Department of Justice Inspector General Michael E.

Horowitz, whose report revealed the dismal failings of the FBI's Nassar investigation, testified, "These gymnasts showed remarkable bravery by coming forward to detail the shocking sexual assaults that they had endured from a USA Gymnastics medical doctor (Nassar) at the same time they were competing at the highest levels for our country. And, as you also heard today, these

athletes reported this abuse with the hope and the belief that their actions would save other young women and girls from the serial abuse that they had endured. Sadly, as our report indicates, the response of the FBI agents who received that information betrayed their law enforcement responsibilities and their duties to these victims."

It is hard to imagine a more demoralizing, disheartening experience than that which these gymnasts endured. They had every justification to surrender to despair and abandon hope. But they could not walk away from the opportunity to prevent what happened to them from happening to other girls and young women. For that, they deserve not only our admiration and respect, but our every effort to hold those responsible to account.

"Nassar is where he belongs, but those who enabled him deserve to be held accountable," Biles testified "If they are not, I am convinced that this will continue to happen to others across Olympic Sports ... A message needs to be sent: If you allow a predator to harm children, the consequences will be swift and severe. Enough is enough."

Melvin Van Peebles, creative genius

ne of the first Broadway plays I ever saw was Melvin Van Peeble's Ain't Supposed to Die a Natural Death. A. Robert Phillips, who led the Black Talent Program at Boston College, arranged for a group of us undergraduates to attend the play, have dinner, and enjoy New York City. I was riveted by the powerful play, a series of vignettes performed by a talented ensemble, who combined laughter, irony, pathos, and more to present a slice of Black life.

Two things stayed with me police officers who were beatafter all these years. One is a ling a Black man and standing. like the other audience members did, to applaud when the film was over.

Some credit Van Peebles with the Blaxploitation genre, but he was so much more than that. Sweetback, to me, was about portraying a different power dynamic than one we were used to in 1971. In Sweetback, you saw a community sticking together, cheering their anti-hero who used everything he had, including his body and his sexual prowess, to elude the oppressor. In 1971, few Black folks were willing or able to give so-called law enforcement officers any pushpushing back since its inception). Sweetback was, if nothing else, a paradigm shift.

Before Sweetback, we saw docile, humble, polite Black men, like Sidney Poitier in Guess Who's Coming to Dinner, or Lilies of the Valley. We saw exotic Black men like Harry Belafonte. And if we go back to Paul Robeson, we saw masterful, but nonthreatening, Black men. We never saw a man quite like Sweet Sweetback. Thanks to Van Peebles,

though, we began to see a series of them. None quite trader and wrote a book about bold enough to kill a police officer, go on the run, and win, but self-assured enough to portray their truth. So there was John (bad mother shut your mouth) Shaft, there was Sam Jackson in Quentin Tarantino's Pulp Fiction and Diango Unchained. Denzel Washington Training Day. So many more. While all of these roles are complicated, and some overflow with stereotypes, they

Even as we tackle issues of anti Blackness, we must also confront the sexism that we see in the Black community, especially in Black film. While these men are not perfect by any stretch of the imagination, they are family and valuesdriven men, role models.

Van Peebles was a role model, too. The multitalented man spent time as an options personal finance. He was a cable car operator in San Francisco and wrote about those experiences in a novel. He was prolific both in English and in French and published several books in France. Van Peebles made full use of his creative gift, and we are all so much better because he did.

Melvin Van Peebles left his footprint on Black cinema. He will be mourned and missed, and his legacy lives on!

Law and order also means the police policing themselves

wish Cariol Horne was on the scene when Minneapolis police officer Derek Chauvin kept his knee on George Floyd's neck for almost nine minutes. If so, George Floyd may be alive today. There is a very high possibility that had Horne been there in 2020, an effort would have been made on her part to stop Chauvin. While Derek Chauvin was charged with second-degree murder and manslaughter, three other officers were charged with aiding and abetting. There are times it is necessary for the police to police themselves.

Former Buffalo, New York police officer Cariol Horne, who is Black, was in a very similar situation in 2006. She intervened to break up a confrontation involving a chokebetween Kwiatkowski, a fellow White officer, and a Black suspect named Neal Mack. "Neal Mack looked like he was about to die," she stated in 2020. "So had I not stepped in, he possibly could have. He was handcuffed and being choked." While Mack con-

tends the officer saved his

life, Cariol Horne was termi-

nated when it was determined that her use of force was unjustified. She was fired from the Buffalo Police Department two months before being eligible to receive her full pension. Waterloo, Iowa is a city of

67,000 residents and has a long history tensions between the police and the city's Black community. Black community makes up 17% of the city

population. On June 1, 2020, Joel Fitzgerald became the first Black police chief in Waterloo. Soon after being sworn in as chief, the reformminded Fitzgerald supported numerous changes. The changes, which are meant to transform the department, includes the banning of chokeholds, outlawing racial profiling, requiring officers to intervene if they see excessive force, and investigating all complaints of misconduct. Along with the efforts to improve policing came the expected backlash. Current

and former officers are not

only opposing the reforms, but fighting the removal of the police insignia which resembles a Ku Klux Klan dragon.

Waterloo is no different than most other police departments. The clash between an entrenched Blue Culture versus the changes needed to hold officers accountable is a main reason many reform-minded officers are leaving. Blue Culture shows how the law enforcement community has a tendency to band together in face of scrutiny and calls for systemic change. Many officers have the integrity, character and ethics to fully serve the public according to their sworn oath. Cariol Horne reminds us of that fact. But the Blue Culture can be deadlv. Derek Chauvin has proven that fact. When people claim to support the police, what type of officers are they supporting? When police reforms are implemented, thereby empowering the Cariol Horne-type officer we are more likely to have Neal Mack-type suspects (lives saved). When those who promote the police status quo, thereby empowering the Derek Chauvin-type officer we are more likely to have the

George Floyd-type suspects (lives taken).

Many of those who support the police status quo believe that incidents of police misconduct are just isolated and not part of a wider problem. Those who believe that misconception tend to overlook the fact that police departments nationwide have their share of officers of low character with no integrity. Usually incidents of wrong doing by an individual officer is not isolated on part. Kwiatkowski, after his encounter with Cariol Horne, was later sentenced to four months in federal prison in 2018 for using "unlawful and unreasonable force" against four Black teenagers. In October of 2021, the mayor of Buffalo signed the Duty to Intervene law which requires police to step in if a fellow officer uses excessive force. This shows that the heart of police reform really comes down to good police officers protecting citizens from bad police officers.

During the same month in which the new law was

What happened to the Haitians?

In a story which has received very little attention, we have learned that the thousands of Haitian migrants who were living under the Del Rio International Bridge in El Paso, Texas, are no longer there.

Although the headlines said the though the majority of the migrants were Haitian, some were from other

countries including Cuba and Brazil.

The Rev. Dr. Frederick D. Haynes III, pastor of Friendship West Baptist Church in Dallas, Texas, visited the camp on Thursday, wanting to see what was going on. He described the conditions there as horrific, noting that the migrants needed many things including showers. He and others with him were not allowed to enter the camp, he said, but were relegated to talking with border officials, who intimated that the migrants were being treat-K. Smith ed well.

But on Friday, when he returned, the migrants - literally thousands of them - were gone.

Some of the migrants were deported back to Haiti, some, the government says, returned to Mexico, and others are being processed in the United States, some housed in Customs and Border Protection centers, and others being processed by the Department of Homeland Securities to see if they can, in remain in the United (https://www.npr.org/2021/09/24/1040446618/biden-borderagents-horses-haiti-migrants-dangerous-wrong)

But it is weird and, frankly, disturbing that in the dead of night, thousands of Haitians were cleared from that encampment. And it is even more disturbing that there has been little attention given to the situation since the migrants were

The Biden administration has come under intense criticism for the way the Haitians have been treated, especially following pictures emerged of border agents beating a Haitian man with a whip.

The president and others said they were horrified that such inhumane actions were being meted out against the migrants. The president said it was "outrageous" that human beings were being treated in that way and said that there will be an investigation.

Investigations in this country of situations involving Black people tend not to be too believable, as they too often indicate that was been alleged to have happened to Black people was

But it will be interesting to see if this "investigation" reveals where these thousands of human beings have been taken and will also answer the question of how the United States government managed to get them out of the encampment - all of them - in the dead of night. It will also be interesting to see if we learn why the mass deportment - or removal - done at night?

It is no secret that many Americans do not want immigrants of color to be admitted into this country, but it's also interesting to note that the resistance to welcoming brown and Black immigrants is global. Nobody wants Black and/or brown people in their country. That resistance has resulted in violence in places throughout the world.

In this country, especially since 911, the resistance to immigration of has grown exponentially in this country. There is is a great fear, it seems, among white people, that there is a move on to replace them with brown and Black people. Many, including Fox News personality Tucker Carlson, are pushing people to believe that "replacement" of whites is real.

Ar the same time, they don't want people to think that they

So, perhaps the US government was acting with concern and compassion, and not sheer terror that there were just too many Black people being admitted to this country. Maybe it is that fear that motivated the Biden administration to approval of the removal of the Haitians in that encampment to be removed in the dead of night.

The new Attorney General Merrick Garland recently reported to Congress that the CRS has only 26 staff members. In its heyday in the late 1960's, it had over 300! Mr. Grande Lum, President Obama's CRS Director from 2012-2016 and Ms. Grace Flores-Hughes, President Reagan's and George H.W. What would have happened if the CRS had 300 full-time Peacemakers and a leader with the Stature and Wisdom of a modern-day Roger Wilkins, receiving information that a busload of people was driving to DC from a southern state, to try to stop the counting of electoral votes by the Vice President

on January 6. The CRS is the only Federal agency with the express purpose to identify and defuse volatile racial and homophobic situations. It has express jurisdiction over violations of the Matthew Shepard Act, and it has developed an extensive library on record of saving faces and to provide safe spots for peo-

ple who want to be more open about their sexual identities. Roger Wilkins was related,

by blood and by common interests to many of the civil rights leaders of his day. His uncle was Roy Wilkins. Roger interned for Thurgood Marshall at the NAACP Legal Defense Fund. The NAACP was the only national civil rights membership organization with deep roots across the Jim Crow south. After Nixon won in 1968, the CRS was toast. Roger Wilkins became a journalist for the Washington Post and the NYTimes. He wrote his three years as CRS Director were "blurs of pain and glory," and that the CRS resources "were meager; its needs monumental." He recalled his sense of betrayal when white DOJ colleagues were invited to a fancy dinner at a Detroit power brokers' segregated club, excluding him from meeting with people who could be quite useful in dampening down the hostilities in the streets. He loved telling the story about walking up to Michigan State Troopers, who were using their batons and rifles on the thousands of voung Black men in the Street. In his finely-cut three piece suit, Roger Wilkins would approach the Trooper check point, his hands reaching for the sky, yelling at the top of his voice: "Department of Justice" "Department of Justice" thinking about his good friend, John Lewis on the Selma Bridge.

the NAACP has had good success working with a federal agency hardly anyone has heard of--the Community Relations Service (CRS and its Conciliation specialists--Peacemakers. **Brief History of CRS**

Two weeks after Dr. Martin Luther King Jr. and Rev. John Lewis brought the strong messages of equality and Freedom Now to a quarter of a million people gathered in D.C., the KKK planted 15 sticks of dynamite in the stairwell of an important Movement Church, 16th Street Baptist and detonated the bomb at 10:19 in the morning. Three 14-year-old girls, and one 11-year old, were dressing up to go upstairs to join their parents for the adult services. They were blown to bits! Twenty other worshipers were badly injured,

The KKK backlash was followed by Dr. King and Rev. Lewis turning up the heat in Selma Alabama, with marches across Edmund Pettus Bridge, and a March from Selma to Gov. George Wallace's office Montgomery. Rev. Lewis got his head cracked open by Alabama State Troopers in 1964, and a Detroit Union member, Viola Liuzzo was murdered by the KKK as she drove marchers back from the Montgomery March. These televised attacks on Black and White protesters for equal rights led directly to the Passage of a series of 10 Articles in what was called the Civil Rights Act of 1964.

The best-known Article probably is Title VII. It put a powerful tool in the hands of southern NAACP lawyers and Branch Presidents-a Federal Friend called the **Employment** Equal Opportunity Commission (EEOC). Black, Brown and all Women workers could file charges of discrimination against the entrenched white male employer network, when applied for jobs, promotions, training and, later, when they had been subjected to offensive and hostile work environments. Jim Crow had been outlawed for 10 years, thanks to the NAACP's 19954 Supreme Court Victory in Brown v. Board, but it was alive and well across the south (and North) in 1964. Article IX forced public schools (from kindergarten to graduate schools) to provide

girls and women-to be empowered and refreshed by competitive sports which had been almost exclusively reserved for boys and men

throughout history. Article X of

the 964 Civil Rights the created i r s t Community Relations Service McSurely (CRS), Peacemakers. President

Lyndon Johnson strongly supported The Peacemakers and quickly named Roger Wilkins, a well-connected Washington Black lawyer, to Generalship, and as the first Director of the CRS. Within weeks Wilkins was flying to Selma where John Lewis and scores of Student Non-Coordinating Committee (SNCC) organizwere non-violently marching into nightsticks of quite violent troopers. A few days later, Viola Liuzzo was killed by KKK at short range, while an FBI confidential informant sat next to her in the car, knowing he too would

be murdered if he disclosed he was an FBI employee. For the next 57 years Peacemakers like Wilkins walked the tightrope of being quite open that they worked for the US Department of Justice, while staying on speaking terms with both sides in the long struggle righteous people in the south, Black and White, were waging to dismantle institutional racism, sexism, and, more recently, prejudice and hate

against LGBTWQ people. Peacemakers work is similar to US Ambassadors in foreign countries. They worked to insure both sides in the Jim Crow South knew exactly what the other side wanted. They facilitated back-door conversations with pridefilled politicians and community leaders. They arranged face-saving ways to back out of public statements. They knocked down rumors that spread like forest fires, ending in violence. Peacemakers created dialogue; sometimes

The song writer penned it well, "my hope is built on nothing lesson than Jesus blood and righteousness, I dare not trust the sweet frame, but wholly lain on Jesus name. On Christ the solid rock I stand, all other ground is sink sand."

Let's began by read our Scripture text: 2 Timothy 3:1-5, (KJV) "This know also, that in the last days perilous times shall come.2 For men shall be lovers of their own selves, covetous, boasters, proud, blasphemers, disobedient to parents, unthankful, unholy,3 Without natural affection, trucebreakers, false accusers, incontinent, fierce, despisers of those that are good,4 Traitors, heady, high minded, lovers of pleasures more than lovers of God;5 Having a form of godliness, but denying the power thereof: from such turn away." This is a picture of future society that we have now enter-a terrible picture of what the last days of human history will be like. But note a

shocking fact: it sounds very much like the society of today. We just do not think of our day as being so terrible; we seldom sit down and study the godless marks of society. But this is exact-

ly what this passage does: it discusses the godless marks of the last days. marks come close to painting a picture of our day and time. This

fact points to day being part of the last days. It is very possible that the Lord's return is at hand. One thing

is sure, we must do just what Christ said: be prepared for His return, for He can return at any

1. In the last days perilous times shall come (v.1). 2. Mark 1: a godless world (v.2-4).3. Mark 2: a powerless religion (v.5). 4. Mark 3: a corrupt ministry (v.6-9).

In the last days perilous times shall come. Perilous times means difficult, troublesome, trying, uneasy, hard, violent, threatening, and dangerous days. The picture is that of people turning to and fro, here and there, not knowing which way to turn "The last days" is a Biblical term that points to the end of the present age, the days right before the return of Christ, and the end of the world. It should be noted, how-

days sound very much like a pic-

ever, that the marks of the end

time are somewhat characteristic

1. People will be lovers of their own selves: this does not mean the normal and natural love of life and of oneself that we should all have. It means selfishness and self-centeredness... o to focus upon oneself and one's own pleasure and flesh instead of upon God and other people, o to put oneself before others: wife, husband, parent, child, friend, neighbor, God. o to put one's own will before God's will, o to seek one's own desires without considering others. o to go after what one wants even if it is unwise and hurts others. o to feel that everyone and everything should revolve around oneself, o to focus upon one's own pleasure and flesh and ignore the crying

needs of the desperate and dying.

Self-love sets one up like a god and feels that nothing matters as much as the pleasure of oneself. In the last days people will love themselves more than they love anyone else. Selfishness will be one of the terrible marks of the last days. This is the behave being demonstrated by the leadership we have in Washington DC, and what is being demonstrated in the cities across America (Trumpism).

People will be proud: self-exaltation, conceit, arrogance; being haughty; putting oneself above others and looking down upon others; scorn, and contempt. It means to show oneself; to lift one's head above another; to hold contempt for another; to compare oneself with others. Pride can be hidden in the heart as well as openly displayed (it is the spirit of the anti-Christ already at work in

Very simply stated, the proud person feels that he is better than others. Note that this is a feeling within the heart. The proud person may appear quiet and humble, but within his heart he secretly feels better than others. God resists the proud.

People will be blasphemers: the word means to slander, insult. rail, revile, reproach, curse. Blasphemy is usually thought to be against God, and it is. But it is also a sin against men. Men can blaspheme men. Think of the cursing and insults thrown against God and men today. Practically everyone is cursing and reviling someone: mothers, fathers, children, teachers, professionals, actors, comedians, politicians, even some professing religionists feel the need to occasionally curse in order to be acceptable (again this what we see being demonstrated, even among those who say they are Christians, the last President broke all of these rules and set a bad example for other in the political arena).

Why is there so much cursing today? Because there is a loss of respect for both self and others, for both position and authority. People rail, revile, insult, reproach, and curse when they are disturbed within-when they sense dissatisfaction, disapproval, unacceptance, bitterness, emptiness, loneliness, and reaction within their heart. A disturbed and dissatisfied heart causes people to blaspheme God and man, including themselves (blaming and cursing themselves when they fail and come ever so short). The second mark of the last days will be a powerless religion. Note: there will be religion in the last days. It will be just like today, churches and temples and worship centers will be every-

where. People will claim and profess godliness, but their worship will be only a form, only an outward profession, only an appearance of godliness. They will not possess God; they will not have God in their hearts and lives. They will profess God and Christ, be baptized in the Christian faith, attend worship services, participate in the rituals and ceremonies recite the creeds and sometimes talk about

But they will deny the power of God. What is the power of God? It is the power to deliver men from the bondage of sin, death, and hell-all through the Lord Jesus Christ. It is the power of the cross and resurrection of the Lord Jesus Christ-the power to save people from perishing and to give them eternal life (POSB-C). This is exactly what Scripture says. Father, in the Name of Jesus I pray that you will open the eyes of the Church that we may see, that the spirit of the anti-Christ is already presence in the World and invading the church. In Jesus Name we pray Amen.


