## Museum L-A Collins Questions Fauci on Maine's vaccinated COVID Cases

U.S. Senator Susan Collins questioned two of the nation's top public health officials, Dr. Anthony Fauci and Centers for Disease Control and Prevention (CDC) Director Rochelle Walensky, at a Senate Health Committee hearing about the federal government's ongoing response to COVID-19. The hearing November 4, titled "Next Steps: The Road Ahead for the COVID-19 Response," was the Committee's fourth hearing with federal officials on the pandemic this year.

Senator Collins began by asking Dr. Fauci why COVID-19 is taking such a heavy toll on the State of Maine. Maine is one of the most highly vaccinated states in the country, and 95 percent of Mainers over age 65 have been fully vaccinated. Nevertheless, over the previous seven days, Maine had the 15th highest current COVID-19 case rate on a per capita basis and the 22nd highest death rate on a per capita basis among U.S. states. In addition, Maine has recently experienced a six percent increase in hospitalizations, an 18 percent increase in people in the ICU, and a 37 percent increase in people on venti-

"First, let me make clear that I believe in the efficacy of vaccines and have encouraged my constituents to become vaccinated," said Senator Collins. "But I'm hoping you can explain what appears to be a contradiction when I look at the data for the State of Maine. Maine ranks in the top five states in the percentage of people who have been vaccinated. Can you explain to me why a state that has done a terrific job in getting people vaccinated is seeing this surge in cases that is overwhelming our hospitals and causing great fear, and pain, and loss?"

Dr. Fauci responded that Maine's high caseload is due to COVID-19 infecting unvaccinated populations as well as breakthrough cases among the vaccinated.

Dr. Fauci went on to say, "[A] vaccinated compared to an unvaccinated person has a multifold less likelihood of being infected, a multifold less likelihood of being hospitalized or dying. I think there were probably confounding multiple factors going into the difficult situation that your citizens in your state are going through, but there's no doubt that the vaccines are clearly much better in the sense of protecting you from infection, hospitalizations, or death compared to the unvaccinated.'

Turning to Dr. Walensky, Senator Collins raised the promising "test-tostay" approach that allows asymptomatic students who test negative for COVID-19 to remain in school rather than quarantining after another student or a staff member has tested positive for the virus. A study in the peer-reviewed British medical journal The Lancet found that case rates were not significantly higher at schools that allowed close contacts of infected students or staff members to remain in class with See COVID, page 16

#### Services launches new portal Revenue laine

Augusta, MAINE -Maine Revenue Services has launched an online portal meant to improve functionality and access for Maine people - and integrate all taxes administered by the agency into a new, single online system. The Maine tax portal will integrate all taxes administered by Maine Revenue Services into a single on-

line system over a period of four years. The Maine Tax Portal will both improve and increase the online capabilities for taxpayers and practitioners and will gradually replace current online services.

The Maine Tax Portal will allow taxpayers and practitioners to make online payments, view bills and notices, and perform

account maintenance activities, such as, adding or removing addresses and closing an account. Depending on access level, authorized representatives may view submissions, letters, messages, and submit payments and returns on a taxpayer's behalf.

The Maine tax portal's expanded online services will be implemented in four separate annual rollouts over the course of four years. The tax types

included in the first rollout, and currently functional, include State of Maine: corporate income, franchise, insurance premiums (including fire and non-admitted premiums), estate, health care provider, blueberry, potato, mahogany quahog and railroad excise and marijuana excise.

The new system will also be used for internal processing, compliance enforcement, administering audits, and for case management including appeals.

All taxpayers currently registered for the tax types noted above will receive an invitation to set up an online account for the Maine Tax Portal via U.S. Postal Service in October or November. Taxpavers may create an online account and access the system. Full user instructions are available at Maine.gov/ Revenue.

In addition to this effort, under the Maine Jobs & Recovery Plan, the Mills Administration is slated to invest approximately \$50 million in Federal monies into safe and efficient State system upgrades to enhance the citizen experience and improve convenience. These Federal funds will support targeted upgrades for citizen-user friendly interfaces and systems, as well as the cyber security investments needed to ensure safe State op-

## Auburn lowers fees & streamlines permit process

AUBURN – The City of Auburn is required to review its charter and ordinances - in their entirety - at least once every 15 years. As part of this required review, the City Council created an Ad-Hoc Permit and Fee Review Committee, comprised of Ward 1 Councilor Holly Lasagna, Ward 2 Councilor Timothy MacLeod, and city staff.

This temporary com-

mittee was charged with identifying opportunities to streamline, simplify, and clarify the process and fees associated with obtaining city permits. Members presented the changes in a series of workshops held in March and April of this year; and the changes were approved in a unanimous vote by Auburn's City Council at a meeting held this evening. "The intent

of this effort was to make it easier for residents, contractors, and businesses to understand our permitting process," said Assistant City Manager Brian Wood. "We also lowered and/or consolidated fees wherever possible. We want to send the message that Auburn is project-friendly and easy to work with, no matter how large or small the project."

Some of the most

single-family building permits. New construction, additions, and mobile homes will be a flat fee of \$25 instead of \$0.25 per square foot, which will add up to significant savings. There was also simplification of certain electrical permit categories. Businesses will also benefit.

The city has completely removed licensing

significant changes impact costs for certain businesses, requiring only that those businesses register with the city. Alcohol beverage establishments will also see a far more streamlined fee structure. Lounges, taverns, restaurants, and similar businesses will pay flat fees, regardless of square footage. "This committee has done exceptional work - this is great; this is real progress," said Mayor Jason Levesque. "Our shared goals of improving and enhancing our relationship with our residents, making each visit to Auburn Hall faster and easier, and supporting growth and improvement projects is a win for residents, contractors, businesses and the city alike." "It feels good to vote for less government," said Ward 3 Councilor Stephen Milks following the vote.






Brister noted, "To have a chance to bring professional women's basketball to a venue like the Armory, it was a no brainer. There we hope to

Maine has moved to a state-based Marketplace, CoverME.gov which will benefit Mainers in need of coverage in many ways. Individuals who need health insurance coverage should

visit CoverME.gov to learn about coverage options and where to go for help sorting through their options and enrolling coverage. For example, CoverME.gov includes a plan compare tool, to help people compare plans and make sure their doctors, hospitals and other providers are included in the plan they choose, and estimate how much financial help their family may qualify for to lower monthly premiums or outof-pocket costs.

CoverME.gov also includes a "Get Help" tool that can be used to help

Maine people find trusted resources – trained assisters and brokers, who can help answer questions about Marketplace coverage and help enroll people in coverage. Mainers previously enrolled through HealthCare. gov which will now redirect people to CoverME.gov for enrollment assistance. CoverME.gov also provides information about Maine-Care, the state's Medicaid program that provides coverage to people with limited inåcome. People can apply for MaineCare any time.

Ann Woloson, Executive Director of Consumers

for Affordable Health Care encourages anyone who needs coverage heading into 2022 to check out their options through CoverME. gov. "We know there are thousands of Mainers who remain uninsured; many are not offered coverage through work, can't afford employer-based coverage or have lost their coverage due to the pandemic. CoverME.gov is an important resource for people who need help understanding their health coverage options and enrolling in coverage." Woloson added "there truly are more affordable

options available to Maine people due to changes made by Congress earlier this year. Tens of thousands of Mainers across all household income levels are seeing lower monthly premiums as a result of larger premium tax credits that reduce plan prices."

Consumers for Affordable Health Care is designated as Maine's Consumer Assistance Program by Maine's Attorney General and the Bureau of Insurance. It provides confidential face-to-face and toll free, assistance through its HelpLine to any Mainer

seeking assistance understanding their health insurance options or who needs help enrolling in coverage. It works closely with other certified Maine Enrollment Assisters, such as Western Maine Community Action, to provide information about health coverage and where to go for help enrolling in coverage. ## Healthcare system staffing shortage grows

I am sure that by now you have all read and seen the stories of Maine hospitals reducing services, diverting patients, or rationing care, in the wake of the Governor's mandate, that healthcare employees receive mandatory vaccina-

tions or lose their jobs. This has created a larger staffing shortage for healthcare systems throughout Maine.

The alarm was sounded two weeks ago when Central Maine Health Care (CMMC) met with a bipartisan group of legislators to express their concern over

having to force skilled employees out of their jobs, because of the Governor's mandate, and the lack of a testing option for employees

CMMC said they will be forced to reduce services in units such as trauma, heart attack, and pediatrics. Central Maine Health deserves praise for being willing to come forward and offer a solution that is afforded every other business: regular COVID-19 testing. Unfortunately, the Governor will not consider this option.

Then, at the end of last week, Down East Community Hospital announced that they would not be accepting ambulance patients into its Emergency Room bay. Writing: "Due to staffing shortages created by the vaccine mandate, the inability to transfer psychiatric and long-term care patients, and the gen-

eral delays in transferring patients that need a higher level of care to larger facilities, we are experiencing significant delays in the emergency departments at both Down East Community Hospital and Calais Community Hospital. All of these issues reduce the number of Emergency Room beds we have available..."

Then, we learned that a 42-bed facility in Saco with 35 patients will be closing for the same reason.

Still--nothing from the Governor.

The Down East Community Hospital statement says they are unable to move patients into larger facilities and long-term facilities, echoing the concerns raised by Central Maine Healthcare that, not only do they have a reduced number of beds because of their staffing

issues, the staffing issues at other facilities caused by the mandate are further reducing available beds because their patients have nowhere else to go.

Then, Thursday of this week, York Hospital announced they are suspending emergency services at their Wells facility. Seacoastonline reported that the suspension occurs "amid a staffing shortage and an approaching end of the month deadline for Maine health care workers to get vaccinated for COVID-19."

The hospital says that the staffing shortage is not a result of the mandate, and we should take their word, but the fact that in the midst of an existing staffing shortage the Governor continues to ignore calls of Maine's healthcare providers for relief from a policy that is further reducing available healthcare staff is

baffling.

This is heavy-handed government at its worst. This is taking a problem and making it worse by refusing to consider the needs of people on the front lines.

Throughout this pandemic, the Governor has refused to adjust policies to meet the realities we face day-to-day.

Despite the cries for help from workers once hailed as heroes for serving us amidst a pandemic, the Governor remains committed to a policy that is creating a healthcare system crisis by reducing access to care from York to Washington County.

Mainers should not have to suffer because the Governor is unwilling to admit her policy needs to adjust to the real life realities brought to her attention from members of the healthcare community serving the public.

### "The Ghosts of Walter Crockett" Memoir released November 16

YARMOUTH, ME. In the 1960s and 1970s, Ed Crockett and his siblings were raised in poverty on Munjoy Hill. The children of a homeless, alcoholic father who lived on the streets for nearly twenty years and who was once known as "the biggest drunk in Portland."

In his new memoir, Portland-native Crockett—a state representative and president of Capt'n Eli's Soda—recounts his struggle to break the cy-

cle of alcoholism, come to grips with the embarrassing specter of his father, and overcome the shaky confidence brought on by a childhood of food stamps and welfare coats, to eventually find success on the same streets where his father once spent his days passed out and begging for money. It's a rough upbringing, but amidst the turmoil Crockett also finds role models, the importance of neighborhood roots, the joys of wiffle

ball, and the unconditional love of family.

The Ghosts of Walter Crockett, officially slated for release on November 16 from Maine-based Islandport Press, is at times harrowing and heartbreaking, but ultimately is a tale of love and redemption that takes readers to a side of twentieth century Portland that has always existed in the shadows of lighthouses, lobsters, and sunsets, but is rarely explored in print.

"Ed Crockett writes

with love, honesty, emotion, and sometimes heartbreak in this unflinching look at his family and his personal struggle to break from poverty, escape the downward pull of his surroundings, and come to grips with the mental anguish caused by his father," said Dean L. Lunt, editor-in-chief of Islandport Press. "Ed also shines a light on the very real, working-class Portland that existed on the peninsula before million-dollar con-

dos, fancy hotels, and hip restaurants."

Ed Crockett grew up on Kellogg Street in a two-family home with his mother, grandparents, and seven siblings. He graduated from Portland High School, earned a bachelor's degree from the University of Maine, and an MBA from Boston College. During his career, he has worked for some of Maine's most iconic brands—including Oakhurst Dairy, Hannaford Brothers, and Lepage Bak-

eries. Crockett and his wife, Martha, raised three children in Portland and still live there. This is his first book.





## Maine Playwrights Festival open for submissions



PORTLAND - Acorn Productions, producers of the annual Maine Playwrights Festival, announces that they have begun accepting scripts for this year's twentieth edition of state's long-running incubator for new plays by local playwrights. Anybody living in Maine is eligible to submit a new play between 8 and 30 minutes in length for consideration in the festival. The deadline for submissions is Sunday, November 28th. Submission information is available at www.acorn-productions.org.

'We're proud to have produced the 2021 festival as an online streaming experience, but we're also looking forward to being back in a theater for our 20th anniversary season," says Daniel Burson, the festival's Artistic Director. "If the pandemic does not allow for in-person performances next spring, though, we'll be ready to pivot. In that case, the 2022 festival will either move outdoors, or be filmed and released for on-demand streaming. We're committed to showcasing the work of Maine's playwrights-whatever it

takes."

The festival is centered on developing and honing short plays, from submission through staged readings, rewrites, and culminating in public performances. The 2022 Maine Playwrights Festival will be comprised of two weekends of fully staged performances of short plays, to be performed in Portland in April-May (if the public health situation allows). The festival anticipates selecting 5 to 7 short plays for production this year. The selected playwrights will receive extensive support revising their pieces during a workshop phase before the plays go into rehearsals.

In addition to the fes-

tival productions, several playwrights not selected for the full festival will also get the opportunity to workshop their plays with this year's professional playwright-in-residence (to be announced in September). Acorn is also offering a playwriting workshop this fall-taught remotely over Zoom-for playwrights of all experience levels to work on refining their scripts for submission. wrights Festival evolved through the years from a set of dramatic readings at Acorn's old studio on Congress Street to a full series of performances by some of Maine's bestknown playwrights. Each year, playwrights from across Maine submit between 50 and 70 scripts to the festival, and a committee of local theater professionals reads them and selects a small group of plays for production at public performances in the late spring. Over the years, the festival has showcased over 100 Maine playwrights, many of whom have subsequently had their work produced at theater festivals all over the country.

## **Protect Maine's Workers**

Senator Susan Collins' family has run a local lumber company since 1844. In her own words, family-owned businesses like these -- and the workers that power them -- are the "heart and soul of many Maine communities."

But now, those workers are under threat from President Biden's sweeping immigration proposal. The White House is attempting to ram this massive social-engineering experiment through Congress in the midst of our recovery from a devastating pandemic. It's illtimed, divisive, and will harm a broad swath of people who have to work hard for a living.

Folks on the left seem hesitant to admit that increased immigration could have harmful effects on anyone, including the working class. But studies have shown that increases in immigration result in lower incomes and fewer job opportunities for many workers already living in the United States.

The sheer scale of President Biden's plan is unprecedented. It would

grant the right to work openly to 11 million illegal immigrants. That's over eight times the entire population of Maine. It'd also greatly expand legal immigration and guestworker programs. All told, it could increase the number of legal U.S. residents by 37 million people in just a decade

Those new workers will compete for jobs with Americans already struggling with the cutbacks, furloughs, and layoffs caused by the pandemic.

The long-term effects are just as troublesome. Although Biden's plan is trumpeted as "healing," it will in fact harm many of the people who voted for him. These are the workers who don't have tech expertise and compete for lower-skilled, often manual-labor jobs. And that's exactly where the flood of immigrants -- who by and large are low-skilled -- will be heading.

To make matters worse, immigrants usually work at the low end of the pay scale, putting downward pressure on wages for everyone.

Here in Maine, our

population is blue-collar. Mainers make their living in paper mills and on fishing boats. We work in restaurants, retirement homes, and small-scale manufacturing operations. We don't have the white-collar privilege that shields us from immigrant competition. So we can't so easily say "all this doesn't affect me" because it does

And we vote.

Sen. Collins knows her voters. And she knows how they feel about amnesty. President Biden may want to take credit for "solving" the issue of illegal immigration by simply ruling that the problem no longer exists. But loggers and millworkers know otherwise. So, one hopes, does Sen. Collins. If this bill passes, the problem won't go away, it will become worse for many Americans.

## **Honor Maine Veterans with Higher Education Reforms**

As we approached Veterans Day, I was reflecting on the oath I took to serve, protect, and defend our American values when I served in the Army. There are roughly 127,000 veterans who live and work in our great state. They all deserve to know their state and country have their back, especially as they navigate the challenges that can often come with the re-entry process. As more and more servicemen and women return from Afghanistan this fall, their re-entry has been front of mind for me as a

Figuring out how to compete in the private sector can be challenging, and many people – both fresh out of high school and later in life – choose higher education as a means to create future opportunities. Choosing a college can be one of the toughest financial decisions that some families must make. Fortunately for veterans, the GI Bill has been helping cover costs of school or training since 1944. In 2018 alone, over 650,000 veterans used their hardearned benefits to pursue a higher education degree.

I encourage veterans to utilize their GI benefits. I did, and that college experience coupled with real world military experience prepared me for a successful career in business and civic service. Whether they were based in Djibouti. or Brunswick Naval Air Station, Portsmouth Naval Shipyard, or Afghanistan, our veterans deserve to know there are high quality educational opportunities for them following their service right here in Maine. However, it would seem that not all colleges have equal results.

looking Veterans for re-entry opportunities through higher education don't have access to quality data to make informed decisions on where their military benefits would go the furthest. Based on the limited information available to the U.S. Department of Education, 30% of schools in Maine graduate less than half of the students who entered its doors four years prior. With some schools in our state reporting completion rates as low as 18%, these statistics are just two of many that illustrate that there is plenty of room for improvement when it comes to higher education policy.

It's past time to modernize our nation's postsecondary policies with some fundamental, common-sense re-

Requiring basic reporting on metrics like enrollment, completion, and post-college success rates would have a multitude of benefits. Not only would these reporting requirements shine a much-needed light on institutions and program areas that need improvement, but they would increase accountability for schools to get their students - including veterans - across the finish line. The College Transparency Act helps to ensure a return on investment for Maine veterans, students, and families, by providing them with the resources they need to make an informed choice.

State and local officials cannot enact these needed policy updates alone; we need our Washington counterparts to act to get these postsecondary education accountability measures passed. I hope Congress chooses to honor our veterans' service this Veterans Day by prioritizing passing legislation that benefits them. It's time to act on higher education re-



daily testing than schools that required students to quarantine at home. Senator Collins previously pressed the Secretary of Education to consider this method in September.

"Dr. Walensky, parents, teachers, and pediatricians have all talked to me about the learning loss, the emotional and behavioral health problems, that

have occurred among children due to their not being in school," said Senator Collins. "Brown University professor Emily Oster has expressed great frustration with the CDC being slow to take a stronger position in favor of test-to-stay... Another public health expert said simply 'It's madness to quarantine school children. The CDC policies hinder learning and provide no meaningful reduction in COVID trans-

missions.' My question for you is, why doesn't the CDC issue guidance or recommendations to encourage school districts to adopt test-to-stay in order to avoid these highly disruptive quarantines of students who are asymptomatic and could be tested?"


In response, Dr. Walensky said the CDC is "working with local jurisdictions now to demonstrate the domestic data here in the United States

that this practice works, it's safe, it's effective, [and] it gets our children back to school. And importantly, we recognize that jurisdictions are actually doing this and other jurisdictions

may want to. And in that context, we're doing peer-to-peer matching of schools that are interested in doing the testto-stay practice and having them talk to schools that are also doing it so they

can use the implementation strategies that a school has already used. So we're actively studying this so that we can provide the data on it working, and we're actively encouraging it as a promising practice."
