## **Policies Voted on At Fall Banquet**

The following policies were voted on at our Fall Banquet on October 1st, 2021.

The policies were then brought to the state policy development meeting held on October 28, 2021. At this time some policies were thrown out due to their redundance or such.

National Policies: We recommend that the USA prohibit the purchase of public and/or private real estate located in the USA by members of the Chinese Communist party.

Berks Policies (Local Policies)

- 1. We recommend that crop insurance have a 578 status.
- 2. We recommend that the right to hunt be by permission of the property owner, not the responsibility of the property owner to post "no hunting."
- 3. We recommend that "family and rural life" provisions abortion and marriage be eliminated.
- 4. We recommend the complete financial statement for PFB be available to members who request it.
