Mille Lacs Trails Snowmobile Club operates like a business

In anticipation of the snow season, Mille Lacs Trails Snowmobile Club accepted their new Pisten Bully Groomer in October 2021.

"It cost about \$250, 000," explained Trail Coordinator Dean Fisher of the club. It has two tracks on it, rather than four, Fisher explained, so they can go over swamps and creeks with it without getting stuck.

To maintain their 150 miles of trails, they have a full fleet maintained by Al Pearson. There is an old pickup truck, a gooseneck trailer, three groomers, two snowmobiles,

two ATVS and a skid steer

with a grapple, bucket and

brush-cutter attachments. "Al Pearson keeps everything going unless it is a major repair," Fisher explained. For example, the 300-plus mile pickup needs

a transmission and that will be outsourced.

Social and recreational pur-

The snowmobile club is a leader in the social life in the Glen Malmo area. They just finished a Santa event for families and in February they will have a meet and greet with hot food and drink to attract snowmobilers to their Fred White Memorial Shelter.

They also teach snowmo-

bile safety classes for youths and give donations from to many charitable causes in the area.

"We fund our operations through a yearly Minnesota Grant in Aid trail grant and from pull tabs sales around the Mille Lacs Lake and Aitkin areas."

They give a substantial amount of their proceeds away to children's programs of all kinds, veterans, people with a health crisis and many other needs in the area.

For example, in the charitable gambling report filed in December 2020, they sold \$5.3 million in pull tabs in the previous year. Of that, prizes were over \$4.5 million, netting \$835,156. Allowable club expenses totaled \$449,150 plus \$2,450. Charitable giving was \$88,962. Taxes and fees took an additional \$270,483, leaving the club with \$107,723 of retained cash.

Grooming

It is a gargantuan job for Fisher and Joe Emory to maintain the trails. The 150 miles is more like double that due to having to go over areas forward and back. "We usually go out early in the morning or at night," Fisher explained.

"The shortest run takes about four hours and the long one can be up to 12 hours."

Their trails meet up with those of other clubs: Aitkin Sno Drifters, Mille Lacs DriftSkippers and Tamarack Sno-Flyers.

They would like to see 8 or 12 inches of snow for a good base. This year, as of press time, there was less than eight inches of snow on the ground. The groomers were pulling a packer wheel behind a four wheeler and packing everything down

Grooming is rather lonely and perilous with creeks and swamp water all over the routes. "We cut the ice with a chainsaw that is marked by inches and we want at least 12 inches of ice to put the groomer over it," noted

Preparing the trails, volunteers cut away "faceslapper" branches and remove brush. Trees are cut at the base and later removed by the skid steer. Over 30 volunteers get a free breakfast for helping

"We really appreciate that land owners that let our trails go over their land," said Fish-

New radar units put Cuyuna police communication on the fast track

The Cuyuna Police Department's radar unit was sorely in need of an upgrade. The unit was nearly 30 years old and its aging technology affected accuracy and frequently experienced interference. Through Community Match Funds, the department upgraded to a state-of-the-art 800mhz, digital-encrypted squad radio, antenna radar, and office-base radio.

"It was like going from a Pinto to a BMW," said Chief Jesse Smith, Cuyuna Police Department. "People who love radar, love running this new unit. The smart tech allows the ability to track speed from front or back and it transitions automatically to moving or not moving."

The technology upgrade was especially timely as it corresponded with major state highway detours in the area, which routed additional traffic through Cuyuna for several months during the summers of 2020 and 2021. The detours brought increased public safety concerns due to impatient drivers

"We really appreciate Sourcewell's support in making this happen," said Chief Smith. "This radar was extremely important—a huge deal in allowing us to do our jobs effectively. We're so happy it could happen now, instead of having to budget for years for it to happen. Now we can do our jobs

much more effectively."

The Cuyuna Fire Department is currently transitioning to the new radio system, which is also used by the Crow Wing County Sheriff.

In addition to the public-safety benefits of monitoring the roadways, the new technology allows the Cuyuna officers opportunities to engage in conversations about it with area residents. As they demonstrate the improved capabilities of the technology, the officers can build relationships with the community—explaining that they pursued acquiring this new technology because ensuring the safety of the community they serve is of utmost importance.

DNR certifies new muskie record

An angler caught a muskellunge weighing 55 pounds, 14 ounces, from Mille Lacs Lake that the Minnesota Department of Natural Resources has certified as a weight-based state record. The previous record was a 54-pound muskie caught from Lake Winnibigoshish in 1957. Although news of the fish has spread quickly in the news and social media, a

record is not official until the certification process is complete.

Nolan Sprengeler caught the muskie on Nov. 22, with friends Kevin Kray and Zack Skoglund. Their plan was to fish the afternoon until after moonrise, which was about 8 p.m. After some delay due to low water and frozen water at accesses, they eventually broke some ice to get Sprengeler's boat in the

evening at about 9 p.m., I felt a tap on the end of my line. I fought the fish to the boat and Kevin Kray netted it for me. The fish measured 57.75 inches by 29 inches," Sprengeler said. "After trying to revive the fish for about an hour we realized she wasn't going to make it. We


"When you donate a scholarship, you are truly giving the gift of nature to a young person," McMillan said.

Since reopening in June after being closed for nearly a year and a half, Long Lake has welcomed schools from around the state, and hosted firearm safety training courses, as well as various retreats, reunions and meetings. Though the reopening was smooth, the lingering

effects of the pandemic can still be felt. A dozen schools cancelled their normal trip to Long Lake due to COVID, representing a loss of more than 33% of total revenue, McMillan said.

Long Lake is an enterprise of Aitkin County, but is self-funded. Though it receives support and services from the county, it is not designed to receive taxpayer dollars. The fundraiser was made possible by the Long Lake Conservation Foundation, a 501(c)3 that supports the Conservation Center's mission of environmental education and in particular, the teaching of wise-use of our natural resources. Rep. Dale Lueck legislative update

The Minnesota Office of Management and Budget announced a whopping \$7.746 billion surplus for the Fiscal Year (FY) 2022-23 biennium. The FY 2022-23 biennium began this past July 1st and runs through June 30th, 2023. \$7.746 billion is the largest projected budget surplus ever in the state's history.

The \$7.746 billion figure includes a carry-forward of \$3.1 billion from excess tax collections in the previous 2-year state budget. The remainder of the surplus is indeed a forecast, representing the projected difference between future tax collections and authorized state agency spending during this biennium.

The \$7.746 number is not the whole story. The state also carries \$2.656 billion in the emergency reserve account, a \$350 million balance in the cash flow account, and about a \$312 million balance in the stadium reserve account.

\$52.3 billion in general fund spending is authorized for the current biennium, the current projection indicates the state will end up collecting about 15% more taxes than is needed to meet authorized FY 2022-23 agency spending.

We often hear "government has a spending problem." Consider that despite an extreme hit to our economy due to COVID, Minnesota continues to wallow in billions of surplus tax collections.

I believe "Minnesota has a huge taxing problem" also applies. What do we do? First, we do not create a bunch of new entitlement programs to spend the excess tax collections. Second, we don't send lump sum bank deposits out to everyone in Minnesota that has a pulse.

Here are a few suggestions:

Immediately use unspent federal COVID relief dollars still in the governor's federal COVID checkbook to pay back the over \$1 billion Minnesota borrowed from the federal government to bail out the state's unemployment insurance account. The governor slammed the doors shut on Main Street businesses, forcing massive layoffs. Pay that loan back now, do not drive Main Street businesses back into extremis with huge increases in their unemployment insurance premiums.

Finally, stop collecting state income taxes on seniors' Social Security retirement checks. Eliminate the healthcare user's tax, a 1.8% hidden sales tax you pay every time you access any form of healthcare. Kill the state business property tax (remember that's a temporary tax created to fix a budget hole created during the Ventura Administration).

Minnesota should not be collecting billions of excess tax dollars. This is an opportunity to fix Minnesota's taxing problem.

Left out, was the part of the statute that says it is illegal to communicate that conversation or publish it without permission. My understanding of illegal and unethical conduct comes from years of training, education, and experience in the legal and law enforcement fields.

I used the word misinformation, to describe the content of that author's articles. For nearly two decades, I assessed information for its intelligence value. Misinformation is a form of lying. It may be accidental or deliberate. Intent can be determined by analyzing how the story is crafted, and comparing that to other known, verifiable information. When what's stated is known to be untrue, it is a lie by admission. If what's stated purposely leaves out parts of the story, that if discovered changes the narrative, it is a lie by omission. The purpose with both is to distract, deceive, or discredit.

Old news, re-hashed repeatedly with generous amounts of negative misinformation to help re-enforce a one-sided point of view, is not fair or accurate. Unfortunately, in this case, there is no sign of things changing for the better. Engaging in character attacks, because someone pointed out factual errors, tells a great deal about the person doing the attacking. I'd can't help but wonder what kind of anger it takes to fuel that fire.

Mayor asks you to let council know what you think

As Mayor of Crosby, my management preference is to deal with issues in a professional businesslike manner. This is opposite the style of Council member Ryan. Ryan prefers to create chaos, then he can boisterously come in as the hero to save the day.

As a member of the personnel committee Ryan was very well aware that we were extremely short staffed especially the last two weeks. He should have also been aware that the two active workers left have not had a day off including weekends-in over 2 1/2 weeks. In fact, Ryan met with the City Administrator on

Friday to approve hiring two new employees.

But instead of addressing the Christmas Light installation delay privately on Friday, and creating a solution, Ryan decided to do this:

At the public council meeting on Monday, Ryan threw the city crew under the bus. He demanded we hire subcontractors to do the work - even though the calvary was on its way. He shoved the crew and their efforts aside. I voted against this because I knew the crew on overtime, was going to get the job done early this week and sure enough, they got most of it on they next day.

Yes, we have had turn over in the Public Works. Starting soon, we will have some new staff and the new foreman will return from Military Duty and take the helm.

It is a time for encouragement, a time to rebuild and improve. This is hard to accomplish with council members that only see the bad.

I will be working hard behind the scenes to offer any help and encouragement I can.

This will require committee members with new ideas and solutions and yes, there will be committee changes made in order to accomplish this.

My choices for the committee assignments will take into account a wide variety of issues:

First off, who is new and inexperienced and what committees will help them understand the issues the council will face in the future.

Second, who is already aware of how the system works and can provide their input through council votes, giving others the chance to grow in their knowledge.

Next, who will possibly be absent next year.

Lastly, who is critical to providing the skills necessary to complete the committees task. I will be trying to accomplish all of this in order to leave the council in a better position at the end of the next year - ready to go for whoever is on the next council.

Council member Ryan has a few items he wants changed one being the city ordinances for nuisances.

This has been delayed and a workshop will be forthcoming. At that workshop, Ryan intends to add further restrictions to resident's use of their property and parking rights. He also wishes to explore the notion of arresting people if they receive too many violations. I strongly oppose these two measures and believe that the existing ordinances are sufficient. I recommend all residents keep an eye out for the workshop and attend it if you want to know the scope to the proposal being made.

Coming up on Monday, December 20, there will a Planning and Zoning Public Hearing at 6 p.m. in the council chamber. Included in this hearing is a revision to the Comprehensive Plan that adds the following to the Goals Section of the plan:

Protect the residential character of neighborhoods by creating and enforcing short-termrental ordinances.

would like heard on this subject, please attend this meeting. The council will need your input in order to vote appropriately for this change. Pro or con - this is your chance to let your council know what you think.

Send in a letter if you can't attend.

Council member Ryan is grateful my term as Mayor will be over in twelve months. As member Ryan has repeatedly commented on how he he is glad he has only a few meetings left, one thing appears to be certain - Ryan doesn't want to be on the council next year. I, on the other hand, will be throwing my hat in the ring
