# Innovator Creates App Focused on Black People, Culture

National STEM Day, which is on November 8, is the time to encourage students to pursue interests in science, technology, engineering, and mathematics. Adam Taylor understands that nurturing youth in STEM can make a major impact in their lives.

Taylor grew up in Connecticut with a growing interest in STEM. His grandfather, Edwin Bradley, loved computers. It rubbed off on his grandson in the nineties. Taylor wanted to build his own computer someday. Taylor, who now resides in Maryland, ultimately built an app called Black that was first released in September of 2017.

“iPhone users can enjoy the “100% Black owned, designed, and developed” app that “collects the news & stories from the world’s

greatest influencers of black culture. With all of your black news in one place, it has never been easier to discover the stories that keep you informed, engaged, and inspired,” per information provided about the app via Apple’s app store.

Langston LLC—Taylor’s his artificial intelligence and software company— builds culturally relevant intelligence and software platforms for the black community. Black is Langston’s first product.

“Our first product, Black, leverages our Langston machine learning, and data mining engine to provide people who identify as black personalized news and stories from a wide range of publishers,” Taylor said.

Taylor regards the news app as “ridiculously smart and unapologetically Black.” The app

allows users to focus on whatever they find interesting without being bombarded by news they do not prefer to consume.

“When you’re on social media, you’re being subjected to people being murdered, over and over again on your timelines, without any concern for people’s mental health,” Taylor said.

The journey with Black kicked off with approximately 12-15 publishers that focus solely on content for people of color. Taylor explained that the Black app is 100% automated in terms of how news shows up in the app. Currently, the target is to add approximately 100 publishers.

The “moonlighting entrepreneur’s” reasons for creating Black date back to the 2016 presidential election when Donald Trump defeated Hillary Clinton. Taylor found himself enduring an impactful experience. He described the first day returning to work at the Massachusetts Institute of Technology (MIT) in Cambridge, Massachusetts by train as “depressing.” Tyler works as an DevOps engineer within MIT’s central IT organization working within their software development activities.

Despite the packed train car of approximately 100 people, Taylor said that he felt alone. He was the only person present who was Black. Additionally, Taylor noted that he was

### Baltimore City urgently needs poll workers!

Baltimore City announced an urgent need for poll workers for Election Day, Tuesday, November 8, 2022. One thousand election judges are still needed as of November 2, 2022, to run each polling location. Voting judges; check-in Judges; provisional ballot judges; and chief judges are needed to complete various duties.

Election judges work from 7 a.m. - 8 p.m. (not including additional set up and clean up hours) to perform tasks such as: Check in voters; greet voters as they come and go; assist voters with disabilities using accessible ballot marking devices; and hand out "I Voted" stickers. They will be compensated \$200 for their service on Election Day, in addition to \$20 for participating in the required training session.

Qualifications require applicants to be at least 16 years old or older; a registered voter in Maryland; and able to speak, read and write the English

language. A candidate or individuals who currently hold a public or political office, or who serves in other capacities for candidates cannot work the polls.

Individuals who are seeking to gain customer service and communication skills; interaction with community members; and/or earn community service hours should apply as soon as possible. Volunteers will be paid by the Board of Elections. Checks will be mailed after the election.

## New York to Pay \$25 Million to Two Men Falsely Convicted of Killing Malcolm X

In 1965, Muhammad Aziz and Khalil Islam were wrongfully convicted of killing Malcolm X and spent over 20 years behind bars after being wrongfully convicted.

Even though the February 21, 1965 murder of Malcolm X at the Audubon Ballroom in the Washington Heights section of Manhattan was one of the most reported on assassinations of the 1960s, the trial of his assailants was botched because of racism, expediency and political considerations.

The documentary, “Who Killed Malcolm X,” which premiered on Netflix in 2020, revealed in detail that there was something wrong with the convictions. The investigative journalism of Washington, D.C. journalist Abdur-Rahman Muhammad spent decades combing through documents and analyzing evidence from Malcolm X’s murder. He also tracked

down those who knew what had really happened. Muhammad is a journalist, tour guide and historian, documentary film makers revealed what he studied over 20 years investigating Malcolm X’s murder.

What was revealed was that Talmadge Hager, a convicted assassin of Malcolm X, stated that the two men convicted with him were in fact innocent. Hagan, who is now 81, (over the years he has changed his name to Talmadge X Hayer and then Mujahid Abdul Halim) was granted parole and released from prison in 2010.

In 2021, Hagan expressed support that the convictions of Muhammad Aziz and Khalil Islam would be overturned which matched his original claims that they were not involved in the murder of Malcolm X.

Decades earlier, the late journalist Les Payne and his daughter Tamara Payne, in their book, “The Dead Are Arising: The Life of Malcolm X,” asserted that Malcolm X’s killers were members of the Nation of Islam’s Newark, New Jersey mosque. The book claimed that William 25X (also known as William Bradley) fired a shotgun at Malcolm X and were joined by Leon Davis and Thomas Hagen.

Both Muhammad Aziz and Khalil Islam, who died in 2009, were exonerated last year. When the allegations were tossed out as the result of a two-year investigation by the Manhattan district attorney’s office. Lawsuits were filed against the City of New York by Aziz and the family of Islam. The settlements arrive three months after the suits were filed in the

U.S. District Court in Brooklyn.

The case of the wrongful convictions on such a notorious high-profile murder prompts many to ask how many other false convictions could be out there. Several studies have been conducted that note that Black men are falsely accused at a much higher level than other groups for crimes.

In 2020, The Innocence Project released the report, “From Emmett Till to Pervis Payne — Black Men in America Are Still Killed for Crimes They Didn’t Commit.”

# U.S. Navy Veteran Goes from Security Guard to Doctor, Co-founds Nonprofit

Veterans Day is November 11, 2022. Many veterans have blazed the trails as extraordinary changemakers, including Russell Joseph Ledet, MD, PhD, MBA. The United States Navy veteran; disparities advocate; speaker; and co-founder of The 15 White Coats proves that obstacles can be conquered against the odds. Achieving the status of physician-scientist is just one accolade earned by the Louisiana native who was once a security guard at Baton Rouge General Hospital in Baton Rouge, Louisiana.

“From 2004 to late 2013, Russell was a cryptologic technician First Class Petty Officer in the U.S. Navy, serving on both active duty and reserve status,” per Dr. Ledet’s LinkedIn profile.

He transitioned from earning his medical degree at Tulane University School of Medicine to Indiana University School of Medicine for a triple board residency program. Ledet is scheduled to complete it in 2027, according to information provided online by Indiana University School of Medicine.

Although Ledet finished medical school requirements in 2022, his beginning in medicine was not a straight path forward.

“I was a security guard from 2009 to 2013. Specifically, September of 2009 to May 23 of 2013 at Baton Rouge General Hospital in Baton Rouge, Louisiana,” Ledet said.

He added that he was on active duty from 2004 to 2009. From 2009 to 2013, Ledet served in the United States Navy Reserves. While serving, he worked as a security guard simultaneously. After ending active duty, Ledet experienced a pay decrease. He applied to work as a security guard while attending school.

“I was going to Southern University to become a social worker just because I grew up on food stamps, and social workers always helped us out, so it was really the only job I knew,” Ledet said. “But when I got to the hospital, I was really enamored by the white coat and just seeing doctors take care of patients, and I started dreaming.”

He began asking doctors to shadow or intern with them to enable him to learn more.

“99.9% of them were like, ‘No, security guards don’t become doctors,’” Ledet said.

But one late night, a surgeon who arrived at the hospital did not know his way around. Ledet escorted him during a walk then asked to shadow him. That man’s name is Dr. Patrick Greiffenstein. He agreed and discovered that Ledet was majoring in chemistry and biology. Ledet had

already made the decision to switch his study path when he decided to try to become a doctor.

Ledet ended up earning his Ph.D. in molecular oncology and tumor immunology from New York University School of Medicine. After completing his Ph.D, he finished medical school and business school at the Tulane School of Medicine and Freeman School of Business. He had a vision to lend a hand to others, too. Ledet co-founded The 15 White Coats.

According to the nonprofit’s website, “The 15 White Coats is determined to reinforce positive imagery in learning spaces worldwide. Our iconic photos are used as an avenue to inspire the next generation of diverse doctors, lawyers, dentists, veterinarians, etc.”

It is led by Ledet; Dr. Sydney Labat; Rachel Turner; and Brian Washington.

The mission includes developing scholarships; facilitating access to culturally relevant literature; and inspiring and mentoring the youth of tomorrow, per details provided online.

The story behind the organization encompasses a viral photo taken of Tulane University School of Medicine medical students in 2019, Tulane News reported.

Ledet said that his daughter visited Whitney Plantation with him and his best friend. While driving back, the then 8-year-old made an insightful comment:

“She told me, ‘Hey, Dad, I finally understand why being a Black doctor in America is such a big deal.’”

His daughter further remarked there that was a time when Ledet and her “Uncle Phil” would have been slaves. The young girl continued to comment that they had come a long way. She acknowledged that she was riding in a car with two Black doctors. Ledet returned to the medical school telling some close friends about an idea to take photographs of the Black medical students together to illustrate how far they had come in the world.

Receiving attention led to forming a nonprofit that helps to diversify medicine. Funds raised and donations support Black people to become doctors through scholarships. Photos of The 15 White Coats are placed in classrooms all over the world for free.

Ledet reflected about his impact.

“I think I’m doing what my ancestors would have expected of me,” Ledet said.

# Afro-Latina Veteran Breaks Barriers, Owns Bank

Benaisha Poole-Watson served nine years in the Air Force. Serving in the military taught her a great deal. The ambitious veteran recalled the day she walked into the recruiting office. Her military journey commenced in Idaho and took her to Korea and California.

"I'll recommend it for anybody who's looking for a place to go and establish some form of discipline, because at some point we all need it," Poole-Watson said, referring to the military.

Poole-Watson's inherited resilience had the makings of a success story. She grew up in South Central Los Angeles, California. When she left her street where mostly working-class families lived, gang violence and drug infestation showed the young girl a different view. Poole-Watson's mother is an immigrant who came to the United States when she was 24 years old. Moving to California from Guatemala was a part of her search for the American dream.

"My mom worked all day and all night from like six in the morning until midnight. She was a nurse in Compton, so that was a 40-minute commute from where we lived," Poole-Watson recalled, adding that she was a latchkey kid.

Her hard-working mother raised Poole-Watson and a sister who passed away at ten years old. Despite struggles, volunteerism, love, and learning were integral aspects of being reared in their home. The Afro-Latina was always academically inclined.

"I always wanted to be better, and I knew that there was more for me. One thing about my mom is that she would take us to model homes. We would walk into the homes and just look at the décor," Poole-Watson said.

The Texas-based entrepreneur realizes that her mother planted seeds for a real estate career by taking her into luxury model homes to see the

possibilities. Later in life, Poole-Watson sought to elevate her career in corporate America, but consistently met challenges due to an undiversified executive management structure. After applying over 200 times for promotional positions and getting denied, Poole-Watson tried another strategy.

"After eight months of praying and asking God to lead me, guide me, show me, He spoke to me and said, 'Get a real estate license,' and so that's how I got into real estate," Poole-Watson said. "I sold over 200 houses my first year in the business while still working that full-time corporate job. The average full-time realtor sells eight to ten homes."

The second year she completed over 350 transactional sales. She began unofficially mentoring other real estate agents.

"People would always say 'If you

started a company, I would join your company.' One day I just woke up and said, 'I'm going to start a real estate company, The Bailey Watson Real Estate Group,'" Poole-Watson said.

She now has over 200 licensed realtors working directly for her covering every major state nationwide, including Maryland. This was all built while working a corporate job. Poole-Watson's ambition kept her wanting to grow so she developed, built, and sold 20 custom houses throughout Dallas substantially increasing her income by not utilizing another real estate agent.

Another stop in Poole-Watson's journey began after she started speaking at conferences about her real estate endeavors, just after the pandemic began. After speaking at an event, someone approached her and asked if she would be interested in an opportunity to own a bank. After attorneys tended to legalities, just two

weeks later, Poole-Watson was up and running as a federally chartered bank. Ironically, she did not know much detail about the industry and now services over 1000 loan programs in every state, except New York. Poole-Watson's bank is called Prime One Home Loans.

"I run a full-service mortgage company funding residential and commercial real estate loans, up to \$650 million. So that means I can fund everything," Poole-Watson said.

She mentioned that she can even fund 1099 independent contractors with 1099 statements and entrepreneurs who have had their business for at least two years with just business bank statements. No tax returns are needed for both loans.

Poole-Watson is a multidimensional individual who graduated from George Washington University in Washington, D.C. She studied law at the University of Maryland in College Park, Maryland. After living in the Washington, D.C. area, Poole-Watson relocated to Dallas.

Giving back is also on Poole-Watson's radar. She recently created a scholarship to enable two high school students nationwide to attend real estate school, paid in full. The scholarship launched in DeSoto, Texas.

The ambitious veteran also provided a message to share with fellow veterans.

"Take your career in the military seriously and chase your dreams or your goals. The things that you want to do can be accomplished even if you have never seen it done before. Use that military career as an asset and as long as you stay in good standing with the service, you can capitalize in so many different ways," Poole-Watson said.

the last person who anyone else wanted to sit next to during the train ride.

“We were all dressed for work, so we were all in button downs, and we had on ties and slacks. We all looked good,” Taylor said. “I couldn’t find any other reason why I was the last person to be sat with other than the fact that I’m a Black man and they weren’t with that.”

Taylor embraced his interest in software while deciding how to figure out how to build the app. He brought his vision to fruition with the help of YouTube videos and tutorials. Support

from friends helped Taylor to see it through. Nairobi Jeannition was a business confidant.

Black’s evolution is still underway. According to analytics, the ideal people who love the app are Black women who are ages 45-54 with an interest in politics. They are in a major metropolitan area. The secondary age range of people who view the articles is 18 -24.

Taylor’s timely idea provides a connecting piece for connoisseurs of Black culture. Apple has supported

Taylor. He was a part of the company’s inaugural entrepreneur camps for Black founders and developers in 2019.

“This is something that I’m not doing for my own personal gain,” Taylor said. “This is something that I just needed to put out into the world because this is really about giving that love back to people of color, to people to black people. And I think that I just want to make us proud.”
