Morrow returning to politics as volunteer in Mississippi governor's race

Johnny Mack Morrow spent almost three decades serving the people of northwest Alabama in Montgomery as State Representative for House District 18.

Morrow served seven terms in the Alabama House. In 2018 he lost a bid to become State Senator for Senate District Six. Although Morrow hasn't been in elected office in six years, politics will always run through his blood.

So it's no surprise that Morrow will

soon be back into politics, but not as a candidate. Instead, he'll be working as a volunteer for Mississippi Democratic gubernatorial candidate Brandon Presley.

Morrow spent the past four years as Special Projects servina Coordinator in the Research and Economic Development wing of Mississippi State University's Stennis Institute of Government. But he will step down at the end of the month to take a more active role in Presley's campaign.

Morrow and his wife Martha moved to Starkville in 2020 after he joined

Firefighters honored for **quick lifesaving actions**

Five members of the Russellville Fire Department were honored before the April 3rd meeting of the Russellville City Council for their quick action and lifesaving skills demonstrated on a call made last October.

Captain Jeremy Glenn, Sergeant Shane Mansell, Fire Marshal Justin Green, Lieutenant Mickey Gentry and Sergeant Brad Pounders received Certificates of Merit and medals for their work in saving a life.

It was the morning of October 20, 2022, when Lila Fuller went to a local nail salon for a pedicure. After she arrived around 9 a.m., Fuller's next memory was seven days later in a

Fuller went into full cardiac arrest. Holly Nail Salon employees quickly called 911 and the RPD responded. Fuller was stabilized and after three shocks, transported to Russellville Hospital. She was then air lifted to North Alabama Medical Center, where she had surgery and remained in the Intensive Care Unit for a week.

Fuller and her son wrote letters to the City of Russellville to express their appreciation to the firefighters who aided her.

"I truly believe God puts the people we need in our lives at the right time and place," Fuller said. "Thanks for caring and not giving up on me. I

Duncan's many talents will be missed

Almost 25 years ago, I answered a call late one afternoon from my desk in the Franklin County District Attorney's Office.

It was a gentleman from the Spruce Pine area with a question about pis-

tol permit fees in Franklin County and how they compared to other counties.

The fact that an elected official answered the phone seemed to impress Duncan, even though that was obviously a part of my job.

We spoke a few minutes and I told him I'd get back to him with an answer, which I did the following

About a week later, Norris Duncan came into my office to thank me for answering his question, and a friendship was born. Although we didn't visit socially, Duncan often

called me with thought provoking questions and story ideas.

Duncan died Friday at Helen Keller Hospital. He lived 87 full years of

If you didn't know Duncan and you heard him speak, your first thought might be that he sounded mad. He spoke in the same tone most of the time. He wasn't a shouter but he was persistent in asking for what he

And those who didn't give him the respect of returning a phone call might find themselves the subject of one of Duncan's drawings, where they could be portrayed in less than the best light. Duncan's talent allowed him to 'enhance' features of the subjects he drew. And those subjects were sometimes elected officials who didn't return calls, or acted in a way Duncan believed was wrong.

Regardless, Duncan was a talented artist. He regularly submitted his original drawings to The Source, a magazine published by Buford Parker, and he often brought drawings to the Franklin Free Press as well. Duncan's contributions enhanced any publication that included them.

"I would tell him what I wanted and he would draw it. He was so good. That's the way it was," Parker said. "We were always good buddies. We had a good time together visiting places and doing articles. We didn't do as much of it the last few years, but we had a lot of good laughs together.

"Norris was a likable person. You just had to get to know him," Parker

Duncan loved history. He was a supporter of the Franklin County Archives and he contributed drawings for the book History and Legends of Franklin County.

Duncan and his wife Shirley shared 68 years of marriage, the same number of years my parents were together. And as I miss them, I'll miss Norris Duncan and his unique insight on our world.

Duncan kept up with current events, both nationally and locally. And unlike many others, when he didn't understand why something was done, he picked up the phone to ask.

I'll always be glad I answered.

Letter to editor: Landfill expansion still a concern

Dear Editor,

If the Franklin County Commission approved a legal review of the county's solid waste policy "to make sure it allows (the Commission) to have solid legal grounds if (they) deny a future solid waste landfill applicant," why did the Commission hire a high priced defendant's law firm, one who almost always sides with businesses and polluters?

The same law firm that represented the Arrowhead Landfill during a large expansion. That landfill just signed a ADEM consent order and paid a \$30,600 fine for violating ADEM rules. Residents there filed hundreds of complaints over 15 years as they were subjected to all the hazards we were concerned about in the proposed landfill expansion here. Now they are asking ADEM not to renew Arrowhead's permits.

The same law firm hired by the Conecuh County Commission when they were asked to approve a Conecuh Woods mega-landfill. The Conecuh County Commission was in favor of that mega-landfill until their residents set them straight - to include voting in new County Commissioners. By the way, this same law firm then had to oppose the mega-landfill as directed by the new Commission.

Hiring this law firm raises serious concerns or questions for Franklin County residents and our county's future. For instance, is Franklin County Land Management (FCLM) a client of this law firm, was it during the landfill expansion application process last summer or has it ever been at any time? Was any conflict-of-interest determination made here and by whom? What was that determination? Neil Hargett, owner of FCLM, told several people in the county last summer he was paying a high priced law firm in Birmingham to assist FCLM. Is this the same firm?

Yes, we know other Birmingham law firms do this work, but do we know if it's another firm or not? The Commission hasn't told us. What does the Franklin County Commission know about that and when did it know?

Does the Commission know it hired a defendant's law firm that almost always represents businesses and polluters? Why did they not hire a law firm that defends the environment and could better address their own stated purpose for hiring a law firm here in the first place?

Who recommended this law firm to the Franklin County Commission and why?

What are the full details of the Franklin County Commission's requested legal review of the county's waste management plan by this law firm? What questions were asked? What specific information does the Commission seek?

Why hasn't the Commission made any and all this public yet? Why haven't they been more forthcoming with all the details when they initially announced this?

Where's the transparency? Franklin County residents have serious doubts whether the Commission is actually asking this law firm to suggest modifications it claims it seeks in order to deny a future solid waste landfill applicant. Could this be the beginning of a tactical and political process that gives the Commission cover to approve a landfill expansion after next year's elections should FCLM refile its application instead?

The Commission knows full well the clear and loud expectations of Franklin County residents given last summer's opposition to the FCLM land-fill expansion.

With the entire Commission up for re-election next year, county residents have seen the Commission's sudden interest in long term issues previously ignored.



the Stennis Institute at MSU, his alma mater

Presley said Morrow's role in the campaign has not been finalized, but he confirmed Morrow would be involved in a volunteer capacity working on some specific initiatives.



Tourism

One of Morrow's major projects with the Stennis Institute was expansion of the 'Rails to Trails' program in Mississippi. Morrow has advocated for expansion of the Tanglefoot trail, working to build a new trail from Greenwood to West Point. Miss., a 92-mile stretch, and a trail from West Point to Ackerman, Miss., a 44mile stretch that would include the Mississippi State University campus.

"Small, rural communi-

ties that were dying prior to the opening of the (Tanglefoot) trail are suddenly and miraculously coming to life," Morrow said.

Tanglefoot Trail, a converted 44-mile rail-to-trail from New Albany to Houston, Miss., has led to significant economic development as recreational tourism and community usage of the trail increased.

Morrow was one of the first legislators to advocate for rural broadband as a necessary utility, like electricity, water and sewer, etc.

As Morrow worked toward the goal of bringing high-speed, reliable, last-mile fiber-optic broadband internet to rural Alabama, Presley contacted Morrow for

economic think tank," Morrow said

"I'm leaving to help a friend who I very much believe in. Life moves on and this campaign is something I strongly believe in, so I'm going to do all I can to help Brandon become the next governor of Mississippi," he added.

And Morrow's confidence in Presley's chances of winning the state's highest office as a Democrat is shared by other political campaign veterans, including James Carville, who served as Bill Clinton's campaign manager the first time Clinton ran for president.

Mississippi's general election, including the office of governor, will be November 7, 2023.

Last year, Carville addressed Presley's candidacy and offered his prediction on how the campaign would fare.




Helping The Homeless



A defining moment: **Golden Tigers rebound to take** series from Jasper

In a week that saw his team go 4-1, the most important game for Russellville varsity baseball coach Jess Smith's team may have been its 8-7 loss to Jasper on March 28th.

Mitchell went the distance on the mound, yielding 11 runs (nine earned) on 16 hits with four strikeouts.


