



**Medicare** Minute "Medicare Part A Part 1"

On a Medicare card Part A will have the word "Hospital" beside it. Because of that Medicare Part A is most commonly known as the inpatient or hospitalization part of Medicare. This means when a Medicare beneficiary is admitted into the hospital most of the services that are received are filed under Medicare Part A. This sounds simple but sometimes it's not.

Medicare Part A has a deductible of \$1,600 per benefit period. Notice two things here. First is the deductible of \$1,600. If you are admitted into the hospital and had Original Medicare only, you would owe the first \$1,600 of your stay. This deductible covers hospital services, including semiprivate rooms, meals, general nursing, drugs as part of your inpatient treatment, and other hospital services and supplies.

The second thing to notice is the term "benefit period". This tells you the deductible is not an annual deductible but could hit you more than once in a calendar year. A "benefit period" begins when you are discharged from a hospital or skilled nursing facility and ends when you haven't received any inpatient care for 60 consecutive days. If you are admitted as an inpatient after the 60 days of no inpatient care a new benefit period begins, meaning another \$1,556 deductible. Also if you are confined to the hospital for 60 consecutive days your deductible will cover you but on the 61st day you will begin paying a coinsurance.

The good news is for most Medicare beneficiaries Part A is free. Free meaning you don't pay a premium for it. The reason for this is while you are working you pay 1.45% of your pay check into Medicare. If you did that for 40 quarters you're entitled to Part A for free. Next week will discuss the other benefits of Medicare Part A.





Callers complaining about immigrants should read George Will's recent commentary in the *Times Daily*. The libertarianconservative columnist noted the US became the world's richest nation by welcoming the most immigrants. Totalitarian states like China oppose immigration.

Over 60% of illegal immigrants have been here at least 10 years and 35% own their homes. They have assimilated. Immigrant start-up companies create 3 million jobs annually. Red-state Texas has more Latino elected officials than does California. As with his misguided "anti-woke campaign", Florida governor DeSantis pushed a law portrayed as a preview of hardlinepolicies he would seek on immigration enforcement if elected president.

Now in effect, the law requires businesses to check workers' documentation against a federal database, includes potential felony charges for transporting people without permanent legal status into Florida, allocates funding to move unlawful migrants out, requires hospitals Medicaid accepting to question patients' immigration status. and invalidates drivers' licenses issued in other states to undocumented immigrants.

That has generated calls for truckers to boycott Florida and heightened

about labor concerns shortages. An estimated 772,00 undocumented immigrants lived in Florida in 2019 – many working on construction farms, sites, and packaging facilities. The law is motivating migrants to depart, Florida's worsening labor situation.

Mexico's president urged US Latino voters to reject DeSantis for trying to win votes at the expense of migrants. Collaboration. not criminalization, is way to resolve the phenomenon the of undocumented migration, the Foreign Ministry said, describing the new measures as driven by xenophobia and white nationalism.

## **Medical Testimony** Is Required In An **Injury Case** In every case we know that an

accident happened, and we know how it happened. We know what the medical treatment was, who did it, and where it was done.

The severity of an injury really determines the value of a personal injury case. Obviously, there are other factors that drive the value up or down. Most personal injury lawyers would agree that the victim of a drunk driver is likely to get more money. Often the perception that someone was on their cell phone or otherwise distracted can drive a verdict higher.

Injuries come in all different

kinds from a catastrophic injury such as the loss of a limb or paralysis to bumps, cuts, and bruises. The monetary value to a large degree

corresponds to the extent of the injury. There are defenses to liability such as contributory negligence meaning that the person that got hurt was in some way at fault also. If there is a strong defense, the value of the case decreases.

In cases where there is medical treatment, the courts will not allow, by and large, an ordinary person to testify about their injuries unless and until a physician testifies that the injuries were caused by the accident that the lawsuit is about. In other words, you can have the accident report showing how the accident happened on one side and on the otherwide on one side and on the other side a stack of medical records showing what the treatment has been. Without a doctor's testimony to bridge the two, the medical treatment doesn't come into court unless a doctor says it was both caused by the accident and necessary for the treatment of the injuries.

Insurance companies are really using this requirement to not pay claims. Unless the medical records are really clear and the injuries are severe, insurance companies often elect not to pay or pay a very small value. One of the problems that we see is that the court

system has for many years allowed doctors the privilege of testifying by deposition and excusing them from having to come to court to testify. That privilege does not extend to physician assistants and nurse practitioners (PAs and CRNPs). We are seeing and will continue to see more treatment by nurse practitioners and physicians assistants. These professionals are certainly entitled to act as expert witnesses and testify to causation and treatment in the vast majority of cases; however, they have to testify live in court.



After classes on Sunday night we will be having our Annual Back to School Homemade Ice Cream Supper. (For kids of course.)


