Nonprofit Dedicated to Transforming Lives of Vulnerable Youth

Sisters Connect with Schools to Develop, **Stock Free Clothing Closets for Youth**

Chanay Banks and Juanita Banks-Whittington had a mutual desire to honor the memory of their late mother's legacy.

"Charlene Banks was a beloved mother, sister, daughter, and friend whose kindness and generosity persisted despite her struggles with addiction and personal hardships," Banks-Whittington revealed.

In 2023, Charlene's Circle of Support (CCOS) became a nonprofit organization dedicated to transforming the lives of vulnerable youth in Maryland who are impacted by parental mental illness, substance abuse, and/ or incarceration. Banks-Whittington, an author, veteran, and Anne Arundel County resident explained that she and her sister grew up receiving community support. They now provide a similar circle of support for today's youth through their decision to brighten children's futures by means of their nonprofit.

"Our vision is to break down barriers and foster a compassionate, empowered community where these challenges no longer dictate the futures of underserved youth. CCOS's programs are anchored in three key pillars: awareness, support, and advocacy. These pillars form the foundation for our care package, clothing closet [Charlene's Closet], and group mentorship programs," said Banks-Whittington, CCOS's co-founder.

Anne Arundel County-based schools, such as Hillsmere Elementary School and Annapolis Middle School, have received donations from CCOS.

Kimberly Terry, principal of Hillsmere Elementary School, located in Annapolis, Maryland explained that in recent years, student enrollment has

fluctuated between 380-400 students. She further stated a few students have already needed to access the closet.

"They have always known that could come to us for academic needs and socio-emotional support. Now, we have enhanced our support with personal hygiene items and basic clothing; therefore, continuing to make Hillsmere their safe space. When students feel safe and comfortable, the learning will come," she added.

Terry mentioned that Hillsmere had a supply closet for younger students. Efforts to collect personal hygiene items for older students began last year with PTA support.

"This year we have additional hygiene items and a larger variety of sizes of clothing to accommodate all students, thanks to the efforts of Mrs. Banks-Whittington."

Personal hygiene items such as toothbrushes, toothpaste, hair ties, brushes, combs, and basic clothing items for third through fifth graders were requested.

"Students and families are grateful that we are able to meet the needs of students without interrupting their instructional day," Terry noted.

She added, "As I explained to Mrs. Banks-Whittington, we often receive donations of clothing for our younger students, but our older students have accidents at lunch, recess, and personally we have not had the resources in-house to help the students. Having the closet now, we can quickly address the needs of all students in a way that maintains their dignity and allows them to quickly return to class and focus on learning," said Terry.

The clothing collection for Meade Middle School is underway.

Mia DiBene-Bennett, the Community School Program Manager at Meade

Charlene's Circle of Support donates money towards Annapolis Middle School Dragon/Uniform Closet.

Middle School, stated that items such as black leggings, athletic shorts, and darkcolored t-shirts have been requested from CCOS.

"Having these resources at their fingertips allows students to continue to engage in learning and concentrate on academics, rather than worrying about their appearance or lack of proper clothing," she explained.

DiBene-Bennett anticipates that the forthcoming clothing closet should be up and running in October.

DiBene-Bennett added, "By providing this resource, Meade Middle can reduce barriers, promote student well-being, and foster an inclusive and supportive learning environment. That, in turn, helps to fulfill the vision of our strategic plan to make our school system a community where everyone can belong, grow, and succeed."

Meade Middle School established an initial clothing closet with help from other partners. However, CCOS will further sustain it through the school year, according to DiBene-Bennet,

who said that the school is grateful to receive the support.

DiBene-Bennett further stated that meeting the basic needs of students promotes regular attendance, engagement, and a more positive school experience for all students.

Chanay Banks, CCOS's founder and executive director, resides in Charles County. She recalled that she and her sister grew up having a strong circle of support. She said that being able to offer the same to other youth has been priceless.

"We know our mom, Charlene, is proud of us, and continuing her legacy feels like she's still with us, guiding us every step of the way," Chanay proclaimed.

National Recovery Month

Beyond Drugs and Alcohol: Discussing Other Addictions and the Need for Recovery

September is National Recovery Month. When these three words come to mind, they often elicit thoughts of individuals who are recovering from drug or alcohol addiction.

Dr. Cashuna ("Shun") Huddleston, Ph.D., a licensed psychologist and owner of New Way Psychological Services, works with children five years old and older; adults; and couples who struggle with a range of issues and disorders. She shared insight into addiction and recovery.

"While substance use disorders (alcohol, drugs, etc.) are the most commonly recognized form of addiction, there are several other behavioral addictions and situations where professional help is necessary. These involve compulsive behaviors that can be harmful to a person's mental, emotional, social, or financial well-being," Dr. Huddleston said.

She also stated that addiction is defined as a chronic disorder that involves compulsive engagement in a rewarding behavior, despite knowing the harmful consequences. It often includes an inability to stop the behavior: intense cravings: and continued use or engagement even when it interferes with daily life.

Additionally, she added: "A behavioral addiction involves compulsively engaging in certain nonsubstance activities, even when those activities cause harm. These behaviors stimulate the brain's reward system in a similar way to substances, causing dopamine release and reinforcing the behavior. Though no external substance is involved, the psychological pattern of craving, compulsion, and loss of control is the same as with substance abuse."

Dr. Huddleston added that nonsubstance-related behavioral addictions can significantly disrupt a person's life, even though they don't involve physical substances like drugs or alcohol. These behaviors provide a temporary dopamine boost. Over time, they can lead to harmful patterns that affect a person's mental health, relationships, and overall well-being.

Some common behavioral addictions and the ways they can become problematic include: exercise addiction; shopping addiction (Compulsive Buying Disorder); sex and love addiction; and gambling addiction. Additional behavioral addictions are gaming addiction; food addiction; work addiction; and social media addiction.

"Behavioral addictions can be triggered by various psychological, environmental, and biological factors that cause individuals to engage compulsively in certain activities. These triggers can lead to the reinforcement of unhealthy behaviors that provide temporary pleasure or relief, creating a cycle of dependence. Behavioral addictions often develop when individuals use certain activities to manage or escape from emotional distress, boredom, or psychological challenges. While these behaviors may provide short-term relief or pleasure, they can ultimately become compulsive and damaging when relied upon as a coping mechanism," said Dr. Huddleston.

She further stated that compulsive patterns and negative consequences can affect anyone. Children are more likely to become addicted to gaming or social media, although adults may struggle with gambling, work, or exercise addiction.

Behavioral addictions often do not

receive the same level of societal attention and seriousness as substancerelated addictions. despite their potential to cause significant harm, according to Dr. Huddleston. However, Dr. Huddleston explained that a prevalent treatment method for behavioral addictions is Cognitive Behavioral Therapy (CBT).

"CBT is highly effective because it focuses on helping individuals identify and change the negative thought patterns

and behaviors that contribute to their addiction. Other common treatment approaches include group therapy, motivational interviewing, mindfulness-based therapies, 12 step programs, and medication," she said.

It is noteworthy to mention that once someone is diagnosed with a behavioral addiction, they typically need to remain vigilant throughout their life to guard against the possibility of relapse. Many people who struggle with behavioral addictions may not fully realize the extent of their addiction or its negative impact on their lives.

"Recovering from any addiction, whether behavioral or substancerelated, requires a multifaceted approach that addresses the physical, emotional, and psychological aspects of the condition. An important part is acknowledgment and acceptance which is a crucial step in recovery. Without this, it's impossible to move forward with meaningful change. Acceptance involves self-awareness, emotional

honesty, and commitment to change," the licensed psychologist said.

Dr. Huddleston also stated that recovery from addiction often requires outside help from professional or structured programs and can include therapy, support groups, medical or psychiatric help.

Reputable online screening tools can help individuals gauge whether they might have a behavioral addiction. although they are not a substitute for professional diagnosis. Mental Health America (MHA) – Addiction Screening Tool; Gambling Self-Assessment Tool (G-SAS); Internet Gaming Disorder Test (IGD-20); and the Bergen Shopping Addiction Scale (BSAS) can offer an initial assessment of whether further evaluation by a healthcare provider might be needed.

Suicide is a Major Public Health Concern

September is National Suicide Prevention Month

TOWSON, MD-

(September 16, 2024) – September is National Suicide Prevention Month, a time to raise awareness of this major public health concern. According to the CDC, suicide rates increased 37% between 2000-2018 and decreased 5% between 2018-2020. However, rates returned to their peak in 2022, with the CDC noting that year, over 49,000 people died by suicide.

During this month, the Baltimore County Department of Health is urging residents to take an active role in raising awareness, knowing the facts, recognizing the warning signs of suicide and how to get help.

"We must all do everything to prevent a person from reaching the point where they feel that suicide is their only option," said Della Leister, RN. Interim Health Officer. "Becoming aware of warning signs can literally be the difference between life or death. One life lost to suicide is one life too many."

In Baltimore County from 2016 to 2022, there were 600 deaths by suicide among residents. The majority of deaths by suicide occurred among males (79%) and residents over the age of 84 (19 per 100,000 residents) had the highest suicide rate compared to all other age groups. Youth deaths by suicide accounted for 6% of the total deaths by suicide. The most common method of death was by firearm (43%) followed by hanging/suffocation (32%) and drug/poison ingestion (12%).

The Baltimore County Department of Health (BCDH), Bureau of Behavioral Health is committed to supporting our residents through education, advocacy, linkage to resources and treatment. Residents are encouraged to reach out 24/7 to

our Baltimore County Crisis Response System by calling 410-931-2214 or the National Suicide and Crisis Lifeline by calling or texting 988 if they or someone they know are experiencing a mental health crisis or need someone to talk with.

The Job That's Too Good to be True

Prior to the government-mandated shutdown due to the COVID pandemic, work-from-home (WFH) opportunities were very scarce. Once the shutdown occurred, businesses had to quickly pivot to remain viable. As a result, remote work today is an accepted norm. This "new" level of consciousness and acceptance of remote work in more fields, like many other societal changes, has provided an opportunity for some people to put a new spin on an old tactic: the job scam.

As the job market becomes increasingly digital, the methods employed by scammers have become increasingly digital. Text messages have emerged as a popular avenue for their fraudulent activities, catching many unsuspecting job seekers off guard. The prospect of easy money, flexible hours, and high pay for minimal work can seem very attractive, often masking the true nature of these scams.

Scammers are creative in their approaches, constantly evolving their tactics. If you are in the job market or know someone who is, knowing how to spot a job scam can make the difference between being employed or victimized. Here are some common types of online job scams to watch out for:

Fake Job Offer Scam: This scam begins with an unsolicited text message offering a job opportunity with an attractive salary and benefits. The scammer poses as a recruiter or employer, claiming to have found your resume online or through a mutual connection. To secure the job, victims are asked to pay upfront fees for training, background checks, or equipment. Once payment is made, the "employer" disappears, leaving them out of pocket.

Check Deposit Scam: Here the victim receives a check as part of their "employment" to buy supplies or equipment. They are instructed to deposit the check and wire a portion of the funds to a third party or back to the "employer." Later, the check bounces, and the victim is left responsible for the full amount, often facing financial consequences.

Package Reshipment Scam: In this scam, victims are hired to receive, repackage, and forward goods, often stolen or purchased with stolen credit card information. The victim unknowingly becomes involved in illegal activities and may face legal consequences when authorities investigate.

Money Mule Scam: This scam involves recruiting victims to transfer funds between accounts or send money overseas as part of their "job." These funds are often linked to criminal activities, such as money laundering, making the victim an unwitting accomplice in illegal transactions.

There are other types of job scams such as mystery shopper, data entry,

and fake job interview scams, with the main purpose being to steal your money, your data, or make you an unwitting participant in illegal activity. Protecting yourself from these and other scams requires vigilance and awareness so here are some red flags to look for as you conduct your job search and/or receive messages about job opportunities:

- Unsolicited Contact: If you receive a job offer via text message from someone you've never interacted with, be cautious. Legitimate employers rarely reach out this way without prior contact.
- Too Good to Be True: Job offers with high pay, minimal work, and instant hiring without an interview process are often scams. If it sounds too good to be true, it probably is.
- Requests for Upfront Payments: Legitimate employers will never ask for money to cover training, equipment, or background checks. Any request for payment is a major red flag.
- Poor Grammar and Spelling: Scammers often use messages with

grammatical errors, spelling mistakes, or awkward phrasing. Reputable companies take care to communicate professionally.

- Pressure to Act Quickly: Scammers create a sense of urgency, insisting that you respond immediately or risk losing the job. This tactic is designed to prevent you from thinking carefully or researching the opportunity.
- Requests for Personal Information: Be wary of employers who ask for sensitive information, such as your Social Security number, banking details, or home address, early in the hiring process.

If you encounter a job scam or fall victim to one, the best thing to do is to report it to help prevent others from being victimized. If you have lost money, you should consider filing a police report with your local law enforcement agency. You also can report the scam to the Better Business Bureau via their website, https://www.bbb.org/ScamTracker. It's also a good idea to report the scam to federal agencies via the FTC (https://reportfraud.ftc.gov/) website and/or the Internet Crime Complaint Center (https://www.ic3.gov/) operated by the FBI. For text message scams. forward the message to 7726 (SPAM) which will allow your wireless provider to spot and block similar messages in the future.

Creatively Black Baltimore Showcases Regional Talent

Joy Bramble, founder of The Baltimore Times, invited me to a meeting to discuss creating an art initiative. During our conversation, she proposed launching a new art initiative and sought my suggestions, given their 39 years in business and my longstanding relationship with her. I suggested dedicating an issue of *The* Baltimore Times to "100 Black Artists in Baltimore You Should Know." Paris Brown, then Associate Publisher, was also present, and together we began brainstorming ideas for this special edition to highlight Baltimore's talent.

Our discussions began in May 2023. In a subsequent meeting, Bramble and Brown inquired about the possibility of planning an exhibition to coincide with the feature's release. I agreed. noting that it would add a unique dimension to the project—something unprecedented in my 45 years as a professional artist. As a Baltimore native educated in the city, I've found the support for the local arts scene frustratingly lacking.

Despite numerous art institutions and museums, there has been little interest in promoting and uplifting African American artists. Baltimore artists from the seventies often banded together, and some even opened galleries to provide support. However, today, with more creatives than ever, the conversation about specifically African American initiatives has become almost nonexistent. Under the diversity and equity umbrella, African American causes often seem to be a low priority.

Baltimore artists have faced these challenges for decades. Opportunities were scarce, and many artists were excluded from events and grant systems. While some have managed


to succeed despite the bias, many are left frustrated by rejection and bureaucratic hurdles. We named our project "Creatively Black Baltimore" to celebrate Black excellence in the Baltimore arts community and to reconnect two to three generations of artists separated by a lack of opportunities. The Black Arts District is a fine example of an arts organization dedicated to empowering Black creatives and their communities.

Our first challenge was finding a suitable space for the exhibition. Initially, we considered the space above The Baltimore Times offices, which was large enough to accommodate the artwork if we limited the size. However, as time passed and finding a venue became more difficult, we eventually revisited an opportunity at the Inner Harbor's Light Street Pavilion.

In the fall of 2023. The Baltimore Times hosted a pop-up exhibition at the Inner Harbor to celebrate Black cyclists through technology as part of our media partnership with the

Maryland Cycling Classics race. The success of this exhibition led MCB Real Estate to approach The Baltimore Times with the prospect of our current project. They offered us the old Ripley's Believe It or Not! space, approximately 12,000 square feet. The space was in a state of disrepair, with most displays ripped from the foundation. During our initial walkthrough, it wasn't clear how things would come together, but with some imagination and ingenuity, we decided to make this the home of "Creatively Black Baltimore." Many are aware of the development scheduled to occur in two years at the Inner Harbor. Ironically, I was at the space in 1979 when it first opened to the public, making it a full-circle moment to be there for both its opening and closing with "Creatively Black Baltimore."

The beginning was slow as I attempted to connect with artists in the region. We started with a few pieces and quickly expanded to over 400 works by more than 80 artists. The exhibition showcases a diverse

cross-section of talent from emerging, mid-career, and established artists. The only criteria were that participants lived in or had worked in Baltimore: all other limitations were removed. The show emphasized participation and engagement, eliminating the jury process. Artists could submit their work regardless of their experience levels. Some participate professionally, while others are exploring it, but our goal was to provide a venue where all could be seen together in a pop-up environment.

Pop-up exhibitions have become a creative trend in many cities, converting uninhabited buildings into art spaces. In this regard, the Ripley's space became a unique popup opportunity. As we began minor repairs and painted the space white, things quickly came together as the art began to arrive.

"I wanted to learn how to become my own boss, so I could work for myself and make my own rules," 11-year-old Harmony Hunt said.

The confident sixth grader from Baltimore County, Maryland, who recently stated that she wants to become an entrepreneur who owns many successful businesses, is headed in the right direction. She has gained experience making bracelets; creating designs; creating scents; packing items, and mailing orders for Harm's Charms, a business that was founded in 2022 along with her mother, Em Hunt. The duo also sells plant-based soaps; handcrafted bath bombs: shower steamers: and men's beard balm and oil. Harm's Charms products are plant-based and cruelty-free. Customers who use the products can add a little luxury to their bathing and showering regiments while indulging in self-care during a spa-like experience.

"Charm's mission is to become a household name while mentoring and giving back to other single mothers and their daughters," Em explained.

Em also stated that Harm's Charms began with a vision that was Godgiven to her during one of the most challenging financial periods of her life.

"With only a few thousand dollars left, I took a leap of faith and invested it into a business for Harmony, who often asked if she could have her own. Though I wasn't in a position to start it for her before, I knew this business was something that could be passed down from generation to generation," Em shared.

Em decided to call the products "Charms" while adding the word "Harms," which is short for Harmony. Despite challenges that were present when Harm's Charms began, Em pressed forward to begin the business endeavor.

"There were nights I wondered how a bill would get paid because I had invested everything into the business. That's what faith looks like—trusting and believing in God so deeply that you surrender and watch the pieces fall into place," the determined mother added.

Some of Em's priceless moments manifest when she now sees Harmony's eyes light up whenever she informs her daughter that they made a sale, have a business meeting, or are headed to another pop-up shop.

"Those moments make every tear, drop of sweat, long hours of planning, and hearing "no' or 'not right now' all worth it," Em said.

Em explained that building the Harm's Charms empire with her only child and that the "Queen in the making" was absolutely amazing.

"Watching how much she's blossomed since 2022 when we went to our first pop up to now is awesome. I'm blessed beyond measure. When there's ever a time I feel overwhelmed or feel like I can't go on, she will literally say, 'it's going to be okay, Mommy' and follow up with a positive comment. Giving up isn't an option when I have someone calling me Mommy," Em added.

According to Em, Harmony is learning discipline and how to harness her creativity because of co-owning a business.

"Harmony is understanding that if you don't work, you don't eat. Being involved in the foundation of Harm's Charms is teaching her the value of hard work, and that success doesn't



come from waiting for a handout or being given a silver spoon. We also volunteer at the Veteran's Hospital [in Baltimore, Maryland (Loch Raven)] and donate to less fortunate children, so she's learning the importance of giving back," Em stated.

Harmony added that she learned to save as much as she can without spending all her earned money on snacks and things that she really does not need.

The mother and daughter team has successfully hosted their first sip and paint event with some of Baltimore's veterans, and they achieved their goal of getting our products into the Maryland Zoo gift shop after mentioning a year prior that it would be nice to have our items there.

"My favorite product is our donut bath bomb because they smell amazing and it leaves my skin soft," said Harmony, the young entrepreneur who is building valuable marketing and sales skills.

She believes that the public should support her business because she is a big dreamer who works hard. "I love people and my supporters. I have great customer service and give back to my community!" she added.


We are not adhering to the traditional rules of museums or galleries but are fully expressing ourselves with creativity. This pop-up environment has certain restrictions based on space, electrical access, and lighting, especially since most fixtures, electronics, and wiring were removed when Ripley's relocated. We collaborated, used our ingenuity, and secured resources to make the space minimally operational—and the rest is history. Our mission is to nurture and uplift Baltimore's African American art scene.

Ravens Justin Tucker Stuck in a Slump

The days of automatically assuming the Baltimore Ravens were going to get points on the board when they reached the opponent's 35-yard line may be over. Ravens kicker Justin Tucker is 0 - 2 from 50 yards or more out this year. That comes after he was 1 of 5 from 50+ last season.

Tucker is 5-of-8 on field goals this year. His 62.5 percent conversion rate and well below his career mark of 89.7 percent. So, what happened?

"It's just a technique issue he's working through right now," Ravens coach John Harbaugh said. "He's got a technique thing going on. He'll work through it. He knows exactly what it is and just needs to smooth it back out. I'm very confident that he will."

Harbaugh would know. He cut his teeth as a special teams coach with the Philadelphia Eagles before taking the head coach job with the Ravens.

Tucker vows to continue working through the issues he's having. And he isn't going to lose his confidence.

"When I go out on the field, I'm confident that I'm going to nail every single kick, no matter where we are on the field," Tucker said. "Trying to overanalyze or dwell on a mistake or a performance that is not up to our collective standard, that's not going to do us any good. What is going to help us is continuing to trust the process, and just come together as a team, and get to work. This is a long season.

"I think everybody in here would say the real accountability is taking the burden of blame on yourself so somebody else doesn't have to. And everybody else in this locker room is built just like that. I think we're going to be just fine. We're going to be a really good football team."





Tucker is considered one of the best kickers. His 89.9% career field goal accuracy is the best ever. Tucker's best season came in 2021 when he led the league at 94.6 percent and also drilled an NFL-record 66-yarder.

Tucker's resume boasts seven Pro Bowls, five first-team All-Pros, and includes being a member of the Ravens team that won Super Bowl XLVII. He's earned the respect and admiration of his head coach who believes in him.

"I just love [Justin Tucker], [and] I respect him. He's everything that you want in a player [and] in a friend," Harbaugh said. "Justin [Tucker] knows that we support him; I've tried to make sure he knows that – that's part of it, just relationship-wise. The talent and the ability, all of that stuff is there.
