#### A Blue-Collar Fight

#### Longshoremen Engage in Coast-wide Labor Action for Better Treatment, Call for an End to 'Corporate Greed'

Ports along the U.S. East and Gulf coasts from Maine to Texas shut down Tuesday, October, 1, 2024, as a result of the expiration of the master agreement between United States Maritime Alliance (USMX) and the International Longshoremen's Association (ILA). Coverage of the USMX-ILA Master Contract includes ILA members from Maine to Texas. Workers at ports on the U.S. East and Gulf coasts are represented by the ILA while USMX represents employers in the maritime industry. These parties include port associations, marine terminal operators, and container carriers.

"Contract negotiations between the ILA International and USMX expired Monday, Sept. 30 at midnight. Since an agreement had not been reached," tens of thousands of ILA rank-and-file members began setting up picket lines," according to statements issued on Facebook https:// www.facebook.com/ILAUnion by the ILA.

"The Ocean Carriers represented by USMX want to enjoy rich billion-dollar profits that they are making in 2024, while they offer ILA Longshore Workers an unacceptable wage package that we reject," the ILA added.

The ILA further stated that "longshore workers deserve to be compensated for the important work they do keeping American commerce moving and growing."

"In addition, the shippers are gouging their customers that result in increased costs to American consumers. They are now charging \$30,000 for a full container, a whopping increase from \$6,000 per container just a few weeks ago. In just a short time, they went from 6K, to 18K, then 24K and now \$30,000. It's unheard of and they are doubling their \$30,000 fee stuffing the same container from multiple

shippers. They are killing the customers," the ILA also asserted.

A coast-wide strike has not happened since the mid-seventies.

ILA President Harold Daggett, the leader of the 85,000-member ILA union further stated on social media that members are prepared to fight as long as necessary to garner the wages and protections against automation our ILA members deserve. However, the ILA said that they will continue to handle military cargo and work passenger cruise vessels. Antoin Jennings and Magdy Wahba, crew members from a military vessel, Roy P. Benavidez were kind enough to bring lunch to strikers in Newport News to show appreciation and support for what they do. As a part of the ILA agreement, military vessels were allowed to continue operations.

Daggett joined ILA members outside the gates at Maher Terminal located in Port Elizabeth, New Jersey to picket. A \$5-an-hour increase in wages for each of the six years of a new ILA-USMX Master Contract is one of the ILA's demands.

"Plus, we want absolute airtight language that there will be no automation or semi-automation, and we are demanding all Container Royalty monies go to the ILA," Daggett added.

President Joe Biden weighed in on the Negotiations Between USMX and the International Longshoremen's Association on October 1. Statement from President Joe Biden on the Negotiations Between USMX and the International Longshoremen's Association | The White House

"Collective bargaining is the best way for workers to get the pay and benefits they deserve," he said.

President Biden urged USMX to come to the table and present a fair offer to the ILA workers.

"Ocean carriers have made record profits since the pandemic and in some cases profits grew in excess of 800 percent compared to their profits prior to the pandemic. Executive compensation has grown in line with those profits and profits have been returned to shareholders at record rates. It's only fair that workers, who put themselves at risk during the pandemic to keep ports open, see a meaningful increase in their wages as well," he added.

The President further stated that his Administration will be monitoring the situation "for any price gouging activity that benefits foreign ocean carriers, including those on the USMX board."

Another statement was issued by the ILA about the strike. It mentioned how their members worked tirelessly during the pandemic to ensure that the nation's commerce flowed, and they continue to sacrifice time with their own families so that goods can arrive in the homes of other families throughout the world.

Additionally, less manpower is needed to do work at ports because of automation. Certain container-handling equipment has been implemented in the

process of loading and discharging vessels which has eliminated several manual jobs that would require compensation from the ILA's checkers (longshoremen who use digital equipment to account for delivered and loaded freight) and longshoremen, thereby increasing profits, according to sources.

"Still due to corporate greed. employers refused to compensate the ILAs members fairly. Over the last several

# Skincare from an Esthetician's Perspective is More than Meets the Eye

"Black Don't Crack" is a common saying in the Black community that reflects the belief that Black skin ages or wrinkles less, and minimal effort is required to keep skin looking attractive despite aging. However, individuals of all ethnicities and ages can benefit from providing tender loving care to their skin.

The skin is the body's largest organ and includes three main layers: the epidermis (top layer), dermis (middle layer), and hypodermis (bottom later). Melanated skin can benefit from being treated with tender loving care. Finding a skincare routine that works for you helps to combat aging and protects skin.

Additionally, reducing your exposure to ultraviolet (UV) rays can lower your chances of getting skin cancer. The CDC reminds that anyone can get skin cancer, but people with certain characteristics are at greater skin cancer risk.

Meka Mathis, a licensed master esthetician of 27 years, provides facials; teeth whitening; lash lift; sugaring; waxing; laser cavitation (non-surgical fat removal); and eyelash and eyebrow tinting services. Mathis serves men and women at her Skin Beauty Bar located in Washington, D.C. She explains the difference between an esthetician and dermatologist.

"Estheticians are licensed professionals by the state who provide skincare services to clients. They help maintain the personal appearance of clients by performing facials, waxing, sugaring, and most skincare treatments. The difference between an esthetician and dermatologist is the medical degree. A dermatologist is a medical specialist educated and experienced in the prevention, recognition, and treatment of skin, hair, and nail diseases," said Mathis.

She further noted that a dermatologist typically gets involved when laser resurfacing or prescription products are needed for the skin. However, when it comes to learning how to maintain an at-home skin care regiment, or visiting an esthetician for self-care, Mathis stated that a facial followed by professional skincare products is a budget-friendly recommendation that can be used to start a skincare routine. Both genders can benefit from having an easy skin care routine that includes a double cleanse: mild exfoliant: toner: and serum: and moisturizer followed by SPF (Sun Protection Factor).

Mathis added, "Men should understand that they must cleanse their skin twice a day and use skincare that addresses their skin type."

It is important to note that investing in skincare made for faces is not merely a luxury.

"Soap is made for the body and Vaseline clogs the pores of the skin of your face," Mathis stated.

Additionally, products that contain lanolin, castor oil, formaldehyde, and mineral oil can damage or irritate skin, according to Mathis.

Mathis specifically recommended the use of baby skincare products that are paraben and fragrance free. Teens should establish skincare geared towards them such as Dermalogica Clear Start, a product that can be purchased at Skin Beauty Bar. The aesthetician further explained that teen skincare should include a cleanser: toner; SPF with moisturizer; and a mask once a week. Mathis suggested that adults who are under 40 years old should incorporate a cleanser; exfoliant; toner; serum; moisturizer with SPF; night cream; and a mask with vitamin C or retinoids once a week into their routine. Lastly, Mathis suggested use of a cleanser with vitamin C or glycolic acids; an exfoliant; toner; serum; moisturizer with SPF; night cream; and a mask containing vitamin C or retinoids once a week for adults who are 40 years old and older.

She also offered insight about products and methods to take care of aging skin.

"It is important to use active ingredients, such as glycolic acids; retinoids; and hyaluronic acid to increase cell turnover, which regenerates new skin. You may minimize damage, wrinkles or flaws by [getting] monthly facials and [using] professional grade skincare products," said Mathis.

A few common skin issues that arise in African Americans include hyperpigmentation, eczema and keloids.

Mathis added, "Hyperpigmentation occurs because we have more melanocytes, and when the skin is injured, it takes time to heal. And when the UV rays, which is sun exposure hits the skin the scarred area becomes darker. That is why it is important to resurface the skin with peels and exfoliants and SPF."

Individuals who want to maintain healthy, glowing skin will benefit from establishing a skincare routine and incorporating healthy eating habits into their lifestyle.

"Drink plenty of water. A great diet includes eating fruits and vegetables and low fat foods. Have a skincare routine that is followed daily," said Mathis.

#### Vance and Walz Begin Cordially but End in Heated Clashes Over Trump, Jan. 6, and National Policy Issues

Republican Senator JD Vance of Ohio and Democratic Governor Tim Walz of Minnesota faced off in the only vice presidential debate of the 2024 election on Tuesday night. which began with a measured tone but eventually escalated into a combative exchange. The debate, which CBS News hosted at their Broadcast Center in New York and Norah O'Donnell and Margaret Brennan moderated, covered a range of important national issues, with Vance's connections to former President Donald Trump and the January 6 uprising emerging as key

The debate's early moments were largely civil, as both candidates laid out their platforms and shared their visions on topics such as foreign policy and the economy. However, tensions flared when Vance was asked about Trump's recent comment that childcare was "not very expensive" compared to the money the country would gain from his policies. Vance explained that Trump was referring to the nation's ability to raise funds by "penalizing companies shipping jobs overseas" and those using "slave laborers." But Vance sidestepped when pressed on whether Trump was committed to the child tax credit, redirecting the discussion to economic penalties for outsourcing, prompting frustration from Walz.

The debate took a sharper turn when Vance was questioned about the 2020 election and Trump's role in the January 6 insurrection. Rather than directly answering whether Trump lost the 2020 election, Vance defended the former president's actions that day,

stating, "Remember, [Trump] said that on January the 6th, the protesters ought to protest peacefully, and on January the 20th, what happened? Joe Biden became the president. Donald Trump left the White House."

Walz responded forcefully, calling Vance's failure to answer directly "a damning non-answer." He continued, "To deny what happened on January 6, the first time an American president or anyone tried to overturn an election, is unacceptable. This has got to stop. It's tearing our country apart."

Walz also drew attention to the broader implications of Vance's remarks, reminding voters of the violence on January 6, including a march on the governor's mansion in Minnesota. "What I'm concerned about is, where is the firewall with Donald Trump? Where is the firewall if he knows he could do anything, including taking an election, and his vice president's not going to stand up to it? That's what we're asking you, America," Walz said, clarifying that accountability for democracy was at

stake in the 2024 election.

Vance avoided direct answers on election integrity and instead pivoted to discussions of censorship, blaming tech companies for "censoring their fellow citizens" and touting Trump's endorsements by former Democratic Rep. Tulsi Gabbard and Robert F. Kennedy Jr. He continued to defend Trump's policies, including tax cuts and immigration, while steering clear of addressing the core issue of Trump's role in questioning the election results.

The debate further escalated as the two candidates clashed over climate change, healthcare, and gun violence. On climate change, Walz highlighted the Biden-Harris administration's investments in clean energy and infrastructure, citing the Inflation Reduction Act as a crucial step in addressing the crisis. "We've made massive investments in electric vehicles, solar technology, and job creation because we know climate change is real," Walz said.





#### **Menopause Awareness Month**

#### **Eradicate the Stigma: Let's Talk About Perimenopause and Menopause More**

Menopause Awareness Month offers a prime opportunity to raise awareness about two female health topics: perimenopause and menopause.

Actress Halle Berry, 57, has spoken out about these transitional times in a woman's life. Her voice reached Capitol Hill months ago as she joined bipartisan senators who push for legislation that would support menopausal research and expansive healthcare options. She was initially misdiagnosed with herpes. The discovery was later made that Berry was in perimenopause, she revealed during a discussion with First Lady Jill Biden at "A Day of Unreasonable Conversation," a conference held in Los Angeles last March.

"I have to use all of who I am, and I have to start making a change and a difference for other women," she said, mentioning that she decided to use her platform to raise awareness about perimenopause.

LaKeischa McMillan, M.D. ("Dr. LaKeischa"), a Maryland-based integrative gynecologist and author of the Amazon Best-Seller, "The Other PMS: Your Survival Guide for Perimenopause and Menopause" explained the significance of knowing that menopause is marked by a woman going 12 consecutive months without having a menstrual period.

"This is very important because if you go 12 consecutive months without a period, and you are not on hormones, and you have a period, you have to have a workup to make sure your bleeding isn't due to uterine cancer. I'm not saying that all postmenopausal bleeding means uterine cancer," she said.

She added, "Perimenopause is

the time in a woman's life when the hormones that helped her have a period start declining. The result can be a shift in your cycle by plus or minus seven days. However, this isn't the only symptom."

The gynecologist believes that the more perimenopause is discussed, the less stigma it carries, and the more understanding society can become.

"Estrogen is just one of the hormones that helps you have a cycle at a set interval every 28, 30, or 32 days. During the reproductive years, estrogen helps the uterine lining grow in preparation for a fertilized egg to implant," Dr. LaKeischa stated.

She added, "When estrogen levels start falling during perimenopause, you can begin experiencing some of the other symptoms that accompany perimenopause other than irregular cycles. You can experience vaginal dryness; hot flashes; skin itching; and mood swings, just to name a few."

Dr. LaKeischa noted that perimenopause can start as early as a woman's late thirties and last years before menopause. Perimenopause symptoms can include having a new onset insomnia; unexplained weight gain; brain fog; joint pain; mood swings; hot flashes; night sweats; and phantom smells. However, perimenopause symptoms can vary. Not everyone experiences the same symptoms.

A woman should consult a doctor if she has perimenopause symptoms.

"Some of these symptoms are debilitating and interrupting a woman's ability to function. Some symptoms are interfering with relationships and activities of daily living. I tell women all the time, you don't have to suffer in silence," said Dr. LaKeischa.

She also mentioned that FSH is a

follicle-stimulating hormone. It is a signal from the brain telling the ovaries it's time to make an egg. This test determines if the ovaries are responding to the signal. The higher this number goes. the more certain you can be that no egg was produced during this cycle, but FSH levels can change throughout perimenopause.

Women can become pregnant during perimenopause, or at the beginning of menopause, even when they have irregular cycles.

"A woman can still have an ovulatory cycle and get pregnant,"

Dr. LaKeischa shared.

She also stated, "This means that during one of those times, a woman can produce an egg. If the sperm is present, it can fertilize it. The broader discussion should involve a reproductive endocrinologist (a fertility specialist) because you have to start talking about egg quality and levels of hormones needed to make the uterine lining favorable for implantation and a whole host of other factors that will contribute to a full-term pregnancy.

She also stated that she often tells her patients that there is not one test that determines their menopause status, although several tests can help determine a comprehensive approach

to managing menopause.

Treatment options exist for perimenopause.


"Options for treating perimenopause range from lifestyle changes to supplementation and bio-identical hormone replacement therapy (BHRT). Women should seek help early. They should seek help as soon as symptoms are interrupting their lives. You don't have to "grin and bear it," she added.

#### CREATIVELY BLACK BALTIMORE CELEBRATES OFFICIAL OPENING

What began as a conversation between Baltimore Times founder Joy Bramble and renowned artist Larry "Poncho" Brown has transpired into an elaborate display of one of the finest Black art arrangements this city has to offer.

Creatively Black Baltimore, a pop-up touted as the "largest regional exhibition of Black art," officially opened to the public during a special reception and celebration on September 28, 2024 in downtown Baltimore.

The exhibit features more than 430 pieces of artwork from more than 80 artists who are either from, reside in or have ties to Baltimore.

The artwork uses essentially every art medium and style imaginable including paintings, drawings, abstract, acrylic, watercolor, pastel, quilting, photography, digital and much more — while reflecting the rich reservoir of artistic genius that lies within the fabric of Black Baltimore.

Brown, the co-founder and curator of Creatively Black Baltimore, is a Baltimore City native whose artwork has achieved international acclaim. He, with the support of community

leaders and local organizations, are on a quest to promote and uplift Black American artists, many of whom are underrepresented in the broader arts community.

Not only did the Creatively Black Baltimore opening reception signify the official opening of the art show to the public, but it was an opportunity for local artists to network amongst themselves along with community leaders and other supporters of the arts community.

"What we're looking for is support and food artists to kind of band together and expand their connectivity with the community. We were able to achieve that," Brown said, reflecting on the reception and ribbon-cutting ceremony.

"It was a great artist fellowship going on there, and it was a great introduction to the project itself."

Brown, whose career as an artist spans more than 40 years, got his start in the industry specializing in graphic design and fine art. From there, his artistic profile and acumen expanded.

Over the past three decades or so, Brown's works have been featured in a number of prominent magazines, books, television shows, films and academic institutions on his path to become one of the nation's most powerful and profound artists.

Creatively Black Baltimore builds upon the legacy and ingenuity of local Black artists of yesteryear who made invaluable contributions to the vibrant arts community that Baltimore has become today. It accentuates Black excellence in the Baltimore arts community in a way that reconnects two to three generations of artists separated by a lack of opportunities Brown pointed out.

The exhibit is housed in 12,000 square feet of space on the second floor of the Light Street Pavilion within Harborplace. Creatively Black Baltimore will occupy the space for two years.

Prior to Creatively Black Baltimore's arrival, the space belonged to Ripley's Believe It or Not!

Art in the exhibit is for sale. Each piece has an accompanying QR code that takes patrons to a website to purchase the artwork. The exhibit, which is free for viewing pleasure, also offers a 3D virtual tour and scheduled events that consist of lectures, art talks, demonstrations, paint parties, small exhibitions and other community outreach efforts.

In addition to the more than 430 pieces of artwork by more than 80 artists included in Creatively Black Baltimore, there is a waiting list, Brown said. In the process of time — as art sells and pieces are moved around — he suspects the show will expand to include work from as many as 100 artists.

"Our mission is to nurture and uplift Baltimore's African American art scene," Brown wrote in an article published in The Baltimore Times last week.

Anthony Coates, an artist whose work is featured in the exhibit, is fascinated with abstract art. He used recycled plastic bags to create pieces that depict the Key Bridge collapse and sunrise over a green pasture. Coates also produced a painting inspired by jazz saxophonist Kamasi Washington.

"I think it's a great opportunity for the artists and the public," said Coates, a West Baltimore native.

"Larry 'Poncho' Brown is an internationally known artist and that needs to be highlighted. He has a vision to put these things together and bring out other artists so we could all have some exposure."

Adriana Downs, 17, is the youngest artist in the Creatively Black Baltimore's exhibition. The high school senior is a sickle cell warrior. Her work reflects her personal journey being a sickle cell patient coupled with her faith.

Downs' other art piece is a painting of the Baltimore skyline. It meant a great deal to be included in the exhibit, she said.

"I never really get to show my art to anyone, and it really meant a lot to show sickle cell through art to other people and share that with the world," Downs said.

A fervent advocate and mentor to artists, Creatively Black Baltimore is simply an extension of the work Brown has been doing for decades.


"What I am trying to do is offer an opportunity for African American artists to show their work," he said. "This show is unapologetically African American, and I think it's time for something like that to take place."

For now, Creatively Black Baltimore is open on Fridays and Saturdays from 1 p.m. to 7 p.m., and Sundays from 1 p.m. to 5 p.m.

#### Meet Linda Lee Hickerson: Donate Life's Newest Board Member has a Passion to Serve

Linda Lee Hickerson, an outgoing resident of Ellicott City, Maryland joined the Donate Life Maryland (DLM) Board of Directors in August. DLM is a state-authorized nonprofit organization serving Maryland. Lee Hickerson, a Howard County Volunteer of the Year for 2015, has a long history of stepping up to volunteer and lend a hand to worthy causes with great commitment and a passion to serve others.

"I like to help people," Lee Hickerson said. "This will be the fifth board I've been able to serve on."

Lee Hickerson volunteered with Mothers Against Drunk Driving (MADD) for over 25 years where she encountered Lisa Spicknall, who is now DLM's executive director. Lee Hickerson recently stepped down from MADD, to take care of an ill husband, work full-time, and juggle other matters. Despite her husband, Brian Hickerson's passing, Hickerson regained her momentum to return to the volunteer space. Her heart to serve, joy of talking to people, affinity for networking, and desire to illustrate a compassionate spirit remained intact. Spicknall told Lee Hickerson that she would love for her to become a DLM board member. Hickerson welcomed the opportunity.

Lee Hickerson reflected on meeting people she encountered who had been touched by organ donation.

"Years ago, in another life, I sold new homes. I had a client who was a heart transplant patient, and I was so impressed with his will to live... and his always being careful. He would call me before an appointment, and he'd say, 'Just checking in. Are we still on? And I'd say, 'Yes, sir, we are.' And I'd wipe everything down in my office," she recalled.

Lee Hickerson, a savvy sales professional who sold new homes for 25 years, recalled having a sinus infection and being on antibiotics. Her client postponed their appointment so that he would not put himself in harm's way. Lee Hickerson reminisced about the way he spoke up and shared the reason for his delayed appointment. She continues to retain sensitivity for people with failed organs and individuals who have dealt with health problems. Lee Hickerson, who is now retired, later worked in the development office at a local hospital.

During Lee Hickerson's downtime, she loves to read, bake, listen to music, partake in crafts, and volunteer to support causes such as organ donation. "My father always said, 'You need to give back to the community,' and that's what I do," she explained.

Lee Hickerson is a registered organ, eye, and tissue donor who puts fear aside, even when doubtful remarks are made about her decision. She previously refuted the idea that medical professionals would not do everything to save her if she signed up to become a donor and happened to experience a life-threatening medical emergency.

"I said, 'That's not true.' It's a common myth that people are afraid of..., but I'm not afraid. I embrace it. If there's something I can do to help someone else, and I don't need them [organs] anymore, then why not?" she added.

Since she has volunteered on other boards, she is comfortable getting the word out about DLM and clearing up



myths and incorrect information.

In fact, Hickerson Lee has already started using social media to share about DLM and start a conversation about organ, eye, and tissue donation amongst family and friends. She posted about the DLM's unanimous approval of her by the board.

"I had 60 of the most complimentary posts," Lee Hickerson shared.

People in her circle openly chimed in about their organ donor status. One friend shared that her husband's organs were recently donated to science because he had a rare cancer. They wanted to help people despite their own situation.

"That's why I said, if I'm going to be gone and someone can use any one of my organs, or skin grafts, eyes or whatever it is, then God bless them. Let's do it. Let's give that gift of life!" Lee Hickerson added.

Regarding her selection as a Donate Life Board member, a host of people congratulated her and agreed that adding her was a great decision.

"I wake up every morning thankful and blessed. I know I've had some hard times, but there's other people out there that are having a harder day

or a rougher day. And to me, if there's something I can do to help, I want to do it," Lee Hickerson stated.


Vance countered by downplaying the urgency, arguing that Democrats were not serious about the issue. "If they really believed climate change was serious, they'd be doing more manufacturing and energy production here in America. That's not what they're doing," he said, accusing Democrats of using climate change as a political slogan rather than implementing real solutions.

Gun violence also sparked a heated back-and-forth. Vance proposed increased school security measures, suggesting, "We need to make sure the doors lock better, strengthen windows, and add school resource officers." Walz quickly criticized the proposal, asking, "Do you want your schools hardened to look like a fort?" He pressed for more comprehensive

gun control measures, emphasizing the need to address the root causes of violence.

Ultimately, Walz positioned himself as a champion of middleclass families, touting healthcare and affordable housing policies. At the same time, Vance remained firmly aligned with Trump, repeatedly defending the former president's record and platform.

Walz appealed to voters to choose leaders who will protect democratic institutions, saying, "When Mike Pence made that decision to certify the election, that's why Mike Pence isn't on this stage." Vance, meanwhile, reflected on his loyalty to Trump, asserting that "Donald Trump delivered for the American people."



years, the net revenues of these companies have grown astronomically from hundreds of millions to billions of dollars, while the ILA members' wage increase does not even cover the cost of inflation. The ILA is fighting for respect, appreciation, and fairness in a world in which corporations are dead set on replacing hard-working people with automation. Employers push automation under the guise of safety, but it is really about cutting labor costs to increase their already exceptionally high profits," per additional information that was issued by the ILA.

According to the Port of Baltimore, it handles more farm and construction machinery than any other East Coast port.

"Farmers in the heartland rely on the Port of Baltimore," a statement posted on X read.

The Port of Baltimore was the sixthranked U.S. port for importing coffee in 2023 with 185,000 tons of coffee worth \$1 billion according to another statement that was posted on the social media account. Coal is another big export item in Baltimore. Trainloads of coal are also loaded in Hampton Roads onto ships to head to other countries.

Additionally, The Port of Baltimore is among the top 20 ports in the United States by tonnage and number of containers handled, is the 10th largest port for dry bulk, and is a major hub for the import and export of motorized vehicles, according to information provided by the U.S. Department of Transportation's Bureau of Transportation Statistics.

After the Dali ship crashed into the Francis Scott Key Bridge in Baltimore, causing a lot of damage on March 26, 2024, it later headed to Virginia International Gateway where containers were off-loaded and additional repairs were made, before finally heading to China in September. There was extra work to do because of the tragedy. ILA members pulled extra shifts in Virginia while supporting emergent labor needs

that arose because of the accident. Virginia is in the top five of the largest ports in the nation.

Port members in Baltimore and Virginia were among ILA members who joined the strike. Many consumers who may not have much knowledge about dockworkers, who are also known as longshoreman, may not have understood their vital role in ensuring that cargo is loaded on and off ships with great care. They must have excellent physical stamina, a willingness to face job hazards ranging from slip-and-fall accidents to handling dangerous equipment, despite the long and odd hours that ships come or go, or the conditions of weather, while often sacrificing family time. Well-oiled teams move containers or climb in machines high in the air. Lashers secure and unsecure tie containers on ships to ensure they do not shift and fall in waters. Drivers move containers from one point to another.

Shortages of goods could range from automobiles to items that customers could expect to find on store shelves, but longshoremen do what many cannot or will not. Truckers need them to keep the supply chain moving to enable consumers to pluck what they need or want from store shelves.

"The ILA has rejected their so-called "nearly 50% wage increase" because it fails to address the demands of our members adequately. They might claim a significant increase, but they conveniently omit that many of our members are operating multi-million-dollar containerhandling equipment for a mere \$20 an hour. In some states, the minimum

wage is already \$15. Furthermore, our members endure a grueling six-year wage progression before they can even reach the top wage tier, regardless of how many hours they work or the effort they put in. USMX also overlooks the fact that two-thirds of our members are constantly on call, with no guaranteed employment if no ships are being worked," the ILA stated online.

"Toilet paper isn't important until you don't have any," an anonymous longshoreman said during the strike. "Our strike puts the world on strike—the rich, the poor, the young, the old, the Black, the white."

Another longshoreman looked toward the street as he shared that ILA members lost friends who have died on the job from accidents and catching COVID during the pandemic. Sometimes dock workers were exposed to COVID when they were unaware that crew members aboard ships put them at risk, in addition to showing up to work amongst each other.

"It created heightened anxiety," an anonymous longshoreman said.

Darrin Riddick-Davis, a longshoreman who is a heavy equipment operator, represented Local 1248 as a strike captain. He has 33 years of experience as a civilian and military longshoreman. Riddick-Davis provided direction to members, and helped Local 1248's president, Chris Faulk, with the organization of members who participated in the strike in Newport News, Virginia. He tracked numbers of ILA members who showed up and went home to sort through notes and phone numbers to organize the next day's strike participants.

Kevin Cooper and Charles Nichols, a lasher and a driver, showed up to support the Local and the causes of their industry. Cooper has been doing his job for 29 years. Nichols has contributed 15 to the industry.

Dock workers with a variety of jobs held signs and encouraged passing cars to honk in support of their contractual plight.

"When people go to stores and find what they are looking for, it is because a vessel was unloaded at a port. This is the one strike that everyone is impacted by," an anonymous longshoreman reminded while walking the picket line.

From time to time, another car horn honked.

ILA members continued to chant, "Corporate greed ends today! Fair pay for the ILA!"

They hope for successful negotiations with USMX. Until that happens. dockworkers from the U.S. East and Gulf coasts say they will continue to strike.
