Former Crosby police chief files discrimination lawsuit

Alleging illegal discrimination in violation of the Minnesota Human Rights Act, former Crosby Police Chief Kim Coughlin filed a lawsuit against Crow Wing County on August 29. The lawsuit, filed in Crow Wing County District Court, claims that Coughlin, who was employed as a Background Investigator for the Crow Wing County Sheriff's Department, was subjected to retaliatory treatment after her husband made formal data practices requests related to a local police incident.

Coughlin was hired by the Sheriff's Department in September 2021. However, according to the lawsuit, her work assignments were significantly reduced following an encounter her husband, Tim Coughlin, had with Deerwood Police Sergeant Jessie Smith on November 10, 2022. The lawsuit states that the verbal altercation between Tim Coughlin and Smith occurred at a local gas station, during which Smith allegedly threatened to arrest Tim and later filed an incident report.

Following the incident, Tim Coughlin made formal data practices requests to

both the Deerwood Police Department and the Crow Wing County Sheriff's Office. According to the Summons and Complaint, after these requests were made, Kim Coughlin was no longer assigned the background investigations she had been regularly handling prior to her husband's requests. The lawsuit asserts that, while other investigators in the department continued to receive work assignments, Coughlin was left without tasks, prompting her to inquire about the lack of work

with her supervisor, Sheriff Todd Klang, and other department members.

The complaint further details that despite her inquiries, Coughlin's work assignments remained stagnant. The suit contends that this lack of assignments was a direct result of the actions taken by her husband and his involvement in the data practices requests, alleging that the county's actions amounted to retaliatory discrimination.

Kim Coughlin is seeking damages, including com-

pensation for lost wages, lost benefits, emotional distress, and other relief in an amount greater than \$50,000 to be determined by the court. The lawsuit also requests an or-

der from the court requiring Crow Wing County to cease discriminatory practices and ensure a non-retaliatory work environment for employees.

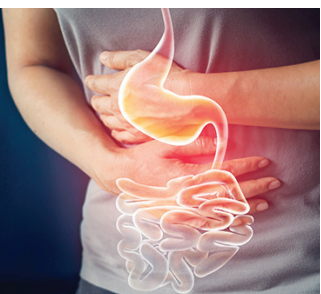

Free entrance to Minnesota state parks and recreation areas on Nov. 29



Looking for a way to unwind and explore the outdoors after Thanksgiving? Minnesotans encouraged to explore outdoors with friends and family over the holiday weekend. The Minnesota Department of Natural Resources is waiving entrance fees to all 73 state parks and recreation areas the day after Thanksgiving, Friday, Nov. 29. This “Free Park Day” is one of four days each year when the DNR waives the requirement for a vehicle permit for state parks and recreation areas. The goal of Free

Park Days is to encourage Minnesotans to get outdoors and enjoy the health and wellness benefits of spending time in nature. “During the hustle and bustle of the holiday season, Minnesota state parks and recreation areas are the perfect places to enjoy the tranquility of nature,” said Ann Pierce, director of the DNR Parks and Trails Division. “We encourage people to get outside with friends and family after Thanksgiving gatherings to enjoy the calming sights and sounds of

nature. With cooler weather, quieter trails, and unique wildlife activity, visitors can experience Minnesota state parks and recreation areas in a new light.” Published studies show the positive physical and mental health benefits of spending time in nature. According to the American Psychological Association, the calming and restorative qualities of nature help lower cortisol levels, which leads to reduced stress and improved cognitive function, and improve overall mental well-being. Outdoor recreation options in late November include hiking, biking, nature photography, birdwatching and wildlife watching. Even though peak fall colors have passed, late fall offers scenic vistas and peaceful trails. This time of year is perfect for spotting birds and wildlife that are easier to see after the leaves have fallen from trees. Look for deer and foxes that are more active in cooler weather, and waterfowl along lakes and rivers.

Visitors are encouraged to plan ahead and arrive prepared for their visit. Check visitor alerts and find directions on state park webpages (mndnr.gov/park-list). Download the Avenza app and the geoPDF map before the trip. The app and maps are free, and maps will display a user’s current location even when not connected to the internet or cell service. Find information on the DNR’s geoPDF map webpage (mndnr.gov/geopdf). Visitors without a smartphone should look for paper maps outside the ranger station. Visit the information signs near the park entrance for

suggestions on what to see and do in the park. Check the weather forecast before leaving home, and dress appropriately for the conditions. Be sure to pack water and snacks. For more information, visit the free park day webpage of the DNR website (mndnr.gov/freeparkdays).
