#### **From The President**

As I neared the end of my year as president, one night, as is sometimes the case, I awakened from restless sleep with a busy mind, contemplating all the things that I would soon need

to accomplish in my daily grind. You know, the cases to attend to in the practice of law, problems to solve at the office, varying duties to fulfill, deadlines to meet, and what to say in this farewell President's Message.

There was a time in my life, where in addition to practicing law, I coached Little League baseball. During that time, I attempted to impart to the team a message they could use for the rest of their lives and not just while they were baseball players. My message was inspired from having read Coach Nick Saban's book, *How Good Do You Want To Be?* 

What Coach Saban teaches, even in his days of retirement, I found to be beneficial to winning, not only on the field, but in life. It's a thing he calls "The Process." The Process is the mechanism whereby the team's attention is directed away from the result of winning and onto doing the things that contribute to a favorable outcome.<sup>1</sup>

To win, you first have to prepare. Next, you have to perform to a standard both individually and collectively. Excellence is the standard of any winning team. What I generally proposed as our standard was simply "your best." I told my guys, "It takes zero talent to hustle." Your best effort is your standard, and our best effort all the time is the team's standard. If everyone upheld the standard, we won.

As we were about to play games, I would sometimes ask this question, "How do you want to be remembered?" <sup>2</sup> And that is what I decided to make the topic of this final message.

Inscribed in my eighth-grade yearbook is a note from one of my teachers that reads: "If I ever need one, I hope to look you up as a lawyer one day." This is a reminder that early in life I had articulated a desire to become a lawyer that was known to at least one of my teachers.

I can also remember standing in my driveway in the summer of 1983 telling my best high school buddy goodbye as he was about to head back to the United States Air Force Academy. I was then majoring in engineering and not enjoying it very much, as calculus and I never saw eye to eye. My friend reminded me, "You are not supposed to be an engineer, you are supposed to be a lawyer." I changed my major the next semester.

I said all of that to say this, that this profession, the law, called me to it. And, how I want to be remembered is as someone who upheld the standard of the calling. The standard being my best effort to every client, every day. My best preparation for every judge, in every court, every time. My best professionalism to my colleagues in the bar all the time. When called upon by client, court or colleague to service, I answered the call with my best effort.

I would also want to be remembered for being grateful to the people who helped me along the way. Nobody helped me through law school more than my study buddy, Carolyn Smilie. The Louisiana Bankers Association gave me my first clerking job. Mike Rubin and Warren Mengis taught me about practicing law before I realized what that meant. The late Pike Hall gave me my first law job as his trusted clerk. Ron Weems and Carey Schimpf were my first law partners, and I would not be practicing law for all these years in Shreveport without them.

Nobody can truly give their best to any endeavor without strong support. I am so fortunate to have had the love, support and inspiration of Brenda Haines, my wife of 31 years. She has been my rock through many trials (literal and figurative). She daily overcomes many health challenges and is still there for me with her best effort every single day. I am truly thankful and blessed to have Brenda on my team.

Coach Skip Bertman is quoted as saying that to win, you have to focus on "What's Important Now." My hope is that all of you will discover that what is important now is giving the best of what's inside of you to the things you are called to do. And, when you think of me, you remember that I gave my best effort to what brought us together in this journey.

<sup>2</sup>Joe Demaggio was often asked why he always ran onto and off the field, why it seemed he hustled every play. His answer was that he never knew who would be in the stands watching and he wanted to be remembered for giving his all to every game.

#### Elizabeth M. Carmody Will Lead the SBA in 2025

Elizabeth Carmody will begin her term as president of the Shreveport Bar Association on January 1, 2025, succeeding Kenny Haines to the one-year post. Elizabeth is special counsel at the law firm of Cook, Yancey, King and Galloway where she practiced with the firm from 2000 through 2002 and rejoined the firm in 2009. ## Federal Bar Donates \$12,000 to Barksdale Charity

## Shreveport Bar Association Archives A Holiday Traditions in Our Legal Community The Wilkinson, Carmody & Gilliam Christmas Party

Since the pandemic of 2020 changed the world and the way we connect with people, traditions have gone altogether by the wayside, or become all that more important. It seems, at least to this writer, that there is no real in-between. The pandemic break from tradition was welcome for some and devastating for others. There is no better time than the holiday season to look at the traditions that have survived, and celebrate the importance of passing on the good bits of yesteryears and fond feelings of togetherness fostered by tradition.

A tradition is the transmission of customs or beliefs from one generation to the next, passed down by those before you, inherited memories and tangible objects whose significance rests solely on the collective belief of the beholders.

Traditions cannot survive without belief, like fairy dust cannot make you fly unless you believe in fairies. Traditions cannot survive without care and love, like the old.

tattered recipe cards shoved into books with handwritten amendments and substitutions, or carefully bubble-wrapped ornaments from your childhood packed up and taken out again annually with the hope for an opportunity to share these treasures with family and friends.

There is one tradition in our small legal community that has continued for over 125 years! The Wilkinson, Carmody & Gilliam Christmas Party, a tradition which has survived the Great Depression, two world wars and a global pandemic.

The firm was founded in 1895 by John Dallas Wilkinson and A.T. Alexander, and boasts the title of the oldest still-operating law firm in Shreveport. In its first year of operation, the firm opened its doors to the legal community hosting a Christmas Party which has continued every year without interruption, unless you consider the limited guest list of 2020 due to Covid-19 restrictions. With much care, hard work, budgeting and planning, it has continued for 129 years.

Every year a theme is selected, decorations are ordered or carried out of storage. An ice sculpture is commissioned. A band is hired. Catering is organized, and invitations are designed and ordered. The invite list includes firm clients, attorneys, judges, officials and friends. The list must update yearly. The staff sends out approximately 800-1000 invitations per year, some with handwritten messages, all

stuck into envelopes, sealed and stamped. The firm has begun to send save-the-date reminders electronically, but holds firm to the tradition of a paper invitation regardless of the expense. The process of stuffing physical invitations usually takes the staff 2-3 days.

Traditionally, the Wilkinson, Carmody & Gilliam Christmas Party was held at the firm's offices in the Wells Fargo tower in downtown Shreveport. With a catered buffet from the Shreveport Club on the conference room table, people moved from room to room squeezing through

the narrow hallways, bumping into old friends and meeting new and interesting characters. Notable guests over the years have included clients from across the pond, professional football stars, and even a Playboy Bunny of the year.

Since 2021, the firm has moved its annual party to the 16th floor ballroom of the Petroleum Club, but carried over traditions of a live band, ice sculpture, open bar and catered meal. Some trends have

catered meal. Some trends have changed over the years and parties, in general, appear to not be as popular as they once were. Hearned that the '50s and '60s were the decades with the biggest, most well-attended parties.

One of the firm's fondest traditions is the handcrafted boards displaying photos from past parties. The photo boards are displayed around the room at every Christmas Party.

Art Carmody, longtime partner of the firm and local legal legend, passed in 2021. At his memorial it was noted that the firm's Christmas Party was his pride and joy. Bobby Gilliam, current managing partner, commented that it is hard to keep traditions going, but the Christmas Party is worthwhile. During 2020 there was discussion over discontinuing the Christmas Party, but the firm overwhelmingly determined that this is one tradition that must continue no matter the cost.

Without traditions such as this Christmas Party, where would one go to hear fantastic stories, like the time Mr. Scott Wilkinson swam across the Mississippi River from one bank to the other only to land some 6-7 miles down from where he started? While initially dubious, this story is undoubtably repeated at every Christmas party and with belief and wonderment we keep tradition alive. I hope to see you all at all the parties this holiday season.



Shreveport Bar Foundation in collaboration with Gingerbread House CAC & Project Celebration

During the month of October our focus was on Domestic Violence Awareness. We created and posted videos with our friends at Project Celebration and the Gingerbread House on our Facebook page to bring awareness and education to our community. Between 30-40% of Americans are impacted by sexual abuse, physical violence or stalking. The Shreveport Bar Foundation has played a huge role in so many of those lives here in Caddo and Bossier parish and we were able to share that throughout the month of October.
















#### **Memorial & Recognition Ceremony**

The Memorial & Recognition Ceremony is a longstanding tradition in the Shreveport Bar Association – a tradition that has been around for 145 years. 


