

EPC Transition Committee moves to its March goal

On Monday, February 24, General Manager Theresa Ostrander, Public Safety Director Matt Hidalgo, and EPC representative Diane Finley worked in tandem with the Emergency Preparedness Transition Committee (EPTC) to hold an open forum for all 400 EPC volunteers. This 90-minute event gave leadership an opportunity

to share the latest updates - new EPC Charter, announcement of the new Emergency Preparedness Coordinator starting March 3 and reporting to Public Safety, as well as the many community outreach efforts that have become invaluable to the formation of The Villages future EPC Program. The message to volunteers—and the entire Villages community—that EPC continues to function exactly as it has until this new integrated program is established was amplified once again. Should an emergency take place, our EPC volunteers are ready for action.

The transition from an all-Villages volunteer program to one now led by the General Manager offers a stronger bridge between the volunteer

ABOD President's Message—February 25, 2025

Welcome everyone to the February Association Board of Directors meeting. A few weeks ago, the Governance Council received a presentation from management on the new technology in The Villages. We have moved from the age of The Flintstones to the age of The Jetsons. From reserves to budgeting to $for\ the\ Future\ of\ The\ Villages$ tee times to work orders, it is amazing the improvements we have had in a very short time. Yes, some of the transition was painful and maybe could have been done differently but the result is incredible, and I think it was worth it. And look: now we have our own app. The more I use it the more I like it.

I have a personal example of how this improvement has worked for me. A few weeks ago, at 9:23 a.m., I created a work order on MaintainX to trim some bushes that had overgrown my kitchen window and were blocking the light. I received an email confirming the request eight minutes later. Fourteen minutes after that my doorbell rang and it was a BellaVista employee confirming which bushes I wanted trimmed. Twenty-one minutes after that, I received email confirmation telling me the trimming was done. That's 43 minutes from creation to completion. Now as most advertisements will tell you, results like that cannot be guaranteed but I was really impressed with the response. Hopefully that level of service can continue for everyone.

The ABOD had a working session on February 13 regarding budgeting and priorities. I would like to thank the DACs for all their hard work and input into this process so far. It appears to me we are now getting squeezed on two sides and decisions are being forced upon us. We are required to do turf reduction by 2029 but on February 6 Governor Newsom signed an executive order requiring everyone to complete fire hardening in "Zone 0." Approximately 1.4 million acres are now being considered a high fire risk. I am unsure of the deadline for this work, as the regulations have yet to be released but it will likely be sooner as opposed to later. The CalFire fire zone maps are being updated and the Santa Clara County map was supposed to be released yesterday. Zone 0 is the space between 0 and 5 feet from any structure and is being characterized as "ember resistant zones." Considering the LA fires, which were the most devastating fires in California history, we will be voting on whether or not to make The Villages perimeter our budget priority this year. Our annual four acres of turf reduction for the coming year will be covered by The Club Board so as a community we will continue to make progress with our turf reduction.

Thank you all for being here and as usual, my phone, my email and my door are always open and available for questions or comments.

Club President's Message—February 25, 2025 Progress and Important Decisions

The Villages has achieved major improvements in the last two years in staffing, operational and financial controls, cost cutting, and long-range planning. Visible improvements include the Clubhouse services and menu quality, and refurbished bocce courts, stables, and the golf course. Public Works now completes over 95% of work orders submitted in timely fashion. Not so visible, but equally important, the staff overhauled our hardware and software systems to improve managing operations, finances and reporting. Work in progress includes completing the new Member Portal, The Villager Online, improving membership services and implementing an effective marketing program that describes the unique characteristics of the Villages' community.

With Theresa Ostrander, our General Manager, the Villages three Boards completed a draft of a Strategic Plan for the years 2025 through 2028. The major observation in the Plan's draft is that our aging facilities have not been adequately maintained. We are not collecting adequate capital funds for repair or replacement of existing facilities. From the Strategic Plan's Executive Summary:

"The leadership and residents must strive to maintain and upgrade the physical plant that exists, so it can offer a relevant experience to the next generation of homeowners, or it will fail to attract new homeowners, which will cause property values to fall."

An example of projects that will need significant funding include the maintenance and repair of our underground utilities. The sanitary sewer, storm drains, water supply and other systems are owned and maintained by the Villages not the City of San Jose. The estimated cost to maintain these systems is \$20 million over the next 10 years. The Club Capital Budget for the next fiscal year, starting in July, will be based on maintaining, improving and protecting our existing Club assets-buildings, roads and utilities.


The next step in our strategic planning process begins with a detailed Member Satisfaction Survey starting with focus groups in May. These will be followed by a detailed online and printed survey. The results will guide policy and strategy to meet community needs and expectations for the future.

Association/Homeowners documents available via email

Per an amendment to California Civil Code, homeowner associations are permitted, with owner's written consent, to distribute annual disclosures, (like the pro forma budget summary) and other specified association documents to owners via electronic mail, facsimile, or other electronic means (such as posting on the association's website) instead of sending those documents out by regular mail or personal delivery. This has the potential to provide cost savings to The Villages. Delivery and postage costs for the Villages' annual distribution of the pro forma budget summary alone are close to \$1,000, not to mention the paper and printing costs.

In order to transmit association documents via e-mail or by posting on the homeowners association's website, 1) the homeowners association must first receive the owner's written consent, and 2) the homeowners association sends a separate notice to the owner that the documents have been posted and are available for viewing.

Consent forms for owners to request delivery of documents have been developed for both The Villages Association and Homeowners Corporations. These forms provide an owner's consent to electronic delivery of documents that are capable, under current laws, of being distributed electronically. Owners have the right to revoke this request and receive "hard copies" of the documents by sending a written revocation signed by the owner, to the applicable corporation.

Why the transition of EPC leadership to the GM's Office?

After a thorough assessment of EPC's charter, the organization's capabilities, and the magnitude of meeting the responsibility to safeguard and aid The Villages community of over 4,000 in the event of an emergency, the Emergency Preparedness Committee (EPC) leaders, Club Board and (General Manager) GM's Office together concluded that the scope and burden cannot be successfully sustained with its current formation.

What happens to EPC during this transitional period?

To maintain stability during this transitional period, EPC continues to function exactly as it has until the new program is established, with the expectation that all volunteers remain in their current positions.

What will EPC transition to?

An Ad Hoc Emergency Preparedness Transition Committee (EPTC), comprised of EPC leadership, Club Board liaisons and representatives from the GM's Office, is carefully assessing the best program tailored to The Village's needs, whether that means a revamped EPC Charter, a CERT (Community Emergency Response Team)-like model, or a custom-fit approach serving in a CERT capacity.

With its magnitude, does the GM's Office have staff to manage the new program?

Not currently. The General Manager added the position of an Emergency Preparedness Coordinator to the management team. This person, working with Public Safety, will take on the responsibilities that the former EPC leadership did. A coordinator has been hired and began work Monday, March 3.

Who's part of the Ad Hoc Transition Committee?

The Ad Hoc Emergency Preparedness Transition Committee (EPTC) is comprised of:

- Club Board Liaisons Larry Versaw and Michelle Breslin
- GM Office Representatives Theresa Ostrander, Matt Hidalgo and Elizabeth Park
- EPC Leadership Ray Blinde, Daniel Grim, Diane & Kyle Finley and Fran Schumaker

What's the goal of this effort to transition EPC under the GM's Office?

Simply stated, our goal remains clear—to establish a more resilient, effective response framework that prioritizes the well-being of all residents.

Where are we in creating our new emergency response program?

The Emergency Preparedness Transition Committee (EPTC) has completed its discovery phase and is putting the final touches on the Pen-to-Paper Phase, updating the Charter and consolidating findings to create a working draft of the Integrated Emergency Plan.

What are the next steps?

Once the working draft moves to final, the Integrated Emergency Plan proposal will be presented to the Club Board at its regularly scheduled monthly meeting, slated for March 25.

There will be an all-Villages EPC volunteer Q&A forum on Monday, March 24 from 9 to 10:30 a.m. at the Clubhouse. Interested volunteers welcome!

Reminder: File for parcel tax exemption by May 31

If you wish to file for an exemption from the annual \$125 Evergreen School District parcel you must do so by May 31. You may do so if your Villages property is your principal residence, and you are at least age 65 or will be age 65 by July 1, 2025. If there are joint owners of your principal residence, only one owner needs to be age 65.

If you had the exemption from the parcel tax for 2024/2025, your exemption has been automatically renewed by the School District. There is nothing more you need to do. This article is about new exemption requests.

If you would like to apply for the exemption for the 2025/2026 tax year, you may file online at www.eesd.org. Click on "Community" and then click "Senior Parcel Tax Exemption." You will need to upload documents to prove three things:

- 1. Proof of ownership: Your current property tax bill
- 2. Proof of residence: Your current PG&E bill
- 3. Proof of birth date: Your driver license, passport, or birth certificate

You may also apply in person for the exemption at the School District Office at 3188 Quimby Road, Monday through Friday from 8 a.m. to 4 p.m. through May 31. Contact: Casey Wink at LAblao@eesd.org or Patty Maciel at MMaciel@eesd.org to schedule an appointment. The phone number is 408-270-6822.

If you are new to The Villages and the address on your driver's license does not match your property tax statement, please schedule an appointment at the district office. Bring your Villager residency card and a second bill to substantiate your residency.

Also, if you do not yet have a property tax statement, take your escrow purchase statement and related papers to the district office. Before the appointment go to www.sccassessor.org and enter your address in the Property Record Search box. The district needs the assessor's parcel

Not sure whether you have the exemption? Go to your last property tax bill. Look on the back page under the section labeled "Parcel Tax/Special Assessments." If a line item is "Evergreen Measure EE 2018 \$125" you are paying the tax. If you can't find this listing, it means you are currently exempt from the tax.

Note: The Senior Resource Services (SRS) office hours for drop-in assistance are Monday, Wednesday, and Friday from 10 a.m. to noon. The SRS office is in the Cribari Center across from the Post Office. You may also leave a message at 408-239-5253 or e-mail SRS at villagessrs@ sbcglobal.net. The purpose of SRS is to provide education and general business and financial information. All assistance is free and confidential. You should ask your professional advisor about your individual situation.

SRS Recommendation:

Get your tax refund ASAP

If you are receiving a refund on your income tax return, the safest, most accurate and fastest way to get your refund is to electronically file your return and choose direct deposit of your refund. Most people receive their refund within 21 days.

Expect an additional 60 to 90 days to receive your refund if you ask for a paper check.

Direct deposit means any tax refund is electronically deposited for free into your checking or savings account. This is the same electronic transfer system used to deposit nearly 98 percent of all Social Security and Veterans Affairs benefits into millions of accounts. You trust it for your Social Security, why not trust it for your tax refund?

Villages pool closures: updates and next steps

Foothill Spa was temporarily closed February 17 after county inspectors found chemical levels outside the acceptable range. The issue was resolved quickly, and reopening occurred in less than 24 hours. Foothill Pool and spa remain open during regular hours (5 a.m. to 10 p.m.) and Foothill Pool remains open for adults only.

Vineyard Pool and Spa are closed due to a fence height requirement mandated by the Santa Clara County Environmental Health Department. The Villages is developing engineering plans to bring the enclosure into compliance. Once the plans are approved by the county, the pool can reopen while modifications are made.

Montgomery Pool experienced a similar enclosure issue in late October. The Villages is following the same process to ensure compliance, working closely with county officials to meet all safety requirements ahead of reopening.

Pools and spas at Montgomery and Cribari are regularly closed for the season from Nov. 1 to March 30, and both are slated to reopen as usual April 1.

Management continues to focus on resident safety and regulatory compliance. Updates on pool status and reopening timelines will be provided as more information becomes available. For facility hours and open status, check the Member Portal's "Today at a Glance" feature (visit member.thevillagesgcc.com).

THE VILLAGES ASSOCIATION ELECTIONS RULES

ARTICLE 3 CANDIDATES FOR THE BOARD AND NOMINATION PROCEDURES

3.1 **Qualification of Candidates**. Candidates for the Board must be Members at the time of their nomination and must meet all other qualifications or restrictions set forth in these Election Rules. In the case of a Member that is not a natural person (such as a corporation or other entity), the entity Member shall have the power to appoint a natural person as the "Member" for purposes of director elections. The Association shall disqualify a nominee for the Board for any of the following reasons:

3.1.1 The nominee is not a Member.

3.1.2 The nominee, if elected, would be serving on the Board at the same time as another owner of the same separate interest and the other person is either properly nominated for the current election or is an incumbent director.

3.1.3 If the nominee, at the time of nomination, is delinquent in the payment of regular and/or special assessments. A nominee shall not be considered "delinquent" if the delinquency relates to the payment of fines, fines renamed as assessments, collection charges, late charges, or costs levied by a third party and/or if the nominee:

(a) has paid the regular or special assessment under protest; (b) has entered into a payment plan for repayment of the delinquent assessments and is not delinquent in payments due under the plan; or (c) has requested and has not been provided an opportunity to engage in internal dispute resolution.

3.1.4 If the nominee has been a member of the Association for less than one year.

3.1.5 If the nominee discloses, or if the Association is aware or becomes aware of, a past criminal conviction that would, if the Member was elected, either prevent the Association from purchasing the fidelity bond coverage required by Civil Code section 5806 or terminate the Association's existing insurance coverage required by Civil Code section 5806 as to that person should the person be elected.

3.1.6 If the nominee has served the maximum number of terms or sequential terms allowed by the Association's governing documents.

3.2 Nominations.

3.2.1 Solicitation of Candidates. 





The purpose of the congressman's special visit was to address questions and concerns from his Villages constituents.



-The aeration of lawns and turf fertilization throughout all the districts is scheduled the week of 3/17/25, weather permitting.

-Broadleaf application throughout all districts continues throughout the community. 4-speed XT (EPA#228-590) is being applied directly to invasive plant material and is not being sprayed completely on the grass. Rather, it is a spot treatment. We have posted signage at the entrances to the villages and in areas where the treatment has been sprayed and we are asking that no one walk on the grass nor have their pets on the grass until the treatment has dried. Thank you for your assistance. (4-speed XT (EPA#228-590)

BellaVista and management have adjusted/reduced the watering schedule based on the latest weather conditions.

Club Maintenance

If your village is not listed below, there is not a large-scale project occurring within your community. However, Public Works continues to address ongoing standard maintenance and landscape requests within each village.

• Clubhouse—The Bistro water feature has been inspected for a leak. Public Works & Recreation Services are currently creating a plan to perform a repair.

• Beta Site—Management installing a bench at the corner of Village Parkway and Village Fairway. This will complete the project.

• Community Pool Closures — Concerns have circulated regarding recent pool closures this past week. The Villages Golf & Country Club management is addressing these issues and working to resolve them guickly.

Foothill Spa was temporarily closed February 17 after county inspectors found chemical levels outside the acceptable range. The issue was resolved quickly, and reopening occurred in less than 24 hours. Foothill Pool and Spa remain open during regular hours (5 a.m. to 10 p.m.) and Foothill Pool remains open for adults only.

Vineyard Pool and Spa are closed due to a fence height requirement mandated by the Santa Clara County Environmental Health Department. The Villages is developing engineering plans to bring the enclosure into compliance. Once the plans are approved by the county, the pool can reopen while modifications are made.

Montgomery Pool experienced a similar enclosure issue in late October. The Villages is following the same process to ensure compliance, working closely with county officials to meet all safety requirements ahead of reopening. Pools and spas at Montgomery and Cribari are regularly closed for the season from November 1 to March 30, and both are slated to reopen as usual April 1. Management continues to focus on resident safety and regulatory compliance. Updates on pool status and reopening timelines will be provided as more information becomes available. For facility hours and open status, check the Member Portal's "Today at a Glance" feature (https://member.thevillagesgcc.com/).

Association Maintenance

If your village is not listed below, there is not a large-scale project occurring within your community. However, Public Works continues to address ongoing standard maintenance and landscape requests within each village.

• Village Cribari — Environmental roofing has made great progress. Building 2 (units 5508-5513) is fully completed. Building 1 (units 5514-5517) needs some additional material to be added. Building 3 (units 5501-5507) has all repairs completed. The vendor needs to add some additional material at this location. The vendor is also awaiting bids for the replacement of two (2) skylights at Building 3.

• Village Heights—Construction work continues at 8480 Grenache. You may observe some additional vendor traffic in that area. Thank you for your patience while the project is completed. Please contact Public Works should you have any questions.

• Village Montgomery—On February 19, the City of San Jose visited the sinkhole project site. On February 28, A&B construction added soil to the area, removed and reinstalled plant material and irrigation, added bark material and added soil. Lastly, the vendor compacted the new and existing soil. The project was completed.

• Village Valle Vista—A leaking backflow (located at 9025 Village View Drive) has been approved for replacement. Management is coordinating the repair and schedule with Salcido's Backflow Services.

Contractor may start several days ahead or behind plan schedule, pending field and weather conditions. As needed, we update schedules accordingly via FastLane. Parking facilities and street frontage may be in use on a temporary basis for vehicle, material and equipment staging. Debris, dust, noise, odor and visual inconveniences may result from a project. Drain After Rain to Prevent Mosquitoes

Recent rainfall throughout much of California has created puddles and stagnant water. With the temperature warming up in many parts of the state, this combination can create the perfect situation for mosquitoes to breed. We encourage you to "drain after the rain" to prevent mosquito-breeding sites.

After rainfall, drain standing water from common backyard sources such as buckets, flowerpots, bird baths, old tires and other small containers. Think an item is too small for mosquitoes to breed in? Think again—newer, invasive mosquito species in California need only a bottle cap worth of water to develop in. Clean all gutters and downspouts as leaves, twigs, seeds, and other organic matter can block water flow. Your efforts to eliminate sources of standing water now will mean less mosquitoes later in the season!

Mosquitoes are a public health threat because they are capable of transmitting debilitating diseases such as West

Nile Virus, Zika, dengue and chikungunya. Protect yourself from mosquitoes by wearing an effective repellent and staying indoors when they are most active.

the nomination before the published deadline for receiving nominations. In addition, the Board may recruit qualified candidates and/or may appoint a nominating committee to nominate qualified candidates. Notwithstanding the foregoing, if Election by Acclamation is going to be considered, the Association must follow the procedures in Section 2.5 ("Election by Acclamation"), above.

3.2.2 No Write-Ins. No "write-in" candidates shall be permitted on the ballots in the election of directors.

- 3.2.2 No Write-Ins. No "write-in" candidates shall be permitted on the ballots in the election of directors.

 3.2.3 No Nominations from the Floor. Nominations of candidates from the floor of membership meetings shall be prohibited in the ballots in the election of directors.
- 3.3 Candidate Registration List. The "Candidate Registration List" shall mean the list of candidates who will appear on the ballot and shall include the names and addresses of individuals nominated as a candidate for election to the Board. Upon request, the Association shall permit candidates to verify the accuracy of their individual information on the Candidate Registration List at least thirty (30) days before the ballots are mailed. The candidate shall report any errors to the Inspector of Elections who shall make the correction within two business days. The Association may, at its discretion, report any known errors to the Inspector of Elections. The Candidate Registration List shall be retained as "association election materials" as required by law.
- 3.4 Notice of Known Candidates. The names of all persons on the Candidate Registration List shall be set forth on the ballot.
- 3.5 **Candidacy Statements**. Any candidate who wishes to submit a candidacy statement may only do so using the Association's authorized form. The content of any candidate statement shall be limited to a statement of the candidate's qualifications to serve as a director.
- 3.6 **Qualification of Directors**. A director must comply with the same requirements set forth in Section 3.1 ("Qualification of Candidates"), above, pertaining to the qualifications for a candidate for the Board. Member Notice: Proposed Changes to Club Rules Attachment D, Rule 1.30 The Pulse and The Villager and Rule 1.32 The Villages Website

At the January 28, 2025, monthly Board meeting, the Club Board approved for 30-day member notice proposed changes to Club Rules Attachment D, Rule 1.30 The Pulse and The Villager and Rule 1.32 The Villages Website prior to formal approval consideration at the March 25, 2025, monthly meeting.

The proposed changes and comments received were discussed at the February 25 Board meeting. The Board approved to continue to publish proposed changes with a text modification to Rule 1.30 The Pulse and The Villager removing the following text from 1.30.D, which includes a last week of the month submission with a first week of the month submission making the potential acceptance of both letters sequential.

Response to the proposed rule changes may be made by one or more of the following methods: 1) Participation in the discussion of the changes at the March 25 board meeting, 2) via e-mail (jmeadows@the-villages.com) with comments sent to the General Manager's office at least seven days prior to the board meetings, or 3) via written comments to the General Manager's office (Business Administration Building A) delivered at least seven days prior to the aforementioned board meetings.

Attachment D

The proposed revision to Attachment D modifies the time period to provide notice of proposed rules changes to members/residents from 30 days to 21 days. Changing the notice period not only aligns the notice period with that for proposed Club Board policy changes but also facilitates more timely approval consideration of proposed changes. Currently, depending on the date of the board meeting, which is held on the last Tuesday of each month, it can sometimes take up to two months for the Board to review and approve proposed changes. By reducing the notice period to 21 days, the process can be streamlined, ensuring that proposals are considered more efficiently and in a timelier manner.

ATTACHMENT D

Club Rules

1. Procedure:

A request to add, delete, or change a rule may be submitted to the General Manager by Management, or any resident, committee, or group of residents. The General Manager will transmit the request, with or without recommendations to the Rules Committee. The Committee will evaluate the request for need, appropriateness, and impact on existing rules. The Board may initiate requests directly to the Rules Committee for rule additions, deletions or changes. The Committee will present its recommended rule changes at a Board of Directors meeting.

The Board shall provide written notice of a proposed rule change to the members/residents at least 30 21 days before making the rule change. The notice shall include the text of the proposed rule change, a description of the purpose and effect of the proposed rule change and a request for member/resident comment on the proposed change. Notice is not required under this paragraph if the Board determines that an immediate rule change is necessary to address an emergency, such as an imminent threat to public health or safety or imminent risk of substantial economic loss to the Club (See Emergency Process below.)

Delivery of the above notice may be made to the rule change requester and members/residents by one or more of the following methods: Personal delivery, mail, a periodical such as The Villager, an information TV channel or as recorded in our governing documents. Email or fax may be used only if the recipient has agreed. Included in the notice will be an announcement of the date and time of a meeting, at which the Board will consider the proposal along with oral and written comments from residents. Response to the proposed rule change may be made by one or more of the following methods:

- A. Participation in the discussion of the change at the Club Board of Directors Board meeting at which the proposed rule change will be considered
- B. Via email with comments sent to the General Manager's office at least seven (7) days prior to the Club Board of Directors Board meeting
- C. Via written comments to the General Manager's offices delivered at least seven (7) days prior to the Club Board of Directors Board meeting

2. Emergency Process

If the Board determines that an immediate Rule change is required to address an imminent threat to public health or safety or an imminent risk of substantial financial loss to the Club, it may make an emergency rule change. No previous notice is required.

3. Trial Period

A trial period of no longer than six (6) months may be used to test a proposed rule change prior to the Board approving a permanent change. The Board will assign responsibility for evaluating the proposed rule and define the evaluation criteria. The proposed rule change and its trial period must be published in The

Villager for two (2) consecutive weeks before the trial period may begin. During the trial period, enforcement will be the same as for permanent rules. After completion of the trial period, the Board may (a) propose the rule (with or without) changes for publication and $30 \, 21$ -day notification, (b) conduct a public hearing, (c) extend the trial period, or (d) reject the change.

Rule 1.30 The Pulse and The Villager

The purpose of the revision to Rule 1.30 is to bring the content of the rule current. Since the writing of Rule 1.30, The Villages has:

- launched the Member Portal and The Villager Online
- · clarified the process of rejection
- formalized the Pulse submission parameters
- hired a Communications AGM to make appropriate edits to existing content

1. The Pulse

A Villages "Pulse" letter serves as a vehicle for residents and non-resident owners to express opinions, or and to make suggestions or comments.

Pulse letters submission can be done through the Member Portal, The Villager Online submission form, email to the Managing Editor, or mail addressed to the may be submitted online via the Resident's Portal or emailed to the editor of The Villager, deposited in the Communications Advisory Committee mailbox in Building B or mailed to The Communications Advisory Committee (CAC), at 5000 Cribari Lane, San Jose CA 95135, or personally delivered to Building B. . To submit letters, follow the guidelines in the Pulse column published weekly in *The Villager print edition and The Villager Online*.

The Communications Advisory Committee CAC will review letters submitted for publication subject to the following:

A. Each letter must include the sender's name, address, phone number, date, and a word count of no more than 200 words. The word count should be furnished by the author in the letter.

- B. Each letter will deal with only one specific topic related to life in The Villages.
- C. Each letter will be reviewed for proper content. The Committee will reject etters containing:
- 1) Statements that cannot be substantiated by the submitter of the letter if <u>CAC or Publisher questions</u> the veracity of the statements<u>.</u> is questioned by the committee.
- 2) Language insulting to individuals or to groups. Insulting language can take several forms from profanity, to name calling, humiliation, and disrespect to even concealed contempt, to inadvertent indifference or disregard. Insulting language or phraseology is most likely to appear in letters where the writers are angry or complaining. Letters should stick to facts and opinions and avoid personal attacks.
- 3) Political opinions or endorsements pertaining to any candidate election in The Villages.
- 4) Partisan political opinions or endorsements pertaining to any election or ballot measure external to The Villages.
- 5) Recommendation or criticism of any product or service other than from clubs and organizations within The Villages.
- 6) Language that discriminates with regard to race, religion, ethnicity, gender, or sexual orientation, which may be deemed offensive.
 - 7) Any website link.
- 8) Any personal name or contact information included in the published letter, e.g., phone number, address, email.
- D. Only one Pulse letter per calendar month, per person is allowed. An author may not queue letters for publication.
- E. Pulse letters are reviewed using the following process:
- 1) Each pulse letter shall be reviewed by two members of the CAC, reviewing the letter together using the criteria stated above.
- 2) An author who is also a CAC member may not review their own letter. In which case, an alternate CAC reviewer will review the letter.
- 3) Pulse letter reviewers who reject letters will inform the author of the reason(s) for rejection and work with the author to revise the letter.
 - 4) Pulse letter reviewers may recommend a Publisher's Comment.
- 5) If a letter is accepted by the CAC reviewers, but rejected by the Publisher, then the Publisher must inform the CAC Chair and the CBOD liaison of the decision and the reason(s) for rejection. The Publisher, CAC Chair, and the CBOD liaison will then work together to resolve the Publisher's reason(s) for rejection, involving the author and original CAC reviewers if necessary.

<u>F.</u> The Publisher may add a Publisher's Comment to a letter, but such Publisher's Comment must be reviewed and approved by the CAC CBOD Liaison.

F. G. A Pulse letter will always be published in The Villager online but will only be included in the printed version if submitted within the appropriate time frame. *The Villager Online* will archive the Pulse letter after one (1) week of its initial online publication.

2. The Villager

The Villager is a newspaper, published weekly online, and in print every first (1st) and third (3rd) weeks of every month, is published by the Club Board for Villages members residents. It has been designated by each Board as the authorized means of providing legal notice to residents and owners of record. The General Manager is the Publisher. The Board of Directors authorize The Villager editors are authorized by the Board of Directors to exercise editorial judgment using the following guidelines:

A. No copy or advertisement will be accepted from any source that expresses partisan political opinions or endorsements pertaining to any election or ballot measure external to The Villages.

- B. No copy will be accepted that:
- 1) Is tactless or of questionable taste
- 2) May be injurious to personal reputations
- 3) Contains the intent to ridicule or shame a person
- 4) Expresses partisan political opinions or endorsements
- 5) Promotes religious or ethnic bias, plagiarizes which includes using Artificial Intelligence (AI) content to generate a significant portion of an article - or uses language that discriminates with regard to race, religion, ethnicity, gender, or sexual orientation that may be deemed offensive.
- 6) Plagiarizes
- 7) Uses language that discriminates with regard to race, religion, ethnicity, gender, or sexual orientation that may be deemed offensive.
- C. Advertising of patent medicine, medical "cure-all" or any other medical articles will not be permitted.
- D. Political advertising and/or endorsements will not be accepted. Candidates for Boards of Directors may advertise as permitted by Club Policy CPo 112.
- E. Advertisements for the sale, lease, or rental of Villages property will be ac-
- F. Advertisements for the sale, lease, or rental of real property outside The Villages will not be accepted from non-residents, except for retirement homes, life-care facilities, etc. However, a resident member owners are allowed to may advertise any property they own owned outside The Villages property.
- G. A resident's death may be published under the heading "In Memoriam." It will be limited to the resident's name, date of birth, and date of death. A memorial service held in The Villages, open to all residents, may announce the place, date, and time of service. Paid obituaries or death notices are allowed in The Villager. A family member, executor, or a designated resident may provide such information.
- H. Contributing writers providing editorial copy on behalf of their designated organizations, committee, or board are to include only information in reference to the organization's activities, membership, and events.
- I. Articles may not promote expenditure of Villages funds without stating such expenditures have not been approved by the relevant board if that is the case.

Rule 1.32 The Villages Website

· Launched the Member Portal and Member mobile app, which now allows members to post a profile image. This image has a specific purpose and guidelines for proper use.

This increased social media functionality is owned by the Club and is managed by the General Manager.

The purpose of socializing a Profile image is for Villagers to recognize members as they interact with other members within The Villages community. To this end, the Profile image selected and displayed in any Villages Golf and Country Club-managed technology software such as , websites, portals, and apps will:

- Be a current photo of member
- Represent a pleasant state, will not be offensive
- Be recognizable as the member identified with the Profile account
- Be properly clothed, if other than a facial photo is selected

Response to the proposed policy changes may be made by one or more of the following methods: 1) Participation in the discussion of the changes at the March 25, 2025, board meeting, 2) via e-mail (jmeadows@the-villages.com) with comments sent to the General Manager's office at least seven days prior to the board meeting, or 3) via written comments to the General Manager's office (Business Administration Building A) delivered at least seven days prior to the aforementioned board meeting.

CPo 204 Rules Committee:

A Celebration of Life is being arranged with details to follow.



GOVERNING DOCUMENTS / LEGAL REQUIREMENTS: None.

Committee: Ceommunications Aadvisory Ceommittee

Responsible to: Club Board of Directors

<u>Composition:</u> Voting Members: Five to seven (5-7) resident owners in good standing appointed by the Board of Directors.

Non-Voting Members: The number of associate members shall be determined by the committee with the approval of the Board. Associate members can actively participate in committee discussions but do not have a vote.

Board Liaison (non-voting)

<u>Staff Support:</u> Community Activities Director, <u>Eex-officio</u> member <u>- Senior</u> <u>Staff member assigned by the General Manager</u>

Editor, The Villager, ex-officio member

Member Term: Two-year staggered terms by Board appointment, from January 1 through December 31. There must be a one year break in service after two consecutive terms before reappointment. A vacancy prior to completion of a term will be filled by appointment by the Board for the remainder of the vacant term.

Officers: The committee shall elect a chairperson from one of its own voting members.

<u>Subcommittees:</u> The committee may appoint subcommittees, as it deems necessary to perform its appointed tasks.

Meetings: The committee shall meet at least quarterly or as required to fulfill its responsibilities.

Responsibilities:

- 1. The committee shall review "Pulse Letters" submitted by members and residents for publication in *The Villager*, to ensure conformity with the publication requirements set forth in VGCC Rule 1.30 The Villager and the Pulse.
- 2. The committee shall advise the Club Board on all aspects of content, format, editing, and publishing for each of the Community's internal communication

media (e.g., *The Villager*, <u>The Villager Online</u>, the cable channels, the Website and Fast<u>News</u> <u>Lane</u>) with the objective of promoting open, accurate, and timely reporting of community information, events, and news to the members, residents, and visitors.

- 3. The Committee shall advise the Club Board of ways to use the Community's communications media to engage residents in discussions of important and timely issues that affect community life.
- 4. The committee may provide advice and recommendations to the Club Board regarding special interest or controversial topics to the readership.
- 5. The committee shall provide the Club Board written minutes for all committee meetings.
- 6. Associate Members must review Pulse Letters in the company of an experienced Committee Member until trained, and shall participate in Committee Meetings, but will have no vote.
- 7. Candidates' Night: The committee will be responsible for one or more Candidate's Night(s). The process of the Candidate's Night(s) will be the responsibility of the Committee who will function independently of the Board.
- 8. Candidates' Questions in Villager. The committee will be responsible for the Candidate's Questions in the Villager. The committee will prepare questions for the candidates, and will function independently of the Board.
