Second Circuit Highlights

Who's watching the dogs? In September 2023, Gray was walking on Pine Street in Ringgold when he was attacked and mauled by a pack

of unrestrained dogs. Before the owner could pull them off, Gray sustained some 130 bites; he was airlifted to LSU Health Center in Shreveport and underwent five surgeries to save his life and limbs. A few weeks later, in October 2023, Brooks was walking down the same street when he was attacked and mauled by a pack of (presumably the same) unrestrained dogs. Brooks was not as fortunate as Gray, however; his survivors discreetly argued only that "his remains were found."

Gray and Brooks's survivors, separately, sued the owners of the dogs, the owners of the house where the attacks occurred, the Town of Ringgold, the sheriff of Bienville Parish and the Bienville Parish Police Jury. The liability of the Police Jury was premised on special statutes: La. R.S. 3:2731 said the parish *may* adopt ordinances regulating dogs running at large; R.S. 3:2773 said a citizen may, or the sheriff, constable or other police officers *shall*, seize any dog running loose; and R.S. 3:2774 said each parish *shall provide* shelters or facilities for dogs so seized; the Police Jury had provided no suitable shelter for such dogs; hence, it was in breach of the statutory duty.

The Police Jury filed exceptions of no cause of action asserting the immunity of R.S. 9:2798.1, arguing the establishment of a dog pound was discretionary and came into existence only when (and if) the parish actually seized any dogs; since none had been seized, there was no duty to establish a dog pound. The district court agreed, sustained the exceptions and dismissed the Police Jury from both suits. The plaintiffs appealed.

The Second Circuit reversed both cases and remanded, *Gray v. Town of Ringgold*, 56,515 (La. App. 2 Cir. 10/1/25), an opinion by Judge Stone, and *Brooks v. Bienville Parish Police Jury*, 56,519 (La. App. 2 Cir. 10/1/25), an opinion by Judge Stephens. The *Gray* opinion branded the Police Jury's approach of "waiting for dogs to be seized to *then* erect a shelter" as absurd; the statutes required a more proactive approach. The *Brooks* opinion added that it was "illogical that the legislature would impose a mandatory duty upon the parish to provide a shelter but only intend for that duty to engage once a seizure occurs." The cases were remanded for

further proceedings.

To be sure, the denial of an exception of no cause does not mean that the police jury will be found liable; further litigation, or perhaps settlement talks, are needed. However, these cases hold that, under R.S. 3:2774, each parish, even small ones, must provide a suitable shelter or facility for dogs seized while running loose, even if no dogs have yet been seized.

It's not exclusive, but it's not permanent either. In the past two years, the Second Circuit has fielded several cases that pitted an earlier "permanent easement agreement" against a later "pipeline servitude and right of way agreement." ETC Tiger Pipeline, the holder of the earlier agreement, usually sought to enjoin La. Energy Gateway, the holder of the later agreement, from installing natural gas pipelines under the property burdened by the earlier agreement. Because the earlier agreement used, in one place, the word "exclusive," courts in DeSoto and Caddo Parish granted the injunctions. Gateway appealed and got the preliminary injunctions dissolved. ETC Tiger Pipeline LLC v. DT Midstream Inc., 55,534 (La. App. 2 Cir. 4/10/24), 384 So. 3d 458, writ denied, 24-00763 (La. 10/8/24), 394 So. 3d 271, and three subsequent cases.

In the latest iteration of this ongoing dispute, an ETC company filed for declaratory judgment and Gateway moved for an injunction. By this time, however, the district court had the benefit of the Second Circuit's cases and granted Gateway's motion, issuing a permanent injunction. ETC appealed.

The Second Circuit reversed in part, *ETC Texas Pipeline Ltd. v. La. Energy Gateway LLC*, 56,493 (La. App. 2 Cir. 10/1/25), in an opinion by Judge Thompson. The court confirmed its earlier jurisprudence but noted that, in this case, the district court granted a *permanent injunction*, which was simply not warranted without a trial on the merits and a showing of irreparable injury, loss or damage, as required by La. C.C.P. art. 3601 A. On the evidence introduced, the permanent injunction would create a "likely insurmountable obstacle" to ETC maintaining its existing lines. The case was remanded without special instructions.

The opinion noted that "potholing" is expressly authorized by statute but suggested that other operations may proceed on a showing of safe clearance, support for underground facilities, and evidence that existing lines

would not be damaged, under La. R.S. 40:1739.13. In other words, there is still plenty of room for litigation.

Self-representation, expanded. In June, I wrote about *ELA Group Inc. v. Bradley Murchison Kelly & Shea LLC*, 56,227 (La. App. 2 Cir. 4/9/25), 409 So. 3d 1046. ELA, a construction corporation, sued its former law firm for malpractice. Rather than hiring new counsel, the president, Mr. Angel, who is not a lawyer, signed the petition and filed it himself in the First JDC. The defendant filed an exception of unauthorized practice of law, which the court sustained, even though by that time ELA had enrolled counsel. The Second Circuit affirmed, citing the "well settled law" that "prohibits nonlawyers from filing pleadings in a representative way." ELA took a writ.

The Supreme Court reversed and remanded, *ELA Group Inc. v. Bradley Murchison Kelly & Shea LLC*, 25-00526 (La. 10/14/25). Its brief (two-page) per curiam recognized prior jurisprudence vacating any filing by a corporate officer instead of an attorney, but drew on its "plenary power" to regulate the practice of law, La. Const. art. V, § 5(B). It found that the special statute defining the practice of law, La. R.S. 37:212 B, is not limited to natural persons. It then concluded that when "a corporate officer or managing member of a limited liability company files an action on behalf of that juridical entity solely to prevent the occurrence of the legal consequence of non-filing, such as prescription, peremption, or default, that filing shall not be found to have no legal effect." The court added that, when this happens, the entity "should promptly enroll counsel of record before taking any additional legal actions concerning the case." Chief Justice Weimer, joined by Justice Griffin, concurred, saying the court should grant to docket to "more thoroughly evaluate" the issue. However, Justice Crain, joined by Justice McCallum, concurred, saying they would "find a corporation may appear as a *pro se* litigant through an authorized officer or representative." Only Justice Guidry dissented, saying he would grant to docket.

The Second Circuit had noted that Mr. Angel filed his suit on behalf of ELA a mere two days after he settled the underlying case (the one that gave rise to the claim of legal malpractice), so it's not apparent that pro se filing was necessary to prevent the tolling of prescription or peremption or the taking of a default. However, the Supreme Court's opinion gives some liberty to small businesspeople to act quickly on behalf of their corporation or LLC.

This annual event holds great importance to the Court, as well as to the families and friends of the departed, the members of the Bench, the Bar, and our community.















SHREVEPORT NATIVE DONOVAN STONE REFLECTS ON CLERKSHIP AT U.S. SUPREME COURT

Shreveport's own Donovan Stone recently completed a judicial clerkship for Associate Justice Ketanji Brown Jackson of the U.S. Supreme Court. His tenure was for the October Term 2024. Back in town in late October 2025, he reflected on his journey to the high court.

Donovan is a graduate of Caddo Magnet (2013), Centenary College (BA, Hist & Poli Sci 2017), and Duke University School of Law, in Durham, North Carolina (JD 2020). At Duke, he excelled academically, serving as online editor of the *Duke Law Journal*, on the Moot Court Board and winning an award for a contribution to the inaugural edition of the *North Carolina Civil Rights Law Review*. During his 3L year at Duke, he took a seminar taught by Associate Justice Samuel Alito, thinking this would likely be his last experience with the Supreme Court.

After graduation – Duke's only "virtual" convocation, owing to COVID lockdowns – Donovan took a clerkship with U.S. District Judge Abdul Kallon (N.D. Alabama), followed by one with Judge Carl E. Stewart, of the U.S. Fifth Circuit, here in Shreveport. He then took a post as a litigation associate at Williams & Connolly, in Washington DC. All the while, faculty members from Duke encouraged him to pursue the Jackson clerkship. "I was never more excited to receive a phone call than when I got the interview," he said. Getting the job, he added, was "a dream come true."

Donovan strongly credits his family for his ambition and accomplishments. His uncle, Jesse Stone Jr., was one of the first Black lawyers in Shreveport and, later, Dean of Southern University Law Center and president of Southern University System; his "aunt," or second cousin, is Judge Shonda Stone, currently serving on the La. Second Circuit Court of Appeal. Referring to Judge Stone, Donovan told me, "We are very close, grew up together, shared a backyard."

Donovan said each Justice has four law clerks. He was careful not to betray any judicial confidences, but summarized his work with the Supremes as having three components: helping the Justice decide which cert applications should be granted, involving reviewing the applications and writing memos; working on the merits cases; and handling the emergency matters. "Please don't get the impression that the law clerks control the work," he added modestly. He emphatically wanted everyone to know that the Justice makes the decisions!

Since his term with Justice Jackson ended, Donovan has taken a gap, spending some time in Shreveport but also taking his mother abroad, to Madrid and London, for her retirement from the Caddo Parish School Board. In early November he will start a new position, at Gibson, Dunn & Crutcher, at their Washington DC office.

I asked Donovan if he entertained any notion of coming back to Shreveport to practice. "I'm definitely open to that," he said. "Who knows where life will take me?" However, with his credentials and résumé he's able to pursue great options in DC. He is sure to find success and satisfaction in the high-octane practice, but he will always be welcome in his hometown.




