FEDERAL INVESTIGATION INTO LENNON LACY HANGING CASE CLOSED

Federal investigators have closed their investigation of the hanging death of Lennon Lacy because they have been unable to find any evidence that would help them prove before a jury that a federal hate crime had been committed. Lacy was found hanging from a swing set in the middle of a Bladenboro, N. C. trailer park in 2014.

The case prompted concerns that the 17 year old African American high school football linebacker's death was a homicide by hanging. Additionally, the trailer park where Lacy's body was found was almost exclusively occupied by White residents.

The U.S. Justice Department has informed two

NC NAACP lawyers and Lennon Lacy's mother, Ms. Claudia Lacy, this week that the investigation has been closed. During the meeting the federal officials explained the steps their investigators had taken to ensure that they had done a thorough investigation. They shared with the Lacy family and their attorneys dozens of photographs of the death scene which showed physical evidence consistent with the North Carolina Medical Examiner's determination that the probable cause of death was suicide. Although the federal representatives were unable to answer all of the family's lingering questions about some evidence, Ms. Lacy and NC NAACP lawyers were satisfied that the federal authorities had tried to conduct a

Federal Appellate Court questions 2013 Voter ID law

While a federal judge in Winston-Salem last April decided that that there was nothing about North Carolina's 2013 voter ID law that should keep African-Americans or others from lawfully casting their ballots, a three-judge federal panel Tuesday wasn't so sure.

Based on remarks and questions coming from that panel of the US Fourth Circuit of Appeals, attorneys for the NCNAACP "...feel very good about our case and the evidence which we presented," attorney Irving Joyner, chairman of the NC NAACP's Legal Redress Committee says. "We clearly hope that the Fourth Circuit will reverse the District Court's [April 25th] decision.... From there, it is on to the [US] Supreme Court, no matter what the outcome is."

Attorneys for the state claim that the 2013 voting restrictions were necessary to stop voting fraud.

The NC NAACP and other plaintiffs appealed to the US Fourth Circuit to fast-track a stay of a federal judge's April 25th ruling dismissing their lawsuit against Gov. Pat McCrory and the Republican-led NC General Assembly for their passage of the 2013 voter ID law until all other appeals have been exhausted. The original suit charged that the 2013 law violated the constitutional rights of black voters. The appeal sought to "...keep in place this Court's prior injunction forbidding Defendants from eliminating same-day registration and refusing to count out-of-

Diversity remains elusive in U.S. churches

(TriceEdneyWire.com) - Churches in the United States remain bastions of segregation decades after the Civil Rights Movement produced legal barriers to the practice.

In 1963, the Rev. Dr. Martin Luther King Jr. said, "It is appalling that the most segregated hour of Christian America is 11 o'clock on Sunday morning" and, according to experts, that assertion remains true today. About eight-in-ten American congregants still attend services at a place where a single racial or ethnic group

comprises at least 80 percent of the congregation, according to findings from the most recent (2012) National Congregations Study, as cited by the Pew Research Center.

And a new study from Baylor University has found that churches that attempt to create more racially diverse congregations find themselves with scantier pews. Researchers based their findings on analysis of data from more than 11,000 congregations in the Evangelical Lutheran Church in America (ELCA) from 1993-2012, as well as data from the U.S. Census Bureau.

They found that while diversity doubled in the two-decade period, membership declined by 22 percent. "Racial diversity itself is not a detriment to growth," said lead author

have now released a new report, showing the adverse impact of the Shelby case.

"This is really an important report. It is an effort to identify problems that have already arisen," said Wade Henderson, president and CEO of The Leadership Conference on Civil and Human Rights and The Leadership Conference Education Fund. "We're witnessing a virtual renaissance of voter restrictions. If they persist, they could have a very serious effect on the upcoming elections. It is an insidious and sophisticated way to shave off a few points in key races. It is a particular problem to minorities...It is a concern of national importance, one that Congress should pay particular attention to."

The high court ruling against the federal government in the Holder v Shelby case in 2013 was followed closely by several primarily southern states, enacting a series of draconian laws that have made it increasingly more difficult for African-Americans, Latinos, students and the elderly to cast their ballots. The Republican legislators supporting these bills claim that the measures are an effort to block voter fraud. Their critics contend that the laws are a way to disenfranchise voters who are more likely to vote Democratic.

But, a national coalition of voters, advocacy groups and voting rights activists as well as in the Department of Justice, have been fighting back in the courts, state-houses and city council chambers. These advocates

It finds that, since Shelby, the states of North Carolina, Arizona, Florida, Georgia, and Virginia - once under the Section 5 preclearance mandate - have engaged in deceptive and sophisticated practices to disenfranchise voters that will have an impact on the 2016 election.

These states are locations of competitive 2016 contests that will have 84 Electoral College votes, two Senate seats, and one governor's seat up for grabs.

"As we approach the first presidential election in 50 years without the full protections of the Voting Rights Act, we're seeing the perfect

storm of a diversifying electorate and a set of states and localities responding by implementing a broad array of voter discrimination tactics," said Scott Simpson, the report's co-author and director of Media and Campaigns

racial composition of a congregation that causes difficulties."

The study, "Congregational Diversity and Attendance in a Mainline Protestant Denomination" tests the belief that homogenous con-

gregations are more likely to grow, the researchers said. "That philosophy for a long time discouraged church leaders from striving for diversity," said study co-author Gerardo Marti, associate professor of sociology at Davidson College. "But in coming to terms with the historic racial segregation of

American congregations, white pastors in the 1990s aggressively committed to overcoming discrimination, urging members to bring in those from ancestral backgrounds and reaffirm the Gospel as rooted in relationships, unity and love. Racial diversity has become a central, and sometimes dominat-

ing, ambition for many White churches."

Despite those ambitions, the researchers concluded that churches that start off as multiracial are more likely to be successful at increasing diversity in a denomination. "We conclude that new congregations started as multiracial represent the

best opportunity for diversifying a denomination," Dougherty said. "It may be that nondenominational congregations may be more adaptable, since they do not have a denominational heritage to sustain."

The report was published in the *Journal for the Scientific Study of Religion*.

precinct provisional ballots" in addition to keeping in place the portion of the law that reduced the early voting period by a week.

The voter photo identification requirement began in earnest during the March 15th primary. Unless the federal appellate court rules otherwise, the voter ID provision

will be in force for the Nov. 8th general election as well.

Based on the evidence presented, members of the three-judge panel openly questioned the timing of the Legislature passing the 2013 voter ID law, with one judge, Henry F. Floyd, saying that the intent to suppress the votes of people of color "...looks pretty bad to me."

Another Appellate Court judge, James A. Wynn, questioned why certain type of

government-issued photo identification, like public university or public assistance ID cards, was disallowed. Judge Wynn once served on the NC Court of Appeals.

There was no word on when the three-judge panel would issue its decision, even though it could, per the petition of the NC NAACP, the League of Women Voters and other plaintiffs, order that the voter photo ID require-

ment not be implemented for the November 8th general election.

"...Plaintiffs believe they have a likelihood of success on the merits on this claim and that voters will be irreparably harmed if the photo ID requirement is in effect in the November 2016 presidential election," the appeal reads. "Plaintiffs believe that if and when they prevail on the photo ID claim, implementation of the

Court's order will be straightforward and simple: the requirement will simply fall away and voters will no longer be asked to show photo ID at the polls in order to vote."

However, as atty. Joyner noted, there's little doubt that attorneys for Gov. McCrory and the Legislature would appeal such a ruling to the US Supreme Court, seeking an injunction to halt any disruption of the 2013 law.

thorough investigation.

There continues to be an outcry in social media from Lacy's family and friends, as well as Black activists, denouncing the federal investigation as yet another coverup. One such post by Durham resident, H. F. Watts, cited, "This is disgraceful! No investigation was conducted. It was physically and mathematically impossible for suicide to happen with a 200 pound man and a short dog leashed."

The NC NAACP brought in an independent pathologist, who found discrepancies in the evidence that cast doubt on the official finding of suicide and identified physical reasons that suggested it would have been almost impossible for the

teenager to have hanged himself from the swing set. Those conclusions conflicted with the official autopsy report, which stated that Lacy had been depressed from the recent death of a beloved uncle and concluded that the 17 year old had died from "asphyxia secondary to hanging."

Also there remains concern by the Lacy family and local Bladenboro residents over a new pair of Jordan tennis shoes that Lacy had purchased that were missing from the death scene, while a pair of white sneakers which nobody recognized was found on his body.

Then there's the relationship with an older White woman, Michelle Brimhall, who has continuously stated that she is convinced Lacy did not take his own life. Ms. Brimhall, however, has retracted her opinion that there had been no hostility toward Lacy and her as a mixed-race couple. She has since indicated in news reports that she and Lacy had been targeted by White racists who told her they disapproved of interracial relationships.

The Bladen County District Attorney, Jon David, has stated, "Some have suggested that the quality of the initial law enforcement investigation was lackluster. In my analysis, this is simply untrue." Attorney David's office also has decided to close active investigation of the Lacy death.

The NC NAACP and Ms. Lacy have always said that we can take the truth and that it will set us free. Ms. Lacy and the NC NAACP will

take some time to digest the news before announcing their next steps in this case.

The statute of limitations on a homicide is open.

Federal officials would consider reopening the investigation if new evidence is discovered that would warrant additional investigation.

DURHAM CIVIL RIGHTS LEADER ANN ATWATER, 80, DIES

[DURHAM] A black woman who befriended a KKK leader during the height of racial tension in Durham during the 1970s has died. Ann Atwater, 80, is best known for becoming friends with KKK leader C. P. Ellis during ten days of workshops designed to bring people together during Durham school desegregation. Ellis ripped up his KKK membership card on the last day of the meetings, saying he couldn't hate black people anymore. Ms. Atwater spoke at Ellis' funeral in 2005. A film

ECSU PLACED ON WARNING BY ACCREDITING AGENCY

[ELIZABETH CITY] The accrediting agency of Elizabeth City State University has placed the historically black university on warning. The Southern Association of Colleges and Schools Commission on Colleges warned the school after a UNC internal audit revealed that ECSU erroneously awarded financial aid and admitted unqualified students to the school. ECSU officials say they are aware of the problems, and are on course to take corrective measures by December 15 of this year.

CLINTON CAMPAIGNS AT NC FAIRGROUNDS

[RALEIGH] Democratic presumptive presidential nominee Hillary Clinton came to Raleigh on Wednesday in her bid to outdistance presumptive Republican nominee Donald Trump in their race for the White House. The former US Secretary of State is trailing Trump in North Carolina polls 43 to 41 percent. North Carolina is seen as a "purple" battleground state that can go either Democrat or Republican during this November's general election.

NC WATER QUALITY IN JEOPARDY WITH LIFTING OF REGULATIONS

[CHARLOTTE] Agriculture is big business in North

Carolina, and while the farms across the state add to the economy and resources, the waste generated in the form of animal waste and fertilizer runoff has the potential to impact the state's water quality.

For the past 20 years, regulations have been put in place to stabilize the impact, but this month the state Senate passed a plan to eliminate many water quality protections currently in place.

Supporters say the rules should be removed because they haven't succeeded in solving the problem of excess nutrients.

But Tom Bean, a lobbyist for the North Carolina Wildlife Federation, says that's faulty logic.

"It's the opposite of what we need to be doing," he main-

tains. "That would be like a diabetic, after 15 or 20 years of controlling his diabetes with insulin, decided it hadn't cured him of diabetes so he's going to stop using them."

The current regulations were put in place following a massive fish kill in 1995 on the Neuse River, after an algae bloom reduced the oxygen in the water to dangerous levels.

The proposed elimination of rules was added to the Senate's budget and would eliminate vegetated buffers along rivers and water quality requirements on impaired waterways such as the Neuse, Tar-Pamlico River Basin, and Catawba River, among others.

Bean calls the current regulations common sense and adds they have been at least maintaining water quality

and preventing it from getting worse.

"To do something as irresponsible as to remove regulations that are working is just asking to create a problem, which ultimately will have to be addressed," he stresses. "Cleanup is always more expensive. Get in contact with legislators and tell them that they oppose lifting the regulations that are in place."

The provision also would delay rules protecting Jordan and Falls lakes, which supply drinking water for more than 700,000 people in the Triangle and provide the opportunity for many thousands of hours of outdoor recreation for swimmers, boaters and fishermen.

for The Leadership Conference on Civil and Human Rights and The Leadership Conference Education Fund. "In 2016, it is entirely possible that the presidency, control of the Senate, and a number of governorships could be determined by the voter discrimination made possible by Shelby."

Simpson added, "Changes are happening in the dark of night. There's no public notice, no transparency ... This report looks at the intersection of states in competitive races. In those five states they're using every tactic in the books. Those engaged in this tend to be Republicans. A lot of it is happening out of fear. Generally, it is happening with city councils, local elections, and school boards. They are afraid that Blacks will gain control and continue to exert influence in these five states. For everything we've found, this is just a fraction of what's actually happening."

When announcing the Shelby ruling, Chief Justice John Roberts left it to Congress to reauthorize the VRA. To date, that has not happened.

Meanwhile, states and locations once protected by the VRA, have remained rogue, according to the report.

For example, the day after the Shelby decision, the speaker of the North Carolina House introduced H.B. 589, one of the most restrictive pieces of election legislation in the country, which came to be known by local advocates as the "monster bill." The bill included a strict ID requirement as well as a range of additional voting restrictions, including significantly shortening the early voting period; eliminating same-day registration; prohibiting the counting of out-of-precinct provisional ballots; eliminating a pre-registration program for 16- and 17-year olds; and mak-

ing challenging voters easier.

"What we are seeing in North Carolina is that more people are being disenfranchised than the margin that decided our recent governor's election and other recent elections in our state," said Anita Earls, executive director of the Southern Coalition for Social Justice, which has played a key role in fighting voter suppression in North Carolina. "These voter suppression measures passed in the wake of Shelby - like ending same day registration, ending out-of-precinct voting, and others - are truly having an impact on our ability to vote. We hope that these measures will not be in place in November 2016."

The report, a collaborative effort between The Leadership Conference Education Fund, the ACLU, the Advancement Project, Asian Americans Advancing Justice, the Brennan Center for Justice, the Lawyers' Committee for Civil Rights Under Law, the NAACP Legal Defense and Educational Fund, and the NALEO Educational Fund, warn that the restrictions are spreading.

Marion Warren, Registrar of Voters for the City of Sparta in Hancock County, Ga., said since 2015, voter rolls were purged, removing registered voters prior to two mayoral elections that removed registered voters.

Voting officials mailed out ballots late and have "refused to make registration voter-friendly," Warren said. "They have moved polling stations into police departments, closed six of 10 polling stations, and some people have to travel 35 miles to get to the polls. There has been an outcry from the public and I got the Department of Justice to look into that particular situation... It seems it's harder for a minority to vote now in the state of Georgia than it was in 1965."

In the battleground state of Arizona, tens of thousands of voters are believed to be disenfranchised after elections officials closed



Dealing with disrespect from Democrats and Republicans

After last week's column on how the major presidential candidates snubbed organizers of this year's National Black Political Convention in Gary, Ind., I received quite a few emails asking: What can we do about it?

For anyone who may have missed the column, I noted that in an ultimate show of disrespect, each major presidential candidate declined to appear before the National Black Political Convention in Gary, despite it being co-sponsored by the National Policy Alliance, a federation that includes 10 major Black organizations:

Blacks in Government (BIG), the Congressional Black Caucus, the Joint Center for Political and Economic Studies, the Judicial Council of the National Bar Association, the National Association of Black County Officials, the National Black Caucus of Local Elected Officials, the National Black Council of School Board Members, the National Black Caucus of State Legislators, the National Organization of Black County Officials and the World Conference of Mayors.

BIG represents 3 million Black government employees and the CBC says its members represent approximately 43 million people.

I pointed out that most Republicans wouldn't dare insult conservatives by failing to appear before the annual Conservative Political Action Conference and that neither Democrats nor Republicans would decline to show up for the American Israel Public Affairs Committee (AIPAC). Yet, they don't think twice before skipping a major gathering of African Americans.

And we continue to take it.

First, let's stipulate that standing on the sidelines is not the answer, regardless of how disappointed we may be at the behavior of Democrats and Republicans. Not voting is a vote - a vote against anything approaching a progressive agenda. With the direction of the U.S. Supreme Court hanging in the balance, that alone should motivate us to turn out this fall in record numbers.

Second, it's irresponsible to suggest that there is no difference between the behavior and voting records of Democrats and Republicans. I certainly can identify with the frustration of dealing with liberal condescension, but that shouldn't blind us to the outright hostility of Republican leaders. Picking the lesser of two evils still leaves us with evil, but not nearly as much evil were Republican policies adopted.

Exhibit A is the GOP record in Congress. When the NAACP graded members of Congress on issues important to African Americans, every Republican in the House and Senate received an "F." Not a D-minus. Not even a D-plus. Voting for them would be voting against our own self-interests.

It hasn't always been this way. Blacks voted Republican from the Reconstruction Era immediately after the Civil War until 1936 when Franklin D. Roosevelt received 71 percent of the African American vote in the most lopsided electoral victory in history. After Harry S Truman desegregated the military and the federal workforce, he received 77 percent of the Black vote in 1948. Even as late as 1960, Richard Nixon got 32 percent of the Black vote against John F Kennedy.

But the Republican Party grew increasingly anti-Black and no Republican president has received more than 15 percent of the Black vote since Lyndon B. Johnson signed the 1964 Civil Rights Act and the 1965 Voting Rights Act. In 2012, Mitt Romney received 6 per cent of the African American vote, according to Roper, and Donald J. Trump appears on track to receive less than that.

More than a half-century after passage of the 1965 Voting Rights Act, Blacks are still underrepresented in public office.

As a Joint Center for Political and Economic Studies report found, "Based on the most recent data, African Americans are 12.5% of the citizen voting age population, but they make up a smaller share of the U.S. House (10%), state legislatures (8.5%), city councils (5.7%), and the U.S. Senate (2%)."

And some of that failure rests squarely on our shoulders.

As the report noted, "...In 2014, when there was great unrest over a police officer's killing of Michael Brown, African Americans made up 67% of residents of Ferguson, Missouri. In 2012, a solid 100% of Ferguson precincts went for President Obama, but during Ferguson's municipal off-cycle elections voters selected Ferguson's Republican mayor and six city council members, all of whom except one were white."

But the problem is larger than that. Essentially, we provide the margin of victory for Democrats year after year and often get little or nothing in return.


So back to the original question: What can we do about it?

Since my days as a reporter for the St. Louis Post-Dispatch in the 1970s, I have advocated a simple and yet powerful step: Pick one local office, say comptroller or city treasurer, and vote Republican and Democrat in alternate elections. Because Blacks vote overwhelmingly in favor of Democrats, I would vote first for the Republican candidate. It wouldn't be long before both Democrats and Republicans fall over themselves courting Black voters. And if that fails to capture their attention, then move to a second city office or a statewide contest.

If this happens at the local level, national party leaders would take note and do everything without their power to avoid a shift of loyalty at the national level. Until we show that we will make politicians pay on Election Day, we will continue to get disrespected by both major parties.

After Orlando, drive out hate with light and love

Orlando now will be added to the haunting list: Newtown, Conn., Virginia Tech, San Bernardino, Calif., Charleston, S.C., Aurora, Colo. and more. USA Today provides

a graphic of 310 mass killings since 2006 (with four or more dead), the dots tracking across the nation. Mass killings still shock us. Somehow we've grown accustomed to the daily terror - in Chicago, nearly five times as many people have been shot and killed since the beginning of the year than the 49 that died in Orlando.

Orlando was, as President Obama said, "an act of terror and an act of hate." The grisly toll was also a product of the easy access to guns, particularly guns made for the military at war. The killer called 911 in the midst of his rampage to announce his allegiance to the Islamic State, but this came as a surprise to his friends and former wife. His father said that his son was outraged by the sight of gay

men kissing on the street, that he didn't think that religion "had anything to do with it." An act of terror and an act of hate.

The human reaction is to want to strike back. Escalate attacks on the Islamic State in Syria and Iraq. Redouble surveillance and crack down on Muslims at home. Donald Trump, the presumptive Republican nominee for president, went, characteristically, to the most extreme, calling on the president to resign and Hillary Clinton to withdraw because they didn't use the words "radical Islam," as if that were a magical chant that would set everything right. He raised alarms about "thousands" of radical Muslims in the United States, and reiterated his call for banning any Muslim immigration. Hillary Clinton was more tempered, while arguing that we had the capacity to eliminate lone wolf terrorists at home and the Islamic State abroad.

Dr. Martin Luther King, Jr. taught us a different lesson. Faced with the violence and terror unleashed against African-Americans in this country, he called on us to reach out, to love and not to hate. "Darkness," he wrote, "cannot drive out darkness; only light can do that. Hate

cannot drive out hate; only love can do that. Hate multiplies hate, violence multiplies violence, and toughness multiplies toughness in a descending spiral of destruction."

This wisdom should not be forgotten now. We would do better to reach out to Muslims in this nation and respect their religion and their rights, rather than to hunt them, to isolate them or to denigrate them. Muslim organizations across the country have issued statements condemning this act of terror. We should embrace them as part of the American community, engage them in the effort to identify the violent extremists, not treat all Muslims like a threatening stranger.

We would do better to reassess our strategy in the Middle East rather than double down on violence. We have displaced the Taliban in Afghanistan and killed Bin Laden; we've overthrown Saddam Hussein in Iraq and Moammar Gadhafi in Libya; we've decimated al-Qaida; our allies have carpet bombed Yemen; our drones bomb in seven countries. Yet the terror spreads, the violence spreads, the chaos spreads. More violence generates more terrorists. Redoubling our efforts can wipe out the Islamic State,

but it will surely add to the terrorist ranks at the same time.

Most mass shootings are not political; the victims most often are relatives or friends. Most casualties do not come from "radical Islamic terrorists." More Americans have been killed by homegrown terrorists motivated by racial or anti-government or anti-gay hatreds than have been killed by those motivated by Islamic extremism.

Gun control cannot end terror, neither the mass shootings like Orlando nor the daily horror as in Chicago. Omar Mateen, the killer in Orlando, was a security guard, apparently with a record clean enough that he was able to buy guns legally. But surely it is inconceivable that military assault weapons like the AR-15 semiautomatic rifle that he used (and that was also used in Aurora and Newtown and San Bernardino) should be so easily purchased. Reviving the ban on assault weapons that lapsed under President Bush is not a full remedy, but it is simple common sense.

HAPPY BIRTHDAY, MOM! - Just a quick shout out to my mom, Lillian, whose birthday it is today. Though she died in 2009, there's no reason to ever forget her. Happy Birthday, Mom!

BACK IN THE HOSPITAL - I'm back in the hospital this week, but no need to worry, I'm scheduled to be until Sunday. As I reported at the beginning

of this month, I've been diagnosed with acute myeloid leukemia (AML) since March, and have undergone chemotherapy since then. This week I'm undergoing my third round of chemo, which is necessary in order to ensure that there is no recurrence of the cancer cells that initially compromised my immune system.

I'm currently in remission now, meaning there are no cancer cells detected in my body. I'm scheduled to go through this week, spend three weeks home under outpatient care, then return for my last schedule week of chemo in the hospital a month from now, and then check in once every three months to make sure that my body stays in remission.

Sager was given the chance to work his very first NBA finals game last week on ABC-TV. Coach Hatchell has a best-selling book titled "Fight, Fight" about her personal struggles battling the disease. So it looks like I'm in excellent company.

My goal is to live my life normally come September. With GOD's help and blessing, I will.

pulling for the Golden State Warriors to defeat the Cleveland Cavaliers for the NBA Championship for a second year in a row, I did smile when I saw Cavalier Captain LeBron James relish the moment of winning championship for his hometown, and do so in dramatic fashion by coming back from a three games-to-one deficit - and LeBron and the boys worked hard for those victories to. So congratulations. Yes, I used to be sour grapes because I wanted LeBron to stay with Dwyane Wade in Miami. But, I guess I can settle for Kyrie Irving in Cleveland.

often said, is to allow your heart to go walking around outside your body.

In many ways, the essence of fatherhood is protection. As fathers, our most basic instinct is to protect our children. As children, our fathers are the ones we seek when we need protection. That responsibility weighs especially heavily for Black fathers in a time when divisive rhetoric seems out of control and the threat of violence looms heavily over our communities.

These fears are not unique to our generation, however. And because we cannot change the world to oblige our children, we must raise our children to navigate this world.

There are as many theories about raising strong, capable and well-adjusted children as

there are parents. "Tough love," "helicoptering," "free range" ... but one thing matters above all else - that children know they are loved. As the theme of a popular adoption campaign goes: You don't have to be perfect to be a perfect parent.

I was fortunate to have a father who is a hero and role model, not only for my brother and sisters and me, but for the city he served as mayor; judge, and civil rights trailblazer. It is his example I strive to follow a civil rights leader and - more importantly - as a father. But make no mistake, as fathers, do as much to shape the future by reading a bedtime story or helping with homework as we do testifying before Congress or presiding over a courtroom.

For the second year in a row, we celebrate Father's Day in

the wake of senseless tragedy as we mourn the 50 souls who were lost in the hateful mass shooting in Orlando. Last year, Father's Day was marred by the racially-inspired murders at Emanuel African Methodist Episcopal Church in Charleston, S.C.

It is our responsibility as fathers, as sons, and as brothers to rise up against the intolerance that fuels this violence, to quell the angry rhetoric that spurs it on, and to cut off the easy access to high-powered weaponry that enables it. As Pope Paul VI - Il Papa, the Holy Father, said, "If you want peace, work for justice."

Can Blacks prompt an 'Orlando' reaction?

In 1991, Latasha Harlins was shot in the back of her head and killed by Soon Ja Du, a Korean store owner in Los Angeles, who received a \$500 fine, sentenced to 400 hours of community service, and five years' probation by Judge Joyce Karlin, who ignored the penalty of 16 years in prison for voluntary manslaughter. Du received no prison time for her callous act of murder - execution style - of a 15-year-old Black girl, over a \$1.79 container of orange juice. This case and the outrage it brought foreshadowed the L.A. civil unrest now known as the Rodney King Riot in 1992.

Mindful of the Harlins' case, I think about the fact that here in 2016, Black lives really don't matter to some police officers, prosecutors, judges, and other Black folks. Preserving Latasha's life was not worth \$1.79, and to add insult to injury the person who killed her only had to pay a \$500.00 fine.

Since that time thousands of Black men, women, and children have been killed - 1,134 by police officers in 2015, according to The Guardian. In Chicago alone, there have been 1,454 shootings and 279 killed as of June 2016 - 207 of

whom were Black. So just who are we trying to convince that Black lives matter, other than politicians? And if Black lives matter, how much do they matter, how much are they worth?

We have recently seen millions of dollars being paid to victims' families, but it pales in comparison to the number of lives lost. Just the Black men and women killed by police, if divided into those millions of public dollars - tax dollars - the individual amounts would be embarrassing and insulting, just as in Latasha Harlins' case. But who cares? Right?

If members of any other group in this country were being killed at the same rate as Black folks are being killed, there would be a collective outrage and indignation such that the problem would be addressed, if not solved, almost immediately.

Moreover, on the economic side of things, just look at the Orlando shootings. Days after that tragedy \$4 million was raised for the victims - twice the previous GoFundMe crowd funding record of \$2 million - and all we hear in the news reports is advocacy for the "LGBT community."

When have we heard so much sympathy and advocacy for Black folks on those news shows? When have we raised significant amounts of money for Black victims? When have we seen LGBT news reporters take commercial breaks in order to shed tears for Black victims? If Tamir Rice didn't make that happen, nothing will.

Obama has some culpability in the Orlando massacre. What nonsense! Trump should be ashamed, if he is capable of such, for turning a tragedy into political manipulation. So should McCain.

McCain says he "mis-spoke," but what he really needs to do is apologize. He has no right to accuse President Obama of being "directly responsible" for the Orlando killings. He was wrong, simply wrong. His statement was not a slip of the lip, but a calculated attempt to disparage our President for partisan purposes. McCain has been a victim of Donald Trump's venom.

In the wake of a tragedy, our nation's leaders ought to follow our President's leadership in offering empathy. We ought also look at ways to prevent further tragedy. Banning assault weapons is one way to offer some solutions, and some Democrats have attempted to deal with that, despite resistance. Loose lips are inappropriate in the wake of this tragedy. Shame on you, Donald Trump and John McCain, for attempting to turn tragedy to your political advantage with your foolish words.

We must be just as willing to bring our causes to the forefront as gay people and other groups are. We should see red, black, and green colors everywhere when we are killed or aggrieved. No one else is

Inaction cannot be an option

his massacre is therefore a further reminder of how easy it is for someone to get their hands on a weapon that lets them shoot people in a school, or in a house of worship, or a movie theater, or in a nightclub. And we have to decide if that's the kind of country we want to be. And to actively do nothing is a decision as well." - President Barack Obama, June 12, 2016

Inaction is not an option. In the wake of the worst mass shooting in American history, we can and must do everything in our power to end this scourge of terror, hate and bullets that fly across our land killing and maiming and breaking hearts and traumatizing communities with ever increasing frequency. How can inaction continue to be an option in the face of senselessness and intolerance fueled by guns? We must act to save our country's soul and the lives of our people - all of our people.

The June 12 attack at the Pulse nightclub in Orlando was both our nation's worst act of terrorism since 9/11 and a hate crime. In that it was all too common: lesbian, gay, bisexual and transgender people are too likely targets of hate crimes in America. A large number of victims were gay people of color who were celebrating Latin Night in what many said they trusted and believed was a desperately needed "safe space." But as we have seen over and over again, America is running out of safe spaces. Not Pulse. Not Bible study at Mother Emanuel AME Church in Charleston, S.C. Not an office holiday party in San Bernardino, Calif. Not a movie theater in Aurora, Colorado. Not a dorm or university hall at Virginia Tech. And not a first grade classroom in Newtown, Conn., in a country where hate, bigotry, terrorism, and mental illness collide with unfettered access to these weapons of war that leave us with no hiding spaces unless we do something now.

Connecticut Senator Christopher Murphy couldn't face the families of the children of Sandy Hook unless he did something. The Senate filibuster he led in the aftermath of the Orlando slaughter lasted for more than 14 hours before there was bipartisan agreement to allow a vote on two common sense amendments that would make all of us and our nation safer. Creating a "No Buy List" so that the more than 800,000 people on our terror watch lists cannot legally buy guns in America should be an easy decision for all of us. Closing the loopholes in existing background checks to reach sales at gun shows and through the Internet to keep more criminals, would-be terrorists, and others from buying guns should be another easy decision. The evidence is clear that expanded background checks work.

A recent study found that a Connecticut law that expanded background checks on all handgun purchases helped achieve a 40 percent reduction in gun homicides during the first 10 years following the law's enactment. These measures the majority of Americans strongly support - and it's long past time that Congress followed the will of the people instead of the will of the National Rifle Association and gun manufacturers whose profits are soaked in the blood of our people.

The majority of Americans also support reinstating the ban on assault weapons and high capacity magazines that have been used time and time again. Why should it be perfectly legal to buy an AR-15 in a Five Guys parking lot in Vermont the day after the massacre at Pulse with no background check and no paperwork at all? Weapons designed for war are now as easy to buy as a loaf of bread.

Since 1963 more than 176,000 children have died from gun violence in America - over three times more than all the soldiers killed in action in the Vietnam War and every external conflict since. Our children have a right to grow up in a caring and decent society that protects their right to live and learn in safety. That right must take precedence over anyone's right to own assault weapons or high capacity magazines that have nothing to do with self-defense or hunting and have no place in the hands of non-military and non-law enforcement personnel. Without these weapons of war how many would be alive today? How many Newtown or Aurora or Orlando victims would have survived?

Our children are afraid for their friends, their families, and themselves. And this needs to change. We all need to stand up until we are heard and laws are changed. Contact your Senators right now to urge them to support these common sense safety solutions all of us so desperately need. Please act now.

Today's farms

Living on a farm was hard work and there were times when we did not all day. Sometimes, it would be decided that the day was better for fishing than for farming. Farming was a year round job. Getting out of bed and making necessary preparations for a good breakfast and feeding the farm animals and pets was a task one was not likely to forget.

Then it was time to get a hoe for the tobacco and corn fields. The hoe is an implement with a thin flat blade on a long wooden handle. It is used for weeding or loosening the soil around plants. Weeding plants was very

important because the weeds could grow tall and cover the vegetable plants. This could happen in cotton, peanut, corn fields, etc. Once the plants started growing in the rich earth, one was able to appreciate great growth.

On the farm today, technology and the application of science are especially useful in the industrial or commercial objectives of farming. This involves the entire body of methods and materials used to achieve such objectives.

On Mt. Pisgah Road in Supply, N. C., many acres of tobacco still grow. There are still cigarette factories in some states. They manufacture cigarettes from the growth of such tobacco. 



One year after Charleston massacre: Root causes of extremist violence remain unaddressed

(TriceEdneyWire.com) - A year ago on June 17, a young White supremacist gunned down nine Black parishioners at a historic church in Charleston, S.C., marking the violent start to a lethal year of extremist violence in the United States.

In San Bernardino, Calif., in the coming months, Islamist radicals would kill 14 people.

In Colorado Springs, Colo., an anti-abortion extremist would shoot three people to death at a Planned Parenthood clinic.

In Oregon, anti-government militants would take over a wildlife refuge, sparking a standoff that ended with one of the militants being shot and killed by authorities.

And in Orlando, Fla., a gunman would slaughter 49 people at a gay nightclub, one of the worst mass shootings in U.S. history.

The roll call of communities devastated by extremist violence in the year since the Charleston massacre is evidence that national and local leaders have not addressed the root causes of this violence, such as online radicalization and the mainstreaming of radical right ideas by politicians and other public figures. The country's changing demographics as well as changes in the cultural and legal landscape - such as the acceptance of same-sex marriage - have attracted some segments of the population to these ideas.

"There was some progress in addressing symbols of hate after the Charleston shooting," said Southern Poverty Law Center (SPLC) President Richard Cohen. "It was encouraging to see the Confederate battle flag removed from the Capitol grounds in both South Carolina and Alabama. We have, however, failed as a nation to recognize and

"Terrorism" moves Congress more than dead children

The shooting at the Pulse Club in Orlando was horrific. Nobody would argue that.

But the fact that the shooter dubbed himself a sympathizer with ISIS, fitting the description of "terrorist," has created movement in the Congress that no other mass shooting up until now has been able to inspire.

There is something wrong with that.

I thought that surely, when the children at Sandy Hook Elementary School were blown to bits by 20-year-old Adam Lanza, that the Congress, many of whom purport to be "pro-life," would act. I thought the lawmakers would unite and create some type of gun-control legislation that would make it harder for some people to get guns.

At the least, I thought they would reinstate the ban on assault weapons. But Congress did nothing. Not even the brutally maimed bodies of little children could move the Congress to act.

The National Rifle Association (NRA) had a hold, it seemed, that took precedence with the specious

assertion that the president was trying to take away the Second Amendment rights of Americans. The argument is so full of holes, so weightless, that it defies any attempt to rationally challenge it.

Nothing, it seems, would shake even the Democrats in the House and Senate. All of the lawmakers, or nearly all of them, dug their heels in, dead, mangled children notwithstanding.

But with the word "terrorism" invoked, the mood has shifted a bit. As soon as it became apparent that this man who had connections with ISIS, albeit distant, the media ate it up. This was a terrorism attack. This...was against America. This...was something different, worthy of greater attention and involvement from lawmakers.

So, deaths wrought by White Christians wielding guns, are not worthy of serious consideration for some kind of gun control? The rights of people to buy guns - not just guns, but assault weapons - should be protected

even if that means they shoot up innocent people, except in the case of the shooter being a Muslim? The massacre of innocent people is "okay" until the shooter sympathizes with ISIS?

Senators and Representatives who have heretofore been silent about or in opposition to any form of gun control are now speaking out.

What the media is completely ignoring, as it continues to vilify Islam, is that there are a lot of Christians, White and Black, who are "radicalized" as well as there are Muslims. While the media is saying that Islam hates homosexuality, plenty of Christians hate it, too.

Some Christians have even said that the murder of the 49 people at Pulse got what they deserved.

Radical Muslims and radical Christians are not that much different when it comes to this subject.

What the media is not concentrating on as hard as it is concentrating on the terrorist aspect of this tragedy is the fact that it seems like it was at least as much a hate crime as it was a terrorist attack. And it may be that the shooter was in conflict because he was struggling


with identifying and accepting his own sexuality. What better way to kill that which you don't like in yourself than to kill someone outside yourself who represents what you are trying to deny?

Those who want to prove that "radical Islamic terrorism" is on the rise, are almost gleeful. This attack proves their premise that that terrorism is the major issue of our time, and adds fuel to their argument that President Barack Obama is the cause of it all.

Meanwhile, assault weapons are still on the market, the media is still feeding the fear about Muslims, and people continue to be mutilated by weapons of war. This is in a so-called civilized society.

It is disheartening and disturbing, but it is the America that we live in today.

bustle atmosphere in our country right now," said SPLC Senior Fellow Mark Potok. "It is beyond reckless to exploit the anger and polarization that's out there.

Unfortunately, that's not stopping some people. The attack in Charleston should have been a wake-up call. We've paid the price as a nation for ignoring it."
