PG&E to remove 130 trees along Almaden Expressway

By Lorraine Gabbert Senior Staff Writer bout 130 trees along Almaden Expressway, between McAbee Road and Rajkovich Way, are facing the chopping block this spring due to their locations near Pacific Gas and Electric's (PG&E) gas transmission lines.

"Any trees within 10 feet to either side of gas transmission lines pose a safety risk," says PG&E spokesman Jeff Smith. "We looked at 340 trees and determined 130 will have to be replaced."

"The removal of any tree is regrettable," says Almaden Valley Community Association (AVCA) Board Member Bob Strain, "and removing 130 trees is clearly going to change the look and feel of the neighborhood."

Initially, PG&E conducted an aerial GPS search of their entire gas

transmission system. From that, they were able to pinpoint the trees, sheds and swimming pools built directly over gas transmission lines. 'We were able to get a general idea of where we had to take a closer look on the ground," says Smith.

"They showed me 210 trees they were looking at," says Councilmember Johnny Khamis, "and I said, 'You've got to be out of your mind.' Now they dwindled it down, but that's still 130 trees less than we have." Ironically, Khamis had been working for the past two years to plant 100 more trees along Almaden Expressway. "I was going in the opposite direction completely," he says, "begging the County to allow us to plant trees and working with the Rotary Club and City Forest on a maintenance program." He even had 43 trees donated. "Then this See PG&E, page 15

t was an exciting morning on April 23, 1988 when several hundred of Almaden Valley residents who converged on Almaden Expressway to plant trees along Almaden Expressway.

The temperature was 51 degrees at 9 a.m. as children, teens and adults picked up their shovels and participated in the 3 hour tree planting event called Trees for Almaden project, which was funded by the City of San Jose's San Jose Beautiful program. Before the tree planting started, Almaden Feed & Fuel treated everyone to a free breakfast.

The Almaden tree planting project also raised funds from Almaden Valley residents, home builders, and local businesses. Many residents donated \$7.50, which was the cost of one tree planted along the Almaden Expressway.





Let's make it simple for residents to report illegal dumping

County

By Dave Cortese Special to the Times It doesn't take much to create a dump.

First, someone drops off a beatup sofa along the side of a road, at the end of a street or on a vacant lot. That invites someone else to leave a pile of garbage, a worn-out refrigerator, a broken table and construction waste. Before long, these illegal dumpers have created a mini-landfill.

Judging by phone calls to my office and the offices of my colleagues on the Board of

Supervisors, these unsightly, and sometimes dangerous, blight deposits have been on the rise, causing enormous frustration for residents and the officials who represent them.

So, I was bewildered at the February meeting of the Housing, Land Use, Environment and Transportation Committee, which I chair, to hear a report that incidents of illegal dumping in 2015 and 2016 amounted to 75 each year throughout the entire County.

I believe those numbers are way too low. But I also think the numbers are a reflection of how hard it is for the average resident to report illegal dumping in Santa Clara County. If we made it easier. I believe the numbers of reports would go up, and the sites could get cleaned up more quickly. Here's how it works now:

To report illegal dumping on a County Road or Expressway, you need to visit sccgov.org, fill out a service request forum or download a Mobile Citizen App on your smartphone so you can take a photo of the debris and send it to Roads and Airports Department. Unless it is after work hours or on weekends, then you call 408-299-2506 to reach County Roads and Airports.

Residents in the Santa Clara County unincorporated area can also file a complaint about excessive junk on private property by calling County of Santa Clara Code Enforcement 408.299.5770. Dumping-in-progress reports should go to the Santa Clara County Sheriff

Department's non-emergency line at 408.299.2311. District 3 residents who live with-

in the City of San Jose can report illegal dumping by calling the Customer Contact Center at 408-535-3500. Dumping-in-progress reports should go to the San Jose Police Department non-emergency line at 408.277.8900.

If you see anything dumped in or near a storm drain, it could affect the quality of water, so you would call the Clean Water Program at 408.299.2506, unless it's after business hours or on weekends, then it's

the County Roads and Airports. The Santa Clara Valley Water District also has a pollution hotline to call at Pollution Hotline at 1-888-510-5151 for incidents in the SCVWD jurisdiction.

There are more numbers, but you get the idea. Too many phone numbers! I'm advocating for a single Illegal Dumping Hotline. One number to report any discovery of trash. Then County staff can route the report to the appropriate responder, and put the cleanup in motion.

The County administration is working on setting up a hotline and also a mobile phone app to help residents report illegal dumping. I'm expecting it to happen in the next 60 days, so that we can get it working ASAP. I will keep you updated. It couldn't happen too soon for me.

Also on the topic of cleaning up our environment, the County has entered into agreements with Caltrans to address illegal dumping along state highways and interchanges in the County, at no cost to the County.

Caltrans will hire the San Jose Conservation Corps to clean up litter and trash through 2018. Caltrans will also fund the Probation Department to work with the Center for Employment Opportunities to supervise and train probationers to clean up trash along other Caltrans areas. The total investment by Caltrans for these two agreements is \$3.7 million.





To mediate or arbitrate... or neither? That is the question

This Week's Question:

"I have a small business here in the Almaden Valley. Often I am asked to sign contracts with various vendors. Sometimes the contracts have a mediation provision and sometimes they have an arbitration provision. What is best for me?

Dear Willie:

You emailed in a very good question, and it is one that many of our Almaden Times readers may have to analyze for themselves from time to time.

Mediation and arbitration are the two types of ways to possibly settle disputes before they end up in court. They are often referred to as "Alternate Dispute Resolution" procedures.

Of course, if a dispute ends up in court, both sides are usually looking at considerable expense, delay, and lack of privacy in working out their differences, often with longterm negative effects, stress and a really expensive attorney bill.

It should be pointed out that both mediation and arbitration have their advantages and disadvantages, and neither is an absolute cure-all for every given situation. You will want to think it over before you sign that contract and very possibly see your own attorney for legal advice.

Mediation generally consists of one or more meetings whereby both sides (or all

sides) attend one or more sessions with a trained mediator to work out a settlement of the dispute. Obviously, having a success-

ful mediation often depends on the skill of the mediator, but if the chemistry of the parties is terrible, the best mediator in the world cannot help settle the dispute.

Mediation is usually optional in terms of trying to work out a settlement. In other words, if it works, fine, and a settlement agreement is prepared and signed. If it doesn't work, it's off to court you go.

One of the advantages of mediation is that a dispute might be settled early and less expensively when settlement is explored early. A contract might require mediation before a lawsuit is filed.

Another advantage of mediation is that it might provide an opportunity for informal discovery to clarify the issues involved in the dispute.

Binding arbitration, on the other hand, is often "final" in a sense, in that it often takes the place of court proceedings. A contract might provide that an arbitrator will decide the dispute and the court process is waived or cancelled.

If the arbitration is "binding", it eliminates the right to appeal, which is a valuable right. You need to think about that.

Also, if the arbitration agreement is very

broad, the arbitrator could even be a lay person without legal training. You also need to think about Qualifications of the arbitrator are very important. Another disadvantage of

arbitration is that a motion in court that disposes of the case is generally not possible since court proceedings are not available. The same is true of discovery where each side can learn more about the case from the other side. Another negative of arbitra-

tion is that some rules of evidence are basically ignored, so

that hearsay and other information is considered. Expert testimony also may not be allowed in the arbitration proceeding.

On the other hand, large jury verdicts might be avoided with arbitration and it is often less expensive than costly litigation. However, since a very small percentage of cases actually go to a jury trial, this may be less of a factor.

Another advantage of arbitration is that it

is usually faster than litigation, as well as more efficient and hence less costly in lawyer fees and related expenses.

The truth is there are no magic answers to your question. Sometimes you or your attorney might be able to negotiate a suitable provision that meets your needs. And, as a practical matter, the other side in your business deal might just say it's a "take it leave it" issue because of their superior bargaining position. In other words, you might be asked to sign their contract as is or there will be no contract. You should always have competent counsel negotiate your business contracts so you do not end up in a dispute where it is far too late.

came and put a big kibosh on everything I was trying to do to beautify the expressway."

PG&E's plan to cut down hundreds of trees in Palo Alto, Scotts Valley, Walnut Creek and Willow Glen enraged those communities. Following the utility's plan to remove 300 trees between Santa Cruz and Felton, the Santa Cruz County Board of Supervisors said, "any other project in the county with such a huge environmental impact...would require a published environmental report that includes public input." Palo Alto city officials required PG&E to allow a public assessment of the environmental impact of removing their threatened trees, while Walnut Creek pressured the utility to re-evaluate trees near a pipeline and provide supporting evidence for their removal.

Khamis says he is extremely disheartened about the removal of the trees, but he also understands PG&E's needs.

Trees, brush and structures can block firefighters' access during emergencies and prevent utility crews from performing safety and maintenance work. Tree roots also pose a safety risk because they can damage the protective coating of underground pipelines, leading to corrosion and leaks.

"Over the last several years, PG&E has been doing an extensive study of our gas transmission system and how we can make it as safe as possible," says Smith. "An area of concern to first responders is being able to access our gas transmission lines in the event of an emergency or natural disaster. It's the same reason you can't park your car in front of a fire hydrant; it's not that fire fighters need access to the fire hydrant on a daily or even weekly basis, but in the event of an emergency, they need it immediately and unobstructed. We want to make sure that if there is a break, a pipe can be accessed quickly without something getting in the way."

PG&E has been closely monitoring the pipelines since the 2010 San Bruno pipeline explosion resulted in a fire, which killed eight people and destroyed 38 homes. In 2015, the utility developed a statewide Community Pipeline Safety Initiative to ensure its 6,750-mile gas transmission pipeline is unobstructed.

"Clearing obstructions to a gas line will not only save time, it may help save lives," said Tim Main, South Santa Clara district battalion chief. "It will make sure our firefighters and all emergency response teams can get to the pipeline quickly and safely."

"We understand people's attachment to trees," says Smith, "and are trying to limit the impact." Smith says that PG&E considered moving the pipeline, but found that the environmental impact of moving it affected an even greater number of trees and had a larger impact than leaving it where it was.

"It's unfortunate, but it does seem that these trees need to be removed if PG&E is going to protect the gas pipelines from roots and provide quick emergency access," says Sierra Club Guadalupe Regional Group's Conservation Committee Chair Dave Poeschel.

"Unlike our fight with PG&E over the 140 trees they wanted to remove in TJ Martin and Jeffery Fontana Parks, where their blanket rules did not make sense and where we were able to save most the trees, I think we're going to have to accept the loss of the trees on or near the pipeline."

"That the need to remove so many trees on Almaden Expressway comes down to safety does make sense," says Almaden Valley resident Mary Ann Holly. "I was pleased...the oleander shrubs also in the median strip...it sounds like they will remain, which would be wonderful."

Even though PG&E pledges to restore the areas following the trees removal to preserve its natural beauty, some residents are not convinced.

"As I look at the county tree ordinance, it appears that PG&E has no obligation to obtain permits or to restore any sort of vegetation," says Strain. "I understand they plan to leave stumps of unknown height, and I have not heard any commitment to maintain the aesthetics of the area. Clearly, we have no interest in repeating San Bruno in Almaden Valley, although I have not seen any comment from the San Jose Fire Department on the efficacy of PG&E's plan."

"They said they're negotiating with the city on beautification, but an agreement isn't worked out yet," says resident Jim Johnson. "I don't want a bunch of stumps left around."

"Safety needs to take precedence over the trees, but PG&E has to compensate us aesthetically," says resident Jason Spitcer. "If median trees have to be taken out, landscapes should be added."

"I don't want a desertscape," says Khamis. "I told them they can't leave the median ugly with stumps everywhere. I hope they listen. I hope the County makes sure they do the right thing."

Poeschel allows that the City and County don't have much leverage as the California Public Utilities Commission regulates PG&E, but says that PG&E should be held accountable for replacing and maintaining the trees until they are fully established, including watering them for three years.


Smith says that PG&E will not leave stumps behind and will landscape, leaving everything better than they found it. The utility also says it will replace the trees it removes with saplings planted a safe distance from the pipes and take full responsibility for the maintenance of the new trees through offering compensation. "Costs associated with the new trees will be paid for by PG&E," says Smith.

"It's important to get as many trees on Almaden Expressway as possible," says Poeschel, "not just for their beauty, but because trees dampen noise, provide cooling shade, absorb pollution and provide fresh air. Trees can help reduce the fine particulate pollution generated by expressways, which permanently impair lung capacity and can cause other cardiovascular disease. So, the removal and replacement of trees is a real health and safety issue."

Poeschel hopes, with the help of the California Native Plant Society, that varieties of shallow- rooted, drought-tolerant, and low-maintenance shrubs and ground cover can be chosen to replace the trees removed by PG&E where trees are not appropriate.

Before proceeding, PG&E will work with community leaders and the city arborist to determine where the new trees will go. PG&E recently met with the Martin-Fontana Park Association Board, which is not fighting them on the tree removals as they believe that PG&E is committed to replacing the trees. "We did not object to the idea and talked generally about numbers, types and location," they said. The Board suggested planting a number of trees in both TJ Martin and Jeffrey Fontana Parks.





By Johnny Khamis City Councilmember The flooding that neighbors experienced last month reminds us all that we must be prepared for disasters.

We all woke up to the news that 14,000 of our neighbors had to be evacuated and we recently learned

the damage from the flooding is estimated at \$100 million. If that isn't enough warning to start taking emergency preparedness serious, I don't know what else would make the point.

Last year I requested that the City start investing more funding into the Office of Emergency Services and to focus on moving the Director of OES under the City Manager's Office and

out of the Fire Department. I will continue to push for this to happen, but today I want to talk about how you can prepare your family for natural and man-made disasters.

The most important goal for you and your family is to be prepared for a disaster, together. If we have another 1989 earthquake or one of a higher magnitude, most City resources will be taken up where population is most concentrated. That means firefighters and emergency responders are going to initially be concentrated in the downtown area and neighborhoods are going to have to depend on their own resources until more help arrives. Please have conversations with your family members about how you will handle a flood, an earthquake, a terrorist act or any other natural disaster that may come our way.

Despite his doubts, Mack journeys to the shack and encounters an enigmatic trio of strangers led by a woman named Papa. Through this meeting, Mack finds important truths concerning the Seven Seals that will transform his understanding of his tragedy and change his life forever.

After suffering a tragic loss of their youngest daughter, the entire family spirals into a deep depression causing them to question their innermost beliefs about God. Each of them faces the tragedy differently. A man who lost his daughter tries to find peace with God inside a shack in the woods.

Based on William P. Young's best-selling Christian novel, which has sold more than 20 million copies worldwide since 2007, The Shack charts the spiritual journey of Mack Phillips (Worthington),

who wrestles with faith at an abandoned "Shack" where his daughter was abducted and killed years before. Through encounters with God (Octavia Spencer), Jesus (Avraham Aviv Alush) and the Holy Spirit (Sumire Matsubara), Mack learns how to forgive and move forward.

When you have a child, there are emotions you cannot and don't want to even describe, so you're more open to deep feelings inside you. ... Especially when the story involves the loss of a child, you understand the deeper connection to it. When I read the Bible, I see a pattern. A code. When I look at religions of the world, I also see a pattern. A code. I look at problems and I try to find solutions. It's possible that everything I believe is wrong, but at least as a scientist I'm trying to find a solution. Religions, Science, and Governments are the same exact coin. Their



purpose is to enslave the masses.

All religions of the world have one concept. Love your friends and kill all your enemies. Though I'm not a Hindu, I'm following the path of Gandhi, Mandela, and Martin Luther King. If we are to survive as a species, then we must love our friends and our enemies. This is the path of enlightenment. Remove all hatred and fear from your life. Only then can you find peace. We must be willing to lay down our lives for our enemies and be willing to go to hell for our enemies. It doesn't matter whether heaven or hell

exist as defined by religions or science.

If every religion in the world followed this path, then there would be peace. This is what I call The Golden Path. This is the main teachings inside the film, "The Shack." If we do not solve the problems of spirituality, life on this earth will cease to exist and the rest of the universe will not miss us. Technology without solving the problems of the mind will not work. I believe that if The Golden Path or The Shack is followed by all mankind, then war would cease from our reality. Man, could even solve death, our last enemy.

Man, believes in scarcity. I do not. When I look at the technology of the electron. There is no such thing as scarcity or lack of resources. There is enough power inside a single electron to provide food, water and power for the entire universe and fuel for every star. An electron is eternal. It's an artificial intelligence program written by the hand of our creator and it's a living, breathing supernatural being. Scientist of today do not understand or grasp the power of eternal technology that has no beginning or end. It lives outside the realm of the box we currently live in. It does not follow the laws of thermodynamics, heat conservation or physics trapped inside our universe. We live in a universe where nothing is impossible.

I wasn't raised religious. I think I was about 16 (when) my grandmother gave me the Bible and said, "Look, maybe you should read this." I had my (metaphorical) shack; I had built that. The shack is a parable for all hate, fear, guilt, and grief of life that you hold onto. ... The Bible shows you ways to forgive what people have done to you, forgive God for letting it happen and, most importantly, learn to forgive yourself and let go of all that burden. I kind of had no understanding of how to do it until I learned to let go of all my hate and my fear. The movie The Shack and the book teach these spiritual lessons about love. Love that's not defined by man, but love that can only be defined by God. It's a gradual process. It takes time and you can't do it alone.

You look back in time and go, "Wow, I must've been searching for something there. And I was looking for lessons I can hand down to my friends, family, and children — maybe that was the journey. But it certainly wasn't at the time. It's just in hindsight that I think maybe those conversations about faith, why we're here and why things happen (were) what I was searching for all along."


