Baltimore model chronicles cancer battle



Trina Isaac was diagnosed with advanced colon cancer in April 2012. She underwent surgery to remove a large portion of her colon which was followed by chemotherapy treatment. However, the cancer persisted and in 2013 Isaac had a permanent colostomy to surgically remove more of her cancerous colon. She recently became a member of the Osto Beauties, a Baltimore-based group formed to spread awareness of women of color living with ostomies. Isaac also serves as an ambassador for Johns Hopkins' Sidney Kimmel Comprehensive Cancer Center's Hope Project, which allows her to speak to first-day chemotherapy patients, providing them with an understanding of what to expect. PNC Foundation, DonorsChoose.org bring spring sunshine to Harlem Park Head Start

Adrienne Kearney-Clemons will be able to spruce up her classroom at Catholic Charities' Head Start - Harlem Park Elementary School without going into her own pockets this spring, thanks to a new initiative launched this week by PNC Foundation and DonorsChoose.org.

Like all caring teachers, Kearney-Clemons purchases needed supplies for students that just aren't in the budget of schools serving low-income communities.

While K-12 schools have turned to crowd sourced funding at sites such as DonorsChoose.org to raise money for school supplies, pre-schools and programs like Head Start were not eligible to post requests on the popular crowd-funding site.

Thanks to PNC Foundation, all that changed this week. Laura L. Gamble, PNC Bank Regional President for Greater Maryland announced the PNC Foundation's "Grow Up Great" program has reached an agreement with DonorsChoose.org to include requests from early childhood education teachers, including Head Start classroom teachers.

"PNC will match, dollar-for-dollar, every preschool donation made to schools on DonorsChoose.org in the locations where the bank has offices," said Gamble, when announcing the foundation's \$5 million gift to fund pre-school requests on the crowd source site.

"This is a great way for all of us to call attention to the value of investing in early childhood education," Gamble said. "A dollar invested in early childhood education is the best investment. It's irreparable."

As part of the announcement event, Catholic Charities Head Start teachers and students at Harlem Park Elementary School received T-shirts, books, gift cards, puppet kits, piggy banks, lunch bags and an iPad. The children were also serenaded with a performance by the Opera Bears, a local group dedicated to ensuring Opera is accessible to children.

The day was a game changer for Kearney-Clemons, her new co-instructor Shannon Bishop, and the entire Catholic Charities Head Start staff.

"These are my babies. I have a passion for them," said Kearney-Clemons who first connected with Head Start when her own children were enrolled in the program and has now served on the Head Start staff for more than 20 years.

"It's the first time I've witnessed anything of this magnitude," said Kearney-Clemons. I'm very excited and looking forward to participating in the DonorsChoose.org option created by PNC. I'm one of those teachers who puts

a lot of money and time into creating a classroom experience for my children."

Since the "Grow Up Great" program was founded, PNC employees have logged more than 652,000 hours for the initiative through a progressive policy that allows 40 hours of paid time off each year to volunteer. Volunteers have collected more than 930,000 books, art supplies, hats, mittens and other items that have been donated for use in classrooms or for the personal well-being of preschool students.

Christine Flores, second year

employee with PNC's Wealth management team is excited about having a little seniority with the bank and is venturing out beyond corporate headquarters to serve the community.

"This is my second year at PNC. I've always been interested in helping out with kids and the community," Flores said.

PNC Grow Up Great is a \$350 million, multi-year, bilingual initiative that began in 2004 to help prepare children from birth to age five for success in school and life.

BGE Green Grants Program Now Accepting Applications

The Great Distracter

Three of Donald Trump's latest ploys to distract attention from Russiagate have failed.

First was Rep. Devin Nunes' late night visit to the White House under escort by two staff members to view classified information. The visit increasingly looks like a prearranged attempt to divert his committee's investigation into Russia-gate. One of the escorts was appointed by Michael Flynn the former national security assistant and efforts by Flynn's successor, H. R. McMaster, to remove him were reportedly thwarted by Trump himself. As Sean Spicer might say, this episode doesn't pass the smell test: It sounds like a "weapon of mass distraction," as someone on CNN said. Trump is grasping for straws—anything that will lead the media and investigators away from the Russia matter, all the more so now that Jared Kushner's meeting with the representative of a sanctioned Russian bank has become known.

The second ploy is a signature example of Trump's untrustworthiness: His turn-about on immunity for government officials who might be prosecuted for criminal behavior. As he has shown time and again, what he once said about a matter is irrelevant to what he now says. Recall that in late September 2016, Trump said in reference to Hillary Clinton and senior staff seeking immunity over her use of a private email server: "The reason they get immunity is because they did something wrong. If they didn't do anything wrong, they don't think in terms of immunity. Five people. Folks, I'm telling you: Nobody's seen anything like this in our country's history." Flynn followed up the same month on NBC's "Meet the Press": "When you are given immunity, that means that you have probably committed a crime." A number of other Trump senior staff weighed in at that time, trying to score points off the idea that a President Hillary Clinton would be under FBI investigation for years, presenting an intolerable situation.

Now that Trump is under assault, he wants Flynn to testify under immunity, to challenge the Democrats' "witch hunt." Same old diversion strategy, and it too smells bad. Trump must be supremely confident that Flynn has nothing to offer the intelligence committees. Recall that Trump waited two weeks before firing Flynn, a clear sign of his hope that Flynn could weather the storm. Flynn, meantime, has lots to gain from a grant of immunity, notably, his discussion of sanctions with Russia's ambassador while still a private citizen. Like Nunes, Flynn is a proven Trump loyalist—a former campaign booster who will do whatever is demanded of him to frustrate a probe of collusion with the Russians. Wisely, the Senate Intelligence Committee turned Flynn down, at least for now.

Trump's third ploy is to keep massaging the "wiretap" accusation, each time trying to redirect the media and Congressional investigators. Trump began by directly accusing President Obama of having wiretapped him at Trump Tower. That accusation got nowhere, so he diverted to the accusation that he and his team had been "surveilled" by Obama's people. Now that that charge has been shown to be nothing more than ordinary and perfectly legal National Security Agency eavesdropping on phone calls initiated from abroad, Trump is asking for investigation of any kind of surveillance by anyone at any time. It's a fishing expedition that he (probably in league with Stephen Bannon) surely knows can go nowhere.

From the president on down, this is an administration on the defensive, populated by people who are their own worst enemies. The Watergate model looks more relevant by the day.

Federal funds available to serve summer meals to children and teens

Baltimore—The Maryland State Department of Education (MSDE) announced that federal funds are available to assist public and private nonprofit organizations in serving free, nutritious meals to children and teens this summer through the Summer Food Service Program (SFSP), a U. S. Department of Agriculture (USDA) program.

More than 396,000 Maryland children are eligible for free or reduced-price school meals, but may not have access to nutritious meals during the summer when schools are closed. For these families, food insecurity increases during the summer months. The SFSP plays a vital role in ensuring children and teens do not experience hunger during the summer.

"The Summer Food Service Program fights hunger, reduces obesity and promotes summer learning. Studies demonstrate that children from families with low incomes have higher rates of summer learning loss than their peers from

families with higher incomes. For every child to succeed, they must have access to nutritious meals during out-of-school time periods," said Dr. Karen Salmon, Maryland State Superintendent of Schools.

The SFSP provides reimbursement to organizations for meals and snacks served to children in areas where at least 50 percent of the children qualify for free or reduced-price meals under the National School Lunch Program (NSLP), or when 50 percent of the children enrolled in a summer program qualify for free or reduced-price meals. Most organizations may be reimbursed for up to two meals or snacks per child per day. Camps and migrant programs may be reimbursed for up to three meals per child each day. Meals and snacks must meet federal nutrition standards.

The Program is open to children and teens age 18 and under and to individuals over 18 who are mentally or physically disabled. Sponsors of hate today must be held accountable

Over the next several days, across the United States, people will pause in solemn remembrance of the 49th anniversary of the tragic assassination of Reverend Dr. Martin Luther King, Jr., in Memphis, Tenn., on April 4, 1968.

Back then I was a young, college student and staff member of Dr. King's Southern Christian Leadership Conference (SCLC) in North Carolina on that tragic day in 1968.

There is no question that it has been a long and difficult road for our communities, during the past half century, as we continue to fight for equal rights and to eliminate racial hatred, discrimination and bigotry.

Many in North Carolina may recall my beginnings in activism when, as a 13-year-old, I fought to integrate the public library in Oxford, N.C., and was the first African-American to successfully struggle to get a library card there. Later, I worked for the SCLC, CORE, NAACP, and the United Church of

Christ Commission for Racial Justice. Today, I proudly serve the National Newspaper Publishers Association (NNPA) as President and CEO.

Over the years, our work has taken different shapes and has required many different approaches and levels of intensity to ensure we continually push our leaders and fellow citizens further down the path of freedom, justice and equality.

Under the Obama Administration, we were fortunate to have friends in the White House, the Department of Justice and all across the Administration, who recognized the historic opportunities, and worked with us to maximize them. We saw many advances for our communities and the priorities were rightly on addressing criminal justice reforms, labor, income, education, poverty and access to health care. We did not arrive fully there, but we were well on our way to making more progress for all people in America.

With the rise of the so called alt-right movement and its anti-immigration agenda that many believe helped to elect President Trump, we find ourselves working to maintain the status quo in civil rights rather than advancing this fight. And we have every right to be concerned and frustrated. Yet, as Dr. King believed, we should work to get each President of the United States, including President Trump, to denounce bigotry and hatred, as well as to champion racial equality.

We must tap into that energy to push our agenda and ensure that our nation's leaders do not support bigotry of any kind and that means identifying individuals and groups that are sponsoring this hate and holding them accountable.

Unfortunately, here in my home state of North Carolina, the Foundation for the Carolinas has spent tens of millions of dollars over the years supporting groups that sponsor hate and advance this anti-immigration and population control agenda that threatens our communities. All immigrants should be treated fairly and equally without discrimination.

Behind a veil of anonymity created by the Foundation, donors who support this organization are able to indirectly fund extremist groups without any public accountability. The Foundation prides itself on—and even advertises—donor anonymity as a reason to contribute to the foundation.

Large donors are assured that Foundation for the Carolinas has “fewer reporting requirements” than private foundations that they might otherwise choose as a vehicle for their giving. This condition, afforded to some of our state's wealthiest individuals, has enabled patrons of the organization to operate unchecked—making this lack of transparency as a significant liability for your organization.

According to the “Los Angeles Times” and others, one individual in particular, Fred Stanback, has used the foundation to direct his money to extreme causes. Behind the cloak of the foundation, Mr. Stanback has become a leading supporter, funneling tens of millions of dollars, to fringe anti-immigrant groups including the Federation for American Immigration Reform (labeled an extremist group by the Southern Poverty Law Center). It is my understanding that Mr. Stanback is behind several donor advised funds at the Foundation, which

afford him this anonymity.

Over a period of more than 10 years, the Foundation has donated more than \$20 million dollars to the Federation for American Immigration Reform (FAIR) and to NumbersUSA, a similarly minded and well-known extremist group. These vehicles have proactively disseminated hateful xenophobic sentiment throughout our region and country, ostracizing some of our most vulnerable citizens.

In addition, the Foundation For The Carolinas' board of directors reserves “variance power,” which authorizes it “to modify any condition or restriction on the distribution of funds if in its sole judgement (without the approval of any trustee, custodian or agent), such restriction or condition becomes, in effect, unnecessary, incapable of fulfillment, or inconsistent with the charitable needs of the area served by the Foundation...” Despite the board's discretionary power, it chose to support organizations whose agendas were clearly at odds with the best interests of a diverse nation.

As a civil rights and social justice leader, my view is that we should not tolerate this kind of unjust targeting of our most vulnerable citizens by Foundation for the Carolinas' anonymous patrons. Public accountability for all nonprofits is necessary. It is our duty to fight for justice for all. It's time for the Foundation for the Carolinas to come clean and stop sponsoring such hate groups. Let's move our nation forward and not backward.

Ravens decide to move on from Timmy Jernigan

The Baltimore Ravens decided it was time to pull the plug on fourth-year defensive tackle Timmy Jernigan. The Philadelphia Eagles sent their third round pick (No.74) overall to the Ravens in exchange for the Ravens compensatory pick in the third round (No.99) overall, as well as Jernigan.

This is the first year that compensatory picks can be traded and Ravens GM Ozzie Newsome wasted no time taking advantage of the rule adjustment. Baltimore currently has seven picks in the 2017 NFL Draft, including four in the first 78 selections. Here are the Ravens picks: First Round (No.16); Second Round (No.47); Third Round (No.74) from Eagles trade— Timmy Jernigan and No.99; Third Round (No.78); Fourth Round (No.122); Fifth Round (No.159); Sixth Round (No.186) from 49ers trade—Jeremy Zuttah and No.198.

With Brandon Williams, Carl Davis, and Michael Pierce as the primary defensive linemen on the roster, the Ravens will need to use at least one of their draft picks to replace Jernigan. Coming off of his best season in the NFL last year, the 24-year old started in 15 games for Baltimore last season. Jernigan registered five sacks and 31 tackles in 2016. He also posted his first career interception. The year got off to a

fast start for Jernigan as he had sacks in each of first three games. Unfortunately, he didn't have any sacks in final seven games. His effort and attitude were questioned as his playing time decreased later in the season.

That did not stop Ravens head coach John Harbaugh from saying he expects Jernigan to have his best year as a pro in 2017. Whether or not Harbaugh was

trying to pump up Jernigan's trade value

is unknown. If Jernigan is to have his best season, it will be with the Eagles in a contract year.

Newsome acknowledged Jernigan as a player during his tenure with the Ravens but has his eyes on the next men in line for Baltimore.

"Timmy has been a terrific player for us for three seasons," Newsome said in a statement released by the Ravens. "This will allow our young group of defensive linemen an opportunity to compete and play."

The NFL Draft is just a few weeks away. Three players that could help the Ravens' defensive line include Dalvin Tomlinson from Alabama, Montravious Adams from Auburn and Chris Wormley from Michigan.

Baltimore has an abundance of early picks this year and could put a package together to move up in the first round to take Alabama defensive end Jonathan Allen if he should fall.

With all of the allegations surrounding Russian hackers, news about email leaks, and major intrusions at political organizations, concerns about your own information security shouldn't be pushed aside. There is no better time to secure yourself and your business than now. This month, I'm giving you five fast tips for protecting your business.

1. Use the latest software

For real, **stop using Windows XP!** The biggest threat to your enterprise is using outdated and unsecure software. Despite what we see on TV, hackers can't just breach any system; they need to know something about a computer system in order to hack it. Old software and operating systems are insecure, and security vulnerabilities are shared amongst crackers. Keep your existing systems up-to-date, and upgrade as soon as you are able. And upgrade your browser!

2. Choose strong passwords

Plain text passwords are very hackable. Choose passwords that combine letters, numbers, and special characters. I get it; it can be hard to remember multiple passwords. Cleverly use letters to

represent numbers, '3' for 'E', and use characters in place of numbers '!' for '1' or 'I'. Use 8 characters or more and a mixture of upper and lower case.

3. Use secure websites

Before purchasing online or handing over contact details on the web look for 'https' in the website's address. HTTPS uses a security standard called secure sockets layer that verifies you are communicating with the site you think you are communicating with. HTTPS also encrypts any data shared between you and the server.

4. Protect your phones

We live and work in a mobile world. If your staff uses phones to conduct business make sure they are the latest editions in hardware and software. Newer iPhones and Android devices support fingerprint-to-unlock technology. Use it!

Also, avoid storing information on phones that are rooted or jailbroken.

5. Stop using flash drives

In some cases they are unavoidable, but in most cases DropBox,

Google Drive, or SkyDrive are better alternatives to removable drives. Plugging a flash drive in a foreign computer is akin to having unprotected sex. You can spread a virus to your computer. If you need to share files with a colleague or prospect ask them to email it or use a cloud storage option.

If you follow these five tips you stand a better chance of preventing data leaks and compromising your personal and professional data.

Baltimore model chronicles cancer battle

Trina Isaac isn't going to let cancer define her. She also isn't going to let it stop her dreams, which include a career at Johns Hopkins Hospital and becoming a professional model.

"I have always— from diagnosis— wanted to show others that living with cancer is not a death sentence," Isaac said. "You ultimately get to choose how you live with cancer. I welcome every opportunity to tell my story to encourage other people to take control of their life and how they live with cancer."

Isaac says she is no inspiration but just a mom determined to see her teenage son grow up.

"I just so happened to be crazy enough to share my journey with the world," she said.

As chronicled by her colleagues in a blog post on Johns Hopkins' webpage, Isaac began working at the hospital in 2008. She recalled feeling sluggish, losing weight and visited Johns Hopkins Occupational Health Services where doctors diagnosed her with advanced colon cancer.

Surgery followed to remove a large portion of her colon and doctors began chemotherapy treatment. The cancer continued to grow, persisting even as doctors prescribed more chemotherapy and radiation. In 2013, Isaac had a permanent colostomy to surgically remove more of her cancerous colon.

"I was diagnosed in April of 2012, my reaction probably was different from many people," she said.

"I remember the doctor saying, 'Trina you have cancer.' I said, 'Ok now what are we going to do about it?' I decide in that moment I was going to be the person that beat the odds and tears was not going to make cancer go away," she said. "My theory was, I had cancer before I knew and outside of my minor symptoms I was doing fine so why should anything change because I knew? I was very deliberate that I was going to

get treatments and go to work, still be a mom. I refused to be considered a patient."

Isaac has continued her career at Johns Hopkins and recently became a member of the Osto Beauties, a Baltimore-based group that was formed to spread awareness of woman of color living with ostomies. She is also serving as an ambassador for Johns Hopkins' Sidney Kimmel Comprehensive Cancer Center's Hope Project, which she said allows her to speak to first-day chemotherapy patients, providing them with an understanding of what to expect.

Isaac has been discovered by designer Luna Joachim and she is now an international fashion model walking the catwalk in places like New York and Paris— with her ostomy bag.

A video she shot also made its way to the "Ellen" show and went viral.

"I actually did the video to cheer my son up over losing our dog. The house was so quiet when he came home from basketball practice so I decide we needed to have some fun," Isaac said.

"I had just come from chemo and was surfing Instagram and saw [a] challenge on [pop star] Ciara's page and decided to do it. It was unplanned and done in one take with my son as the videographer," she said. "I wrote a simple post on Facebook telling the story of my day dealing with chemo and posted the video. I think people were amazed I had so much energy after the long day of chemo I had. It went viral and everyone kept telling me to tag Ellen, so we all did and it ended up on Ellenation.com. Ciara also posted it to her Instagram page."

The illness opens eyes of many people and seeing a bald woman on the runway that just so happens to have cancer evokes much thought, Isaac said, noting that the visual supports her message of living despite adversity.

"I have stage IV colorectal cancer with metastasis to my liver and lungs. The biggest change is all the time I have to put in for doctor's appointments, blood-work, juggling wok, my son and cancer," she said. "I think I just live a purposeful life now. I always encourage people to #MMOP— Make Memories on Purpose— and I hold myself to the same standard. My message to others battling cancer is keep living, remember your mind is stronger than cancer."

"Don't let cancer kill your spirit. Choose happy."

and substance abuse. Additionally, counseling services offer programs designed to strengthen the family unit for youth, teens, women living in traumatic situations, individuals reentering society from incarceration, and individuals living with HIV in North County.

Coates added another point that connects with why he feels that Medley's work is valuable.

“Hope is what we all need,” said Coates referring to the valuable work Medley does for individuals marginalized by society. “Hands that lend that hope is a different story. Everyone doesn't have the hands to lend to give help to others. People don't have hope if they don't have help, so I feel like the connection for the community is that the community needs help and people who just don't talk about our conditions in the community, particularly (in the)

African-American community, but people who can put their hands to the work. That's what Sherry does.”

“This is North County, Glen Burnie, which we know from community assessments and statistics, this is where a great deal of our problem lies. And to get in the midst of that community and work, I feel is courageous.”

The organization will host the Hands of Hope 2nd Annual Spring into Health Expo 2017 from 10 a.m. to 2 p.m. at Marley Station Mall on April 29, 2017.

“This year, this health fair is the closing event for Healthy Anne Arundel Month in partnership with the Healthy Anne Arundel Coalition,” said Marsella Haskin-Hare, community program co-ordinator for Hands of Hope, noting that the event is in partnership with the Department of Health and Mental Hygiene of Maryland. “This is an inter-

active health fair, so we don't want you to just come and pick up paper. There is pilates. There is zumba. There is exercise for men. Home health care. There will be screenings for diabetes, high blood pressure, and HIV. There [will be] spine adjustment and screening. We hope to have massage. There will also be BMI (Body Mass Index) checks.”

Haskin-Hare noted that financial and real estate professionals will participate in the total health and wellness fair.

Filmmaker debuts new movie in Baltimore

Roosevelt Jackson's life plays like a real-life movie reel. In his mid-20s, his debut film "In It To Win It," was a success. The film earned the young filmmaker high accolades and glowing reviews, and prompted some to refer to him as "The Next Spike Lee."

However, Jackson's life would soon spiral out of control. He battled depression, was homeless, and tried to commit suicide three times.

Jackson was in a battle for his life and he looked as though he was down for the count. But with his dying mother and his newlywed wife in his corner cheering him on, Jackson would make a courageous comeback. He has since written and produced several stage plays and films.

On Thursday, April 6, 2017, his newest film, "Residue," made its Baltimore premiere with a Red Carpet debut at the Charles Theater located at 1711 N. Charles Street. Residue is the compelling story of how police brutality affects the lives of families living in the Baltimore, Washington, D.C., Virginia, and surrounding areas.

"Residue is a story of families who have to put their lives together after a senseless act of police brutality claims the life of a character named Ty Johnson," said Jackson. "The film looks at the other lives that are impacted, including that of his father Clay Johnson. This film focuses on all the cleaning up that has to take place after all the heartache and pain. These families have to rebound and put their lives back together.

"The film does not mention a city or a particular police department. The film just says, 'city police.' I see and hear the news, and use this information to write my own movie scripts. These are real-life situations played by performers," Jackson said.

According to Jackson, who is now 48, Residue was filmed primarily in Baltimore and Washington, while some

scenes were shot in Virginia. Jackson said he wrote, produced and edited the film, which is mostly comprised of Baltimore performers.

"This initially started as a short PSA," recalled Jackson. "Now it's nearly a two-hour movie. It took me about two months to write it."

In addition to "In It To Win It" and "Residue," Jackson's movie credits include "Life According to Rasheeda," while his stage play credits include "Through Darkness Came Light," and "If Loving God is Wrong I Don't Want to be Right!"

Jackson reflected on his own life story. "I took the money that I had made from doing hair shows, and used it to produce In It To Win It," recalled Jackson. "The film was very successful, and I started

smelling myself. And just like that, God took everything away. He said, 'you're not ready.' I didn't want to write anymore, I tried to commit suicide three times, I slept in my car, and on people's couches. I lived like that for two years. It was a very dark time in my life. But when my mother got sick, I knew I needed to change some things around."

Jackson said his mother Christine Jackson was dying of cancer. His father Franklin Roosevelt Jackson, Sr. died in 1987.

"My father died two weeks after I graduated from high school, and now my mother was dying," said Jackson. "Nobody believed I could get myself together to help take care of my mother, but I did. I also met Niani, who would become my wife. She read some of my writings and encouraged me to do something with them and to begin writing again.

"When my mother read one of my stories she told me to do something with it. When she realized I had gotten myself together, and was on the right path, she was at peace. She died in my arms in the ER. That was in 2001. Her last words were 'I am okay.'"

Jackson is a native of Washington, D.C. and was raised in Oxon Mill, Md. He and his wife Niani, who is also his business partner, are the parents of two children, ages nine and 15.

Jackson talked about what he hopes to achieve through Residue.

"I want viewer to realize that people have a lot of feelings and thoughts about police brutality. People are going to be shocked about some of the views. I want it to help educate, and to get people talking without yelling. If that happens, then I've done my job."

Dr. Tammi Rogers portrays Mayor Rogers in the film.

"Residue is a docudrama that captures people's views as to how they see a particular situation," said Dr. Rogers. "I like the way Roosevelt has captured what people are thinking about the brutality going on in the world. This film is about these families and their aftermath as a result of police brutality. We seldom get to see the aftermath. This movie brings it all together."


