

Our most recent audited financial statements (fiscal year 2016) reflect strong cash flows covering operating expenses and capital expenditures. The unaudited financial statements for fiscal 2017, however, reflect an operating deficit of \$273,000, almost entirely due to poor performance at the Yacht Club. Going forward, we must examine factors contributing to this and search for remedies.

Our threshold for Board spending without referendum at \$1.7 million should be looked at in light of future asset repair and replacement needs to assure members that responsible spending will prevail. Our priorities must be to update the Reserve Study using current numbers and projected needs, taking into account inflation, and ensure fair allocation to members. The discovery of sink holes and worm-infested bulkheads points to the reality of unexpected and costly capital improvement needs.

The recent introduction of an unbudgeted 20% member discount for food and beverage venues seems questionable. This action substantially reduces our food and beverage margins. To make up this difference, we will need to dramatically increase our business to remain net revenue neutral. It would have been more prudent to allow the Board to consider potential impact to costs of sales and operations before finalizing the budget.

Nicole Schafer Crosariol

I am an amazing team player. During my 6 year employment at Powerhouse Gym and Beach Bounce, I collaborated and worked with over 200 employees, from 9 different departments and 4 physical locations. While collaborating from the head of each department, we were able to not only accomplish, but exceed what was expected across the board. Currently, I work with an amazing group of women who all own their own retail LuLaRoe businesses. We all use our strengths to execute creative ideas and strive to not only grow our businesses, but to branch out and support the whole small business community. In any great team, you need each member to bring their knowledge and expertise to the table to accomplish a common goal. I bring a unique background, and would make decisions based on what everyone needs. I listen, and will help bring innovative ideas that would help benefit us all.

Douglas Parks

While the annual assessment is very reasonable as compared to association fees in the surrounding areas, consideration should always be given to avoid increases, and if possible, reduce the annual fee for OPA property owners. This year's budget is a good example of missing an opportunity to reduce the assessment, as the budget was based on the previous year's assessment fee, rather than approaching it from a zero-based revenue/expense perspective. For the record, I voted against the adoption of the budget for this and several other reasons.

On a positive note, I do need to point out that over 98% of the assessment fees have been collected from the membership, which is above the national average for associations and similar organizations.

The Board and General Manager need to continue to work closely with the Budget and Finance advisory committee in preparing next fiscal year budget. Given the recent successful renovation of the Beach Club and golf course clubhouse, the demand for contributing to the "reserve" fund is greatly reduced and consideration should be given to passing the savings to OPA property owners by reducing the annual assessment.

Martin Clarke

Ocean Pines is in a sound financial position. We benefit from an excellent Fire and Police Department. Our Public works, administrative and recreational staff are dedicated professionals. We have a potent balance in our maintenance and replacement reserves which currently exceeds well over Seven Million Dollars.

Under the leadership of our current board much of our long neglected and deferred maintenance has been achieved. The renovation of our Country Club, new Manklin Meadows playground and pickle ball courts, new Beach Club bath rooms, as well as the mandatory repair of two major bridges has been accomplished. The long overdue renovations to the administration building and police department have been approved in the recently finalized budget for completion within the next twelve months. We owe this board our sincere thanks and appreciation.

With this in mind, when our new General Manager prepares next year's budget he should only fund the required depreciation and decrease the additional amounts we have continually been adding to our reserves under the five year funding plan. This strategy is no longer necessary, and by its elimination, we can easily reduce our membership's assessments by more than \$75.00 a year.

Brenda Wascak

I appreciate the fact that Ocean Pines finances are listed in the OP Report so we can see what the actual operating costs are for our community. I like the fact that the many articles written by the Treasurer explain the expenditures and share data points to help keep our community in the loop and better understand the financial issues that are addressed throughout the fiscal year. I am an advocate of our Fire Department and Police Department because they look out for our safety on a daily basis. I would work to make sure that the safety and infrastructure of our community is funded first and foremost and then recreation and beautification.

Describe your thoughts on OPA amenities. What is going well and what needs to change?

Colette Horn

Support of the amenities adds to the financial value of our homes. Acknowledging years of support by long-term residents, we should look at a "legacy member assessment discount" option.

The audited financial statements reflect a significant overall amenity operating profit for fiscal 2016. unaudited financials for 2017 reflect a substantially lower profit (40%) than the prior year. The Yacht Club poor performance represented 70% of that decrease. It was the amenity with the largest variance from budget, with a loss of \$229,000 vs. a budgeted profit of \$34,000. One may expect that renovations of meeting and banquet space and enlargement of the Tern Grille at the Golf Club will position us for additional net revenue increases. Factors accounting for Food & Beverage operating losses this past year will need to be examined carefully and remedied going forward.

The Yacht Club is plagued by chronic complaints of poor food/beverage product and service quality. It is yet to be seen whether the 20% discount and recent personnel shake-up will exacerbate this or solve it. Increased stability in staffing and better management are critical to increased event bookings and greater overall customer satisfaction, which should boost revenues and improve financial performance.



Carozza garners highest pro-business rating

Maryland Business for Responsive Government (MBRG), a statewide, nonpartisan, nonprofit organization, has released the 2017 results of its annual publication Roll Call, now available online. Roll Call is in its 32nd year of printing.

Delegate Mary Beth Carozza (R-38C) scored 100%, indicating a probusiness position. MBRG considers cumulative scores above 70% as probusiness.

Each year, MBRG's State Advisory Council selects recorded votes from the most recent General Assembly session that are essential to create/retain jobs and promote a healthy business climate throughout Maryland. MBRG identifies these bills in Roll Call and analyzes the votes to produce a score for each legislator.

For the 2017 analysis, "Roll Call" analyzed 15 Senate votes and 16 House votes.

This year, 11 Senators (just 23% of the Senate) and 37 Delegates (just 26% of the House) received perfect scores of 100%, whereas 84 Delegates (60%) and 18 Senators (38%) scored below 30%. The high-scoring legislators generally rejected the extreme policies of legislative mandates and bans, whereas the lower-scoring legislators generally embraced such approaches. For example, the paid leave bill (House Bill 1 and Senate Bill 230) mandated paid leave for employees of 15-person organizations who work as little as 12 hours per week or as few as 107 days per year, and dozens of proposed amendments that sought to lessen the job-killing effects of this mandate were roundly rejected. The legislators who voted against the bill and in favor of the amendments generally scored well, whereas those who favored the mandate and rejected the amendments generally scored poorly.

"Maryland Business for Responsive Government truly understands the policies needed to increase economic development and grow jobs for Maryland's future, and I am proud that they recognize my pro-business votes that benefit both employers and workers across the state," said Delegate Carozza. "I respect the leadership and work of the members of MBRG and am grateful for my 100 percent rating this year."

MBRG is a statewide, nonpartisan

political research and education organization supported by corporations, trade associations, chambers of commerce, and individuals. Its purpose is to inform Maryland's business community, elected officials, and the general public about the political and economic environment needed to foster economic development and job creation in Maryland. lack an able caregiver.




illness), and facilities for grief support and community education.



Croaker Fishing

Fishing Report: Flounder fishing has been good when the water is clear with quite a few keepers being reported. The good news is that weakfish seem to be returning to the bays with some nice fish being caught in the South Bay behind Assateague. Offshore when the weather permits there have been some good catches of black sea bass, a few flounder and tile fish.

What is a Croaker?

(Refer to the illustration)

The Atlantic croaker is one of the most abundant fish in North American coastal waters and is important as a commercial fish as well as an important sport fish. Locally they can be caught from fishing piers as well as the surf and by boat in both the ocean and coastal bays. They usually arrive in

our waters in early July or as late as August. Just keep up to date with the fishing reports to find out when the



action starts. Croaker will not remain in the bays for long. Usually, 2-3 weeks at the most then they will migrate offshore to the shoals.

Croakers are bottom feeders and a close relative of spot and red drum. They are given their name because of the unique sound they make when caught. However, they are fun to catch and good to eat. Kids love to catch them because when they are biting it can be nonstop action.

Maryland Regulations:

In the state of Maryland Croaker must be a minimum of nine inches in length to keep and the limit is 25/per person/per day. I must admit I usually do not keep croaker less than 13 inches as I like to fillet croaker and you need larger fish for a reasonable size fillet. Also keep in mind that in Maryland a 14 inch croaker will get vou a citation and a 17 inch croaker will get you a patch.

What type rig should you use?

Croakers are one of the easiest fish

to catch because they are bottom feeders. The best way to catch them is with a standard two-hook high-low rig with a 2-3 oz. bank sinker. Hook size is important as you need to use a smaller hook in the size 4-6 range. Usually either a wide gap or (long shank) hook will do the job.

What bait should you use?

Expensive bait is not necessary when fishing for croaker. A small piece of squid, shrimp, cut bait such as spot or mullet or a piece of clam will do just fine for these hungry fish but like any other fish if you want a bigger fish put on a bigger piece of bait. If you are also fishing for flounder you can also catch them on frozen shiners and squid combination.

When is the best time to fish?

I personally have had my best luck on the early outgoing tide but most

fishermen feel you should fish the same tide as you would for flounder. That is the last two hours of the incoming tide and the first two hours of the outgoing

Where is the best place to fish?

Any of the local fishing piers, Route 50 Bridge, or surf but if you are surf fishing be certain to comply with local regulations as to when and where you can fish. Behind the convention center and along the bulkhead from Second to Fourth street. Also, check with your local tackle shops as they will give you great advice as to where the bite is best. If fishing by boat try the area around Harbor Island in 12-15 ft. of water. Also, the thoroughfare around the convention center and the south bay behind Assateague Island is a great location. Move around and watch for the concentration of boats as this is a good indication someone found a school of croaker.

Note: Don't forget the Ocean Pines Chamber of Commerce Flounder Tournament Saturday August 5. This is a great tournament - sign up at the Chamber office.

Broken into five goals, each goal of the Action Plan is designed to address a different aspect of COPD so that the entire spectrum of complex issues related to the disease is covered.

Goal 1: Empower patients, their families, and caregivers to recognize and reduce the burden of COPD; Goal 2: Equip

Brecht, Lead Respiratory Therapist at the Pulmonary Clinic participated in the NHLBI (National Heart Lung and Blood Institute) COPD Town Hall collaborating on goal 2.

Atlantic General is helping our COPD patients with these goals through the establishment of the Pulmonary Clinic to educate and provide a forum for patients to get questions answered and to foster self-management of COPD. The Pulmonary Clinic has also invested in training for the Registered Respiratory Therapists through the American Association for Respiratory Care. These Therapists are now certified COPD educators. The Pulmonary Clinic has also adopted the eBright ACO standardized guidelines to help with diagnosis, treatment and improved quality of life for patients with COPD.

Resolution M-02 specifically states that the amenities should be run in a business-like manner and fee-based amenities should be managed to cover, at a minimum, operating costs through fees and operating revenues. The Beach Club and the 5 pools managed by the Association are prime examples of this compliance.

Even with the quality, and quite frankly marvelous, effort the acting General Manager and his team put forth to reinvigorate the building and business management of the Cove, we still showed significant operating losses during these off-season months. In my opinion, if that level of effort and creativity, didn't produce the desired results, its proof enough that we need to close down the operation during the off-season as a prudent business decision and am very interested in what OPA members think of that approach.

Ocean Pines has always enjoyed the finest amenities of any community on the eastern shore of Maryland. Every property owner pays for the cost of these amenities as part of their yearly assessment.
