# Governor's Address: Now is the time to get hydropower from Canada

We've been saying it for years: Maine's high electricity prices are not competitive. Affordable energy is just over the border, but politics is preventing us from getting it.

Dear Maine Taxpayer,

Maine residents spend nearly double the national average for energy. In fact, Maine has the 12th highest electricity cost in the country.

We were glad to see reports this week detailing the five large-scale hydropower proposals that could send thousands of megawatts to the Northeast, which would lower energy bills for Mainers. We have been trying to get inexpensive hydropower

from Canada for years, but to no avail. States to our south are now working to get it. We must take advantage of this inexpensive power that will be flowing right past us. But environmentalists, newspapers and Augusta politicians keep blocking our efforts to reduce energy prices for Maine and New England.

Their policies also drive away large manufacturers that provide good-paying career jobs for the Maine people. Our high natural gas and electricity prices have been cited in the closing a number of mills in Maine. Rather than invest in Northeastern states, major manufacturing companies take their jobs to the Southeast, where energy costs and taxes are much lower. We

have said repeatedly that we welcome any form of energy that actually lowers the cost of energy in Maine. But we need lower costs now, not decades into the future.

Despite the objections of liberals, we have been focused on reducing energy costs. We are working with other New England governors—Democrats and Republicans—to get affordable natural gas from Pennsylvania into our region.

In May, I testified in Washington, D.C. before the House Energy and Commerce's Subcommittee on Energy and Power. I urged them to speed up the federal permitting process for producers of clean and affordable energy.

Since 2012, Mainers

have installed over 10,000 heat pumps, reducing heating costs for households and small businesses.

Since 2013, we have devoted resources to help Mainers reduce their home heating costs through incentives ranging from insulation to heating system upgrades—the first time the state has put funds toward one of our greatest energy challenges.

We have introduced a bill several times since 2011 to remove the 100-megawatt limit on hydropower, which would allow us to get inexpensive hydropower from Quebec. But politicians who are indebted to wealthy environmentalists and special interests keep rejecting it.

It makes no sense to ignore the clean and affordable energy that is available right next to us. Despite my efforts, I cannot do it alone. I need your help. If you want lower electric bills, lower home-heating costs and

better jobs, please urge your representative and senator to support common-sense efforts to get affordable energy to Maine.

## Only Steps Forward

# Auburn combines excellent healthcare with great tourism

There has been much excitement and attention given in the last week to our announcement of a project to redevelop the Lunn and Sweet Shoe Factory building on Minot Avenue, better known as "The Barn" to most around town.

While renovations of historic buildings, in particular mill spaces, is growing in Lewiston-Auburn, the notion of medical tourism is new,

and I understand that it has raised some skepticism about its potential here and how it relates to other growth plans for the city.

While I can't cover everything here, I will highlight some of the questions I've been asked and would happily field further questions from folks at the contact information at the end of my report.

Medical tourism is an emerging industry, even though it hasn't been seen yet in New England, and

often involves international travelers scheduling opportunities to visit an area of the world around securing healthcare services. Central Maine Healthcare and its various subsidiaries was an attractive quality for our region being chosen for investment.

A unique mix of service, expertise and the recent collaboration with MassGeneral made Central Maine Healthcare a key partner, and the city is thankful for the leadership

The "customers" for this facility will be predominantly successful

business people from mainland China seeking to visit Maine to enjoy its clean air, clear water and fresh, local foods.

The two Chinese businesses that signed a memorandum of understanding last week, Age Doctor Group and Miracle Enterprises LLC, intend to work together through their network of healthcare facilities and clients in China to secure travelers to the U.S. to stay at this facility. While the first proposed facility is in Auburn, the investment group envisions a network of residential facilities in Maine to serve their customers.

Why not let local investors do the project? Having sat in numerous meetings with potential downtown investors and been engaged with developers that own mill space in Lewiston, renovating historic properties is not the challenge in this case; finding tenants is. So while

local developers may have looked at that property, housing wasn't seen as a viable use.

A traditional hotel wasn't seen as viable in this market, given the recent construction of hotels in the area and challenges in financing them. The lack of significant parking limits office uses in a way the Bates Mill isn't limited because of Lewiston's long-term commitment to build structured parking.

This, of course, is no critique of local investors. They are working hard with existing projects, trying to seek a return on their capital. The Barn building is in need of a significant investment, and this proposed use is unique and adds to the mix of downtown development efforts.

Why healthcare in Lewiston-Auburn and not Boston? The customers for this facility are seeking not only access to excellent healthcare services, but also

Do you know whom the least powerful elected Lewiston city government official is? The answer may surprise you: the mayor.

Under the city charter, the duties of the mayor consists of cutting ribbons, representing the city at various functions, running city council meetings, appointing individuals to city boards and voting on issues only if a city councilor is absent.

Do you know who has the real political power in city government? It is the seven ward councilors. They set policies, tax rates, sit on various boards and perform a myriad of other duties that directly affect Lewiston and its individual wards. They are not the power behind the throne—they are the throne.

Local elections are less

than 90 days away. Unlike state and national elections, where candidates spend a year or more of bombarding you as to why you should vote for them, the lead-up to local candidates will start after Labor Day and continue until Tuesday, November 3.

In the upcoming elections, you, the voter, will determine the path that not only Lewiston will take, but also its sister city, Auburn.

The upcoming elections in Lewiston and Auburn will be between local people that have lived in the area much of their lives and have a financial and emotional stake in our cities. Compare this to the Maine People's Alliance, which is attempting to get at least a foothold in, if not take over, the government of both cities.

(Young Professionals of Lewiston and Auburn), a group formed and sponsored by the Lewiston Auburn Chamber of Commerce, will hold a candidates forum in which those running for local elected offices get to introduce themselves and field a question or two from members of the audience.

There will also be the biennial mayoral debate

between the candidates running for the Office of Mayor in Lewiston. This is televised live and is taped so it can be repeated at various times in order to give those who may have missed it a chance to view it.

It has been so long since they had a mayor's race in Auburn, I am not sure if a debate will occur in this race or be televised.

With the stakes so high in this year's coming elections, it now becomes imperative that the voters of each of the Twin City wards go to the polls and know—not think or assume—what each candidate's position on the issues are in order to make an educated choice. To make sure voters in each ward are informed on how each candidate stands on the issues important to them, I would suggest finding a location in each

ward where two separate debates would be held between the candidates of those wards.

This would give voters and candidates the opportunity to debate and define their stands on the issues important to their constituents.

a great tourism experience. For many who are leaving Chinese cities, traveling to an American city such as Boston for an extended period isn't the goal. And their choice of Central Maine Healthcare as a partner should reaffirm to area residents that we are home to a premier hospital with leading medical professionals. The investors see that.

Why would tourists from China want to visit a city like Auburn? The answer to this is two-pronged. For one, many longtime residents still can't see that Auburn—and Lewiston-Auburn—is a community with assets people want to come to enjoy: an accessible riverfront to walk along, bike along, paddle or fish along; emerging arts and cultural activities; and a growing local food businesses.

Because we are in Maine, we take for granted how clean our environment is. Many of us don't realize how much other parts of the world envy that.

And second, Auburn is a gateway city. We offer urban services, like the hospital's location, but are also very accessible to Maine's coast and mountains, all within a reasonable travel distance. Embracing that "hub" role will serve us well with this project and in the future.

There is still much to be discussed in the project timeline, including negotiating a "joint development agreement" to support public infrastructure investment that protects local taxpayers while advancing the private investment. Expect to see Auburn City Council

public workshops on this topic, and know that I am actively seeking state and other partnerships to bring non-property tax dollars to this effort.

## CMMC program on diabetes and relationships

Proper diabetes care is important, but the time, energy and resources needed to manage the disease can put a major strain on relationships. How does one effectively manage diabetes while preserving and strengthening the relationship between patient and care partner?

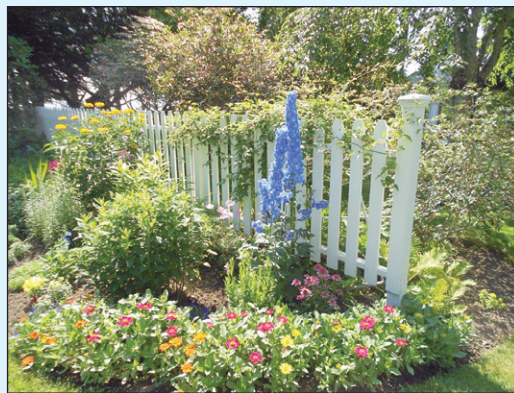

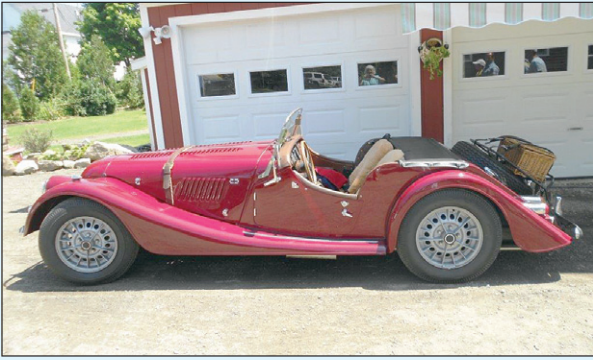

While the house was not open to visitors, we delighted in touring its extensive gardens opening to breathtaking ocean views. As indicated by the plans laid out on the patio tables, the gardens have undergone redesigns over the years, including an extensive renewal and replanting in the 1990s that exemplifies the very best of coastal Maine landscape design.

The Tranquility Garden at the 1850 ship captain's home on Sea Street revealed exquisite gardens and sculptures. The owners have spent three decades transforming the grounds into this large, contempla-

tive garden with its many “garden rooms.” Entrance to the garden is through a conservatory, striking with its floor-to-ceiling stained glass windows in pastel colors. Trees and plants that have withstood a century are now in a series of “garden rooms” with unusual flowers, bushes and trees. We found many rooms that invited lingering and meditation.

Vintage cars were a new feature at many of the houses. Also new were two historic Inns, Norumbega and Whitehall, open to the public and offering iced tea, lemonade and freshly baked cookies.

We enjoyed the history of the Alden House at Harbor Hill, where Emma Alden, the first president of the Camden Garden Club, lived when the club was founded 100 years ago. The 1855 Queen Anne house has beautiful mahogany woodwork and stenciling and is surrounded by spa-

cious, lush gardens.

Another new feature this year was the historic exhibit, on display at St. Thomas Episcopal Church, covering the club's proud 100-year history. Over the years, proceeds from the club's annual tours have funded many projects benefiting the town, including flower baskets and wreaths, lamp posts, gardens at the Public Landing, Village Green and traffic medians, flower boxes on bridges and archways, post-secondary scholarships and a special project for 2015: a refurbishing of the Village Green.

Centennial Tour Chair Ronnie Beason and her committee did an outstanding job, bringing in new features while keeping the tried and true, making the event well worth the trip.

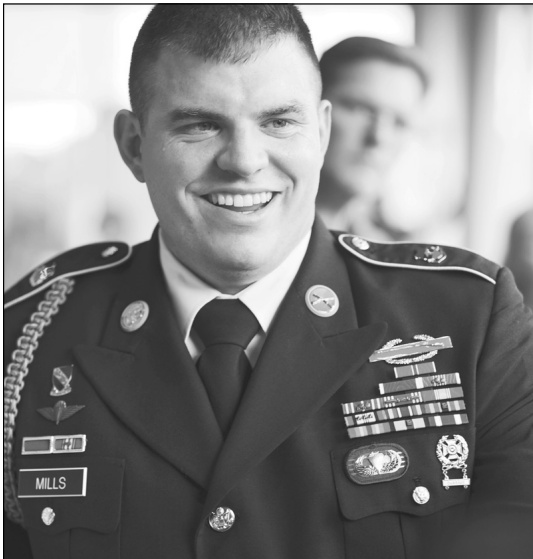

## “Soldier’s Story” to screen at Sawyer Memorial



Retired U.S. Army Staff Sergeant Travis Mills

Motivational speaker, actor, author and advocate for veterans and amputees Travis Mills will present his film “A Soldier’s Story” on Friday, August 14 at 2 and 7 p.m. at Sawyer Memorial in Greene.

On April 10, 2012, while serving on his third tour of duty in Afghanistan as a United States Army Staff Sergeant in the 82nd

Airborne Division, Mills was critically injured by an improvised explosive device, losing portions of all four of his limbs. Thanks to his strength, courage and will to live, the heroic actions of the men in his unit and the care provided by the Walter Reed Army Medical Center, he became one of only five quadruple amputees from the wars in Iraq and Afghan-

istan to survive his injuries.

While his life today continues to present many challenges, he remains on the road to recovery, astounding his friends and family with his progress and amazing spirit. In September of 2013, he founded the Travis Mills Foundation, a nonprofit organization that benefits and assists wounded and injured veterans. He has also founded the Travis Mills Group, LLC, through which he consults with and speaks to companies and organizations across the country about overcoming adversity.

His story has been featured on local and national news shows, including Fox News’ “Happening Now” with Jenna Lee and “The O’Reilly Factor” with Bill O’Reilly. His forthcoming book, “Tough as They Come,” will be on sale in bookstores on October 27. Those attending the show will receive a portion of the book at the door.

tertainment for this month’s La Rencontre on Thursday, August 13 at 11:30 a.m. at the Franco Center in Lewiston.

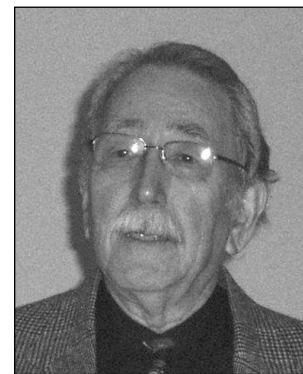

## “Memories of a Civil War Widow”

At the next meeting of the Lisbon Historical Society, Civil War historian Dr. Charles W. Plummer will discuss the memories of Lisbon Falls Civil War widow Bertha Curtis Woodbury on Wednesday, August 12 at 7 p.m. at the MTM Center.

Robert Woodbury was a Civil War veteran who served with the 29th Maine Infantry Regiment. Only 24 when she married the 68-year-old veteran in 1916, Bertha Curtis wasn’t born in Lisbon Falls until years after the Civil War ended. In spite of the difference in their ages, their marriage was a happy one and they were blessed

with the birth of a daughter.

Robert died in 1934 at the age of 86 and was laid to rest in Hillside Cemetery in Lisbon Falls. Upon his death, Bertha became one of 537

widows of Civil War veterans still living in the United States, only five of whom were left in Maine. She received a Civil War widow’s monthly check for \$70.

A favorite pastime of hers was sharing humorous stories about their marriage. “Some men are ugly, but he wasn’t,” she frequently recalled. “He’d do anything I wanted.” After living her entire life in Lisbon Falls, she died in 1983 at the age of 90 at Marcotte Nursing Home in Lewiston.

Plummer will share stories that Mrs. Woodbury enjoyed telling and will dis-

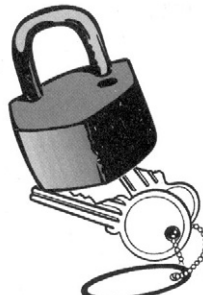

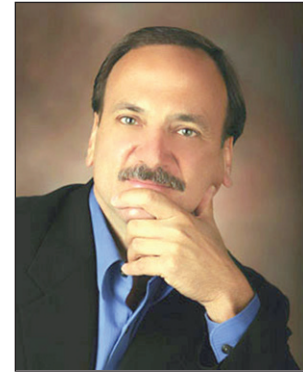

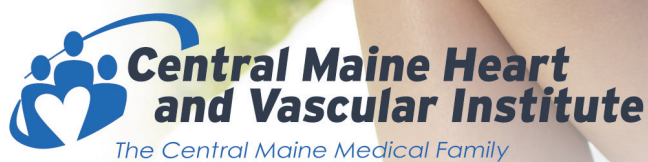
