WHAT ARE THEY WAITING FOR, SOMEBODY TO GET SHOT?

Someone once inquired how I find all the subject matter to write about in this column, which seemed like an odd thing to ask. There are so many interesting exciting things out there in the Great Outdoors it is sometimes hard to pick just one subject each week! Once in a while there is something I don't like to base my column on, like an eagle's or osprey's nest failure, the appearance of another invasive species in "our swamp," or the foolish acts of some humans. This week it *Would you feel safe driving down this road?* is one of those foolish acts on the Tonawanda



Wildlife Management Area. This problem area had been mentioned in my column at the end of this April and I was hoping that it had been removed by now but you know our representatives in Albany.

I was out on one of my evening "adventures" with my camera last Saturday evening around the Tonawanda WMA. A cruise down the Owen-Bartel Road was taken and as the public shooting ranges came into view it was noticed that the first one had a bunch of young guys standing around with guns. There were seven vehicles parked in the area with one pickup actually parked in the road with no one in it. Nothing really unusual; many time vehicles are left parked half off the road by irresponsible shooters in this area. It is also not unusual to have a semi-automatic rifle or shotgun blasting off 20 feet off the road as you drive by.

As the next three ranges were passed a father was seen teaching his son how to shoot and the other two had individuals target shooting that seemed to be shooting responsibly. This is not often the case as it is not uncommon to see rifles or shotguns leaning against vehicles, individuals just "wahoo shooting" and acting in a dangerous matter with their guns. In fact a quick look at ALL the road signs on this road tells you many of these folks using the shooting ranges are acting in very irresponsible ways other than shooting down range into the backstop mounds.

Just before the Ditch Road was reached I heard and then saw a Niagara County Sheriff vehicle turn on to the Owen-Bartel Road with lights flashing. After he went by I turned around and headed back to see what was going on, fearing something bad had happened at the ranges. Sure enough right where all the vehicles and young guys had been there sat the Deputy's vehicle with lights still flashing. Pulling over near by it could be seen that someone was down on the ground and the others surrounding him. Apparently a individual stabbed himself in the leg and a paramedic was administering first aid and a medevac chopper was on its way. How the heck does a person stab himself so bad that he needs to be transported by chopper to a hospital? Stupid is just stupid I guess, but remember these guys were there with guns to shoot!

Sooner or later someone is going to get shot with all the stupid weapon mentality in this area. With the road signs in this area being all shot up it has been a wonder no one driving down this road or out hiking on the wildlife management area hasn't been shot by these jokers. The road shoulders are also being "dug up" with immature idiots who find it a challenge to drive into a big mud hole, which of course causes another hazard for other drivers. I travel this road a lot on my evening "adventures" and it always amazes how I never see any law enforcement personnel in this area. Maybe if there were this wouldn't be such a problem.

As mentioned in my 4-30-2017 column there has been a push to get these ranges shut down before someone gets hurt or killed. Everyone is for this to happen, so what is the problem? Guess what - the folks in Albany are dragging their butts again. Well, now we have an accident and I wonder how long before someone gets killed? Maybe it won't be the shooter, maybe it will be a hiker, birder or DEC worker in the nearby marshes, or a mother and her children who just happens to be driving down the road at the wrong time. Maybe everyone who uses this State Wildlife Management Area should drop a line to our DEC Commissioner Basil Seggos (basil.seggos@dec.ny.gov) and Senator Ortt (ortt@nysenate.gov) and express their feelings on this problem before someone does get killed.

Spice Things Up at Your Next Picnic

Picnics are often pot luck affairs. While standard picnic fare like potato salad and watermelon are always welcome, spicing things up with something new can make picnics that much more memorable.

The following recipe for "Sunday Picnic Deviled Eggs" from Neal Corman and Chris Peterson's "Virgil's Barbecue Road Trip Cookbook" (St. Martin's Press) is fairly spicy and can provide a little extra kick at your next picnic.





Sunday Picnic Deviled Eggs Serves 4 to 6 8 extra-large eggs ■ 1/4 cup mayonnaise 1 teaspoon Creole mustard ■ 1/4 teaspoon hot sauce ■ 1/4 teaspoon ground cumin 1/2 teaspoon kosher salt 1/4 teaspoon cracked black pepper 2 teaspoons finely chopped pickled jalapeño slices 1 teaspoon pickled jalapeño juice 1/2 Hass avocado, peeled and pitted Pinch of smoked paprika 1 tablespoon chopped fresh cilantro 2 ounces dried Spanish chorizo

1. Place the eggs in a medium pot and cover with cold water. Bring to a boil, cover the pot and remove from the heat. Keep covered for 11 minutes, then remove the eggs from the water and place in a bowl of ice water to stop the cooking process.

2. Preheat a sauté pan. Cut the chorizo into very small dice and sauté until crispy. Set aside to cool.

3. In a small bowl, combine the mayonnaise, mustard, hot sauce, cumin, salt, pepper, I jalapeño, and jalapeño juice.
