





## AFRICAN-AMERICANS TAKE THE REINS OF LEADERSHIP IN NORTH CAROLINA

If the local elections of November 2017 in North Carolina will be remembered for anything in history, it will be for the number of African-Americans who were elected to positions of leadership in at least three cities, and the county commission of the State's capital county.

Three of the four newly elected Black officials were sworn in Monday night in their respective cities and counties. Their victories are generally being seen as a significant step forward for African-Americans statewide.

If there is a perceived "star" in the group, it is

Charlotte Mayor Vi Lyles, the first African-American woman to lead the Queen City in its history.

"I want to be known as the

best mayor to create opportunity for all of us," Mayor Lyles told a packed City Council chamber moments after she took the oath of

office.

### Upperman Center hosts silent auction to support students

The Upperman African American Cultural Center will host a silent auction on Monday, Dec. 11 to raise funds for the Upperman Trust to support students.

The exhibit showcases the photography talent of Venita Jenkins, a content and communications specialist in the UNCW Office of University Relations. She captured the dynamic, colorful sunrises presented in "My Lord, What a Morning!" along the coastline and waterways of New Hanover County, which is a part of the Gullah Geechee corridor. The exhibit serves as the introduction to the Upperman Center's theme for the

year, "A People by the Sea." Jenkins donated her images to the Upperman Center for inclusion in the auction.

Jenkins, a passionate amateur photographer, hopes the exhibit encourages viewers to see each day through a lens of opportunity.

Governor, GOP legislative leaders not responding to NCNAACP invite to meet

It has been a week since The Reverend Dr. T. Anthony Spearman, President of the NCNAACP, sent a Nov. 27 letter to Gov. Roy Cooper, Speaker of the NC House Tim Moore, Pres. Pro tem of the NC Senate, Phil Berger, and NC Chief Justice Mark Martin, requesting a meeting to discuss "...seeking new approaches to overhaul the criminal justice system....and explore other issues our members are concerned about."

"Today, while our Nation and State are in the midst of great political turbulence, caused at least in part by racist voting and criminal justice policies and practices, there is a great need for honest political leaders to speak directly with each other and listen carefully across the table of civility," Dr. Spearman wrote.

Bishop William J. Barber, President, Repairers of the Breach, a national social justice organization, and Co-chair of the Poor People's Campaign: A National Call for a Moral Revival, announced Monday that, for 40 days, starting on Mother's Day,

May 13, 2018, there will be "...a season of direct action civil disobedience and voter registration power building...."

There's little doubt that Lyles comes to the job prepared and ready. She's spent the most of the last 30 years working in the City's budget office, also serving as an assistant budget manager. For the past several years, Lyles has served on the council, where she became a voice for low-income neighborhoods seeking better economic opportunities.

"I'm anxious to serve as your instrument of change," the new mayor told those gathered Monday evening.

In Kinston, not only did cit-

izens in November vote to elect a new African-American mayor, but remarkably voted in an all-African-American City Council.

On Monday night, new Kinston mayor, Dontario Hardy, was sworn-in by NC Associate Supreme Court Justice Cheri Beasley, along with the rest of the six-member Kinston City Council.

"I stand before you, filled with great joy, and as a beneficiary of the vote of the people," Mayor Hardy told yet another packed City Council room.

"I stand here today to say, as mayor, I am more than your leader. I'm your leader with a servant's heart," Hardy, whose

November upset of veteran popular incumbent, Mayor B.J. Murphy, was a true surprise, added.

Hardy is the second Black mayor in Kinston's history. Johnnie Mosley was the first, serving two terms in the early 2000's.

The third Black NC mayor who was elected last November, Fayetteville City Councilman Mitch Colvin, will be sworn in next council meeting. Monday night, Colvin watched as his colleagues bade farewell to outgoing Mayor Nat Robertson, who gave keys to the city to council members with whom he served, and wished Colvin, who defeated him, well.

the NCNAACP, nothing has come by way of a response.

What the new NCNAACP president is asking for is not unusual. On the national level, presidents, both Democrats and Republicans, have been meeting with civil rights leaders for decades. President Kennedy met with Dr. Martin Luther King, Jr., Whitney M. Young, of the NAACP, and other Black leaders of the 60's civil rights leadership. So did President Lyndon B. Johnson.

On the Republican side, Dr. King met with President Dwight D. Eisenhower, while

Mayor-elect Colvin, in turn, gave Mayor Robertson a key to the city.

"We have had our differences publicly and privately, but for the most part, we knew our intentions were the same and that was what was in the best interest of the city," Colvin told Robertson, as the audience applauded.

Finally, a year ago, she actually resigned from the Wake County Board of Commissioners, frustrated with the lack of board progress on issues she felt were important to the citizenry. A day later, supporters convinced her to rescind her resignation.

Monday night, Wake

Commissioner Jessica Holmes was unanimously elected by her colleagues as the new chairwoman of the board for the next year. Nominated by the outgoing chair, Sig Hutchinson, who will now serve as her vice chairman, Holmes becomes the youngest African-American woman ever to chair the Wake County Board of Commissioners and only the fourth to ever serve.

"Sometimes leaders lead from the front, and sometimes leaders lift up other leaders," the Pender County native and UNC - Chapel Hill Law School alumna said. "I thank you for that opportunity today to lead this board."

At his Nov. 27 press conference at the NCNAACP's new headquarters in Raleigh, Dr. Spearman was asked what will he do if Dec. 15 comes and he still gets no answer from the "leaders of ....NC government."

"We are hopeful that we will get a response to our letter by the 15th of December; but...you can mark me by this, that if we do not receive anything, we are geared up to move forward, as we have been doing, to do rallies, whatever needs to be done, for such a time as this," Dr. Spearman vowed.

Collectively addressing them as the "...leaders of three co-equal branches of NC government," Dr. Spearman did give them until Dec. 15 to either call the NCNAACP office or contact him to respond "if you are open to such discussions..." but as of Dec. 5, according to Spearman, it's been crickets. None of the principals have replied.

Apparently, neither the governor, House speaker,

Senate president pro tem nor the chief justice of the NC Supreme Court, wants any part of a sit-down meeting with the NCNAACP. On the same day of Dr. Spearman's press conference, announcing his willingness to meet and releasing the letter he wrote to them, this reporter sent an email to everyone except Chief Justice Martin, asking if they would be willing to meet with the NCNAACP to discuss serious issues affecting the community.

They had until Friday, Dec. 1, to respond to the press request, but thus far, as with

geous, fusion long-term, agenda-based movement, rooted in nonviolent direct action and voter mobilization. We will stand for a third reconstruction."

Just back from an international conference at the Vatican in Rome Thanksgiving week, where the focus was on speaking out on issues affecting the poor and working poor, Bishop Barber also assured that the movement for which he's calling falls right in line with the message of Pope Francis.

"With fierce determination and revolutionary love, we commit to fill the legislatures of this land with a cry for love and justice. We are committing to put our bodies on the line to save democracy and reconstruct America." Speaking from Washington, DC Monday, near the US Capitol, Dr. Barber, surrounded by supporters and fellow activists, went on to state that twenty-five states, including North Carolina, will be the focus of the nonviolent "direct action" against poverty, systematic racism, expenditures on war and ecological destruction.

Many observers liken the Moral Revival for which Dr. Barber is calling next year to the memorable Moral Monday demonstrations he led as President of the NCNAACP in 2013, when thousands of demonstrators from across North Carolina came to Raleigh to protest

what they felt were repressive policies from the Republican-led State legislature in 2013.

Approximately 1,000 demonstrators were arrested, but they ultimately inspired similar protests across the country, and as Dr. Barber recently found out during the Vatican conference, even around the world.

After twelve years, Barber stepped down from NCNAACP leadership in October, though he is still a member of the Executive Committee. As Co-chair of the Poor People's Campaign, Barber is now traveling the nation, recognized as a national civil rights leader, preparing for the fiftieth anniversary of Dr. Martin Luther King, Jr.'s 1968 Poor People's Campaign.

"And now, if anything, with the new [Trump] administration, we have seen extremism and policy violence towards the poor go on steroids," Bishop Barber said Monday. "Extremists who've hijacked the Republican Party are pushing tax cuts for the super rich at the expense of the poorest among us."

"The President continues to loudly pit us against one another while quietly deconstructing the government he swore to protect," Barber continued.

"This campaign is about America's hearing the cry of the poorest among us."

"Our problem isn't that we don't have enough money," Dr. Barber continued. "It's that we don't have the moral capacity to face what ails our democracy."

**FAMILY OF HUNG BLACK TEEN FIGHT TO GET HIS BELONGINGS BACK**

[BLADENBORO] The family of a black teenager whose body was found hanging from an outdoor swing set, which was investigated by federal authorities, but determined not to involve foul play, say they are getting the runaround from Bladen County authorities who apparently have not given back the teen's belongings. The teen, 17-year-old Lennon Lacy, was found dead in August of 2014. An attorney for Lacy's family says the Bladen County district attorney is not cooperating, but the DA counters that he's asked for a list of the items to be returned, but so far the family has not complied. The attorney, Mohammad Shyllon, says a list isn't possible because only authorities know what Lennon was wearing when he was found hanging. At press time, the two sides were still at a stalemate.

**UNC CENTER FOR CIVIL RIGHTS BREAKING AWAY FROM UNIVERSITY**

[CHAPEL HILL] THE UNC Center for Civil Rights, founded by late civil rights attorney Julius Chambers, has decided to move away from the UNC System and operate independently in the aftermath of the all-Republican UNC Board of Governors halting its legal work, and the staff attorneys being terminated recently months ahead of schedule.

Attorneys Mark Dorosin and Elizabeth Haddix were terminated Nov. 30th. However, they have renamed the non-profit law firm after Chambers, and will continue to represent poor people, and accept law school interns.

**NCNAACP BLASTS PASSAGE OF SENATE TAX BILL**

[RALEIGH] The NCNAACP is pleased at all with passage of the Senate tax reform plan. "The bill is a scam and a sham," the civil rights organization said. "To reform something means to improve it. The bill improves the lives of the ultra-wealthy, and of the massive corporations who have funded the campaigns of many who occupy seats in the government. As has been proven by the current North Carolina Jim Crow super-majority legislature, when legislation is rushed through, 'rammed through' as reported in the Washington Post, giving lawmakers and experts little or no time to review the contents, its results are devastating for The People-Of, By, and For whom the government exists. In the law, deliberately concealing facts is *prima facie* evidence of fraud." COMPILED BY CASH MICHAELS

### The American plutocracy gets tts immoral tax bill

**"**I tremble for my country when I reflect that God is just: that his justice cannot sleep forever." Thomas Jefferson said that about slavery, but he might well have been talking about what is now happening in Donald Trump's Washington.

Republicans are putting the finishing touches on a tax bill that takes from the poor to give to the rich. Then they plan to turn to savaging federal programs for the poor to make up for the deficits they've created.

Millions of vulnerable Americans will suffer for their greed and their folly. The tax bill — cobbled together in secret meetings without a public hearing, passed with handwritten amendments in the columns, legislators forced to vote without reading it — is simply a disgrace.

According to the nonpartisan Congressional Budget Office, lower-income people will end paying \$5.3 billion more in taxes, while those earning \$1 million or more will

pay \$5.8 billion less. The Tax Policy Center reports that nearly the top 1 percent will pocket two-thirds of its tax breaks. Ten years from now, when all the measures kick in, those earning \$75,000 or less per year will end up paying on average more in taxes.

This is a brazen expression of money power, as the St. Louis Post-Dispatch put it, an example of American plutocracy — a government of the wealthy by the wealthy, for the wealthy. The vulnerable will suffer the costs. An estimated 13 million will lose health insurance. Those workers who get their insurance in the state exchanges will be hit with 10 percent increases in rates or more. Graduate students will be faced with massive tax hits, as the bill taxes tuition that universities waive (money that the students have never seen). Ten million low-income parents will be stripped of the child tax credit.

This while the top one-tenth of 1 percent, who make over \$4.5 million a year, pocket an average tax cut of \$127,000. The plunder has become immoral. Now, the Republican Congress will turn to savaging programs for the poor to help pay for the tax cuts. Next "we're going to go into welfare reform," Donald Trump threatened at a rally last week. Sen. Marco

Kelley, for example, is in his late 40s.

That pledge seems no longer operative. He promised a health care plan for "everyone." Not true. He said

Rubio reassured business leaders not to worry about deficits; the next step will be "reducing spending."

That will mean instituting structural changes to Social Security and Medicare for the future." The House Republican Budget Resolution makes their priorities clear. It projects 40 percent cuts in programs for low- and moderate-income Americans by 2026. This includes cuts in Medicare, which will be turned into a voucher, losing value over time; more than \$1 trillion in cuts from traditional Medicaid; and 30 percent cuts in food stamps, leaving millions without food assistance.

Hit hard will be Pell Grants that help low-income students pay for college, child nutrition assistance for the very vulnerable and SSI benefits for the disabled and impoverished elderly. Domestic services — everything from education to transportation — will be cut. Spending on low-income programs is already as low as a percentage of the economy as it was in 1970. Trump, of course, pledged that he would not cut Social Security and Medicare during the campaign.

That pledge seems no longer operative. He promised a health care plan for "everyone." Not true. He said

the rich would not benefit from the tax cuts. Not true. He said that he would not benefit. A lie. Republicans claim the tax cuts will produce growth and jobs. They claim the spending cuts will reduce deficits and help sustain growth. These are but excuses for the immoral. The moral calculus is clear. We will be judged, the Bible says, by how we treat "the least of these."

In Isaiah 10:1-3, it is written: "Woe to those who make unjust laws, to those who issue oppressive decrees, to deprive the poor of their rights and withhold justice from the oppressed of my people, making widows their prey and robbing the fatherless. What will you do on the day of reckoning, when disaster comes from afar? To whom will you run for help? Where will you leave your riches?" But politicians respond not to what is moral but to what is popular. What will be the reckoning at the polls? Will Americans fall for the smoke and distractions? Or will they vote in large numbers against those who impose this folly? Only a political reckoning will curb the damage that is being done to this country.

### The Trump trick bag

**T**wo people reported to work at the Consumer Financial Protection Bureau on November 27, both expecting to lead the bureau. Leandra English, who had been chief of



staff to former Director Richard Cordray (he resigned before Thanksgiving to return to Ohio to run for governor), was appointed to the director position by her old boss.

Simultaneously, 45 appointed Mick Mulvaney, head of the Office of Management and Budget, to hold the job. Reportedly, Mulvaney arrived at the office bright and early Monday morning, carrying a bag of donuts. Both Mulvaney and English sent memos to the entire staff asserting their leadership. Mulvaney rolled his sleeves up and got to work at an agency he had previously ridiculed. English headed to court to assert the right to her job.

Now, here comes the trick bag. Leandra English found herself in Judge Timothy

Kelly's courtroom. The judge, in the US District Court, was appointed by 45. Is there any coincidence that English did not prevail in her suit? Mulvaney is right when he says that anyone who expected the Consumer Financial Protection Bureau to operate the same way under 45 as it did under President Obama. "Elections have consequence," he crowed. With that smug bragging, he illustrates why other relatively (I use the word advisedly) principled Republicans put up with 45 and his antics.

While too many of us are focused on 45's foolish antics, flippant verbal attacks, and downright dangerous international behavior, the "Buffoon-in-Chief" and the Senate are quietly packing the courts. 45 is moving faster than President Obama, Bush, Clinton, and Bush have, with as many as 200 positions already filled. Further, 45 is appointing younger and more conservative jurists than ever before. Kelley, for example, is in his late 40s.

The Consumer Financial Protection Bureau was established by the Dodd Frank legislation of 2010, the Congressional reaction to the horrible abuses that banks engaged in to cause the Great

Recession. It regulates the rules relating to mortgages, credit cards, insurance, and other financial instruments. It is the only agency that stands in the gap for consumers, the only one that has the ability to stand up to banks and force them to be responsible. In its short existence, tens of millions of dollars have been returned to consumers, and thousands of bad actors have been ousted on the CFPB web page.

The election of 45 put this agency's integrity in jeopardy because his election was the triumph of predatory capitalism. While 45 swore he was for the working class, which was campaign mumbo-jumbo. Instead, he always planned to gut the agency that was unpopular with Congressional Republicans, and the preponderance of bankers in his cabinet certainly guarantees the agency's destruction. But the court's swift finding against Leandra English reminds us that we can expect to find the tenets of predatory capitalism and consumer exploitation to be upheld by these newly packed courts.

Court appointments have generated little attention. On at least one occasion, the American Bar Association has described a nominee as "unqualified", something that

they rarely do. On another occasion a man who has a law degree but who has never tried a case was nominated as a judge. Really? Less than political patronage, 45 is systematically presiding over a massive ideological shift in our nation. It's a trick bag, one that many did not anticipate.

Consumers who care about the protections we need against big banks and credit card companies need to write their elected representatives and urge them to strengthen the legislation that authorized the CFPB. And, progressive lawyers must pay more attention to these flawed judicial appointments that 45 is making. These are absolutely frightening times, with 45 running amok at the People's House at 1600 Pennsylvania Avenue. He is running amok, and his foolishness is guaranteed to generate commentary and revulsion. But we can't be so absorbed by the foolishness that we ignore what he is doing with the courts.

## It's about the power

If not before, by now, we all have an elementary understanding of Sexual Harassment, but how far must we look back to find a cause or reason for acts of Sexual Harassment? Going back, can we stop at the Women's Lib Movement? Or, can we begin our examination with the Suffragettes? Is it more correct for us to reach back to the Founding Fathers and inquire as to why women were not referenced in the Constitution and why the rights and privileges of citizenship were not conferred therein? Even white women had to fight for the right to vote, and the men preventing them from voting were their fathers, brothers, grandfathers, uncles, husbands, etc! Still many of these are men who are opposed to the Equal Rights Amendment for women!

While it's common to see the TV Talking Heads expressing shock and dismay related to the increasing reports of Sexual Harassment, I haven't heard one give, what I believe to be, an honest determination of cause. Most will agree that the acts signal a use of power; but I've heard none use the word CHATTEL.

Throughout the history of western civilization, women have held a subordinate social position to men. Until the 1940's, married women in America were assigned to work in the home. Although there was work for single women, they were encouraged to marry and take their place in the home. Accordingly, men assumed responsibility for household and family decisions, and for initiating sex. It was considered permissible, even required, for men to beat their wives "to show their love." Give me a break! This gender dominance carried over to the workplace and Sexual Harassment was the ultimate result.

Roy Moore's violation of juvenile females was more criminal in nature than others that have been reported. Verbally suggestive language can be Sexual Harassment, but injurious physical contact elevates the violation to another level.

**WE NEED STANDARDS:** As with the existing uniform structure between them, Federal, state and local governments should establish simplified uniform policies regarding the adjudication of complaints of Sexual Harassment. Private sector protections should be established under the EEOC or state provisions. When people know better, they're charged with doing better.

I have numerous nieces, sisters and female friends. I want them to have equal opportunity to work in any area they choose and feel that they can do so without fear of sexual harassment, sexual abuse or sexual discrimination. No one who prevents them from doing so should get a pass—not even #45.

I'll be 62 in four weeks).

So, here's Part Two of my testimony, and hopefully you'll find something in it to help your rescue not only your health, but your spirit, too!

Earlier today as I was preparing to go to the gym for my daily workout, a biblical phrase kept ringing in my head.

(I'm paraphrasing) "your body is a temple."

To me, this means that our bodies, the living, breathing, heart-beating, blood-flowing shells our human spirits live and work in, are temples for GOD, and specifically the Holy Spirit to live in. Thus, they are NOT meant for us to abuse in anyway.

And yet, we ALL do, because our temples (bodies) are also where our hopes, hurts, dreams, sadness, joy, ambitions, love, pain...pain...PAIN...also reside.

So, in reaction to ALL of that which resides in us, and more, we either consciously, or unconsciously, abuse ourselves, assuming that we can handle it, and will still live to see another day.

It's only after we learn that we have high blood pressure, or diabetes, or a heart attack, or even cancer, that we realize

Let me sit down at the table...or worse yet, in front to the TV set, with all of that in front of me, and I...WAS...IN...HEAVEN! Didn't care about the aftermath, or what that kind of destructive eating would ultimately cost me...I was IN THE MOMENT, and that's all that mattered.

And I artfully justified it...dealing with stress, problems, anger, fear, anxiety, fractured love, tension....whatever. Bad food was emotional "medicine," I thought, and it was my own, personal way of coping, so "mind your own damn business!"

Yeah, but eventually, "...my own damn business" became very SERIOUS business.

## The Christmas gift of no more tears

*"I saw the helpless Cherokee arrested and dragged from their homes, and driven at bayonet point ...The sufferings of the Cherokees were awful, the trail of the exiles was a trail of death."*

**S**o wrote Private John Burnett, one of 7,000 soldiers accompanying the 16,000 Cherokee Indians

on their forced march from the southeastern United States to the eastern half of Oklahoma a designated Indian Territory. "Nun-na daul Isun-yi" the Cherokee called it, "the trail where they cried," the Trail of Tears.

From May 1838 to March 1839 an estimated 4,000 died on that journey. My maternal grandfather, born in 1890 in Indian Territory, grew up with aged relatives who made that forced march, one of whom bore the scar of an impatient soldier's bayonet because she wasn't walking fast enough.

What Private Burnett didn't mention in his diary was the presence of some 2,000 African slaves owned by Cherokee who also endured this harsh and merciless walk, whose descendants are today known as the Cherokee Freedmen.

Thus theirs is a collective history and a shared tragedy, the tears of African slaves and Cherokee Indians indistin-

guishable in composition and cause. For the Cherokee it was a new and unknown experience of removal and relocation, but for their African slaves it was a repeat of their own history of the Middle Passage from Africa to America marked by tears of grief, fear and pain of multiple kinds.

Very few records exist of the Middle Passage from the experience of a slave, but one, written by Olaudah Equiano, a Nigerian transported to Virginia in the 18th century, gives us a glimpse into that tear-stained journey:

"I was soon put under the decks, and here I received such a salutation in my nostrils as I had never experienced in my life: so that, with the loath-someness of the stench, and crying together, I became so sick and low that I was not able to eat."

The Cherokees, the most Christianized of all Native American tribes, sang hymns on their Trail of Tears". One sung more than any other was written by John Newton, who until his conversion to Christ made his living transporting human cargo from the coast of West Africa to feed the slave trade.

The most familiar and popular hymn in the English speaking world today, Amazing Grace came from the pen of a man responsible for the shedding of countless tears of those transported and those left behind.

While conveying a message about a personal, life-changing

experience with God's amazing grace, one verse in particular testified for both Cherokees and their African slaves to a shared faith in God's grace as both a saving grace and a keeping grace on their horrific journey of removal and relocation.

*Thru many dangers, toils and snares, I have already come;*

*Tis grace hath brought me safe thus far; and grace will lead me home*

While none of us have endured the Trail of Tears or the Middle Passage, there is a trail of tears that runs through every life, tears shed over the loss of a loved one, tears shed over a family member destroying themselves through wrong choices, tears shed over marriages that have known betrayal and failure, tears over chronic illnesses and pain, tears over what others have done to us and tears over what we have done to ourselves. No one escapes the shedding of tears.

The Christmas narratives in Scripture conclude with an oft neglected portion involving the Wise Men - and tears.

Being warned by God in a dream not to return to Herod who wanted to know where this new born King could be found, they returned home by another route. Enraged, Herod ordered the slaughter of all baby boys up to two years of age, a direct response to the manger scene of that first Christmas, fulfilling a painful prophecy from Jeremiah:

"A voice is heard in Ramah, weeping and great mourning,

Rachel weeping for her children and refusing to be comforted, because they are no more."

And so today Christmas is a time of looking backward and remembering those who 'are no more' and tears are shed. But it is also when we look forward to a time when, in the words of the prophet Isaiah often read during Advent, "The Sovereign Lord will wipe away the tears from all faces."

It is a trustworthy promise from God's trustworthy Word in the Book of Revelation, a promise which will touch all human tears, from the tears of the mothers of Ramah to the tears of the millions traversing the Middle Passage to those on the Trail of Tears to our own tears from our past to our present, that as we celebrate His first Advent someday earth will experience the Second Advent of Jesus Christ, and then it will be that "God will wipe every tear from their eyes. There will be no more death or mourning or crying or pain, for the old order of things has passed away." God's Christmas gift of no more tears.

## CRAZY FAITH MINISTRIES On using God's name in vain

**I**t has been spectacular and disturbing to watch Roy Moore, Republican candidate for Senator in the state of Alabama, navigate and manipulate religion for his own purposes.

Moore, accused of sexual misconduct against at least nine women, some of whom were teens when the alleged assault, has taken to defending himself on "moral" grounds," saying that he represents "Christian values." God is against the policies and beliefs of "the liberals" and "the socialists," he says, and even challenged late night show host Jimmy Kimmel to a fight over "Christian values," a challenge Kimmel accepted with enthusiasm.

Some supporters are making him the victim, saying that he is being attacked because he is a Christian. It is a charge which is as sickening as it is inaccurate.

Whose Christian values is he representing? To what "Christ" is he referring?

What has happened in this country and all over the world since the time of Jesus' life here on earth is an appropriation of what Jesus stood for and taught. Wes Howard-Brook, in his book Empire Baptized: How the Church Embraced What Jesus Rejected, 2nd-5th Centuries, clearly argues that the "religion of empire," which the world practices for the most part today, was from the beginning different from the "religion of creation," which Jesus taught.

"Christianity" as we know it today, says Howard-Brook, a state religion, was "almost the exact opposite in nearly every respect from what Jesus had proclaimed and for which he was killed." Early Christian writers, including Origen and Clement and Tertullian, among others, "generated a Christianity that almost completely inverted the gospel of Jesus."

Evangelicals have had a history of using Christianity to sanction their cultural beliefs and desires. What Southern Christians, and Christians from the North as well, were most interested in was preserving their "way of doing things." White supremacist beliefs made them adhere to a belief in the rightness of segregation and discrimination against people of color. In the name of the Christianity which they practiced, they worked hard to preserve the "Closed Society" of the South. Blacks were not welcome and God, they said, made that clear in the Scriptures.

To go against those who believed in white supremacy, then was to go against God. Christian values included buy-in into racism, and indeed sexism. The Constitution protected wealthy, white, male Protestants. In the belief system of early American Christians, only those people were fully human; blacks, Native Americans, women and other non-white, non-Christians, were not fully human and therefore not eligible for freedom or dignity or respect.

That Roy Moore is acting like a victim is problematic, but the fact that he is couching his racism and sexism in a so-called adherence to "Christian values" crosses a boundary that has for too long been accepted.

God, the father/parent of us all, was not a bigot and neither was God's son, Jesus.

Jesus taught that all people were worthy of love and acceptance, forgiveness, grace and mercy. Moore has been using the language of the "religion of empire," as he has said that the enemy is the "Liberals," and the belief of too many in equal rights for LGBTG individuals, for Muslims and immigrants. He has vilified those whose beliefs are different than is and which seem, for the most part, more in line with the words found in the Gospel, as "the enemy."

He pushes a theology of separation, bigotry, sexism, xenophobia, Islamophobia and more. He is of the ilk who believe that "freedom of religion" only applies to Christians, since, he erroneously believes, Christians were the only religion in the land at the time of the writing of the Constitution.

His religion is cultural relativism, far removed from the words spoken by Jesus in the Gospel that says that those who love God must love, protect and take care of "the least of these."


In the name of Christianity, "Christian values" of many whites sought to justify segregation, calculating everything that happened "in this life to give advantage to white people and to saddle blacks with corresponding and unyielding disadvantages," said Carolyn Renee Dupont in her book, Mississippi Praying: Southern White Evangelicals and the Civil Rights Movement, 1945-1975. Religion then and religion now - specifically Christianity - was used and is still being used to engage in behavior which is a far departure from what Jesus taught and from what dignity for all would look like.

It is abominable that Moore is denying his alleged pedophilia by acting like a wronged man of God, and it is even more abominable that people are falling for the hype. In the Decalogue, it clearly states that we who believe in God are not to use God's name in vain. My mother would say that any time one lies about someone - or lies on or about God - that that person is using another's name in vain, or in the case of manipulating God's words for our own purposes, using God's name in vain.

Roy Moore is an insult to decency; this Congress and the evangelical Christian community are an insult to decency as well. The God of us all must be weeping as this masquerade goes on, threatening to cast this country deeper into a maelstrom of destruction in which it is now swirling.

## Old memories of traveling

**M**y first memories of traveling by Greyhound Bus Lines go back to the year of 1947, when I experienced my first trip from Wilmington, North Carolina to Swedesboro, New Jersey. I remember that I had to have my ticket ready, and my luggage was securely stored in the proper place for safety reasons.

I can remember that the bus made stops all along the way to discharge some passengers and take on others and to exchange drivers. Since the trip took several hours, I took the opportunity to sleep "on and off."

I traveled with one of my aunts, who, even though those were days of hardship, was a person of strong faith that brought much hope. She felt we would be successful in finding work on the asparagus farms and peach orchard/plantations. We needed the money to buy food and

other necessities, as well as to save to help us return to North Carolina. This was an experience I will remember for a long time.

There is another trip which I will long remember. This was the first trip I ever took to Baltimore, Maryland. This trip was also made by bus, and I recall it with fondness. I remember the smile I had on my face as I traveled. I remember looking the crowd over, and other Blacks who were also headed to where they believed they would find better life with greater opportunities. It was easy to reach out to those around us and be friendly to those with whom we came into contact. I was excited to be able to pass the time of day with those sitting near me on the bus.

I remember that the bus stopped at a bus station in Richmond, Virginia, and, in that bus station, there were homeless persons, trying to keep warm. It made a great impression on me as I watched a night watchman putting these homeless persons out into the cold. I thought to myself how great it would be if there were help available for these people.

When I arrived in Baltimore, Maryland, I was greeted by the Bostic family. They made sure I was made comfortable and was afforded the proper rest. They also made sure that I attended religious services and engaged in religious activities at First Christian Community Baptist church. It was here where I was always greeted and embraced with lots of love. We enjoyed going shopping, bowling, and spending time with young people. It was a plus for young people to have good, respectful, and respectable behavior, especially in the Bostic family. Good behavior is a trait which has run through all the generations of the family and continues to grow. The seed has been planted by the earliest generations and been cultivated by the generations which have followed.

Verniece E. Stanley is a native of Brunswick County. She grew up on a farm but wanted more excitement in life. She graduated from high school in Brunswick County in 1948 and graduated from Fayetteville State Teachers' College in 1952. She taught school in Brunswick County for nine years. She moved to Baltimore, Maryland, married, and taught school for twenty-five more years. She received her master's degree from Morgan State College in Baltimore City. She retired and moved back to Bolivia, N.C. where she enjoys writing articles for The Wilmington Journal and is an active member of the NAACP Board.

When I left Trenton, New Jersey, I was glad to return home to Bolivia, North Carolina. When I think of folks I met while in other places, particularly senior citizens, I am reminded how much they are really like my friends at home. It's good to know that, wherever we travel, warm, close friendships can always be a part of our lives.

Eventually, I was excited to be able to travel to Trenton, New Jersey, where I learned to love like home. It was a less-than-three-hour trip from Baltimore, and, while in Trenton, I was privileged to be involved with a special program to assist low income families and homeless people.


