

CHARLOTTE CLERGY: END SOLITARY CONFINEMENT

The NC American Civil Liberties Union said it amounted to "torture" two years ago.

Before he left office, President Obama outlawed the practice when it came to youth offenders being held in federal custody.

Even the State of North Carolina has indicated that it would limit the practice in its prisons after it was determined that some targeted inmates had spent upwards of a decade in detained isolation.

Yet, law enforcement officials maintain that placing prisoners in solitary confinement in local county jails, is an invaluable tool to maintain safety and order in unpredictable inmate populations.

"Charlotte faith leaders have received multiple firsthand reports of mistreatment by jail staff," charged Rev. Samantha Barbee, representing the Charlotte Clergy Coalition for Justice, opening a press conference of clergy and former inmates on May 3, in front of the


Senior Briauna Daye leaves legacy at UNCW

Two months ago, BriAuna Daye was in a head-on collision that resulted in a broken femur and hip. There was doubt that she would be able to finish her final semester at UNCW, but with drive and determination, Daye was among the Seahawks who walked across the stage during commencement on May 5.

"I was sending emails from my hospital bed because I was so close [to graduating]," she said. "I prayed to God that this hurdle that felt like a wall wouldn't keep me from reaching the goals I set for myself this semester, and now I find myself in a position where I conquered every hurdle that

With many proud, happy African-American families coming together to celebrate graduations from several of North Carolina's finest historically Black colleges and universities this month like NC A&T University in Greensboro and North Carolina Central University in Durham, the last thing anyone will be thinking about is how much debt he or she owes after four years of higher education.

However, according to a just released report, he or she probably should.

The report, "Racial Disparities in Student Loan Debt and the Reproduction of the Fragile Black Middle Class," by Jason N. Houle and Fenaba Addo, at the Center for Demography and Ecology at the University of Wisconsin - Madison, paints in startling terms a disturbing fact. There is a huge gap in the disparity between Black and White student debt, and it is growing.

Indeed, the report states, "...the burden of rising debt is racialized and is disproportionately shouldered by students of color, and particularly Black youth."

Furthermore, these disparities are large, and then they grow over time."

Several studies in recent years confirm that the overall wealth divide between African-Americans and Whites has widened in recent years, particularly per a Pew Research Center study done in June 2016.

"In 2014, the median household income for Whites was \$71,300, compared to \$43,000 for Blacks. However, for college educated Whites, the median household was \$106,600, significantly higher than the \$82,300 for households headed by college educated Blacks," the Pew Report found.

Now add on the new study on the racial disparity in student loan debt.

According to the University of

Wisconsin - Madison study, Black students rely on private loans more than White students, so they're paying higher interest rates and higher loan fees, meaning they are carrying higher default risks.

Black students are more likely to be directed towards high-risk, predatory, high interest loans that are normally designed to be difficult to pay back.

Black students are more likely to attend "predatory for-profit" schools or underfunded institutions, many of which have "high levels of debt accumulation...and high drop-out rates."





Black candidates do well in 2018 NC Primary elections

If the May 8th primary election is any indication, North Carolina African-American candidates will be front and center for the Nov. 6th mid-term elections later this year.

In Greensboro, **Avery Crump**, 45, became not only the first woman ever to lead the Guilford County District Attorney's Office, but certainly the first African-American female ever to do so. Crump won the Democratic primary by 53.5 percent. There is no Republican opponent for November, so unless a write-in candidate emerges, Crump, an alumna of NC Central University School of Law and former district court judge, will indeed become the next Guilford County D.A.

In Durham, two shocking

victories for the political establishment there.

Another black woman has taken the reins of power in the county prosecutor's office. **Satana Deberry**, executive director of the N.C. Housing Coalition, unseated incumbent Roger Echols, with 48.8 percent of the vote in a three-way race.

Echols, also an African-American, had been Durham district attorney since 2014. He garnered just 40.6 percent of the vote. Defense attorney Daniel Meier trailed with just over 10 percent.

Deberry, also an attorney, vowed to change the culture of the Durham District Attorney's Office if elected. Since there was no Republican primary, Deberry is effectively the new D.A. once the primary results are certified, and Echols finishes his term.

But the primary election drama in Durham isn't finished, as voters went to the

polls and decided they needed a new sheriff.

If the numbers hold, they voted decisively.

Former Duke University campus police chief, **Clarence Birkhead**, unseated one-term incumbent Durham Sheriff Mike Andrews, 69 to 31 percent. With no Republican primary, that makes Birkhead, an African-American, the next sheriff since Andrews steps down.

Andrews, who had a lot of traditional law enforcement support, drew heat because he was willing to work with federal ICE agents on detaining illegal immigrants for deportation. Birkhead opposed that, plus vowed to improve law enforcement's relationship with communities of color.

In congressional primary races involving African-Americans, **Rep. G.K. Butterfield** had no opposition in the First, but will face a Republican opponent in the

fall.

Former state legislator **Linda Coleman** pulled off a Democratic primary victory in the Second Congressional District, defeating two other opponents. She will try to unseat Republican incumbent George Holding, a Trump loyalist, in November.

And 12th District **Congresswoman Alma Adams** not only promised to beat her three Democratic primary opponents, but make sure that they knew they were beat. She did, and will also face Republican opposition in the fall.

Headed east to Robeson County, **John Campbell**, a minister and long-time local school board member, advanced in his Democratic primary race to become a state senator representing District 13 in the NC Senate. Campbell won his primary against Bobby Jacobs-Ghaffar, who had dropped

out of the race in March, but whose name was still on the ballot.

Campbell will now seek to defeat Republican state Sen. Danny Britt in November.

In Mecklenburg County, African-American candidates also did well, with long time prosecutor **Spencer Merriweather** winning the Democratic primary for district attorney. He current serves as interim, and will take office in 2019.

And former police detective **Garry McFadden**, who also campaigned against cooperating with ICE agents if elected, will now get his chance as the new Mecklenburg County sheriff, unseating incumbent Irwin Carmichael.

Carmichael had been accused by local clergy of putting youthful offenders in solitary confinement in the detention center.

With no Republicans running, McFadden will also

take office in 2019.

There were some black candidates who did fall short in the May 8th primary across the state.

Wilmington native Rep. Rodney Moore only garnered 17 percent of the vote in the Democratic primary in Mecklenburg County, losing to **Nasif Majeed**. Also in Mecklenburg, state Sen. Joel Ford lost his primary election to **Mujtaba Mohammed**. Mohammed will face Republican Richard Rivette in the fall.

Finally, one black victorious candidate may have celebrated a little bit too early after his dramatic victory.

Robert Williams of the Nash County town of Sharpsburg unseated incumbent Mayor Randy Weaver by just seven votes primary night. But reportedly, Williams allegedly almost caused a vehicular crash near city hall, resulting in his being charged with DWI.

NAACP, said she and other clergy were seeking justice and an end to solitary confinement, especially for youthful inmates, because they have not developed all of their cognitive skills and can be the most damaged.

After the press conference last Thursday, Mecklenburg County Sheriff Irwin Carmichael "adamantly denied" that inmates in his jails were being mistreated.

However, earlier in the week, the sheriff did confirm that "...youthful offenders are kept in a Disciplinary Detention Unit..." if they have threatened a guard or caused any trouble.

Rev. Corine Mack, president of the Charlotte-Mecklenburg

Hanover counties were also contacted for this story, but did not respond by press time Tuesday.

THE BIG PAYBACK: Let's "Takeover the Polls"

If there ever was a time that Black people needed to fully understand the power of their Black dollar, as well as the need to emphasize the importance of putting their money where their true influence is, that time is now. The upcoming November 2018 elections are by far one of the most important election cycles in the history of the United States. More importantly, it is one that the Black community can't afford to ignore.

African Americans make up roughly 13 percent of the overall population in the U.S., and have a buying power so strong that it can't be overlooked. While having a strong and consistent buying power in itself is a powerful asset for any group to have, turning that asset into a long-term money maker and wealth generation tool is the only thing that will strengthen the overall position and status of African Americans in this country, especially in the area of politics.

With this November election right around the corner, it is a prime opportunity for Black people to realize their true collective power by joining in with one another to create one of the most important movements of this era. It is time for Black people to "Takeover the Polls" in every local, county, state and federal election in this country.

Yes! It is time for Black people to "Takeover the Polls" by any means necessary. This can only be accomplished by championing a concerted effort to register Black non-voters and by encouraging existing, registered Black voters to get out and vote.

One of the leading voices in the Black community is aggressively mounting a push towards registering new voters and increasing voter turnout in the Black community, beginning with the midterm elections and establishing a solid foundation that goes well beyond November.

The National Newspaper Publishers Association (NNPA), which is a trade group that represents over 200 Black-owned media companies across the U.S., recently launched an initiative to register 5 million new, Black voters before the midterm elections. This effort is a bold step that is sure to make a profound impact come November.

Dr. Benjamin Chavis, Jr., the president and CEO of the NNPA, is championing this bold initiative on behalf of a storied organization that is the largest and most influential Black-owned media resource in America, reaching more than 20 million readers, combined, in print and online, every week.

In addition to working with the publications within the NNPA, the campaign initiative will focus on an aggressive voter registration drive, community-level education on important issues, and a mobilization effort, which are all designed to reach young, Black eligible voters, particularly in battleground states, like Texas and North Carolina.

"This coming November, the 2018 midterm elections will be one of the most important elections for American Americans in our lifetime," Dr. Chavis said. "This is about voting rights and the enormous suffering and bloodshed that our people have experienced to make American democracy real and fair. Yet, this is also about responsibility."

Dr. Chavis and the NNPA have also partnered with organizations like the NAACP, in order to accomplish the goal of registering these 5 million new, Black voters.

"I am proud that the NNPA is encouraging and mobilizing the Black community to get 5 million more African Americans registered to vote across the nation," Dr. Chavis continued. "We have to take over and overwhelm our political adversaries at the voting polls in 2018. This is a payback year! Now is the time!"

In order for African Americans to "Takeover the Polls" effectively before November, however, there are several things that must be done to make it work and get the results needed to make a significant impact.

First and foremost, education about the importance of voting is critical in order to get as many Black people registered to vote as possible, as well as help them truly understand what's at stake.

Secondly, political candidates must ensure that Black people become more familiar with who they are, which can only be done by effectively advertising in Black media outlets, like the Black newspapers, in their respective geographic locations.

Lastly, more accountability must be placed on the Democratic Party. The Democratic Party must do more, at every level, to cultivate and show appreciation for their loyal base of Black voters, if they want to truly see change during the midterm elections.

According to the Pew Research Center, 87 percent of Black voters identify with the Democratic Party or lean Democratic, compared with just 7 percent who identify as Republican or lean Republican. Black women are a driving force behind this high percentage of Black registered voters, and when they turnout, they make a huge difference.

Take the recent Alabama Senate race for example.

When Alabama Democrat Doug Jones faced a challenging, uphill battle against controversial Republican candidate Roy Moore in their special Senate election, it was Black voter turnout that made the difference. As a matter of fact, "Black voters turned out for the special election [in Alabama] at a higher level than their share of the electorate when Obama was on the ballot in 2008 and 2012," according to CNN.com.

After getting reports that 96 percent of Black voters backed Jones and 98 percent of Black women voters supporting Jones, Democratic National Committee (DNC) Chair Tom Perez tweeted, "Let me be clear: We won in Alabama and Virginia because #BlackWomen led us to victory. Black women are the backbone of the Democratic Party, and we can't take that for granted. Period."



Strong, but true words from the DNC Chair, but will those words translate into true appreciation for the power of the Black vote leading up to the November midterm elections and beyond?

The need for groups like the NNPA to work collaboratively with the DNC, community leaders and others committed to creating a political revolution, is paramount and necessary. The revolution must start now. However, it must go beyond the midterm elections

Trump's 'New Deal for Blacks' was dealt from the bottom of the deck

African-American unemployment has reached its lowest levels ever. President Donald Trump boasts about this on the stump, naturally claiming credit for a recovery that began after his predecessor, Barack Obama, saved an economy that was in free fall. Trump says he's delivering on his promised "new deal for blacks."

Don't fall for the hype. A low top line unemployment rate is a good thing. Tight labor markets force employers to compete for workers. More African Americans who are too often the last hired find jobs.

Those who have lousy jobs are more confident about looking for better ones. Even harsh employers like Wal-Mart find it necessary to lift wages to attract and keep decent workers. Wages should start going up. But we haven't seen much of that in this economy.

That's because while the topline rate is down, it doesn't count millions who have given up looking for work and have dropped out of the work force.

Only if the economy continues to grow and unemployment continues to decline are we likely to see wages starting to improve.

The big problem, however, is that most of the jobs are simply lousy. Virtually all of the new jobs aren't

secure - they are part-time, short-term contract jobs, with variable hours, few benefits and low wages. Not surprisingly, African Americans are more likely to be caught in these kinds of jobs than whites are.

Like most Americans, African Americans find that the costs of what they need are rising faster than their wages are. Paychecks don't buy what their paychecks used to buy. Health care costs are exploding. College debt is now higher than credit card debt and auto debt.

Housing costs are at or near record highs, both for those who want to buy a home and those who want to rent. As bad as this is for everyone, it is worse for African Americans. Black unemployment rates remain nearly twice as high as White unemployment rates.

Black households make less income and have dramatically less wealth than White households. This is true at all levels of education and in every region.

According to a report from the Asset Funders Network, the median wealth of single

African-American women is a stunning \$200.

It is \$300 for single African-American men. It is \$15,640 for single White women and \$28,900 for single White men. There is less poverty now than there was 50 years ago. African-Americans have started to close the education gap - in graduating from high school, getting a college or advanced degree. Yet in 1968, the median black household only earned 63 percent what a median white household earned. In 2016, the gap was worse, with blacks earning only 61 percent of what a typical white household earned.

It is reversing Obama's order to provide millions more with overtime pay. Trump boasts that he has dismantled Obamacare. The result is millions more losing coverage or unable to afford the prices that are rising in part as a result of Trump's attacks.

The administration plans to reduce funds for Pell grants and college loans. Its tax cuts will go overwhelmingly to the already rich, while it calls for reducing the resulting deficits by slashing spending on Medicaid and Medicare, on food stamps and education. Low-wage White workers will be the most numerous victims, but African-Americans and Latinos will be hit disproportionately. A good economy with full employment can help solve many problems.

But Trump's "new deal for Blacks" is a bad deal from the bottom of the deck. We know what to do to reduce poverty and entrenched discrimination. It isn't a mystery. It is simply a matter of will - and of power.

VA HOME LOANS.....

Not just for Veterans

It's true and a little known fact that there are some civilians that can qualify for a Veteran Administration (VA) Home Loan. However, before I begin that let me start by stating I deeply respect and SALUTE all of our armed servicemen and women. If anyone deserves a program of any kind that gives extra perks and consideration, it would be YOU.

This week I want to shed light on just how special VA mortgages are and how they benefit the ones that deserve it most. VA loans are 100% financed and do not require PMI (Private Mortgage Insurance) which causes a higher monthly mortgage on other types of loans. VA loans

can have lower interest rates, the Debt/Ratio can be higher which may cause an increase in the loan amount you can get to purchase a home. It has lower closing costs and it's easier to qualify and get approved. Did you know that VA loans do not have a minimum credit score requirement? Nope, not by Veteran Administration; however individual lenders require scores and they vary. Since VA is not the actual lender but instead a "co-signer of sorts" for you with the lender, the lender's requirements over-rules. The good news though is that because VA is guaranteeing the lender that if you don't pay and the lender forecloses, VA will make the lender whole. That fact is what causes the lender to be a bit more relaxed on their overall requirements vs other types of loans. In my career, the lowest score I have seen a lender allow for a VA

loan was a 500-credit score. Believe me, that is NOT typical and very impressive and forgiving of some obvious past credit challenges. Still, with that lender and others, they want to know that you've been able to manage your current finances very well within the last 12 months and some will forgive one late payment with a GOOD explanation. There are also some lenders that will give even more relaxed requirements to disabled veterans for good reason. Many have paid a hefty price to serve and protect us and that should be honored.

Now let me tell you more about who else could qualify for a VA Home Loan that is not or did not serve in traditional Active Duty.

The list includes Reservists and Members to the National Guard; Cadets of the U.S. Military, Air Force or Coast Guard Academies; U.S. Public Health Service officers; National Oceanic &

Atmospheric Administration officers; and Spouses of Deceased Veterans. Yes, all of these are exceptions and if you meet all other VA & lender requirements you can get approved for a VA Home loan. There is also a VA Refinance and VA Refi-Cash Out program that is very good. If you're eligible and didn't use your VA loan privileges, it might be worth checking into if you're thinking of refinancing. Another good feature of VA loans is that it's an assumable loan. If you decide to sell and if the buyer is found eligible, they can just assume your loan vs. going the traditional loan process route.

This could be a great resale feature especially if interest rates have increased and your rate is lower than the current market rate. If you're Active, Disabled, Retired Military or one of the eligible mentioned civilians who currently are renting, you owe it to yourself and your family to go get what you've earned. Start by contacting your local Veteran's Administration office and see if you qualify for a VA loan Eligibility Statement. They will guide you through that 1st step and direct you to the next. If successful in getting a VA loan approval, you'll be surprised how little out of pocket and how close your mortgage amount might be to your current rental amount. Heck, I've even known some people to end up with the new house payment being LOWER than their rent amount. I just helped a disabled Veteran that rented for 25+ yrs close on his home and that was his story. He paid \$250 earnest deposit + \$500 appraisal fee upfront, and in the end, he got \$777 back (\$27 more than paid out) and a mortgage only \$85 more than rent. Then there was Mr. W, a disabled Veteran that had rented for 50 years (yes FIFTY), it cost him a total of \$237 out of pocket to buy. He moved from Clay Street to the country into a beautiful new home where he now sits on the porch listening to crickets and watching the squirrels, LOL! Oh my, my yes indeed, you've earned this, GO GET IT. Until next week, share this article with 3 people and reach out for your FREE personalized action plan to OWN in 18 months or less.

NCDOT TO HOST A PUBLIC MEETING IN MAY FOR PROPOSED INTERSECTION IMPROVEMENTS AT U.S. 17 BUSINESS AND DOCK STREET WILMINGTON, NEW HANOVER COUNTY

STIP Project No. W-5601DH

The N.C. Department of Transportation is proposing to make improvements to the intersection of U.S. 17 and Dock Street. Improvements include extending the existing median on U.S. 17 Business at Dock Street through the intersection. Included in the project is the addition of a crosswalk on U.S. 17 with a pedestrian refuge in the median, adding extend curb (bulb-outs) on all four corners on Dock Street, and landscaping of the intersection around the curb ramp areas.

A public meeting to present information on the proposal and obtain feedback will be held Monday, May 21, 2018 in the Council Chambers at Wilmington City Hall located at 102 N. 3rd Street in Wilmington.





"Honor Thy Mother"

President Woodrow Wilson signed a bill proclaiming Mother's Day as a national holiday celebrated on the second Sunday in May.

Here we are today, still observing Mother's Day on the second Sunday in May. While commercialization has taken over the initial concept of Mother's Day,

Mother - One who gives birth to or raises and nurtures a child; A female parent; A woman who holds a position of authority or responsibility

Honor - Recognition of one's right to great respect

"Men may work from sun to sun, but a woman's work is never done!" Old Proverb

Mother's Day is a national holiday observed on the second Sunday in May of each year for the purpose of honoring mothers. Looking at the history of Mother's Day, we find that Mother's Day was first proclaimed in 1870 in the United States. Julia Ward Howe called for it to be observed each year at the national level in 1872. The original idea behind Howe's Mother's Day was a call for Pacifism and disarmament by all the women. Later, Anna Jarvis, followed by her daughter, launched a quest to get wider recognition for Mother's Day. As the custom for Mother's Day celebration spread, its focus shifted from a pacifism and reform movement to a general appreciation, and admiration of mothers.

Later, on May 14, 1914, while history credits both Julia Ward Howe and Anna Jarvis with initiating the concept of Mother's Day celebrations, we still must refer to the Word of God where we see the original concept of "motherhood" was and still is, God's idea! In Genesis 3:20, scripture shows us that the first woman recorded in history biblically speaking is Mother Eve, because she was the mother of all living. In Genesis 4:1, after Eve conceived and bore her first child, a son named Cain, she said, "I have gotten a man from the Lord." Being the first "mother", we must take note of her knowledge, spiritual insight, and understanding, that while Adam, her husband, gave her the seed for that first


