

ATTORNEY CRUMP ADVOCATES FOR WARSAW POLICE VICTIM

Was the violent videotaped May 4 arrest of 22 year old Anthony Wall, of Fayetteville, by a Warsaw police officer outside of a Warsaw Waffle House and

its aftermath a case of excessive police force?

Attorney Benjamin Crump, well known nationally for his advocacy of alleged police abuse victims, says yes, and appeared with Wall and Fayetteville Attorney Allen Rogers Monday during a press conference in

front of the Cumberland County Courthouse.

Crump says he wants to see police dashcam video, as well as video from inside the Waffle House restaurant, to determine all of what was said and done, leading up to, and including, the now infamous smart phone video that

purportedly shows Warsaw Police Officer Frank Moss with his hand tightly around Wall's throat, slamming the young man against the Waffle House store window outside and then

North Carolina honors Pender County native

History was made when Pender County native, Mattie R. Sharpless, was nominated to be a United States Ambassador in 2001. This nomination, confirmed by the United States Senate as the U.S. Ambassador to the Central African Republic, made her the first female, and the only African American to have been appointed as Ambassador from the Foreign

Agricultural Service of the U.S. Department of Agriculture (USDA).

On May 10, 2018, the State of North Carolina made history in honoring the Pender County native and trailblazer by designating a portion of U.S. Highway 17 in her name for her career in foreign agricultural trade relations, and for having served in a variety of senior level positions in Washington, D.C. and abroad.

Poor People's Campaign kickoff targets poverty

In 39 state capitals Monday - from Raleigh, NC to Sacramento, California - protesters holding signs saying, " Systematic Racism is Immoral, and "Fight Poverty, Not the Poor," vowed to steer the nation and public policy back towards caring about the least of us.

Organizers called it "the most expansive wave of nonviolent civil disobedience in U.S. history."

Then, to emphasize the point, protesters committed deliberate "direct acts" of civil disobedience, and promised more of the same over the upcoming six-week period, to put the spotlight on issues such

McCrory charged with "race baiting" in post primary remarks

A prominent Republican former governor has sent what some are saying is a "racist sounding" "dog whistle" about mounting Black political power in North Carolina, and at least one Democratic member of Congress has called it "appalling."

Congresswoman Alma Adams (D-NC-12), who represents the Charlotte-

Mecklenburg area in her congressional district, was among several public officials last week who were outraged by former Gov. Pat McCrory's remarks, chiding the election of so many Black elected officials to government leadership there.

"I'm worried about the segregated aspects of Charlotte-Mecklenburg politics and lack of diversity we might have," the Republican former governor, who many recall enthusiastically signed the 2013 law restricting early voting and instituting voter ID before it was eventually struck down, told his listeners the morning after the May 8 primary.

McCrory has since claimed that he was acting as a "political analyst" and not a partisan when he expressed dismay last week on his daily WBT-AM radio show about the successful influence of the Charlotte-Mecklenburg Black Political Caucus, and the fact that so many of the candidates it endorsed won their primaries, including candidates for sheriff and

Experts say the mentally ill are gun violence victims, not culprits

(TriceEdneyWire.com) - When the mother of a mentally ill man called 911 for help from her home in Dallas a few years ago, she did not expect him to be shot to death by police right in front of her.

When she called in, she specifically requested officers with mental health training and told them her son, Jason Harrison, 39, was suffering from bipolar disorder and schizophrenia. He needed to go to the hospital, she said. Her son's erratic behavior was nothing new. She had called for help before. So, when she opened her door, she casually informed them of her son's current state.

"He's just off the chain," she told the officers as her son ambled out the door just behind her. "Incoherent, talking about chopping up people."

Harrison seemed calm. He was twiddling with a screwdriver. Immediately, the officers began shouting at Harrison to drop the screwdriver. He didn't. Five seconds later, he was dead after being shot five times. He lay dying in the driveway of the well-kept, middle-class home as officers continued to yell at him to drop the screw driver.

What happened to Harrison in 2014, even according to police, happens far too often when the mentally ill encounter police. Additionally, it is a startling example of the relationship of mentally ill when it comes to guns and shooting. Despite statements by President Donald Trump and others regarding mentally ill Americans and guns, they are most likely the victims instead of the shooters, statistics show.

According to a study by the Treatment Advocacy Center, for example, at least half of the people shot and killed by police

each year have mental health problems. Research suggests that the rhetoric around mass shootings can support an invalid stereotype that people with mental illness are responsible.

The mass shooting at Stoneman Douglas High School in Parkland, Fla., where 17 people were murdered, is an example. While students and others focused on gun reform, President Trump's initial reactions to the shooting were a commentary on the shooter's mental health and the failure of school officials, friends, family and others who knew him to report him.

In a tweet sent out the day after the shooting, Trump said, "So many signs that the Florida shooter was mentally disturbed, even expelled from school for bad and erratic behavior. Neighbors and classmates knew he was a big problem. Must always report such instances to authorities, again and again!"

Ironically, while Trump has recommended an improved mental healthcare system as a solution to this nation's gun problem, he signed a bill last year that makes it easier for mentally ill people to purchase guns. Additionally, his latest budget proposal would cut public funds for mental health treatment as well as cut funds for an educational department program that is supposed to support safer schools.

The constant focus on a shooter's mental stability in mass shooting creates a false image of mentally ill people, experts say. According to the American Mental Health Counselor's Association, less than 5 percent of all violence in America is attributable to the mentally ill.

Instead, mentally ill people are more likely to be victims of violence than to commit violence, researchers found. A study in 2014 by researchers at North Carolina State University, RTI International, the University of California, Davis, Simon Fraser

Harrison, 39, was shot and killed after his mother called police to take him to a mental hospital when he was having a psychotic episode. Five seconds after Harrison and mother met police the door of his home, he was shot when he didn't follow commands to put down a screwdriver.

University and Duke University found through their study group of mentally ill individuals, only 2.6 percent of the violent acts they committed were in school or workplace settings.

Instead, the researchers reported, 31 percent of the mentally ill individuals had been victims of violence in the same time period. Dr. Tanya Alim, a psychiatrist at Howard University Hospital and associate professor in the Department of Psychiatry and Behavioral Sciences, said while some point to the mentally ill regarding gun violence, the nation is not providing the care the mentally ill need.

According to the U.S. Department of Health and Human Services, more than half of adults with mental illness in the U.S. do not receive mental healthcare treatment. "We need better access to care,"

Alim said. "We need to decrease the stigmatization related to mental health treatment, and we need prevention, meaning helping children at an early age and identifying illnesses early on before things get out of hand."

Dr. Harold Koplwicz, the founding president of the Child Mind Institute and one of the nation's leading child and adolescent psychiatrists, said early care may have an impact on gun violence. According to the National Institute of Mental Health, 75 percent of all psychiatric illness occurs before the age of 24 and 50 percent before the age of 14.

"If we change the system so that people are better able to recognize it, you can treat something a lot more effectively if it's only a year old or two years old, than someone who gets psychiatric illness after 25 or 30 years like any of us," Koplwicz told CBS News.

Jeffrey Swanson, a professor of psychiatry at Duke University has done extensive research on guns and mental illness and argues the two subjects should be separate parts of the public debate.

Those who have untreated mental illness and are not incarcerated run the risk of being shot and killed during any interaction with police. According to the Treatment Advocacy Center, people with untreated mental illness are 16 times more likely to be shot by police than other civilians. By comparison, African Americans are three times more likely to be shot by police. Family members of these victims call for better training of police officers to de-escalate potentially violent situations with mentally ill people.

In addition, experts say the traditional tactics officers use in these situations are the opposite of what they should be doing. For example, instead of yelling and encroaching on a mentally ill person's space, they should speak calmly and give them space. One of the keys, law enforcement officials say, is Crisis Intervention Training, which trains officers in how to deal with the mentally ill and others during intense interactions. Only about 3,000 of the nation's 18,000 police departments, however, have their officers go through Crisis Intervention Training, according to the National Alliance on Mental Illness.

acts that are deemed criminal and they are arrested and locked away. The National Alliance on Mental Health estimates that between 25 percent and 40 percent of mentally ill Americans will be jailed or incarcerated at some point in their lives.

The most glaring example is Cook County Jail in Chicago. Cook County is the largest single jail in the U.S., housing about 6,500 prisoners. According to the National Alliance on Mental Health, an estimated one in three of its inmates has a form of mental illness. Consequently, every morning, correctional officers hand out thousands of doses of anti-depressants, anti-anxiety medication and other anti-psychotics.

Those who have untreated mental illness and are not incarcerated run the risk of being shot and killed during any interaction with police. According to the Treatment Advocacy Center, people with untreated mental illness are 16 times more likely to be shot by police than other civilians. By comparison, African Americans are three times more likely to be shot by police. Family members of these victims call for better training of police officers to de-escalate potentially violent situations with mentally ill people.

Still, there is a link between mental illness and crime, if only because when the mentally ill do not proper treatment and medication, they commit

for citizens to have their votes suppressed."

Those who spoke Monday at the Poor People's Campaign rally in Raleigh's Bicentennial Plaza called for an end to repressive public policies coming from the Republican-led NC General Assembly and the Trump Administration in Washington, D.C.

When the time for direct action came, designated protesters locked arms and left the Bicentennial Plaza, walking to Jones Street in front of the Legislative Building. There, under the watchful eye of State Capitol and, later, Raleigh Police, participants, Black, White, young, old, and even handicapped,

formed a large circle in the street and, with the exception of moving to a shaded area under a tree, stayed in the street with their arms locked, singing and chanting.

As Raleigh Police officers asked each one to move out of the street, and, as they refused, they were taken, without force or handcuffs, out of the line, and walked beyond the police lines to waiting patrol cars, where they were given written citations.

North Carolina organizers promise to repeat again next Monday, May 21, when the Poor People's Campaign addresses racism and immigration.

INDICTS DEPUTY, TWO
TROOPERS IN BEATING**

[RALEIGH] A Wake County grand jury this week indicted a Wake Sheriff's deputy, and two NC State troopers for the April 3rd beating of a 29-year-old black man, apparently for no reason. Kyron Dwain Hinton says he's pleased that the law enforcement officers - Deputy Cameron Broadwell, and troopers Michael Blake and Tabitha Davis - were indicted with assault with a deadly weapon inflicting serious injury, and

willfully failing to discharge duties.

Hinton says he was assaulted and arrested while walking home from a sweepstakes parlor late April 3rd. The arrest warrant alleged that he was pointing his hand in the air as if he'd had a gun, and ignored commands to get on the ground. The warrant also alleged that he physically resisted being handcuffed, and the deputy's K-9 unit dog had to be used to restrain him.

But Hinton counters that he did nothing wrong, was unarmed, and was beaten up against a patrol car with their flashlights, and the dog was allowed to attack him and bite him on the arm. Hinton sustained injuries to his face, head and torso, along with a broken eye socket. All charges against him

were dismissed by the Wake District Attorney's Office. A local television station is seeking footage from the body cameras worn by the officers that night.

**SNAP WORK
REQUIREMENTS IN
FARM BILL COULD
COST NC**

[RALEIGH] The U.S. House of Representatives is expected to vote Thursday on the Agriculture and Nutrition Act of 2018, more commonly known as the Farm Bill.

While the name might imply it will influence only the country's agriculture industry, the impact extends far beyond that. At stake in this year's legislation are measures that would institute work requirements for

SNAP recipients.

It might sound like a reasonable expectation on the surface - but Beth Messersmith, North Carolina campaign director for MomsRising, said the implications run deep in the Tar Heel State.

"When we talk about the Farm Bill, it's not something vague that happens in Washington," she said. "It's going to have very real impacts here at home, and it's particularly going to hit hard parents with young children, those with disabilities, those caring for someone with disabilities and our seniors."

North Carolina is the 10th hungriest state in the country, according to the U.S. Department of Agriculture, and at least one in seven families struggles to put food on

its table daily.

More than half of SNAP recipients already work, Messersmith said, and those who do not often are incapable of working. Without the benefits, many will rely on community food pantries, already struggling to meet the needs of their communities.

Messersmith said the new work requirements don't take into account fluctuating hours of many service-industry jobs and related needs that come from working, such as child care and transportation.

"If they saw their hours cut at work, they could be at risk of losing their SNAP benefits for up to a year," she said. "Seniors, for example; if they can't meet the minimum number of work requirements because of age discrimination, they would be at

risk of losing the SNAP benefits they rely on."

While the legislation starts at the federal level, Messersmith said it will fall to the states to find funding to enforce the legislation.

"States are going to have to provide increased job training and employment, but it doesn't provide meaningful funding to help states do that," she said, "and it's going to say that states have to track the work hours of these 6 million to 7 million SNAP recipients every month, but it really doesn't provide the funding to make that happen."

The Farm Bill would cut SNAP funding by \$17 billion, a savings partly needed to cover the cost of the tax cuts passed by Congress last year. Its text is online at agriculture.house.gov. (SOURCE: Stephanie Carson of NCNS)

body slamming the young man to the parking lot pavement.

The video has spurred cries from no less than the NAACP Legal Defense Fund and even the daughter of late civil rights leader, Rev. Dr. Martin Luther King, Jr., Rev. Bernice King, CEO of The King Center in Atlanta, who tweeted upon reading a story about the incident, "Family, let's stay out of Waffle House until the corporate office legitimately and seriously commits to 1. discussion on racism, 2. employee training and 3. other plans to change and until they start to implement changes."

Rev. King was referring to, not just the May 4 Warsaw inci-

dent, but an earlier controversy at a Waffle House in Alabama where White police officers arrested a young Black woman, wrestling her to the ground and, according to video of the event, exposing her breasts while handcuffing, with one officer threatening to "break her arm" if she did not comply.

The NAACP Legal Defense Fund called the Warsaw incident, and specifically that police officer's alleged chokehold of Anthony Wall, "grossly inappropriate."

The video of what happened to Wall outside of Waffle House May 4 has raised questions about whether Officer Moss could have employed a far less violent manner to subdue Wall after an allegedly boisterous confrontation between the

Fayetteville man and Waffle House staff inside the restaurant.

Wall had escorted his 16 year old niece to her prom and had taken her to the restaurant afterwards to eat. However, apparently, because of a busy night, all of the tables had not been cleaned for them to be seated, reportedly.

Wall and his niece sat down at a dirty table, reportedly, and words were exchanged with a Waffle House employee.

A video posted to the Duplin Times Facebook page from inside the Waffle House shows a young Black man closely resembling Anthony Wall, along with a young Black female, both formally dressed, standing at a table, yelling and cussing at Waffle House personnel. There are other

African-American teenagers in the video that also apparently attended a prom.

The next scene in the video shows a different angle of the Officer Moss arrest of Wall. He already had the young man down on the ground, and another officer in a dark uniform was assisting in handcuffing Wall before he was taken away.

Wall was eventually charged with resisting arrest and disorderly conduct. He said he offered no resistance while being arrested outside.

At Monday's press conference, flanked by his attorneys, the young man alleged that he was mistreated by police personnel after his arrest, which included being thrown into a police cruiser with an aggressive K-9 police dog.

Attorney Crump indicated that a lawsuit is most likely in the offing against the Warsaw Police Dept., and most likely Waffle House, as well. He alleged that his client was the target of gay slurs from at least one Waffle House employee, thus causing the confrontation before Officer Moss arrived.

The open question now is, once Moss did arrive after he was called by the Waffle House staff, how did he try to defuse the volatile situation and did he consider the admittedly angry Wall such a threat, that the officer was justified in using near lethal force?

The Black mayor of Warsaw, Rev. A. J. Connor, says yes.

In a videoed message, last week, Mayor Connor said that Officer Moss was justified in containing young Wall in the

violent manner in which he did because the "...young man had broken the law,...and refused to cooperate..."

The mayor added that the State Bureau of Investigation is probing the matter. So is the Warsaw Police Dept.

Officer Moss remains on the job during the course of the investigation.

Attorney Crump, a native of Lumberton, called what happened to Anthony Wall "...a gross violation of his civil and human rights."

In his video, Mayor Connor insisted that what happened to Anthony Wall was not "race related."

However, Attorney Crump and others disagree, asking if Anthony Wall were White, would he have been treated in the same fashion.



Graduation is just the first hurdle

The Black Panther, Chadwick Bozeman, graduated from Howard University with a Bachelor's degree in Fine Arts (BFA) in 2000. His writing partner is also a HU graduate. Bozeman came back to his alma mater to address the Class of 2018, and to reportedly receive an honorary degree.

The Howard University graduation is one of more than 100 HBCU graduations, and more than 4000 graduations around the country. April Ryan brought down the house at Bennett College on May 5. Sophia Nelson spoke at the Philander Smith (Arkansas) graduation. All over the country, families are gathering, people are celebrating, and graduations are an occasion of joy.

If you are African American and graduated from the University of Florida, however, your achievement might be marred by the horrible memory of a faculty graduation marshal physically pushing you off the stage simply because you stopped to flash a frat sign or to execute a couple of steps. More than 20 students were assaulted by the unidentified faculty member (although some say he is a chemistry lecturer), who is now on paid leave.

Why would the university continue to pay someone who seems to have differentially attacked Black students (apparently no white students were assaulted or pushed off the stage)?

This lecturer is a menace to society and college students who should not be exposed to his racism, either on a stage or in a classroom.

University of Florida President W. Kent Fuchs has apologized to the affected students and reached out to at least some of the students. The New York Times reported that Alpha Phi Alpha fraternity member Oliver Telusma '21 got a call from President Fuchs, but as of May 8, had not called him back.

From where I sit, Telusma should not call President Fuchs, instead the President needs to track that student (and the others) down and visit them personally, if necessary. The University of Florida incident reminds Black students that graduation is but one of the hurdles they must clear. Every day, every single day, they face the possibility of pernicious racism, differential treatment, and the threat of law enforcement to compel compliance with the most foolish of laws and norms, spoken or unspoken.

That's why Holly Hylton, the white woman who managed a Philadelphia Starbucks, felt free to call the police on two black men after they had been seated for a scant two minutes without ordering anything. That's why a hysterical white female bigot called the police on a Black man who was barbecuing in a public park in Oakland, California, where barbecuing is customary.

That's why the police were called on three Black women (and a white man) because they failed to wave or smile when they exited an Airbnb in Rialto, California, and detained for 45 minutes even though they had proof that they had reserved the Airbnb. That's why the police wrestled a Black woman to the ground (exposing her bare breasts) in an Alabama Waffle House after she asked for plastic cutlery, and an ignorant employee reportedly said she did not know her place. And the beat goes on and on and on. Law enforcement officers, whose mission is to "serve and protect" are frequently questioned by Black people and have now become the tools of racist white people who want Black people to "know their place".

The police are too often called to put black people in their place, to force them to comply, to reinforce the tenet of white supremacy; the notion that when we see a white person we must shuck and jive and smile. So-called law enforcement officers become servants of racist who want us in our place. I want the graduates to know that their place is everywhere. Class of 2018, your place is in that Starbucks at the table, order or not. Your place is in that Waffle House, getting the utensils you requested. Your place is at the lake in Oakland, burning those bones on your grill. Your place is on that stage at the University of Florida. As a matter of fact, your place is everywhere!

Resistance, though, now has a high price. Who wants to go to jail and end up, maybe, like Sandra Bland, whose mysterious death in Texas still has not been solved. Who wants to be handcuffed, humiliated, exposed, and maligned, just because you asked a simple question. Starbucks will close thousands of stores to the tune of millions of dollars for unconscious bias training. But who will train these biased police officers and the racists who call them because their feelings are bruised because no one waved at them.

The Class of 2018 will learn, as have millions of other African Americans, that racism is alive and well. They've cleared a hurdle with graduation, but even as some cross the stage they are being reminded that there are many more hurdles to clear to survive in our unfortunately racist nation. Perhaps, though, the Class of 2018 will be among those to dismantle the racist hurdles. Perhaps in the process of clearing other hurdles (graduate and professional school, marriage and children, artificial intelligence and gentrification), they will also find the wherewithal to eliminate racial barriers to success.

Congressional Black Caucus introduces bill based on Main Street Marshall Plan

"Every man is our brother, and every man's burden is our own. Where poverty exists, all are poorer. Where hate flourishes, all are corrupted. Where injustice reigns, all are unequal." — Whitney M. Young

Whitney M. Young first proposed a "Domestic Marshall Plan" in the 1960s; elements of that proposal were incorporated into President Lyndon Johnson's War on Poverty.

In 1990, National Urban League President John E. Jacob urged Congress to shift \$50 billion in defense spending — part of the so-called "peace dividend" resulting from the end of the Cold War — into an "Urban Marshall Plan."

The Congressional Black Caucus' Jobs and Justice Act, unveiled Thursday at a news conference at the U.S. Capitol, represents the most inclusive legislation of the Main Street Marshall Plan, first proposed as part of the 2016 State of Black America and finalized in detailed form last year.

Among the provisions of the bill based on the Main Street Marshall Plan, the Jobs and Justice Act:

•increases funding for programs that promote minority-owned businesses (MBDA and SBA).

•creates incentives for infrastructure spending bills to include development programs that recruit and train individuals from communities with high unemployment rates.

•authorizes states to establish local hiring bid specifications or consider the hiring of local workers in the evaluation of bids and proposals for federal-aid highway projects.

•invests in transportation infrastructure through the successful "TIGER" program, which provides competitive grants to local governments and transit agencies to fund innovative highway, bridge, and transit projects.

•funds the creation of more than 1.9 million jobs by addressing critical physical and digital infrastructure needs in schools.

•establishes new programs or amends existing programs for job skills training for older individuals and for workers in highly-skilled industries; and scholarships for students pursuing degrees in science, technology, engineering, or mathematics (STEM) and teaching certifications.

•makes the work opportunity tax credit permanent allows states to assist, through Title XX Block Grants, low-income and long-term unemployed individuals with developing their own businesses and self-employment opportunities.

•incentivizes businesses to create apprenticeship programs.

•creates a grant program to subsidize summer jobs for in- and out-of-school youth ages 14 to 24 and year-round jobs for youth ages 16 to 24 who are out of school and work.

•Raises the federal minimum wage to \$15.

•Urge businesses contracted to rebuild infrastructure, to actively recruit, hire, and provide on-the-job training to African American men ages 18 to 39 through existing jobs, apprenticeships, and "earn while you learn" programs.

As I said when we introduced the detailed Main Street Marshall plan a year ago, it is time for the nation to treat its urban communities and cities as the jewels that they are. This comprehensive plan to rebuild and accelerate the growth of America's urban communities will accelerate the growth and progress of the nation as a whole.

I urge you to contact your member of Congress and urge him or her to support the Jobs & Justice Act.

A royal wedding that affirms truly noble values

Prince Harry of Wales, sixth in the line of succession to the British throne, will marry the American actress Meghan Markle on Saturday,

with all of the ceremony and global hoopla that the British royalty inevitably attracts. Harry is the son of Charles, the Prince of Wales, and the late

Princess Diana. What's notable about Prince Harry, however, is not so much the royal blood that he inherited, but the royal values that he has chosen to express.

Harry chose a military career, training at the Royal Military Academy at Sandhurst. He was pressured to take safe assignments far from the line of fire. But unlike the many leaders and national security advisers who posture tough but evade the draft or service in the military, he fought hard to stay with his unit and go into battle.

He stood with his unit in times of war. With them he shared risk. In 2007-8, he served on the front line in Helmand, Afghanistan, but was pulled after his presence was revealed and the Taliban pledged to throw all their resources into getting him.

He then trained as an Apache attack helicopter pilot and returned to Afghanistan in 2012 with the British Army Air Corps.

That was more than a display of patriotism. It provided him with real world experience in battle - an experience that is always sobering, making leaders less casual about sending young men and women into combat across the world. Those who experience battle are often those who best understand why the use of military force should be avoided, undertaken only as a very last resort to avoid greater loss of life.

After leaving the military, Harry devoted time and energy to veterans, launching the Invictus Games for injured servicemen and women, and he remains a supporter of its foundation. He has traveled often to Africa. As a counselor of state, he visited children's homes in Lesotho and later launched Sentebale, the Princes' Fund for Lesotho, a

charity to aid children orphaned by HIV/AIDS, a disease that has been a scourge in much of Africa. Last year, he became the president of African Parks, a conservation group. He joined volunteers to translocate elephants to repopulate areas that have been decimated by poaching and environmental destruction. He has called Africa his "second home," and will continue to play a role in mobilizing concern for its challenges and attention for its accomplishments.

Harry's decision to wed Meghan Markle, an African-American actress, showed remarkable independence. Markle, a politically progressive, divorced, biracial, femi-

The reasons why the United States has never achieved greatness

A recent column by a black Republican activist in the Washington Informer included the following: "But to my liberal friends who constantly ask 'When was America great?' I simply say that America was great when Lincoln freed the slaves. America was great

It takes a willful denial of American history to make such a statement in 2018. The historical truth is that the federal government of the United States has never in its entire history voluntarily promoted or protected the civil and human rights of black people. It has done so only when forced by compelling, strategic circumstances. The real deal is that the false history he so ardently and inaccurately declares is exactly what is being taught in most elementary schools, high schools and colleges in this country. And

those teaching it are well aware of what they are teaching.

The columnist, who insisted that Lincoln freed our enslaved ancestors, should read Lerone Bennett, Jr.'s must-read book, "Forced into Glory: Abraham Lincoln's White Dream!" The late brilliant journalist/historian includes the following Lincoln quote in his book: "I

will say then that I am not, nor ever have been in favor of bringing about in any way the social and political equality of the White and Black races. That I am not nor ever have been in favor of making voters or jurors of Negroes, nor of qualifying them to hold office, nor to intermarry with White people; and I will say in addition to this that there is a physical difference between the White and Black races which I believe will forever forbid the two races living together on terms of social and political equality. And inasmuch as they cannot so live, while they do remain together there must be the position of superior and inferior, and I as much as any other man am in favor of having the superior position assigned to the White race."

As for the Emancipation Proclamation, Bennett noted that "Lincoln's Emancipation Proclamation was a tactical move designed not to emancipate the slaves but to keep as many slaves as possible in slavery until Lincoln could mobilize support for his conservative plan to free Blacks gradually.

I strongly believe that if it wasn't for those propaganda needs, the federal government would have sat by and allowed the terrorists to crush the civil and human rights movements. That's exactly what Washington did when Black folks were regularly lynched by White, racist terrorists in the late 19th and early 20th centuries.

As for America being great "when we elected the first black president," my position is one of total skepticism about how that came about. I still want to know how a man who was barely known to most of us before 2004 could be elected president of the United States in 2008. It took big boys to pull that off. I agree with the great Rev. Jeremiah Wright who has been quoted as saying that President Barack Obama "was selected before he was elected."

The columnist should know that the United States has never been great as far as Black people are concerned. And it will never achieve greatness until it pays in full the debt owed to the descendants of the Africans whom it enslaved for over 300 years. The U.S. loves to brag about being the wealthiest country in the world. It should be since it is the only country in the world to have enjoyed 300 years of free, enslaved labor.

PASSING

In 1995, a journalist I know was interviewing the First Lady of Virginia, Susan Brown Allen, wife of the new governor at the time, George Allen.

As related to me, Susan Allen began talking about her research into her ancestry with the aim of joining the Daughters of the

American Revolution. When the reporter asked if the first lady had done any research on the governor's family, there was a hesitant response.

"You see," the first lady explained, "George's mother was born in Tunisia."

"In Africa?" the reporter responded, surprised.

"No, in Tunisia." Mrs. Allen answered.

"Yes, in Africa," the reporter said.

The reporter's take away from the conversation was very clear. George Allen's mother was born in Africa, which made her "African." And if George Allen's mother was African, didn't that make him an "African American?"

Racial pedigree for many "white" Americans is extremely problematic.

In the 1990s, when I was appointed by the court in Hampton, Va. to take depositions in divorce proceedings and recommend to the court whether a divorce should be

granted, racial pedigree was a sticky problem for some "white" people who had to give sworn testimony before me.

Even though in 1967, the U.S. Supreme Court ruled in the case of Loving v. Virginia that laws against interracial marriages were unconstitutional, many jurisdictions allowed parties to a divorce proceeding to swear that they were of the same race. This required under the old law to establish that the marriage had been legal in the first place. The logic was that if you had not been legally married, you could not be legally divorced and entitled to the rights that came with that.

Keeping the assertion about race in the deposition testimony in the 1990s was legal nonsense because interracial marriages had been taking place legally in Virginia for more than three decades, but some die-hard white supremacist lawyers enjoyed having that language entered into the record for their white clients.

My way of quashing this foolishness was to ask the person stating that both parties were members of the white race to prove that assertion. I would explain to the person claiming to be white that they had 32 great-great-grandparents, and I would require them to identify all 32 and provide proof of the racial identity of all each of them. I would also explain to them that they were required to swear that their testimony was true to

the best of their knowledge. And if they could not prove that they had knowledge as to the truth of their testimony, they would be swearing falsely.

Given the "one drop rule," no "white" person in America can prove he or she is not Black, or that he or she is white.

Whiteness is a state of mind (and it could be argued that it is a mental disorder). But it has been used to justify the unjust enrichment of one self-identified group of people over others.

Race is ever present in the minds of Americans, whether in the minds of Black folks trying to survive in a racist society, or in the minds of white folk who self-identify as being normative in our culture. But racial classifications have no function as an element of physical science. Humans have intermingled too thoroughly and for too long.

As an example of this, it can be pointed out that while America is focused on the marriage of Prince Harry of England and Meghan Markle, one fact is being overlooked. Both Meghan and Harry have African ancestry. In 1995, PBS posted a report on its "FRONTLINE" website that documented that Queen Charlotte, Prince Harry's ancestor, who was married to King George III, the King of England during the American Revolution, was directly descended from Margarita de Castro y Sousa, a member of the "black

branch of the Portuguese Royal House."

Admittedly there seven generations between Prince Harry and Queen Charlotte, but in America, we have the one drop rule, which makes all these royals Black.

Queen Charlotte's lineage should not be startling given the long history of people with African Ancestry living in England. It has been documented that as early as 1511 a black trumpeter was paid to participate in a procession commemorating the birth of King Henry VIII's only son.

Throughout our history in America, there have been great efforts by some whites to ensure that Black folk are identified as the "other," meaning not like white folk. But the truth of the matter is that there is no "other." We are all connected by our humanity and a common ancestry that confounds notions of racial purity.

And because there are no "others," contrary to what white supremacists would have us believe, we must push back against the notion that whiteness and race are anything other than social constructs, engineered to enrich one group of self-identified individuals at the expense of those who are excluded from that group.

Simply put, most, if not all, white folks are just passing.

God, religion and oppression

We have a lot of religion in this country and in this world, but in spite of religion, the world is a holy mess.

While members of all religions claim their allegiance to God, I as a Christian wrestle with the disconnect between our profession of Jesus as our personal savior and our nearly universal refusal to practice Biblical Christianity, i.e., doing what Jesus commanded us to do. Many Christians boldly dismiss the commands given by the Christ to love our enemies, to forgive those who have done us wrong, and to turn the other cheek when we are attacked or oppressed.

The Rev. Dr. James Cone, who only recently died, talked about how he could not reconcile the God he studied in seminary with the presence of evil in general and racism in particular. The religion of both white and black people was silent on the subject of white supremacy, and he wrote in *The Cross and the Lynching Tree* that the silence made him "angry with a fiery rage that had to find expression."

Cone said he had to develop a theology that could make room for one to be both black and Christian, because everywhere, including the black community, "the public meaning of Christianity was white."

The truth is, black and brown people, women, people who are physically, emotionally and developmentally challenged, and so many others, have had to try to find meaning in a world which has - in the name of and in spite of their profession of Jesus - ignored them.

All of us - white and black - were taught the same theology created by men (not women) who believed in their innate superiority. All who were not white, male and wealthy were expected to just accept our lot in life. Religion has allowed white supremacy to reign unfettered, controlling people with the threat of a possible seat in hell if we didn't all just shut up and play the game as the rules dictated the game should be played.

This aggressive and oppressive theology is still pervasive; those who believe in the rightness and the sacredness of white supremacy are fighting with everything they've got to hold onto it. White supremacy apparently believes in authoritarianism and despises efforts to democratize and equalize the lives of God's people. White supremacists believe in following "the law" if "the law" increases or at least protects their supremacy, but if a law threatens that power, they are the first to encourage the disobedience of that law. A case in point was the refusal of schools in the South to integrate after *Brown v Board of Education* ruled that "separate but equal" was unconstitutional. School officials refused to abide by "the law," and it might be safely assumed that many of the protesters were church-going Christians, as they lived in the Bible Belt.

But their passion for following "the law" decreases when it is others who are protesting what they consider to be unjust laws or policies. The recent spate of protest against the National Rifle Association being conducted by teens has drawn all kinds of criticism by disapproving adults who again would probably consider themselves to be devout Christians. Just recently, Oliver North, newly elected as president of the NRA, said that the students who have been protesting since the tragic shooting at Parkland High School in Florida are "civil terrorists," and vowed to "counterpunch" their efforts to get common-sense gun laws passed.

What is it about white supremacists that makes them think their cultural beliefs are superior to the will of God as stated in the Bible? How is it that they can think that their refusal to dismantle oppression is no problem, and that their cultural belief - i.e., that those who protest the laws of the Empire are out of line with their conception of God - is in fact all right with God?

The God of the Hebrew scriptures and the message of the Gospels is that all people matter to God. The message of both parts of the Christian Bible is that God, the creator of us all, wants us all to be treated with dignity.

God did not make any mistakes. If God had wanted this world to be all white and male, it is safe to assume that God would have made everyone white and male. We who experience oppression understand that. The white supremacists do not.

And so this world, in spite of religion and a stated belief in God in general and for some, a belief in Jesus, is a hot and holy mess. And it doesn't look like things will change any time soon.

nist American, does not exactly fit the royal tradition. Despite slurs of the tabloid press, she has captivated the British and people across the world like a breath of fresh air. Talking of her experience, she quipped, "It's time to focus less on glass slippers and more on glass ceilings."

In full swoon, the press has suggested that the enthusiastic reaction of the public to the remarkably stylish and thoughtful young woman might transform race relations in Britain, revolutionize the house of Windsor, and help strengthen U.S.-British relations strained in the time of Trump. That's far too much to load onto her shoulders, but there's no question that the union is a symbol of change.

"It is difficult to overstate how important it is to have a member of the royal family ... who is mixed race and embracing her heritage and stating that is very much

part of her," historian Ted Powell told the Observer: "It is hugely positive for Britain, particularly in the wake of Brexit and the controversies of immigration policy and race."

As an heir to the throne, Prince Harry's marriage needed the formal consent of his grandmother, the Queen of England. When she provided it, it provided an unprecedented royal seal of approval not simply of Ms. Markle but also of the diverse peoples of the Commonwealth. In itself, the marriage won't change race relations in Britain, or erase the legacy of colonialism across the commonwealth. It is a marker, not a motor force of change. But in a time of growing racial division and of leaders fanning hatred and nationalist furors, it is a marker that points in a hopeful direction. And that is worth celebrating.

We wish the newlyweds well.



Trump and the lies that lead to war

(TriceEdneyWire.com) - "In theory, the so-called 'Iran deal' was supposed to protect the United States and our allies from the lunacy of an Iranian nuclear bomb...In fact, the deal allowed Iran to continue enriching uranium and - over time - reach the brink of a nuclear breakout..."

President Donald Trump, "Speech on the Iran Nuclear Deal", May 8, 2018.

On May 8th President Trump announced he is withdrawing America from the Iran nuclear deal. His stated rationale for this action is illogical and fraught with inaccuracies and lies.

Just a little background, the Joint Comprehensive Plan of Action or (JCPOA) or "Iran nuclear deal" was struck between Iran and six world powers - the US, UK, Russia, France, China, and Germany in 2015. It was the signature foreign policy achievement of Barack Obama's presidency. According to MSNBC's Andrea Mitchell who interviewed Donald Trump on the day that it was signed, Trump was opposed to the deal as soon as he received word that President Obama had signed it.

His opposition to the Iran deal had nothing to do with its content. According to Andrea Mitchell, he (Trump)

had not even seen the deal, let alone read its text before he expressed his opposition to it.

As stated above, Trump said during the speech, "In theory, the so-called "Iran deal" was supposed to protect the United States and our allies from the lunacy of an Iranian nuclear bomb..."

Every respected intelligence apparatus, both US, UN and foreign stated that Iran is adhering to the conditions of the agreement. Even former CIA Director Mike Pompeo told the Senate Foreign Relations Committee, "assessment when asked about it on April 12 during his confirmation hearing for secretary of state. "With the information I've been provided, I've seen no evidence that they are not in compliance today..."

Captain Nativ, the chief of an intelligence section in the "central command" of the Israeli army has stated, "We see a fundamental change in the nuclear challenge from Iran. In the next few years we understand that we don't really have any threat from Iran because of the deal, I will say from this period to five years from now... So in the long run we can't really say that it is a good deal or a bad deal. But we can say for the next few years, for the near future we won't have any nuclear challenge, so for that, that's is good." This is a direct contradiction to the lies being spread by Israeli Prime Minister Netanyahu.

As part of his rational for backing out of the Iran deal, Trump said he has proof that Iran has lied, "...we have definitive proof that this Iranian promise was a lie. Last week, Israel published

intelligence documents - long concealed by Iran - conclusively showing the Iranian regime and its history of pursuing nuclear weapons."

According to NBC News, Netanyahu's presentation on Iran's defunct nuclear program was high on drama and short on current data. He claimed that tens of thousands of files prove there was an effort to build and test weapons; unfortunately, the presentation did not contain any big surprises for the U.S. intelligence community. There was nothing in the documents, which Netanyahu said were smuggled out of Tehran to change the American intelligence assessment that Iran is living up to its agreement and is not attempting to restart a nuclear weapons program. All of this was told to the Senate Intelligence Committee by American intelligence officials on Feb. 13, 2018.

Trump continued his fiction by stating, "Over the past few months, we have engaged extensively with our allies and partners around the world, including France, Germany, and the United Kingdom...We are unified in our understanding of the threat and in our conviction that Iran must never acquire a nuclear weapon." This is a subtle misrepresentation of the facts. Both French president Emmanuel Macron and German chancellor Angela Merkel, visited Washington last month in last ditch efforts to get Trump to stay in the deal. Boris Johnson, the UK foreign secretary, has been in the US this week and appealed to Trump through an interview on Fox &

Friends, telling Trump he is wrong.

Why would Trump site Israeli intelligence when his own intelligence agencies said months ago that Iran was in compliance with the agreement? Like his predecessor President George W. Bush did by creating the Office of Special Plans in the Pentagon, Trump is using bad data, misinformation, disinformation and/or lies to put America in the precarious position of backing Israel in a war with Iran for no rational reason. One of the links between Bush's war in Iraq and Trump's aggressiveness towards Iran is John Bolton. Bolton served as United States Ambassador to the United Nations from August 2005 to December 2006 under the Bush Administration and is currently Trump's National Security Advisor.

Bolton was one of the signatories to the infamous PNAC letter to President Bill Clinton wherein Clinton was asked to overthrow Saddam Hussein. "The policy of "containment" of Saddam Hussein has been steadily eroding over the past several months...Our ability to ensure that Saddam Hussein is not producing weapons of mass destruction, therefore, has substantially diminished...The only acceptable strategy is one that eliminates the possibility that Iraq will be able to use or threaten to use weapons of mass destruction. In the near term, this means a willingness to undertake military action as diplomacy is clearly failing. In the long term, it means removing Saddam Hussein

and his regime from power. That now needs to become the aim of American foreign policy."

President Clinton did not fall for the 1998 lie. President George W. Bush fell for it in 2003 lie, helped perpetuate it and invaded Iraq.

In December of 2017 President Trump made the unilateral decision to defy over 20 years of precedence from previous administrations, "...to move the U.S. embassy to Jerusalem or to recognize Jerusalem as Israel's capital city." Contradicting well established rationale and policy Trump "...determined that it is time to officially recognize Jerusalem as the capital of Israel. While previous presidents have made this a major campaign promise, they failed to deliver. Today, I am delivering."

Campaign promises are made by candidates to express a desire to take the country in a particular direction. Once elected, presidents are usually swayed by daily security briefings, consultation with policy experts and meetings with allies. The Washington Post reports, even the simplest version of the presidential brief has proven too challenging. Now, Trump gets his briefing verbally. Trump said, "I've judged this course of action to be in the best interests of the United States of America and the pursuit of peace between Israel and the Palestinians." First, how can he make such judgements when he does not understand the intricacies of the relationships and issues. Second, rarely do "campaign promises" unilaterally become US foreign policy.

Dr. Bandy Lee, assistant professor in forensic psychiatry at the Yale School of Medicine believes, "The special counsel's indictments started a crisis - a mental health crisis in a president who is not able to cope well with ordinary stresses such as basic criticism or flattering news." In her edited volume "The Dangerous Case of Donald Trump: 27 Psychiatrists and Mental Health Experts Assess a President" it was stated, "Trump is an "extreme present hedonist." He may also be a sociopath, a malignant narcissist, borderline, on the bipolar spectrum, a hypomanic, suffering from delusional disorder, or cognitively impaired."

Donald Trump has been unable to make the shift from campaign to governance and unilateral decision maker to leader of the free world. His ill-informed rants and decisions are moving this country closer and closer to the brink of international isolation and disaster. The fact that Trump nominated Mike Pompeo as secretary of state and appointed John Bolton as national security adviser - both Iran hawks - does not bode well for peace and stability. I think the US is being positioned to back Israel's play and attack Iran.




