



# Arrests, Jesse Jackson mark Poor People's Campaign

The second week of the Poor People's Campaign: A National Call for a Moral Revival focused on systematic racism, voter suppression and immigration, but it was marked by high profile arrests and intensified demands for social change.

In Washington, D.C., Monday, Rev. Dr. William Barber, national co-chair of the Poor People's Campaign, was joined by veteran civil rights leader, Rev. Jesse Jackson, leading a large group of clergy, poor people and supporters into the US Capitol Rotunda, praying, and seeking to deliver a list of demands to both Senate Majority Leader Mitch McConnell (R-KY) and House Speaker Paul Ryan.

But U.S. Capitol police refused Rev. Barber, Rev. Jackson, and Poor People's Campaign Co-chair Rev. Liz Theoharis access to either office and gave the group three warnings to disperse or be arrested.

After ordering TV cameras and news reporters to move to a separate room with the doors closed, officers arrested Rev. Barber and his supporters, ushering them outside to the rear of the Capitol Building.

"America's democracy was under attack long before the 2016 election by racist voter suppression and gerrymandering, which are tools of White supremacy, designed to perpetuate systemic racism," Rev.

## School named for Williston Class of '59 pioneer

In December of last year, the village of Sanniquellie, Nimba County in the Republic of Liberia, Africa saw a dream realized with the opening of the Early Childhood and Development Center. This Center provides a learning environment initially for some 100 children, ages two to four.

When completed the Center will have a multipurpose library, a conference room and six classrooms.

The Director of the Center is Pastor Peter S. Gonway.

In recognition of the person, who is a staunch catalyst for the realization of that dream, the school is named The Sia Barbara Ferguson Kamara ECD Center.

Barbara Ferguson Kamara is a native of Wilmington, NC and a member of the Williston Senior High School Class of 1959.

Barbara's association with Liberia dates to her serving there in the Peace Corps after graduating from Johnson C. Smith University. Her early assignment was to teach mathematics to students and teachers.

After leaving the Peace Corps, Barbara has had a distinguished career establishing herself as one of

## Federal lawsuit demands that HUD enforce fair housing


Civil rights leaders, housing advocates join forces

(TriceEdneyWire.com) - In 1965 and as part of a visionary public policy strategy known as The Great Society, President Lyndon Johnson created a new cabinet level agency, the Department of Housing and Urban Development (HUD). The agency became responsible for developing programs and crafting policies that would support urban America with decent housing, homeowner-

ship opportunities and more. Following enactment of the Fair Housing Act in 1968, HUD was further charged with its enforcement.

But the current HUD Secretary, Dr. Ben Carson, appears to either not know, or willfully ignores the vital mission of the agency he was appointed to lead. From proposing billion-dollar budget reductions, increasing rental fees for public housing, and halting efforts that require local communities receiving HUD funds to address fair housing needs, Secretary Carson's tenure has been troublesome to a growing num-


ber of consumers and advocates alike.

**Rep. Adams pushes Education  
Secretary DeVos on helping HBCUs**

Emphasizing that the June 30 end of the federal fiscal year was "...extremely critical," Congressman Alma Adams (D-NC-12) pushed U.S. Education Secretary Betsy DeVos Tuesday to commit to implementing a key provision in the recently passed 2018 Omnibus budget "...provide for the deferment of loans" made under the Historically Black College and University (HBCU) Capital Financing Program, and over \$20 million to cover the cost of HBCU Capital Financing Program loans, including "the cost of modifying such loans."

Rep. Adams, an HBCU alumna who taught at Bennett College, co-chairs the Bipartisan HBCU Caucus in Congress

President Jimmy Carter appointed her as Associate Commissioner in the Department of Health and Human Services where she was responsible for the National Head Start Program, the Appalachian Regional Commission child development programs, child care regulations and research and demonstration programs. Her last position

was Administrator of the District of Columbia Department of Human Services' Early Care and Education Administration.

Since her Peace Corps days, Barbara has made countless trips to Liberia consulting with the government as the country seeks to make early childhood development one of its priorities.

Barbara says "I have been able to build lifelong relationships not only with government officials but with the villagers. I have been embold-

ened by their absolute commitment to solving the problem of literacy."

To give some perspective, early childhood participation in the schools is less than 30%. The overall literacy rate for the 15-24 age category is about 60% for males and for females 40%.

No wonder Barbara has stated a hope in her Vision Statement that "Liberians will realize that building a strong foundation starting with the first 1,000 days of a child's life will contribute sig-

nificantly to the transformation of the education system and improved economic vitality for Liberia."

At the dedication service, Dr. Yar Doniah Gonway-Gono, the President of the local community college and the brainchild of the Center thanked Barbara for her level of hard work that allowed this village to carry on in molding the minds of this young generation.

Barbara joins a group of other Class of 1959 Williston graduates who have facilities

named for them. Rachel Freeman Elementary School of Engineering is named for the late Mae Rachael Freeman, former Chairperson of the New Hanover Board of Education. McNeil Residence Hall at North Carolina A and T University bears the name of Joseph McNeil, civil rights leader of the "Greensboro Four". This is quite a testimony to the Williston Legacy and to the Class of 1959.

fair housing has led to a federal lawsuit filed by housing and civil rights advocates who are calling upon a federal court to reinstate a key rule used to fight segregated housing. On May 8, the National Fair Housing Alliance, Texas Appleseed, and Texas Low Income Housing Information Service (Texas Housers) jointly asked the U.S. District Court for the District of Columbia to reinstate a HUD rule that Secretary Carson suspended this past January.

The rule, known as Affirmatively Furthering Fair Housing (AFFH), implemented the legal requirement that federal agencies and federal grantees further the purposes of the Fair Housing Act by dismantling residential segregation. The rule took effect in July 2015, after widespread documentation over several years revealed how many HUD grantees made no discernible effort to end segregated housing in their locales.

In response, the AFFH rule specifically required any organization receiving HUD funds to have a plan and timeline that incorporates community concerns to actively address local housing problems. This planning approach was structured to enable HUD grantees to take meaningful and measurable actions to overcome historic patterns of segregation. Additionally, the rule promotes fair housing choice, and fosters inclusive communities that are free from discrimination.

"Each day HUD holds up

requiring jurisdictions to fully comply with the law is another day that millions of people are being denied fair housing opportunities," said Lisa Rice, President and CEO of the National Fair Housing Alliance. "HUD's action is a clear example of justice delayed, justice denied."

According to the complaint, HUD suspended the rule on January 5 without providing any prior notice or opportunity to comment. HUD also did not offer any explanation or evidence as to why the agency felt justified in suspending the rule.

Unless the federal court intervenes, the rule suspension will remain in effect until either 2024 or 2025.

Across the country, an estimated \$5.5 billion in HUD funding is awarded each year. Nearly two-thirds of these funds go to approximately 1,210 grantees through HUD's Community Development Block (CDBG) Grant program. With this year's rule suspension and continuing for several years, grant recipients - largely state and local government jurisdictions -- can obligate their allocations without any concern for compliance with the Fair Housing Act rule.

A permanent rule reversal could also signal a return to the kinds of actions that necessitated the rule.

For example, a 2007 False Claims Act case was brought against Westchester County, New York. Thanks to a whistleblower organization, it was disclosed that the county defrauded the federal government in its use of \$50 million in HUD revenues over several years. This county regularly certified HUD

compliance with the Fair Housing Act even though the local jurisdiction was deliberately concentrating affordable housing in a small number of Black and Latino cities. The county also shared its CDBG funds with overwhelmingly white suburbs that refused to allow affordable housing.

In a 2010 report to Congress, the General Accounting Office found many jurisdictions lacked any oversight or accountability with HUD funds.

Nearly one-third of local jurisdictions failed to make a minimal effort to write a report known as "Analysis of Impediments to Fair Housing Choice"; in housing parlance the report is known as an AI. The GAO found that 29 percent of jurisdictions did not complete this report over a five-year period. Another 11 percent had not done so in a decade. Others could not identify a date of completion or had no AI at all.

In short, HUD did not meaningfully oversee its grantees in this process. However, after the rule took effect, communities responded with forward strides.

In Philadelphia where widespread evictions in communities of color were cited as a serious barrier to fair housing, the city began an Eviction Prevention Project that included legal assistance for consumers facing unjust evictions.

In other examples, Paramount, California began an initiative to increase access to group home housing for people with disabilities. New Orleans promised to create 140 units of affordable

rental housing by 2021.

These and other positive housing developments are now on hold with the rule suspension.

"For Secretary Ben Carson and HUD to wipe away the rule just as it was beginning to take effect is shameful and contradicts what has been a fundamental principle of HUD's mission," said Sherrilyn Ifill, NAACP Legal Defense Fund President and Director-Counsel.

For Michael Allen, a partner in the civil rights law firm Relman, Dane & Colfax,

the suspension crossed an important line.

"Flouting the rule of law," noted Allen, "HUD's action signals to every jurisdiction in the country that there will be no consequence for civil rights violations, and that HUD has no interest in helping cities, counties and states to expand housing opportunities for their residents."

**STATE BRIEFS**COMPILED

EXPECTED FROM  
GOP-LED LEGISLATURE**

[RALEIGH] It had long been rumored, but now published reports say that the

Republican-led House Elections Committee is expected to unveil a new bill to once again require voter identification in North Carolina. In 2013, the GOP majority in the General Assembly passed a voter ID law that was eventually struck down by the US Supreme Court. Many observers said then that Republicans would try again to reinstitute it, changing the framework so that if challenged in the courts again, it

could pass legal muster.

**ATTY. DOVEY JOHNSON  
ROUNDTREE, 104, DIES**

[CHARLOTTE] A pioneering black female attorney, Dovey Johnson Roundtree, died May 21 at an assisted living facility. The Charlotte-native was 104.

Atty. Roundtree is known for fighting against segregationist laws affecting interstate bus travel while she served in the Women's Army

Auxiliary Corps. Her legal career spanned nearly fifty years, and in that time, as a criminal defense attorney, Roundtree advocated for poor African-Americans and black churches, once joking that she and her partner worked for "eggs and collard greens." She was once called, "a legal aid clinic before there were legal aid clinics." Attorney Roundtree was also a mentor to a number of talented African-American attorneys like Charles Ogletree. She

once said, "I make my clients my children. I can see stars where there's nothing but a bunch of clay."

**911 TOLD OFFICERS MAN  
THEY BEAT HAD A GUN,  
BUT HE WAS UNARMED**

[RALEIGH] Two Highway Patrol troopers and one Wake County Sheriff's Deputy were told by a 911 operator that a black man they stopped April 3rd, and allegedly assaulted, was "10-

32" (had a gun), according to a recording of radio traffic. But when Kyron Dwain Hinton, 29, was stopped that night, and eventually beaten with a flashlight and attacked by a K-9 dog, he had no weapon. The officers say Hinton was uncooperative. He suffered 20 dog bites, a broken nose and eye socket. A Wake County grand jury has indicted all three officers for assaulting Hinton. All charges against him in the incident were dropped.

and represents a state with more HBCUs (eleven) than any other, pushed Sec. DeVos during Tuesday's House Committee on Education and the Workforce hearing on making sure that HBCUs receive the assistance they require regarding the financing program loans before, or by, the June 30 fiscal year deadline.

"The deferment will help these institutions make payments and provide them with the necessary temporary relief from their loan payments," Rep. Adams said. "We have approxi-

mately five to seven HBCUs that need these deferments in place by the end of their fiscal year."

Adams was concerned because DeVos had not yet responded to an urgent May 8th letter she and Congressmen Bobby Scott and Ted Budd sent to the secretary regarding the matter; even though DeVos confirmed during the hearing that she did receive it and that she will respond.

The three congress persons originally fought to have the provision installed in the 2018 Omnibus budget to help HBCUs.

"...many (HBCUs) must have some deferment or modifica-

tion underway in order to meet requirements of end-of-year fiscal audits required by their accrediting bodies," Adams, Scott and Budd wrote.

Failure to meet end-of-year fiscal audit requirements could result in the closure of an HBCU. Adams made clear that that is something she does not want to see again, and if the US Dept. of Education does not follow through with the mandates of the 2018 Omnibus budget, that could very well happen.

Adams told Sec. DeVos in open hearing that she'd heard that the department might change the way it administers the loan deferment and modification, and she pressed DeVos "

...will you commit to administering the deferment program equitably so that we can ensure that we don't have HBCU closures..."

"We are working on this carefully now, and I commit that we are going to see the intention of this addition to the Omnibus ...see it through, and are committed to supporting HBCUs in their mission," Sec. DeVos responded.

Congresswoman Adams thanked Sec. DeVos for her stated commitment, again emphasizing the importance of meeting the June 30th fiscal year deadline, and the Education Dept.'s working with those HBCUs that meet the required

criteria for loan deferment and apply in time, get one.

Earlier in the hearing, Sec. DeVos was grilled for not specifically what the Civil Rights Division of the US Education Department does. Published reports previously

indicated that DeVos was changing the original mission of the Civil Rights Office from advocating for Black, Hispanic, disabled and other students who were alleged victims of discrimination in the nation's schools.

The *Wilmington Journal* was founded on the principle of the Black Press Credo. 

The Brunswick County Board of Elections reported just 10.10% (10,008 ballots) were cast by the 99,096 eligible voters in the county during the recent 2018 primary election. In spite of efforts by the BOE to expand voting hours, locations, early voting, one-stop voting and even Saturday voting in the four satellite locations, only 10.10% chose to be equal.

## Who will protect solar consumers?

Thanks to President Barack Obama, the solar and wind industries are expanding rapidly. He provided tax credits and subsidies for renewable energy (part of the American Recovery and Reinvestment Act of 2009).

Despite the stunning failure of the solar company Solyndra, which left taxpayers liable for its \$535 million collapse, our nation's capacity for solar and wind boomed under President Obama, with the cost of rooftop solar dropping by 54 percent during that administration, and with the number of US households with solar panels exceeding a million households by 2016.

Just this month, California has passed legislation requiring that all new homes use solar power, an amazing boost to the industry! And the United Nations announced that solar attracted more investment in 2017 than any other power source, clean or dirty.

For all the support President Obama offered the solar industry, his administration didn't offer consumers enough protection against unscrupulous solar panel sales persons. Thus, consumer advocates have had to be aggressive in protecting consumers from illegitimate business practices in the solar industry. A year ago, three members of Congress wrote to the Consumer Financial Protection Bureau asking that these shady business practices be investigated. I

wrote a column about the flawed practices and had the opportunity to meet with Abby Hopper, President of Solar Energy Industries Association (SEIA).

The organization says it is working to increase pro consumer policies around the country, and has a Consumer Protection Committee, a set of free tools to help consumers understand solar agreements, and projects to include underserved communities in the solar industry, including a supplier diversity program. Some of the members of the industry group are also involved in community colleges, STEM programs, and employment training.

So why did Hector Balderas, Attorney General of New Mexico, recently file a 17-count civil complaint against Vivint, a Utah-based rooftop solar company, accusing them of fraud, racketeering and unfair business practices. Balderas says Vivint employed "high-pressure sales techniques and procedures designed to mislead consumers" and lock their customers into contracts lasting 20 years, with rates that increase "by over 72 percent," as the agreement matures. Vivint is not a minor player in the rooftop solar industry.

In fact, they are one of the largest companies, selling solar panels to consumers across the United States. Still, SEIA has no comment on the Vivint situation in New Mexico on their website, which shouldn't be too surprising, since Vivint is a member of SEIA.

To be sure, the website says all the right things. It highlights its consumer protection work, mentions diversity and inclusion, speaks of environmental awareness, and provides updates on public policy. Beneath a sunny

exterior, though, there is a problem with unscrupulous solar companies. When rooftop solar companies lose money, as SolarCity did, losing more than \$800 million in FY 2016, they get extremely aggressive, desperate to keep growing, and seek out new customers, taking advantage of those who are less sophisticated. That's what New Mexico says Vivint did, and they aren't the only ones.

Another major player in the rooftop solar industry is Sunrun, which has had its own ethical concerns. Last year, the Wall Street Journal reported that the Securities and Exchange Commission (SEC) is investigating whether Sunrun (and SolarCity) misled investors. In the Journal piece, the reporter cites Freedom of Information Act requests, which found, according to the Journal: "Hundreds of complaints have been filed against solar companies in Texas, Oregon, California and Florida, with customers saying they are paying more on their utility bills, not less as they were promised, and have been sold expensive systems they cannot afford."

What also strikes me as odd, is that in their latest filing with the SEC, the CEO of Sunrun, asserts that the cost of maintaining the electrical grid - such as transformers, power stations and transmission lines - over the next few decades does not make financial sense, and that we should instead be encouraging Americans to install solar panels.

I am supportive of renewable energy, and believe that allowing the utilities to totally dominate the electric market is problematic. But, I am also extremely leery of the government mandating more rooftop solar because the industry is seemingly rife with bad actors, who prey

upon unsuspecting consumers. If we were to employ policies at the state and federal levels, that would divest from our electric grid and instead invest in rooftop solar, why should we believe that companies like Vivint would suddenly behave themselves? We shouldn't, which is why I agree with the Consumer Federation of California's call for government to "create a framework of consumer protections."

Solar companies love to highlight the immense investment that is needed to modernize our existing electricity grid. The companies are right that work needs to be done and they are also right in the unfortunate conclusion that these investments are likely to result in higher rates for customers. However, the solar companies conveniently ignore the fact that as more and more well-off households spend thousands of dollars to install solar panels, the cost to sustain and modernize the grid will be shifted to the poorer Americans without solar panels. No matter how much we support renewable energy, we cannot ignore this unfair reality and we need to make sure that government subsidies don't accelerate this regressive cost shift.

The need for renewable energy has led the federal government, and many states, to provide subsidies for solar energy. We also need to provide protection for the consumers who are being ripped off by those unscrupulous actors in the solar industry!

**TO BE EQUAL****Diane Nash: A Civil Rights icon celebrates her 80th birthday**

*"She would not be moved. I felt my voice go up another decibel and another decibel and soon I was shouting. 'Young woman, do you understand what you're doing? You're going to get somebody killed!' And there's a pause, and she said, 'Sir; you should know, we all signed our last wills and testaments last night before we left. We know someone will be killed. But we cannot let violence overcome non-violence.' Here I am, an official of the United States government, representing the President and the Attorney General, talking to a student at Fisk University, and she, in a very quiet but strong way, gave me a lecture."* - former Assistant to the Attorney General John Seigenthaler, on trying to talk Diane Nash out of the Freedom Rides in 1961.

**H**appy birthday to Diane Nash.

Women have always been the spirit of the Civil Rights Movement, at every point in

our history, but many never seem to garner the acclaim they deserve. Diane Nash, who turned 80 this week, has been a leader among leaders.

Unlike many African Americans of her generation, Nash as a child in Chicago was seldom confronted with the depth and breadth of segregation's brutality. She has said her family rarely spoke about racism when she was young, and her first real encounter with serious prejudice was her rejection from a modeling school that did not accept Black students.

"I had never traveled to the south at that time," she told an interviewer for the PBS documentary Eyes on the Prize. "And I didn't have an emotional relationship to segregation."

Her arrival at Fisk University in Nashville, Tennessee, as a transfer stu-

dent from Howard, changed all that.

"When I actually went south and saw signs that said "white" and "colored" and I actually could not drink out of that water fountain or go to that ladies' room, I had a real emotional reaction to that," she said.

It would have been easy for Nash to retreat back to Chicago, back to her comfortable middle-class life and loving family. But she chose to confront injustice head-on.

She quickly discovered James Lawson, who was then the southern director for the Congress of Racial Equality (CORE) and was conducting non-violence workshops in a church basement.

In 1960, at age 22, she led the Nashville Sit-Ins, aimed at desegregating lunch counters. A few months later, she helped coordinate the Freedom Rides, riding interstate buses into the south to challenge the southern states' failure to enforce a desegregation ruling by the Supreme Court.

She would be jailed dozens

of times over the years - once while pregnant and facing the possibility of giving birth in prison. She and her then-husband James Bevel initiated the Selma to Montgomery Marches, credited with spurring the passage of the Voting Rights Act.

She and Bevel soon turned their efforts toward protesting the war in Vietnam. She had her passport revoked after traveling to Moscow, Peking and Hanoi, where she participated in an interview with North Vietnamese President Ho Chi Minh.

Though she often is described as the only woman within Martin Luther King's inner circle, she told a local television interviewer in 2016 she never considered King her leader. "I always considered myself at his side and I considered him at my side," she said. "I was going to do what the spirit told me to do. So If I had a leader, that was my leader."

**T**his week, the president of this nation - a white man who seems so glued to his whiteness that he cannot move without it making itself known and heard - called a group of people "animals."

The group was undocumented immigrants and he said "dangerous people" are trying to get into the United States. He said, "We have people coming into the country or trying to come in (and) we're stopping them. You wouldn't believe how bad these people are. These aren't people. These are animals." (<https://www.nytimes.com/2018/05/16/us/politics/trump-undocumented-immigrants-animals.html>)

The reaction to what the president said was swift; people and organizations were appalled, which caused the Trump machine and Trump surrogates to clarify that the president was only talking about undocumented immigrants.

That was supposed to make everything all right.

The phenomenon of white supremacy is the core of the American value system. Rev. Dr. Martin Luther King Jr said, "A nation that will keep people in slavery for 244 years will "thingify" them - make them things." From the birth of this nation, those who were running the system of white supremacy made people "things;" black people were thingified, certainly, but so were women, children, native Americans and poor white people. White supremacy is a friend to no one but itself, and it works to keep wealthy, white men in control.

Because those in power, those in control of the white supremacist machine - thingified people in order to exploit their bodies, time and talent for the purpose of making the system the wealthiest in the world, they lost the capacity to see fellow human beings as human and to consider the damage they did as they used people but did not connect with them as human.

So, breaking up the families of Africans brought to this land did not affect them; they could not see the anguish in the eyes of mothers whose babies were being snatched from their arms and they could not hear the screams of those same babies as they were thrust into the arms of an unknown person. They could not relate to the anguish of native Americans as they were robbed of their land; they could not consider the possibility that their treatment of everyone who was not white, male and wealthy had a deleterious effect on them.

And so even though many cringed and are still cringing at the fact that the president of this nation called a group of people "animals," even as he is kissing the feet of a known, murderous dictator names Kim Jung Un, he and his "base" can see nothing wrong. This man, who "thingified" Mexicans at the beginning of his campaign, sees good in white supremacist groups, honors dictators and says this country will "protect" them, sees nothing ironic or wrong in what he is doing or saying. He does not care that the vast number of Americans who heard his "animals" remark will not take the time to distinguish between which immigrants are legal and which are not; he does not realize or will not acknowledge that his words will lead to more violence against innocent people.

White supremacy destroys the spirits of those who adhere to it. This same president refused to apologize on behalf of his administration for a crude remark one of the White House staffers said in regard to Sen. John McCain, the Republican senator from Arizona who is battling terminal cancer. He has thingified everything and everyone he does not like or who he thinks does not like him. He runs roughshod over human decency with nearly everything he says and does, and he doesn't care what carnage he leaves behind.

That is the danger of "thingifying" another human being. Human smallness trumps the capacity to be decent or to even want to be decent. Because of the words of this president and his cronies, many people are going to unduly suffer because in the eyes of the stool pigeons of white supremacy, they will be things, not people.

Only when the tide turns against those who thought they were "in" with the "in-crowd," aka the ruling class of white supremacy, only to realize that they have been "thingified" too will they see the error of their ways. In the phrase of many a mother, "God don't like ugly." To "thingify" any human being is an affront to God, who created all that has been made.

People won't realize that, though, until the process of thingification reaches their own lives, and by that time, God only knows what this country will look like.

**Manifest Destiny in modern America**

**O**ne weekend evening in 1966, while traveling from Camp LeJeune in Eastern North Carolina to Myrtle Beach, S.C., my Marine buddies and I began to see roadside signs advertising a "Fish Fry" near the South Carolina border. It was late, we had not eaten dinner, and fried fish sounded like a pretty good idea. We followed the signs that led down a dark country road to a point where cars were turning into an open field.

We fell into the long line of cars and pickup trucks and inched forward until we could see a man directing the vehicles where to park. It was then we realized that we had a big problem. The man directing traffic was wearing a white Ku Klux Klan robe and conical headgear. My three traveling companions were white, and I was in the back seat, so we were able to pull out of line and head back to the main road without anyone noticing that there was an African-American in the car.

No one in our car said a word when we saw the Klansman. No one needed to say anything. We all knew that we had come very close to entering a particular type of "White Space" where my presence was not welcome. We all knew we had to get out of there.

Later, we joked about it - after we had put several miles between us and the fish fry and were certain no one had followed us. We continued our drive without any more problems.

Once we got to Myrtle

Beach, my friends and I split up, thinking that we each could do better meeting girls on our own, rather than in a "pack." But it did not take long for me to realize that I had entered another white space. While there was no one walking along the shore in Klan regalia, in 1966 Myrtle Beach was resistant to accommodating Black folk, no matter what the recently enacted Civil Rights Act said.

Black folk are not welcome in white spaces. And recent events have demonstrated that some white people will not tolerate us invading those spaces. Recent instances of white people calling the police to come and control the presence of a Black person have startled many Americans. But for many African Americans, this behavior by white people is nothing new.

If we give sufficient thought to what race means in America, it is easy to understand why white people always call the cops on Black people. In the minds of many white people, all the space around them belongs to them. This goes back to the notion of Manifest Destiny and beyond. It was this way of thinking that allowed the "American" settlers to massacre the Indians and take their land. "American" became a code word for "white," otherwise "Native" Americans would

have as much right to the land as any other Americans.

Many white people, from Christopher Columbus to Donald Trump believe they have a God-given right to claim whatever space they want. And it is in those spaces where they expect to exercise their white privilege.

In years past, white spaces were the front seats of Southern buses, movie theaters and railroad cars reserved for whites only. A classic white space was Levittown, N.Y. in the 1950s, a community where Blacks were not allowed to live even though the homes were subsidized by federal loans. While some of the vestiges of a meaner time have faded away, the fetid stench of white spaces and white privilege still linger in America.

That stench has wafted into our nostrils each time a Black person is made to feel unwelcome by someone who calls the cops to prevent them from sitting in a Starbucks, playing a round of golf, moving into their apartment, moving out of an Airbnb or riding on the Napa Valley Wine Train. And the list goes on.

Those people who call the cops do so because their white privilege feels threatened. To them, white space is where white Americans expect to enjoy "the good life" and the bounty of this country. But as with an exclusive country club, most people of color need not apply.

The tragic death of Trayvon Martin can be explained in these terms. George Zimmerman saw Trayvon as someone who did not have per-

mission to be in his gated community, and Zimmerman took it upon himself to enforce that white space.

The truth of the matter is that for some white people, a person of color is not entitled to be anywhere in America; their presence is tolerated only at the discretion of white people. There are those white people who will look into a television camera and declare that America is a "white Christian" country, and there are those white people who will not make such public declarations but will call the police when Black men sit in their Starbucks for less than three minutes without ordering anything.

Once people of color come to understand that many white people believe that the totality of America belongs to them, then we will have a better understanding of why they are so quick to call the police. Ignoring the fact that they are all descended from different groups of immigrants with different cultures, they believe the "other" has no entitlement in this country. No right to look differently or speak differently. No entitlement to worship differently or to have a different sexual orientation. Our very existence is a discomfort to them and the more prestigious the white space, the more virulent the objection to the presence of people of color.

Just as their cultural forefathers before them, these white Americans believe that it is their manifest destiny to have all that is to be had.



Back in 1935, he founded the Florida State Teachers' Association. Under the auspices of this association, he began a movement to foster the equalization of salaries. He filed the first suits demanding the equalization of salaries for all teachers in the area in state and federal courts.

In 1935, working along with various others, Mr. Davis was the first to demand a nine month school term for Black students. Up until this time, the school year for Blacks consisted of only six months, unlike the nine month year for Whites. Blacks were expected to work for six months in the farmers' (mostly Whites') fields and to go to school the remaining six months.

There are still problems in the present, and there will be problems in the future.

Teachers are still "way down the ladder" on the pay scale. The need is still great for funds to purchase instructional supplies and supplementary materials for the classroom. No wonder many teachers and sympathetic supporters came together in a special teacher rally to call attention to salaries, working conditions, job satisfaction, etc. in North Carolina. We hope this is the beginning of a movement in educational advancement.

## GET THAT DEED AND FLIP THOSE KEYS!

## The Evaluation... HOW MUCH IS IT REALLY WORTH?....

**R**eal Estate value is determined by a few factors and this week I want to enlighten you on how it's obtained. One thing for sure is that personal opinions of how much it's worth are usually far greater than market value.

Realtors & appraisers call it Personal attachment or Emotional attachment evaluation. If it's a property that holds a lot of memories or been in the family for generations, many tend to think very highly of it. I truly understand as to why you would because those things are precious, but the challenge comes when the comps do not line up to support it.

So, what are COMPS? Comps is a real estate appraisal term referring to properties that have sold in the last 12 months or less with characteristics that are

similar and close proximity to subject property (your property) whose market value is being sought. Further broken-down: It can be a home, land, building, etc that sold within last 12 months that was in the same block, community, 1-mile radius or as close as possible that has same or very close features of the property that it is being valued its worth. Example: If your home is a 3 bedroom brick home on 1/4 acre lot, built in 1991 on Castle Street, then the appraiser is not going to look at a 3 bedroom log cabin home on 2 acres built in 1991 in Castle Hayne to determine how much it's worth. The properties are too far apart in distance, the land sizes and features of the homes are nowhere similar. Therefore that log cabin home would not be a good comp to determine how much your brick home is worth. Same goes for land. If your land is 5 acres in Leland, the appraiser will not use a 5-acre tract of land in Wilmington to come up with a value. Also, if your property is a 5-acre tract in Leland with a residential zoning, then a 5-acre tract in Leland with a commercial zoning

would not be a good comp. I recently had a client contact me about possibly listing a commercial property that had a re-zoning of the area and the new zoning did not allow for as many commercial uses as the old zoning did when they brought it some years ago. That caused the value of their property to go down. Needless to say, that did not feel good but those are the types of things that can happen over time that can negatively affect the market value. I'm sure you got the picture by now so let me tell you about the difference between Realtors and Appraisers. Realtors use comps as well to do a Market Analysis for individuals looking for some indication of what they can list a property for sale. The difference is that Realtors are encouraged to give "a range" of what it could list for and we do not provide a certified report for that opinion whereas a licensed appraiser will. A Realtor may say, "your property is worth between 100,000-115,000" and the appraisal can say, "my certified opinion of market value is \$112,000".

So any Realtor can help you only if considering list-

ing property for sale and together you and your Realtor can determine what amount to list it for. If ever need or want a certified report of market value for any other purpose, you definitely need to hire an appraiser. However, be mindful that an appraisal is an "individual person's opinion of value". Yes, even if 2 different appraisers are looking at same comps, they sometimes can come up with a value totally different from one another. Go figure, strange but it does happen more than you know especially if using bank an appraiser that lives in Swansboro NC to appraise a property within the city limits of Wilmington. Smh, I just lived that nightmare with a buyer. The take away lesson is to make sure the appraiser knows the area they are evaluating. ### NBCI pleads to find a way to help young White mass murderers before they kill us all

17-Year Old Dimitrios Pagourtzis, another mass murderer

**WASHINGTON DC** - The National Black Church Initiative (NBCI) a faith-based coalition of 34,000 churches comprised of 15 denominations and 15.7 million African Americans, is stunned that this society continues to ignore the obvious. We have a problem with white males between the ages of 15 and 21 who are committed to committing mass murder because either they are angry, they suffer from poor mental health or they harbor irrational hatred. We do not know what drives this population because society refuses to identify this subgroup as a problem because they are white. Race is not the issue here, we need to get them some help.

We must find the most humane way to help this subgroup of young white males.

Rev. Anthony Evans, President of the National Black Church Initiative says, "I am not sure what it would take for the clinical community to take this historic threat as a real threat to humanity, but we will continue to point it out no matter what people think. We believe that we are right because we are concerned about this subgroup of young white males who are bent on committing mass murder anytime they are angry, mentally ill or under the influence."

The National Black Church Initiative is sure that if young African American males were killing at the rate of these young white males, the country would mobilize in a way to find them and kill them.

But, because they are young white males we refuse to even recognize, in language or actions, this particular subgroup of white mass
